# Tobin Bridge and Route 1 Chelsea Lane Closures Start in April



The Massachusetts Department of Transportation (MassDOT) announced the Department will be rehabilitating the surface of the Tobin Bridge and complete required maintenance to improve the structure which will require lane closures and result in significant traffic impacts on the Tobin Bridge and Chelsea Curves section of Route 1 beginning April 1st. These impacts will lead to increased travel times on sections of Route 1 northbound and southbound for drivers and MBTA bus customers.

The Department also released details about transit options available to travelers such as free fares in the inbound direction on the SL3 bus line offered at the Chelsea, Bellingham Square, Box District, and Eastern Avenue stops for the duration of construction. The MBTA also announced that they will be running additional MBTA Blue Line trains to additional capacity, and these measures will be funded by MassDOT Highway Division project funds.

Beginning April 1st, lane closures on the Tobin Bridge northbound will be put in place, although two of three travel lanes will be open during daytime hours. One of the three travel lanes on the Tobin Bridge northbound will be open during overnight hours.

Beginning by early May, Route 1 travel lanes in the Chelsea Curves area will be reduced so that two of three north and southbound travel lanes will be open in the daytime. One of three north and southbound travel lanes will be open during overnight hours.

"MassDOT is carrying out simultaneous work on this infrastructure, which was constructed in the middle of the 20<sup>th</sup> century and hasn't been rehabilitated since the 1970s in order to ensure its continued use and reliability and minimize

the overall impact on commuters and the local community," said Highway Administrator Jonathan Gulliver. "We thank travelers for their patience as MassDOT begins this necessary project, and we encourage everyone traveling throughout the Route 1 area to make smart commuting decisions such as considering public transit, using the appropriate technology apps to find the best route and time to travel, and building extra time into their commutes to account for potential roadway congestion."

"During construction, free fares are being offered for Silver Line 3 (SL3) inbound customers at certain station stops and additional Blue Line train capacity is being added. In addition, public transit customers will be able to use a CharlieCard to travel between North Station and Chelsea on the Commuter Rail," said MBTA General Manager Steve Poftak. "Some MBTA customers on "certain bus routes will experience delays, so we urge riders to consider taking advantage of these additional travel options being offered during construction.'

MassDOT is advising the public to also consider using the Haverhill or Newburyport/Rockport Commuter Rail lines and note that the Haverhill Line historically has parking capacity at Haverhill and Bradford stations. The Newburyport/Rockport Line historically has parking capacity at Newburyport, Salem, and Lynn stations. Customers can monitor @MBTA\_Parking on Twitter for capacity updates and information.

MassDOT's traffic modeling suggests that on Route 1 northbound, afternoon peak travel times could increase in duration and have significant delays. Vehicle backups are expected to extend onto the I-93 ramps, along

the Leverett Connector, and towards Rutherford Avenue. On Route 1 southbound, morning peak travel times could similarly increase in duration with significant delays expected. Vehicle backups are expected to extend to the Route 60 Rotary in Salem and may intermittently extend beyond Salem Street.

MassDOT is carrying out work on the Tobin Bridge and Chelsea Curves section of Route 1 at the same time so that these projects will be completed in 2021. If the projects were done at separate times, drivers would be inconvenienced for additional years. This work will eliminate the need for weight restrictions and postings, and MassDOT will use accelerated construction techniques to shorten the overall construction time.

MassDOT encourages the public to be mindful of these impacts and seek alternate routes. Those traveling through the area should reduce speed and use caution. These operations are weather dependent and subject to change without notice.

# Stirpe Nostra

#### CAPSULE GEOLOGY

For the novice, a very small and elementary dose of geology, blended with some technology, might help to provide a better understanding for parts of ancient theology.

The solid surface of the earth as we see it is either rock or soil. Rock is the term used to denote the large geologic formations. Rock is broken into stone of various shapes and sizes. Rock is divided very generally into three classes according to the method by which it is formed. These classes are: (1) Igneous rock, which is formed by solidification of molten rock; in other words by volcanic action. Granite curbstones are a good example of igneous rock. It is the strongest and most durable of all rock; (2) sedimentary rock, which is formed from disintegrated products of other rocks. Flagstone is an example of sedimentary rock; (3) metamorphic rock, which is rock whose physical or chemical character is altered by pressure, temperature, and time. Marble is a good

Marble plays such an important role in religious architecture that it might be well to note that the most desirable qualities in sculptural marble are pure white crystals, straight uniform grain, freedom from natural stains, voids, and microscopic cracks. A good grade of marble is available in the U.S.A. Marble from Carrara, Italy is better

example of metamorphic rock.

Christus (also known as Christus Consolator) is a 19th-century Carrara marble statue of the resurrected Jesus by Bertel Thorvaldsen. Since its completion in 1838, the statue has been located in the Evangelical Lutheran Church in Denmark's Church of Our Lady in Copenhagen, Denmark.

and pentelic marble from Mt. Pentelicus in Greece ranks with the world's best.

Soil is formed from the disintegration of rock. Soil that remains where it was formed is called residual soil and it builds up at the phenomenal rate of about one quarter inch in one thousand years. Soil that has been transported by water and deposited at another site is called alluvial soil. The

deltas of all rivers contain troublesome deposits of alluvial soil. An important soil type which is formed by wind-blown material is called loess

Soils are also classified as (1) coarse grained like gravel and sand and (2) fine grained like silt and clay. The grain size of sand is about 1/1000 inch but in clay it is less than 1/12,500inch. Much of the plains of Mesopotamia are made up of silt and clay carried down by the Tigris and Euphrates from the mountains the north. During ancient times these two rivers emptied into the Persian Gulf independently. Alluvial deposits have now forced the two rivers to join as one before reaching the Gulf and they have built up more than one hundred miles of silty soil in a huge delta. Ancient cities that used to be close to the shoreline are now far inland.

It follows then, to understand your Bible lands, you must understand the influence of geology upon that area. There was little or

no building stone, just silt and clay, more silt and more clay. Where there is a lack of other building materials and an abundance of clay, we can look for and find brick. In this area there was small brick, large brick, sun-dried brick, kilnbaked brick and glazed brick in many colors.

Teresa Verzeri was born in Bergamo (Italy) on July 31, 1801, the oldest of seven children of Antonio Verzeri and his wife the countess Elena Pedrocca-Grumelli. Teresa's mother, Countess Elena had felt drawn to religious life, but her aunt,

Intelligent, gifted with an open spirit, vigilant, and upright, she was educated to discern, to seek true values and to be faithful to the action of grace. Teresa was a devout and intelligent child; she desired nothing more than to pursue a life of service to God despite originally being apprehensive about what her vocation would entail.

Teresa became a Benedictine nun at Bergamo, with the Daughters

Teresa passed away on March 3, 1852.



## Three Proposals to Activate the Charlestown Navy Yard Approved by the BPDA

and the Boston Planning & Development Agency (BPDA) announced that three proposals to temporarily activate the Charlestown Navy Yard have been approved for the summer. The proposals include free public programming which will open up the Navy Yard and waterfront for residents and visitors from across Boston.

The BPDA received a total of six proposals in response to a Request for Proposals (RFP) released last year. After a thorough review that included significant community engagement, three proposals have been offered temporary licensing agreements for operation in summer 2019. The proposals

- An outdoor community gathering space with activities for residents and visitors of all ages, along with beer and wine service, will be sponsored by the Anthem Group. Activities will include exercise classes, performing arts events, movie nights, photography classes, family educational programs, and more. The pop-up space will move to different locations throughout Navy Yard over the course of the summer.
- The Navy Yard's USS Constitution Museum will offer free outdoor programming by bringing historical exhibits and signage outside of their current location to the new Dry Dock #2. The BPDA is supporting the USS Constitution with a \$10,000 grant.
- A tall ship, operated by the Charlestown-based Navy Yard Hospitality Group (owners of Pier 6 and the Reel House) will temporarily dock and be converted into a floating res-

Mayor Martin J. Walsh taurant. The 245-foot long ship will include an artistic lighting installation connecting to Shipyard Park.

> "By bringing activities for people of all ages to the Navy Yard, we hope to encourage a more inclusive and equitable waterfront for Boston's residents and visitors to enjoy," said Mayor Walsh. "The Navy Yard is a place of national historic significance, and we are pleased with the creative proposals we received and the selections that will be moving forward this summer. We look forward to continuing to work with the community to ensure that the Navy Yard is a welcoming public space, while celebrating and respecting its history."

> "Friends of the Charlestown Navy Yard is excited to see the implementation of the activation and programming initiatives," said Michael Parker, Chairperson of the Friends of the Charlestown Navy Yard, "The initiatives selected will highlight the Navy Yard's maritime culture and the outdoor activities will bring the Charlestown community together along its beautiful waterfront.'

The proposals will operate on a trial period from May to October. Following the trial period, the BPDA will work with the community to assess the success of the programming. License agreements for the selected partners will expire at the end of October.

The BPDA has negotiated a rent structure which requires each revenue generating proposal to set aside a significant percentage of their gross sales for free public programming and investments in the public open spaces.

The BPDA also received significant support for the idea of bringing kayak rentals to the Navy Yard, but was unable to identify a financially viable location and partnership in the first round of responses. The BPDA is currently exploring releasing a new RFP specifically for kayak rentals in hopes of being able to deliver on this idea this

Spring has blossomed before us, green and cool as a bright sprig of spearmint. The longer days fill the early evening hours with resplendent golden sunrays. Robins are now a regular sight, scampering among bushes or taking off in flight from the treetops, their red feathers flashing the joy of spring. Buds become more pronounced, seemingly smiling with anticipation at the secret leaves concealed within. The first crocuses and daffodils wave gaily in the brisk breeze. Spring places me in the mindset of regrowth and renewal, inspired by the nature that blooms and flourishes all around me. In particular, I think of the gardens that are now beginning to take form, the first tender crops sprouting from the damp, dark soil. My father, like many Italians, loved to garden and took great pride in reaping the gifts that the Earth provided. He did not bequeath me a green thumb, but he did instill in me an appreciation for all that grows and all that originates from the natural world. In the springtime, early garden plants often take the form of delicate herbs. I love cooking with herbs, as their pungent aroma wafts through my kitchen and their sharp taste provides a kick to recipe. However, I discovered that herbs all come with their own unique folklore and superstitions. In honor of the spring and the rebirth of vegetation, let us dive into the traditional lore of some of our favorite herbs.

Basil: Basil, or basilico, is one of the best-known herbs of Italian cooking. It forms the crux of pesto, that delectable sauce hailing from the region of Genoa, typically made with crushed pesto, pine nuts and olive oil. In Italy, basil further symbolizes loves, and in romantic partner announced omen of death.

her intentions by placing a pot of basil on her windowsill! However, this fragrant herb also holds a sinister side. People in the Middle Ages thought it gave birth to scorpions. Some scholars speculate that the word "basil" shares the same root as "basilisk," a spooky legendary creature that had the body of a snake and the head of a rooster, and could kill its prey with just a glance!

Lavender: I always thought of lavender as a pretty flower that blossomed in spring and summer, but it is actually used as a culinary herb as well! Honey made from bees that sip on lavender nectar is prized in the Mediterranean world. Lavender also forms the basis of many herbal teas. People use dried lavender buds to flavor breads, scones and chocolate, while candied lavender flowers make sweet cake decorations. In Italy, lavender is called lavandula. It was so prized in ancient Rome that it cost as much as a farmer's monthly wages! Its name derives from the Latin word lavare, or wash, because it lavender was used to perfume laundry and baths.

Parsley: Parsley is known as prezzemolo in Italian. This beloved herb adds color and flavor to Italian pastas, stews and casseroles. It frequently appears as a garnish, a custom which has roots in superstition. Ancient cooks believed that parsley was an antidote to poison, and though we now know that is false, the credence lives on in the form of decorative parsley! In ancient Rome, on the other hand, parsley was often planted on graves. This custom inspired a bevy of sinister parsley lore, such as the superstitions stating that only evil people can grow parsley well, or that giving away or olden days a girl looking for a replanting parsley serves as an

Rosemary: When I think of rosemary, I think of my mother flavoring chicken or fish with this woodsy, piney herb. It is also delicious baked into biscuits and breads like focaccia. As William Shakespeare noted in Hamlet, rosemary symbolizes remembrance. It was once scattered atop caskets to ensure that funeral mourners would always remember the dead. The herb known as rosmarino in Italian also formed part of medieval brides' wedding bouquets, and as such became a token of love. Folklore also attributes rosemary with the power to repel the evil eye and frighten

away malicious spirits. Sage: I am in love with the classic Italian combination of savory pumpkin and sage, or salvia. You might say that whoever thought of this delectable flavor profile was wise indeed, and you would be right! The herb sage is associated with wisdom, which is why we call intelligent people sages. Supposedly, bringing a pot of flowering sage indoors invites bad luck, so people would make sure to pick sage before it bloomed. A girl who picks sage on St. Mark's Day (April 25th) or Midsummer (June 24th) will dream of her future spouse, while eating sage in May promoted longevity.

Thyme: Thyme, or timo in Italian, is a popular herb with which to season soups, stews and pastas. It also tastes wonderful mixed with lemon. This little herb carried a load of significance in the ancient world. The ancient Greeks burned thyme in their temples, believing that its aroma would imbue people with courage. In ancient Rome, it was used to purify rooms. By the Middle Ages, thyme had become synonymous with preventing nightmares and, when given as a gift, inspiring courage in knights. Like many other herbs, thyme was associated with the supernatural and as such was strewn onto coffins to assure a safe passage to the otherworld.

And there you have it — six well-known herbs and their associated folklore. I hope that the traditions and customs attached to these herbs will inspire you to use them in your cooking and, furthermore, to learn about the way people in times past related to the gifts produced by the Earth. After all, spring is about honoring the rebirth of nature, and delicious herbed goods provide us with a delectable way to do so!

It is amazing how fast time flies by you until you find yourself at Boston City Hall a number of weeks ago celebrating the 50th anniversary of what was called the New Boston City Hall when it opened to the public in February 1969.

I can remember the very heated campaign for mayor in 1967. Several candidates were in the running. The top two candidates being Secretary of State Kevin H. White and School Committee Chairwoman Louis Day Hicks. It was Old Boston versus New Boston. All across the nation, eyes were on the City of Boston. Hicks was a Southie girl who believed in the city's neighborhoods, especially her own South Boston. White, to many Hicks supporters, was a White Knight riding into town and was viewed by critics as an Irish Yankee who came upon the scene in 1960, when he ran statewide beating a man named Ed Brooke, who would later become a U.S. Senator. It was old versus new in politics, in life, and in the life of our nation. New City Hall was born at the right time and in the right location, and still serves as an anchor in the continued growth in our city's life.

At the same time Boston voters were deciding who would be the next mayor, Bostonians were watching a structure rising out of the earth in the new Government Center. When the building was completed, many didn't know what to think about its looks. It was praised by those in politics and the field of architecture, but seemingly much reviled by the common

folk looking at the building designed during the height of the "Brutalist" period of American architecture.

One of the many architects who worked on this building attended the recent birthday party for this well-known and misunderstood building. His name Michael McKinnell and I spent a good 15-minutes talking with him before all the festivities began. We talked about the history of this edifice. What it meant 50 years ago, and what it still represents today. Brutalism was never fully understood. It was definitely an unfinished product as it was meant to be. The beauty was more abstract than anything else.

This building shocked everyone at first look, and sadly for second, third, fourth, etc. I remember the amphitheater look of the City Hall Plaza where folks could seat semi-circle as concerts would play on the Plaza. I saw Bob Hope on stage right there in 1969. I saw the Bruins rally there way back in the early '70s. I also remember the beautiful reflecting pool and fountain, where people could eat lunch on a nice day. The water cooled off the coldness of the "Brutality" of City Hall on the other side of the Plaza. The



Review: **Onegin** at Greater Boston Stage Company

Onegin, now playing at the Greater Boston Stage Company in Stoneham is the U.S. premiere of the musical based on the epic poem of the same name by Alexander Pushkin. It has been very popular in Canada, and after seeing this production I can understand why. In this version, Russian literature meets rock opera. The result is two hours of very enjoyable theatre.

Set in 19<sup>th</sup> Century Russia, it is the story of Evgeni Onegin

(Mark Linehan) who has moved to the countryside where he has inherited his uncle's estate. There he befriends the young poet Vladimir Lensky (Michael Jennings Mahoney). To cheer his new friend up, Lensky introduces Onegin to his girlfriend's sister Tatyana (Sarah Pothier).

We hear how Tatyana is immediately taken with Onegin as she sings *Let Me Die*, in which she tells of her love of books and her feelings that Onegin has walked out of one of the great novels she has read. Ms Pothier's rendition of *Let Me Die* is beautiful. Her voice is sweet and conveys a vulnerability that captures the essence of Tatyana.

Unfortunately, the object of her affection does not respond in kind. He makes his feelings clear in *Onegin's Refusal* in which he sings the lyric, "Marriage is not for me." Mark Linehan's voice is strong and rich, and it doesn't take long to understand the character of the self centered Onegin.

The story moves to tragedy as Onegin's thoughtlessness causes his friend Lensky much pain. Onegin's flirtation with Lensky's fiancée

Olga (Josephine Moshiri Elwood) leads to the two friends having a duel. The result causes much pain while giving Onegin what appears to be the first sense of caring for others.

While tragic, the play has many upbeat and funny moments. Christopher Chew as Triquet puts on quite the rock star performance during "The Queen Of Tonight." Kerry Dowling's glower seems aimed at each audience member as she sings *Rules For Dueling* while dressed as a

Cossack complete with mustache. There are a number of memorable moments such as this.

Michael Jennings Mahoney who plays Lensky has a remarkable voice. The melancholy that shows during *Olga Will You Weep* is deeply moving. I was impressed and taken with what I heard.

The five piece orchestra was on stage throughout the performance as are most of the cast members. And, in a nice touch, a few members of the audience are also seated on stage and take part in some of the numbers.

Onegin plays through March 31st in Stoneham, and I highly recommend it. This Greater Boston Stage Company production is well worth seeing. With political divisions permeating so much of our daily lives, it is nice to be able to take a break from the madness and see a play that is touching, human, and has such a great score

Review: An Inspector Calls

ArtsEmerson, Emerson Cutler Majestic Theatre, Boston

Directed By Stephen Daldry A National Theatre Landmark Production Now through March 24<sup>th</sup>

When the curtain rises for *An Inspector Calls*, now playing at the Emerson Cutler Majestic Theatre, a magnificent Victorian mansion appears center stage shrouded in mist and rain. It is rather breathtaking to see as we hear the occupants talking over dinner. Eventually, the sides of the house swing back revealing the diners while allowing the audience to get to know each character.

At first I thought the house would steal the show, but nothing could take away from the fine acting on display over the next 100 minutes of this fast paced production filled with rapid fire dialog.

J.B. Priestly's play which was written in 1945 and is set in 1912, takes place the home of the prost

takes place the home of the prosperous Birling family, celebrating the engagement of their daughter Sheila (Lianne Harvey) to Gerald Croft (Andrew Maclin). Croft's family runs a company that competes with the Birling's firm, and the wedding appears to be as much a business merger as an affair of the heart.

The mood begins to change quickly when the mysterious Inspector Goole (Liam Brennan) arrives and begins questioning the individuals about a young woman named Eva Smith. Eva has taken her own life and the Inspector acts as a conscience while going from person to person while finding blame in each for driving the young Smith to such despair.

Priestly made no attempt to hide his agenda and it is clear the story comes down to a very black and white social commentary; wealthy industrialist is cruel and exploitative while the workers

have no control over their lives. It is a theme that will be popular with many of today's Millennials who seem to be quite taken with socialism, but it does not lend itself to discussion. Priestly has written a work that is more of a sermon promoting rather than an argument for his beliefs.

Does this mean only people who agree with the author should see it? Not at all! Actually, it is a very good work with excellent dialog, many surprises, and characters that are well developed, and that while it is strongly political in nature, there is much in it that will resonate with people from all spectrums of opinion. Step back from where Priestly is trying lead

the audience and you have a story about human nature and the harm people do to one another because they don't understand or simply choose not to see the consequences their actions have on the lives of others. This is a problem for not only wealthy capitalists, but for many people when they have power over others. It could even be true of college professors or lower level management people.

This is the U.S. tour of the National Theatre production of *An Inspector Calls* and the set from the original London West End theatre has been brought over. It is a first rate work that is a pleasure watch. At times I felt as if I were sitting in a London theatre while watching this incredibly talented troupe of actors plying their art. Costumes, lighting, and effects further enhanced

Gerald Croft (Andrew Maclin), the future son in law, and Sybil Birling (Christine Kavanaugh), the family matriarch, struck me as the coldest of the bunch. Both appeared to be from the school that says if nobody sees you, you didn't do anything wrong.

Not to be forgotten is Edna, the Birling's maid. Played by Diana Payne-Myers, she has very little dialog but acts as witness to all that happens. While subtle, she is quite moving and plays an important role in the play. Opening night was also Ms Payne-Myers 91st birthday. She has been performing the part for 22 years I think she has it down pat.

Be neither turned off or on by the political bent of An Inspector Calls. It is excellent theatre and it would be a shame not to take it in. We are in such polarized political times, but that has always been true to some degree. The important thing is to be able to listen to one another no matter how much we may disagree. While you may or may not agree with J.B. Priestly's political views, there is much common ground to be found in how we can improve our lives when it comes to treating others with kindness and respect.

One thing everyone can agree on is this is a superb production that should not be missed.





# Nanna & Babbononno

A Nostalgic Remembrance



First of all, to all my Irish brethren, Erin Go Bragh and a happy St. Patrick's Day to ya.

Last weekend, we were driving on Atlantic Avenue and were stopped by a traffic patrolman due to a parade crossing in front of us. As they approached, I could hear the strains of an old Irish tune, "Wild Colonial Boy" being played on multiple bagpipes with drums supplying a rhythmic background. When the band crossed in front of my car, I saw that they were all dressed in Irish costume and all participants, except the musicians, were waving to the evening crowd. By the way, the Atlantic Ave I mention is not the one in Boston. It is Delray Beach, Florida. I didn't know there were any Irish in these parts, but I guess I was wrong.

We Italians have a saint's day that is as important to us as St. Patrick is to the Irish. but not as publicized. It is St. Joseph's Day. March 19th is the day the foster father of Jesus Christ is honored in parts of the Christian world. His day is celebrated by the Anglican (Episcopal) and the Lutheran Churches as well as in the Roman Catholic Church. It is a patronal feast day in Poland and Canada and for people named Joseph or Josephine, In Italy as well as Spain and Portugal, it is Father's Day.

Seeing the date falls during Lent, meatless dishes are served, following ancient customs. In Sicily, St. Joseph has become a patron saint. During the Middle Ages, Sicilians prayed to St. Joseph to stop a severe drought that had affected all of the island's crops. They promised that, if Sicily was spared, they would prepare a feast in his name. Their prayers were answered and the fava bean crop that resulted saved the Sicilian population.

In Sicilian communities, it is traditional to wear red clothing and eat Neopolitan zeppole. All the other dishes are meatless, but most contain breadcrumbs that represent saw-dust, seeing that Joseph of Galilee was a carpenter.

Since we are in Florida,
Loretta and I celebrated St.
Joseph's Day at St. Thomas
More Parish in Boynton Beach.
Following Mass, we were part of the traditional dinner prepared by the folks at the parish. It was great, but I wish I could have been back in Boston to have celebrated the St. Joseph's Day dinner at my favorite North End restaurant, La Summa's on Fleet Street.

Within five minutes we were on Washington Street heading toward Raymond's. Once inside, the men's department was just to the right on the first floor. Barbara Summa, the owner, is part of the Renaissance Lodge of the Sons of Italy, and hosts the traditional St. Joseph's Day dinner on whichever Sunday falls closest to March 19th. This year, Sunday, March the 9th worked out. Lodge President Dean Saluti, his wife, First Lady Margie Cahn and dozens of other lodge members headed to La Summa's to literally dive into the traditions of the day. Dean and Margie go out of their way to promote this event, and if we were home, Loretta and I would

be in attendance, both wearing something red.

You may ask, "What's so different about the St. Joseph's Day dinner than most Italian dinners?"

The meal is meatless, and might start out with stuffed artichokes, followed by a dish of rabbi (with hot peppers if Dean Saluti captures the cook ahead of time). Next, comes pasta with calamari and muscles, followed by various types of fritate. If you like the first pasta course, there is another (thick spaghetti) flavored with orange rind and breadcrumbs. I can't leave out orange and fennel salad, and for dessert, fruit, strufoli and zeppole. I might be leaving something out of the menu, but Barbara Summa won't.

This was the time of year when the members of my family thought of new Easter outfits. Nanna and my mother would head for Jordan Marsh, Dad and I to Filenes Basement, but for Babbononno, there was only one place where he thought he could get a bargain, Raymond's Department Store. Raymond's was a department store on Washington Street about a block and a half to the left of the Old South Meeting House, as you're heading away from the North End.

My grandfather was friendly with a salesman who had been waiting on him for years. The man escaped Russia about the same time Babbononno landed in America. Evidently he had lived in the North End in the early 1900s, when there was a sizable Jewish population in and around Salem Street, just in from Cross Street, and Babbononno knew the man from that neighborhood.

The first time I met the man (I've forgotten his last name, but Babbononno referred to him as Sammy), was when, as a teenager, my grandfather asked me to bring him to Raymond's to buy an Easter suit. As in the past, we headed for Maverick Station, worked our way to Milk Street Station and wound up at the back end of the Old State House. Within five minutes we were toward Raymond's, Once inside the men's department was just to the right on the first floor. As soon as we entered, we were surrounded by salesmen trying to get our attention. Most had foreign accents, but all were well dressed, suits, starched white shirts and silk neckties.

enquire about the other's family, and then, the conversation regarding a new suit would begin with me just observing the situation. They would begin by reminiscing about having coffee together in the North End when they were young men and both lived in the neighborhood. When the pleasantries were over, the subject of a new suit would take center stage, with both men on a search for something that pleased my grandfather.

I must comment at this point ... Babbononno was four feeteleven inches tall, but in good shape for a man his age. A doctor would comment on his good health many years later and ask my grandfather what he attributed his longevity to. At this point in his life, when Babbononno was in his 90s, he said, "A good wife, good home-made wine, good cognac and good cigars. When the doctor asked about food, my grandfather answered, "Oh ya, that too."

Sammy and Babbononno would find a suit that fit the frame of a short man and my grandfather would refuse alterations by the store's tailor, stating that only Billy the Tailor from White Street in East Boston would make them. To Babbononno this man had magic fingers. I think he was right. Anyway, within a few days, my grandfather was ready for Easter Sunday.

# SHRIMP IN TOMATO SAUCE OVER LINGUINE

14 ounces of crushed tomatoes 1 medium chopped onion

1 large garlic clove chopped (optional) 1/4 cup olive, canola or

1/4 cup olive, canola o vegetable oil

1 teaspoon of dried basil or two fresh basil leaves 1/2 pound fresh medium

3 tablespoons white wine Grated cheese of choice

shrimp

Heat oil in skillet, add chopped onion, garlic (optional), and basil. Simmer until onion is opaque. Garlic should not brown. Add crushed tomatoes and stir thoroughly. Cover and allow the sauce to come to a slow boil. Lower heat and simmer for about twenty minutes. Stir occasionally to prevent sauce from sticking to the bottom of skillet. Add a half-cup of water if mixture appears to be too thick.

Remove outer skin from shrimp. Wash thoroughly and set cleaned shrimp aside in a bowl. When sauce has cooked about twenty minutes, add shrimp, stir and cover. Cook shrimp in sauce until they are pink. Do not overcook shrimp. Cover and remove skillet from heat.

Cook linguine, or pasta of your choice according to the directions on the package. While pasta is cooking, return shrimp-sauce mixture to burner to reheat *slowly*. After a minute, add three tablespoons of white wine to shrimp-sauce mixture. Stir and bring to a *slow* boil. Turn off burner and remove from heat. When pasta is cooked and strained, place in a serving platter and top with tomato sauce and shrimp.

*OPTIONAL:* Adding additional shrimp will give enough shrimp to serve with the pasta and some separately with a fresh green salad. Remaining sauce freezes well.

Serves two.

Blame the know-it-alls who "fixed" things up over the decades.

I have always been an amateur urban planner and my daughter today is an architect. We often debate Boston City Hall. She understands the building better than I ever did.



The last time an inside the park home run was hit by a pitcher, the guy's name was Deacon Phillippe for the Pittsburgh Pirates in 1910. Stottlemyre was one of the all-time best major league pitchers in my younger days as a fan.

Another great who recently passed away at 92 was Don Newcombe who was the workhorse on many old Brooklyn Dodgers teams. The guy who would demand the ball and gave a great effort as long as there was life in that right arm of his. Back in 1950, he actually pitched both ends of a doubleheader. He had a brief career in the old Negro League with the Newark Eagles. Newk was quite dependable taking the ball every fourth day and few were as fierce as Newcombe. He played for the Brooklyn Dodgers from 1949-57, with the L.A. Dodgers

in 1958 when the team headed to California, then with the Reds and finally the Indians when he retired from baseball in 1960.

Overall, he was 149-90 with a 3.56 era. He won the Cy Young in 1956 going 27-7 with a 3.06 ERA and won the MVP Award too. That year he had a season that belonged to a precious few like Ron Guidry in 1978, Tommy Seaver, 1969, Doc Gooden, 1985 or Roger Clemens, 1986.

Four years later (1960) he was out of baseball, a downfall helped when he switched from beer to hard liquor. His fall was so complete that he ended up hocking both his 1955 World Series ring and an expensive watch to make ends meet.

When he passed, he was into his  $30^{\text{th}}$  year of sobriety and was most proud of that accomplishment. He once said, 'I was a strong man and alcohol had driven me to my knees. I was on top of the world and it tried to kill me Until I said 'I won't let you kill me."

Newcombe was the third and final part of Branch Rickey's plan to integrate the Dodgers, following Jackie Robinson in 1947 and Roy Campanella in 1948. It was a very difficult period for Black players as Jim Crow stilled ruled the day. When he returned to the Dodgers after joining the military during the Korean War (1952-53), he and Robinson pressured the owner of the Chase Hotel in St. Luis to allow the Dodgers' black players to stay there. The owner agreed as long as no black players used the hotel swimming pool. Newcombe said, "I guess he was afraid we'd turn the water black but it was a start." Newcombe was not only a winning pitcher but he also liked to finish what he started getting 136 lifetime complete games.

Two great pitchers now up in heaven surely still pitching in the angel league.



#### Jack the Giant Killer

#### Dempsey was at his Best Against Larger Opponents

Recently, I saw a photo of Jack Dempsey and Fred Fulton squaring off before their fight which took place on July 27, 1918, in Harrison, New Jersey. This was just a little less than a year before Dempsey would challenge champion Jess Willard for the title. Fred Fulton had been promised a title fight against Willard and was a 2-to-1 favorite going into the fight with Dempsey.

Looking at the photo you can see Fulton, at 6'4", had a height advantage over Dempsey. He also outweighed him by 20 pounds. Fulton was guaranteed\$12,500.00 for the fight and Dempsey was to get \$5,000.00. The bout was scheduled for eight rounds.


When the bell rang for the opening round Dempsey stepped from this corner in his familiar crouch. Fulton threw a jab which Dempsey slipped and landed a right and a left to Fulton's body. The two then stepped back and Dempsey threw an overhand left at his taller opponent catching him square on the chin. Fulton was out before he hit the canvas. The whole affair took only 23 seconds.

Dempsey would fight seven more times in closing out 1918. He would take a break for the first half of 1919, before stepping in with Jess Willard. In the seven fights he had after defeating Fulton and before fighting Willard, he won all but one. He only loss on his record for that period was in a four round exhibition against Willie Meehan.

Along the way Dempsey took on another giant in Carl Morris. Earlier in the year Dempsey had won via disqualification against Morris when Morris repeatedly fouled him by throwing low blows. Dempsey did not like Morris and wanted to punish him. It should also be noted that Morris stood 6'4" and weighed in at 226 pounds. Dempsey was 35 pounds lighter at 185.

The Morris bout did last longer than the Fulton fight, 37 seconds longer to be exact. Dempsey ended this one with a short left hook to the body. Once again Dempsey showed he had little trouble dispatching fighters much bigger than he was.

While Dempsey was the

was the betting favorite against Morris. It was well known Morris was intimidated by Dempsey and people also knew that Dempsey had been winning handily when Morris fouled out in their fight earlier in the year.

Now Dempsey was to face a man even larger than Fulton and Morris. Heavyweight Champ Jess Willard stood 6'6" and weighed in at 245 pounds. Dempsey weighed 187 for the fight, a difference of 58 pounds. Even though Dempsey had proven he could dismantle the big men, many thought that Willard would be too much for him. In fact, there were those who feared Willard would kill Dempsey.

Dempsey did have his back-

ers though and by fight time the odds had narrowed to 6 to 5 in Willard's favor. Jack Doc Kearns, Dempsey's manager, put down a bet on Dempsey. He wagered \$10,000.00 at 10 To 1 odds that Dempsey would win by a knockout in the first round.

Kearns almost won his bet as Dempsey came out in the first round and floored Jess seven times in that first three minutes. In fact, Willard was on the canvas and being counted out when he was saved by the bell. His seconds climbed in and helped underdog in the Fulton fight, he him back to his feet and led him to his corner where they revived him for the second round.

Willard had taken a savage beating in that first round and it appeared the fight would end soon. However, the champion was game as they come and not only made it through the second round and the third but was not floored again in the fight. His corner finally threw in the towel before the start of the third round when his injuries became too serious for him to continue.

In a year's times Dempsey had fought eight times and during that same period he defeated three men who had huge advantages over him in height and weight. The three giants were only able to last a total of ten minutes and 23 seconds with

Dempsey would go on to fight one more big heavyweight when he defended his title against Luis Angel Firpo, also known as the Wild Bull of the Pampas. Firpo stood 6' 2 1/2" and weighed in at 216 1/2 founds or the fight. Dempsey came in at 192 1/2.

In what is remembered as one of the wildest fights in heavyweight history, Dempsey was knocked out of the ring in the first round. In return, Dempsey floored Firpo seven times in the same round. It was a slugfest and Dempsey was ferocious becoming stronger and more fierce after he was hurt.

In the second round Dempsey floored Firpo three times the final time for the count of ten. Again, Dempsey had made short work of a big opponent. Even though Dempsey was rocked in the first round, he gave Firpo a savage beating.

Now the total time that foes who outweighed Dempsey lasted with him stood at14 minutes and 20 seconds. It looks like having a size advantage over Dempsey was a liability.

Why was it that Jack Dempsey was able to beat such big men, and not only defeat them but to do it with relative ease? Dempsey was extremely fast. He also had great power. On top of that, he knew how to use being smaller to his advantage. In fact, by going into a crouch he would make himself even smaller when facing a larger opponent.

Dempsey was also a master at slipping punches and getting into his foe's blind spot. Contrary to what many believe, Dempsey did not just wade in throwing punches. He feinted and moved in order to get his opponents to lead to him. Once they did, he would slip the punches and counter with his own short punches. You can see him doing that in the Willard fight where he waited for an opening before attacking.

Jack Dempsey is known as a slugger, and he was a fearsome puncher. It should also be remembered that he was also a brilliant ring strategist who was very methodical in his destruction of his opponents.

Dempsey could bang, but he could also box. It is why he is ranked near or at the top of the greatest Heavyweight Champions who ever laced on a pair of gloves.

# HOOPS and HOCKEY in the HUB

ONE SPLENDID SPRING — That's what it was two years ago when something magical took place. There was an atmosphere, an aura, a feeling that just pervaded the TD Garden during the 2016-2017 season and came to a never-to-be-forgotten culmination in the NBA playoffs.

And although basketball is very much a team sport, many would credit the exploits and accomplishments of one player for enabling one of the most exciting playoff runs in the history of the Boston Celtics take place.

He was diminutive in stature, at least by NBA standards, but during those two months of the playoffs, he became one of the tallest to walk among us.

Only 5-9, he displayed a smile that was not only genuine, but also infectious and contagious. At times, it seemed like not only everyone throughout the region was smiling with Isaiah Thomas.

And why not? When he flashed that ear-to-ear grin in postgame interview situations, it seemed that he generated so much electricity that you could have shut the lights off in the room.

For just a brief period of time — on the night after St. Patrick's Day — those moments were recalled and brought to the fore as Thomas returned to the Garden as a member of the Cleveland Cavaliers.

There was a video tribute shown on the Jumbotron that is suspended over center court followed by a very appreciative standing ovation by the Garden crowd, who once again showered the favored one with a positive outpouring of elation and emotion.

Isaiah Thomas was one flashy player during that memorable spring who obviously enjoyed what he was doing — not necessarily because he did it well (which he did) but because he liked the experience of creating the moves that enabled him to play so superbly. It's been said that "smile and the whole world smiles with you." In the Garden during that special time it most certainly did.

He was maneuverability in motion, a maker of memorable plays - ones that evoked "did-you-just-see-that" responses from those privileged to see those magical moments.

Thomas was the last player selected in the 2011 NBA Draft. The one who would go on to create those everlasting moments during that unforgettable spring was passed over by almost everyone until the Sacramento Kings used the final pick on draft night to select the one who had played three seasons at the University of Washington. Now he was to travel south and join the team that plays in the state capital of California.

In those years before coming to the Celtics, he would play with both Sacramento and Phoenix before finally arriving in the Hub in mid-February of 2015. Because he was a member of the Celtics for only about 27 months, one can't expect that his number will ever be retired to the rafters.

No, Thomas is not numbered among the Celtics legends who periodically return to the Garden to bask in the afterglow of their storied careers after winning a number of NBA championship rings. All of them played for the Celtics over the course of numerous seasons and often set standards of longevity as well as basketball excellence.

But perhaps, just perhaps, Thomas possesses a distinctive quality that can't be acquired simply by being victorious.

A number of years ago, when we covered a lot more professional golf tournaments than we do now, it became apparent to us that there was a difference between how stars Jack Nicklaus and Arnold Palmer were received by those who followed the game that is played over lush green fairways.

Nicklaus, of course, had won many major tournaments over a lengthy career and was respected for those accomplishments. Palmer had done essentially the same thing. Yes, he also was respected, but he possessed an additional quality that was bestowed upon him. In addition to being respected, he was beloved — an attribute Nicklaus did not possess.

And that is perhaps what separates Thomas from many of the great Celtics players of the past. Those men who played in prior decades are all respected for what they achieved on the parquet.

But Thomas has that additional quality. It was so apparent during the time set aside for the video tribute — which took place near the end of the first quarter. Thomas is not only respected in Boston. He is beloved

In that splendid spring of two years ago, Thomas went beyond being exceptional. He became inspirational as he led the C's to a first round series victory over the Chicago Bulls in the immediate aftermath of the passing of his sister.

During the following series against Washington, he scored 53 points during a game 2 victory over the Wizards. He also led the way with 29 tallies and 12 assists in a crucial Game 7 triumph that propelled the Celtics forward to an Eastern Conference Finals matchup against LeBron James and the Cleveland Cavaliers.

It was then that physical problems began to slow Thomas. After losing the first two games to the Cavs, Thomas was removed from the rest of the playoffs because of a hip injury.

It would later be revealed that the situation with the hip had been an ongoing one. Thus, many of his memorable moments in the Hub may have unfolded with his hip not 100 percent.

Traded to the Cavs over the summer in a controversial move by Celts GM Danny Ainge, Thomas would not play for Cleveland until early January and would be traded to the L.A. Lakers in February 2018. One month later, he was out for the rest of the season because of hip surgery.

During the summer of 2018, he was signed to a one-year deal by the Denver Nuggets. But he would not play until February 13 about a month before coming to the Garden.

Some now say that his playing days are winding down. Perhaps. But there will always be that one splendid spring. Special for the way it unfolded and special because of the one who made it happen — the one who is beloved.
