#### CALIGULA THE SEXOLOGIST

Caligula often boasted that his own mother, Agrippina, was born in incest, which Augustus had committed with a daughter named Julia.

Caligula himself lived in constant incest with all of his sisters, and violated an older sister Drusilla when he was still a minor. Years later he took Drusilla away from her lawful husband and forced her to live with him as his wife. When she died, he declared a national season of public mourning, and made it a capital offense to laugh, bathe, or even to dine in company with one's own family. He did not love the rest of his sisters with so great an affection, and often prostituted them to his favorites. Later, when the occasion suited his purpose, he condemned them as adulteresses.

He attended the marriage of Livia Orestilla to his good friend Gaius Piso. He took a fancy to the bride and simply ordered that she be taken off to his palace. A few days later he divorced from Piso.

No woman of rank was immune to his advances. His general approach was to invite both husband and wife to dine with him and other couples at the palace. As

they passed his dining couch he would look them over very critically and very purposefully. During the balance of the evening, as often as fancy took him, he would leave the room, sending for the female who pleased him best, and then return soon with compliments or even lewd comments regarding her attributes or her performance.

During one phase of his reign as emperor he was in need of more money, so he supported public brothels in the palace, setting aside a number of rooms, furnishing them to suit the grandeur of the palace and, ordering matrons and freeborn youths to stand exposed. He then sent his servants out to the parks and basilicas to invite men, young and old, to come and enjoy themselves. He even loaned money, at high interest rates, to those eager beavers who were temporarily without funds. He also set up a battery of clerks for keeping the records. I guess this made him a genuine, first class, down-to-earth, "Latin Leno.

Caligula had no respect for his own chastity, nor for that of anyone else. It was claimed that he had unnatural relations with men,

boys, prisoners, or freemen, and didn't seem to draw the line anywhere unless it was on a pair of pajamas. A young man from a wealthy family publicly confessed that he had violated the emperor during constant companionship and had worn himself out in the process.

In the meantime he had a notorious passion for a concubine named Pyrallis (not to be confused with paralysis), and we must not lose sight of the fact that his mistress Melonia Caesonia was still active and very much on the scene. He loved her but often exhibited her to his friends "al fresco." He threatened to resort to torture, if necessary, if she would not explain why he loved her so passionately, yet whenever he kissed her neck he would say, "Off comes this beautiful head whenever I give the

Melonia Caesonia, as you may recall from a previous column, was the one who gave him the love potion that started "all this jazz." Slipping this cat a love potion was like carrying coals to Newcastle. What he really needed was a jug of G.I. coffee and a cold shower three times a day.

#### Come Si Dice "Born on the Fourth of July" in Italiano?

On March 17, 2011, the Republic of Italy officially celebrated Italy's 150th Anniversary with a series of activities across the nation of Italy, in Washington, D.C., here in Boston, and throughout the United States, to highlight the unique partnership between Italy and the United States. As long-time allies, both nations share a common set of values, historical ties, and cultural relations that span multiple centuries.

Freshly back from a Washington trip, I decided to look into how our national government is honoring the birthday of modern united Italy. Here's what I found

Bills have been filed in both houses of Congress (H.R.742 and S.369) to award posthumously a Congressional Gold Medal to Giuseppe Garibaldi and to Recognize the Republic of Italy on the 150th Anniversary of its Unification. As the legislative texts point out, America has many reasons to celebrate Garibaldi and the Risorgimento (the Resurgence of a united Italian nation-state).

Giuseppe Garibaldi was born on the Fourth of July in 1807. In the early 1850s he lived in the United States and even applied for U.S. citizenship before returning to Italy as a commander in the Risorgimento that led to the unification of Italy. The Risorgimento's progress was eagerly followed in a United States ideologically opposed to European dynastic "tyranny." The victory was viewed in this country as a powerful vindication of the right of the individual to political self-determination.

Giuseppe Garibaldi, who led Italy to unification in 1861, was offered a command as Major General in the Union Army by President Abraham Lincoln. Garibaldi declined, but to honor him, the 39th New York Infantry was known as 'The Garibaldi Guard'. About 150 of its 850 men were Italian. It fought in the Union Army from Bull Run to Appomattox.

The sponsors in the House of Representatives are Republicans Michael Grimm and Peter King of New York, and Democrat Bill Pascrell of New Jersey. In the Senate Republican Michael Enzi of Wyoming is sponsoring the bill.

David Trumbull is the chairman of the Boston Ward Three Republican Committee. Boston's Ward Three includes the North End, West End, part of Beacon Hill, downtown, waterfront, Chinatown, and part of the South End.

#### FDR — NO COLLECTIVE BARGAINING

In his letter to the Resolution of Federation of Federal Employees against Strikes in Federal Service, dated August 16, 1937, the iconic stalwart of the Democratic Party Franklin D. Roosevelt made the following declaration relative to collective bargaining and I quote:

"All Government employees should realize that the process of collective bargaining, as usually understood, cannot be transplanted into the public service. It has its distinct and insurmountable limitations when applied to public personnel management. The very nature and purpose of Government make it impossible for administrative officials to represent fully or to bind the employer in mutual discussions with Government employee organizations. The employer is the whole people, who speak by means of laws enacted by their representatives in Congress. Accordingly, administrative officials and employees alike are governed and guided, and in many instances restricted, by law, which establish policies, procedures, or rules in personnel

In his letter, it is clear Roosevelt did not consider denying workers bargaining rights as an assault to their

"There is a crisis in state and municipal finance. That much is clear. What hasn't been fully understood is that the fate of the Democratic Party is bound up in the resolution of that crisis."

# ROCCO J. ANTONELLI

Rocco J. Antonelli passed away on March 8, 2011 after a brief illness. He was 88. Rocco was a well respected, nationally known C.P.A with a distinguished career of public service. He was president of the National Society of Public Accountants which later chose him as Accountant of the Decade. He served on the Commonwealth of Massachusetts Board of Public Accountants under three governors.

He authored the National Regulatory Accountancy Laws and was elected Middlesex County Treasurer. He was appointed Treasurer of the City of Somerville.

A lifelong basketball enthusiast, he was a star player for Tufts University. The school named the lobby at the University gym after him. Rocco had a tryout for the Boston Celtics when he returned from the Navy and has counted many of the Celtics greats among his nearest and dearest friends.

Rocco attended St. Joseph's in Somerville and graduated from Somerville High School with Honors. There, he received the outstanding Scholar and Athlete Award as a basketball player. He graduated from Tufts University Magna Cum Laude but his studies were interrupted when he entered the U.S. Navy Reserve on Pearl Harbor Day, December 7, 1942. His naval officer training was conducted primarily at Columbia University where he was commissioned as an ensign in 1944.

As an active duty naval officer he was assigned to the USS Wilkes Barre CL 103. He commanded the ship combat information center. His ship participated in the Philippine Liberation, Iwo Jima, Okinawa and Tokyo Battles. Rocco was highly decorated for bravery Malden.



with four bronze stars. Lt. Sg. Antonelli was present at the signing of the surrender of the Japanese on September 2, 1945 in Tokyo Bay.

One night on the "Willie B", the junior officers gathered and discussed their futures after the war. Rocco, who was admired by his contemporaries, coaxed into considering an MBA program and a career in business. After the war, he applied to Harvard Business

School and was accepted, graduating with honors. His professional career was exemplary. He began his career working for the Rockefeller Companies. He was the assistant to the president of the Algonquin Gas Transmission Company and was personally responsible for the natural gas pipeline that we have today in New England. Rocco then founded R.J. Antonelli and company, accountants and auditors in Somerville. He later relocated to Woburn.

Rocco is survived by three sons, Rocco J. Jr., of Rockport, Massachusetts; Robert B. of Somerville, Massachusetts and Stephen of Leominster, Massachusetts; a brother Rudy J. of Las Vegas, Nevada and a sister Mary M. of Somerville, Massachusetts. He was the son of the late Rocco H. and Rose J. (Desimone) Antonelli. He was the brother of the late Ralph R. of Somerville, Massachusetts; Jean T. Stanger of West Virginia and Frank A. of Florida. He had many nieces and nephews. He was married to the late Nancy Burke and Dorothy Allison.

#### JAPAN EARTHQUAKE-TSUNAMI KILLS THOUSANDS

shore triggered a huge tsunami that hit Japan's eastern coast with death tolls expected to rise sharply. Flooding and fires were widespread. The government ordered a damaged nuclear plant to vent radiation, which has surged to 1,000 times normal. Waves reached U.S. shores but caused minor damage. Most people were killed by the waves that followed the quake. The strongest ever recorded in Japan.

Retail sales were hot in February, rising 1%. Consumer confidence has tumbled. Retail sales rose in February by the most in four months on broad-based demand, the Commerce Department reported. Soaring gas prices impact on consumer spending raises concerns about consumer spending. Fears that violence in Libya and elsewhere that crude prices which have soared above \$100/barrel. The US price for a gallon of gasoline is \$3.55/gallon versus \$3.15, a month ago. Retail sales were up 8.9% in February. The best since July 2005. With gas prices soaring, the latest poll found majorities favoring a wide range of drilling with support higher than when oil peaked at \$1.42/gallon in 2008. #### Death by Red Line Train

Recently, I read a small he received his wish. newspaper story concerning a nameless man who was killed by an on-coming Red Line train at the Central Square station. According to witness statements to the MBTA police, the guy allegedly lowered himself down from the platform into the track pit as a train was approaching the station. You hear about these suicides much too often. I still remember the aftermath of a suicide at old Northampton station back when I was a kid living in the South End. People gathered around Washington Street watching emergency folks respond to this tragedy. I remember watching firefighters carrying the victim on a stretcher down the long stairway to the street below. I wondered then as a 10-year-old why someone would so violently choose to end his life. I assumed then that it was a guy but I never found out either way.

However, I was bothered by the gawkers who seemed attracted to watching it all like some TV show. I shouldn't say this but I probably was gawking too. Looking back on that event and reading of an endless string of additional suicides by train, I'm not a gawker anymore. Nor would I like to witness such a tragedy in the making. When it comes to complete hopelessness, the more things change, the more they stay the same.

I have worked in the mental health profession since 1972 and sadly I have known many folks who apparently sought a quick and violent end to their internal miseries. What leads folks to decide their own fates? Are they in that much pain that jumping in front of oncoming trains or traffic, or taking a dive off a tall building seems like the perfect exit from their agony? What are their last thoughts before CRASH happens. This individual who reportedly lowered himself off a platform in front of an on-coming MBTA at Northampton station. I train left no room for possible both understand better and rescue. He meant to die and still not at all.

Many folks who walk among us can show happy faces while living with pain and their heads crowded with voices making them often wish they would never wake up. Did a person wake up on Tuesday, February 22 and decided to make his way over to Central Square station to check out of this life? Did he make his bed that morning and have his last meal? Did he know when he arrived at the T station that he wasn't taking the train? Or did the voices within his head start screaming at him while waiting for his train?

Our lives are often more fragile than we think. Often under our strong exteriors, we mask our deepest fears. Hiding them and wanting to be better than we think we are. We play pretend. Smiling on the outside and crying inside the dark walls of our emotions. We used to say only crazy people kill themselves. When I was younger, folks who killed themselves were denied a Catholic funeral Mass because they ended life in mortal sin. Folks who kill themselves aren't sinning and are not necessarily that crazy either. People you least suspect sometimes do themselves in and we never know whv.

In over 38 years, I have known 31 or so people kill themselves. It goes with the territory of working in this field of mine. I mourn for those I knew and hope God grants them the happiness they sought here on Earth. Once I even saved someone from a suicide attempt. About 15 years later, that same woman met me again and thanked me for saving both her life and her future. I laughed and told her, "No one ever dies on my watch because there's too much paper work involved. She laughed. I laughed. She walked away with her future still in her living hands.



#### The insurance company won this one.

BOAZOVA vs. SAFETY INSURANCE CO. **Appeals Court of Massachusetts** Decided December 16, 2010

The plaintiff had a homeowner insurance policy. Boazova bought a house in Arlington for which she purchased homeowner's insurance from the defendant, Safety Insurance Company. The policy remained in force, modified from time to time, at all times thereafter. In August, 2005, while renovating her kitchen, Boazova discovered that moisture had caused the sill and adjoining floor joists and wall studs to rot.


According to Boazova's own expert, "[t]he cause of the rotted sill plate, wall studs and floor joists is the concrete patio that was poured directly against the house. This permitted moisture to migrate to the top of the foundation,

rotting the clapboard siding, the 1x exterior, and eventually the sill plate, floor joists, and wall studs." He further or repeated seepage or leakopined that "[t]he current situation is the result of rot and deterioration over an extended period of time," and that the rot and deterioration were hidden. He concluded that "[w]ere it not for the water, the structure would still be intact."

Boazova filed a claim under his policy. The insurance company denied the claim and the homeowner sued. The court agreed that coverage did not apply. The insurance policy provides: "We insure against risk of direct loss to property described in coverages A and B only if that loss is a physical loss to property. We do not insure, however, for loss:

"2. Caused by: (9) Constant age of water or the presence or condensation of humidity, moisture or vapor, over a period of weeks, months or years unless such seepage or leakage of water or the presence or condensation of humidity, moisture or vapor and the resulting damage is unknown to all "insureds" and is hidden within the walls or ceilings or beneath the floors or above the ceilings of a structure."

The Court decided that the insurer was not liable to pay this claim. Know what's in your policy. How many people know what is covered under their policy?

Our stately noted musicologist proudly reports Gene Krupa, the famous big band drummer's drum set is now on permanent display at the prestigious Smithsonian National Museum of American History. At the Smithsonian, the Krupa will join a set used by Buddy Rich. In brief, Eugene Bertram Krupa was born in Chicago in 1909 and began playing drums professionally in the mid-1920s: he was soon working with such greats as bandleaders Glenn Miller and Eddie Condon. After he joined the Benny Goodman band in 1934, Krupa — with his musicianship and good looks — became a major attraction. At a groundbreaking Benny Goodman concert in Carnegie Hall on January 16, 1938, Krupa's sensational driving beat behind "Sing Sing Sing"— and his reprise of the number in the movie Hollywood Hotel defined him as the very model of a modern drummer. Krupa's fame had an unhappy consequence. "Krupa insisted on having drums in the forefront of the band. Benny Goodman wanted the audience's focus to be on him." With certain numbers, Gene stole Benny's thunder; in the end that cost him his job. After leaving Goodman, Krupa formed his own band and became a frequent performer on television. He died in 1973 at age 64.

Gee, we were one of the many youngsters who became drummers and of course, Gene Krupa was our inspiration. We all enjoyed swing away and taking an occasional "Sing Sing Sing" drum solo.

#### SPLIT GREEN PEA SOUP

1 cup split green peas 1 medium onion chopped (optional)

1 quart of water 1 cup small elbow or shell macaroni

2 tablespoons of canola or olive oil

Ham pieces, ham hock, or ham bone are excellent additions to this recipe.

Wash split peas and place in water in a two-quart pan. Bring water to boil and add chopped onion, ham pieces, ham hock, or ham bone. Cook slowly, partially covered, to prevent overflow of liquids. Check frequently to prevent mixture from sticking or burning. When all split peas have dissolved, add oil and stir. Cover pot, shut burner, and move from

Following directions on the pasta package, cook small elbow or small shell macaroni to tenderness desired. Mix pasta with pea soup and serve together with ham pieces or separately.

Pea soup can be frozen. Defrost first, before heating for use. Serves two.

NOTE: During the Depression, many of my relatives served Pea Soup often, as did my mother. This economical, nutritious, and easy-to-prepare meal was especially welcome on our supper table during the cold winter months.

the splendid public education. For the first time in decades, Americans have been asked to look under the government unions that have long been on a collision course with taxpayers. Though it arrived in Madison first, this crack-up was inevitable.



# Nanna & Babbononno

A Nostalgic Remembrance



and was home for a week with either the measles or chicken pox, I'm not sure. As I recuperated, I felt better and was out of bed most of the time. As there was a period of semi-quarantine back then, Mom didn't dare let me out of the house. As a result. I was in the kitchen most of the time watching Nanna get the dinner menu ready. There was only so much playing with toys and reading books that I could stand before becoming bored and watching Nanna afforded me whatever cooking skills I learned.

My grandmother had learned how to cook back on the family farm in Avellino watching her mother make the daily meals, but being unable to read, she only knew portions by what we might call the trial and error method. After several formative years of practice, Nanna became a good cook. As I watched her cook a generation later, she could only give me proportions and amounts by saying, "A pinch of this, a spoon of that," and that was the way I learned. Of course, seeing I was the first born male in an Italian family, I was the second coming and whatever I wanted was granted.

During my convalescence, I wanted to try my hand at cooking. With Nanna's guidance, I set out to explore my culinary skills. Today, we buy everything pre-made: pasta, gravy, sausages, meatballs, canned or frozen vegetables, pre-packaged lettuce or salad ingredients, salad dressing ... you name it, it comes wrapped, bottled, canned, packaged, frozen, dehydrated or pre-mixed from a supermarket. Nanna would have none of this. She made everything from scratch.

That first day that I felt well enough to stay with her in the kitchen was a Monday. Dinner was to be chicken soup with escarole and pastina, roasted chicken, string beans sautéed in garlic and oil, salad and dessert. She began by showing me meats which included meathow to make the chicken balls and sausages. Of broth by boiling a chicken. course she had to taste When the soup was ready, she would have kept parts of the bird in the pot, the neck, the feet, the heart, the gizzard and other organs. The rest of the chicken was left out on the table to be picked at for lunch. For dinner, she cleaned the other chickens, stuffed them with home-

**OCCASIONS** 

I was in grammar school made egg stuffing and baked them in the oven. These were not chickens purchased on a disposable tray and covered with plastic wrap. They were purchased live at a slaughterhouse and killed, cleaned and dressed just for her. The vegetables were fresh, having been purchased from a green grocer. As a result, I learned how to cook a Monday chicken.

> By Friday, I knew how to cook lamb chops, pork chops, stuffed veal, all with an array of vegetables and salad. Friday was fish day. If you were Catholic, you weren't allowed to eat meat on Friday. This meant that either Nanna or Mom would head to the fish store and pick up the makings of a Friday night dinner. Faber's Fish Market was a fifteen minute walk down the Brooks Street Hill from Eutaw Street. On that Friday, I learned how to clean and prepare smelts for the first course. The second fish might be cod and Nanna made it two or three ways, plain baked for Babbononno, broiled with breadcrumbs and seasoning for the rest of the family and a few pieces to flavor the linguini which she would make aglio-olio (garlic and oil).

> On Saturday, it was steak, but Nanna taught me how to make steak pizziola, a dish I still love to this day. The highlight of the week was Sunday dinner. Back then, regardless of what was going on it was family Sunday dinner with Nanna and Babbononno.

That Sunday, I got up at about 5:00 am with Nanna. She was going to show me how to make gravy, the sauce that was a traditional necessity for the pasta and meat courses. She would start by searing spare ribs and pieces of pork in olive oil and garlic. Then she would add tomatoes, and later, maybe, a can of tomato paste, but this was after she had added in a pinch of basil, a pinch of oregano, a pinch of mint, par cooked ground beef, and later her par cooked everything every few minutes to make sure they weren't any mistakes. When this large pan of gravy was ready to just simmer, it was time to make the pasta.

Babbononno had a machinist friend make a stainless steel rolling pin with V shaped grooves sometime

back before I was born and Nanna used it every time she made spaghetti. She didn't buy a box of spaghetti that is hard and dry and might have been in the cardboard box for months. She made her pasta fresh ... from scratch. I watched her pour out a mound of King Arthur flour, make a hole in the middle, crack in several eggs, beat them, add semolina, salt and maybe a bit of yeast to taste, and roll the entire mix until she had the dough for the pasta. Then she let it stand on a dish under a damp dish cloth, which she called a mappina, and when it had risen and was ready to be rolled out, she dusted her cutting board with flour, rolled a piece of dough until it was a flat circle and using Babbononno's invention, cut it

into strips of spaghetti. Later, she would choose which vegetables she would add in to her dinner, and sauté them with oil and garlic. When all was said and done, the feast would be ready for the table, and of course, had to be accompanied by a couple of bottles of Zi'Antonio's best homemade red wine. Zio Antonio was Nanna's oldest brother and Babbononno's best friend. According to Babbononno, he was the best wine maker in either East Boston or the North End. (I remember his wine. It was THAT good — and I'm not a wine lover.)

That was the way I learned to cook as a kid, watching my grandmother prepare fresh food adding in a pinch of this, a pinch of that. Mom learned Nanna's secrets a generation before I was born, but even though she was a good cook, Nanna was a great cook.

That was many years ago and now I'm the old timer in the family. Periodically, when I have time, I will cook, but I usually don't have the time. With our schedules, it's easier to get take-out or head to a local inexpensive restaurant and have them do the dirty work. In spite of the time restrictions and crazy schedules, I still like home cooked Italian food.

My son, John seems to have picked up of the desire to cook and he seems to have inherited the talent to make gravy and prepare either fish or meat the way I like them.

Nanna and Babbononno would be proud of him and his abilities in the kitchen, but they passed away long before he was born. My father would watch John when he was a kid trying to cook in our kitchen, and say, "That kid's going to be a chip off the old block." Dad knew how to cook, too, and saw John's potential. If Dad was here today, I would take his word for it. GOD BLESS **AMERICA**

Things in Italy haven't been that bad, despite the paralyzing political crisis that has gradually deteriorated to the point of causing problems to Silvio Berlusconi's government (majority), with the Premier increasingly in judicial troubles, from the days of 'Tangentopoli' investigations (years earlier) mainly on corruption charges. Europe is economically resurging from a crisis that seems increasingly a thing of the past, particularly in Germany whose economy has bounced back so much so that unemployment is nearly gone. The same cannot be said of the United States where, sadly, the economy is still struggling while unemployment continues to stay high. The world seems to have split. To the economic crisis of a few nations, namely in Europe and in the Americas, we discover an economic boom occurring in a few nations whose economies continue to grow successfully, such as in Brazil, India, Taiwan, Indonesia, Vietnam, Hong Kong, Singapore, Norway, South Korea, Australia, New Zealand, and above all in China where the economy has kept growing a lot more than in any other nation. Multinational corporations are reaping large profits in Asia more than in Europe or in the United States. The monetary stability, both in China and in Brazil, attracts the investing interests of foreign corporations, be they Italian or US.

We hope to report better economic news affecting Italy and the United States in the future.

# Big Dig Firm Hired for MBTA Project

We all remember Parsons Brinckerhoff. Here in Boston, it is best-known for its terrific role in overseeing the Big Dig Project. You remember the Big Dig, right? The delays, cost overruns and of course that 2006 ceiling collapse that killed a Jamaica Plain woman? The MBTA has hired this company as a subcontractor on an \$8.7 million deal to help the Commonwealth manage its \$115 million purchase of 20 new locomotives to be built in Idaho. 

#### HOOPS and HOCKEY in the HUB

Regardless of the results of the Hockey East Tournament, one thing is certain defending national champion Boston College is going to the Big Dance once again.

BC, which advanced to the Hockey East Tournament for the seventh straight season, will take the first steps toward seeking its second consecutive national title and its third championship in the last four years when the NCAA regionals are played the weekend of March 25-27.

"We have had a good body of work, if you look back on it," said veteran BC coach Jerry York on the eve of the Hockey East Championship. "We are extremely proud of that. I think we were 4-3 at one time (early in the season) or 5-3 but you could tell we had a lot of good people and good character in the locker room."

BC, which earned the top seed in the Hockey East event, was the Number 1 ranked team in the country (just behind North Dakota), with an excellent 28-7-1 overall record and a 20-6-1 regular season conference record, making the Eagles the first team to capture 20 Hockey East wins in conference play. Not surprisingly York, who is in his 39<sup>th</sup> season as a college coach (his 17th at BC) feels that record is a reflection of his team having improved over the course of the season.

"I think we have gotten better as we have gone through the season," noted the coach, who owns an enviable 28-8 record in the NCAA Tournament while behind the bench at BC. "The NCAA did a survey on the age of teams and we are the youngest team in college hockey as far as chronological age. Ourselves, BU and Michigan are the three youngest teams."

York sees somewhat of an irony in that since because he has a veteran core — the team's senior class captured its 99th and 100th victories in the Eagles' two victories over UMass-Amherst in the Hockey East quarterfinal round — complemented by a newer set of faces.

"Everyone talks about how we are veterans," he noted. "And we really are because we have played in a lot of big games. But we are so young and there was a chance to grow as a team this year because of our age. I think we have responded to that and have gotten better."

York cited senior goal-tender John Muse of Falmouth, who came into the Hockey East semifinals tied for the school record in career saves with 3,605 — as a veteran who has led by example.

"John Muse has really been the catalyst for our team, said York of the netminder who came in as a freshman after Cory Schneider turned pro and proceeded to backstop the Eagles to the 2008 National Championship. He owns a

perfect 8-0 career record in NCAA Tournament play.

This year Muse started 29 regular season games and ranked fifth nationally in save percentage (.927) and six nationally in goals against average (2.08). He had 30 or more saves in nine games. "I think he has had an outstanding career but this year — his fourth year with us — has been his best year by far."

In addition, York praised the squad's two other seniors — Brian Gibbons and captain Joe Whitney. Both have reached the 100 career assists threshold, making them two of just 15 players in school history to accomplish the feat. In addition, Gibbons has scored four shorthanded goals (BC has 13 on the season) and has assisted on five others, meaning he has been involved in nine of those 13 scores. They lead a team that lost only one home game all season and made The Heights a popular place, with average home attendance swelling to 6,783 per game, the highest average in Kelley Rink's 23-year history.

York also said his team has the capability to contend in any type of hockey game, either one dominated by an offensive display or a defensive lockdown.

"I think we are capable of playing in either one. We can play solid defense and have proven that over the year. But if it becomes a game where you need six goals to win I think we have enough firepower to do that. Once that puck drops you can talk all you want about how things are going to materialize but things happen in hockey more so than in other sports as far as how the game is going to go. We are prepared for both types of games, though we would like to play better defensively."

The contributions of special teams have also made an impact this season. BC concluded the regular season ranked third in the nation in penalty kill rate at 87.6 percent. On the other side of the coin, the Eagles led Hockey East and ranked sixth nationally in power play success, scoring 38 goals on 162 power play opportunities - a 23.5 percent rate. In addition, the team finished the regular season ranked third in the nation in goals per game with a 3.85 average while ranking tied for fourth nationally in average fewest goals allowed (2.24 per

So, once again, the Eagles are a complete team, an elite squad about to face other elite teams in a quest for the 2011 national championship that will be decided on April 9 in St. Paul, Minnesota. BC has all the tools to accomplish the task once again, a team well balanced and ready to go. By the time the Masters Golf Tournament starts, we'll know if the ultimate goal has been attained.
