Tom Brady, You Are No Patriot, and I Ain't Talking Football

Tom Brady has launched a new athletic clothing brand, but if you thought that might mean new jobs for American textile and apparel workers, your hopes are about to get deflated.

According to his website (which I will not name, least I give him free publicity), "We currently make our goods between New York, Mexico, Portugal, Lithuania, Vietnam, and China." As far as any products made in New York, it is impossible to tell from his website, because, in the case of individual articles, they all lack the federally mandated disclosure of whether they are domestic or imported. Given the current interest in Americamade goods, it is fair to assume that were they made in America, he'd be highlighting that. So, it looks like little, if any is actually made in New York State. The site is also not in compliance with fiber content labeling law.

It's not like these articles cannot be made in the U.S. Its athletic wear, of the same sort the U.S. Department of Defense acquires for our warfighters — and does so using 100% American-made sourcing. Using publicly available sources I confirmed that the U.S. Department of Defense, in one year alone, 2021, acquired similar garments made in Alabama,

California, Florida, Georgia, Michigan, Mississippi, New York, Tennessee, Texas, and Puerto Rico (several manufacturers). Furthermore, nearly all, if not all, states have sheltered workshops for the blind or otherwise disabled that provide these articles. Even here in Massachusetts JA Apparel Corp, New Bedford, gets military contracts for apparel comparable to some of the Brady line.

And at his prices — \$75 for a T-Shirt and \$175 for a hoodie — he certainly cannot claim that living wages paid to Americans have forced him to go off-shore. This is pure greed, and disregard for American workers, and in the cases of China and Vietnam, disregard for the rights of the workers in other nations.

According to Human Rights Watch:

"Vietnam's human rights record remains dire in all areas. The Communist Party maintains a monopoly on political power and allows no challenge to its leadership. Basic rights, including freedom of speech, opinion, press, association, and religion, are restricted. Rights activists and bloggers face harassment, intimidation, physical assault, and imprisonment ... workers are not allowed to form independent unions. The police use torture and beatings

to extract confessions. The criminal justice system lacks independence."

The same group ways of China:

"China's one-party authoritarian state under the Chinese Communist Party systemically curbs fundamental rights. Under President Xi Jinping, in power since 2013, the government has deepened repression at home and sought to muzzle critics abroad. It has arbitrarily detained human rights defenders and lawyers, tightened control over civil society, media, and the internet, and deployed invasive mass surveillance technology. The government imposes particularly heavyhanded control in the ethnic minority regions of Xinjiang and Tibet. The government's cultural persecution and arbitrary detention of a million Uyghurs and other Turkic Muslims since 2017 constitute crimes against humanity.

Brady is not the only celebrity athlete who needs to be called out. Several American professional ball players refuse to stand for the American National Anthem, because 150 years ago we tolerated slavery, yet they have multi-million-dollar promotional contracts with sneaker companies that use **slave labor**

Stop Using LuSys Laboratories COVID-19 Tests: FDA Safety Communication

The U.S. Food and Drug Administration (FDA) is warning people to stop using the LuSys Laboratories COVID-19 Antigen Test (Nasal/Saliva) and the LuSys Laboratories COVID-19 IgG/IgM Antibody Test. The performance of these tests has not been adequately established and the FDA believes there is likely a high risk of false results when using these tests. Neither test has been authorized, cleared, or approved by the FDA for distribution or use in the United States.

The LuSys Laboratories COVID-19 Antigen Tests (Nasal/Saliva) and COVID-19 IgG/IgM Antibody Tests may also be sold under the company names Luscient Diagnostics or Vivera Pharmaceuticals, or with the trade name EagleDx. The FDA believes that these tests were distributed for use in laboratories or for at-home testing.



Recommendations for Test Users, Caregivers, and Health Care Personnel

Stop using LuSys Laboratories COVID-19 Antigen Tests (Nasal/ Saliva) and COVID-19 IgG/IgM Antibody Tests.

COVID-19 Antigen Test (Nasal/Saliva)

- Test users and caregivers:
 Talk to your health care provider if you were tested with the LuSys Laboratories COVID-19
 Antigen Test (Nasal/Saliva) and you have concerns about your test results.
- Health care personnel: If the antigen test was given less than two weeks ago, consider retesting your patients using a

different SARS-CoV-2 diagnostic test if you suspect an inaccurate result. If testing was performed more than two weeks ago and there is no reason to suspect current SARS-CoV-2 infection, it is not necessary to retest.

• Report any problems you experience with the LuSys Laboratories COVID-19 Antigen Tests (Nasal/Saliva) to the FDA, including suspected false results. See Reporting Problems with Your Test.



Stirpe Nostra

Castel Sant' Angelo, Rome, Italy

The Emperor Hadrian was born in 76 A.D. His full name was Publius Aelius Hadrianus. He filled high offices during the reigns of Nerva and Trajan and was proclaimed emperor by the army and the Roman Senate after Trajan's death. He ruled as emperor from 117 to 138 A.D.

History is still uncertain about Hadrian's formal education and training. Some reports credit him with being a architect and others claim that he was an extremely talented amateur. Ancient writers say he was accomplished in "arithmetic, geometry, painting and art." He was also a student of Greek art, architecture and civilization, and was responsible for sending many young men to Athens to study.

Hadrian was one of the most cultured and gifted figures in all of ancient Roman history, but he was not without vanity and temper. As a young man, he was snubbed by the celebrated Greek architect Apollodorus of Damascus. Later as emperor, he was again severely criticized by the same architect on the design of a temple. This was a bit too much for Hadrian

and it became the last critique ever made by the tactless Apollodorus.

Hadrian was also an ardent traveler and this is reflected in the design of his Villa at Tivoli, his ultimate artistic achievement and one which inspired many world famous structures. He also influenced the design for many new temples and the rebuilding of others.

Hadrian died a slow and painful death in 138 A.D. and was not widely mourned. He was loved by few, but feared by many. Probably the most famous of all ancient Roman tombs is the mausoleum that Hadrian designed for himself and the members of his family. He started construction on the tomb in 130 A.D. It was completed a year after his death by Antoninus Pius, his successor. The structure is almost 300 feet wide and over 150 feet high. The exterior face of the entire structure, including a cone shaped roof, was faced with white marble. There were beautiful marble statues around the roof and a bronze quadrigae at the summit. A central chamber held the stone coffin of Hadrian;

its base was later destroyed by fire and the lid is now used as a fountain in the Baptistry of St. Peter's.

Pope Gregory I was walking barefooted as he was conducting a penitential procession through the streets of Rome to pray for the cessation of a plague which was ravaging the city in 590 A.D., when he beheld a vision of Michael the Archangel sheathing his sword while standing on the uppermost part of the mausoleum. This vision coincided with the end of the plague and the structure has been called Castel Sant'Angelo since that time. A covered passageway from the tomb to the Vatican was built by Pope Nicholas III in 1277. This permitted the tomb to be used by future Popes as a place of safety when the city was under siege.

been used by the party in power as a stronghold. At least one Pope and many others were murdered within its walls. Antonio da Sangallo designed the octagonal dungeons which were added to the corners of the lower floors, while Pope Julius II added the front loggia and Pope Leo X erected a Chapel. Pope Clement X remained in safety there during a seven-month siege. The tomb has been plundered by the Vandals and the Goths, and its beautiful statues were used as missiles from the parapets. It has been hammered by all the machines of warfare, despoiled by robbers, and remodeled by engineers during the past centuries. Majestically it stands, overlooking the Tiber, one of the great landmarks of the city. Its history is almost the history of Rome.

• Report any problems you experience with the LuSys COVID-19 IgG/IgM Antibody Test to the FDA, including suspected false results. See Reporting Problems with Your Test.

Test Descriptions

The LuSys Laboratories COVID-19 Antigen Test (Nasal/ Saliva) uses a nasal swab or a saliva (spit) sample intended to detect proteins, called antigens, from the SARS-CoV-2 virus.

The LuSys Laboratories COVID-19 IgG/IgM Antibody Test uses serum, plasma, or blood samples. The antibody test is intended to look for antibodies produced in response to SARS-CoV-2, the virus that causes COVID-19, by a person's immune system, indicating a recent or previous infection. Antibody tests should not be used to diagnose or exclude an active COVID-19 infection.

The LuSys Laboratories COVID-19 Antigen Tests (Nasal/Saliva) and COVID-19 IgG/IgM Antibody Tests may also be sold under the company names Luscient Diagnostics, Vivera Pharmaceuticals, or with the trade name EagleDx. The FDA believes that these tests were distributed for use in laboratories or for at-home testing.

Potential Risk of **False Test Results** LuSys Laboratories COVID-19 Antigen Test (Nasal/Saliva): · False-negative antigen

test results mean that the test says the person does not have COVID-19 but the person is actually infected. A falsenegative result may lead to delayed diagnosis or inappropriate treatment of SARS-CoV-2, which may cause people harm including serious illness and death. False-negative results can also lead to further spread of the SARS-CoV-2 virus, including when people are grouped into cohorts (that is, they are housed together) in health care, long-term care, and other facilities based on these false test results. When false negative test results are received, actions to limit exposure to an infected person might not be taken, such as isolating people, limiting contact with family and friends, or limiting access to places of employment.

• False-positive antigen test results mean that the test says the person has COVID-19 but they are actually not infected. A false-positive result may lead to a delay in both the correct diagnosis and the initiation of an appropriate treatment for the actual cause of a person's illness, which could be another life-threatening disease that is not COVID-19. False-positive results could also lead to further spread of the SARS-CoV-2 virus when presumed positive people are grouped into cohorts (that is, they are housed together).

LuSys Laboratories COVID-19 IgG/IgM Antibody Test:

· False-negative antibody test results mean that the test says the person does not have antibodies to the SARS-CoV-2 virus when the person actually does have antibodies. Falsenegative results could lead test users to take fewer precautions to prevent spread of infection if the test is used inappropriately to diagnose active infection or if the test result is interpreted to mean that they did not have a recent infection.

· False-positive antibody test results mean that the test says the person does have antibodies to the SARS-CoV-2 virus, when the person actually does not have antibodies to the SARS-CoV-2 virus. Falsepositive results could lead test users to take fewer precautions to protect themselves from a future SARS-CoV-2 infection if the test result is interpreted to mean that they have had a previous SARS-CoV-2 infection.

FDA Actions

The FDA regularly monitors the marketing of unauthorized, unapproved, or uncleared tests, including reports of problems with test performance or results. The FDA is providing this information to help educate test users, caregivers, health care personnel, and the public and to reduce the risk of false test results that could lead to serious illness and death.

The FDA will keep the public informed if significant new information becomes available.

Reporting Problems with Your Test

If you think you had a problem with a SARS-CoV-2 test, the FDA encourages you to report the problem through the MedWatch Voluntary Reporting Form.

If you think you had a problem with your device, the FDA encourages you to report the problem through the MedWatch Voluntary Reporting Form.

Health care personnel employed by facilities that are subject to the FDA's user facility reporting requirements should follow the reporting procedures established by their facilities.

MBTA Launches New Online Youth Pass Application

The New Secure Online Application Makes it Fast, Simple, and Easy to Apply for the Youth Pass Program Online, and is Available in English, Spanish, Simplified Chinese, Traditional Chinese, and Portuguese

Online Applications to be Expanded to the MBTA's Other Free and Reduced Fare Programs in 2022

The MBTA announced the launch of the new digital Youth Pass application available online at mbta.com/youthpass/apply.

"Providing young adults with more convenient access to this secure, easy-to-use application is another step in providing broader access to the MBTA's system through the Youth Pass's discounted fares and monthly passes," said MBTA General Manager Steve Poftak. "We continue to be excited to expand the reach of the Youth Pass through our municipal and community partnerships, and we're proud to see the official launch of this online application, which we aim to expand to other reduced fare programs in

"With our industry-leading design and research process, we are able to deliver improvements like this to riders faster than ever all while ensuring the tools we build are secure and accessible to everyone," said MBTA Chief Digital Officer David Gerstle.

"Truly a collaborative effort," said City of Boston Department of Youth Engagement & Employment leadership. "As the largest Youth Pass municipal partner/administrator, we believe the development of the new MBTA online application could not have come at a more critical time for Boston's eligible youth and young adult population. This new application allows us to streamline the Youth Pass application process and enhance our partnership with the MBTA to ensure we're expanding our reach and always improving systems, processes and services for young people across the City of Boston to access this important resource."

The Youth Pass is a card that can be used by eligible young adults with low incomes to purchase roughly 50% reduced oneway fares or \$30 monthly LinkPasses for the bus, subway, and Fairmount Line Zone 1A stations at MBTA Fare Vending Machines, the CharlieCard Store, fare boxes on buses and trolleys at streetlevel stops, or at retail sales locations. Youth Pass cards can also be used to purchase half-price one-way fares for Commuter Rail, Express Bus, and ferry.

Previously, young adults were required to complete the application process in-person at the location of their local Youth Pass office, including bringing their eligibility documents and submitting a paper application form. In the wake of the COVID-19 pandemic, the MBTA prioritized and accelerated the creation and implementation of the online application process. Applicants can now apply to the program remotely and easily online from their home computer or mobile device without having to visit their local Youth Pass office in-person. Young adults residing in any participating municipalities can now simply visit mbta.com/youthpass/apply to complete the online application, which is available in English, Spanish, Simplified Chinese, Traditional Chinese, and Portuguese. Applicants can use the online application to upload their eligibility documents and select to have their Youth Pass card mailed or picked up from their local Youth Pass office, if approved.

In collaboration with the MBTA's Commercial Strategies and Programs team, the MBTA's Customer Technology Department accelerated the development of the online application,

Patrick F. Healy, OMI

Oblate Priest for Nearly 75 Years

Rev. Patrick F. Healy, OMI, passed away at Cambridge Hospital the age of 100 after a brief illness.

He was born in Charlestown, MA, the son of the late Patrick Healy, Sr., and the late Catherine (Walsh) Healy. Fr. Pat was the ninth of the ten Healy children, all of whom predeceased him.

He attended St. Mary's grade school in Charlestown and Boston Latin and

Boston English high schools, before entering Holy Angels Collegiate Institute in Buffalo, NY, the minor seminary of the Missionary Oblates of Mary Immaculate.

In 1940, Fr. Pat entered the novitiate in Tewksbury, MA, taking his first vows on September 8, 1941. He made perpetual vows 3 years later at the Oblate residence in Essex, NY. He was ordained to the priesthood on June 2, 1947 in Washington, D.C. by Bishop Arsene Turquetil, OMI, retired bishop of Hudson Bay, Canada.

After ordination, he was assigned as a teacher at Holy Angels Collegiate Institute in Buffalo, NY, and continued in 1951 at the new Bishop Fallon High School in Buffalo. He later was a teacher at the Oblate minor seminary in Newburgh, NY for 4 years, before volunteering for the Mission of the Oblates in Japan, where he served for 13 years as rector of the seminary and treasurer of the mission.

In late 1965, while on vacation in the U.S., he was a passenger on an Eastern Airlines flight, which was involved in a mid-air collision outside New York City, and he spent several months recuperating. He then



joined the U.S. Army as a Chaplain, serving until 1980 in Korea, Okinawa, Vietnam, Germany, and Japan. He received the Nation Defense service Medal, the Vietnam Campaign and Service Medals (with 3 bronze stars) among many other military decorations.

In 1980, the provincial asked him to become pastor of St. Timothy's parish in Miami, where he supervised

the building of a new church. He then became superior of the Oblate Residence & Infirmary in Tewksbury. He later served as a chaplain for the Army in Germany and West Point from 1987-1999. He continued his service to the military as chaplain at the Soldiers Home in Washington, DC (2000-02), then he resided in Tewksbury while preaching retreats and

He was chaplain at Chelsea Soldiers' Home for more than 20 years, a position he held until his death.



The Mystery and Magic of the Moon

Every January, I look forward to a certain kind of dark and still night. During a night like this, a mystical hush infuses the air, as if the whole Earth stands holding its breath, interrupted only by quiet wafts of chilly wind. Gray clouds scuttle across the dusky sky, obscuring the stars. I hear the gurgling of melting snow as it rushes down the drainage system, a sound indicative of the frequent January thaws and the cyclical turning of the year. Indeed, the sensation of the coming spring permeates this night, as only short hours before the sky had been a jewel-like hue of deep blue. However, the sight which makes me shiver with the most awe on this night is the full moon suspended above me. She glows with a pearly white incandescence as she winks from behind the passing clouds, adding to the enigmatic mood of the evening. Seeing such a moon reminds me of all the reasons why this heavenly orb resonates so strongly with me: her mysterious beauty, her link to powerful femininity, the way her graceful silver light whispers promises of the changing seasons. The January moon has always been particularly meaningful for me, as she brims with the energy of the New Year and forms an elegant and radiant counterpoint to the dark winter skies. She carries the anticipation of the spring, much in the same way as women-centered January holidays like St. Agnes's Day. In all of her manifestations and stages, the moon has captured the attention of societies worldwide, boasting her own slew of folklore and superstitions.

In part, my love from the moon appears woven into my DNA, a characteristic of my Italian heritage. When I was a child, my dad would frequently sing a catchy pop hit he remembered from his Italian boyhood, whose lyrics intoned: "La luna, la luna, ti portará fortuna" — meaning "the moon will bring you luck." Several Roman deities, the majority of them women, presided over the moon. Diana, the forest-dwelling huntress, was associated with the crescent moon, perhaps because it resembled the shape of her bow. The darker side of the moon belonged to the goddess Trivia, most commonly known by her Greek name Hecate, who ruled over witchcraft, crossroads, and all the spooky aspects of



night. Finally, the goddess Luna served as the very personification of the moon, and her name lent itself to the Italian name for "moon." Contemporary Italians still include mentions of the moon in their folklore, especially in the realm of superstition. The most famous Italian moon-related superstition, also repeated frequently in the United States, declares that the full moon exerts an influence over human behavior, encouraging romance but also lunacy. In fact, the word "lunacy" shares the same root as "luna." Italians also whisper stories of the lupo mannaro, or werewolf, who changes into a frightening beast under the full moon. Sundry moon superstitions include cutting one's hair during a waxing moon, to ensure that it will grow back lusciously as the moon gets bigger, and that pointing at the moon is considered rude and unlucky. These pieces of lore speak to the moon's immense cultural significance.

One January holiday in particular boasts the same sense of magic and mystery I associate with the moon. January 21st is St. Agnes's Day, or la Festa di Sant'Agnese in Italian, honoring a Roman virgin and martyr killed in the early fourth century. In Italy, this feast is linked to lambs, possibly because of the similarity between the name Agnese and the Italian word for lamb, agnello. Every year, the Pope blesses two lambs brought to Rome on January 21st specifically for the feast of St. Agnes. Significantly, sheep begin birthing lambs and commence the process of lactation around the middle of January. Therefore, la Festa di Sant'Agnese is one of those January holidays that looks ahead to the promise of spring, that honors rebirth and the new life blossoming under the winter snow. However, in addition to livestock, old St. Agnes's Day celebrations sparkled with enchantment and secrets. In the England of yore, the eve of St. Agnes's Day was set apart for romantic divination. Since St. Agnes is the patron of young women, girls would seize this opportunity to perform a plethora of charms in order to dream about their future spouse. These charms involved mysterious activities such ranging from silently walking backwards to bed, baking a cake at night without uttering a word, or repeating a magical rhyme while throwing grain into the soil. The romantic, supernatural nature of St. Agnes's Day perfectly accentuates the frigid, moonlit nights of January, when the moon illuminates the shadowy skies and hints at the spring to come.

Though she is often eclipsed by the warm and fiery sun, the moon provides us with a unique blend of mystical beauty and starry-eyed magic. She is a prominent figure in folklore and mythology, having long amazed people with her changing faces and powerful nocturnal presence. Wielding the mighty ability to affect tides but gentle enough to form lacy patterns of moonlight through the bare winter tree branches, the moon continues to enjoy her place in superstition, as people still repeat tales of her influence on human behavior. I encourage everyone to take time out of their busy lives to glance at the moon in all her splendor — whether she stands as a full white orb, or a glimmering sliver in the sky, or shyly peeks behind slate-colored clouds. One of my favorite moon moments was years ago, when I was driving back home with my mother after visiting my grandmother. As we passed a lake whose waters gleamed like polished glass in the nighttime, we immediately noticed an enormous full moon suspended in the sky, sending her spangles of light flitting across the tranquil waters. This moment reminded me that there is still so much beauty, magic and mystery in our world, which will only continue to be revealed as the winter melts into the renewed life of spring.



accomplishing the project's design, user testing, and launch through the use of SimpliGov's no-code, cloud-based platform.


Thanks to my good friend Michelle DiFronzo and the band Trif3cta, which is a super club band playing oldies, '60s, '70s, disco, and R&B.

This past Saturday, a burst pipe on the fourth floor of West End Place flooded 30 residential units, The West End Museum, and The West End Museum

It's been a really challenging few days. We haven't fully processed the ramifications of this yet, but there are a few things I can share:

- 1. Through staff efforts, the exhibits, including photos, bikes, etc. currently on display in the Museum are okay.
- 2. Damage to archival materials is less severe than it might have been. I will be assessing losses and damage over the next week or two, but for the most part the material culture of the West End is safe. That said, there will be losses, and each item carries an irreplaceable value. Working through the damage is going to be a deeply painful experience.
- 3. We are going to be closed indefinitely, and won't reopen until we can be sure the Museum is safe for visitors and things are back up to our usual standards.
- 4. I will begin giving weekly walking tours of the West End around the start of February. That's going to be the only way to "visit" in person for a bit, but I hope it will give everyone an opportunity to engage with the West End story while our doors are shut.
- 5. The Weekly will continue to come with historic articles, what was supposed to be last week's article is really great, you'll see that one on Friday!

It's going to take time and money to get back up and running. If you've been considering becoming a member of the WEM, this would be an especially meaningful time to do so.

If you have enjoyed what the Museum has to offer, it's also a good time to donate.

Grow a Few Vegetables Indoors this Winter Saint Fabian Pope and Martyr

by Melinda Myers

Limited outdoor growing space or cold winters may have you missing fresh homegrown vegetables. Make this the winter you try growing a few vegetables in a sunny window or under artificial lights.

Greens are one of the easiest to grow indoors. Most leafy vegetables tolerate the lower light indoors, require minimal space, and prefer cool temperatures.

Select a container with drainage holes that will fit near a sunny window or under an artificial light set up. Keep the artificial lights about six inches above the top of these and other plants. Fill the container with a well-drained potting mix and sprinkle seeds of your favorite leafy greens over the soil surface. Lightly cover the seeds and moisten the soil.

Remove overcrowded plants, called thinning, to provide sufficient space for the remaining plants to reach full size. Begin harvesting the outer leaves when four to six inches tall.

Extend the time between watering and increase success when growing these and other vegetables by amending the soil with a moisture-retaining product, like Wild Valley Farms' wool pellets (wildvalleyfarms. com). This organic and sustainable product holds 20% of its weight in water and slowly releases moisture into the soil when needed.

Add some crunch to your salads with quick maturing salad radishes. Plant seeds 1/4" deep and thin to one to two inches apart. Use scissors to the thin the plantings at ground level and use the greens to add a bit of zip to salads and sandwiches.

Expand your indoor edible garden by growing dwarf sugar snap peas. These and other vegetables that you eat the fruit or flowers need more light. Supplementing natural sunlight with artificial lights will help increase success.

Select shorter varieties that will be easier to train. Patio Pride grows only nine to 16" tall while Sugar Ann and Little Marvel grow up to 18" tall.

Plant two seeds in each threeinch pot or several seeds two

inches apart in a long rectangular container. Once the seedlings reach two inches tall, thin the plantings. Leave one plant in each individual pot and seedlings spaced four inches apart in larger containers. Cut the extra sprouts at ground level and use them in salads, sandwiches and

Peas are self-fertile, so no bees are needed. Harvest pods when they reach the size you prefer.

Don't forget the tomatoes. These take longer and are a bit more challenging but that is the joy of gardening. Start your plants from seeds if transplants are not available.

Consider growing one of the many small-scale tomato varieties that require less space and increase your chance of success. All-America Selections winners Patio Choice Yellow, Lizzano, Torenzo as well as Tiny Tim and Micro tomatoes are some varieties you may want to try.

Grow small plants in one- to two-gallon pots and larger varieties in three- to five-gallon size containers. Water thoroughly when the top few inches of soil begin to dry. Once flowers form, lightly shake the stem to aid in pollination.

Growing vegetables indoors is a fun way to enjoy edible gardening year-round. With every planting you'll increase your overall gardening experience and success.

Fabian was born on or about the year 200A.D. He was a noble Roman by birth, his father's name was Fabius. Nothing more is known about his background.

The papal election of 236 was a difficult one. Pope Pontian reigned for only five years He was exiled to Sardinia, where he died. Fabian had come to Rome from the countryside when the new papal election began. "Although present" at the election, says the historian, Eusebius, Fabian "was in the mind of none." As the bishops and others considered several prominent men, legend claims that a white dove came out of nowhere and sat on Fabian's head. They believed that this was a sign from the Holy Spirit that they should pick Fabian. He was installed as the new pope by acclimation. The legend concerning the circumstances of his election is preserved by the fourth-century writer Eusebius of Caesarea

During Fabian's reign of 14 years, there was a lull in the storm of persecutions. Fabian had enough influence at court to effect the return to Rome the bodies of Pope Pontian and the scholar Hippolytus, both passed away of hard labor in the mines of Sardinia. This could not have been done without the emperor's approval. According to the sixth-century historian Gregory of Tours, Fabian sent seven bishops from Rome to Gaul to preach the Gospel: Gatianus of Tours to Tours, Trophimus of Arles to Arles, Paul of Narbonne to Narbonne, Saturnin to Toulouse, Denis to Paris, Austromoine to Clermont, and Martial to Limoges. He also condemned Privatus, the originator of a new heresy in Africa.

communities of Rome into seven districts, each supervised by a deacon. Eusebius writes that he appointed seven subdeacons to help collect the official acts of the martyrs — the reports of the court proceedings on the occasion of their trials. Fabian initiated considerable work on the catacombs, where honored Christians were buried with the ascendency of the Emperor Decius, the Roman government's tolerant policy toward Christianity temporarily ended. Decius ordered everyone in the Empire, with the exception of Jews, to demonstrate their loyalty to Rome by offering incense to the cult images of deities which represented the Roman state. This was unacceptable to many Christians who took the commandment against idolatry with deadly seriousness. Fabian was thus one of the earliest victims of Decius, dying as a martyr on January 20, 250, at the beginning of the Decian persecution.

Nanna & Babbononno

A Nostalgic Remembrance



It was January of 1948 and right after I got up and looked out the window, I turned on the kitchen radio to check the no school announcements. The snow was coming down pretty good and I was hoping for those prayed-for words, "No school, all schools, all day in Boston." Finally, after the weather report, my prayers were answered.

I next made a couple of phone calls to friends whose families had telephones and discovered that all the neighborhood kids were going coasting down Brooks Street hill.

Brooks Street runs from the top of Eagle Hill in East Boston to Bennington Street, the main thoroughfare that brings you from Central Square to Orient Heights and Beachmont. The top of Eagle Hill is where East Boston High School is located. The intersecting streets begin with White Street and proceed with names taken from battles of the Revolution: Monmouth, Eutaw, Trenton, Lexington, Princeton, Saratoga and Bennington. It's all downhill and perfect for coasting when covered with snow.

My friends told me what time everyone was going to meet at the top of the hill and I headed to the cellar to clean off my sled. Most kids had Flexible Flyers, Flying Comets, Lightning Guiders or sleds that Sears and Roebuck sold. Me ... I had a one-person sled called a Snow Bird. It was short, light and fast. After a quick breakfast, I headed for the cellar, applied solid wax to the runners, shined the wood and headed out to join the crowd that would be racing down the Brooks Street hill. It seems that every kid in the neighborhood had heard the no school announcement and was ready to race.

By mid-morning, it had stopped snowing and the plows had done their best to clear the streets. There would be a thin coating of packed snow on all of Brooks Street, a perfect setting for coasting down the hill. We lived on Eutaw Street not far from the corner of Brooks and Eutaw. Carrying my sled under my arm, I headed for the starting point of the races, roughly where Monmouth Street and Brooks intersected, a block away up the hill.

When it was my turn to race, there were about four or five sleds that were going to compete. I knew all of the kids I would be racing against and also know that the competition would be tough, but I was ready and confident. When it was our turn, five sleds lined up and we began running down the hill carrying our sleds in front of us. When the signal was given, we jumped forward landing on our sleds as they hit the packed snow, and down the hill we went with kids lining the snow banks cheering us on. I was leading the way for the first couple of blocks until the unthinkable happened. Someone's dog began chasing the racers as we progressed down the hill. The dog caught up to me and began nipping at my right boot. The dog's owner started chasing him

to get a leash on him, but to no avail. Paying attention to the dog distracted me from what I was doing, and soon, all of the other racers passed me.

From the top of my sled, I kicked out at the dog and yelled to the owner, "Junior, Get your 'F-----' dog away from me." I yelled loud enough for everyone to hear me say the "F" word, including Nanna, who along with three other of her friends, was walking up the Brooks Street hill. They had gone food shopping early that morning and were on their way home. I wasn't aware that my grandmother nor her friends were within earshot.

I came in third and was not happy about the situation. I knew that without interference, I should have won the race. Accepting my fate, I headed back up the Brooks Street hill unnoticed until I reached the point where I yelled at the dog. There were people looking out their windows who all gave me dirty looks. One of my friends stopped me and told me that he saw my grandmother and her friends walking up the hill just as I yelled at the dog. I knew I was in trouble. Most of the women of Nanna's generation were from the old country, but in spite of their lack of fluency with English, knew what the "F" word sounded like and what it meant. When I reached the corner of Eutaw and Brooks, Nanna was standing there waiting for me with her blackoil cloth shopping bag filled with her morning purchases.

Nanna was never one to yell at me. I was the first-born male in my generation in a very Italian family, which means that I was a little prince. She just gave me a dirty look as I passed her and continued up the hill hoping to race again against a few more of my sled carrying friends. By the time the races were over, it was time for lunch and I headed home. En route, several of the old ladies of the neighborhood were in their windows and all gave me dirty looks. I began putting things together and knew I was in trouble. When I arrived home, Mom, who had already conversed with Nanna, greeted me with a lecture regarding the use of profanity which she said countered the way I was being brought up and then offered a threat of what my father would do if he found out.

I knew I was in trouble. I figured that if Nanna told my mother, Mom would tell Babbononno, and if they all knew, Dad was sure to find out. I had never heard Dad use foul language. The worst expletives I had ever heard him or Mom use were Hell and Damn. Nanna, when upset, had a few Italian expressions she learned back in Avellino. Babbononno, on the other hand, could cuss with the best of them, in Italian and when provoked made no bones about using blush-provoking expressions. What I had yelled was a word we didn't use in our house. Again, I knew that I would be in trouble when Dad found out.

At dinner, everyone was more quite than usual. Until Dad

announced that he wanted to talk to me privately later on. As I waited for my father many things shot through my mind ... would I be grounded, would I have privileges taken away, would I be punished?

I didn't know. Dad sat me down and began to talk about what he envisioned as a future for me, which included a proper vocabulary that excluded profanity. He told me that there were other ways of expressing frustration without using vulgarity. He didn't chastise me but described the way I was being brought up and what my vocabulary should include and what words should not be used. The way he ended the lecture was to tell me he wasn't bringing up a street bum and I should consider an apology extended to Mom, Babbononno, and especially Nanna. I followed his instructions and made my apologies, and soon, the incident was forgotten. Something must have sunk in back then, as I seem to have developed a pretty good vocabulary, which excludes the "F" word.

Every Italian Nonna has her own favorite way of making a ciambella. These traditional Italian ring cakes typically consist of flour, butter or oil, sugar, eggs, milk, essence and leavening. The flavors vary from Nonna to Nonna, as well as the texture and density. Some prefer a citrus flavor while others opt for vanilla, or sometimes even anise. Many Nonna's prefer a dense cake; others like to make a soft and moist one. Some bake their ciambellas in a bundt or tube while many continue to use the old-fashioned ring pans. Regardless of the flavor, texture, or what pan these Italian ring cakes are baked in, nothing could possibly taste better with an espresso or hot cup of cappuccino than a slice of "Torta Ciambella Italiana!"

I cannot begin to tell you just how many versions of these Italian ring cakes or *ciambellas* my own Nonna created. She made lemon, orange, vanilla and sometimes even marble, chocolate or pistachio flavored. Nonna often added ricotta, sour cream or yogurt to her recipes, and each *ciambella* always ended up being incredible. The recipe I am sharing today is one I remember her telling me had been passed down throughout the years. This "Italian Donut Cake" is anise flavored and surprisingly enough, when baked and iced the flavor very much resembles that of an egg biscuit. This slightly different, but oh so delicious "*Torta Ciambella Italiana*" is one I am confident you are absolutely going to love!

ITALIAN DONUT CAKE Torta Ciambella Italiana



4 eggs

3/4 cup sugar

1 cup oil (I used sunflower) 1 cup whole milk, warmed

(not hot)
2 1/2 to 3 tablespoons anise extract

2 1/2 cups flour

2 teaspoons baking powder

Icing:

2 cups confectioners' sugar 2 tablespoons butter, melted

4-8 tablespoons whole milk

1 1/2 teaspoons anise or

lemon extract (I prefer lemon)

Preheat the oven to 350°. Grease and flour a ciambella, bundt, or tube pan. In a large mixing bowl, beat eggs and sugar until fluffy. Add oil, then warm milk and extract, blend well. Sift in flour and baking powder, mix together until smooth. Add mixture to the prepared pan, and bake in a preheated oven for 50-60 minutes. Cool well.

To make icing: Place confectioner's sugar in a large mixing bowl. Add butter and extract, then gradually add in milk (more for a thicker icing, less for a thinner version). Ice cake and sprinkle with colored nonpareils.

The Death of Yvonne Fletcher

The years 1984-85 saw two violent riots in London, both resulting in the death of a police officer. The first one, resulting in the murder of 25-year-old Police Constable Yvonne Fletcher brought far reaching geopolitical tensions between the United Kingdom and Libya.

The roots of the riot began in 1980 when Muammar Gaddafi unleashed a vendetta against Libyan expats in various countries, including the United Kingdom, who had become vocal critics of his government since fleeing the country.

Between 1980 and 1984, vocal Libyan nationals residing in the UK had been assassinated by Gaddafi's agents, many via car bombings. The UK tried to maintain peaceful relations with Libya but as the violence increased, the British government found itself forced to deport suspected aggressors.

In February of 1983, Gaddafi replaced his London appointees with a committee of students who announced upon their appointment violent retribution against dissidents of Gaddafi's government.

Tensions reached a breaking point on April 16, 1984 when, enraged by news of the execution of two students who had spoken out against Gaddafi's regime in Tripoli, members of the Libyan National Salvation Front announced a demonstration outside of Libya's People's Bureau in St. James's Square. Hearing this news, the People's Bureau appointees sent Gaddafi a telex informing him of the demonstration and direction on how to respond. Gaddafi replied with orders to open fire on the protestors.

This reply, however, was intercepted by the National Security Agency in the United

States which, in turn, passed it on to Britain's Government Communications Headquarters. Though the information was passed on to Britain's Security Service, the city police was not notified. From here, a series of mistakes resulted in lost opportunities for preparedness.

Gaddafi's appointees did approach the Metropolitan Police and ask that the ending demonstration be stopped. The reply was that there would be police presence to prevent the escalation of violence but that the police would not or could not stop the demonstration.

On the morning of the demonstrations, April 17th, a dispatch of 30 police officers (including Fletcher) had barely finished setting up crowd control barriers in front of the Libyan People's Bureau building when demonstrators began crowding the building.

For a while, it did not seem as though the protest was going to become particularly violent. The Libyan National Salvation Front arrived chanting their hatred for Gaddafi but stayed behind the police barricade. Likewise, Gaddafi appointees also arrived on the scene with counter-chants but, initially, it was little more than a mere shouting match.

Suddenly, however, at around 10:18 a.m., shots were fired from one of the windows of the People's Bureau. Eleven protestors were wounded and Fletcher was hit in the back. She was still conscious as she was moved to Charles II Street, even advising her colleagues to remain calm. She was put in

an ambulance and rushed to Westminster Hospital but died at around noon.

The police meanwhile evacuated the People's Bureau of civilians and armed officers put the building under lockdown.

Meanwhile, in Libya another catastrophe was unfolding. Sixty members of Gaddafi's Revolutionary Guard Corps attacked the British embassy in Tripoli holding all 25 government officials inside, including Ambassador Oliver Miles, hostage. By April 19th, the siege was lifted and Miles and the rest of the government officials were freed. However, Britain began a push to get all its nationals out of Libya.

Gaddafi went on television blaming Great Britain for the violence and the subsequent embassy siege in Tripoli. The next few days saw five bombs planted throughout London, four were successfully diffused, and the fifth, which exploded on the 20th of April in Heathrow Airport's Terminal 2, fortunately did not result in any deaths.

On April 22nd, the United Kingdom formally severed diplomatic ties with Libya. Libyan officials were given until the 29th to leave the country and British diplomats in Tripoli were, likewise recalled to the United Kingdom by the same

He said his mother bought the cards for him in the mid-80s as a gift but has refused to hand them over to him after repeated requests. He just alleged this in his Manhattan Supreme Court lawsuit against her.

The mom was reportedly befuddled by the legal action. "Are you serious?" she said about her son's actions. She says she's a big fan of Paige and she keeps the cards safe and every couple of weeks takes them out to look at them.

Paige was a Hall of Famer and first African American to pitch in the world Series and Kiner was a Hall of Famer too who played for the Pirates and ended up being a broadcaster for the Mets.

Actually, if the cards are in "gem mint" condition, they could be worth \$30 thousand. Of nearly 3,300 Topps Paige cards from 1953 graded for auction, only eight have rated at that level. Mom has called the legal action "very sad."

She also said she has already left these two cards to her son.

Joey Archer - He Always Had a Boxer's Chance

It has often been said when a fighter appeared to be overmatched but was a solid puncher he had a puncher's chance at winning. This meant that even though he odds were against him on paper, he could pull out an upset victory by virtue of landing the big shot, also known as a lucky punch.

Max Baer was a decided underdog against Joe Louis yet he was given a puncher's chance. Same was said about Earnie Shavers when he went up against Muhammad Ali. Shavers certainly came close put couldn't pull it off.

Ruben Carter was a monstrous puncher so always had a shot of scoring a major upset in a big fight as he did against Emile Griffith when he stopped him in the first round of their bout.

But what about the boxer's chance. The times when a contestant not known for his power is able to upset a terrific puncher. This happened to Hurricane Carter when he was beaten by Joey Archer.

Archer also beat another very hard puncher when he decisioned future middleweight champion Dick Tiger. Both the Carter and Tiger fights were very close split decision victories for Archer. However, many felt both of his opponents were just too strong and powerful for him and would walk through the slick boxing Archer.

Joey Archer at 5'10" was tall for a middleweight. He looked frail and out of his 45 victories in 49 fights he only scored 8 knockouts. He was never stopped. In spite of that he was able to beat much solid opposition and earn two cracks at the middleweight championship, both times against Emile Griffith. Each fight was very close decision losses by Archer. Many at ringside thought he had done more than enough to win the title in the first match.



Archer defeats Jose Gonzalez

Joey Archer, who was from the Bronx, NY, made his pro debut in 1956 with a 4 round decision over Danny Jones at Sunnyside Gardens. He compiled 30 straight wins before drop-

ping a decision to Jose Gonzalez in 1962. In the fight both man were cut and Joey lost by unanimous decision. Two months later Archer handily won a rematch with Gonzalez.

Joey would continue piling up wins on the road to his title shot against Griffith. He beat solid competitors in Mick Leahy, Denny Moyer, Blair Richardson, Holly Mims, Ruben Carter, Dick Tiger, Don Fullmer, Willie James, and Sugar Ray Robinson (This was Robinson's final bout). In the Richardson bout the Associated Press reported that Archer landed close to 200 left jabs on his opponent.

Joey was cruising towards a shot at the title and was just about set to sign to fight Emile Griffith when he accepted a return fight with Don Fullmer. The fight was scheduled to take place in Boston on December 13, 1965. The 12 round but was for something called the WBA American Middleweight Title which was held by Fullmer.

In those days Boston officials had a reputation for rendering some very odd decisions, and this bout was no exception. At the end of 12 rounds it appeared Archer had easily outpointed Fullmer, but not in the strange eyesight of the two judges who scored the fight for Don. Referee James McCarron favored Joey.

The stench from the decision was so bad that it did not prevent Archer from getting his shot at

Emile Griffith. The two signed to meet in a bout at Madison Square Garden on July 13, 1966.

A crowd of 13,776 turned out on a very hot night and they were not disappointed. The fight was an exciting 15 round affair. Archer boxed beautifully while Emile kept the pressure on and fought well inside. Joey was in constant motion and proved a very difficult target. Emile was the stronger man in close. It was a difficult fight to score and at the end of fifteen rounds the scorecards were close but in Emile's favor. Judges Art Aidala and Al Berl had Griffith winning 9-5 and 8-7 respectively while

referee Johnny LoBianco saw it as a draw. The press was mixed in its opinions with UPI scoring it 8-6-1 for Archer and the AP having it 9-5-1 for the champion. In his dressing room after the fight Joey said, "I thought, I really thought, I had it 9-6 easy,"

It was both a good enough and close enough fight that the two were signed to fight again in six months. The rematch did not disappoint and the ending was again controversial. Archer started out strong and was leading in the early rounds but Emile came on during the second half of the fight.


Archer did not have the same fire as in the first bout yet still put up a great effort while again came up short on the scorecards, this time by unanimous decision. 8-6, 8-6, and 8-7. Again, the press was split on the outcome with two reporters from the AP choosing different winners. One had it 8-6-1 for Archer while another had it 7-6-2 for Griffith.

Joey was very bitter at this loss. He refused to shake hands with Griffith which upset Emile who told Don Dunphy "That was not Joey." In fact, Joey was so disgusted after having lost three controversial decisions in a row that he walked away from boxing. He never fought again and I'm not sure he ever attended another boxing card. He really disappeared from the fight scene.

He and his brother Jimmy ran a couple pf bars in New York. The second bar they operated, Joey Archer's Pub, was conspicuous by its absence of boxing photos on the wall. It became known for its poetry nights. Archer really appeared to have been fed up with boxing.

While neither Griffith fight could be termed highway robbery, In Joey's mind he had worked hard and deserved to win. He had fought the

best over many years, and many of those fights had been close decision wins for him. It was in the two biggest fights of his life that he was unable to sway the judge's opinion. This left him angry and finished with boxing not only as a fighter but in having any

involvement with the sport.


I'm not sure if Joey Archer could be termed a recluse, but I have not been able to find any interviews he has given in all the years since his retirement. No current photos seem to exist. He really did fade from sight.

During his career Archer was beautiful to watch in the ring. He used his left jab like an artist using a brush to paint a portrait. He was quick on his feet and a master at feinting. Had he won the title and kept fighting he certainly would never have been forgotten. I hope he found peace with himself and has had a good life. He had a career he should be very proud of.

HOOPS and HOCKEY in the HUB

The NHL was a different place over 60 years ago. But it was one where Willie O'Ree was able to both break a barrier and keep a secret.

"I will never forget how my teammates in the Bruins locker room accepted me," said O'Ree, who had his number 22 retired and raised to the rafters at the Garden on January 18, some 64 years after he cleared the boards and took his initial strides as the first black man to play in a

National Hockey League game. But as he would learn this was also an era "when some of the fans and opposing players were not ready" for a black man in the NHL.

And through it all he kept a secret.

Today, if one was injured or coping with the results of an injury, the team's medical staff would know, as well as the coaching staff and the general manager.

Hockey was different game back then. One could say it was more physical (Gordie Howe lost two teeth while scoring his first NHL goal) but it was definitely came up short when it came to employing protective equipment.

Players did not wear helmets, none wore visors, and the goalies guarded the crease without the benefit of a mask. Just stop and think about what it must have been like to face slap shots without any facial protection while possibly being screened from a perfect view by opposing players.

Although it has been decades, we still remember the goalie for the local high school team. Not so much for his ability but for his appearance. At age 17 he wore dentures, both upper and lower, because he was missing a number of front teeth. Why? Because he didn't wear a mask.

And what was Willie's secret in that very different era? He was legally blind in one eye, a fact that he kept from Bruins coach Milt Schmidt and general manager Lynn Patrick. It was an injury sustained during the 1955-1956 season as he was coming up through the junior hockey system in Canada. O'Ree had managed to keep it to himself as he progressed through the various ranks of hockey. If his injury had become known, he would not have been allowed to play in the NHL, according to league regulations.

The incident that caused him to lose about 95 percent of the vision in his right eye occurred during the 1955-1956 season when he was playing with the Kitchener Canucks of the Quebec Hockey Association. Not wearing a visor or helmet given the era, he was injured when he was hit directly in the face by a puck that not only injured his eye but also broke his nose and cheekbone as well.

We remember reading years ago that during the youth hockey season in Canada, approximately 10-12 youngsters would lose the sight in one of their eyes while playing in leagues across the various provinces of our neighbor to the earth.

To the parents of today whose children play hockey with helmets and full facial protection, we say be very thankful that they participate in the game during the current era when player safety is emphasized.

Before COVID-19 limited access by reporters, it felt good to enter the Bruins locker room (or any of the college ones) and see all the unmarked faces, meaning they had escaped all the dreadful facial injuries of past generations.

But the world of hockey that Willie O'Ree participated in was a far cry from today. Rough, tough, unforgiving and by today's standards, dangerous.

However, it was a world of traditions. It was the Original Six era, which lasted from 1942 to 1967, a time when each team had only five opponents and games were played in some of the most hallowed halls in sports.

Thus, when Willie O'Ree came over the boards to play in his first NHL game, he was participating in history by achieving his life's goal — to play in the National Hockey League. Via a video link to his home in San Diego, O'Ree recalled simply being issued number 22. He said that initially it had no special significance to him. As the years went on, however, he came to embrace the number since it represented his age at the time he first played in the NHL. His first game came again the Montreal Canadiens, a storied franchise and arch-rival of the Bruins. And the ice sheet he was skating on was in the Montreal Forum, which one *New York Times* writer years ago call "the cathedral of hockey."

True, he only played 45 games spread over two seasons in the NHL. But in an era of only six teams, with no players receiving guaranteed contracts, that was still quite an accomplishment.

And he had an impressive 21-year career in pro hockey. In addition to those 45 games with the Bruins, O'Ree went on to be a standout performer in the Western Hockey League, playing with Los Angeles and San Diego over the years. He led the WHL with 38 goals during the 1964-1965 season, one of five 30-goal campaigns he had in the league. He finished his career with 639 points (328 goals and 311 assists), amassed while competing in 785 Western Hockey League games.

O'Ree has served as the National Hockey League's Diversity Ambassador since 1998. He was Inducted into the Hockey Hall of Fame in 2018.

A LONG TIME COMING — When Brad Marchand scored a hat trick on January 12 and David Pastrnak added another on January 13, they were the first consecutive Bruins hat tricks since April 7 and 9 back in 1998.
