Boston's City Council Swearing in Ceremony

New Year's Day 2024 ushered in a fresh-faced Boston City Council. Headlining the inaugural ceremony was the unanimous selection of the next Boston City Council president Ruthzee Louijeune. Nominated by District 1 City Councilor Gabriela Coletta, Louijeune was selected by a 13-0 vote gathering unanimous support to succeed former City Council President Ed Flynn.

In her speech, Louijeune commented that she wasn't the first black woman to lead the council and thanked past council presidents and current Massachusetts Attorney General Andrea Campbell as well as former acting Mayor Kim Janey for "blazing the trail" for her. She topped the ticket in this past November's election and was sworn in along with colleagues, earlier in the day to her second term. She will lead the council for two years, per the term limits set by the City of Boston Charter.

Louijeune is the first Haitian American to serve on the council

and is responsible for assigning key committee chairs, leading council proceedings and for

setting the agenda and path for the 13-member council over the next two years. Prior to her election, Louijeune worked as Senior Legal Counsel for U.S Senator Elizabeth Warren's Presidential Campaign.

Also sworn in were four new councilors John Fitzgerald, Enrique Pepèn, Henry Santana, and Benjamin Weber. Fitzgerald is the son of the late State Representative

Kevin Fitzgerald and is the past deputy director of real estate operations for the Boston Planning and Development Agency. Santana is a native of the Dominican Republic and Mayor Wu's former director of civic organizing. Pepèn was the former head of the Boston Office of Neighborhood Services, and Weber is a labor attorney.

Durkan, Pepèn, Santana, and Weber were all endorsed by the mayor, while Fitzgerald was backed by former Mayor Marty Walsh. Re-elected to the council were At-Large Councilors Julia Mejia and Erin Murphy, along with district councilors Gabriela Coletta, Ed Flynn, Brian Worrell, Tania Fernandes-Anderson, and Liz Breadon. Mayor Wu administered the oath of office and remarked on the diversity of the current and incoming councilors.

Key Support Drifting Away?

The demographics that carried Biden into the White House in 2020 are showing much less support as we move closer to the 2024 election. The recent *USA TODAY*/Suffolk University Poll indicates that Biden is trailing Donald Trump 37 percent to 39 percent due to his inability to hold down critical voting blocs that carried him to victory four years ago.

At 81 years old Biden is hemorrhaging support from black, Hispanic and young voters. Among black voters, Biden's support has declined to 63 percent down from 87 percent in 2020. People under 35 and Hispanic have actually jumped to support Trump, with the former president leading in both demographics. Young voters (37-33 percent) going for Trump. Hispanics are now favoring Trump by 39 to 34 percent according to the polling.

54 Percent OK with Ruling

Most Americans — including 25 percent of identified Republicans — support the Colorado Supreme Court's ruling disqualifying Trump from the ballot. The online YouGov survey also had a second survey question. Would this ruling be overturned by the U.S. Supreme Court? There 43 percent thought the Supremes would put a stop to states from attempting to keep Trump off the ballot.

First night began in Boston in 1976 as an opportunity to provide local artists and musicians a chance to showcase their



APHRODISIACS, ETC.



In this day and age, we often jest about certain aphrodisiacs or sexual stimulants. For some unknown reason, discussions of this nature always seem to center around the poor little raw oyster.

The ancients didn't mess around with mere child's play, they used the oyster to settle the stomach, restore lost appetite, and as a gentle laxative. When boiled with honey it was used to cure "tenesmus" (the inability to urinate). Vapors from steamed oysters were inhaled to help slow down running colds. NEAA Donates to NEMPAC



Mary's legacy lives on through the warmth she shared and the love she bestowed upon her family and friends. May she rest in eternal peace.



DCR and Greenbelt Announce Conservation Restriction on Lynn Woods, Permanently Protecting the Park from Development

Gift of Conservation Restriction from the City of Lynn Ensures More Than 2,000 Acres of Land Will Remain Accessible to the Public for Recreation and Water Supply

L'Anno Bello: A Year in Italian Folklore La Befana:

A Feast of Stockings and King Cakes

If we were only to take a quick glance around us, the Christmas season appears to basically have finished. Scraggly trees stand forlornly next to dumpsters and dusty ornaments once again occupy shelf space in the closet. Dwindling leftovers and stale cookie crumbs speak of the great holiday feasts the previous week. However, according to both religious and folkloric calendars, we are still in the midst of the Christmas season! Christmas lasts for twelve days, up until January 6th, which is the feast of the Epiphany. In Italy, the Epiphany, or la Epifania, is a significant holiday with traditions that equal those of Christmas Eve. An ancient feast day, the Epiphany honors the visit of the Three Magi to Baby Jesus. On the eve of this holiday, Italian children excitedly head to sleep, knowing that in the morning they will find their stockings full of presents from La Befana, Italy's premiere gift-bringer. Along with the arrival of La Befana, the Epiphany also ushers in the Carnival season, a joyous time of mischief which paves the way for spring. With its appealing imagery of magical witches and playful silliness, the Italian Epiphany bursts with unique and fascinating customs.

Nowadays, Italian children receive presents on Christmas from *Babbo Natale*, or Santa Claus. However, *La Befana* has still retained her status as Italy's most famous folk figure and favorite gift-bringer. Who exactly, then, is this mysterious character? *La Befana*, whose name derives from a corruption

of the word "Epifania," is a fairylike witch who, like her male counterpart, drops presents in the stockings of good children while leaving behind coal for the naughty. She is typically depicted as an old woman in ragged clothes mounted on a broomstick. A well-known legend explains La Befana's connection to the Biblical story of the Epiphany. According to this folktale, La Befana was sweeping her house when the Three Magi approached her, inviting her to accompany them on their way to find Baby Jesus. La Befana initially declined, saying she was too busy with her cleaning. However, she later changed her mind and hopped on her broomstick, flying through the sky in an effort to find the Magi. Unfortunately, she was never able to locate them, and still soars through the air with her broom to this day, depositing presents for children as she continues to search for Baby Jesus and the Magi. When I was a little girl, I was frightened of La Befana, whose stern and haggard countenance formed a sharp divide to the jolly and merry-faced Santa Claus. My apprehension was amplified by the haunting traditional melody my grandmother sang, which intoned: "La Befana vien di notte/Con le scarpe tutte rotte/ Col vestito a la Romana/Viva, viva La Befana!" (Translation: "La Befana comes at night/with her shoes all broken/Dressed in the Roman style/Long live La Befana!"). However, I now love La Befana for her powerful symbolism of feminine strength and her unique sense of magic.

Many scholars believe that the figure of *La Befana* originated from old folk goddesses who oversaw the transition from winter to spring, which intensifies her cultural significance.

As a matter of fact, the Epiphany as a whole functions as a threshold to the arrival of spring. The winter solstice has already passed, and the hours of sunlight slowly lengthen. The sapphire-blue skies and golden sunsets of these midwinter evenings instill in me an excitement over the turning of the yearly cycle. Though we can of course expect more months of snow and cold, the promise of spring now unfolds quietly before us. The Epiphany ends the Christmas season, as is evident in an Italian dictum which proclaims: "La Epifania tutte le feste le porta via" ("The Epiphany sweeps all the feasts away"). However, the Epiphany does introduce another season, that of Carnival. Carnival, the precursor to Lent and Easter, extends from the Epiphany to Mardi Gras, or the Tuesday before Ash Wednesday. As such, Carnival serves as a spring festival, a herald to the still far-off feast of Easter. All over the world, people bake King Cakes on Twelfth Night, or the eve of the Epiphany. King Cakes are breads made specifically for the Epiphany and Carnival season, with variations differing worldwide. In France, King Cakes contain a flaky crust and an almond frangipane filling. Spanish King Cakes are adorned with candied fruit. Louisiana-style King Cakes are ring-shaped, with a cinnamonsugar swirl inside and a colorful topping. I make this kind of King Cake every Twelfth Night, decorating it with the traditional Carnival colors of green, purple, and yellow. I follow the folk custom of hiding a chickpea inside the cake—whoever finds it will receive good luck in the coming year! With such a cheerful dessert promising good times ahead, the revelry of Carnival can officially begin! Though the Twelve Days of

Christmas are nearing their close, the celebrations do not have to end. The Epiphany provides us with ample ways to bring more festivity into our lives. We honor the arrival of La Befana, the magical witch who fills children's stockings with presents under the cover of night, who symbolizes the ancient strength and power of women while also ushering the change of the seasons. We can celebrate Carnival, that long welcome to spring that fills our days with color and laughter. As the Christmas season yields its way to the bright new days of January, we should always maintain our childlike wonder and our love for the magic and mysteries of Mother Earth inside us. So let us get ready for La Befana, for she lights our path to a joyful season of hope and promise!

Life always remains what you make it and we can still dream forever and ever but I can't click my Nikes and find myself back in Roxbury in 1965.

When Jeff Dunham was eight years old, his parents gave him a Mortimer Snerd Dummy for Christmas, which came fully equipped with a how-to album. Jeff was so enthralled by his new toy, he went to the library and borrowed a book on ventriloquism from his local library. In the fourth grade, Dunham declared to himself that he wanted to be a ventriloquist, but not just any, he wanted to be the best one ever.

During his teen years, he would start performing at various places, such as church, Six Flags, and school events. Using his puppets, he developed



a unique style of lampooning, and they would act as cover for him to say things that were regarded as indecent for him to say himself.

In 1976, he made his television debut when reporter Bill O'Reilly interviewed him for a local news story. This had caught the attention of others, and while still in high school, he made commercials for car dealerships in Dallas and Tyler.

Jeff was born to be a showman, and he used his school years to help develop his act, like dealing with a heckler on stage, which won him his audience, or posing with his dummies for his high school photographs as a way to get professional photographs for his act. By 1980, his peers in high school had voted him most likely to succeed after graduation.

By his junior year, Dunham was raking in \$70,000, and word had spread about his act, landing him coveted spots opening for Bob Hope and George

Burns. After graduating from Baylor University in 1986, he continued with his act, adding new Characters to his lineup, which included, Peanut and José Jalapeño.

While he was a talented individual, there just didn't seem to be any room for growth with ventriloquism, and he wasn't taken seriously. So as 1988 drew to a close, he moved from Texas to LA, where he made friends with the owner of The Comedy & Magic Club, Mike Lacey. There he would observe comedians like Jerry Seinfeld, and using them as inspiration, he quickly sharpened his act, but it was still tough out there.

He was booked on The Tonight Show, which was later cancelled due to a change of heart by his booking agent. Despite the many setbacks, he didn't let them get in the way of his success and carried on performing and honing his craft. In 2003, he got his big break with an appearance on Comedy Central Presents. The move gave him the platform to release several DVDs, allow him to tour nationwide, pack out venues, have his own TV show, and have a line of merchandise.

While there were still several setbacks, it is safe to assume that he has now become one of the best out there, and this show promises to be a feature filled event that will leave you laughing all night long.







Saint Euthymius

Euthymius was born in the year 377 in Melitene in Lesser Armenia, to a noble and pious family. His parents, Paul and Dionysia, had prayed for a son, when the child was born they named him *Euthymius*, meaning, "good cheer."

Euthymius was educated by Bishop Otreius of Melitene, who later ordained him and placed him in charge of all the monasteries in the Diocese of Melitene. In 405, at about thirty years of age, he secretly set out on a pilgrimage to Jerusalem and remained for some time in a cave near a settlement of monks at a monastery called Pharan, about six miles east of Jerusalem.

In 411, Euthymius withdrew into the wilderness with



a fellow-hermit, Theoctistus, living in a rough cavern. When

many disciples gathered around them, they turned the cavern into a church and built a monastery which was placed in the charge of Theoctistus. Euthymius is credited with establishing the monastery of Caparbaricha in 422.

When reports of a miracle Euthymius had performed, the name of Euthymius became famous throughout Palestine, and large crowds came to visit him in his solitude. He retreated with his disciple Domitian to the wilderness of Ruba, near the Dead Sea, living for some time on a remote mountain called Marda by the Byzantines — no other than the ancient Masada of Roman-era fame. When large crowds followed him to this place, he decided to return to the region of

the monastery of Theoctistus, where he took up his residence in a cavern. Every Sunday, he came to the monastery to take part in the Mass.

In time, because numerous disciples desired him as their spiritual guide, he founded in 420, on the right side of the road from Jerusalem to Jericho, a monastery similar to that of Pharan. The church connected with this monastery was dedicated in 428 by Juvenal, the first patriarch of Jerusalem. Euthymius settled there for the rest of his life. Euthymius passed away on January 2, 477 A.D. The Feast Day of Saint Euthymius is January 20.

Betsy Ross

Betsy Ross was born on January 1, 1752, to Samuel Griscom and Rebecca James Griscom on the Griscom family farm in Gloucester City, New Jersey. Betsy was the eighth of seventeen children, of whom only nine survived childhood.

Betsy grew up in a Quaker household. She learned to sew from a great aunt, Sarah Elizabeth Ann Griscom. After her schooling at a Quaker-run state school, Betsy's father apprenticed her to an upholsterer named William Webster where, at age 17, she met John Ross, an Anglican. The two young apprentices quickly fell for one another, but Betsy was a Quaker, and the act of marrying outside of one's religion was strictly offlimits. To the shock of their families, Betsy and John married in 1772, and she was promptly expelled from both her family and the

Friends meeting house in Philadelphia that served as a place of worship for Quakers. Eventually, the couple opened their own upholstery business.

In 1776, at the start of the American Revolution, John was killed by a gunpowder explosion while on militia duty at the Philadelphia waterfront. Following his death, Betsy inherited his property and kept up the upholstery business, working day and night to make flags for Pennsylvania.

A year later, Betsy married Joseph Ashburn, a sailor. Ashburn, however, also met an unfortunate end. In 1781, the ship he was on was captured by the British, and he passed away in prison the next year. In 1783, Betsy married for a third and final time. The man, John Claypoole, had been in prison with her late husband Joseph and met Betsy when he delivered Joseph's farewells to her. John died 34 years later, in 1817, after a long disability. Betsy passed away on January 30, 1836, at the age of 84, in Philadelphia.

No official documentation has been found to confirm that Betsy Ross was responsible for creating the very first flag, but it is conceivable that Colonel George Ross — a signer of the Declaration of Independence and her deceased husband's uncle — recommended Betsy for the job. Some historians attribute the design of the first flag to Francis Hopkinson, a New Jersey delegate to the Continental Congress and signer of the Declaration of Independence, leaving the actual fabrication of the flag to Betsy Ross.

A Nostalgic Remembrance



When I was a kid in East Boston, the hectic lifestyle my family would lead during the Christmas season would come to an abrupt end in January. Dad and my uncles would return to just playing a few evenings of the midweek and definitely weekends. Dad would also be back to work days at his job in the Boston School Department, Uncle Nick was back in his office at the musicians union as the vice president, and Uncle Paul would rejoin the printing company he worked for. Babbononno, long retired, would reconnect with his pals at the storefront societies in both the North End and East Boston. The one exception to Babbononno's activities was the Christmas season of 1958. Just before the holidays arrived that year, Nanna passed away.

During WWII, my grandmother had had a heart attack, and after a long stay in the hospital, she recuperated to the point where she resumed normal but abbreviated activities. Things went well until the mid-1950s, when she developed breast cancer and after operations that seemed successful, she went through the primitive recuperative steps that were necessary for survival. She was often in pain and succumbed to the disease after it spread to her lungs late in 1958. Christmas 1958 was not a happy time.

During WWII, after her heart attack, Babbononno sold the big house on Eutaw Street in East Boston, as it was too much for Nanna to handle. They rented an apartment on Princeton Street for a few years, and later moved to Lexington Street, where they were living when Nanna passed away. Babbononno was up there in years and the decision was made for him to move in with us. Backtracking again, when Babbononno sold the house at 70 Eutaw, Dad and Mom rented a third floor walkup at 74 Eutaw, two doors away. The house was and still is attached to number 72 Eutaw. 74 Was owned by the parents of a woman Mom had grown up with and her husband was someone Dad had grown up with. They had the 3rd floor apartment available and we moved the distance of two houses away from where I was born.

The apartment consisted of four connected rooms, a hallway bathroom and a small room at the end of the hallway near the staircase that brought us to the third floor. That room was occupied by a single brother of the landlord's wife. When he moved out, wanting to try his luck in California, Dad rented

the room to be used as either a workshop or a music room. It would serve as both until Babbononno moved in with us early in 1959. My room was a small one just off the kitchen, but when Uncle Gino and Aunt Ninna were married after the war and were just starting out, they moved in with us. For almost a year, they took over my bedroom and I had the living room couch. When they finally found an apartment, I had my bedroom back. When it was Babbononno's turn, the tools headed for the cellar and the spare room became the bedroom my grandfather would sleep in.

It was difficult at times as I was in college and often studied at the kitchen table. Dad would play almost every night leaving both Mom and Babbononno at home. Mom had a circle of lady friends in the neighborhood and a couple of evenings a week would tie up with them for tea and gossip. That left Babbononno with me and he developed a curiosity about the things I was studying, especially history, which was one of his favorite subjects. As a result, we had many conversations on the historical developments of the world, but I often met with a couple of East Boston friends that attended college with me. We had an informal study group that was on going and I often had to leave Babbononno alone at night. When this happened, I felt sorry for him, as he would sit in front of the TV which bored him, or he would re-read one of the Italian newspapers he loved, including this one.

Parking at night became a problem not long after WWII ended. With everyone on the street buying new cars, Dad had to hunt for a parking space when he came home after playing with his band at night. Seeing he had to get up early the next morning, he was often upset if he had to drive around the neighborhood until he could park. By the time the '60s rolled around, things got worse. I had just started on a teaching career, was playing music as many nights as I could afford and began taking courses toward a master's degree. One winter's night Dad couldn't find a parking space on our block. It was snowing, and by the time he drove home from his job, it was late due to slow moving traffic. He searched for an hour and finally found a spot on another street blocks away. He then trudged home in several inches of snow with a bass violin under his arm and wet feet, swearing all the way in two languages.

He told Mom at dinner that next night that he wanted to buy a house with a garage and a driveway somewhere outside the city. My mother was so attached to East Boston she didn't want to move. When the scenario was repeated, Dad told Mom that he was going to move and he would pay for the Eutaw Street apartment for her and Babbononno to stay in. Mom knew he meant what he said and knew that her place was with her husband. That spring, they bought a house in Belmont. We were familiar with the town as Uncle Gino and Aunt Ninna had built a house there not long after my aunt delivered a set of twins to this world in 1950.

Babbononno didn't want to leave East Boston either, but didn't want to stay alone. He gave in and on Easter weekend of 1961, we left East Boston for Belmont. At first, I couldn't sleep at night ... it was too quiet: no sirens on the streets, no planes landing at Logan after flying directly over the house ... no noise at all, just crickets and birds to entertain us. We got to love it, but Babbononno hated it. Back in East Boston, he could go to his clubs and play cards several times during the week. He could also head to Central Square where he could buy the Italian newspapers he loved along with the Di Nobili cigars he loved to smoke. Belmont Centre which was a close distance from us offered nothing Italian back then and Babbononno, as I said, hated it.

Finally, the decision was made after long conversations with my uncles, Babbononno was to head back to East Boston. An apartment was found near Maverick Square and we moved him there. My mother was off the wall one day when I returned home from work. When I asked her what was wrong, she said, "I called your grandfather a while ago and a woman with a thick Irish brogue answered. It turned out to be a neighbor near his age and seeing he was in his mid-90s and she pushing 90, I told my mother that the most erotic thing that could happen would be them holding hands. Mom had to accept the relationship ... we did.

In Italy, the Feast of the Epiphany or La Festa dell 'Epifania is a significant holiday, particularly for Italian children. This special day commemorates the arrival of the three Wise Men at the manger bearing gifts for Baby Jesus. According to Italian legend, during their journey, the Magi encountered a witch-like woman on a broomstick, named La Befana, and invited her to join them. Befana initially declined, but later regretted her decision and set off alone to bring gifts to the child. Unfortunately, she never found the manger, so she instead left presents for other children throughout the land. In honor of this tradition, on the Eve of the Epiphany, children continue to leave out their shoes or stockings for La Befana to fill. On her broomstick she flies, stopping to fill the socks of good girls and boys with fruits, sweets, and presents, and for those who have not been so good, she leaves a lump of coal instead!

I remember the smile on my Nonna's face as she told me that as a young girl she would look forward to the oranges and dolls made from clothespins that "the old woman" would leave in her stockings. The coming of La Bafana brings joy and excitement to families across the country and of course, as with all Italian celebrations, it is accompanied by various goodies to eat. In particular, are the star shaped cookies, known as Befanini. The traditional recipe for these results in a simple citrus flavored biscuit, and though my Nonna had several recipes she used to create these cutout cookies, the one I am sharing, is her special rendition. So, I hope you enjoy them as much as we always did!

NONNA'S LA BAFANA STAR COOKIES Biscotti Stella La Befana Nonna



- 6 cups all-purpose flour
- 4 teaspoons baking powder
- 1 teaspoon salt
- 1 cup crushed com flakes (about 4 cups whole)
- 2 cups margarine or butter, softened
- 2 cups confectioners sugar
- 2 eggs
- 2 teaspoons vanilla extract
- 1/4 cup whole milk

Icing:

4 cups confectioners sugar

1 1/2 to 2 teaspoons vanilla extract

3 to 4 tablespoons whole milk

nonpareils

star shaped cookie cutters

Preheat the oven to 350°. Line two baking sheets with parchment paper and set aside.

In a medium mixing bowl, stir together flour, crushed cereal, baking powder and salt, set aside. . In a large mixing bowl, beat margarine or butter and sugar until light and fluffy. Add egg. vanilla and milk. Mix well. Add flour mixture and mix well.

Wrap dough in plastic wrap and chill for about an hour, or until firm.

Roll chilled dough on lightly floured board to about 1/8-inch thickness. Cut with floured star shaped cookie cutters.

Place on parchment lined cookie sheets. Bake in a preheated oven for about 8 minutes or until done. Cool on a wire rack.

To make icing, mix confectioners sugar, vanilla extract and enough milk to make a thick glaze. Ice cookies, sprinkle with nonpareils and let dry.

Recycle Your Christmas Tree into the Landscape

Removing the branches from Christmas trees and layering them over bulbs and perennials keeps the soil consistently cold, reducing the risk of early sprouting and winter damage. (Photo courtesy of MelindaMyers.com)

Don't drag that Christmas tree to the curb to be hauled away by the trash collectors. Give it a second, even third life, in your landscape. No live Christmas tree? Don't worry. I'm sure your friends and neighbors will share theirs.

Move your locally grown Christmas tree outdoors after the holidays. Avoid trees imported from other states that may host invasive insects that can infest your landscape and nearby Christmas tree farms. Your local municipality or Department of Natural Resources has more information on any threats and disposal recommendations for your area.

Use your cut Christmas tree to protect evergreens in your landscape from winter winds and sun. They make excellent windbreaks while shading sensitive plants in your landscape. Strategically place your discarded tree on the windward side of rhododendron, boxwood, and other broadleaf evergreens to reduce problems with winter burn. Place it on the south side of these plants to shade them from the drying winter sun.

Or remove the branches and use them as winter mulch over bulbs and perennials. Layer the boughs over the plants and soil to keep the soil consistently cold. This reduces the risk of early sprouting and winter damage that can occur during winter thaws.

Or set the tree in the landscape for a bit of added greenerv. Secure it in a snow pile or use stakes and guy wires in milder climates where the soil is not frozen. The birds will enjoy the added shelter and you will enjoy watching these visitors to your landscape.

Then consider adding a bit of food for your feathered visitors. Decorate the trees with fruits, berries, and seeds the birds can enjoy. Stringing cranberries and popcorn is a fun family activity and makes an attractive outdoor garland. Slices of oranges on colorful yarn and homemade bird ornaments can complete the adornments.

Sweep up the fallen needles that were under your tree indoors and use them as mulch in the garden. Place them directly on the soil or atop the snow. As the snow melts, the needles will be right where they belong. And don't worry, they will not make the soil too acidic. In fact, as they break down, they add organic matter to the soil.

As spring arrives, consider chipping and shredding your tree into mulch for trees and shrubs or pathways in the landscape. No chipper? You and your neighbors may want to rent a chipper to shred these and other prunings for use as mulch in your landscapes.

And, if this is not possible, check for recycling resources in your community. Many municipalities have special pickups for Christmas trees. These are chipped, shredded, and made available for citizens to use in their landscapes.

Lake communities often sink the discarded trees to the bottom of lakes and ponds to provide habitat for the fish. Another great way to give your tree a second life.

And once you discover the value of this free resource you may find yourself collecting a few more from the neighborhood. However, your family may ask that you wait until dark to drag your evergreen treasures back home.

and its permanent protection will mean those benefits will be there for future generations, who may need Lynn Woods even more than we do now."

"The forward-thinking Lynn residents who, one hundred and thirty years ago, donated their land and money to give us the Lynn Woods deserve to have their act of generosity remembered," said Jane Kelley, president of the Friends of Lynn Woods. "I can think of no better way to thank them then to preserve and protect their gift for future generations."

Lynn Woods was one of the first - and for a time the largest - municipal parks in the country. In 1870, the then Lynn Water Board, now known as the Lynn Water and Sewer Commission, acquired the land that would become Breed's Pond following a destructive fire in the city the previous year. In 1889, Frederick Law Olmsted, the landscape architect behind Boston's Emerald Necklace, advised the City of Lynn that the site should be left undeveloped and preserved in its natural state for local residents to enjoy. In 1890, Lynn voters approved the creation of what was then the 998-acre Lynn Woods. The park, which stretches through Lynn, Saugus and Lynnfield, has since grown to the more than 2,100 acres it is today and includes more than 30 miles of trails for hiking, running, skiing, biking, and walking, as well as three water reservoirs.

Red Sox Trade Sale to Atlanta



Chris Sale's time with Boston has mercifully come to an end as the veteran left-hander has been traded to the Braves for infielder Vaughn Grissom and additional cash. Sale waived his no trade clause to make the deal happen which ended a torturous seven year relationship with Boston. The Red Sox will send Atlanta \$17 million to cover part of Sale's \$27.5 million still due him in 2024.

When Sale, a 7-time All Star signed with Boston prior to 2017 he became the ace immediately. Sale finished second in the Cy Young voting in 2018 with a 2.11 ERA with 308 strikeouts. He was subsequently awarded a five-year \$145 million extension

on his contract. He didn't pitch in 2020 after undergoing Tommy John surgery and has only made 31 starts and pitched 151 innings over the past four seasons. Last season was his best year since 2019 posting a 4.30 ERA over 102.2 innings. Now the Braves with World Series aspirations hope that Sale can help them keep up with the Dodgers.

This deal will also bring infielder Lucas Grissom, who turns 23 later this month and has appeared in 64 games for the Braves and batted .287. Most likely he will become the club's second baseman.

With the Sox unloading Sale and also picking up another

solid starter in Lucas Giolito the day before sending Sale sailing off to Atlanta, things are starting to look better all-around for Boston. Up until last week, I thought

the Mets were really serious about Lucas Giolito and getting him into their starting rotation but that didn't happen and now he's travelling another 215 miles to Fenway Park. Last season he pitched 184.1 innings and struck out 204 batters between the White Sox, Angels, and Guardians. Overall. he finished 8-15 with a 4.88 ERA in 33 starts, however his 41 homers allowed did lead the AL. Giolito is only 29 years

This workshop is designed to introduce the concept of legacy letters and to help you craft your own legacy letter. It includes discussion and brief writing exercises. Jay will offer advice to help you complete your legacy letter, share it with loved ones and preserve it for future generations.





HOOPS and HOCKEY in the HUB

That is because former Celtics head coach Ime Udoka will be coming back for the first time since the conclusion of the Celtics postseason run in the Spring of 2022. That is when Udoka led the Green on their impressive run to the NBA Finals in his lone season as the team's bench boss.

Out of basketball for the entire 2022-2023 season following his suspension — an action that effectively ended this past February, when former assistant coach Joe Mazzulla, who had been serving as interim head coach, was named the team's permanent head coach.

But athletics, as well as many other realms of employment these days, are often the land of second chances. Udoka received his this past April when he was named the head coach of the Rockets.

Houston was definitely in need of a rebound. Udoka replaced Stephen Silas who had compiled a 59–177 (.250) record over the course of the prior three seasons. In his last campaign with Houston, the Rockets logged a very poor 22-60 mark under him.

Hired to improve the fortunes of the franchise, Udoka has already pumped some rejuvenation back into the Rockets. As the calendar flipped to January and the dawn of a new year, Houston was right in the thick of the mix in the middle of the Western Conference, sporting a .500 record through 30 games. The Rockets should be right about there when they meet the Celtics on the parquet on January 13. The Celtics should be the overwhelming favorites since they had put together an excellent 26-7 record through January 2.

However, it could also be that Udoka has needed some time to make his adjustments mesh with the realities of the Rockets. People sometimes forget that although the Celtics did go all the way to the 2022 NBA Finals in his one year with the team, it was a struggle for a little more than half the season.

The C's went 23-24 before going on a 26-3 run to close out the regular season. They then went on a successful run to the Finals, sweeping the Brooklyn Nets 4-0 in the opening round and then eliminating the Milwaukee Bucks in the second round and the Miami Heat in the Eastern Conference Finals with both those series going the full seven games. The C's then lost in the NBA Finals to the Golden State Warriors in six games.

The timing led to one of the most unusual junctures in Boston sports history with two national championships under way at the same time within the same geographic area — the NBA Finals with the Celtics and Warriors plus the U.S. Open Golf Championship at The Country Club in Brookline.

It will be interesting to see the reaction in the Garden when Udoka is introduced by the public address announcer as the Rockets head

Several players were close to him during his one year in Boston, including current star Jayson Tatum.

In a recent podcast that was posted in December, Tatum indicated that he had a lot of respect for Udoka and what he accomplished with the Celtics during his lone season with the team.

"I've got so much love and respect for him," stated Tatum, noting the highly successful run in the final stretch run of the regular season that continued into the playoffs.

He attributed much of that success to the way Udoka interacted with the players.

"The mentality of him every day saying stuff like we are a track team and we are not running from nobody. For that message to come from the top, from the coach, I think it just ran through everybody."

In a presentation that ran on CBS Boston during NBA All-Star Weekend last February, Tatum called Udoka "probably my most favorite coach."

Tatum said that he had talked with Udoka in the months following his suspension, "nothing crazy, just checking in."

The Celtics star stated that Udoka was "telling me he has been watching me play" and urging him to "keep up the good work. Things like that."

Tatum indicated that whatever led to the suspension "doesn't have anything to do with me but it can't take away the relationship me and him have and the impact he had on me in that one season."

He added: "I loved Coach K (at Duke University. I love Brad Stevens. I love Joe (current head coach). But I just had a different kind of relationship with Ime. He was probably like my most favorite coach — and that is not a knock against anybody. I have a great relationship with coach Joe. I love everything that he is doing. I am extremely happy for him."

REMEMBERNG WHEN — It was 18 years ago (January 10, 2006) that former star player Joe Thornton returned to the Bruins as a member of the San Jose Sharks — less than two months after being traded to the west coast franchise at the very end of November.

When he left the team Thornton was the B's scoring leader to that point in the season. But he did not last long in his one-game return to the Garden. He was given an automatic game misconduct and ejected from the game for checking Bruins defenseman Hal Gill from behind. That came with just over five minutes having elapsed in the first period. Gill was diagnosed with a pinched nerve in his right shoulder, left the game, and did not return.

Thornton, a former Bruins captain, was the number one overall pick in the 1997 NHL Draft. He had posted 33 points in 23 games before the trade. He was still the leading scorer for the B's when he took the ice on that January night.

Joe Thornton won both the Art Ross Trophy (points leader in the regular season) and the Hart Memorial Trophy (regular season MVP) for his performance during his split season with the Bruins and San Jose. He went on to play 14 seasons with the Sharks, plus short stints with Toronto and Florida. He retired this past October. His biggest disappointment was that he never won the Stanley Cup.
