In addition to the OSIA leadership, also speaking at the swearing in event was State Senator Joseph Boncore and his father, Philip Boncore, past State OSIA President. The Sons of Italy in America has over 50 chapters throughout the Commonwealth, and its grand lodge was even once located in the North End.

The new Lodge #2996 will have a concentrated focus on the North End, but its mission reflects the national organization's goals of promoting Italian culture, traditions, language,

the legacy of our ancestors, and contributions to the U.S. and the world.


Stirpe Nostra

TWO AND A HALF



"Condicio duo et dimidia, proposte due e' mezzo," or Proposition two and a half ... if you think it started in California or Boston ... you'd better think again. Laws that were intended to limit and control expenditures of individual citizens in ancient Rome were called "Sumptuariae Leges."

Concerns about economy probably all started in Greece, as is evidenced in the writings of Lycurgus, who tells of the Spartans being forbidden to have their houses constructed by implements other than the axe and the saw. Food and clothing were restricted to the most simple varieties. The use of gold or silver was not permitted in coins, however, iron was quite common. The death penalty was inflicted upon any-

one who drank undiluted wine, except when otherwise directed by a physician. Early Athenian laws forbade expensive feminine apparel and ornaments; even the dowry of a bride was not exempt. Expensive funerals were prohibited and the number of guests that could be present at any public entertainment was controlled by law.

Sumptuary laws in Rome followed those of the Greeks. The first Roman law that restricted entertainment expenses was enacted about 181 B.C. It limited the number of guests that could be invited to public functions. Civic leaders were required to swear before consuls that they would not spend more than the law allowed for banquets and the use of that happy red stuff was restricted to

"vinum indigena" or local wine. Controls were set on the amount of money that could be spent on national or local festivals, including the nature of the food to be consumed. Laws even fixed a limit on the amount of meat and fish that could be eaten at home, while at the same time encouraged the consumption of homegrown vegetables.

The dictator Sulla restricted the amount of money that could be spent on gravestones, tombs, and funerals. He violated his own rule when his wife died. While Julius Caesar was away from Rome, the enforcement of many sumptuary laws were ignored, but upon his return, he caused guards to be placed in the marketplaces to seize forbidden luxuries. The guards even removed restricted food from tables in private homes. The Emperor Augustus banned the use of litters, purple garments (dye was too expensive) and pearls. Tiberius prohibited the use of gold plating except for religious utensils. He also prohibited the wearing of silk for men. Nero reduced the amount of food that could be consumed by others, but not for himself. Marcus Aurelius economized on the gladiatorial shows, while the Emperor Tacitus forbade the wearing of gold embroidered garments. Oh well ... they weren't very comfortable anyway.

Saint Giuseppe Moscati

"The Holy Physician of Naples"

Giuseppe was born in 1780, the seventh of nine children born to an aristocratic family which came from the village of Santa Lucia in Serino, near Avellino. His father, Francesco, was a well known lawyer and magistrate, his mother, Rosa De Luca dei Marchesi di Roseto, was of noble birth.

Giuseppe completed his elementary schooling in 1889 he then entered the Liceo Vittorio Emanuele II in Naples. In 1892 his brother, Alberto, received severe head trauma in a fall from a horse during his military service. Observing the care which Alberto received at home inspired in Giuseppe an interest in medicine. He graduated from the Liceo in 1897, the same year that his father passed away. He continued his studies receiving his doctorat from the Faculty of Medicine at the University of Naples in 1903.

Moscati remained committed to his faith his entire life, taking a vow of chastity and practicing charity in his daily work. He also attended Mass daily. Moscati regarded his medical practice as a lay apostolate, a ministry to his suffering fellowmen. Before examining a patient or engaging in research he would place himself in the presence of God. He encour-



aged his patients to receive the sacraments.

It was claimed even before his death that Moscati was a miracle-worker; some said that he could accurately diagnose and prescribe for any patient merely by hearing a list of symptoms, and that he was responsible for impossible cures. Reports of his good works continued well after his death, with further reports that he interceded in impossible cases.

Immediately upon receiving his degree, Moscati joined the staff of the Ospedale degli Incurabili, eventually becoming an administrator. He won further recognition for his actions in the aftermath of the eruption of Mount Vesuvius on April 8, 1906.

When cholera broke out in Naples in 1911, Moscati was charged by the civic government with performing public health inspections, and with researching both the origins of the disease and the best ways to eradicate it. To his satisfaction, most of his ideas were put into practice by the time of his death.

Besides his work as a researcher and as a doctor, Moscati was responsible for overseeing the directions of the local Institute of Anatomical Pathology. He was also a medical school professor and a pioneer in the field of biochemistry whose research contributed to the discovery of insulin as a treatment for diabetes. He became one of the first Neapolitan doctors to experiment with insulin in his treatment of Diabetes.

During World War I, he tried to enroll in the armed forces, but was rejected; military authorities felt that he could better serve the country by treating the wounded. His hospital was taken over by the military, and he himself visited close to 3,000 soldiers.

He passed away on April 12, 1927. Moscati was canonized on October 25, 1987, by Pope John Paul II. The Feast of Saint Giuseppe Moscati is November 16th.





L'Anno Bello: A Year in Italian Folklore

In Praise of November

I first noticed the commercials a few days before Halloween. Ads for layaway deals in big-box stores began to pepper my television viewing experiences, replete with images of smiling Santa's, rolling ornaments and the sound of chattering jingle bells. Whenever one of these commercials caught my eye, a familiar, tingling sense of anticipation crept over me as I thought of the pleasures of the holiday season: swirling snowflakes, cookies baking in the oven, Christmas carols on the radio, potato latkes on sale for Hanukkah, trees illuminated with dozens of twinkling lights. However, I soon brought myself back to reality. I looked outside at the last yellow leaves drifting down from bare branches, the cornstalks and pumpkins decorating neighborhood homes. Halloween may be over, but we still have the whole month of November to enjoy! It is very tempting to dive into the pleasures of the holiday season early on, but the pulsating rhythms of the seasons and their unique feast days are meant to be experienced slowly, spiced with the trifecta of time, nature and mindfulness. This desire to live the seasons to their fullest proves especially palpable in November. Rather than a mere segue to the frenzied month of December, November boasts its own fascinating customs and traditions. As a month which signaled the end of the harvest and ushered in the beginning of winter, Italians honor the many faces of November, and their insights can help us appreciate this time for its singular delights.

At times, November can appear to be a somber month, sober and silent. Its skies are thick gray blankets outlined by bare, black branches. Dead leaves collect in clumps across the wet ground. Night wraps its dark cloak around the Earth early in the evening, uninterrupted by the colorful holiday lights that start to appear much later in the month. Winter feels imminent as the first bewildered snowflakes spiral down from the slate-colored sky. This is the month when nature settles into a nap, slumbering until its rebirth in the spring. Old Italian proverbs, hailing from the days of a primarily agricultural society, speak of the month's chilly, bleak characteristics. A dictum stating "Per Ognissanti, mantello e guante" reminds Italians to start putting on their coats and gloves on All Saints' Day, or November 1st. Another maxim, "Per Santa Caterina, la neve si avvicina," warns that snow looms close around the time of November 25th, the feast day

of St. Catherine. Some may find this transitional state of November, caught between the harvest of the autumn and the desolation of winter, downright dreary. However, I believe it perfectly fits the nature of the month. November was the month of Samhain for the ancient Celts, a month to honor the dead. It is befitting that the weather should match ponderous ruminations on mortality and life. I find November the perfect time to devote myself to solitude and tranquility, to recharge my energy before the hectic holiday season. However, November also

contains another side, one of warmth, family and festivity. In Italy, November marked the end of the harvest. To celebrate this occasion, villages across the country held communal feasts in order to enjoy the results of Earth's bounty. Oftentimes, these feasts became attached to particular saints' days. St. Martin's Day, or San Martino in Italian, occurs on November 11th and features banquets of goose, chestnuts, and the year's new wine. In fact, these foods feature in a notable Italian St. Martin's Day proverb: "Oca, castagne e vino per festeggiare San Martino!" Another feast, St. Andrew's Day, or Sant'Andrea, on November 30th, traditionally contained feasts of pork, commemorated in an Italian aphorism which states: "Da Sant'Andrea del maiale venticinque giorni a Natale." This proverb not only reminds Italians of the customary pork dishes on St. Andrew's Day, but also speaks of the fact that Christmas is twenty-five days away! Here in the United States, Thanksgiving beckons us into the comforts of family and friends, of heartwarming reunions and copious food to share. The stores brimming with boughs of holly and jolly elves tease the goodwill and joy of the upcoming holiday season. Though November demonstrates that nature goes through periods when it is devoid of regrowth and resting, the love of good company and the generosity of the Earth help us overcome that.

Italians honor November with communal feasts and unique holidays. Yes, the temperatures may drop to a biting cold, and the first dustings of snow may glitter on the ground. However, November also brims with a plethora of traditions that enforce the warmth of family gatherings in the face of the approaching the winter, from the sampling of new wine of St. Martin's Day to preparations for Christmas occurring at the end of the month. Since time immemorial, Italians knew that best way to contend with the solemn, wintry tone of November was to revel in its unique characteristics, but also introduce joyous festivities to keep people full of hope and optimism. As the month progresses, we may become worried about a frigidly cold winter filled with heavy coats and thick scarves. However, during such moments of dreariness, we should remember that the bleak November weather offers a much-needed chance for relaxation and reflection, and that the light and gaiety of the holidays will soon be upon

Don't Blame Long Island Closing for "Methadone Mile"

I was surprised to read that Medical Area, spilling over into City Health and Human Services Marty Martinez has announced that when Long Island is reopened and a new bridge is up and running that the new plan does not include moving the homeless population back to the island. Sounds like now Long Island will become a worldclass regional recovery center. I wonder if the surrounding communities in Greater Boston have all been notified of this new idea. To me it sounds like Boston is "regionalizing" the drug epidemic to make it more acceptable for cities like Quincy.

How are those in recovery going to travel back and forth to the island for services? Will any clients be staying overnight while in recovery? How large a population at this so-called "world-class regional recovery campus" is going to be using services there? Is a bridge still the only transit alternative to providing recovery services to folks there? More questions than answers so far.

Why have I not seen coverage in both print and broadcast media serving Greater Boston? Should I be learning this news from a weekly newspaper? Finally, and what of the ongoing crisis regarding the homeless and drug addicted population inhabiting Methadone Mile and the surrounding Boston

nearby South End, Roxbury, and Dorchester neighborhoods.

As someone who grew up in the Worcester Square area of the South End, how does this new recovery center help my old neighborhood if there is no identified plan yet presented to anyone on what to do about the homeless crisis that grew when Long Island was closed? Will anything change except on paper? Serving those seeking recovery is great, but what of the many still in denial or those who are still homeless and out on the street getting into constant trouble? What happens to those folks who are homeless, addicted, and mentally ill? More questions than answers. Has Boston sat down with Quincy elected officials to see where they stand on this new idea? Would it make a difference to them? Would they still oppose any new bridge built?

Boston keeps acting as if their plans are a fait acompli, and it is far from that. The City of Boston needs to stop its passive-aggressive stance with its neighbors and quickly or nothing will ever get done for anyone which is a sad statement on government leadership. The City of Boston needs to build trust with places like Quincy and stop being so uppity and demeaning with its righteousness. Not going over so well, is it?

FUN HOME

At SpeakEasy Stage ... Is First Rate Calderwood Pavillion

Directed by Paul Daigneault now through November 24th

The musical Fun Home now playing at the SpeakEasy Stage Company is deeply moving and complex. Based on the graphic memoir of the same title by Alison Bechdel, it tells the story of Ms Bechdel's childhood and her coming out as a lesbian while in college. However, this is not a story simply about a young woman coming to terms with her sexuality. It is much more complicated than that. In reality, her coming out is not the center of the story.

The play opens in, what seems to be, the happy home of the Bechdels (Welcome To Our House on Maple Avenue). Alison's father, Bruce (Todd Yard), is an English teacher as well as a director of a funeral home. The title of the play is taken from the shortened and more enjoyable name the Bechdel children, Alison has two brothers; Christian (Cameron Levesque) and John (Luke Gold), use for the family business.

Alison is played by three actors depicting her at different ages. There is Small Alison (Marissa Simeqi), Medium Alison (Ellie van Amerongen), and present day Alison (Amy Jo Jackson). The play does not follow a chronological order, but rather follows the present day Alison as she looks back on events in her life while drawing cartoons as she relives the various times. Much of the time she is sitting at a writing desk or standing off to the side looking on and drawing as her memories are played out by the others. She makes comments as she observes. I found this very effective as it is common for people to look back on their lives as if they are witnessing a play or a movie. Trying to figure it all out can get complicated, and this story is no different when it comes to complications.

Those complications are not so much in Alison's coming to grips with her own sexual identity; she does quite well with that, but with her father's having to deal with his. It turns out Bruce is gay and has never come out. He has gotten into trouble for "procuring alcohol for underage boys". Tyler Simahk, last seen at SpeakEasy in Allegiance plays multiple

roles as the young men Bruce procures beer for. He is also somewhat controlling, not abusive, of his children, and it is easy to gather that controlling behavior is reflective of his attempts to control his own behavior. It is painful to watch him struggle.

In the song "Maps" Alison talks about drawing maps of the

She advises Alison: "Don't you come back here I didn't raise you To give away your days Like me."

The song is strong and delivers the message of how living lies is painful to all involved. Fortunately, Alison has learned that difficult lesson.

While this story is one that involves much struggle and pain, it also has its happy moments. While Bruce was in much pain and controlling, he was also a loving father. The children loved him and Helen, as well as each other. The song "Come To Fun Home" is a rousing number sung by the three siblings as they pretend to make commercial for the funeral home. It is somewhat of a cross between the Osmond's and the Jackson Five, and all much fun. Marissa Simeqi, Cameron Levesque, and Luke Gold bring the house down while dancing and taking turns singing into a can of Pledge used as a microphone.

Desire Graham plays Joan, the understanding, though

neighborhood as a child. At one point she says about her father "I can draw a circle, his whole life fits inside". That line had me thinking of how trapped Bruce must have felt.

Bruce eventually killed himself by stepping in front of a truck. This was not long after Alison came out, and she says "My beginning would be your end". These words are powerful as they so strongly convey the torment in not being able to live who you are openly. Alison was fortunate, though it still wasn't easy, to have come of age in a time when she could find support and acceptance. Bruce had to live his life in the shadows and with guilt and anger that was turned within.

One of the most powerful moments in the play is when Alison's mother Helen (Laura Marie Duncan) sings "Days and Days":

"Welcome to our house on Maple Avenue

See how we polish and we

We rearrange and realign Everything is balanced and

Like chaos never happens if it's never seen."

In which she laments her life, feeling she wasted it in attempting to be the good wife."

edgy, friend Alison makes on campus and who eventually becomes her lover. Joan may be a bit tough but she is kind, and just the supporting figure Alison needed

Amy Jo Jackson in her role as present day Alison comes across as thoughtful and wise. It is interesting watch her expressions as she observes and begins to understand her life as it evolved. Often when looking back we see ourselves with a more sympathetic eye. It is good when we can cast that view onto our present day selves. We can learn that from Alison Bechdel.



Here in my community, a pot shop is seeking to open on the same block as a health care facility where folks wait outside to receive treatment for drug and alcohol dependence. A Nostalgic Remembrance



Well, it finally happened. I turned eighty on the 21st. On the morning of my birthday, October the 21st, I attended a military function. I belong to the Veterans Association of the First Corps of Cadets in Boston, and there was a change of command for the active end of our unit. Colonel John Silva picked me up and we headed to Camp Drum for the ceremony and the celebration that followed. It was an impressive gathering and I was happy with the way the day was unfolding.

The plan was, once we left the army base, we were to head to John Silva's and watch the football game. I live en route back to his place and asked if he minded stopping at my house for a minute. John loves good cigars and I am always smoking his. I wanted to have him try out a few of mine from a new batch I had picked up the day before. He seemed reluctant to head to my place but did anyway. I thought it was a bit strange, but didn't say anything. I just assumed that he was in a hurry to see the Patriots win, yet, another football game. As a result, I ran in the house, and ran right out with the stogies I had for him. He seemed relieved after we left, but again, I just let the situation pass without saying anything.

The plan was to then head to his place, watch the game, and along with his fiancée, Stephanie, catch up to my wife, Loretta, after she finished teaching, and have a nice Sunday Italian dinner. Let me explain my wife's schedule. She is a professor at Cambridge College and often teaches weekend intensive courses. This means that the course is set up to run for two weekends, all day long on Saturdays and Sundays. These two weekends constitute an entire course. I used to do the same thing when I was younger, but teaching all day long is a bit hectic at my age.

Anyway, the plan was to meet Loretta at DeMaino's in Revere, not too far from where John Silva lives. I hadn't heard from my wife all day, but thought nothing of it seeing she was in a classroom for eight hours. When we arrived at the restaurant, Stephanie asked the hostess if they had a reservation for Loretta Christoforo. She replied that Loretta was already there and waiting in their backroom. The hostess pushed open the door to the backroom and a group of people yelled out, "Surprise!"

The backroom of this restaurant is actually a function room and it was filled with my family and closest friends. Loretta didn't work that weekend, she planned a surprise 80th birthday party to honor me. Much of her time was spent finding old pictures (or should I say, young pictures) of me and having them blown up. They were in frames all over the room, pictures of me from a-year-and-a-half-old to my present age. (I really didn't want to say eighty again)

My son, Michael, had come home from New York for a few days, and was there to hug me along with his brother, my son,

John, my daughter-in-law Beth, and my granddaughter, Lina. Lina is pint-sized, but came running over yelling, "happy birthday Nonno." The list of guests included the last person from my folk's generation, my aunt, NInna Contini, my late Uncle Gino's wife. I was thrilled she was there. All of this happened so fast, I was at a loss for words, something that usually doesn't happen.

The rest of the guest list consisted of my closest friends, several of them guys that I've adopted as brothers, seeing my blood relatives are so few. Everyone grabbed me, hugged me, and wished me a happy birthday. It took me a while, but I finally composed myself and greeted my guests, almost with tears in my eyes.

The food was served buffet style and was just what the doctor ordered for a Sunday: pasta, meatballs, sausages, eggplant parm, chicken, fish, and salad, a little something for everyone's taste buds including a birthday cake. Someone asked me, "What if someone doesn't like Italian food. My answer was, "That's un-American!"

The dinner party lasted for close to three hours and on the way home I could see that Loretta was tired. She hadn't worked that weekend. She was planning and preparing everything to make the event a true surprise. Before he left, John Silva told me that he was reluctant to stop at my house fearing that Loretta might be there or return home while we were there and mess up the surprise aspect of things.

After we unloaded Loretta's car, she went right to bed, exhausted to say the least. I headed to the den to try to relax and began to think about the surprise parties from times past. Babbononno loved parties in his honor, and although most weren't surprises, (Nanna had to tell him to keep him home) he enjoyed them as if they were.

Nanna wasn't as keen on surprise parties as was her husband. If she celebrated a birthday, she preferred her family surrounding her, and that was it.

My folks, on the other hand ... that was another story. Mom loved big parties, big surprise parties. Dad often preferred to just go to a restaurant, but was outvoted every time. On many occasion, I threw my folks surprise parties for either birthdays or anniversaries, especially anniversaries. The first was for their 25th. I was 23, teaching days and playing music nights and decided to honor them with a surprise party at Blinstrubs Supper Club in South Boston (remember Blinstrub's?) Uncle Nick set things up with Mr. Blinstrub and we had the center table in front right below the stage, where Sammy Davis, the entertainer for the week, could make a big deal of them, and he did. All of the family, Dad's sister, Mom's brothers, and her closest cousins were there, as well as a few neighbors that lived in close proximity in East Boston.

I did the same thing for my folks 40th, and ten years later, for their 50th. By that point in time, most of the relatives were gone, but I made up for the lack of numbers on that end with dozens of their neighbors, social friends, and musicians that had worked with Dad throughout the years.

Most of guests at my surprise party read this column, and I want to thank them publically for being there to share a special day. And, to my wife, Loretta, thank you so much. She hates parties, but I love her anyway. When my sons called everyone to attention and recalled funny episodes in our lives, they had me laughing and crying at the same time. I have to say it, I'm just a very lucky guy."



When Fenway Park Packed a Punch



Fenway Park

Fenway Park is the home to a team that can now be called among best, if not the best, in baseball history. The Boston Red Sox were dominant this year and in the World Series.

Old Fenway Park is the proud home to the Sox. It is considered one of the most beautiful ballparks in the country, and it is one of the few remaining old time parks. Bostonians are not only proud of their team they also take great pride in having such a wonderful home venue to host that team in.

Fenway Park first opened in 1912. Over the years it has been the sight of baseball games. It has also been known to have other events as well. Among these were professional wrestling, rock concerts, ice hockey, football, ski jumping, and boxing.

The first boxing card to take place at Fenway was on Monday, August 11, 1919. In the main event that night, local Frankie Britt won a 12 round decision over Ralph Brady in a lightweight battle.

There would be two more fight cards held at the park over the next year before taking a break. Boxing would resume being staged at Fenway on June 26, 1928 when Al Mello faced Billy Murphy for the New England Welterweight Title. Mello came away with a in after 12 rounds. Other local fighters who appeared that night included, Hy Diamond, Charlie Donovan, Jack Donohue, and Ray Cross. They all came were victorious.

There were 22 more fight cards held at Fenway from 1928 through 1937. On August 24, 1937 Tony Shucco and Al McCoy fought to a draw in the main event promoted by Rip Valenti. There would not be another fight held there until after WWII.

During those years there were a number of great venues for staging boxing matches. These included the Boston Garden, Boston Arena, the Mechanics Building, and another ballpark; Braves Field.


Staging and outdoor fight always came with the risk of bad weather forcing a cancellation or hurting attendance. Often times big title fights were held outdoors because they could accommodate the huge crowds eager to attend. I don't believe crowd capacity was the reason for holding outdoor fights in Boston. It more likely was because it is such an attractive place to be on a warm summer night. Also, in the days before air conditioning was widespread it could be a nice alternative to sitting in a stuffy arena.

During the 1930s some of the world's leading contenders made appearances at Fenway Park. The ill fated Earnie Schaaf lost a decision to Babe Hunt on September 2, 1930. Tony Shucco fought there again in 1937 when he lost a decision to top contender Natie Brown. Maxie Rosenbloom defeated Joe Barliow there in 1932, and the great Kid Chocolate also fought at Fenway in 1932 defeating Steve Smith by decision. Future heavyweight king James J. Braddock made his only appearance at the park when he won a decision over Joe Monte in 1930.

In 1936 former heavyweight champ Jack Sharkey, on the comeback trail, took on Phil Brubaker in a ten round main event at Fenway. He came away winning a close ten round decision. *The Associated Press* gave this report on the fight:

"Jack Sharkey projected himself back into the heavyweight picture today as the result of a close but convincing 10 round victory over young Phil Brubaker. Sharkey got up off the floor at Fenway Park last night, gave the 22 year old Brubaker an artistic boxing lesson, and promptly served notice that he's serious about making a comeback. Knocked down, cut and battered by Brubaker's first round rush, Sharkey rallied to outbox, outpunch and outpoint the California clouter. The 33 year old exchampion, all things considered, waged one of his best fights to score an uphill victory."

The win would earn Sharkey a match against an up and coming heavyweight contender by the name of Joe Louis. Sharkey would retire after losing to Louis.

Boxing returned to Fenway in 1945 when two aging former heavyweight contenders faced off. Tami Maurlello took on Lou Nova. Both had challenged Joe Louis for the championship years before and were at the tail end of their careers. Maurlello showed he still had quite a bit of fire in him when he destroyed Nova in the first round, dropping him less then a minute into the fight. He then opened a cut over Nova's left eye before finish him off with a right to the jaw.

There would only be two more fight cards promoted at Fenway Park and they would be in the mid 1950s. Both would be headlined by one of the most exciting fighters to ever come out of Boston, the great Tony DeMarco.

In 1954, hot on the trail for a shot at the world welterweight title, DeMarco showed he vaunted power when he stopped George Araujo in the 5th round. Araujo put up a valiant effort but was outgunned by the power punching DeMarco.

The final boxing show to be held at Fenway Park took place on June 16, 1956 when Tony DeMarco once again headlined a show promoted by Sam Silverman. DeMarco was now the former welterweight champ, but was hot on the comeback trail coming off two wins since losing the title to Carmen Basilio.

DeMarco showed he was still a serious contender to be dealt with as he won a ten round decision from the very talented Vince Martinez. Martinez started fast winning the early rounds, but DeMarco came on to dominate the rest of the fight and nearly stopping Martinez in the tenth round.

I don't know if Boston will ever again see another boxing show at Fenway Park, but it sure would be exciting. Taking a seat at ringside on that field of dreams would be an unforgettable experience. Maybe some promoter will consider doing it again.

HOOPS and HOCKEY in the HUB

IT DIDN'T TAKE LONG — For the Cleveland Cavaliers to dispatch head coach Tyronn Lue to the hinterlands. In fact, all it took was six regular season games.

With more than 90 percent of the 2018-2019 schedule yet to be played Cavs management decided to dismiss Lue, a former assistant coach with the Celtics. How shocking was it? The coach of last year's Eastern Conference team in the NBA Finals didn't even make it past the two week mark of the current regular season.

And while it was true that the Cavaliers were winless at 0-6 over that short span, much of that can't be blamed on Lue. First of all, megastar LeBron James jumped ship over the summer and signed as a free agent with the Los Angeles Lakers.

Then there is the saga of mainstay Kevin Love. He missed three of Cleveland's four preseason games with a foot injury and tried to play through the injury as the regular season began. Although he had seen action in the first four games, he missed the last two prior to Lue's dismissal. One day after the coach's departure it was announced that Love would be out for a month.

Lue led the Cavaliers to the 2016 NBA Championship — the first Cleveland major sports team to win a title in 52 years. The Cavs were also in the NBA Finals in 2017 and 2018 under Lue but were defeated by the Golden State Warriors both times.

But don't shed too many tears for the coach. The checks from the Cavs will keep on coming since he has two full seasons and the rest of this season left on the five-year, \$35 million contract (\$19,178 per day year round) he signed in 2016. So he's out of a job (at least temporarily) but not out of a check.

Lue has a history of securing success with a team when taking over at midseason. When David Blatt was fired by the Cavs at the midpoint of the 2015-2016 season Lue stepped in and led the Cavs all the way to the title — a run that not only included knocking off the Warriors in the finals, but also tarnishing their remarkable 73-9 regular season mark.

So, when other teams make in-season coaching changes this winter, one of the best will be on the market and available, ready to step in at a moment's notice.

WILL BASEBALL EVER LEARN? — It happened again. Another memorable finish to a thrilling game but one that was seen by far fewer people since the vast majority of Americans were fast asleep when the dramatic conclusion was beamed across the country.

We speak of Game 3 of this year's World Series which ended at about 3:30 am, Eastern Time, meaning it was even after midnight in Los Angeles when the Dodgers walked off the field with their only victory.

The 18-inning, seven-hour plus affair was the longest postseason game in Major League history but few will recall it given the late hour of its conclusion.

Unfortunately, baseball, a grand game if there ever was one, has a number of concerns today. One is that many youngsters are not as enthused with the game as those of prior generations. National surveys indicate they are more interested in watching football or basketball than viewing baseball.

Yet another complication concerns when the games are played, particularly the World Series games. The relatively late starts — around 8:10 pm this year — virtually guaranteed a fighting-to-stay-awake-to-the-finish challenge.

There's a classic saying: "Out of sight, out of mind" and it applies here. Someone once wrote that the Super Bowl was the most popular sports event is America. The writer gave an interesting reason — because everyone is able to see the Super Bowl.

It starts at 6:30 pm Eastern Time (3:30 pm Pacific) which means that people in all four time zones are able to see the game, which normally lasts a little over three hours. Even in the rare occurrence of an overtime, the game would probably only last no longer than an additional half hour.

David Ortiz's dramatic home run that beat the Yankees in 2004 was hit at 1:15 am. This year's dramatic World Series Game 3 ended around 3:30 am. What if those events had happened when millions more were awake? Might baseball be more popular?

The Patriots have won five Super Bowls in the Tom Brady era, none more popular than 2017 event when the Pats erased a 28-3 deficit to claim the title. All five of those Super Bowls, including the one-for-the-ages 2017 finish, were seen at popular hours when everyone was awake — including elementary school children (the adult fans of tomorrow) who had classes the next day.

Imagine if Tom Brady and his teammates had worked their magic in a number of after midnight finishes with a diminished audience because millions had gone to bed. Things might be different, right?

With baseball this fall, it was once again out of sight and out of mind with college football games and pro football previews dominating the next day's sports media programming.

There was a time, decades ago, when every World Series game was a day game. Youngsters could watch most of the games after school, which included all the dramatic finishes — such as Don Larsen's perfect game in 1956 and Bill Mazeroski's Game 7 winning ninth inning homer in 1960. Those days (and we mean that literally) are gone now.

But there are 24 time zones in the world. Thus, when it is late night or early morning here, it is daytime in other locations. One such place is Japan which has a 12-hour difference with the Eastern Time Zone.

That means that all those after midnight finishes here are early to mid-afternoon conclusions there. The dramatic ending of World Series Game 3 took place about 3:30 pm on Saturday afternoon in Japan.

Might that be one reason why baseball is so popular in that Asian nation that lies half a world away — and why it is losing popularity in the nation of its origins.
