Supreme Court to Rule on Controversial Social Media Posts

The Supreme Court is set to hear arguments between Republican led states and the Biden administration on how far the Federal Government's reach is over controversial social media posts on hot button topics, such as COVID-19 and election fraud.

The lawsuit filed by Louisiana and Missouri, accuses the Biden administration of influencing social media sites to censor conservative opinions or points of view. Lower courts ruled in favor of the states, but the Supreme Court has halted these rulings while it hears arguments on these issues.

This isn't the first time the Supreme Court has heard these types of issues. Last month the court laid out standards for when public officials can block social media followers and prior to that the court heard arguments on Republican passed laws in Florida and Texas that prohibit large social media companies from taking down posts due to views expressed.

The states suggest the White House, Surgeon General and FBI have forced changes in online content posted on X (formerly Twitter) and other social media sites. The administration pushed back that none of the actions the states allege come close to problematic coercion. The social media companies are not involved in the case.

Free speech proponents hope the court uses this case to draw a line between acceptable government censoring and the right to free speech. A decision is expected by Summer.

Weed Ups Heart, Stroke Risk Study

A study in the *Journal of the American Heart Association* may help clear up the health effects of using cannabis. The University of California, San Francisco research funded by the National Institute of Health found that people who smoke weed daily are 25 percent more likely to have a heart attack and 42 percent more likely to have a stroke than those who didn't use the drug at all. "We know that toxins are released when cannabis is burned, Similar to those found in tobacco smoke," said Abra Jeffers, a former researcher at the Center for Tobacco Control Research and Education.

Texas Turns on Blackrock

A Texas school fund recently told BlackRock it was terminating its contract to manage nearly \$8.5 billion of state money, accusing the investment giant of boycotting fossil-fuel energy producers, which represents a large part of the state's industry.

BlackRock has denied it is engaging in any boycott, saying the money pulled is a tiny sliver of the \$10 trillion in assets that it manages . Administrators of the Texas Permanent School Fund said BlackRock breached state law.

Crossings Leap to February Record

The nation's southern border set a record for February migrant encounters, with 189,922 attempted crossings as official brace for an expected spring surge, according to new Customs and Border Patrol data.

The data eclipses the prior February record of 166,010 encounters set in 2022, and the 156,000 during the same month last year. The tallies do not include migrants who cross the southern border undetected.

Educators Urge Cellphone Ban in Schools

Around the country teachers are saying students routinely send snap chat messages in class, listen to music, shop on line and many other examples of how cellphones create a distraction for teachers and learning. The grasp these phones have on students and adolescents in American society today has become acceptable behavior, but teachers are now declaring is most parents may not actually be aware of the extent these students are using them in classrooms and schools. The number of educators and administrators urging the ban of these phones during school days is growing daily.

Teachers feel the prohibitive behavior that students used to have about not using phones

in class is gone. Often the only solution for a teacher is to physically remove the cellphone from the student. Many schools have rules regulating the use of phones by students in class, but there is also a growing number of state and federal leaders endorsing cell phone bans. Many teachers believe that when distractions are decreased, learning improves and students are more likely to talk with each other.

Last year Florida became the first state to crack down on phones in schools. In July a law took effect requiring all Florida Public Schools to ban student cellphone use during class time and block access to social media in WI-FI. Oklahoma, Vermont, and


Kansas have all introduced "phone free school" legislation. Nationally 77% of U.S. schools say they prohibit cellphones at school for non-academic use, according to the National Center for Education Statistics.

In order for school cell phone bans to work effectively, educators believe it must be school administration who enforces it and not leave it to the teachers responsibility. Some students fear this policy will take away their means of communication with family and friends and some parents fear being cut off from their kids if there is an emergency. It will take time, effort, and cooperation from many parties to find a policy and system that will work for everyone.

Stirpe Nostra

EVEN FUNERALS HAVE ROOTS

"Funus" is the Latin name for rope, cable, or cord. It is also the name that was given to the funeral rites in ancient Rome. Their Latin word funus, and in turn, our English word funeral, are both derived from the burial procession during those ancient times which employed twisted ropes that had been smeared with pitch and used as torches to light the way. Torches were necessary

because all Roman funerals took place during the hours of darkness.

The funeral rites in ancient Greece predated those of the Romans and probably set the pattern by which later civilizations conducted themselves during those moments of grief. There is no cynicism attached to the following statements and please remember that I'm calling attention to popular beliefs and customs that go back more than five centuries before the birth of Jesus Christ. Those persons who are truly interested in the roots of many Christian beliefs are requested to compare these ancient customs with those of today.

"Elysium" or the "Elysian Plains," in Greek mythology, was the place where chaste, moral, righteous, or virtuous people went after death



with pitch and used as **Rooms X, Hellenistic Age Urns, Vatican** torches to light the way. **Museums**

and where there was complete happiness, paradise, and ideal bliss. The ancient Greeks attached great importance to the burial of their dead. They believed that a soul could not enter the Elysian Fields until the body had been properly buried. Apparently, this feeling was so strong that it was considered a religious duty to throw earth upon an unburied body if one happened to be found.

Among the Athenians, children who might have been released from all other obligations toward unworthy parents were still considered morally and religiously bound to bury them. Neglect in providing a proper burial for one's relative was considered to be a serious charge against the character of any man. The belief was also quite common that the dead had a moral and legal right to

a proper burial.

At the moment of death the eyes were closed by one of those present, an "obolus" (small coin) was placed in the mouth and then the mouth was also closed. This coin was intended, symbolically, to be used as payment for Charon's fare (to be explained later). The body was then washed, anointed with perfumes, and clothed in rich white garments that were burned in the crema-


tion. Laws were passed limiting the number of garments that could be burned. A wreath of flowers was also placed upon the head of the deceased. The body was laid out on an ordinary bed with a pillow that supported the head and back and the feet were turned toward the door. Special vases that contained perfumes were placed beside the body and were usually buried with the coffin or ashes. These vases were very beautiful and were manufactured specifically for funeral purposes. A honey cake was also placed near the corpse. This cake was intended, also symbolically, to be used as a reward for "Cerberus," the threeheaded dog that guarded the gates of Hades, a kind of middle world, which seems to have been the forerunner of our purgatory.

Family members and near relatives gathered around the corpse and wailed or uttered loud expressions of grief.

Many of the mourners even went so far as to beat their breasts, pull their hair, scratch their cheeks, tear their clothes, and sprinkle ashes on their heads. Some families even hired professional singers to lead the mourning chant. The last item to be noted as a part of the death vigil was a vessel of water that was placed near the exit door to the house. This was available so that persons who had been inside could purify themselves from the pollution of death by sprinkling water on themselves.

Biden Signs Executive Order to Advance Women's Health

President Biden signed an Executive Order last week to advance the study of women's health. Women account for half of the U.S. population, yet their health is underfunded and understudied. At one time scientific study was based solely on men. It wasn't until the 1990s that the Federal Government mandated women be included in Federally funded medical research.

Even in present day, research often does not represent women equally regarding illnesses or scientific study. Biden's Executive Order is set to change that. "We still know too little about how to effectively prevent, diagnose, and treat a wide array of health conditions in women," said Dr. Carolyn Mazure, the Head of the White House initiative on Women's health.

Biden claims to be a lifelong believer in the "power of research" to help save lives and provide high quality health care to people who need it. This is also a winning political issue for Biden. First Lady Jill Biden is leading the effort to mobilize and organize female voters.

Women were a huge part of the demographic who elected Biden in 2020, giving him 55% of their vote, according to AP Vote Cast. Black women and suburban women were staunch Biden supporters. The National Institute of Health funds a large amount of biomedical research, which is vital to understanding how medications affect the human body and for deciding how to dose medication. Certain conditions have different symptoms for men and women, including heart disease, while others are more unique to women only, including uterine cancer. The First lady recently announced \$100 million in funding last month for women's health.

FEMA Denies Massachusetts Request

Governor Healey has submitted an appeal over FEMA's denial of Massachusetts request for major declaration regarding the catastrophic flooding to impact the state this past September. Healey emphasized the severity of the damage and the need for assistance in recent correspondence to President Biden and FEMA Regional Director Lori Ehrlich.

"These storms were devastating for our community. I saw the impacts first hand. Homes and businesses were destroyed, roadways and bridges were inaccessible. Six months later they are still rebuilding, the state had done all we can to support the recovery, but the needs far out pace our available resources," the Governor's appeal letter stated.

Healey requested the initial declaration hoping it would result in Federal money to assist with the recovery in the Western part of the state. However, FEMA recently denied the request and rebutted with the belief the state is capable of handling the damage without additional funding. U.S. Represent James McGovern, D-Worcester, expressed frustration and disappointment with FEMA's denial and exclaimed, "Massachusetts is one of the least dependent states in the nation on the Federal Government, and in our time of need, FEMA's slamming the door in our face."

"The flag represents this beautiful country we live in. It also represents the people who fought and gave their lives for it. I am pretty happy I now get to pull up to school in this thing, and I am happy to show off my American pride," Blasek stated.

This inspiring young man received so much support that the school was forced to back down and apologize.

Trump to Add \$3 Billion to Wealth

Investors approved a deal last week to make "Truth Social," owned by Donald Trump, a publicly traded company. This will put an end to a long delayed and anticipated merger that will generate a multibillion dollar pay out for former President Trump.

According to a behind the scenes vote during a recent meeting, a majority of Digital World Acquisition Corporation voted in favor of a merger with

Trump Media. Indications point toward the deal being immediately finalized. The new company will be called Trump Media and Technology Group and trade under DJT, Trump's initials. Shareholders voted to approve the merger following years of legal and regulatory obstacles. Trump will own a dominant stake in the publicly traded company, with his shares worth more than \$3 billion dollars.

Trump would hold 58.1% of the company or approximately 79 million shares. Unfortunately for Trump the shares are not as liquid as it seems, and may not offer a quick solution to his financial issues stemming from the New York Civil Fraud case pending against him. If he doesn't post a \$175 million dollar bond within 10 days, the New York Attorney General will begin to seize his assets.

L'Anno Bello: A Year in Italian Folklore

A Sweet and Sparkling Italian Easter

Few other holidays burst with the same sense of sunshiny joy present in Easter. Every aspect of this feast sparkles with the promise of new life: the buttery yellow daffodils waving gaily in the breeze, the robins tending to their perfectly blue eggs, cuddly bunnies munching on fresh spring grass. When I was a little girl, I viewed Easter as the gateway to spring. It was the occasion for wearing frilly flowered dresses, biting down into creme-filled eggs, and counting my jewel-toned jelly beans. Now that I am older, my attention has turned to the time-honored customs and traditions of Easter. My Italian heritage has made me appreciate the tapestry of Easter folklore and practices held sacred by my ancestors. This tapestry of traditions reflects the spiritual significance of Easter while also paying homage to the springtime. When I incorporate these customs into my contemporary Easter celebrations, I imbue the holiday with recollections of the past and renew the symbolic rituals which have been repeated for generations. Whether they involve wearing new clothes or baking a delicious pie, Italian Easter practices are laden with profound meaning and allegory. Collectively, they represent the Italian love for vitality, feasting and spring.

Easter in Italy, known as Pasqua, brims with numerous examples of regional folk customs. My father fondly remembered a procession known as la Madonna che Scappa in Piazza, popular in his hometown of Sulmona, nestled in the mountains of Abruzzo. Literally translated as "the Madonna who runs in the plaza," this pageant demonstrates the Virgin Mary's joy upon learning that her son Jesus has been resurrected from the dead. The parade begins with the participants solemnly marching down Sulmona's main plaza, bearing a statue of the Virgin Mary draped in black cloth. Suddenly, the funeral robe is lifted, revealing a colorful and beautiful dress

underneath. As fireworks pop, the marchers run at full speed with the statue toward the local church, and the crowd cheers as Mary is reunited with Jesus. In Florence, a spectacle known as il scoppio del carro, or "the explosion of the wagon," also uses fizzing lights to enchant the crowd: a cart laden with fireworks erupts into a fiery display with the twinkling white and gold hues of spring flowers. This love for rebirth and spring is also evident in quaint. widespread Italian folk customs and sayings. One Italian superstition declares that everyone must wear at least one new article of clothing on Easter. The dictum derives from the fact that it was once discouraged to buy clothes during the penitential season of Lent, and Easter offered the irresistible opportunity to step out in new outfits. My family and I always wear new clothes on Easter, and I always felt that this tradition mimicked the new life blossoming during the spring. Italians also celebrate Easter by dyeing eggs, a symbol of eternal life. Italian customs, therefore, mirror both the profound religious meaning of Easter while also honoring the exciting season of spring.

Of course, Easter in Italy also boasts a plethora of characteristic foods and treats. Easter pies, called pastiera, are a staple of Italian Easter meals. Some regions prefer a savory pie stuffed with meat and cheese. However, other areas fancy a dessert pie which, depending on local tradition, can be made with sweetened wheatberries, rice, or ricotta cheese. I make a homemade ricotta pie for Easter, flavored with semisweet chocolate chips and orange peel. The ricotta, chocolate, and orange form a quintessentially Italian combination, and the pie makes a lovely and old-fashioned finale to our Easter lunch. Easter breads also dot the Italian peninsula this time of year. The colomba pasquale, or Easter dove, is a thick cake flavored with citrus



peel and almonds and derives its name from being baked in a dove-shaped pan. Other Italian Easter breads feature colorful eggs tucked into the dough and multihued sprinkles scattered on top of a glaze of icing. It is impossible to be glum when looking at such whimsical creations! Many Easter menus in Italy prominently feature lamb since it is the meat that first becomes available during the spring. I am a vegetarian, however, so I much rather enjoy the adorable lambs carved out of butter or marzipan that adorn Italian bakeries during the Easter season. Finally, no sweet characterizes my childhood Easters more than l'uovo di Pasqua, or the large chocolate egg filled with treats. My father would bring one home sometime around Holy Week, and we would wait until Easter to break it open. What is truly wonderful about Italian Easter food traditions, though, is that they do not end on Sunday. The next day, Easter Monday, is known as la Pasquetta, or "little Easter." Custom calls for outdoor excursions and picnics on this day, a great chance to delight in the spring weather and finish up the leftovers!

Easter truly stands as one of the most extraordinary holidays of the year. Religiously and symbolically, Easter embraces the universal themes of rebirth, renewal, and rejuvenation. Indeed, the English name Easter may originate from Eostre, a Germanic goddess of the spring. After all, spring represents the period of the year in which Mother Earth vibrantly dances out of her winter slumber, and this reawakening of

The image in the newspaper lasted just moments but the sight of that photo's angry display and weaponizing of a US flag will never fade from my memory and of so many others, especially Ted Landsmark, who was the recipient of such hatred.

Sometimes I wonder whatever happened to the young high school dropout from Southie named Joe Rakes? What possessed him to do what he did? Was it just pure hatred? Was it plain angry? Was it just hopelessness? Did he move toward Landsmark to hurt him and for what? Anger makes people do terrible things. I still recognize the young man's image right behind Rake. He was a friend of mine from Charlestown, a good kid with a tough Townie exterior. I am so glad he wasn't holding the flag pole in his hands. I am sure that Rakes wasn't that much unlike my friend next to him.

The period between 1974 up to probably 1978 was not a good time for Boston. There was so much anger and hatred, enough to share across the city's neighborhoods and across people, all people regardless of skin color.

I was living in Charlestown during forced busing. I witnessed the worst of time and the best of times. I blame politicians, lots of politicians who stirred the pot of hate, reeling up the worst inside people. They sat back and watched things play out thinking their hands were clean.

I grew up in Roxbury in the '50s and '60s, my parents sent me to Catholic school because they didn't trust the public schools, and it had to do with education and not race. Growing up where I lived, everyone lived together as best we could. Many of us lived in several of the projects surrounding us. We hung out with each other, did lots of things together. We attended the Emmanuel House after school.

When busing started I was over in Charlestown; I was a recent college graduate, age 25 and already a published writer at that time. I look back at the struggle many parents went through back then. The media loved the struggle and only made matters worse. Nothing surprising there.

As I remember those times, I wonder how anyone could move forward from it all. Somehow, we did. Those times weakened our city of neighborhoods. We have gotten better but the sores of those days will never heal. My feelings of politics changed back then. I realized we let our elected officials speak for us and in the process lost our own voices.

I am still a published writer today and continue to speak up for the city I loved and the people in it who are mostly just like me. I still remember those Pittsburgh Pirates from 1979 who were unlikely champions that year and their theme song was "We are Family."

Today Boston is a much better place where people keep learning to get along with each other. We can't undo the past but we can build a better future. I want that to be the lesson I learned back when our politicians wanted us further and further away from each other. I say Power to the people. In unity there is strength. We cannot undo the past but we can find ways to make the future better.

Charges Against Gold Star Dad Dropped

The Gold Star father who was arrested after shouting at President Biden during his March, 7th State of the Union was just notified that the charges against him have finally been dropped. Steve Nikoui said he was "not very much surprised that the Biden administration hadn't intervened on his behalf sooner."

The charges initially brought against Nikoui were under the jurisdiction of the U.S. Attorney for the District of Columbia, which is under the direct supervision of the United States Attorney General Merrick Garland.

Nikoui was escorted out of the House Gallery during Biden's State of the Union speech after he began yelling "Abbey Gate" and "13 Marines" a number of times. The outburst was in reference to an attack at the Abbey Gate Hamid Karzai International Airport in Afghanistan after the U.S. military's withdrawal. The surprise attack killed 13 U.S. service members and injured hundreds more, including Nikoui's son, Marine Lance Corporal Kareem Nikoui.

The grieving gold star father was approached by congressional security during his tirade and told to stop. He refused and continued on. He was then removed from the House Gallery and arrested by Capital police on the misdemeanor charge

of crowding and obstructing. "Disrupting the Congress and demonstrating in the Congressional Buildings is illegal," U.S. Capitol Police said in a statement.

The Gold Star families have openly criticized the Biden administration since the 13 Marines were killed on August 26, 2021 by a suicide bomber. Biden's withdrawal from Afghanistan resulted in a swift takeover by the Taliban after the government collapsed. The President has yet to apologize to families like Steve's who lost loved ones in the terrorist bombing. The families believe they deserve justice, not prosecution.

Will Michelle Obama run for President?


doubt about whether Biden will actually be the Democratic standard bearer come November.



Saint Laserian



St. Laserian was said to have been of noble birth. He was born around the year 566. His family was of the Ulaid, a Celtic People living in Ireland. Laserian was sent to Scotland to be educated by monks at a very young age. It is not certain at what age that was. As a youth, he was reputed to

have worked extraordinary miracles. As a young man he lived the life of a hermit on the Holy Island off the coast of the Isle of Arran. He lived in a cave. This island became known as Molaise's island. St. Laserian is also known as St. Molaise. He worked many miracles there enabling water to flow when it was needed for milling. He also banished robbers from the vicinity of the monastery.

From that island, Laserian travelled to Rome. It is not known how long he remained there but it is thought to be about four years. He was in the favor of Pope Gregory the Great and was ordained by him. Laserian then journeyed to Ireland to preach the Faith there.

He founded a monastic community at Old Leighlin in South Leinster in the late sixth century. His choice of location was said to have been inspired by Divine Guidance. Laserian was not the first Christian to settle in the Barrow valley. St. Patrick too, is associated with Leighlin. There is a St. Patrick's Well at Ballyknockan near Leighlin. Other saints were associated with the area. Laserian was



reputed not to have settled initially at Old Leighlin.

Laserian went first to Lorum Hill, south east of Muinebheag (Bagenalstown). Here he was directed by an angel to go to where he would see the sun first shining and set up his religious foundation there. The place he chose was Old Leighlin Hill. Another Holy Well at Lorum is named in honor of Laserian. Laserian crossed the River Barrow and came to Old Leighlin. He founded his religious community there. The holy abbot Gobanus and his followers were settled there. Immediately, Laserian's miraculous powers were made manifest

Gobanus and his community moved on and allowed Laserian to remain at Old Leighlin. The monastery at Leighlin continued to grow. Other Holy Men who later became saints themselves visited Laserian at his Monastery. Among them was St. Finbar of Cork and also St. Molua.

St. Laserian is said to have passed away on April 18, between the years 638 and 641. The Feast Day of Saint Laserian is celebrated on April 18.

FRANKIE VALLI

AND THE FOUR SEASONS

OH, WHAT A NIGHT!



When the name — The Four Seasons is mentioned, a good number of people would immediately think of the connection to Frankie Valli and The Four Seasons, not the name of the luxury hotel. Frankie Valli's given birth name is Francesco Stephen Castelluccio, and the soon to be 90-year-old, and lead singer of the legendary group, The Four Seasons, still continues to tour. The popular group inhabited Boston's Wang Theater at Boch Center on Saturday for a sold-out

Since starting out in 1960, Frankie was able to rack up 29 Top 40 hits with the Four

Seasons. Amazing when one realizes that the New Jersey native authored a host of #1 hits, including "Sherry" (1962), "Big Girls Don't Cry" (1962), "Walk Like a Man" (1963), "Rag Doll" (1964), and "December, 1963 (Oh What a Night)" (1975). Plus, the #2 charting "Can't Take My Eyes Off You" (1967), and as a solo artist #1 hits of "My Eyes Adored You" (1974) and "Grease" (1978), penned by Barry Gibb of the Bee Gees. On the basis of that resume, the Four Seasons' original group (Valli, Tommy DeVito, Nick Massi and Bob Gaudio), were inducted into the Rock and Roll Hall of Fame in 1990. They were again inducted in the Rock and Roll Hall of Fame in 1999, this time in the Vocal Group Hall of Fame category.

Valli's performance (Saturday 3/23) at the Wang Theatre was the result of his suggestion that the appropriately named 'Frankie Valli & The Four Seasons: Last Encores Tour,' would end the group's 64-year run. It does leave the possibility that future performances may still be considered when the tour finishes, but all indications were that the rigors of touring (at 90) were likely one of the main factors in Valli's decision.

In a 90-minutes masterpiece, Frankie Valli and The Four Seasons transported the sold-out audience back to the Golden Music years of the '60s and '70s. Hitting the stage of the Boch Center Wang Theatre in a black velour tuxedo jacket, Frankie Valli was surrounded by The Four Seasons, attired in black suits, black shirts and ties and possessing golden voices and an unbelievable harmony. Together they delivered covers of 22 songs mainly recorded by Frankie Valli and The Four Seasons, and a handful of Valli solos, along with other artists. They opened the celebration performing the title track from the film Grease, a song written by Barry Gibb of the Bee Gees in 1978. It was the beginning of a wonderful night for the mixed aged audience, as Valli injected a bit of humor early in the show, remarking that he hadn't been in Boston more ... because he wasn't invited! From that point on the audience was on their feet for the rockers, and singing along for the many tunes that followed.

Following were a set of hits from 1964 included, "Dawn (Go Away)," "Save It For Me," and Valli remarked to the audience he needed to slow things down so he could rest, then sang "Silence Is Golden," the B-side of their hit single "Rag Doll," which they performed later in the show as part of their encore. Additional songs from the sixties surely must have brought back some wonderful memories for the adoring audience, with "Sherry," the first big hit for Valli and The Four Seasons, "Big Girls Don't Cry," "Walk Like A Man," a solid cover of Maurice Williams and The Zodiacs' doo-wop hit from the '60s - "Stay," complete with Valli falsettos. After the band introductions which included three horns, three guitars, a drummer, and his musical director for over 40 years, Robby Robinson on piano, the show continued with Valli's selfadmitted favorite Frank Sinatra's signature song, the Cole Porter penned "I've Got You Under My Skin," plus the upbeat "Opus 17 (Don't You Worry 'bout Me)," "Tell It To The Rain," and "Working My Way Back To You."

The three-piece horn section was outstanding on the night, along with the tight and precise vocalizing of The Four Seasons quartet, providing Valli with all the support he needed to deliver his powerful performance. One of the many highlights was the cover medley of The Temptations' 1965 hit "My Girl," and The Rascals' 1967 hit "Groovin'," written by Felix Cavaliere who recently passed away. Valli turned romantic via "Who Loves You," "My Eyes Adored You," and "Can't Take My Eyes Off You," before pointing to Heaven and "Swearin' To God," which featured a dynamite saxophone solo and an explosive guitar solo, both of which received overwhelming applause. The night was still filled with hit after hit, and the band's energy was infectious as they delivered "Beggin'," the excitement of "December, 1963 (Oh, What A Night)," "Bye, Bye, Baby (Baby Goodbye)," and the show came to a close with the encore finale, "Let's Hang On!" Valli's fans came out to honor him and his lengthy career, and in turn, Valli honored them with a night that many will long remember ... or to sum it up, "Oh, What A Night!"

A Nostalgic Remembrance

Maybe I'm getting older, but life seemed simpler back when I was a kid. It might be that everything was new to me and everything was part of a learning experience. One thing I've realized is that nothing stays the same. Part of the simplicity package was the way we shopped. Much of it was done at the corner grocery store. Actually, there were no supermarkets in East Boston or the North End. Today, those corner grocery stores are called convenience stores, but 7-Eleven made sure it's not the same. Let me give you examples of the

Nanna might say to me, "I ran out of soap powder. You go to the corner store and see what they have." She would give me a quarter and I would head for Cutliff's Variety Store which was on the corner of Eutaw and Brooks Streets in East Boston. Mr. Cutliff would be behind the checkout counter which was on the right just as you entered. He would be wearing a white apron, a straw hat and a pencil atop his right ear. He'd say hello and I'd smile back and head to where the soaps were located. There were basically only three brands that the women in my neighborhood used, Duz, Rinso and Super Suds. I knew that Nanna liked Duz, but before I picked up the box, I searched the rack. They had bar soap with names like Lifebuoy, Lava, Lux, Palmolive, and Ivory. But Nanna wanted Duz for her washing machine and that's what I bought.

Nanna was one of the few in the neighborhood who had a washing machine. Most of the women washed their clothes in the kitchen sink using a scrub board and a brush. When the clothes were clean, the water would be drained from the sink and each garment would be wrung out by hand. The next step was to dry out the clothes. That meant opening a window, taking clothes pins from a bag hanging outside the window and hanging the clothes on the clothes line which stretched from the house to a pole or tree on the other side of the back yard. When Nanna hung everything on that line, which was usually on a Monday, as that was wash day, the entire neighborhood knew what she owned: Nanna's underwear, her house dresses, Babbononno's long underwear, sox, shirts, his work clothes, table cloths that no longer showed wine and gravy stains, and handkerchiefs. The only articles that didn't go on the line were the lace curtains, table cloths and doilies. They would be dried on a stretcher, a frame with two or three horizontal strips of wood, one on the top, one in the middle and one on the bottom. Connecting them were three vertical strips of wood, one on each end and the other in the middle. The entire contraption was about

five feet tall and about six feet long. There were nails facing you every couple of inches and everything lace was hung of the nails to prevent them from shrinking as they dried. In the good weather, these stretchers were located in the back yard. In the winter, they were in the cellar

Dad would often send me back to that same corner store to buy cigarettes. When I was a kid, they were fifteen cents a pack, or two for a quarter. Today, there are dozens of choices and the cost is over eight dollars per pack. Back then, the cigarette packs were housed in cubby hole shelves behind the checkout counter. You had your choice of Camels, Lucky Strike, Chesterfield, Philip Morris, Old Gold, Pall Mall, Kools, and Raleigh. There were those that liked king size cigarettes and they bought Pall Mall. Kools were mentholated and had a cork tip. Raleigh had redeemable coupons. If a smoker didn't want to spend the fifteen cents, you could buy mongrel brands like Wings or Alligators. They were cheaper. For those who really didn't want to spend much money, they sold Bull Durham. This brand was a do-it-yourself selection. For five cents, you received a little bag of cigarette tobacco and a pack of rolling papers that allowed the owner to roll thirty cigarettes. When I would ask the owner for two packs of Old Golds, Dad's brand at the time, there was no question as to age. He knew that they were slated for my father. Once in a while, Babbononno would give me a dime to buy two American cigars for him. He was used to the Perodi and DiNobili brand of stogies, but when he wanted an American cigar, he would say, "Jenny, me compra due cigari, uno Dexter e uno sette-ventiquattro." (Johnny, buy me two cigars, a Dexter and a 7-20-4) It wasn't until the early 1950s that new brands of cigarettes hit the market and many arrived with filter tips and king-sized lengths Winston, Marlboro, Salem, Tareyton, Parliament, Benson and Hedges, L and M, Viceroy and Kent, most in fliptop boxes.

Today, you can go to any of the convenience stores and buy a lottery card using your favorite numbers, or purchase they type of card where you scratch the surface with a coin to reveal numbers or objects that allow you to win an amount of money. Back when I was a kid, there was no such concept. The Massachusetts Blue Laws prohibited any form of gambling. The folks in my neighborhood could not be deterred from playing their favorite numbers. There was a corner bookie who took the bets. The federal security numbers would be published in the Evening Record, a tabloid sized nightly newspaper. If your number came out, you could win approximately seven dollars for every cent gambled. Once in a while, Nanna would

The Tagano, or 'u Taganu', is a traditional Easter pie hailing from the town of Aragon in Sicily's province of Agrigento. This delectable baked pasta dish gets its name from the terracotta pot it was traditionally cooked in. It is prepared on the afternoon of Holy Saturday and is a staple during the Easter Monday picnic festivities throughout Southern Italy. The Tagano Festival of Aragon celebrates this rich and savory pie on the Sunday after Easter, showcasing its delicious Sicilian flavors.

As with any other Sicilian recipe, families put their own spin on many of these classic dishes since immigrating to this country. When it comes to the Tagano of Aragon, staples like eggs, Tuma cheese, rigatoni, and minced meat are always present, regardless of the adaptation. Some variations involve lining the terracotta pot with cheese and others call for the use of sliced bread. The recipe I'm presenting today stays true to its roots while providing a delightful and straightforward twist on a classic favorite that is guaranteed to please every taste bud. *From my home to yours, Buona Pasqua!*

TAGANO of ARAGON Baked Pasta Pie



1-pound rigatoni pasta, cooked al dente

1-pound Tuma cheese, sliced 3 cups fresh Pecorino Romano, Caciocavallo or Parmesan cheese, grated

24 (2 dozen) large eggs

½ teaspoon cinnamon
 ½ cup fresh parsley, chopped
 ½ pounds veal or pork minced meat, or mini meatballs
 Salt and pepper

Preheat the oven to 350°. Grease an 8-quart round terracotta baking dish or a Dutch oven.

In a large mixing bowl, beat the eggs and continue beating while adding the cinnamon, salt, pepper, parsley and grated cheese.

Cover the bottom of the pan with a couple of ladles of the egg mixture, then add a layer of rigatoni and mix. Layer the meat and then Tuma cheese. Repeat this process, ending with a layer of Tuma cheese. Pour remaining egg mixture over top of Tuma and add additional grated cheese if desired.

Cover and bake for about 1 hour. Carefully remove the cover of the baking pan at the 35 minute mark and continue to bake until golden and bamboo skewer inserted in the center comes out clean or slightly wet, from the cheeses. Do not overbake or it will dry out.

Allow the Tagano to cool for an hour before carefully transferring to a flat plate or wooden board. Serve at room temperature and refrigerate leftovers.

Guglielmo Marconi

Guglielmo Marconi was born at Bologna, Italy, on April 25, 1874, the second son of Giuseppe Marconi, an Italian country gentleman, and Annie Jameson, daughter of Andrew Jameson of Daphne Castle in the County Wexford, Ireland. He was educated privately at Bologna, Florence and Leghorn. At an early age he took a keen interest in physical and electrical science and studied the works of Maxwell, Hertz, Righi, Lodge and others. In 1895 he began laboratory experiments at his father's

country estate at Pontecchio where he succeeded in sending wireless signals over a distance of one and a half miles.

Marconi traveled to England in 1896 to seek a patent for his apparatus. One was granted to him that year - the first patent ever granted for a system of wireless telegraphy, (voice radio). After demonstrating the system's ability to transmit radio signals across the Bristol Channel, he established the Wireless Telegraph and Signal Company Limited (re-named Marconi's Wireless Telegraph Company Limited in 1900).

In 1899, Marconi was able to transmit signals across the English Channel, from Britain to France. A vear later, he received a patent for "tuned or syntonic telegraphy." This patent number 7,777 allowed simultaneous transmissions on different frequencies. Thus, stations next to one another were able to operate without interfering with the others' signals. In` December 1901, determined to prove that wireless waves were not affected by the curvature of the Earth, he used his system for transmitting the first wireless signals across the Atlantic between Poldhu, Cornwall, and St. John's, Newfoundland, a distance of 2100 miles.

Between 1902 and 1912 he patented several new inventions. In 1902, during a voyage in the American liner "Philadelphia", he first demonstrated "daylight effect" relative to wireless communication and in the same year patented his magnetic detector which then became the standard wireless receiver for many years. In December 1902 he transmitted the first complete messages to Poldhu from stations at Glace Bay, Nova Scotia, and later Cape Cod, Massachusetts, these early tests culminating in 1907 in the opening of the first transatlantic commercial service between Glace Bay and Clifden, Ireland. In 1905 he patented his horizontal directional aerial and in 1912 a "timed spark" system for generating continuous waves.

In 1914 he was commissioned in the Italian Army as a Lieutenant being later promoted to Captain, and in 1916 transferred to the Navy in the rank of Commander. He was a member of the Italian Government mission to the

United States in 1917 and in 1919 was appointed Italian plenipotentiary delegate to the Paris Peace Conference. He was awarded the Italian Military Medal in 1919 in recognition of his war service.

During his war service in Italy he returned to his investigation of short waves, which he had used in his first experiments. After further tests by his collaborators in England, an intensive series of trials was conducted

in 1923 between experimental installations at the Poldhu Station and in Marconi's yacht "Elettra" cruising in the Atlantic and Mediterranean, and this led to the establishment of the beam system for long distance communication. Proposals to use this system as a means of Imperial communications were accepted by the British Government and the first beam station, linking England and Canada, was opened in 1926, other stations being added the following year.

In 1931 Marconi began research into the propagation characteristics of still shorter waves, resulting in the opening in 1932 of the world's first microwave radiotelephone link between the Vatican City and the Pope's summer residence at Castel Gandolfo. Two years later at Sestri Levante he demonstrated his microwave radio beacon for ship navigation and in 1935, again in Italy, gave a practical demonstration of the principles of radar, the coming of which he had first foretold in a lecture to the American Institute of Radio Engineers in New York in 1922.

He has been the recipient of honorary doctorates of several universities and many other international honors and awards, among them the Nobel Prize for Physics, which in 1909 he shared with Professor Karl Braun, the Albert Medal of the Royal Society of Arts, the John Fritz Medal and the Kelvin Medal. He was decorated by the Tsar of Russia with the Order of St. Anne, the King of Italy created him Commander of the Order of St. Maurice and St. Lazarus, and awarded him the Grand Cross of the Order of the Crown of Italy in 1902. Marconi also received the freedom of the City of Rome (1903), and was created Chevalier of the Civil Order of Savoy in 1905. Many other distinctions of this kind followed. In 1914 he was both created a Senatore in the Italian Senate.

In 1905 he married the Hon. Beatrice O'Brien, daughter of the 14th Baron Inchiquin. In 1927, he married the Countess Bezzi-Scali of Rome. He had one son and two daughters by his first and one daughter by his second wife. Marconi passed away in Rome on July 20, 1937.

Old Chelsea Soldier's Home to Become Safety Net Housing

Massachusetts will open an additional temporary shelter for migrant and homeless families in April at the former Chelsea Soldier's Home, which is currently vacant and was previously scheduled to be demolished. The state opened a new veteran's home in Chelsea this past December. "This was a building that was vacant, that was set to be demolished, and could be quite easily and readily repurposed into a safety net site," according to Governor

Massachusetts Secretary of Veteran's Services, Jon Santiago, noted "none of the veteran's services will be affected by this move." Healey's administration said the temporary shelter will serve pregnant women and families with children who are waiting for placement in the state's current over capacity emergency shelter program.


"We have said for months now that our system is at capacity, and we do not have the space, providers or funding to continue expanding," Emergency Assistance Director General Scott Rice said in a statement.

The state continues to spend a reported \$75 million a month on the emergency shelter program for 7,500 families, costing \$10,000 per family. How are we the wives, husbands, parents sons, daughters and siblings of our illustrious United States Veterans, expected to sit back quietly and watch the continued disrespect shown to our service members as they are so easily tossed aside. If the state politicians would smarten up and change the right to shelter status of Massachusetts, we instead might be renovating this site for additional veteran housing rather than for those crossing the border illegally.



Spring Garden Cleanup with Pollinators in Mind

Adjusting your spring cleanup schedule will help pollinators like this bee on an allium flower.

Spring cleaning, indoors and out, is a long-standing tradition for many households. But as we learn more about the important pollinators, insecteating toads, songbirds, and beneficial insects, the more we realize we need to adjust some of our timing and methods.

It is safe to remove winter protection, such as mulch, when the temperatures begin hovering around freezing or your plants are beginning to sprout. Keep some frost protection handy just in case you need to protect any tender plants from a hard freeze.

Always check for frost heaving. When cold winters are interrupted by warm spells, bare soil may thaw and then refreeze. This temperature fluctuation can cause the soil to shift and push spring flowering bulbs, coral bells, daylil-

ies, and other perennials out of the soil. Just gently push them back in place or reset in the soil making sure the roots are covered.

Wait for temperatures to be consistently above 50 degrees to start cutting back perennials that were left standing. This allows any beneficial insects overwintering in the hollow stems time to emerge and find a summer home.

Cut some of the stems to the ground and some back to 18 to 24" on each plant. These old stems provide summer homes for some of our native bees. As new growth emerges in spring, it will mask the older stems so your garden will look as beautiful as ever.

If you can't wait, stack the stems out of sight until temperatures warm and pollinators have a chance to emerge.

Then chop and compost the debris in mid-summer.

Tie or bungy cord tall ornamental grass plants before cutting them back to make cleanup easier. Then use a hand pruner for small jobs or a string trimmer or hedge clipper for larger plantings. Wait for new growth to fill in shorter grasses and simply comb your fingers through the plant removing the old brown

Leave fall leaves on the soil surrounding the plants to serve as mulch, suppressing weeds and conserving moisture. As the leaves break down, they add organic matter and nutrients to the soil. They also provide homes for beneficial insects and insulate the soil for plants, toads, and more

Mark the location of perennials like butterfly weed and hardy hibiscus that emerge later than most plants in spring. This helps to avoid accidentally weeding them out. Leave a few stems standing, use plant markers, or next fall plant some spring flowering bulbs near the plants to serve as a colorful placeholder.

ny spots bare for groundnesting bees. Avoid areas like entryways and gathering spots where people and the bees may collide. Although the bees are docile and not likely to sting, people are often fearful leading to their elimination. Setting aside some out-of-theway spaces for ground-nesting bees allows everyone to coexist more happily.

Consider leaving some sun-

This is also a good time to tidy up garden beds and lawn edges. You'll slow the invasion of weeds and grass into garden beds and lawn encroaching onto walks.

Remove weeds as they appear. The smaller weeds are easier to remove and eliminating them before they flower and set seed means fewer weeds you'll need to pull in the future.

Take advantage of the delay in spring cleaning by cleaning and sharpening your tools. When the temperatures are right, with tools in hand, you



give me a piece of paper with her name on it and a series of three or four number combinations. She would add a nickel with the piece of paper and tell me to give it to the bookie who would know what to do from there. This was part of the weekly shopping as far as my little mind was concerned.

If I was a good kid, I would get a nickel for a treat. I liked soft drinks and the choice was limited, Coca Cola, Pepsi Cola, Royal Crown Cola, 7 Up, and orangeade. There was another brand that Mom liked, Moxie. It was bitter and nasty to my taste buds, but to Mom, anything bitter or bad tasting was good for you. There was a local bottler in East Boston that sold soda for about a dime less than the major brands. Saraford made several flavors of soda and most were popular in my house. I liked my Royal Crown Cola and Saraford orangeade.

The one thing that I never bought at the corner store was bread. They sold American bread: Wonder Bread, Bond Bread and bread from the Cushman Bakery. We never ate American bread. According to my family, you bought bread at


Martinez hit .271 with 33 homers and 103 RBI in just 113 games last season for the Dodgers. The Mets are hoping great things out of him for the upcoming season.



ROBERT EDGREN


Artist, Journalist, Athlete Boxed with Jim Corbett

Robert Wadsworth Edgren excelled in many fields. He became best known for his boxing writing, but was good at just about everything he tried.

While attending the University of California in the late 19th Century he was recruited for the track and field team for throwing events. At 6'5" and weighing 225 pounds he went on to set the world record in the hammer throw in 1901. In 1906, he competed in the Olympic Games in Athens.

Edgren went on to enroll in the Mark Hopkins Institute of Art when that school became affiliated with the University of California. While still in school he got a job at

the San Francisco Examiner, which was owned by William

Randolph Hearst. Hearst had taken a liking to Edgren and hired him even though he had no experience.

Upon graduating in 1896 he went to work for the paper full time. His coverage of the Jim

Corbett vs Bob Fitzsimmons heavyweight title match held at Carson City in 1897 gained him notoriety and a national readership. All this time he continued with his athletic endeavors.

While Edgren was spending time at Corbett's training camp reporting on the champ's progress, Gentleman Jim noticed his size and athletic prowess. He suggested the two spend some time in the ring sparring. For the next five weeks Edgren and Corbett sparred on a daily basis, though by Edgren's own admission he wasn't much of challenge to Gentleman Jim.

Fortunately, he survived to cover the fight.

I can't think of another time when a journalist sent to cover a world champion in training for a title fight became a sparring partner of the champ.

Bob Edgren not only was a great boxing scribe; he was also an outstanding artist who added illustrations to his columns. Beyond his talent as a writer and artist, he also had a reputation for his honesty. In the days of no-decision fights, gamblers would rely on the judgment of newspaper men when settling their bets. Often times reporters were paid off by unscrupulous bookies in order to reflect the outcome of a

fight that would be most profitable to them. Edgren never lowered himself to that practice.





HOOPS and HOCKEY in the HUB

There he was. Back where his days as an NHL coach had begun. It was as an assistant, back then, mind you. But it was still the big time with the planes, fine hotels and a world removed from those minor league bumpy bus rides.

Yes Peter Laviolette could appreciate that more than most

Yes, Peter Laviolette could appreciate that more than most people. For he was a winner in the lottery of life, a person selected by circumstances whose genesis would eventually snowball into outsized proportions leading forward to a career that would span decades across the hockey world and the sport he loved.

And thus it was that Peter Laviolette, a native of Franklin and a graduate of Westfield State University, climbed behind the visitors bench at the TD Garden on a late March evening, prepared to coach his 1,500th game in the National Hockey League.

It had been so many years since he had been discovered by a scout who had either been given the wrong directions or misunderstood the information he had been given.

Coming down a ramp off interstate Route 91 in Western Massachusetts, long before the era of Google Maps would come into existence, the scout asked for directions to a certain college game where a player he wanted to see was in action.

Instead, he would wind up at another college game miles away from his intended destination, instead parking his car at a rink where Westfield State was playing and one Peter Philip Laviolette, Jr. was on the ice as his senior season was winding down

The scout liked what he saw and that led to the offer of a pro contract. Soon, Laviolette, a defenseman, was continuing to play the game he loved all the while being paid to do it.

However, big-time success on the ice was not forthcoming. He had a 10-year minor league career, complete with a very brief 12-game "cup of coffee" with the New York Rangers during the 1988-1989 season.

When that brief stay with the Rangers came to an end, little did anyone realize that one day he would be back, directing the Blueshirts from behind their bench during his 1,500th game as an NHL coach.

Laviolette finished off his minor league career by playing four years with the Providence Bruins, a time that ended in the spring of 1997. Never to skate in a pro game again, it soon became evident that it was off the ice where Laviolette would find his calling, rather than gliding across the glistening surface.

It was a mentoring job on one of the lower rungs of the pro hockey ladder — head coach of the Wheeling, West Virginia Nailers of the East Coast Hockey League. But by the spring of that 1997-1998 season the Nailers had indeed nailed it: a 37-24-9 record and berth in the playoffs that carried them into the third round.

The next year Laviolette was back in Providence, as the P-B's head coach. The result: a 56-15-4 regular season record, the Calder Cup Championship and AHL Coach of the Year honors.

By the fall of 2000 Laviolette was an assistant with the Big B's on Causeway Street. But the unforeseen intervened. The team got off to a slow start and head coach Pat Burns was fired 10 games into the season. The speculation was that Laviolette might get the job but Mike Keenan was brought in to coach the team.

Discouraged, Laviolette finished out the year in Boston and found his first NHL coaching job as the head coach of the New York Islanders the following spring. In the two seasons he was there, the Isles made the playoffs but were eliminated in the first round. Former Bruin (and then Islanders GM) Mike Millbury, issued the pink slip in the spring of 2003 — just 36 months before Laviolette hoisted the 2006 Stanley Cup as the head coach of the Carolina Hurricanes.

Revenge against the Bruins came for Laviolette during the 2010 Stanley Cup Playoffs, as he took down the Bruins in the so-called "meltdown" series. Up 3-0 in games, the B's saw the Flyers come back to tie the series at 3-3 to force a decisive game seven. Then, up 3-0 in game seven, the Bruins saw the unthinkable happen as Philly came back to win 4-3 and capture the series. The Flyers eventually lost to Chicago in the Stanley Cup Final.

People tend to forget the "meltdown" series since the very next year, the Bruins went on to capture the Stanley Cup Championship. But for the entire 2010-2011 regular season, the B's had to live with the disastrous result of the "meltdown" series.

So, there must have been some additional satisfaction when Laviolette left the bench following the Rangers 5-2 victory over the Bruins on March 21st. Down in Gotham, it always feels nice when a team based in New York can beat one from the Hub. But there must have been somewhat of a special feel knowing that the 1,500 game milestone came against a franchise that nearly a quarter of a century ago chose to bypass him and select another from outside the organization. And what happened to Mike Keenan? He was gone at season's end.

In addition to winning it all with Carolina in 2006, and making it to the 2010 Stanley Cup Final with Philadelphia, Laviolette also guided Nashville to the 2017 SCF where the Predators lost to Pittsburgh.

Yes, it has been a long and winding road for Peter Laviolette since that scout showed up that day at a rink, other than the one he was supposed to visit, and saw a Division Three player competing in one of his last collegiate games.

There have been many positive turns (and a few pink slips) since that moment but more than 1,500 games later the saga continues. The Rangers will make the playoffs this season by earning a berth through their high finish in the Metropolitan Division.

Beyond that, as veteran coach Peter Laviolette can tell you, the possibilities are without limit.
