## POPE FRANCIS I

December 17, 1936 - April 21, 2025



Pope Francis I, passed away on Easter Monday, April 20, 2025. Pope Francis, 88 years old, was the first South American and Jesuit Priest to ascend to the seat of St. Peter, the most powerful position in the Catholic Church. Cardinal Kevin Farrell, the Vatican camerlengo, the temporary head of the Vatican between the end of a papacy and the beginning of a new one, confirmed the pontiff's death. "Dearest brothers and sisters, with deep sorrow I must announce the death of our Holy Father Francis. His entire life was dedicated to the service of the Lord and of his Church. He taught us to live the values of the Gospel with faithfulness, courage, universal love, especially for the poorest and most marginalized. With immense gratitude for his example as a true disciple of the Lord Jesus, we commend the soul of Pope Francis to the infinite merciful love of God, One and Tribune."

Jorge Mario Bergoglio, Pope Francis I, was born in Buenos Aires, Argentina, the eldest of 5 children, to Mario Jose Bergoglio, an accountant from Italy, and Regina Maria Sivori, the daughter of Italian immigrants. December 13, 1969, he was ordained a priest with the Jesuit religious order, named auxiliary bishop of Buenos Aires and in 1998 named archbishop of the Argentine capital.

On February 21, 2001, he was elevated to cardinal by Pope John Paul II, was elected Pope on March 13, 2013, he was the first to take the name Francis, after St. Francis of Assisi.

## Credit Late Fee Scrapped

A federal judge recently threw out a U.S. Consumer Financial Protection Bureau rule capping credit card late fees at \$8 after the agency agreed with opponents that the rule adopted during the Biden Administration was illegal.

U.S. District Court Judge Mark Pittman in Fort Worth, Texas, granted a joint request by the CFPB and other interested parties to cease the cap.

## White House Still Supporting Hegseth

The White House continues to back Defense Secretary Pete Hegseth after a report just revealed he sent information about the March strike against the Houthis in Yemen to friends and family members via Signal chat group.

When asked by reporters during an Easter Egg Roll, Karoline Leavitt replied that Hegseth was "doing a great job." However, U.S. Rep. Don Bacon, R-NE, stated, "If this is true that he had another Signal chat with his family about the missions against the Houthis, it's totally unacceptable ... I find it unacceptable and I wouldn't tolerate it if I was in charge."

# Massachusetts Officially Kicks off 250th Anniversary of American Revolution

Paul Revere Departs North End for Historic Ride

The City of Boston, and the North End neighborhood, was the place to be as the 250th Anniversary of the American Revolution was officially launched, commemorating Paul Revere's legendary midnight ride and the "two if by sea" lantern signal from the

Old North Church. There were a number of events over the weekend honoring the historic events, including reenactments, educational programs and community celebrations. People of all ages, differing cultural and geographical locations all passionately and enthusiastically participated in the festivities, soaking in the history.

A traditional lantern service was held at the Old North Church on Salem Street, where historian Heather Cox Richardson delivered a keynote address focusing on the lantern signal that warned of the British Troops movements in 1775, culminating in the lighting of lanterns in the church's steeple, highlighting the original "two if by sea signal."

Visitors gathered at the Paul Revere House to witness "Paul Revere Bids farewell," a reenactment of Revere's departure from his home as he sets off on his historic ride. At Langone Park on

# Stirpe Nostra

## **SATURNUS**



Temple of Saturn, in the Forum Romanum, Rome

Saturnus is the proper Latin name for the Roman god, Saturn, who was the subject of this column last week. He was considered to be a mythical king of Italy, who introduced agriculture and civilization into that country. The Romans identified Saturn with the Greek god Cronus. They also made Saturn the father of Jupiter (thunder and lightning), Neptune (sea), Pluto (lower world), and Juno (wife of Jupiter). The reign of this mythical king is said to have been a golden age for Italy, and especially for the aborigines (earliest known inhabitants of that country).

The legend of Saturn tells us that he came to Italy during the reign of the god Janus and was hospitably received. Saturn formed a settlement on the Capitoline Hill (one of the famous Seven Hills of Rome), which at that time was called the Saturnian Hill. He taught his people agriculture, suppressed their savage mode

of life, and introduced civilization and morality. He and his reign became so popular that the whole country was called Saturnia, or "The Land of Plenty."

Saturn was suddenly taken from this mortal world and ascended to the abode of the gods. Because of this incident, we are told that the part of Italy which is now called Latium (Tivoli, Frascati, Subiaco, Anagni, Viterbo, Caprarola, Toscanella, Fossanova, and Ostia), received its name from "Lateo," which means, "To live a retired life."

The remains of the Temple of Saturn still overlook the rostrum in the Forum Romanum. There are now only eight Ionic columns standing on a huge concrete base. It was originally built in 497 B.C., rebuilt about 284 A.D., and is one of the oldest sanctuaries surrounding that Forum. Here, under the protection of Saturn, they kept the standards, or flags of their

legions, and a very formal ceremony was required whenever those standards were removed or returned to their vault. A secret chamber below the temple held the public treasury, a store of gold and silver to be used only in case of extreme need. This temple was also used as the archives for the bronze tablets containing the engraved decrees of the Roman Senate.

The statue of Saturn which stood in his temple was hollow and filled with oil. Some historians say that this represented the abundance of olives in Latium. Also, the feet of Saturn's statue were wrapped in a ribbon made of wool. This reference to oil and wool recalls to my mind the last part of the proper ancient Roman wedding ceremony. Before entering her new home, the Roman bride tied some wool around the doorposts and then anointed it with oil to signify health and plenty.

## **Boston Marathon 2025**

A First and a Record

Marathon Monday 2025 served as the finale to a celebratory long weekend in the city of Boston, beginning with the 250th anniversary of the American Revolution, phasing into a glorious Easter Sunday while phasing out of Passover, easing into game 1 of the Celtics quest for Banner 19, holding steady on a

traditional early morning Patriot's Day Red Sox game and finishing with a marathon course record and sibling repeat.

Sharon Lokedi broke the Boston Marathon course record, while fellow Kenyan, John Korir, joined his brother as a race champion of the 129th running of the crown jewel of all marathons. Lokedi beat out one-time defending champion Hellen Obiri in the final mile, finishing in 2 hours, 17 minutes and 22 seconds — 19 seconds ahead of Obiri and 2 1/2 minutes faster than the previous Boston best.

Korir finished in 2 hours, 4 minutes and 45 seconds, the second-fastest winning time in race history. At the marathon finish line in Copley Square, Korir was welcomed by his older brother Wesley Kirir, a 2012 Boston Marathon winner. The Korir brothers are the first siblings, or relatives of any kind, to win the world's oldest and most prestigious marathon.

On the 50th anniversary of wheelchairs competing in the marathon, Marcel Hug of Switzerland clocked in at 1 hour, 21 minutes and 34 seconds to claim his eighth Boston Wheelchair title. Susannah Scaroni of the U.S.A. won the women's wheelchair race for the second time, finishing in 1 hour, 35 minutes and 20 seconds, guaranteeing that the "Star-Spangled Banner" would play at the finish line on Boylston Street in Copley Square on Patriot's Day, the traditional state holiday that commemorates the American Revolution.

## What is a Real ID?

TSA to Begin "Phased Enforcement" of REAL ID Requirement Beginning May 7, 2025

Thanks to a United States security law passed twenty years ago, Americans are now required to update their driver's license or identification cards to become REAL ID-Compliant, or they will not be able to board U.S. airlines. The May 7, 2025, deadline is fast approaching, so if you have not already taken the necessary steps, you should do so ASAP!

On May 7, federal agencies, including the Transportation Security Administration (TSA), will no longer accept driver's license or ID cards that do not have a star in one of the upper corners to represent their Real ID verification. To become REAL ID compliant, you must provide additional information like a Social Security number. Flyers who do not have REAL ID verification on their license should plan on using a passport, a passport card, a permanent resident card, military ID or an enhanced driver's license offered by certain states.

TSA will begin "phased enforcement" on May 7th, but it's still unclear if that means turning away travelers without proper documentation or subjecting them to an additional security screening. The Department of Homeland Security (DHS) website state's "travelers without a REAL ID compliant license or acceptable alternative beginning May 7, 2025, will not be permitted through the security checkpoint." In a federal rule established this year, the TSA says its "phased approach" could last two years, with the potential to issue warnings to people without REAL ID verification. Access to other federal facilities will also require a REAL ID.

Check with your local Registry of Motor Vehicles (RMV) on how to obtain a REAL ID or make an appointment to get a new compliant license. Drivers who have recently renewed their license may already have a REAL ID. You'll need proper documentation to show your full legal name, date of birth, social security number and lawful status, as well as two proofs of address. If you do not have your social security card, you can provide a W-2 or pay stub with your name and Social Security number on it.

For anyone wondering the purpose of this new requirement, Congress passed, and former President George W. Bush signed the REAL ID Act in 2005 after the 9/11 Commission warned that it was too easy for terrorists to obtain a driver's license. Implementation of the law has been delayed in getting all 50 states and U.S. Territories to embrace the new requirements and begin issuing advanced identification, which the federal government estimated would cost approximately \$11 billion dollars in 2007. TSA senior officials believe that REAL ID's "bolster safety by making fraudulent ID's harder to forge, handicapping criminals and terrorists," while some conservatives feel Americans are now required to jump through more hoops just to travel within our own country.





## L'Anno Bello: A Year in Italian Folklore

May Day Brings the Magic

Looking out my window, I can see that the trees no longer hide their blossoms. Just moments ago, it seems, branches stood bare, with only the tiniest speck of a green bud poking through. Now the vibrant tone of fresh, young leaves fulfills the spring promise made by these delicate early sprouts.



May Day, as evident by the name, occurs on May 1st every year. The ancient Celts celebrated May Day as a holiday called Beltane. Beltane marked the beginning of summer, the time when livestock were moved to wider pastures for grazing. In the majority of European countries, May Day festivities begin the prior evening on April 30th. This is Walpurgis Night, a feast in honor of a mysterious Saint Walpurga. Since May Day serves as a transitional seasonal milestone, poised on the cusp between spring and summer, people in older times believed that witches, fairies, and sundry other supernatural beings rambled through the Earth during this liminal evening.



Contemporary Scandinavians and Northern Europeans still dress like witches on Walpurgis Night, welcoming May Day with bonfires and picnics. Italians also link the month of May with the paranormal. The ancient Romans dedicated May to the worship of the dead, perhaps prompting the old superstition that it is unlucky to marry in May. Europeans now celebrate the woodland sprites thought to be especially active in May, and indeed, May Day festivities revel in the wonder of the springtime forest. People adorn their homes with greenery and, in a remnant of an old fertility ritual to help crops grow, dance around maypoles festooned with garlands and ribbons. Many Italian cities and towns celebrate May Day, or Calendimaggio, with quaint festivities. The medieval city of Assisi hosts a Renaissance fair where costumed participants enjoy parades, concerts and balls. The citizens of Nogaredo, a city in the northern region of Trentino, dress up as witches for their Calendimaggio feasts and decorate the town with spooky lights and bonfires. Magic is certainly appropriate for May Day — after all, what greater magic is there than the rebirth of nature in the spring?

In addition to the folkloric nature-based celebrations, May Day also functions as Labor Day in many countries worldwide. In Italy, for example, May 1st is a public holiday known as la Festa del Lavoro, part of International Workers' Day. Italians take this day to commemorate the contribution of workers while also enjoying some rest and leisure. Similar to the ancient nature rites of May Day, families may flock to the beach or mountains, gather for picnics, or visit famous historical sites. Others attend parades that focus on the achievements of the Italian labor movement or partake in demonstrations that call for an end to the workplace injustices, which still persist

to this day. As part of the Italian-American community, we too can celebrate la Festa del Lavoro by ruminating on the remarkable strides that Italians have made in the United States. At the beginning of the twentieth century, most Italian immigrants arrived in America with little money or formal education, but

nevertheless worked hard, often in strenuous and thankless jobs, to provide for their families. Italians became particularly active in the labor struggle that rocked the nation at the turn of the century, quickly forming unions, participating in strikes, and raising the demand for shorter workdays, injured workers' compensation, and an end to child labor. We should thank the Italians and other immigrant groups for the safety regulations and labor law advancements made in the workplace since those long-ago days. However, la Festa del Lavoro also urges us to continue our ancestors' campaigns. Many labor injustices still exist both in the United States and the world at large, including slavery, children forced into dangerous jobs, and unsafe conditions in factories and mines. Just as flowers and leaves bloom with renewed vigor during the spring, so too should our compassion bloom, and we should strive to make the world a better place for our fellow humans.



# **Dimentia Risk is Rising**

## Preventative Steps are Within Reach

Cognitive decline may be more prevalent, but lifestyle changes can make a real difference. Dementia diagnosis is rising in the U.S., with people over 55 facing a 42% risk of developing it in their lifetime. However, there are preventative steps that may be taken to reduce the risk according to Dr. Joel Salinas, behavioral neurologist at NYU Grossman School of Medicine.

One of the biggest factors in the increase is demographics, according to Salinas. "The baby boomer population, being one of the largest groups, is also the fastest aging groups. As we get more and more baby boomers, not just over 65, but into their 70's and 80's, we're going to see more and more of them developing some degree of cognitive impairment due to a plethora of reasons." Age is indeed the biggest risk factor. "After age 65, our risk starts to increase. By the time we got to our 80's, that risk is about one in three, and then after 85, it starts to go up even higher, to almost one in two," said Salinas

He also noted that the pandemic could most definitely have played a role. "This is still being understood, but it seems like COVID-19 also affected blood vessels in the body and brain, so people who already had a vulnerability for developing dementia could have an acceleration or an earlier presentation."

Research has also shown that loneliness and isolation can increase cognitive decline. "We know that individuals who don't have a lot of social engagement are at a higher risk. There's still a lot being done to figure out which came first, is it you're developing the disease and you're presenting with symptoms of loneliness earlier than others, or is it the loneliness and social isolation that increases your risk? I think it's probably both," stated Salinas.

There is also a genetic component of dementia, but it tends to be rare. "If you think about risks and protective factors like a seesaw, these genetic mutations may outweigh anything protective you do, but the nicest thing is that because they're rare, the chances are you don't have those risks,

so you probably have genetic risk than can be outweighed by some degree of protective factors," surmised Salinas.

A major study published last year found that almost half of dementia cases are potentially preventable with lifestyle changes, with exercise and proper nutrition topping the list. Addressing hearing loss by using a hearing aid can also help keep dementia at bay as well as remaining socially engaged. Refraining from smoking and limiting alcohol consumption may also boost prevention, as does getting enough quality sleep.

"It's all about putting the odds in your favor that you will be less likely to develop one of these conditions, or at least likely to delay the onset of symptoms. It's never too late to take them on, but whenever you start them, the more consistent you are with them, the bigger return you'll have," Salinas offered. The neurologist study showed 92% of people with mild cognitive impairment go undiagnosed. "That's when we really want to intervene, but most of the time people are being diagnosed when the condition is moderate to severe." It certainly can be difficult to distinguish between the normal effects of aging and the early signs of dementia. Salinas does note some key differences, "We have more difficulty with memory and thinking as we get older, but it should never be to the point where it interferes with our dayto-day functioning. It's normal to experience blips once in a while, like forgetting your keys or blanking on a name, but if you're seeing that happen much more frequently over time and it's getting worse, that may suggest there is something neurodegenerative and not just normal or typical aging," cautioned Salinas.

To ensure earlier diagnosis and intervention, Salinas recommends speaking with a health care provider as soon as atypical symptoms are noticed, "It is important to take them seriously, but often symptoms get dismissed by doctors or medical providers, so do seek a second opinion, especially from a neurology specialist," advised Salinas.

The contest was organized by Sperm Racing, a group of young millionaires who raised more than \$1 million to back this derby race that takes place on April 25th at the Hollywood Palladium in front of thousands of spectators.

"Two competitors. Two samples. One microscopic finish line," declares Sperm Racing boss Eric Zhu. Whichever finishes first as verified by

In an interview with CBS he said, he had mixed feelings about getting a letter from the government with an appointment to become a U.S. citizen. "The first feeling is that I've been waiting for this for more than a year," said the student, and the other feeling is, "Wait a minute, is this a honey trap?"

His lawyer said his client was unlawfully detained for no reason other than his Palestinian identity.

# Caterina Maria Romola di Lorenzo de Medici

Caterina Maria Romola di Lorenzo de Medici was born in Florence on April 13, 1519. Her father was Lorenzo de Medici, Duke of Urbino and ruler of Florence and her mother was Madeleine de la Tour d'Auvergne, cousin of Francis I, King of France.

Catherine's mother passed away when she was two-weeks-old and her father soon afterwards. In 1533, at the age of 14, Catherine's uncle Pope Clement VII arranged her marriage to the duke of Orléans, second son of the king of France.

A year after their marriage, the duke began a long affair with Diane de Poitiers who remained an influential in his life for the next 25 years, leaving Catherine eclipsed. It was not until ten years after their marriage that

Catherine gave birth to their first child. This greatly improved the queen's standing and the couple eventually had seven surviving children.

In 1536, the duke of Orléans became heir to the throne. Eleven years later he was crowned Henry II of France. Unfortunately it was to be a short reign as Henry died in a jousting accident in 1559, thrusting Catherine onto the political stage. Their eldest son Francis was proclaimed king, but passed away after less than a year. Then in 1560, their second son Charles was crowned, aged just ten years old. Catherine acted as regent for the young king and as a result influenced Charles throughout his reign.

She at first adopted a conciliatory policy towards the Huguenots (French Protestants), but in 1562 civil war broke out in France, marking the beginning of the series of conflicts which became known as the French Wars of Religion.

In 1572, in an effort to bring reconciliation, Catherine arranged the marriage of her daughter Marguerite to the Protestant Henry, King of Navarre. During the wedding celebrations in Paris, the Huguenot leader, Coligny, was murdered, as were hundreds of other Protestants who had gathered for the wedding. This became known as the St Bartholomew's Day Massacre, in which Catherine was thought to be involved.

Charles IX died in 1574 and Catherine's favorite son Henry succeeded as Henry III of France. She continued to play a central role in government and made further fruitless attempts to reconcile the opposing sides in the ongoing civil war.

Catherine passed away on January 5, 1589 and was buried next to her husband in the church of St. Denis in Paris.



## Saint Richard Reynolds

Richard Reynolds was a Bridgettine monk of the Syon Abbey, founded in Twickenham by Henry V. He was born in Devon in 1492, educated at Corpus Christi College, Cambridge, and joined the Abbey in 1513. Reginald Pole is quoted as saying that Reynolds was the only English monk well-versed in the three principal languages of Latin, Greek and Hebrew.

Reynolds is said to be the most renowned spiritual counsellor of the Syon community. He would have likely been consulted by Elizabeth Barton, the Holy Maid of Kent, who had been executed at Tyburn almost a year earlier for speaking out against the king's marriage to Anne Boleyn. Reynolds had previously arranged a meeting between Elizabeth Barton and Thomas More. It was his connection to Barton that particularly compromised Reynolds in the view of the Crown officers.

Reynolds was arrested and imprisoned in the Tower of London around the middle



of April 1535, along with the Carthusian priors John Houghton, Robert Lawrence and Augustine Webster (a monk of Sheen Priory in Richmond). All four were tried for the denial of the royal supremacy. Against Reynolds, there was the additional charge of attempting to dissuade people from submitting to the king's authority. A witness claimed that Reynolds had stated that the "Dowager Princess" (Queen Catherine) was the true queen. Reynolds denied that he had declared an opinion against the king.

All four were executed on May 4, 1535 by drawing and quartering at Tyburn, London after being dragged through the streets. Also convicted of treason for speaking against the King's marriage to Anne Boleyn, and martyred with them on that day, was John Haile, the parish priest of Isleworth where Syon Abbey was located. The quarters of the body of Reynolds — the first man to refuse the Oath of Supremacy were chopped to pieces and hung in different parts of London, including the gate of Syon Abbey. The Feast Day of Saint Richard Reynolds is May 4th.

## **Boston Antisemitism Probe is Off**

## *Is it Temporary or Permanent?*

The Trump's administration's request to visit Boston amidst a probe of the city's response to "incidents of antisemitism" at its schools and colleges was rebuffed by Mayor Michelle Wu's administration. The Trump administration's proposed visit comes at a time when Harvard and the president's administration are locked in a heated battle over federal funding.

Earlier this month, U.S. Department of Justice officials (DOJ) met with the city's legal counsel, department chiefs and a representative from the Boston Jewish community met to discuss the specifics of a meeting tentatively scheduled for this past Wednesday, April 23<sup>rd</sup> between Mayor Wu and the federal government's new antisemitism task force.

According to Wu's office, the meeting was never confirmed and that the task force failed to respond to the city's request for specific antisemitism incidents that may have occurred at its schools and colleges. "There is no meeting with the DOJ on the

schedule this week. The task force had requested a meeting to discuss the city's handling of unspecified incidents, without providing details. At the request of the task force, city officials and representatives from the Jewish community met with the task force on April 9, and we have been awaiting more information prior to confirming any additional meetings. We have not heard back."

Mayor Wu has been engaged in a quite public and fierce battle with the Trump administration over immigration and other policies, was initially sent a letter in mid-March, from the task force informing her of their intention to visit her and three other big-city mayors as part of its probe into antisemitic incidents in their schools and colleges. "We are aware of information alleging that schools in Boston have faced unacceptable incidents of antisemitic harassment and violence. Within the next 30 days, we would like to meet with you to discuss actions, if any, that the city is taking to address alleged discrimination or hate crimes against Jewish individuals in any Boston schools, to include K-12 institutions and post-secondary institutions." Wrote Leo Terrell, senior counsel to the U.S. assistant attorney general.

According to Mayor Wu's office, the April 23rd meeting was contingent upon specific incidents be submitted to the city for review prior to confirming the meeting. Because those records were never provided to the city, the Wu administration was hesitant to confirm the meeting. "In order to ensure that we are prepared for a productive discussion with you and your team, we ask that the division share with us any information on the incidents of antisemitic conduct in Boston as referenced in your letter," wrote the Wu administration to the DOJ.

It seems the city hasn't heard back from the federal task force since the April 9<sup>th</sup> meeting, leaving the onus on the feds to make the next move.



A Nostalgic Remembrance



Several years ago, I wrote a story about a trip to Italy that I made in 1972. The story was funny due to the antics of my old buddy, Sal Meli. The beginning portion of the almost threemonth trip has some historical reference and I decided to separate it from the rest of that vacation and put it down on paper. It involved an uncle of Sal's, his mother's older brother, and his involvement with Benito Mussolini. Sal, unfortunately, is gone after years of dealing with dementia. His older sister is gone and the remaining younger sister would have been too young to remember any of this story surrounding her uncle and his involvement with the Fascists.

To begin with, Sal's parents decided to immigrate to the United States after WWII. I believe they arrived in the late 1940s, and settled in East Boston. Sal was in the middle of a brood of three children. The other two were an older sister and one younger. He would have been five years older than I, and today, that doesn't mean much, but back when we were kids, that put us in two separate generations.

We finally became friendly when he was in his mid-twenties, a period of time I was just entering. My family was still living on Eutaw Street in East Boston, and on a warm spring day, I was playing handball at Constitution Beach in Orient Heights, and while waiting my turn, became involved in a conversation with Sal. We seemed to have a lot in common and decided to get together at a local Revere watering hole that many East Bostonians and North Enders frequented, The Caravan. (Remember that nightclub across from Wonderland Dog Track???) From that point on, we began double dating and hanging out at the Cave, a long gone Latin American nightclub that was located in the alley just to the right of the Colonial Theater. That all happened in the 1960s. By the early 1970s, both of us had gone through a couple of broken engagements and were traveling around the world. The only continent we never reached was Australia. The others parts of the world we visited, with many vacations taking place in Latin America.

Sal's parents went to work not long after landing in Boston, and after 20 years, decided to retire. They both would have social security and union pensions to live on from that point on. Sal's father discovered that he had 2 pensions coming to him from the Italian government. He had been a police

officer in his Sicilian town before WWII, and was an officer in the Italian Army during the war. Each of these service involvements made him eligible for 2 pensions. If you combine the 4 that he and his wife were eligible for in the U.S., the total of 6 pensions would make them quite comfortable in their senior years. As a result of all of this, and a promise that Sal's father made to his wife about returning to Italy in their old age, they returned in 1970, and bought a luxury condo in a suburb of Agrigento, Sicily.

Sal decided to visit his parents during the spring of 1972. Just as the school year was coming to an end for me that June, he called. Prior to leaving Boston, he and his fiancée had broken their engagement and I kind of thought that the trip was more to forget her than to visit his parents. Anyway, he asked if I would like to join him in Sicily. I told him that I had a couple of bookings with my band that summer, but didn't think it would be difficult to find a bass player to cover me and I could have my pianist lead the jobs. To add to this, the Boston schools were opening a week or so late in September due to when Labor Day fell. As a result of these facts, I said yes to a trip to Italy and left a few days later.

My passport was in order, but there were shots required to return to the U.S. from Europe, so I called Dr. Rose Jannini in Winthrop to have her take care of the vaccinations. Once my ticket was purchased, off I went, with Babbononno screaming for me to take him. He had never been back to his homeland, and unfortunately, never would return. By this point in time, he was in his 90s, and he really couldn't travel. I convinced him that I needed him to watch out for my folks, and would call from the land of his birth if I needed him. He was OK with that and I was off the hook.

I flew from Boston to Rome and then from Rome to Palermo on a shuttle that ran every two hours. Once all of the logistics were in place, I called Sal at his parent's condo and gave him my arrival information. Sal, accompanied by his father and his uncle (his mother's oldest brother who lived in the same condo) decided to take the train to Palermo and intercept me at the airport. I was greeted by Sal and his father, Carmelo, a few minutes after exiting customs. Sal's father then introduced me to his brother-in-law. I greeted him in Italian until the man gave me his full name and then said with no trace of an accent, "Please call me Uncle Gus."

Agostino Faldetta was happy to practice his English, something he couldn't do in southern Sicily, as few locals spoke English back then. He asked me questions about myself, my family and what the future had in store for me. When I finished, Sal's father told me that his brother-in-law was born in Italy, but was educated in the States. He had become successful in Boston, but when the Depression hit, he looked at what Mussolini was doing in Italy, and decided to head there. Because part of his American education was military, and the fact that he spoke English without an Italian accent, he was commissioned an officer in the Italian Army and almost immediately became an advisor in Mussolini's inner circle, joining with the men who had been with Il Duce since his rise to power in 1922. Gus took over the conversation from there and began to reveal episodes that included meetings with government officials, military leaders and their ally, Adolph Hitler.

The men wanted to take the trolley from the airport to the center of Palermo and head for a hotel to spend an overnight there, considering it was late afternoon. I told them that I would rather rent a car and we headed for Maggiore, then, the second largest car rental agency in Italy ... second to Hertz. Once we were all in a FIAT 127, a fastback that held 4 people as long as they weren't over 5 feet tall, we headed for the local Jolly Hotel. We checked in with Uncle Gus telling me that, with their military IDs, we would get a sizable discount. I wasn't going to argue. After a shower and a quick shave, we were on our way to a restaurant in the center of Palermo. As we walked toward the restaurant the older men selected, Uncle Gus pointed out things like street lights, paved roads and a modern wide main avenue. He added in the concepts of indoor plumbing and the telephone and told me that all of what I saw and would experience was thanks to Benito Mussolini. At that point, I knew I was in for quite a story and didn't know whether I should begin waving an American flag, but I was ready.

Taralli Pugliesi are crisp, ring-shaped crackers from the Puglia region of southern Italy, where they've been a pantry staple for centuries. Legend has it they were born out of necessity — flour, olive oil, salt, and white wine brought together by an ingenious mother during a time of famine. Traditionally baked in wood-fired ovens, these crunchy treats have become a beloved symbol of Apulian culinary heritage.

My Nonna made Taralli often — both savory and sweet — but when it came to *Taralli Pugliesi*, she always followed the recipe from "the old country", using only the finest ingredients she could find. She believed there was no shortcut to tradition. The dough is tough to work with and the process can be time-consuming, but the result is always worth the work. Whether served with a glass of wine, tucked into a lunchbox, or added to an antipasto board, *Taralli Pugliesi* are irresistibly crunchy and famously addictive — so much so, that in this country, they're often referred to as "Italian Potato Chips" because, truly, you can't eat just one!

# NONNA'S TRADITIONAL TARALLI PUGLIESE



4 cups (about 500 g) 0 or 00 flour

1 cup and 2 ½ tablespoons (277 ml) dry white wine.

2/3 cup (160 ml) extra virgin olive oil

2 teaspoons salt

1 teaspoon black pepper

4 teaspoons fennel seeds

In a stand mixer (or by hand), mix the flour with the salt, pepper and fennel seeds. Add the olive oil and dry white wine. Mix using a dough hook or knead by hand for at least 10 minutes until a smooth, elastic dough forms.

Shape into a ball and wrap the dough in plastic wrap (cling film) and let it rest on the counter at room temperature for 30 minutes.

After resting, knead the dough again briefly to smooth out any lumps or cracks (This is a dry and often difficult dough to work with!!). Break off small pieces of dough, about 15 grams each (roughly 1 tablespoon), and roll each piece into a rope about 12 cm (5 inches) long. Form each rope into a ring shape and press the ends together to seal. Place the shaped Tarallo on a baking tray lined with parchment paper.

Once the first tray is filled, place it in the refrigerator for 30 minutes. (Though I have sometimes eliminated this step, it helps the Taralli hold their shape and develop a shiny surface when baked.)

## Prepare to Boil:

While the first tray chills, continue shaping the remaining dough and preheat the oven to 190°C (375°F). Bring a large pot of salted water to a boil. Working in batches of 10–12 Taralli, drop them into the boiling water. Stir gently with a fork. When the Taralli float to the surface (about 1–2 minutes), remove them with a slotted spoon and place them on a clean tea towel to drain and dry.

Transfer the drained, dry Taralli to a parchment-lined baking sheet and bake at  $190^{\circ}\text{C}$  ( $375^{\circ}$ ) for 30 minutes, until golden. Then increase the temperature to  $200^{\circ}\text{C}$  ( $390^{\circ}\text{F}$ ) and bake for an additional 5–6 minutes for a crisp finish. (I have also baked them at  $400^{\circ}$  the entire time until golden and crunchy. It really depends on the oven used)

Remove the Taralli from the oven, allow them to cool and serve at room temperature. These are best enjoyed cool and crunchy.

## **BROTHERS**

## in the Ring

Boxing has sometimes been a family affair with brothers taking up the sport. Out of the ones that have shown success, often it is just one brother that makes it to the top.



Rahman and Muhammad Ali

Ali and his sibling Rahman both had extensive amateur careers beginning in their home t o w n o f Louisville, KY. Many of their fights were staged at the studios of and broadcast on WAVE-TV.

Muhammad

While both Ali boys did well in the ranks of the simon-pure, the elder Cassius went on to Olympic Gold and later to become known as one of the greatest heavyweight champions of all time. Rahman turned pro in 1964 winning a four-round fight on the undercard of his brother's championship victory over Sonny Liston in Miami Beach.

Over the next couple of years Rahman would fight sporadically, having just four fights from 1964 to 1966. He won all of those encounters. He finally hit his stride in 1970 when he became much more active. He would have 14 bouts during the period 1970 through 1972, winning ten with three losses and one draw.

Rahman Ali hung up the gloves after being stopped by Jack O'Halloran in 1972. He remained visible in Muhammad's camp and was among his brother's greatest supporters. There was never any bitterness between the two as can sometimes happen when family members are involved in the same business. In fact, Rahman was and remains very proud of his older brother's accomplishments.



Leon and Michael Spinks

Michael and Leon Spinks also started out as amateurs, where they both had outstanding success. They each won National AAU ties and both went on to rep-

resent the United States in the 1976 Olympics. Michael won Gold in the middleweight division while Leon brought home the top medal fighting in the light-heavyweight division. The brothers turned pro shortly after.

In 1978, fighting in just his eighth professional bout, Leon upset Muhammad Ali to win the heavyweight championship. Meanwhile, Michael was taking a more methodical approach to his career. In 1981, he won the WBA version of the light-heavyweight championship with a victory over Eddie Mustafa Muhammad. In 1983, he would become the undisputed champion in that weight division when he took a fifteen-round decision over Dwight Muhammad

It was in 1985 when history was truly made. Michael gave up the light-heavyweight title to take a shot at Larry Holmes for the heavyweight championship of the world. In his first fight as a heavyweight after putting on almost 25 pounds in three months, Michael made history by becoming the first light-heavyweight champion to move up and win the heavyweight crown. That was not the only history made that night. It was also the first time two brothers had become undisputed heavyweight champions.

Earlier in the 20th century two siblings were making names for themselves in the ring. Mike and Tommy Gibbons were perhaps the most talented brothers to ever step into the prize ring. Both were brilliant defensive boxers who took on the best of their day. Unfortunately, neither was able to win a world title. Tommy did challenge Jack Dempsey for the heavyweight championship and became the only man to ever go 15-rounds with

Brother Mike was also very impressive. He had a total of 73 matches with 65 wins (38 by kayo), only 3 losses, and 5 draws. Mike was never stopped.

The combined record of the Gibbons brothers was a total of 135 fights with 121 wins (86 by kayo), just 7 losses, and 6 draws. Out of that 135 fights, the only time either failed to make it to the final bell was Tommy's fight with Tunney. I don't think there have ever been any brothers in the sport of boxing that have had this combination of talent.

There have been a number of other family affairs in boxing. The Klitschko brothers, Wladimir and Vitali, who both won versions of the heavyweight title. The fighting Zivic brothers; Fritzie (World Welterweight Champion), Jack, Pete, Eddie and Joe. Dick, Randy, and Jackie Turpin.

never won a title but did face men such as Stanley Ketchel, Gunboat

## HOOPS and HOCKEY in the HUB



We have always liked Payton Pritchard — ever since he joined the Celtics back in 2020 and learned that not only was he a highly competent basketball player but that he had stayed all four years in college and graduated.

Yes, that is right. When Pritchard walked across the stage at the University of Oregon in the spring of 2020, he was doing something that very few NBA players have accomplished these days — earning a college degree.

That says something about Pritchardwho was just honored by being selected



After all, the objective of every college student should be to earn a degree. These institutions were founded for educational purposes. While there have always been some who have left — either to transfer to another college or to leave because they felt college was not for them — the current group of elite athletes who arrive is different. They arrive on campus with the stated intention of leaving after a year or so. In other words, they arrive without intending to earn

That was part of the atmosphere that was swirling around the Oregon basketball program when Pritchard enrolled for his freshman year (2016-2017).

That decision meant that he would be an anchor at the University of Oregon while an ever-changing carousel of players swirled around him. He once stated that the coaching change that took place with the Celtics back in 2022 did not really bother him since he was used to change — noting that there were some 60 different players on the Oregon roster over the course of his four-year college career.

But just like today, he was forever the stalwart. In his four years of secondary education his team — West Linn High School — won a state championship all four years. He averaged 22 points per game his junior year and 23 points a game his senior season. As a swan song to his high school basketball career he scored 45 points in the Northwest Shootout, a postseason all-star game between players from Oregon and Washington.

As a capstone to his first year at Oregon, the Ducks made it all the way to the Final Four, their first appearance in that group since the late 1930s. Pritchard was the only freshman player to start in that 2017 Final Four across all four teams.

Over the ensuing summer all the starters left except Pritchard who averaged 14.5 points per game his freshman year. In his junior year the team won the PAC-12 Championship and advanced to the NCAA Sweet 16 round. He was named the Most Valuable Player of the PAC-12 Tournament.

As a senior Pritchard got even better, averaging 20.5 points and being selected the PAC-12 Player of the Year. He was a consensus All-American and earned the Bob Cousy Award as the nation's leading point guard.

It would only be a relatively short time after that when he would get the chance to meet the man for whom the award is named since he was chosen as the 26th pick in the 2020 NBA Draft by then Boston GM Danny Ainge. The most recent would come on Opening Night last October when the Celtics received their championship rings and Banner 18 was raised to the rafters. Bob Cousy — at age 96 — was on the parquet with Pritchard and the other Celtics to see that happen.

Isn't it interesting to see how success in the athletic world-as well as in life in general — has a way of bringing people together. Of course, success in the NBA also brings financial blessings. Pritchard is currently playing under the terms of a four-year \$30 million contract.

At times, it may seem to fans that Pritchard is a starter rather than a reserve. He was the only reserve player in the NBA to be on the court for more than 2,000 minutes during the regular season, finishing with 2,166. And over the course of that 82-game regular season, Pritchard played in 80 of them.

For this regular season just concluded, Pritchard fired in 246 three pointers off the bench, the most in a regular season in NBA history. He also scored a career high 1,079 points and was third in total assists among reserves with 257.

So his presence was ubiquitous from October through the middle of April and, of course, it continues into the playoffs. His various skills gives coach Joe Mazzulla the luxury of knowing that there will be virtually no difference in quality of play when calling for his top substitute player to enter the game — a feeling of comfort that many other coaches only wish they had.

Pritchard just turned 27 a few months ago (January 27) so the best may be yet to come with regards to his performance on the court. An advancement to the starting rotation does not seem out of the realm of possibility at some point in the future.

After all, the man for whom the NBA's Sixth Man of the Year Award is named — Boston's John Havlicek — came off the bench for the first seven years of his career. So there is an inspiration for Pritchard as he continues to progress in the future.

And just think: most of this year's playoff games still lie ahead for him and the team as a whole. Something positive to think about.
