

### THE BIBLE LANDS



The history of ancient Mesopotamia, also called the West Asiatic or the Tigris-Euphrates country, was actually composed of three major periods. These were known as the Babylon Period, the Assyrian Period, and the Persian Period. They all occupied the territory that was part of the "Bible Lands." Mountains in the northern portion of the country reach heights of 7,000-feet, but further south, the country slopes downward to form a broad central alluvial plain, which occupies the valley between the Tigris and Euphrates Rivers. The previous column noted that history marks this as the location of the "Garden of Eden." The name "Garden of Eden" implies, an area where climate, soil, and rainfall were ideal. The Old Testament calls this area "Shinar, Babel, and The Land of the Chaldees." It was one of the richest and most fertile districts, and supplied one third of the grain produced in all of western Asia. A magnificent system of artificial irrigation was introduced by a network of canals. The greatest of these canals was called the "Nar Malka." It connected the Tigris with the Euphrates and was still in use as late as 700 A.D.

During the Babylonian period, the people maintained a civilization, which has not been properly appreciated until fairly modern times. The discovery and deciphering of many thousands of inscribed tablets from some of the oldest cities of Babylonia give a very accurate account of their ancient life in details, which are clearer than most other nations except Egypt.

Their laws were administered by judges and supreme judges. Punishment was handed out in the form of fines, loss of civil rights, imprisonment. and at times even death. Appeals could be made to the king. They used a form of silver currency, with denominations named "talents, maneus, shekels, and paras." Taxes were levied for the improvement of their roads and canals. They were also required to pay a "king's tax" (property tax), and an "army tax."

All Chaldeans of free birth were educated. Slaves were protected by law against harsh treatment from their masters; they could own property; and in fact were often taught trades by their owners. Women occupied a favorable position in their society, especially after marriage. They could own property and engage in business ventures. Motherhood was especially respected and offences against any mother were severely punished, sometimes even by mutilation.

# NEWRA Monthly Meeting June 13, 2024

30,000 applications for a police officer position, now they are lucky to receive 1,500 - 1,800.

Again, it was reinforced that the NE/W is fortunate to not have to deal with violent crime and remains a very safe community. The Mobile Operations Unit (MOP) is assigned to the area 20 days at a time and prioritized based upon 311 and 911 calls.

The main topic of the evening was the update by Captain Martin on the 2024 Summer Feast Celebrations. He made it abundantly clear things are going to be done differently this year ... the feasts will end the music at 9:00 pm and vendors will shut down at 10:00 pm. He has spoken to 3 of the 4 societies so far and will meet with the fourth very soon, regarding an enhanced security plan. Over 50 officers were provided last year to 1 particular feast. Outside vouth and gangs are ruining the festival tradition and longtime North End residents are becoming frustrated.

There will be check points at every access and entry point in the feast. Anyone will be allowed to exit but only a few will be allowed in at a time. No bags, No liquid will be allowed in and No intoxication will be tolerated!

This year there will be heavy police presence inside and outside the feast with the goal for next year and forward to reduce the presence of police inside and focus on the outside neighborhood enforcement. If this year's plan is successful, Captain Martin is hoping we may be able to go back to the extended hours next year but with the same enhanced security plan in place. If this plan does not work, then there will be occupancy limits put in place and the hours will be drastically cut, ending by late afternoon.

An update on Cutillo Park renovation was provided. The contractor is still finishing, the decking area remains problematic with rat burrowing so it may need to be cemented and will hopefully be finished in a few weeks. Morton Street/ Salem Street restaurants are still creating trash issues. It is known as one of the dirtiest areas of the North End.

The last item on the agenda was a holdover from the May meeting. Billy Ferullo, attorney for Frank Pellino, spoke on behalf of his client's application to open an approximate 70-person restaurant with a bar and transfer of a beer and wine license to this location, 364 Hanover Street, formerly Maurizio's restaurant and adjacent doctor's office. Pellino owns Caserece on the corner of Hanover and Richmond Street and has been in the restaurant business for over 40 years. The association voted 9-7 in support of his application, and Pellino hopes to open in October/ November.

Next month's meeting is scheduled for Thursday, July 11th, 6:30 pm, location TBD, and will hopefully include an informational meeting with the feast societies and representatives regarding the plan put forward by the BPD.

# TJX Companies to Require Sales Associates Wear Body Cameras

It may sound unusual, but a local Fortune 500 Company has announced they have equipped employees with body cameras inside of its stores. TJX Companies, Inc, who counts TJ Maxx, Home Goods and Marshalls amongst its subsidiaries, did not disclose which specific stores or locations had begun using these devices or the percentage of employees required to wear the cameras.

"Body cameras are currently being used by certain loss prevention associates who have gone through training on how to use cameras effectively in their roles," a company spokesperson wrote. John Hurst, President of the Retailers Association of Massachusetts, believes TJX may be the first retailer in the state to deploy body cameras. "I don't know of any other companies but this sounds like a timely important step to protect employees and consumers alike. Given the state law changes on felony larceny penalties going from a minimum of \$250.00 up to \$1,200 in Massachusetts, inconsistent enforcement and prosecutions, more organized criminal theft and fencing operations, all leading to low risk/high return crimes, this makes sense.

The body camera footage will only be available to law enforcement in a subpoena request. Ryan Kearney, General Counsel for the Retailer's Association of Massachusetts said "unprecedented levels of crime including thefts, acts of violence, illegal on-site drug use and the risk of violence to employees is an even more significant concern than loss of profits."

A recent survey conducted by the National Retail Federation found 88% of retailers reported shoplifters are somewhat or much more aggressive and violent compared to a year ago. TJX spokesperson said the goal of the body cam is to help protect employees and customers.

# Hero Square Dedication Honoring James "Fitz" Fitzgerald A Charlestown Patriot

M/Sgt James B. "Fitz" Fitzgerald, October 2, 1937 -August 22, 2017 was recently honored posthumously, with a Hero Square on the corner of Holden Row and Wesley Streets, in Charlestown, where he made his home for 45 years.

Fitz was a lifelong resident of Charlestown. He enlisted in the United States Army on October 29, 1956. After completing his basic training at Fort Dix, New Jersey, he was stationed at Fort Campbell, Kentucky. Fitz was a member of the E Company 1st Battle Group, 327th Infantry for advanced Infantry, and continued onto Airborne School. After being honorably discharged on August 15, 1963 Fitz joined the A Company 11th SFGA Reserve Unit in Boston as a light and heavy weapons leader and an intelligence and operations



sergeant. He retired in 1988 with 32 years of service, all in Airborne.

Some of the awards and decorations bestowed upon Fitz during his years of service include Master Parachute and Jungle Expert Badges, Canadian, British, German, and French Parachute Badges, a member of the U.S. Army Parachute Team "Golden Knights" and recipient of the Silver Star, Bronze Star with OLC, and Purple Heart with OLC. Fitz went onto become a City of Boston Firefighter for 30 years, initially at Engine Company 7 and retired from Engine Company 24. He was the past President and Vice President of the Boston Fire Fighters Union, local 718.

Fitz' wife Frances, daughters Kathleen, Michele, Linda and families would likely extend their appreciation to District 1 Councilor Gabriela Coletta Zapata, the City of Boston, the American Legion - JW Conway - Bunker Hill Post #26, Charlestown Veterans History Project and the Abraham Lincoln Post #11 G.A.R. For this wonderful honor and all their support.

# L'Anno Bello: A Year in Italian Folklore Midsummer, a Magic and Mesmerizing Time

What is it about summer nights that make me think of magic, moonbeams, and fireflies and fairies flitting about a darkened forest? Perhaps the answer lies in the velvety hue of the evening sky, offset by the delicate diamond-like stars that peek out from the late sunset. Or perhaps the answer resides in the comforting sound of crickets and cicadas humming their melody from deep within bushes and trees. It could also be that people tend to congregate outside during the warm summer twilight, illuminating the atmosphere with candles and lanterns from barbecues and alfresco dinners. I always find that the most magical of these nights occurs around the summer solstice, the longest day and shortest night of the year. In olden times, the summer solstice was known as midsummer, which can confuse those of us who view the solstice as the beginning of summer rather than the middle. Ancient Europeans used agricultural rather than purely astronomical methods of gauging the seasons, and so the solstice was considered the height of summer rather than its commencement. As Christianity spread across the continent, Midsummer festivities became absorbed into the feast day of St. John the Baptist, creating an indelible mix of traditions. The result is one of my favorite holidays, a festival that embodies the magic and boldness of summer.

Europeans in older times began the summer on Mav people slip them under their 1<sup>st</sup>, or May Day, the holiday pillows to dream of their future that marked the time to let spouse.

livestock out to graze in pastures. Summer ended on Lammas, which fell on August 1<sup>st</sup>, the festival of the grain harvest and the first fruits of the autumn. As a result, the summer solstice marked the midpoint of the season and as such was called Midsummer. In Europe, Midsummer heralded not only the longest day of the year, but also the period after which the daylight hours would slowly shorten. For this reason, I like viewing the solstice as the middle rather than the beginning of summer as well - it makes little sense to celebrate the start of summer when the sun begins to diminish in the sky! Midsummer customs later attached themselves to June 24<sup>th</sup>, St. John the Baptist's Day, the feast commemorating the birthday of the important Biblical figure six months before Christmas. In Italy, St. John's Day customs symbolize both the decline of the sun after the solstice and the sense of magic which pervades the evening. All over the Italian countryside, gli fuochi di San Giovanni, or St. John's bonfires, blaze from the hilltops on the eve of the saint's festival. These fires both mimic the power of summer sun while also symbolically imploring the sun to stay longer in the sky. Young Italians may also spend the evening gathering herbs, which are supposedly imbued with mystical properties on this unusual and magical night. According to old superstitions, these herbs work especially well for romantic divination, and

Across Europe, similar Midsummer and St. John the Baptist's Day traditions utilize the seasonal staples of water, fire and greenery. In Scandinavia, Midsummer is one of the most significant holidays of the year, on par with Easter and Christmas. Sporting wreaths of flowers on their heads, Scandinavians celebrate this holiday by dancing around Maypoles bedecked with greenery, building bonfires near lakes and rivers, and sitting down to feasts featuring summer ingredients like strawberries and potatoes. Meanwhile, girls in Ukraine and other places in Eastern Europe float flower garlands down rivers and attempt to foretell the future by interpreting the movement of the garlands. People in Spain and Portugal celebrate the Feast of St. John the Baptist with outdoor carnivals, bonfires, street fairs, and the exchange of potted herbs. Italians, of course, never pass up an opportunity for a festival and party accordingly on St. John the Baptist's Day, especially in cities of Florence and Turin, where he is the patron saint and outdoor fairs and fireworks displays mark the occasion. Out in the countryside, people may enjoy St. John's apples, or le mele di San Giovanni. A favorite of my father, these are small green apples so named because they ripen extremely early, just around the time of the solstice. No matter where one goes in Europe, charming Midsummer revelries emphasize the importance of the summer sun and the blessings of the season. The United States even boasts its own festivals full of outdoor excursions, fireworks and water - the Fourth of July, of course!

Above all, Midsummer is a holiday tinged with bittersweet nostalgia. While it honors the height of the sun's power and the carefree days of summer, it also recognizes that the hours of sunlight will slowly start to diminish once this date is past. It is a poignant reminder that nothing lasts forever. Yet, Midsummer is celebrated with joy, not sadness. Its celebrations encourage people to enjoy the longest day of the year by living life in the present moment. We know that the year is a cycle, and that we should appreciate each season for what it offers. The darkness of autumn and winter reveals celebrations of the Earth's bounty and communal feasts where families gather together in joy and goodwill against the cold. And yes, the sun will be once more reborn in a bright blaze of glory on the winter solstice, immortalized in light-themed holidays like Hanukkah and Christmas and New Year's Eve. This summer solstice, live in the moment and enjoy all that summer has to provide on the longest day of the year - and let's make a vow to carry that sunshine, optimism and wondrous magic within us for the rest of the year. # Saint Gregory of Narek

Gregory was born in a village in the kingdom of Vaspurakan, a medieval Armenian kingdom, on the southern shores of Lake Van, which is now eastern Turkey, sometime between the years 946 and 952. Gregory was raised in a monastery and eventually entered the Narek Monastery, known as Narekavank in what is now Turkey, as a monk where he lived for most of his life. Gregory was

part of a renaissance occurring at that time in Armenia in literature, painting, architecture, and theology.

As an Armenian monk, Gregory lived humbly and taught at the monastic school. He wrote his prayers in the "Encyclopedia of Prayer for all Nations" in hopes the book would one day guide people of all stations around the world to prayer.

He was a leader of the well-developed school of Armenian mysticism at the Monastery and was asked to answer the question, "What can one offer to God, our creator, who already has everything and knows everything better than we could ever express it?"

In his Book of Prayer, also called the Book of Lamentations or the Song of Songs, Gregory wrote that the answer to the question is "the sighs of the heart." The book contains 91 prayers and was completed one year before he passed away around the year 1012. Several miracles and traditions have been traced back to Gregory

and he is known as "the watchful angel in human form."

Gregory of Narek is venerated as a saint by the Armenian Catholic Church and is also recognized as a saint of the Roman Catholic church. On April 12, 2015, Pope Francis officially proclaimed Gregory of Narek as a Doctor of the Church.

### PAUL McCARTNEY & WINGS - ONE HAND CLAPPING (2LP Vinyl) MPL/Capitol/UMe

The wait is over: With the June 14 release of One Hand Clapping, one of the most bootlegged live albums in musical history will finally receive a proper release. In August 1974, when Band on the Run was enjoying a seven-week consecutive #1 stint at the top of the UK album charts, Paul McCartney and Wings headed to Abbey Road Studios for the filming of a video documentary and possible live studio album — One Hand Clapping. Despite overwhelming demand for newly recorded material from the biggest band in the world at that time, One Hand Clapping was never officially released. Filmed and recorded over four days, the release of One Hand *Clapping* is an historic moment for Paul McCartney fans. Over the years, various parts of One Hand Clapping have been bootlegged with varying degrees of success. Some of the material has also appeared on official McCartney releases. However, the June 14 release of One Hand Clapping, which features the original artwork designed for the project, including a TV sales brochure for the unreleased film at the time, is the first time the audio for the film — plus several additional songs recorded off-camera — have been officially issued. One Hand Clapping showcased Wings' new line-up, fresh off their return from Nashville, where they recorded the classic single Junior's Farm. Following the departure of Denny Seiwell and Henry McCullough, the previous year on the eve of recording the Wings masterpiece, Band on the Run, Paul, Linda, and Denny Laine were joined by guitarist Jimmy McCulloch and drummer Geoff Britton. Additionally joining the band in the studio were saxophonist Howie Casey. Opening with an instrumental jam that would become the One Hand Clapping theme song, the album features live-in-studio renditions of Wings mega-hits "Live and Let Die," "Band on the Run," "Jet," "My Love," "Hi, Hi, Hi," "Junior's Farm," Paul's much loved solo song Maybe I'm Amazed," reworked extracts of Beatles' classics "Let It Be," "The Long and Winding Road" and "Lady Madonna," the Moody Blues hit "Go Now" with Laine singing, and a Paul solo piano version of the Tin Pan Alley classic "Baby Face." One Hand Clapping will be released in multiple formats, including an online exclusive 2LP + 7" package featuring an exclusive vinyl single of previously unreleased solo performances recorded on the final day of the sessions in the backyard of Abbey Road studios. These include the unreleased track "Blackpool," The Beatles' iconic "Blackbird," Wings B-side "Country Dreamer," and cover versions of Eddie Cochran's "Twenty Flight Rock," and Buddy Holly's "Peggy Sue" and "I'm Gonna Love You Too." One Hand Clapping serves as a celebration of the enduring legacy

of Paul McCartney and Wings. It captured a moment when Wings had found and defined their signature sound - just as Paul had shaped popular culture the decade before with The Beatles, he was doing it once again in the 70s with Wings. This recording gives an insight into the inner workings of the band as they work and play together in the studio. It also underscores Paul's incredible talent as a live performer: Fifty years on, Paul is still performing many of these songs in packed stadiums across the world.

### **CARLY PEARCE** hummingbird (CD) **Big Machine Records**

Grammy Award-winning country star Carly Pearce celebrated her brand-new album, hummingbird, out now via Big Machine Record, and showing no signs of slowing down. Pearce also released the accompanying video for "Oklahoma." Blending traditional country sounds with deeply personal storytelling filled with honesty and wit, showcases Pearce's transformative journey through loss and growth and marks her debut as a co-producer alongside Shane McAnally and Josh Osborne, marks Pearce's emergence from the storm — stronger than ever - and highlights her rebuilding process and newfound joy, drawing inspiration from the hummingbird's symbolism of healing, hope, and resilience. This past June the 9<sup>th</sup> was my father's birthday. He was born Giovanni DeCristoforo on Thursday, June 9, 1910, which would have made him 114 today. Unfortunately, he only made it to 81. He grew up the hard way. Grandpa Christoforo was a day laborer who worked with a pick and shovel, as he arrived here in the 1890s without a trade, or an ability to read or write in either Italian or English. Growing up on Chelsea Street in East Boston, Dad did odd jobs to help out with family expenses and to survive the streets of his neighborhood. Grandpa also had another problem, he liked to drink, which would eventually terminate his life due to contracting cirrhosis of the liver.

In high school, Dad was an athlete, competing in baseball, football and swimming. He attended East Boston High School and majored in machine shop. After he graduated, he worked for an iron works and helped put up the super structure for what would be-come the Seville Building where the Seville Theater was located.

Early on, he developed a desire to play music, bought himself a pawnshop violin and took lessons from a music teacher in Maverick Square. I once asked Pete Cerrini (Pete Herman) a neighborhood friend and fellow musician, if what I had heard was correct, that Dad was a tough kid. Pete, at that time, was the president of the Boston Musicians' Association. He answered, "Your Dad wasn't tough, he was the toughest. When we were kids and school let out for the summer, to save money, your grandfather would shave your father's head. This meant he would have to walk through Maverick square with a violin case under his arm and a shaved head ... he had to be THAT tough."

In his late teen years, Dad switched to tuba and bass violin and mastered both. He tried his hand at classical music, Dixieland and a new Avantguard form of music, called swing. Well, he survived the streets of Boston and became a much-in-demand musician, now calling himself Johnny Christie, professionally. In 1933, he joined a swing band and became friends with two brothers in the sax section, Paul and Nick Contini. On a given Saturday, they had a double header, and between jobs, headed home for an early dinner. They invited their bass player friend to join them, and Johnny met their sister, Angelina or Anne, as she liked to be called in English.

They hit it off and began dating which resulted in a threeyear engagement, mainly due to Dad being on the road with the popular bands of the day. They married on October 25, 1936 at the Sacred Heart Church in East Boston, and Anne joined him on the road.

Two years later, Anne announced that she was pregnant and on October the 21st, I showed up and was named after my father. Dad got off the road and became part of a group playing at the Hotel Vendome, then located on Dartmouth Street in downtown. For the next three years, Dad did well, playing six nights per week with Jimmy McHale's combo and recording with Vaughn Monroe. Right after I was born, Mom needed a lot of attention and they moved from their Allston apartment back to Mom's parent's house at 70 Eutaw Street in the Eagle Hill section of East Boston. By the way, Mom's parents were Nanna and Babbononno, Mike and Jenny Contini, my maternal grandparents.

Unfortunately, by the end of 1941, we were involved in World War II. Uncle Paul was too old to be drafted, Uncle Nick (my Godfather) joined the navy and their youngest brother, Louis or Gino, as he was called, joined the army air corps. Dad opted for a day job, teaching machine shop and shop math at his alma mater, East Boston High School.

He had planned to wait until he got his draft notice and then join the marines. But that never happened.

On a given day he was enlisted by two members of the OSS, today's CIA. They were looking for someone to deal with Italian war prisoners that were being housed at the closed immigration station on Marginal Street in East Boston and in forts on several of the Boston Harbor islands. Dad accepted the responsibility, and worked things into his schedule. This exempted him from the draft and he never made it into the marine corps.

Dad and the guitarist, John Alaimo, left the Jimmy McHale band and joined the relief band at the Bradford Hotel roof. It was a Latin American band led by Johnny Rosato who arrived in Boston from New York, minus

a guitarist and bass player. So, Dad taught school during the early part of the day, dealt with Italian war prisoners in the afternoon and played music six nights a week at the Bradford.

In 1942, Nanna had a heart attack and the big house at 70 Eutaw Street had to be sold. Both Nanna and Babbononno moved into an apartment on Princeton Street and Mom, Dad and I moved to the 3<sup>rd</sup> floor flat of 74 Eutaw, just two doors away, an apartment we would live in until the spring of 1961. By then, Nanna was gone and Babbononno was in his mid '80s and living with us.

During the war, parking on Eutaw Street wasn't a problem as very few families had cars, but by the mid-50s, you had to hunt for a parking space at night. We moved to Belmont, a west of Boston community where Uncle Gino and his family lived. By this point in time, I had finished college, was teaching in Boston during the day and playing music at night having taken up the bass violin studying with my father.

Dad stayed with the Boston School Department through the court ordered bussing days and then decided to retire. He was getting older and decided to limit music to just the weekends. With time on his hands, he and Mom did a lot of traveling, cruising to the islands of the Caribbean, taking excursions to Canada and sightseeing throughout the United States. Life was good.

Unfortunately, when Dad was in his late '70s he developed aneurysms and needed operations to counter them. Finally, in 1991, during the fall of his 81st year, one untreatable aneurysm burst and Dad passed away. He was always in good physical condition and we thought he would live to a ripe old age. Mom was the delicate one and it was assumed that she would precede him, but she made it to almost 100, just like Babbononno did. Longevity was on her side, Uncle Paul made it to 95, Uncle Nick to 94 and Uncle Gino to 101.

All in all, Dad was successful in life and he and Mom were married for 55 happy years.



Cavatelli are a traditional pasta from southern Italy's Molise and Puglia regions. These eggless, oval-shaped pasta shells have a gap through the middle which is great for capturing various sauces. Customarily they are made from semolina flour, water, and sometimes a pinch of salt. This eggless dough is what gives cavatelli its firm texture. The pasta-making process has been a cherished family activity for centuries, where dough is rolled, cut, and shaped by hand.

My Nonna made cavatelli for many occasions, either in the traditional southern Italian way or using her rendition with ricotta, flour, and egg, similar to her gnocchi recipe. Some families use white flour instead of semolina for the cavatelli dough, while others use a combination of both. I'm sharing the simple southern Italian version along with my Nonna's Ricotta Cavatelli. Both are easy to make and delicious to eat. Cavatelli pairs perfectly with various sauces, from simple tomato-based ones to complex combinations of vegetables, meats, and seafood. A classic dish is cavatelli with broccoli rabe, garlic, and olive oil. Beyond their culinary versatility, cavatelli hold cultural significance, as families often gather to make these chewy, delicious pasta shells for special occasions, symbolizing a labor of love and tradition.

### NONNA'S CAVATELLI



### Traditional Cavatelli

250 g or 1 <sup>3</sup>/<sub>4</sub> cups semolina

150 ml or <sup>3</sup>/<sub>4</sub> cup hot water

Pour the semolina on a wooden board, create a well in the center, and gradually add hot water, mixing it into the semolina to form a paste-like consistency. Continue adding water until the semolina has fully absorbed it. Knead the dough by pressing with the palm of your hand, folding it back, and repeating. If the dough is too dry, add more water; if it feels sticky, add a sprinkle of semolina flour and knead it in. Shape the dough into a ball, cover with plastic wrap, and let it rest for half an hour.

### Nonna's Ricotta Cavatelli

4 cups 00 or all-purpose flour 16 ounces whole milk ricotta, drained well 2 medium to large eggs, beaten

To prepare the dough, place the flour on a clean working surface create a well in the center. Add ricotta and egg mixture to th well, then using your hands, carefully mix together. Then gradually incorporate the flour until fully absorbed. Knead the dough until smooth and elastic, adding more flour if sticky. Shape the dough into a ball, cover with plastic wrap, and let rest for a half hour.

### How to Roll Out Cavatelli


After resting, ensure the dough is soft and smooth. Cut a piece and roll it into a snake-like shape, stretching it out with both hands. If the dough is sticky, sprinkle some semolina or flour on your board before stretching it. Cut the dough into small pillows, like gnocchi, using an angled butter knife. To shape the cavatelli, press down on each pillow with the knife and roll it back, so the dough wraps around the knife edge and then closes back into shape. You can also use a cavatelli maker, but ensure the dough is dry enough to avoid sticking to the rollers.

As you make the cavatelli, place them in a single layer on a parchment or wax paper-lined baking sheet sprinkled with semolina or flour to dry.

### To Cook Cavatelli

Fill a large stockpot with water, add salt and allow to boil. Place cavatelli in the pot and allow to cook until they begin to float to the top, about 5 minutes. They should be al dente, do not overcook. Remove with a strainer spoon and serve with your favorite sauce!

Migrants began staying at Logan last year as shelters ran out of beds and folks remained at the airport until shelter space was found. Airports in San Diego, Chicago and El Paso are also being used to house migrants.



Referee begins counting over Dempsey while Tunney has not gone to a neutral corner

As the confetti commenced its downward flight of triumph - all eyes looked upward, their gazes transfixed on the symbols of their upward hopes that had just been realized.

The Celtics entered the 2023-2024 season as one of the elite teams in the NBA — picked by many prognosticators to win it all. And that moment had now come true with their victory over Dallas in the NBA Finals.

They never faltered and now stood in an area where few could enter.

Watching the proceedings from our seat high in the arena, we were able to take in the entire scene - the vast majority of the people remained in their seats for the ceremony, others remained on the court but only a select group could enter a cordoned off area for the awards ceremony.

Immediately following the final buzzer an area of the court was transformed into a zone for the presentation of awards. If you were on the floor or seated low in the stands it might not have the following meaning. But because of our seat "high above courtside" (and aided by the jumbotron screen) it did.

If one were to think about what unfolded in a certain way, it really was an area where the players, coaches and perhaps even the owners were transported back to another time - one more innocent than the realities of the adult world of 2024.

For in that zone, in that space, there was a transformation. It seemed that everyone became a youngster again. Outside the cordoned off area, the real world of agents, contracts, contract extensions and negotiations existed. That is today's business regarding players, franchises and the real world commitments of the NBA and its various business and broadcast partners.

But inside that cordoned off area, those present realities were held at bay — were suspended if you will — as everyone became a youngster again. It was as if the opening lines of a poem by Elizabeth Aikers Allen had taken hold: "Backward, turn backward, O time in your flight, Make me a child again just for tonight.'

And within that space that is just what was taking place. also had some stiff competition of their own right in the Boston area. Just a short drive away in Brookline the U.S. Open Golf Tournament - one of the major events on the international sports calendar - was being played at The Country Club, challenging the Finals for publicity even in the Boston area.

Then just before the 2022-2023 season was to begin came the coaching change.

Fortunately, it was Joe Mazzulla, a coach known to the players since he had previously served as an assistant, that got the job. So there was a sense of continuity in that critical area.

The C's didn't quite make it back to the Finals in the Spring of 2023, being eliminated by Miami in the Eastern Conference Finals.

But over the summer the acquisitions of Jrue Holiday and Kristaps Porzingis bode well for the franchise. The Celtics were selected by many prognosticators to win it all in the Spring of 2024. Over the course of the campaign they were together for a total of 259 days - from Media Day back on October 2 to the night they won it all on June 17. They went 80-21 in the combined regular season and postseason and were an excellent 16-3 in the playoffs alone. Out of a possible 28 games in the playoffs, the Celtics needed only 19 to win the title.

And let's not forget coach Mazzulla, signed by former GM Danny Ainge to coach the G-league affiliate in Maine, he was later hired by Boston as an assistant coach in 2019. At age 35, he is one of the youngest coaches to ever win an NBA Championship.

Plus he played his college ball at the University of West Virginia, the same college where NBA icon Jerry West — who died on June 12 at 86 — also played. So the legacy of the Mountaineers in the NBA is continuing.

The last NBA Championship for the Celtics came in 2008 under coach Doc Rivers. They reached the Finals again in 2010 when they came within six and a half minutes of another title but fell just short.

Just to show you how time flies, 16 years ago at the time of the 2008 Finals, coach Joe Mazzulla was 18, Jayson Tatum was 10, Jaylen Brown was 11 and Jrue Holiday was 16, Derrick White was 13 and Kristaps Porzingis was 12. Payton Pritchard was 10. Crowds lingered long past the end of the game. Although the official time of victory came at 10:59 p.m., people still were out on the streets in front of the Garden hours later. When Ch. 5 aired live video from outside the Garden at 1 a.m. the streets in the immediate vicinity resembled Times Square in New York City at New Year's. We were still safely inside the building and did not take our leave until much later.



Silent Calvin Coolidge was in the White. While there were rumbles of problems in Europe, peace and prosperity ruled in the United States. Prohibition may have been in full swing, but that did not dampen the festive atmosphere among the people. It was The Jazz Age! Flappers and bootleg liquor were out in abundance.

In Chicago on September 22nd, Jack Dempsey was going to step into the ring to try and regain the title from Gene Tunney. Tunney had won the heavyweight belt a year earlier. Jack earned a rematch by kayoing Jack Sharkey.

The fight, held outdoors, attracted 104,943 spectators and a gate of \$2,858,660, the equivalent of over \$50,000,000 today, and that is without pay per view.

The Dempsey vs. Tunney rematch has become legendary

The argument over how long Tunney had actually been down and whether or not this prevented Dempsey from scoring a knockout has been argued about since the moment it happened. In watching the film of the round, it appears to me that the well-conditioned Tunney had cleared away the cobwebs well before getting up. He was in good enough condition to avoid being tagged again by Dempsey.

What often gets overlooked in the fight is what happened in the next round. Gene was fully himself as he came out for round eight. Dempsey was once again in pursuit of the champion, but Gene was elusive of the. It was mid round when Dempsey started to throw a left hook. With lightning speed Tunney beat him to the punch with a left jab

his feet so quickly, as the punch really hurt him.

After flooring Dempsey, Gene had the fight pretty much wrapped up. In fact, in the tenth and final round Jack was staggered and possibly on the verge of being decked again as the final bell rang. I think if the fight had been scheduled for fifteen rounds instead of ten Dempsey very well may not have lasted the limit.

Make no mistake, this was not an easy fight for Tunney. Dempsey was always dangerous. He was also determined to regain the title and fought as hard as he could. Gene just had too much of everything for him; speed, power, conditioning, and a solid chin.

Would the outcome have been any different if Gene was facing the younger Dempsey? We'll never know.

The players were laughing and clowning around — just as they might have done when then were voungsters. The owners were no longer successful businessmen. They were youngsters who collected sports cards and followed their favorite players and teams. Financial success in the business world would later enable them to own a franchise.

When Javlen Brown was announced as the winner of the Finals MVP Award, it was just as if a school yard celebration had broken out, only this time those doing the celebrating were his teammates in their 20's and 30s. It had been a challenging three-year journey to reach this pinnacle — with its unique challenges along the way. First there had been that trip to the Finals in 2022 that had ended in a setback to the Golden State Warriors rather than success. In addition, those 2022 Finals

The Celtics victory over Dallas came on June 17, exactly 16 years to the day after the C's defeated the Lakers for the title at the Garden in 2008. The victory over the Mayericks also came one month to the day since the Bruins were eliminated from the 2024 Stanley Cup playoffs back on May 17.
