# The North End Deserves Its Own Museum and This is Why!

Four (4) years ago, a proposal was submitted on behalf of the North End Historical Society to the BPDA (Boston Planning and Development Board) for the 2000 SQ FT Civic/Cultural Space at 131 Beverly Street at Lovejoy Wharf owned by Related Beal Realty next to the Converse Building by then Director Tom Damigella with North End Historical Society co-founders Alex Goldfeld and Jimmy Pasto. This space was created to be occupied by a nonprofit that will serve the North End community culturally and educationally.

We chose to pursue this opportunity because the space comes with a FREE 25-year lease agreement! Want to Know More

On June 1, 2023, Tom Damigella made a 15-minute ZOOM presentation to the BDPA committee that explained the importance of why the North End deserves to have a museum in the Civic/Cultural space at Lovejoy Wharf. Presentation is on NEHS website: Northendboston.org.

We believe that we are the best candidate for this Civic/cultural space at Lovejoy Wharf because we are the only surviving neighborhood from 1630 Colonial Boston settlement which should have a place to showcase its 400 years of history and culture.

The North End has seen centuries of change in politics, religion, immigration, and education. This historic district witnessed the creation of the American Republic as well as waves of immigrants seeking the American Dream. We are the Cradle of Liberty!

The North End Historical Society is proposing to construct a modern facility complete with touchscreen displays, exhibition space for historic artifacts, and an auditorium and theatre at Lovejoy Wharf which is right at the beginning of the new Harbor Walk Path.

One last note. The West End has a museum. There is also an African American Museum on Beacon Hill. China Town has their own community/ civic space. We believe that it is time now for the North End to have its own Civic/ cultural space for its museum.

We expect a final decision by the committee to be made sometime this summer of 2023.

It is vital that the North End's iconic place in Boston history be preserved and protected for future generations to know and appreciate. A museum surely will help to guarantee that

# **MassDOT Advises Travelers to Plan Ahead** for Busy Fourth of July Holiday Travel

Registry customer service locations closed Tuesday, July 4 -MBTA schedule adjustments over holiday weekend Special hours for I-93 Boston-Quincy HOV lane

The Massachusetts Department of Transportation (MassDOT) is advising travelers to plan ahead and expect increased volumes of traffic for the Fourth of July holiday period. If traveling, MassDOT recommends utilizing "real time" travel tools, checking holiday schedules for public

transportation, and planning Jonathan Gulliver. trip departure times and routes based on available information.

"With the upcoming holiday, we are anticipating increased levels of traffic congestion, and we're encouraging travelers to plan ahead and make use of our travel resources," said MassDOT Highway Administrator

# Stirpe Nostra



### **LUCIUS VERUS THE SQUANDERER**

Marcus Aurelius ascended the throne upon the death of Antoninus Pius and, at that time, bestowed all honors upon his adopted brother Lucius, even to the point of making him an equal partner in the empire. This was done even though the sovereignty was presented to Marcus alone. Marcus also bestowed his own name upon his brother so that he now became officially known as Lucius Ceionius Aelius Commodus Verus Antoninus. Verus, in return, transferred his loyalty to Marcus, catered to his every wish or directive, and conducted himself with dignity for a short period of time.

Caligula, Nero, and Vitellius were known for their vices but, given a little time, Lucius Verus took second place to none of them. He roamed around the city after dark, visiting taverns and brothels, engaging in merrymaking and brawling, but always concealing his identity. He often returned to the imperial palace with his face beaten and bleeding. One of his favorite tricks of vandalism was to throw large coins into the cook-shops, smashing glasses, cups, and the like. He also favored gladiatorial bouts and these were often performed for his pleasure at have been served in ancient

his banquets. His meals often continued so far into the night that he would fall asleep on the banqueting-couch and had to be carried to his bedroom. Marcus Aurelius knew what was going on but looked the other way.


Many notorious banquets

Rome, but nothing is said to have compared with the most notorious feast of Lucius Verus, who immediately flaunted conventions by placing dining couches for twelve instead of the usual nine. The handsome young boys who did the serving were presented as presents, one to each guest. Also given away were the carvers and the platters upon which they performed their handiwork. There was a supply of live animals and birds of a variety that matched the food that was served. These five species were also given to the guests, along with the jeweled goblets and cups that each used for his drinks ... one for each drink. In addition to all of this, the guests were presented with golden vases filled with ointments and even the carriages, along with their mules and drivers that were used for their journey home from the banquet. The estimated cost for this entire affair was six million sesterces (\$300,000). When news of the affair was brought to the attention of Marcus, he lamented and expressed deep concern for the fate of the empire.

# **Newburyport/Rockport Line** to Accept Zone 1A Fares July 1 - August 31

This Mitigation is in Place to Support MassDOT's Sumner Tunnel Restoration Project



The MBTA and Keolis Commuter Services, the agency's operating partner for Commuter Rail, announced that Zone 1A fares will apply for the entire Newburyport/ Rockport Line beginning July 1 through August 31 while the Sumner Tunnel is closed for restoration work.

The Zone 1A fare is \$2.40 one-way and is equivalent to the cost of a subway ride. Additional details are available at mbta.com/sumner. During this time, Commuter Rail passengers can also park for free at Beverly, Gloucester, Hamilton/ Wenham, Newburyport, North Beverly, Monserrat, Rowley, and West Gloucester station parking lots. Salem and Swampscott parking will be \$2/day.

"The reduced fares on the Newburyport/Rockport line are an important part of our mitigation plan as we encourage people to 'Ditch the Drive' and find alternative travel options during the Sumner Tunnel closure,' said Transportation Secretary and CEO Gina Fiandaca. "I want to thank our partners for their efforts in creating options while this work is ongoing, and our residents and travelers for their willingness to explore these options over the next two months."

"I'm pleased we're able to offer discounted Zone 1A fares on the entire Newburyport/Rockport Line in order to support the Sumner Tunnel closure this summer," said MBTA General Manager and CEO Phillip Eng. "A Zone 1A fare is \$2.40 — the same cost as a one-way subway fare. We hope the public takes advantage of this excellent mitigation and considers Commuter Rail not only as a travel alternative this summer, but as the best means of travel

### Saint Paula Frassinetti

Paula Frassinetti was born March 3, 1809, in Genoa, Italy to Giovanni Battista Frassinetti, a cloth merchant, and his wife Angela. Paula was third of five children, her four brothers all became priests. When she was nine years old, her mother passed away and an aunt came to help with the household. Three years later her aunt passed away, and at the age of twelve, Paula assumed the responsibility.

At the age of nineteen, Paula went to stay with her brother Giuseppe, a priest at the seaside village of Quinto in Liguria, to fulfill the call she felt toward a life of service to God. Paula often assisted her brother in teaching poor children at his parish, and soon realized her vocation as an educator.

In 1834, she and six other women formed a small community called the



"Daughters of Holy Faith." Giuseppe and members of the parish started a small school in a church that had been dedicated to Saint Clare

the school. They went to Genoa to help during a breakout of cholera.

In 1835, Luca Passi, of Bergamo, a friend of her brother Giuseppe, asked Paula if she would assume the Pious Work of Saint Dorothy, a project he had founded to serve the poorest and most needy youth. Thereafter the Daughters of Holy Faith became known as the Sisters of Saint Dorothy. The Sisters took jobs to make money to carry-on their work of educating very poor children, their goal was to bring young people to God through education. Poverty and sickness were always with the Sisters, who often did not even have enough money to buy medicine for themselves. But Paula was determined and knew that God was always with her.

On May 19, 1841, Paula established a house in Rome. The work of the institute expanded beyond Liguria and Rome, to other parts of Italy as new houses, boarding schools, and orphanages were established. Later the sisters established a presence in Malta, Portugal, and Brazil. In the United Kingdom the sisters ran an International Student's Residence and were involved in Parish Ministry.

She passed away on June 11, 1882, after a bout with pneumonia following several strokes. Her body was reported to be found incorrupt in 1906. Sister Paula Frassinetti was canonized in 1984 by Pope John Paul II. The Feast Day of Saint Paula Frassinetti is June 11.





Mayor Michelle Wu has announced the  $27^{th}$  annual Mayor's Garden Contest highlighting the hard work of Boston's urban gardeners. The competition provides the perfect opportunity to recognize the skills of all Boston residents who contribute to the beauty of the city's landscape.

Boston's green thumbs have until 11:59 p.m. on Wednesday, July 12, to submit their gardens for award contention. The contest recognizes gardeners who have landscaped, planted flowers, trees, shrubs, and, in the process, helped beautify Boston's neighborhoods.

Gardeners or those nominating their favorite gardeners may find printable and online nomination forms at boston.gov/mayors-garden-contest. The preferred method of entry is to submit photos through the online application. Alternatively, contestants may request an application by emailing their name and address to gardencontest@boston.gov. Paper applications are also available in English and ten additional languages.

Judges will fan out across the city visiting finalists the week of July 24. Once the votes are tallied, first place winners will receive the coveted "Golden Trowel" award from Mayor Wu while second and third place winners will be awarded certificates

Gardeners who have won three or more times in the last ten years will be automatically entered into the Hall of Fame. These distinguished Hall-of-Famers are not eligible to enter

as contestants but are invited to return as judges.

First place winners are eligible for a drawing for a JetBlue Grand Prize consisting of roundtrip flights for two to any nonstop destination from Boston. Terms, conditions, and blackout dates apply. In addition, Mahoney's Garden Centers will provide gardener's gift bags to the top three winners in each category, as well as gift certificates for the 2023 Hall of Fame winners.

### L'Anno Bello: A Year in Italian Folklore

Feeling Festive on the Fourth

No other holiday smells, tastes or feels like summer more than the Fourth of July. It is the scent of fired-up grills emanating from every American backyard, the light swirl of smoke rising up in the hazy heat. It is the taste of sweet buttered corn crunching between your teeth. The Fourth of July encompasses the sounds of families laughing as they share food and memories outside, and of fireworks exploding across a silky night sky. To this day, I still feel a mysterious shiver when I hear the faint sound of fireworks bursting from some far-off festival during a starlit evening. These distant fireworks instill in me the feeling of the unknown, the sensation that little feasts are sweeping the country before the big celebration of Independence Day. Because of these exciting and myriad feelings, the Fourth of July remains one of my favorite holidays, the quintessential celebration of summer. It is a commemoration of family and food, patriotism and heritage, history and diversity, all converging in a brilliant summer day.

Had Massachusetts representative John Adams been correct, we would have been honoring our country's Independence Day on the second of July. That was the day in 1776 when, during the height of the Revolutionary War, the convention of delegates from the Thirteen Colonies, known as the Second Continental Congress, approved a resolution that declared independence from Great Britain. Adams predicted that this day would forevermore be marked with parades, bonfires and games.

on the nature of Independence Day celebrations proved accurate, only the date shifted to the fourth, when the Congress finally approved this declaration after much revision. Therefore, the Fourth of July commemorates a tremendous event - a bold statement of independence, a desire to free oneself from oppression that would inspire revolutions the world over. As a patriotic holiday, the Fourth of July is also a perfect time to honor America's diversity, and during this holiday I often reflect on what it means to be Italian-American. Italians have been involved in America's quest for liberty and equality since the country's early days. The Tuscan physician Filippo Mazzei inspired the Declaration of Independence's statement that everyone has fundamental equality. Giuseppe Garibaldi, the hero of Italian independence, was recruited to fight in the Civil War and though he did not because of his commitment to Italy's freedom, his name inspired a Union Army regiment comprised of soldiers from both Europe and America. An Italian immigrant, Constantino Brumidi, painted the U.S. Capitol dome. I believe that America's diversity and blend of cultures is precisely what makes our country so great, and on the Fourth of July I celebrate my pride as both an American and an Italian-American.

Along with its history, the Fourth of July is also a revelry in the primordial pleasures of summer, of outdoor festivities and food and fire and the splash of water. In this way, it resembles European Midsummer celebrations, which mark the height of the season around the

summer solstice. My family has several Fourth of July traditions which I hold especially dear, all of which epitomize the unbridled joy of summer. On the night of July 3rd, my husband and I watch a fireworks display put on by our old hometown. As we sit in the stands of the high school football field, we are surrounded by images of vintage Americana: children playing tag across the field, glow sticks waving like little bursts of starlight brought down to Earth, snatches of classic rock tunes, and streaks of color illuminating the night sky as the crowd hushes with awe. On the Fourth, my family gathers for a festive meal which would not be complete without my two Independence Day mainstays: a Southwestern corn pudding and, for dessert, Zebra Pudding, a delectable dessert consisting of chocolate wafers layered with whipped cream, decorated with chocolate sprinkles, and refrigerated until properly cool and the wafers turn soft. My mother usually makes a panzanella salad and, as an appetizer, a dip of salsa and cream cheese served with tortilla chips. As we gather for food and fun, we laugh and share nostalgic and funny stories as the hot summer day descends into a balmy, firefly-filled evening. I will always be thankful for this day of community, love, pride and food!

The Fourth of July grants us an opportunity to pause and reflect on what is most important in life. As we celebrate the freedoms that make America wonderful, we should pause and honor the sacrifices of the men and women throughout history and the modern day who made these freedoms possible. We should take this holiday as a chance to feel proud to be an American but also proud of our ethnic heritage, which contributes to our unique identities. Finally, we should see the Fourth of July as a prime feast of summer, and all of the joys that the season entails. With that, I must take the time to wish everyone ... A Happy and Safe Fourth of July!

# There are Rules for Me and Rules for You in Today's America

# The Artist and the Eternal City



A recent publication by author Loyd Grossman and published by Pegasus Books, and distributed by Simon & Schuster, The Artist and the Eternal City with subtitle Bernini, Pope Alexander VII, and the making of Rome, is very much what its title indicates. Indeed, this work conveys to the reader — and not only to those who have a keen interest in the history of the Church in general or of Rome in particular – a good, and detailed treatment of the determination of Pope Alexander VIII to "restore the prestige of his church by making Rome the key destination for Europe's intellectual, political, and cultural elite."

The method in which to help execute this ambitious program was in the employing, or commissioning of artists to create much of the artwork for which the Church is known. This custom, which was also employed by various private patrons to have works art such as sculptures and paintings created was utilized by Popes for not only ecclesiastical edifices but also for general public display. The Artist and the Eternal City ... therefore gives the reader some good insight of the Popes of the 1600s and the artist Gianlorenzo Bernini, (1598-1680) and Bernini's affiliation with the papacy.

This appealing historical account of Bernini will certainly inform those who would like to

know more about the background of the artist whose work and talent is ubiquitous throughout Rome; most evident, of course, are the following four, and these are just located within the Vatican itself: the Balacchino, with its sculptured, twisted columns; this imposing structure, taking almost 11 years to complete and reaching an impressive 30 meters (close to 100 feet) is a Bronze canopy which covers the main altar in St. Peter's Basilica; the construction commissioned by the then Pope Urban VIII in the early 1600s when Bernini was in his midtwenties. There is the Bernini Colonnade, the structure that surrounds the plaza directly in front of St. Peter's (Piazza San Pietro) and adorned with 284



Doric columns holding up the colonnade which 140 statues are positioned. The third is the Chair of Peter, or the throne of Peter, or its Latin description Cathedra Petri; and the fourth structure is "the Scala Regia, the ceremonial entrance to the Vatican Palace."

While these structures certainly required inordinate attention, it didn't preclude Bernini's getting involved with other projects; truly, to state Bernini was prolific would be an understatement as numerous sculptures, edifices, fountains and other various structures are attributed to him. His works of art would be too many to be lighted

Bernini's association with the papacy respective to his receiving of commissions during this particular historical period (rich in building projects) is not lost on a dominant theme of the book — Baroque art — a style characteristic to Bernini. This decorative and exaggerated art form is not just considered attractive aesthetically but also suggests the *Church Triumphant* — certainly an important and appropriate premise given the powerful status of the Church yet still embroiled by the threat of the Reformation and its precarious consequences. Grossman gives the reader a good background and overview of the use of this architectural style, it's adoption of the during this time and indeed, on the impact that it has made in the city of Rome's ambiance.

Grossman's book also gives a generous application of the use of obelisks. These monuments which are tall, slender stone structures and pyramidal at the top and often have inscriptions, give even more credence to Rome's connection relative to historical significance; obelisks are prominent in the Eternal City. These structures (13 in total) from the ancient world, especially Egypt are displayed in Rome. And in trying to achieve the goal of not only enhancing the city but by truly creating a spectacular one in terms of importance, these stone creations were transported to Rome going back even centuries before the popes of the seventeenth century reigned; in fact, the obelisk that stands in St. Peter's Square and rises 131 feet, was transported to the city by the Roman Emperor Caligula 37 years before the birth of Christ. It was eventually positioned in its current prominent location.

Grossman's book is not only rich in context but also in illustrations. Certainly, the numbers of

visuals augment the history. And, ancillary information can be found with a section *MAPS OF ROME*, 1776. One can view several pages of a very detailed record in terms of layout of the city. And for those interested in knowing more about the obelisks of Rome, there is the supplementary *Obelisk Walk of Rome*, a narrative of each of the obelisks.

Much is covered in Grossman's 315 page detailed history of Bernini, Pope Alexander VIII, as well as other Pontiffs who served during Bernini's long career, as well as other notable artists who played a role in helping with enhancing the city.

This is a book that will keep your interest, provide some interesting background, and answer some questions about the style of Baroque art that is so much a part of the Eternal City.



St. Padre Pio was canonized by Pope John Paul II in 2002. Pius of Pietrelcina (1887-1968) was a Capuchin Catholic priest from Italy, born as Francesco Forgione, and given the name Pius (Italian: Pio) when he joined the Capuchins, thus becoming known popularly as "Padre Pio," He became famous for bearing the stigmata.





### **SONNY ROLLINS:** GO WEST!: THE CONTEMPORARY **RECORDS ALBUM** (3-LP Vinyl Box Set) Craft Recordings

Craft Recordings has released Sonny Rollins' Go West!: The Contemporary Records Albums. a new 3-LP, 3-CD and digital collection that explores Rollins' output for Lester Koenig's revered Los Angeles jazz label. The 20-track set presents two classic albums from the legendary saxophonist's catalog: Way Out West (recorded in March 1957) and Sonny Rollins and the Contemporary Leaders (October 1958). Adding additional context are six alternate takes, culled from both albums. Originally released in 1986 on the long-out-of-print compilation album Contemporary Alternate Takes, these tracks allow listeners to hear Rollins and his fellow musicians develop such iconic recordings as "Way Out West" and "Come, Gone." Both the 3-LP edition and the 3-CD set both include an expanded booklet with new liner notes by the Grammy Awardwinning music historian Ashley Kahn. In the spring of 1957, 26-year-old Sonny Rollins was primed for a new adventure. For nearly a decade, the tenor saxophonist had worked his way up through the ranks of the New York City jazz scene. By the mid-50s, Rollins was playing alongside such stars as Miles Davis, Clifford Brown and Max Roach, and Thelonious Monk, and had released his first albums as a leader on Prestige Records. The saxophonist had also established himself as a talented composer, through such now-iconic jazz standards as "Oleo," "Airegin," "Doxy" and "St. Thomas." But while the Harlem-born artist was firmly entrenched in the East Coast hard bop scene, the opportunity to explore the sights and sounds of the West Coast (where the cool jazz movement was in full swing) had a strong appeal. Rollins commemorated his inaugural trip to California with Way Out West. Recorded in the early hours of March 7 with bassist Ray Brown and drummer Shelly Manne, the album marked the saxophonist's first in a trio setting. A loose concept record, Way Out West was comprised of originals ("Come Gone" and the title track), standards (Duke Ellington's "Solitude," Isham Jones' "There Is No Greater Love") and a pair of Western classics: Johnny Mercer's "I'm an Old Cowhand" and Peter DeRose's "Wagon Wheels." In 1958, Rollins returned to Los Angeles — but this time he was a star. In the two years following his first visit, the saxophonist had released multiple albums, made his debut at Carnegie Hall and was hailed by critics as the decade's most influential tenor sax player. His follow-up for Contemporary, Sonny Rollins and the Contemporary Leaders, would bookend this eventful era — marking the musician's final album of the '50s, before he embarked on his first European tour and took a three-year hiatus, ahead of his next artistic

phase. Recorded over three days that October, Sonny Rollins and the Contemporary Leaders found the horn player primarily in a quintet setting, the album showcased the talents of each musician, as they played eight standards, including "Alone Together," "You," and "How High the Moon." Rollins' love affair with California wasn't just about the scenery, to him, these trips and their resulting albums represented a unique moment in his life — one filled with creative exploration, a thrilling sense of opportunity and romance.

Additionally, Waters new version of the classic Pink Floyd song "Comfortably Numb" features as the final track. Waters commented: "Our Us and Them Tour lasted three years ... At every gig we did an encore after the main show closed with "Comfortably Numb," the encore was always "Mother," I can't remember why I decided to start doing other songs? ... Anyway, at some point after the end of the tour...I started thinking, "It could make an interesting album, all those encores" ... "The Encores". "Yeah, has a nice ring to it!" Then ... 

A Nostalgic Remembrance



This Sunday, Loretta and I celebrate our 45<sup>th</sup> anniversary. We met at Boston University about 47 years ago when we both were in doctoral programs. She opted for a course in the department I was in and I was immediately smitten when I saw her. It took me quite a while to convince her to go out with me, and that first date included a night at the Boston Pops and dinner at the Parker House. We dated off and on, as she was teaching school during the early part of the day and taking several afternoon and night courses.

I was teaching at Hyde Park High School during the day and playing music several nights per week. I had to work my academic schedule around my two professions so that they wouldn't collide with each other. What all this meant was that I had little time for a social

I guess things worked out, because two years later, we decided to get married. Loretta was living in the North End and wanted the ceremony to take place at St. Leonard's. Seeing we decided on July the 2<sup>nd</sup>, the rectory at St. Leonard's was going to be understaffed considering the 4<sup>th</sup> of July was the following Monday and many of the priests were taking a long weekend. We were faced with a problem but obtained the services of Fr. Simon Iocca, who was at the Paulist Center on Arch Street.

Uncle Nick spoke to John Polcari about us having our reception at his restaurant, back then, it was still located in the North End. I booked a limo from a friend, took my best man, Sal Meli, and my ushers to Castignetti's for tuxedos (Remember that men's store?), and booked my own band to play the reception. By the end of June, everything was set to go. Mom and Dad wanted to host a buffet dinner on the night of the wedding rehearsal and my God father, Uncle Nick, set up the bar.

I invited Fr. Simon to join us at my folk's home and he accepted the invitation. I drove the two of us from the North End to Belmont, where Mom and Dad were living at the time. Fr. Simon insisted that the ride not include anyone else, and en route, asked me a lot of

personal questions. When we arrived, he said, "Oh, by the way, our little talk was your confession, and you're ready to receive Communion tomorrow." Mom and Dad went all out with Italian and Chinese specialties, and Uncle Nick had a fine steady hand when it came to pouring the drinks.

Part way through the evening, Fr. Simon asked me if he could use one of the rooms to hold confession in case there were other members of the wedding party or guests who wanted to receive Communion. I didn't know who was Catholic and who wasn't, but made a general announcement. I offered the good priest my old bedroom and one of my groomsmen was the first to accept entrance to the impromptu confessional.

When they came down to the first floor, both Fr. Simon and my friend, Paul, were laughing. When I asked what was so funny, Fr. Simon said, "This is the first time in my life I listened to a confession with the confessor and me sitting on a bed, me with a scotch on the rocks and the sinner drinking a beer. By the way, there was an open copy of Playboy sitting on the

On the next day, July 2, 1977, Loretta and I were married at a 4:00 o'clock wedding Mass at St. Leonard's. After the ceremony, the limo brought us a few blocks away to Polcari's, and there, reception began. The wedding dinner was a multi-course Italian dinner (of course), and we were toasted before, during and after each course. I played a pre-planned trick on Dad and his piano player, who was one of the guests. Often, when they played an affair, they would insist that they were invited to eat, but only served fish heads and rice. After everyone was served their main course except Dad and his pianist, they asked me what was going on. At a prearranged signal given by me, they were served fish heads and rice accompanied by chopsticks. I could be a wise guy at times.

Loretta had chosen two songs for our first dance as husband and wife, the Italian favorite, Anema Core and Glenn Miller's Moonlight Serenade. We danced to them together and then she danced with her father and I with Mom. They both had tears in their eyes as they danced with their children. At about 10:00 p.m., Loretta threw the bouquet and we headed to our new house. Actually, I had purchased a home on the Belmont, Arlington and Lexington line when we decided to get married. We spent three months doing it over to meet our tastes, and it was time to move in. We were going to wait a few days until Uncle Nick was situated at his Florida home and join him and his wife, Aunt Dorothy, for a honeymoon, but it didn't work out. The day after our wedding, Dad and Mom called to let me know that Ralph Manfredonia had died that morning. Ralph and Dad had known each other since they were kids, and Ralph and his wife, Grace, owned the three-decker in East Boston where I grew up. Instead of a honeymoon, we attended a wake and a funeral.

We were happy as a married couple but we did have problems. I won't go into details, but we have only two children, sons John and Michael. John was Loretta's 4th pregnancy, and Michael her 6th. The problems before and in between must have aged us to say the least. The summer of 77 came to an end and it was time to head back to teaching. As a result, we still hadn't had a honeymoon. The first vacation was Christmas and there was a lot of music to play and a lot of happy moments with both our families celebrating Christmas Eve and Christmas Day together.

Right after the holidays, Uncle Nick called from Florida and told us that we were to head for his place for the February school vacation, and he wasn't going to take NO for an answer. Actually, Uncle Nick headed up the musicians' union for over two decades and decided to retire only after Loretta and I were married and settled. He added, "Besides, Aunt Dorothy has never met Loretta. They have to get to know each other."

When the February school vacation hit, we were on a plane heading for Florida and ten days at Uncle Nick and Aunt Dorothy's place. They never had any children and they became like parents. When John and Michael came along, my uncle and aunt became surrogate grandparents. Until my sons were on their own, we vacationed with Uncle Nick and Aunt Dorothy at least twice a year, during the February or April school vacation and in August after Little League season was over. So far, it's been a wonderful life.

Her rendition of the Icebox Cake was made with graham crackers, homemade cooked pudding, and fruit. I was told that "Zia Tindara's Ice Box Cake" was a family favorite. This no bake, easy to make dessert is absolutely perfect to serve at any of your summertime gatherings!

### ZIA TINDARA'S ICE BOX CAKE La torta ghiacciata di Zia Tindara



- 1 box plain graham crackers 10 cups whole milk
- 1 large box 4.6 ounce cook and serve vanilla pudding (not instant)
- 1 small box 3.4 ounce cook and serve vanilla pudding (not instant)
- 1 large box 4.6 ounce cook and serve chocolate pudding (not instant)
- 1 small box 3.4 ounce cook and serve vanilla pudding (not instant)
- 2 cans fruit cocktail, drained maraschino cherries to decorate (optional)

Prepare the vanilla and chocolate pudding as directed on the package and refrigerate each for about an hour to set and cool.

Line a 13 x 9 baking dish (Pyrex) with a layer of graham crackers. Layer 2/3 of the chocolate pudding on top of the crackers and then half of the drained fruit cocktail. Repeat with another layer of graham crackers, the vanilla pudding, and remaining fruit cocktail. Place a final layer of graham crackers and spread with the remaining 1/3 of chocolate pudding and decorate the top with crushed graham crackers and/or maraschino cherries. Refrigerate at least 5 to 6 hours before serving so the graham crackers soften into a cake-like consistency. Refrigerate leftovers.



# THOUGHTS BY DAN ABOUT THIS & THAT

The Early Genius of

### F. Scott Fitzgerald

I strive to be a completionist in regard to the artists I admire and writers are no exception. Of course, this almost always leads us through a variable quality of work, even for those we hold in high regard. However, to understand the evolution of an artist it is important to study at least the bulk of their work including, maybe even especially, the failures.

In this vein, any one at all interested in the career of F. Scott Fitzgerald should read his first short story, published in *St. Paul Academy Now and Then* in October of 1909 when Fitzgerald was only thirteen.

The truth is "The Mystery of the Raymond Mortgage" is not a very good detective story filled with lapses of narrative clarity, jerky plot turns and an abrupt resolution. It reads at best like a summation, or a draft, of the writers that inspired it, Doyle and Poe. It looks, indeed, like it was written by a thirteen-year-old. But what a thirteen-year-old!

What astounds about "The Mystery of the Raymond Mortgage" is how uncannily a pre-teen understood the tropes of early detective fiction and even detected the developments of the following two decades through Chandler and Hammett (the story begins with a grizzled stranger visiting the detective in his office with some information on a case). The story fascinates not on its own merits but because the signs of

a literary genius in the making are evident.

Fitzgerald's first novel, *This Side of Paradise*, was still more than a decade away and by then Fitzgerald was well on his way into becoming the writer who would be canonized as the author of *The Great Gatsby* with a long assortment of short stories touching many aspects of American life in the Jazz Age.

The early 20th century was a transitory time in literature so it is not at all surprising that rising writers would be influenced by forces they would later abandon as they developed their own style shaped by the world they lived in, the Great War, the vibrant '20s and the darkening clouds of the Depression being the principal factors. Mark Twain would die in 1910, though some of his as of then unpublished work would emerge into the 1960s. Six-years later Henry James would be gone but that void would be filled the following decade by Fitzgerald's contemporary, Ernest Hemingway. Hemingway not only considered Twain the father of American literature but combined Twain's pure, whimsical prose with the ex-pat experiences of Henry James (though James's experiences in Europe were closer to Fitzgerald's than Hemingway's). Hemingway also began his literary career in the last place a rugged man of the outdoors would be expected: poetry. For Fitzgerald and Hemingway, the rest is history.

### Fr. Nicholas A. Albin, SJ



Deacon Nick, for the past year, was a familiar face at Saint Leonard's parish while studying at Boston College for his Master of Divinity Degree which he received this past May.

Nicholas A. Albin, SJ, was born in Falls Church, Virginia, and was

raised with his younger sister by his two loving parents in the Washington, D.C., suburbs of Northern Virginia. Growing up, his family and studies at Bishop O'Connell High School were foundational to his faith. He desired to continue his Catholic education while studying business - leading him to attend Xavier University in Cincinnati, where he encountered the Jesuits. He graduated in May 2012, earning a Bachelor of Science in business administration, with a Major in finance. After being inspired by a Jesuit professor of philosophy to consider life as a Jesuit, Nicholas entered the Jesuits at the Novitiate of St. Alberto Hurtado in St. Paul, Minnesota, in August 2012. He professed first vows in August 2014 and began his philosophy studies at Loyola University Chicago.

During philosophy studies, he spent his summers working with migrants along the border of El Paso, Texas, and Ciudad Juarez, Mexico, as well as in the Kohima region of Northeast India, teaching English and theology while giving retreats in Ignatian spirituality. After presenting his thesis analyzing Aristotle's philosophy of friendship through ancient Greek tragedies, he earned a Master of Arts in social philosophy from Loyola University Chicago in May 2017. Nicholas was then missioned to Walsh Jesuit High School in Cuyahoga Falls, Ohio, where he taught theology and mathematics, served as the moderator for student government, and led students in academic summer immersions to the Ignatian sites in Spain, France and Italy.

In August 2020, he began his theology studies at the Boston College School of Theology and Ministry and was ordained to the diaconate in September 2022, serving as a deacon at St. Leonard of Port Maurice Parish in Boston's North End neighborhood. He graduated from Boston College School of Theology in May 2023 with a Master of Divinity. After his priestly ordination in June 2023, Nicholas will begin his next mission as the assistant to president for mission at Creighton Preparatory School in Omaha, Nebraska, while pursuing graduate studies in educational leadership and Ignatian spirituality at Creighton University.

## What's one interesting fact about yourself not everyone would know?

One thing that people may not know about me is that I spent a summer visiting and ministering to the people in the Kohima region of Northeast

India. Months before the summer, the idea of traveling to the twinning region of the Midwest Province came to me in my prayer. It was not an experience I would have volunteered for on my own, but I felt a call from God to explore this opportunity. I expected it to be a challenging experience — being so far away from the comforts of home and adapting to a new place. However, to my complete surprise, it was truly a "fourth week of the Spiritual Exercises" experience for meone full of God's love and grace. It was actually the first time that I felt God's love for me. I have always grown up knowing God's love for me and for others, initially as an intellectual concept, but it was through my encounter and sharing in the experiences of ministry with the people of the Kohima region where the love of God became a felt experience for me. Just simply being with the women and men throughout that region - from teaching in the classrooms to offering retreats to sharing in meals and conversation — I felt like I had experienced God through the people I was ministering to and with.

### Who's your favorite saint, and why?

My favorite saint is Francis Xavier. As an undergraduate student at Xavier University, the story and experience of Francis Xavier's missionary zeal was well incorporated into our transformative Jesuit education. I admire how Francis Xavier willingly gave himself to the mission of the Jesuits, responding readily to Ignatius Loyola's request of him to travel to Asia. One of my most impactful spiritual experiences as a Jesuit was attending the celebration of a Mass next to the remains of Francis Xavier during a trip to Goa, India.

Where has your Jesuit vocation taken you that you never thought you would go?

A pleasant surprise in my Jesuit formation was serving as a high school teacher in my regency experirience for me and

ence. It was a very new experience for me and a job that I never imagined myself doing when I first entered the Society of Jesus. However, to my complete surprise, I fell in love with it. The students were wonderful, and I had excellent colleagues. For three years, I taught sophomore theology (ecclesiology) and algebra I to first-year students. I also loved serving as the moderator for student government where I helped the students with hosting events to boost school spirit, creating fundraising and service opportunities for the local community, and planning the school dances. I also was honored to help lead students in academic study immersion programs visiting the Ignatian sites in Spain, France and Italy. All in all, while I was the one tasked with teaching the students about theology and mathematics, they were the ones teaching me how to be a Jesuit priest. I am so grateful that I had an opportunity to serve for three years as a high school teacher during my Jesuit training.

# Who is one important mentor who has accompanied you on your journey? What made them a good mentor?

While I have had many mentors in my journey, one mentor who stands out for me is Fr. Cyril Whitaker, SJ, who I had as a philosophy professor during my junior year at Xavier University. One day, I emailed him my assignment on Descartes, and he replied back in an email: "Thank you for your paper, Nick. By the way, have you ever thought about becoming a Jesuit priest?" It was his question that inspired me to begin my discernment — which led me to going on retreats, attending spiritual direction and praying with St. Ignatius' Spiritual Exercises — and ultimately led me to entering the Society of Jesus. It has been a pleasure to stay in touch with him throughout my Jesuit formation. His desire to bring people closer to Christ and his care for those he ministers to and with continue to serve as a positive example which I desire to follow in the Jesuit priest I hope to become.



# 85 Years Ago Joe Louis Destroyed Max Schmeling

It Was More Than a Fight



On June 22, 1938, Champion Joe Louis and Max Schmeling met in the ring at Yankee Stadium. Two years earlier almost to the day, in a huge upset Schmeling had kayoed the up and coming Louis in the 12<sup>th</sup> round. That fight also took place in Yankee Stadium. Last week marked the 85<sup>th</sup> anniversary of that fight.

In their first fight Louis was a 10 to 1 favorite, and odds were 4 to 1 he would stop the German. He had already knocked out former champions Max Baer and Primo Carnera and was looking to add Schmeling's name to his list of active former champions. Max had other ideas. He said before the fight he saw a flaw in Joe's defense and would exploit it. That he did, flooring the Brown Bomber in the fourth round and then putting him down for the count in the twelfth.

Not only was this a huge upset, but it was also a useful tool for Adolph Hitler who was claiming Germans were the master race. The dictator was quick to exploit Max's win as he touted the superiority of members of the Third Reich.

Louis would return to the ring less than two months later and put an end to the career of another former champ, Jack Sharkey. The Brown Bomber continued winning culminating in his taking the crown from James J. Braddock in 1937. However, Joe did not feel he was really the champion as the loss to Schmeling haunted him. He made three successful defenses of the title, winning a decision over Tommy Farr, and then kayoing Nathan Mann and Harry Thomas.



In the meantime, Schmeling also had three successful fights, and he had become the poster boy for the Nazi Party. He always claimed he did not support the party.

By the time the rematch was set for June 22, 1938, the fight had taken on much larger status than a heavyweight champion defending his title against the only man to have defeated him. It was now a proxy battle in the war of freedom vs fascism.

Hitler was certain Schmeling would win, and if he did the heavyweight title would become Nazi property, and in the hands of the German Minister of Propaganda, Josef Goebbles would be used to great effect promoting the rise of the German Empire. Yes, a lot was at stake in this fight.

To say Joe Louis was the right man for this moment in history would be an understatement. Joe was only the second black man to hold the most valued title in sports. White America still was not comfortable with a negro heavyweight champ after the period of Jack Johnson's reign.

While Joe was a very different man than Johnson, there was still the matter of his race. What this fight was doing was allowing whites to see Louis as not simply a black man, but as an American. One who was stepping up to defend the country.

Louis clearly understood this as well, but he also had the desire for revenge burning deeply inside of him. There wasn't a day, a moment, that passed since his loss to Schmeling that Joe didn't think about him. He was laser focused on showing the world who the better man was. He also had to prove to himself that he deserved to be called the World Champion.

He also now had to prove that Germany would not prevail in the battle of good vs evil. Yes, this was a sporting event, but it encapsulated all of the madness that was happening in the world. Even though the United States was not committed to the war in Europe, the dark clouds that were forming would soon after turn into a storm that America could not avoid.

As for the actual fight in the ring. It can be said that any fight that ends as quickly as this one did, means the fans did not get their moneys worth. Not in this case. Louis vs Schmeling was perhaps the most exciting heavyweight title fight in boxing history. The incredible drama added to the tension that makes for such a dramatic battle, but even without that, seeing Joe Louis so utterly and calmly destroy Max Schmeling in 2 minutes and four seconds was breathtaking.



Louis fought brilliantly and with precision. He was ruthless but never out of control. The furry he unleashed was done calmly, methodically, and with all of the great skills both taught and natural that Joe had.

Joe's victory was a humiliation for Hitler and his thugs. The dictator had the radio broadcast to the German people cut off as soon as it became apparent what was happening. Excuses were made. Schmeling's image disappeared from public view.

As for Louis. He finally felt he was the true Heavyweight Champion. This fight also marked a change, albeit a slow one, in how the average American viewed their fellow black Americans. It also allowed those black Americans to feel proud and to begin to feel empowered. It would still take decades for them to gain the rights as free citizens that was due them, but Joe Louis, not only in this fight, but in his life, played an important role in moving things forward.

It was often said back then that Joe Louis was "A credit to his race". The great sports writer Jimmy Cannon update that by writing "Joe Louis is a credit to his race: the human race". Never forget that.



### HOOPS and HOCKEY in the HUB

Doc Rivers will not be coming back to Boston anytime soon but one of his most reliable assistants is set to rejoin the Celtics in the Hub.

Sam Cassell, a member of the 2008 NBA Championship team that almost won a second title in 2010, will be coming back to the Garden as a top assistant for the 2023-2024 season, working with head coach Joe Mazzulla.

Although Doc will not be here, quite a bit of the Danny Ainge philosophies of coaching will be still be around — now in Cassell — and in Mazzulla for that matter.

Quite a few people forget that Ainge, the former Celtics GM (now with the Utah Jazz) over time hired both — Doc to coach the Celtics in 2004 and Mazzulla, who served as an assistant for the Celtics minor League team in Maine (then the Red Claws) for the 2016-2017 season. He also acquired Cassell late in his playing career to bolster the Celtics bench for its successful title run.

In fact, Cassell picked up his third championship ring with the C's in his final NBA season after winning two with the Houston Rockets in 1994 and 1995).

Doc remained with the Celtics until he moved on to coach the Los Angeles Clippers in 2013. He hired Cassell as one of his assistants in 2014. By that time the former point guard had five years experience in coaching, having signed on as an assistant with the Washington Wizards in 2009.

Doc and Sam would be a tandem in L.A. until 2020 when Rivers would come East once more to take over the Philadelphia 76ers. Sam came with him and remained in Philly for three years with Rivers, until Doc was shown the door after losing to the Celtics in this year's Eastern Conference semifinals.

Thus, Cassell brings a solid bank of NBA wisdom to the Celtics bench, a quality that cannot be understated in today's super competitive league environment. In adding Cassell, the Celtics have brought aboard a coach that literally has been a member of an NBA coaching staff since 2009. Couple that with his 15 years in the league as a player (with eight different teams) and you have an individual that undoubtedly has a wealth of information to draw upon no matter what situation should arise. This will Cassell 30<sup>th</sup> season in the NBA — 15 as a player and 15 as an assistant

The veteran assistant will thus provide a quality that was lacking during the latter portion of the regular season and throughout the playoffs. Back in March, Damon Stoudamire, the only coach on the Celtics bench with a good deal of playing experience at the NBA level, resigned to return to the college ranks as the head coach of Georgia Tech.

That the C's were able to go so deep into this year's NBA playoffs without a voice on the bench with significant pro experience is a tribute to the 2022-2023 coaching staff of the Celtics — whose season commenced and

continued somewhat under trying conditions.

Cassell came to the Celtics from the Los Angeles Clippers in March,2008 — after clearing waivers and just as the Celtics were starting their final regular season stretch of games that would eventually culminate in success during the four rounds of the NBA playoffs. His presence was acknowledged as one of the major factors in the Celtics having such a strong bench for the playoffs. When the Celtics defeated the Lakers in six games for the NBA championship, that title game would come to mark the last NBA game that Cassell would ever play.

Talk about going out on top. But, on the other hand, maybe now a resumption to be at or at least very near the top. Remember that the C's came within one game of going to the NBA Finals this spring. Cassell is only 53. A year or two or three with a top contender can only continue to enhance his resume for a head coaching job — the

goal of all NBA assistants.

A NEW NBA TOURNAMENT — There has always been an undercurrent of feeling that not that many people pay much attention to the fall portion of the NBA schedule. When the season opens, baseball's playoffs and World Series capture attention as well as regular season NFL and college football games. The National Hockey League is also playing its early season games.

Well, for the 2023-2024 campaign the NBA has something different planned for the early portion of the season. It will be an in-season tournament, one that leads to a trophy being presented and a somewhat decent payday (by NBA standards at least) to those playing in the championship game.

And there could be other aspects that are new. NBA Commissioner Adam Silver has indicated that players might wear different uniforms and that the basketball court itself could look different.

Silver said the concept of an in-season tournament comes from European soccer, noting that since one third of today's NBA players grew up outside the United States, they are familiar with such a structure.

The tournament would include all NBA teams with designated games having a dual identity as tournament games and regular season games. The top eight teams in this early phase would advance to a single elimination round that would be whittled down to the two finalists.

Teams that got knocked out would simply continue their regular NBA schedules. The championship game would be played in December with the members of the winning team receiving \$500,000 apiece with the losers getting half that amount. The championship game would be an 83<sup>rd</sup> game for both teams and would not count in the regular season NBA standings.

So, we'll see how it goes and how it is received by fans around the league. At any rate, it will be Year One of a different concept.
