ENFORCE THE LAWS WE HAVE! by Gregory D. Lee

In the July 7, 2010 edition Latino civil rights and advoof USA Today, Janet Murguia, the president and CEO of the National Council of La Raza, wrote an opposing view to the newspaper's contention that the U.S. government should not sue Arizona over its yet-to-beenacted law to check the papers of suspected illegal aliens. The newspaper is actually for "comprehensive immigration reform," but against the suit, so it was like Ms. Murguia was debating herself.

I got your comprehensive reform right here!

Ms. Murguia used the same, old, tired, arguments opponents to the bill have made since Gov. Jan Brewer (R-AZ) signed it. She wrote that the "Justice Department has a duty to block Arizona's unconstitutional law." The constitutionality of the law is yet to be determined by any court. Even though she's a lawyer, I hardly think Mr. Murguia is qualified to render such an opinion when she is the leader of the nation's largest

cacy group. She mentions that, according to the FBI, "crime along the border and in Arizona is actually down." If true, you have Maricopa County Sheriff Joe Arpaio and his deputies to thank. Attorney General Eric Holder is investigating him because his policy is to arrest and turn over illegal immigrants to Immigration and Customs Enforcement. That's his reward for good law enforcement.

Ms. Murguia contends that "Arizona's new immigration law ... is sure to lead to racial profiling." What evi-dence can she cite? Only the federal government has immigration law, not the states. Arizona's SB 1070 merely requires that when a police officer lawfully encounters a person he reasonably believes is in the country illegally, he must check his documents to verify his lawful presence in the country. The law specifi-

The Elderly Win Again

In the last week of June, Beacon Hill passed a new driving bill that featured a bill on texting while driving that passed, 150-1. The legislation also included a new requirement that seniors 75 or older must renew their licenses in person and pass an eye test every five years.

Dale Mitchell, executive director of Ethos, a senior outreach group in Jamaica Plain reacted to the new senior regulations by saying, "Everyone supports safety on the highways. We're opposed to anything that singles people out based upon age. We don't think that age is the only factor that constitutes the potential for diminished capacity behind the wheel. Mayor's Column

Last week, officials identified the presence of Asian Longhorned Beetles (ALB) in six trees on the grounds of the Faulkner Hospital in Jamaica Plain. While we are confident that the discovery of the ALB here in Boston is an isolated and contained incident, this is a serious issue that presents a very real threat to Boston's cityscape. The City of Boston is working closely with state and federal officials, taking every step and precaution necessary to protect our trees and prevent further spread of the ALB.

The affected trees discovered in

the City of Boston has been collaborating with state and federal partners, residents can play a key role in our effort. You can help by educating yourself and your neighbors on how to spot a possible infestation and keeping a close watch on the trees in your neighborhood.

Important information to help recognize signs of the ALB:

• The beetles are usually 3/4-11/4 inches long, with jet black bodies and mottled white spots. Their antennae are 11/2 to $2\frac{1}{2}$ times their body length and have distinct black and white bands on each segment.

Jamaica Plain were immediately removed and the neighboring trees in the area have been heavily surveyed. The surrounding area within a 1.5 mile radius around the site where the beetles were found have been designated as a "Restricted Area" and it is absolutely critical that any type of wood not be removed from this designated area so that we can further prevent the beetles from spreading. I ask that residents and business located within this area cooperate fully with tree surveyors and officials to ensure that the inspection process goes as smoothly as possible.

We understand that the news of the ALB presence in Boston has been a great concern to our local communities. While

• Look for sap, which may flow from oval pits in the tree that are chewed by female beetles laying their eggs.

 Look for the accumulation of coarse sawdust around the base of infested trees. This sawdust is created by the beetle larvae as they bore into the main tree stem and branches.

• Look for round holes the size of a dime on the trunk and on the branches of trees. These exit holes are made by adult beetles as they emerge from the tree.

This is not the first time the ALB has been found in Massachusetts. An infestation discovered in Worcester in August



THE TOMB OF CECILIA METELLA

One of the well known circular tombs in Rome is that of Cecilia Metella. She is now known as St. Cecilia. The structure is a landmark on the Via Appia and it is still standing, through it suffered from neglect and violence. The tomb is said to be the oldest Roman building where marble was used. The original cone shaped roof has been removed and all of the marble facing has been stripped off. Some of the marble has been reused at the Fountain of Trevi.

The Mausoleum is about 70 feet in diameter and 100 feet high. The thick stone walls leave little space on the inside for a simple circular room which is open to the sky. The sarcophagus was removed long ago.

Fr. Rocco was born in the also converted to Christianity. These were bad times and an outward display of his new Christian faith soon resulted in his execution. Shortly thereafter Cecilia chose not to repudiate her faith and she also was condemned to death by suffocation in the bathroom of her home. The hot air furnace was loaded with about 7 times its usual amount of fuel and she remained locked in the room for over twenty-four hours. Cecilia survived the ordeal with little or no ill affects, an official was then sent to behead her. As a novice he struck with a trembling hand the three blows which the law at that time allowed, but left her still alive. She remained where she had fallen for two days before death mercifully took her.

> St. Cecilia was originally buried in the Catacombs of St. Calixtus. The Church of St. Cecilia was later built over the site of the house in which she was martyred and in 821 A.D. her body was transferred into that church. The legend of St. Cecilia tells us that as a result of a vision or a dream which occurred about 1500 years after her death, the tomb was reopened. She was found to be lying on her right side as a sleeping maiden and not on her back in the usual death position. The body showed no visible signs of decay and appeared to be in a perfect state of preservation.

sculptor-architect, The Carlo Maderna was commissioned to carve a statue representing her exact position. The body of St. Cecilia now lies in a white marble sarcophagus in the confession beneath the high altar of the Church of St. Cecilia in Trastevere. The statue carved by Maderna is also beneath that altar.

Saint Lawrence of Brindisi

Saint Lawrence was born Caesare Russi at Brindisi, Italy on July 22, 1559, he was the son of Guglielmo and Elisabetta. When he was twelve years of age his father died. He then pursued his studies at Venice with the clerics of St. Mark's and under the supervision of one of his uncles. At sixteen Caesare entered the Capuchin Franciscan community at Verona where he received the name of Lawrence. It was at the University of Padua that he demonstrated his remarkable gift of languages; not only was he fluent in his native Italian, but he easily mastered Hebrew, Latin, Greek, Spanish and French, he also made rapid progress in theology, philosophy and acquired a wide knowledge of Scripture. He was ordained a priest at 23.

Lawrence's sensitivity to the needs of people a character trait perhaps unexpected in such a talented scholar — began to surface. He was elected major superior of the Capuchin Franciscan province of Tuscany at the age of 31. He had the combination of brilliance, human compassion and administrative skill needed to carry out his duties. In 1598, Lawrence was sent with eleven other Capuchins to establish Capuchin communities throughout Germany and Austria



where Lutheranism was spreading rapidly. He came to the attention of Emperor Rudolph III as a result of his holiness, wisdom and administrative ability and

was appointed by him to organize the Catholic nobles against the invading Turks. It was at the Battle of Stuhlweissenburg, October 11, 1601 that Lawrence roused the troops with a powerful sermon, then rode with the army as chaplain into battle carrying a crucifix; the Turks numbering 80,000 men outnumbered the German army of 18,000 yet were repulsed and were eventually expelled from Europe. On the 14th of October the Turks suffered a second defeat and withdrew their army behind the Danube.

In an effort to achieve peace in the Kingdom of Naples, Lawrence was sent by the Holy See as a spe-

FERRYING BETWEEN THE NORTH END AND EAST BOSTON



When I was a child living in Boston's North End, I remember my father had friends in East Boston and we would often take the ferry over to Eastie from the North End. If I remember correctly, the fare was two cents. Mostly, the ferry carried folks in their cars. They paid a nickel. It was like the slow boat to China. The ferries stopped when the Tobin Bridge was opened. Back then, both neighborhoods were quite Italian. For a short time my father's family lived on London Street but were displaced by the Sumner Tunnel which sent them packing back across the water to the Sacred Heart Parish and North Square again.

I loved my time in the North End, especially the summers and the feasts. I had relatives there as a kid on Fleet Street. Today, in 2010, there are still family members from my grandmother's side of the family who still call the place "home sweet home." I have enjoyed recently spending more time in the North End and feel sort of like a "Prodigal Son" of sorts. I hang out at Mirabella Pool and at Contrada's. I've been writing in the *Post-Gazette* for about a quarter century now. I am a graduate of the Michelangelo back in 1963 and recently bumped into Joe Bonafine, a fellow classmate at the "Mick."

Late last year, I moved to East Boston for the first time in my life. I live in the Eagle Hill neighborhood and am liking it. Of course, demographically, I live in a growing Latino area where Spanish and not Italian is the foreign language. I think my area is a good mix of Italian and Latin. Orient Heights is still quite Italian. Down by Maverick Square, it is more Central American. All in all, people get along. Neighborhoods in transition can usually be far worse. The Spanish-speaking population is just the latest wave of immigrants to call East Boston their home. The Irish settled here over a hundred years ago. For much of the 20th century, the place was definitely Italian. Today, Brazilians and Latinos have come to appreciate what East Boston has to offer.

East Boston has changed much since the days of the ferry and it will continue to change. East Boston is now part of my demographic portfolio. It was a pleasant surprise. I still view myself more North End thanks to my grandparents but Eastie is growing on me. Independence Day Italian Style





Independence Day celebrations lasted a little longer this year for Boston's Italian American community, as the Dante Alighieri Society wished a slightly belated "Happy Birthday" to the United States of America, last Friday, with a concert which, despite the record heat and the summer weekend date, attracted enough people to fill its main hall to capacity.

And the performers were not even famous.

Pianist Nadia Testa and Flautist Alessandro Crosta, an italian duo specialized in instrumental renditions of operatic arias, did tour Italy and Brazil several times, but had played very seldom in the US, and were totally new to the Boston area. Also, the two featured local singers, Soprano Sara Oettinger and Tenor Jeffrey Hartman, though young and promising, did not add celebrity to the lineup.

Yet the crowd of over CD, Il Canto di Mefite — 200 who converged on the Pescosolido building, in Cambridge, did not seem to titled after, and dedicated

regret their decision, as by the end of the night were all standing up, loudly demanding one encore after another.

"People here are not afraid to cheer" said an exhausted but happy Ms. Testa at the end of the two — hour — plus — long performance. "With an audience so enthusiastic and warm it is hard to believe we are this far from home," she added.

A just as drained and satisfied Mr. Testa, echoed his co-star. "It's an almost dream-like experience," he said. "The best feeling for me when you are abroad is to see how music overrides immediately language and culture barriers."


Certainly the accessibility of the evening's repertoire helped to bridge potential gaps. Apart from a few popular crowd pleasers like "O Sole Mio" and "Funiculi' Funicla," the program was mostly drawn from their last CD, Il Canto di Mefite — Mefite's singing, a collection of famous arias from Operas titled after, and dedicated to, women (Tosca, Boheme, Carmen, Lucia Lammermoor and others).

The title's mythological reference was not chosen by chance: Mefite is in fact the Goddess of fertility who, in the belief of the ancient Greeks, roamed Irpinia, a ruggedly beautiful mountain area of the Italian region of Campania, where the two musicians — as well as a great number of Italian immigrants to Boston come from.

This "call of the land" definitely contributed to the success of the event, as well as the efforts by Dante president emeritus Lino Rullo, also an Irpinia native, who led the organization of this concert for American Independence — involving at least a dozen Italian American clubs and associations throughout the Boston area.

"We never do anything for the Fourth of July," said Rullo. "After America has done so much for us, it is time to start giving something back."

Q2 PROFITS CLIMBED 27% BUT OUTLOOKS KEY

versus a year ago the second quarter earnings started rolling out this week. All eves will be on the guidance for the rest of the year. Is it sustainable? Aluminum giant Alcoa will report on Monday and other bell weathers will follow this week. Intel. Bank of America, JP Morgan, Citigroup and GE are due on Friday of this week. Wall Street expects a 27% profit gain for the S&P500 companies according to Thompson Reuters. That's up from 22.7% projected on April 1st. Cost cutting helped bottom liners in Q2, analysts say and they expect a 9% gain in revenues. Energy profits surged nearly 72% and steel makers, diversified steel makers and chemical firms will show big profits, and reflect strong prices and demand. The tech sector should be strong. Financial firms which enjoyed crisis era comparisons in the past three quarters are expected to produce gains of 18%. Analyst project strong earnings to continue through 2011, but investors aren't convinced. The S&P500 has rallied so far in July, but after selling off in May and June. Alcoa should report a profit of .13¢/share. Sales should top 19% to \$5 billion. The dollars strong Q2 gains may hurt multinational earnings, and shouldn't hurt earnings going forward, analysts say. So far the monthly sales reports are mixed says Christopher Chen, a retail analyst with Weeden & Co. An unusually cold May had consumers still buying sweaters and fleeces instead of bathing suits and shorts. In June, hot temperatures helped some ap-

also did well. Wealthy customers are feeling better about the economy and are trading down less often. At the lower end, the customers are still struggling and she expects cautious guidance going forward. The Wal-Mart customer is still struggling Chen said. Stocks added to their uptrend on Friday marking their 4th straight gain. The NASDAQ gained 1% and the S&P and the Dow rose .8%. Volume was down sharply on all exchanges. In fact it was the slowest day of the year on the NASDAQ. On the plus side, no recent breakouts have fallen apart. A strong uptrend may create doubts among investors who stay on the sidelines for the first few days. One stock that has done well is Bancolombia. The Columbia Bank has risen seven straight days. Digital entertainment developer Rori has also held out after breaking out with four straight days of strength. Investors are waiting to see if the earnings season which begins this Monday serves up encouragement. It's possible that the markets hesitation is right on, we will have to wait and see. In the past few weeks, key economic data, including hiring, retail sales and housing activity have been weaker than expected, just as inventory replenishment is set to wane. Europe's sovereign debt crisis has weighed on the economy. This week the earnings will dictate how earnings gains will impact forward projections, analysts say.

Inventory restocking is slowing. Sales at the wholesale level fell .7 points to 121.5, the lowest since July

Attorney Peter B. Gay, former National Supreme Venerable (President), Order Sons of Italy in America passed away on July 8, 2010. He was born in Taunton, Massachusetts on July 13, 1915, the second son of Olympio and Ida (Pocassoni) Gay. He attended Taunton Public Schools, graduated from the University of Notre Dame and received a law degree from Boston University in 1939. He successfully passed the Massachusetts Bar examination on September 15, 1939. Attorney Gay was the first man of Italian descent from Taunton to become a member of the Massachusetts Bar and elected to public office. Mr. Gay was discharged from the U.S. Army in 1945, served as a member to the Taunton Municipal Council for six years, admitted to practice before the United States Supreme Court in 1964, a successful candidate in 1948 as Representative for the Fourth Bristol District Taunton, Massachusetts. Peter was Chairman of the Committee on Legal Affairs. He was appointed by several speakers of the House to various State Commissions and was cited by Massachusetts Taxpayers Association for his "attendance and efficient work as a legislator."








East of Rome lies a small provincial town named Opi. It sits on a hillside that is almost impenetrable. Although this story is a fictional account the setting, Opi, is a real town in Italy. Ironically, author Peter D. Cimini has relatives who reside in Opi and uses their names throughout the story. The characterization of these people took courage.

Cimini writes about an immigrant Italian family that experienced the difficulties associated with leaving their homestead, Castellamare di Sabia, Italy and face new obstacles, in New York City. Hard work and working together, the Ciarletta family was able to overcome ethnicity related problems. They established a coal and ice delivery business and changed with the times to heating oil deliveries. The entire family participated in the established business led by the foreseeing patriarch, Leopold Ciarletta.

As the family grew, the tribulations of family life, as well as business, began to disenchant grandpa Leopold and grandma. They finally decide to return to their roots in Italy. Adding to the dilemma, the prolific grandparents took six of their American born children with them and left two of the oldest sons in New York City to run the business. Sometime later, the family in New York City was notified that Grandpa, Leopold Ciarletta, was ill and requested that his son Peter and Peter's son, Daniel visit him in Italy.

Following this dramatic visit, that ensured the patriarch's well being, a disaster was about to strike. While Peter and his son Daniel waited to board the ship

to America from Naples, Daniel was kidnapped from the crowded streets of Naples.

Now begins the rest of the story. His kidnappers rushed Daniel to a remote mountain area where the town of Opi lay. His father Peter was at a complete loss attempting to explain to the local police what had happened to his son Daniel. He made every conceivable effort to locate his son. He even went to the king of the Gypsies to plead his case to no avail.

In the meantime Daniel was being forced to live with an Italian family named Sgammotta. On his first morning in Opi, Daniel was

shown his duties, such chopping firewood and garden duties etc. Always under the watchful eyes of his captors, Daniel is now a semi-slave. Every day is the same. Work

> suspect to the reader also. Adding to the mystery is the invitation by his captive family, the Sgarmmottas, to have Daniel eat with them on Sundays and also attend church together. Nonetheless, every attempt to escape was thwarted by the armed guards or by his captor, Vincenzo Sgarmmotta.

Daniel was summoned to the local church by Father Mascia who explained the reason for Daniel's capture. that was to take them back was impossible to escape. It is here that Daniel learns

there are six additional captured lads in Opi. Father Mascia relates how the Nazis had devastated the town. The captured seven were needed to replace the youths Opi had lost and save the town and its people.

The Opi Seven, as these young lads came to be known, met every Sunday in an empty lot and became deep friends. They came from different parts of the world and were able to converse and learned to accept the different philosophies they expounded. They pledged never to forget one another.

Cimini cleverly adds a triumphal sex adventure to this limited life style. Thirtyseven years old Theresa, a resident of Opi approached kidnapped Gabriel, who was a handsome sixteen-yearold, and said that they could meet secretly three times a week.

The following says it all. "She and Gabriel touched the stars and the moon twice that Sunday morning (which was the first time they had met)."

Back in the USA, Daniel's dad Peter was having a difficult time dealing with his family socially as well as business wise. He was deteriorating physically. Apparently he was still suffering emotionally over the loss of his son, Daniel. Understandably he blames himself for the circumstances leading to his son's capture.

I would expect that the captured, known as the Opi Seven, would be affected philosophically by their status. Bear in mind they are teenagers and their thought process was developing. Sixteen years passed. They believed their life and chance to escape was futile. Every plan they attempted failed.

Nineteen-sixtynine came and went. They had been prisoners for twenty-two years. Then out of the blue the town's council called a meeting at the church and declared they would be released. They were scurried to Rome for a five-day debriefing by the police, doctors and psychiatrists. Dr. Amabilia Luciani explains to Daniel the Stockholm Syndrome in answer to his question regarding his feelings toward his captors, especially his fondness for Gelsomina the daughter of his captors. "This syndrome is thought to be an unconscious emotional response to the traumatic experience of being kidnapped and held for a long period of time. The positive emotional bond that often develops between the victim and captor is a defense mechanism of the captive's ego to cope with stress.

Despite my feelings that author Cimini's story at times appeared to be convoluted, I have nothing but praise for his descriptive emotional scenes, especially with his family, I was mesmerized.

Peter D. Cimini is a masterful storyteller who had the courage to write a novel about a complicated subject. I will be mulling over this book for a while. It left me with an educated over read.







Recipes from the Homeland

CAPONATA

- 1 medium eggplant diced
- 6 or 7 tablespoons olive oil
- 1 sliced onion
- 3 tablespoons prepared tomato sauce
- 2 stalks celery diced
- 2 tablespoon wine vinegar
- 1 tablespoon sugar
- 1 tablespoon capers
- 4 green pimento olives
- 1/4 teaspoon salt
- 1/8 tablespoon ground pepper A sprinkle of cayenne pepper (optional)

Wash eggplant whole (without removing outer skin) and

dice. Heat five tablespoons of olive oil in a skillet and add diced eggplant to simmer until it softens. Add sliced onion to skillet and one or two teaspoons of additional olive oil and fry until onion is lightly browned. Add tomato sauce and diced celery. Simmer mixture until celery is tender. If needed, add a tablespoon of water before adding capers and chopped green pimento olives. Stir frequently to prevent sticking.

Slightly heat wine vinegar separately. Add sugar and stir. Then pour vinegar gently over eggplant mixture in skillet. Simmer for ten to fifteen minutes. (Optional) Add a sprinkle of cayenne pepper. Salt to taste.

Serve this hot or cooled as a side dish with broiled lamb chops, breaded fried cutlets or roast beef. It is also delicious on crackers or toasted bread to serve as hors d'oeuvres.

Caponata can be refrigerated for future servings. It can also be frozen and reheated.

NOTE: My husband and I met Louis and Rose "Dolly" Sorrentino on Cape Cod in the 1980's. They were former North End neighbors of ours for many years. We renewed our friendships.



cial envoy to the King of Spain, Phillip III concerning the conduct of his Viceroy of Naples, Ossuna. After successfully finishing his mission, he took seriously ill in Lisbon and passed away in 1619.

Lawrence had a balance in his life that blended selfdiscipline with a keen appreciation for the needs of those whom he was called to serve. Saint Lawrence's canonization took place on December, 8. 1881. With St. Anthony, St. Bonaventure, and Blessed John Duns Scotus, he is a Doctor of the Franciscan Order. In 1959 Pope John XXIII proclaimed St. Lawrence a Doctor of the Universal Church. His known writings include eight volumes of sermons, two didactic treatises on oratory, a commentary on Genesis, another on Ezechiel, and three volumes of religious polemics. Most of his sermons are written in Italian, the other works being in Latin. There are three volumes of his works with notes in Greek and Hebrew. His Feast Day is July 21st.

DID YOU KNOW THAT ...

There should be a hit parade of the richest Mafia chiefs, or "Capi" (a.k.a. Padrini) in Sicily. One of these, maybe the richest, is Matteo Messina Denaro, from the province of Trapani, a fugitive from justice for 17 years. In a matter of a year, the authorities (both the police and the ever-present Guardia di Finanza, or Treasury Police) have confiscated Denaro's patrimony of 1.4 million euro (@ \$1.85 mil.), which equals the 5% of the Region of Sicily's budget. This patrimony consisted of real estate, corporate stocks, checking accounts and many other assets registered to third parties or alter egos of the Godfather, who had invested large sums of money earned from a variety of activities such as R.E properties and the distribution of food items.

Another recent police action against this Godfather resulted in the confiscation of assets valued 500 million euro (@ \$670 mil.) which they found were recorded to an enterprise from the province of Agrigento, one R.C. (for reasons of privacy his ID cannot be disclosed), who had been tried and sentenced to jail terms for being a "Mafia associate," who managed Denaro's assets, mainly in real estate, and in the process creating a monopoly.

Among the confiscated assets (R.C.'s) there were individually registered companies and various corporations that operated in the real estate market, 200 land lots, 90 buildings, 9 industrial buildings with adjacent silos and 120 vehicles. Also confiscated were: apartments, villas, rental apartment buildings, 50 cars and a luxury boat. All the confiscated assets now belong to the State, no longer to Messina Denaro, who has lost everything. And yet, the Mafia still survives!

cally *prohibits* racial profiling and requires that the officer has another good reason for the contact before demanding documents.

Examples of this include when the person is in a stolen car; selling oranges on a freeway off-ramp without a business license; delivering 50 kilograms of cocaine to an undercover police officer; or is suspected of killing a rancher on his property. This is comparable to seatbelt laws that require a driver commit a moving traffic violation before the police can cite him for not wearing his seatbelt. Despite this, Ms. Murguia writes that "SB 1070 will only make what is already a bad situation worse." Far worse for whom? Ille-

gal aliens?

Ms. Murguia forgets that Mexican nationals only make up half of the estimated 12 million illegal aliens in this country. The Arizona law will apply equally to non-Latinos. These people have predominately overstayed their visas and refuse to go home. They need rounding up every bit as much as their Latin counterparts. What she also does not mention is that the Arizona law merely replicates federal law requiring foreign visitors and legal permanent residents carry proof of legal entry at all times. If police arrest a legal alien for not having documentation, producing it later will render the matter moot. The way to guarantee not getting arrested is to carry documents to prove you are here legally. There is no constitutional right to obey only laws you agree with. Carry your green card or passport with a valid visa, and there's no problema. But if you do not have papers and are here

illegally, then it's hasta la vista, baby!

Ms. Murguia and La Raza's solution to "our broken immigration system" is that it "must be comprehensive." I agree. Comprehensive enforcement of existing immigration law will determine if it is adequate or in need of reform. Without the enforcement equation, we cannot validate the law's fairness and effectiveness.

"Comprehensive reform" to her is amnesty and citizenship for illegal Mexican aliens. That's not reform, it's a reward for violating federal law. My comprehensive reform would replicate Mexico's immigration laws that don't tolerate illegal aliens in the country or their receiving government benefits.

The Boston murder count keeps climbing. It now stands at 31, compared to 2009 when it was only 24 at the same time last year. Reverend Shaun O. Harrison reacted to the shootings saying, "... I'm hoping the community will step up, because the police can't do it alone."


