We sincerely appreciate your understanding and cooperation as NEW Health's Hanover Street location undergoes renovations to the roof. The City of Boston Inspectional Services Department and the George Robert White Fund, that manages the building, have ensured us that the building is structurally sound and safe for occupancy.

The next phase of the project will require the health center to close our third floor from Monday, August 7th through Sunday, September 3<sup>rd</sup> for a new ceiling installation. #### **Democrats Pressing Ethics Rules for SCOTUS**

Senate Democrats are pushing ahead with legislation imposing ethics rules on Supreme Court justices but Republicans call the move a no-go. Republicans have made it clear they won't support this legislation and it has no chance of passing a Republican-controlled House. The GOP acknowledges issues on the court; they also say it is a constitutionally created separate branch of government over which Congress has limited powers.

"They're a coequal branch of government and they're accustomed to dealing with these issues on their own,' said US Sen. John Cornyn, R-TX. "Just hypothetically, what if the Supreme Court sent over a code of ethics for the Senate?," he asked. "How do you think that would be received as a coequal branch of government"? In an opinion piece last week in the Washington Post, Senate Minority Leader Mitch McConnell stated, "Unfortunately, Democrats have moved from complaining about the Supreme Court's reasoning to questioning its independence."

#### **Boston Mayor's Enemies List**

Latest news from Boston going national is out of City Hall where Mayor Wu is facing criticism for "Nixonian tactics" after the administration admitted to the creation of a list of her most vocal critics. The list was made in response to a request from Boston P.D. after the mayor had been harassed and physically intimidated by individuals for several months outside her home, at city functions and other public events. The acknowledgement of the list came after the list was uncovered in an email obtained through a public research request. According to a news story in the NY Post published

this week on July 17, the request for the list reportedly came from police officials following the 2022 Dorchester Day parade after many people on the list harassed the mayor throughout that year's parade.






#### COMMODUS ... THE BASTARD RULETH

Commodus had not only developed the habit of drinking all night long but often wandered through taverns and brothels, squandering the resources of the Roman Empire. Even the selection of provincial rulers was made from among his criminal companions or was recommended by them. He so detested the Senate that he vowed to destroy all of them; consequently, some senators formed a conspiracy against him. The fool who was sent to perform the assassination betrayed the plot by forecasting his intention before performing the deed and was quickly overpowered. Needless to say, this set off a round of executions.

Meanwhile Saoterus, the lover of Commodus, became more powerful than the officers could endure. He was escorted from the palace through a ruse and assassinated. Commodus, who was now angered more than he had been concerning the attempt on his own life, started a wholesale purge of the Praetorian Guard, exterminating one entire family named Quintilii and a number of high-ranking officials. After this incident, Commodus appeared in public infrequently, performed few, if any, of the duties required of an emperor, and even processed written messages through his secretary Perennis. The emperor was now easily persuaded to devote himself to pleasure while the secretary assumed all of the burdens of the government and, of course, the power that went along with those burdens.

Commodus was now living a riotous life in the palace amidst his drinking, gambling, banqueting, baths, and 300 concubines. Secretary Perennis gradually secured all of the power, carried on indiscriminate executions, plundered at will, violated all of the laws, and stuffed his own pockets. Meanwhile, back at the bedstead, Commodus debauched most of his sisters, conducted an affair with his father's cousin, and killed his wife because she cheated on him.



Now, by a strange turn of fate, Perennis was declared an enemy of the state, was executed, and his office was presented to Cleander. This turned out to be just one more case where the cure was worse than the sickness and more crimes were committed under Cleander than under Perennis. Prefects of the guard were being changed daily or hourly, and all positions of honor were sold for money. Once again, condemnations, plundering, and executions became the order of the day until by still another strange turn of events, Commodus caused the death of Cleander.

It was at this time in history, about 189 A.D., when Commodus pulled out all stops and went on a wholesale killing spree which included (for fear of retaliation) the kin of most victims. Bellona was a mythical goddess of war, with an active cult of worshippers. In his passion for cruelty, Commodus actually ordered each of the male worshipers to cut off one of his arms while devotees of another cult were forced to beat their breasts with pinecones to the point of death.

He was fond of dressing as an Amazon and carrying a club. In this manner, he fought lions in the arena but also struck at any men who came near him. Men with feet and leg deformities were dressed to look like giants, and then he stalked and killed them with bow and arrow. Anyone who ridiculed him was thrown to the wild beasts. One fat person was cut right down the middle of his stomach so that his intestines gushed forth, while some men were given a new name of "one-eyed" after he plucked out one of their eyes, and still others he named "one-foot" after he cut off one of their feet. In addition to this, he murdered many other persons, some because he didn't like their garments or manner of dress, while others were slain because they appeared noble or handsome. At one time, he even bled men to death with scalpels as he played at being a surgeon. During his reign, many men were able to secure punishment for their enemies by bribery or even to buy immunity for themselves, a change of punishment, or a substitution of another person for one who was condemned to death. He sold provincial governorships, administrative posts in the city, and he even sold results in lawsuits. Finally, to show his impartiality, even his top city officials were either poisoned or introduced to the point of his sword after a few months in office.

# Saint Candida Maria of Jesus

Josefa Cipitria y Barriola was born in 1845 in Andorian, Spain, the eldest of seven children of Juan Miguel Cipitria and María Jesús Barriola. Her father was a weaver. Rather than attend school she helped look after her siblings because she was the eldest child. She made her First Communion in 1855.

At a young age, she went to Burgos to help support the household and worked as a domestic servant in various homes. Barriola was very affected witnessing the extreme poverty and poor living conditions in a place undergoing the social effects of the Industrial Revolution.

Miguel José Herranz, a Jesuit priest, advised her on her path ahead and at his advice she started a number of charitable and education programs; the two met in Valladolid in 1868. Barriola believed that she experienced a vision of Jesus Christ on Good Friday, March 26, 1869. On December, 1871, along with five companions, she founded the Daughters of Jesus and she assumed the religious name: "Cándida María de Jesús".

The nuns founded the congregation for the education of children and the advancement of women in Salamanca. The congregation received diocesan approval from the Bishop of Salamanca on April 3, 1873. On December 8, 1873 she made her solemn profession.

Barriola based her spiritual principles and practices on the Spiritual Exercises of Saint Ignatius. Father Herranz collaborated with her as she wrote the constitution for the order which received the decree of praise from Pope Leo XIII on August 6, 1901; full papal approval came from Pope Pius X in 1913 after her death.

Barriola passed away in 1912. In 2005 her order had 1116 religious in 114 houses in countries such as the Dominican Republic and the Philippines. She was Canonized on October 17, 2010, by Pope Benedict XVI. The Feast Day of Saint Candida Maria of Jesus is August 9.





# L'Anno Bello: A Year in Italian Folklore A Summer of Superstition

A few years ago, I wore a brand-new dress to a close friend's wedding. As soon as I saw it, I was immediately struck by its beautiful pastel-flowered pattern, and I imagined how it would look like a garden in motion against a hot July sky. In addition, the dress, and the event to which it was worn, reminded me of another fact. Summer is here, and for many people that means wedding season. There are many wonderful aspects that I love about weddings: the reunion of family and friends, delicious and intricately decorated cakes, pulsating dance floors, peals of laughter resounding through the room. However, in the midst of this joyous festivity, I am often reminded that Italian weddings carry a sinister side, enveloped in the world of superstition. Because marriage involves such a monumental life change, Italian society ascribes a number of superstitions to weddings, born of natural anxieties and the universal desire to prescribe good luck to the new couple. My family members still hand out confetti, or sugared almonds, as favors at showers and weddings. Supposedly, when wrapped in groups of five, they bestow fertility, health, longevity, happiness, and wealth to the newlyweds. However, wedding confetti is merely a portion of the rich tapestry of Italian superstitions.

I love learning about superstitions because they are reminders of the values held dear by ancient societies. The superstitions that survived to this day tap deep into the fears and desires of the human subconscious: worries over our mortality, longing for a good an unpredictable world. People scoured everyday occurrences for both good and bad omens, and often the signs were contradictory: a black cat, for example, could be the harbinger of fortune or disaster (on a side note, I have a black cat, and I can attest that there is nothing bad about her!). Gathered below are some Italian superstitions repeated in my family, most from my grandmother. If you think that summer proves an odd time to talk about something as creepy as superstitions, keep in mind that Italian culture begs to differ. Ancient Romans celebrated many festivals honoring the dead during the spring and summer. Odd, perhaps, but in the harsh world of antiquity death was an everpresent companion — along with primal emotions of joy and hope - no matter what the season. So, in honor of both wedding season and the journey of everyday life that continues into the summer, get ready to dive into the spooky side of Italian folklore:

• The number 17 is bad luck: This was an oft-repeated nugget from my grandmother. In the United States, Friday the 13th serves as the quintessential bad-luck day. In Italy, it is the 17th of the month. The roots of this superstition extend to ancient Rome. Author Mirella Sichirollo Patzer theorizes that this belief originated from the fact that the Roman numeral for 17, XVII, can be rearranged to spell VIXI, a Latin word meaning "he lived" that is found carved in many ancient tombstones.

• *Malocchio*: This translates to "evil eye" and is an extremely popular superstition entire Mediterranean world. Supposedly, looking at a person with jealousy or anger is enough to trigger a mountain of bad luck upon them. As such, Italians devised a plethora of charms to ward away malocchio. One of them is the cornicello, a horn-shaped amulet found everywhere ranging from necklaces to home decorations, usually colored bright red (when I was little, I thought these were supposed to represent chili peppers). The cornicello is modeled after the cornucopia, a symbol of abundance and fertility in ancient Greek and Roman mythology.

• Birds: My grandmother acquired a very ominous voice when she talked about birds, as they are generally heralds of bad luck in Italy. A bird flying into the house is a death omen, perhaps because ancients viewed birds as being closer to the world of the dead due to their ability to fly. My grandmother mostly feared owls, which Italians also consider a death omen as a result of their intense stare and eerie cry. Conversely, however, owls also represent wisdom and knowledge.

• Salt: Many readers will probably be familiar with the idea that spilling salt is bad luck, since this is a superstition that has reached all corners of the globe. It is also quite popular in Italy, and my grandmother swore by it. This superstition originates from the fact that salt was a very precious commodity in ancient times, and thus spilling it could really result in financial bad luck. Also related to the "precious commodity" line of superstitions are the Italian beliefs that it is bad luck to spill olive oil or throw away bread.

From birds and salt to numbers and amulets, Italian life is peppered with fascinating superstitions. Though most people do not take them as seriously as they did in the past, when uncertainty ruled the most basic interactions of daily existence, these superstitions are still followed out of appreciation of tradition or a sense of fun. Rites of passages and major life events, such as weddings, attract the bulk of these superstitions. As I enjoyed my friend's summer wedding, I also thought about the myriad superstitions that mark the Italian counterparts of these celebrations: the aforementioned confetti, the chiming of bells which originated as a way to ward off evil spirits, the belief that rain on a wedding day is paradoxically good uck, and the granting of the bomboniera, or wedding favor. No matter what occurrence life throws your way, you can be sure that Italian society has some sort of interesting lore attached to it! So as you enjoy the warm summer weather, make sure to watch your saltshakers and guard your eyes, whether or not you are attending a wedding! Many who grew up in the 1950s-2000s could consider a large part of the collection their own "living history."


Irsay is considered to have the largest guitar collection on



## Yesterday & Today

#### A COLUMN OF PAST AND CURRENT EVENTS

**Rembrandt,** was born on July 15, 1606, in Leiden, Netherlands. Rembrandt was the fourth of 6 surviving children out of 10. Rembrandt's father, Harmen Gerritzoon van Rijn was a miller. His mother, Neeltgen Willemsdochter van Zuytbrouck, came from a family of bakers.

Early in his career and for some time, Rembrandt painted mainly portraits. Although he continued to etch and, occasionally paint portraits throughout his career, he did so less frequently over time. Roughly one-tenth of his

painted and etched works consists of studies of his own face.

Rembrandt possessed an exceptional ability to render people in their various moods and dramatic guises. Rembrandt is also known as a painter of light and shade (Chiaroscuro) and as an artist who favored an uncompromising realism that would lead some critics to claim that he preferred ugliness to beauty.

Rembrandt quickly achieved renown among Dutch art lovers and an art-buying public for his history paintings and etchings, as well as his portraits and self-portraits. His unusual etchings brought him international fame during his lifetime, and his drawings, which in fact were done as practice exercises, were also collected by contemporary art lovers.

The core of Rembrandt's work, however, consists of biblical and — to a much lesser extent — historical, mythological, and allegorical "history pieces," all of which he painted, etched, or sketched in pen and ink or chalk. The painting known as *Night Watch* (1640/42) was clearly a turning point in his stylistic development. These changes are not the result of an involuntary evolution but rather a conscious search in pictorial and narrative respects, with his great predecessors.

According to the myth that evolved after his death, Rembrandt died poor and misunderstood. It is true that by the end of his life his realism had been supplanted by Classicism and had become unfashionable in Holland. Nevertheless, his international reputation among connoisseurs and collectors only continued to grow. Certain artists in 18th-century Germany and Venice even adopted his style. Rembrandt is considered a forerunner of the Romantic movement and regarded as one of the greatest figures in art history. Rembrandt passed in Amsterdam on October 4, 1669.

Back in the day during the summer, there was no such animal as air conditioning. We lived in house that had wooden screens that were coated with DDT to keep out the mosquitoes. Maybe, just maybe, one of the screens had an electric fan in it to keep us cool, but that was it. Nanna used the cellar kitchen to cook in and we, more often than not, ate in the back yard.

The table and chairs in the back yard had started out in the upstairs kitchen a generation earlier. When it got old, it became the kitchen set for the kitchen in the cellar, and the cellar kitchen set went out to the back yard. Whatever set that had been part of the back yard décor, was sold to a junk man who would come to the house from Chelsea, pick it up with his horse and wagon, and then ride through the neighborhood yelling out, Any old rags," with something else added on that no one could understand. Things didn't go to waste. Even the dished and silverware used for the summer dinners were those that had seen a better day. You might ask, "Why didn't they use paper dishes and plastic utensils?" Well, they cost money. Both Nanna and Babbononno coming from modest means knew how to cut corners. Bringing up their children during the Depression of the '30s gave the next generation a sampling of how to cut corners, too.

The one thing my family wasn't frugal on was food. They bought the best. But, back in the old neighborhood, there were no supermarkets. More often than not, there were corner stores with some specializing in the products or produce they sold. Today we shop in supermarkets and to examine a piece of meat or chicken, you have to look through a clear cellophane wrap to the contents lying in a Styrofoam dish.

During World War II, everything was rationed, and like all families, we had ration books with stamps inside that determined how much of something you could buy. With several of us living as separate families under the same roof, things were a bit easier. Even Dad and my uncles had rationing to deal with where their cars were concerned. First of all, a few months after the war started, all auto manufacturers stopped making transportation for the civilian market. They all switched to war production.

This meant that after the first few months of 1942, there were no new cars made. If you wanted to buy a car, it had to be a used one. You couldn't buy new tires. They too were only manufactured for military vehicles. If you needed tires, you bought recaps, retreads or just used tires. And, gasoline was rationed for all private vehicles.

People who owned vehicles were issued stickers that were to be displayed in the right front corner of their car's windshield. The most common sticker had a black capital A right in the center. This entitled the owner to three gallons of gas per week. People who had to drive for a living which included the musicians in my family had stickers with capital B in the middle. This group of people was entitled to five gallons of gas per week. During the war, Dad taught at East Boston High School during the day and walked the two blocks from where we lived to where the school was located. My uncles used public transportation, the Boston Elevated, today's MBTA. At night, they usually played with bands that worked the downtown Boston hotels, restaurants, or nightclubs. Things weren't too bad as a result. At the beginning of the war, Dad played with a quintet at the Fife and Drum room of the Hotel Vendome on Commonwealth Ave. When he left that band, he joined a Latin American band that played on the roof level nightclub of the Bradford Hotel on Tremont Street. The distances weren't that great and the Sumner Tunnel was only fifteen cents each way. Come Sunday afternoon, Dad always had a little gas left over to take Mom and me for a short ride.

As I said, everything was rationed and you shopped at specialty stores. On a given day, Nanna, Mom, and I would head to the corner of Eutaw and Meridian Streets and take the trolley to Maverick Square where a slaughterhouse was located. Nanna and Mom would pick out the chickens they wanted (live chickens) and have them killed, prepared, and then bagged. Nanna would put them in her black oilcloth shopping bag and we would head to Jefferies Point and one of the bakeries that existed. Nanna would buy Babbononno the round loaf of bread which is the only type he would eat. Mom would buy a sliced Scali loaf wrapped in white wax paper. From there it was a

long walk to Bennington Street where Kennedy's Butter and Egg store was located. Once the purchases were made and the stamps given to the salesperson, we would walk to Brooks Street and start up the hill to where we lived. The John Sava grocery store was on the corner of Bennington and Brooks. Any canned goods that were needed could be bought there, and again the correct amount of stamps turned in. The next stop was Faber's Fish Market, where the catch of the day was displayed in the showcases surrounded by cracked ice.

As we continued up the Brooks Street hill, there was a butcher shop on the corner of Brooks and Princeton. Everyone called the place Brooks Brothers. A father and three sons owned the business and Nanna would buy her meats freshly cut in front of her. Again, ration stamps were given. The walk up the hill next included a stop at a green grocer on the corner of Brooks and Trenton Streets. Mr. Bruno, an old timer would sell the ladies in my family the fruits and vegetables they needed for the next couple of days. He would always slip me a peach when no one was looking and Mom would give me a penny for a hand full of dried peanuts that were houses in a silver colored machine that was an antique and falling apart, but still worked.

There would be one more stop at a store on the corner of Eutaw and Brooks, Cutliff's Variety, which later became Staffier's Grocery. Before the Staffier brothers bought the place from old man Cutliff, the store was stocked with the needs for the Americans in the neighborhood. When it became Italian after the Staffier brothers took over, Nanna and Mom could buy Italian cold cuts and cheeses, plus anything else they forgot to get on their journey. There was always someone on the corner who Nanna would speak to and give a nickel to. He was the local investment specialist whom Nanna and many others would visit to play the number for the day. The payback for a lottery number win was about seven dollars a cent and Nanna always had a number to play. She actually hit a few times. No one ever told her that this man was a bookie and playing the number was illegal. Once we were back in the house, all the purchases of the day were put away and Nanna and my mother would do some accounting to see what they spent and how many stamps were used and what was left over. This is the way we lived through World War II. The best part of the story is that everyone in the family that was in uniform came home alive. **GOD BLESS AMERICA** 



Brioche col Tuppo, also known as brioscia, is a highly aromatic and delectable Sicilian pastry that exemplifies the island's renowned pastry tradition. These brioche are characterized by their soft aromatic dough, which offer a diverse array of perfectly balanced citrus, honey and vanilla flavors. The name "Brioche col Tuppo" originates from the method of making the pastry from two balls; a smaller one placed atop the larger one. Many believe this unique shape bears a resemblance to the traditional chignon hairstyle worn by Sicilian women, commonly referred to in the local dialect as "tuppo". This delightful pastry is commonly enjoyed alongside another Sicilian specialty, the refreshing granita. Additionally, it serves as an ideal companion to a scoop of ice cream or gelato, which often makes for an excellent substitute on the island for a satisfying lunch or dinner!

There are many traditional recipes for the *Brioche col Tuppo* that call for Manitoba flour along with the use of lard. Many of these recipes can be time consuming and some of the ingredients are difficult to find in the states. The recipe I am sharing may be considered "Americanized" to some, but it yields the same delicious results as those used by home bakers in Sicily. Indulge in a Sicilian *Brioche col Tuppo* and you will savor the flavors and heritage of this remarkable region in every bite!

#### SICILIAN BRIOCHE col TUPPO



2 tablespoons honey

- 1 organic lemon, zested
- 1 organic orange, zested
- 1/3 cup sugar
- 1 cup whole milk, minus 1 tablespoon
- 1 ½ teaspoons yeast
- z 2 eggs
  - 3 1/3 cups bread flour

1 beaten egg and 2 tablespoons whole milk to brush tops

Line a baking sheet with parchment paper and set aside. In a mixing bowl, add the honey, lemon and orange zest and sugar, whisk together. Cover this mixture and allow it to sit for 10 minutes.

Heat the milk to lukewarm and add it to a small bowl. Sprinkle in the yeast and whisk together. Set aside for 5 minutes.

In the mixing bowl with the honey, citrus zests and sugar, add he eggs, beat together and then add the yeast/milk mixture. this mixture, using a dough hook attached to your mixer, gradually add in the flour until all is incorporated. Knead for about 15 minutes. The dough should be soft and sticky. Place it on a lightly floured dough board and fold it into thirds, and then thirds again and into a ball shape. Place this dough in a bowl double its size, cover well and place the bowl in a warm place (such as an oven turned off with the light on) and allow it to rise for 2 hours until it is double its size. When the dough is ready, place it on a lightly floured dough board, knead for a few seconds and cut into 8 even pieces. Take each piece and remove about 1/6 of the dough from each for the top knots. Fold each large piece like an envelope, then a rounded circle and place each circle spread apart on the prepared baking sheet. Take the smaller pieces and fold and roll in the same manner. One by one, take your index finger and make a well in the center of the circle and insert the top knot securely. Repeat until complete. Place the baking sheet in the same warm place you allowed the dough to rise and let rise for about an hour.

Carefully remove the risen Brioche col Tuppo from their rising place (even if the top knots have shifted, do not touch them or they will deflate) and gently brush each with the egg wash. If you prefer them sweeter, you can sprinkle them with sugar before baking. Bake for 15 minutes, until light golden brown. Enjoy!

## Still Time to Plant and Enjoy Beets

Beets are one vegetable you can purchase most months of the year but those you grow yourself taste the best. The good news is there is still time to grow your own this season.

These flavorful vegetables contain fiber, vitamins A and C, calcium, potassium, phosphorous, and more iron than most vegetables. Betalain, the antioxidant and pigment in beets, can be used as a natural red dye and food coloring. In fact, it inspired the saying "red as a beet" and was used to provide that color in makeup.

Beets tolerate warm temperatures but germinate best during cooler weather. Plant seeds  $\frac{1}{2}$  inch deep and one to three inches apart every three to four weeks for a continuous harvest. Make your last planting about eight to ten weeks before the first fall frost.

Beet seeds are a cluster of seeds. Remove all but one seedling in the cluster soon after the seedlings appear. You will also need to remove any excess seedlings to provide the remaining seedlings the space they need to grow and reach full size. Take the sting out of this task by thinking of thinning as a form of harvesting. Use the beet greens removed during thinning as sprouts on sandwiches, salads, and in stir-fries, and other dishes.

Reduce the amount of thinning needed with the help of seed tapes. The seeds are secured onto biodegradable tapes at the proper spacing. Just dig a shallow furrow, lay in the tape, and cover it with soil at the proper planting depth. You'll spend a little more money on seed tapes but save lots of time.

Make sure your plantings receive sufficient moisture throughout the growing season. The flavor is best during cooler weather. All leaves and no edible roots may be a problem you have experienced when growing beets, radishes, and carrots. Thinning and growing root vegetables in well-drained fertile soil at the proper spacing is key to growing success. Improve heavy clay soils by working several inches of organic matter into the top 8 to 12 inches of soil. If this hasn't worked in the past, try growing your beets in containers filled with a quality potting mix.

Harvest beets in about 50 to 60 days when the roots are 1 to 1.5" in diameter. Pull or carefully dig the beets with a garden fork or shovel. Place the shovel several inches away from the root crops. Push it straight into the soil to avoid damaging the roots. Wiggle the shovel to loosen the soil and tilt to lift the beets free.

Trim the leaves back to an inch and leave the taproot intact. Rinse off the soil and allow the beets to dry before storing them in a perforated plastic bag in the refrigerator. Wash, and further trim your beets as needed right before using them. Minimize scraping, cutting, and slicing that will increase the loss of vitamins and flavor.

Most garden centers and mail-order catalogs still have beet seeds available for purchase. You'll find red, purple, golden, and even white beets to grow and enjoy. Select the variety that best suits your gardening and cooking needs.



# Jappy Birthday Mickey Walker

July 13th marked the one hundred and twenty second anniversary of the birth of the Toy Bulldog. Mickey Walker was an all-time great who won the welterweight and middleweight championships. He was also successful when he campaigned as a heavyweight, beating Bearcat Wright and holding future champ Jack Sharkey to a draw. His quest for the title ended when he was stopped by Max Schmeling in an elimination fight for a chance at champion Sharkey.

Mickey fought from 1919 to 1935 and never ducked anyone. He was fearless and tough as nails. He emulated Jack Dempsey and believed he could use his speed and power in the same way as the Mauler did to beat men much larger than himself.

He packed 118 fights into his career, winning 93 with 59 coming via knockout. He lost only 19 times and had four draws. His opposition is comprised of the greats from that era and include in addition to Wright, Sharkey, and Schmeling; Harry Greb, Paul Berlambach, Lew Tendler, Tiger Flowers, Johnny Risko, Dave Shade, Mike McTigue, Ace Hudkins, King Levinsky, Paulino Uzcudun, and Maxie Rosenbloom. As you can see, he fought all comers regardless of size.

In retirement, the champ became a noted artist. His paintings received critical acclaim. He also tried his hand at acting and saloonkeeper. He spent all of the money he earned in the ring and was broke at the time of his death in 1981 at the age of 79. He had been suffering the effects of his many years in the ring.

SAVARD RETURNS TO NHL — There was a saying that one would occasionally hear across America a few decades ago. As one got to be toward what was thought to be the start of middle age, a friend or relative might say "life begins at 40."

That demarcation may have been moved further up the line in the present day. But we could not help but think of it when we became aware of the good news involving former Bruins player Marc Savard who will getting another opportunity in the NHL at age 46.

The former center, who had his playing career curtailed by a series of concussions, will be joining the Calgary Flames as an assistant coach some five years after officially retiring as a player.

For Savard, this marks a new beginning, a fresh start if you will, following years of waiting, wondering and watching. In the beginning it meant waiting for the results of medical tests and what decisions would be based on them, it meant watching from afar as his Bruins teammates captured the Stanley Cup in Vancouver back in 2011. It also meant wondering if there would ever be a place for him again in the National Hockey League.

And for a short time there was. It came back in the 2019-2020 season when Savard served as an assistant in St. Louis. He came to the franchise in the immediate aftermath of one of the most amazing comebacks in NHL history — the Blues rocketing from being in last place in the then 31-team league on New Year's Day in 2019 to winning the Stanley Cup in June against the Bruins, his former team.

During the following season, life in North America changed profoundly, Covid-19 arrived in March. The NHL shut down — finally to resume in August where the Blues lost to Vancouver in the first round of the playoffs. Savard had done his job — improving the St. Louis power play — but opted to return to be with his family in Ontario, thus not coaching at any level during the 2020-2021 season. For Savard there would be more waiting.

When he got the call again it was not from the NHL but the Windsor Spitfires of the Ontario Hockey League. But it was a head coaching position, a good placement for a re-entry attempt. Windsor is located right across the river from Detroit, home of the Red Wings. If this were Boston, it would be like having the Bruins playing in the Garden and the Spitfires playing in Cambridge.

In two years with Windsor, Savard won 88 games for a fine .695 winning percentage. The team made the Ontario Hockey League playoff finals in 2022. and the power play was ranked in the top three in the league during the two seasons Savard was behind the bench.

Meanwhile, up in the NHL The Flames compiled a 38-27-17 record that left them two points shy of making the playoffs in the Western Conference, the first spring they had missed the postseason since 2014. Head coach Darryl Sutter, the brother of former Bruins coach Brian Sutter, was fired — even though he had won the Jack Adams Award (NHL's Best Coach) in June 2022.

So, when the Flames hired new head coach Ryan Huska, you knew further changes would be made. And that is when Savard was brought aboard.

"I know how competitive Marc is from when we played together over three seasons here in Calgary," stated Calgary GM Craig Conroy in a press release. "Savy has a great offensive mind which will help boost our power play and help drive our offensive game. His style was very well known as a player and he sees the game the same way as a coach."

Unfortunately, although he played over 800 games in the National Hockey League, Marc Savard is best known in the Boston area for the concussions he sustained, how they impacted his playing career and how the aftermath of these events played out over an extended period of time.

Marc Savard grew up in Ottawa, the national capital of Canada. He certainly got the attention of the hockey world when he compiled 139 points in just 66 games during the 1994-1995 season with Oshawa in the Ontario Hockey League.

Selected 91st in the 1995 NHL Draft by the New York Rangers, he would continue to play two more season with Oshawa (and have another 130-point year) before advancing to initially play with both AHL Hartford and the Rangers. He was traded to Calgary by the Rangers after two seasons, playing four years in Calgary followed by three with the Atlanta Thrashers, putting up 97 points during the 1995-1996 season. That was fortuitous coming into free agency as the Bruins awarded him a four-year, \$28 million contract on July 1, 2006. He didn't disappoint, amassing 97 points in his first season on Causeway Street. He had 66 in his second and 70 in his third. He later signed a seven-year \$28 million contract with the B's on December 1, 2009. It was soon after that when problems began. On January 7, he sustained a right knee injury and on March 7 — his first day back in the lineup — he suffered a concussion. He returned for the playoffs but over the summer of 2010 struggled with post-concussion syndrome, causing him to miss the first 23 games of the 2010-2011 season. He sustained another concussion on January 23, 2011. It was the last time he would ever play in the NHL. He got his name on the Cup when the B's beat Vancouver that spring, the franchise saw to that, but never returned as an active player. He remained a Bruin in a formal way until 2015 when his contract was included in a transaction with Florida. The contract later would wind up with New Jersey, It was not until January, 2018 that Savard announced his formal retirement from the NHL. So Marc Savard begins a new chapter in his life. Only time will tell how the story turns out.
