Medford Overpass Update:

Work Continues in "Deliberate" Manner to Stabilize I-93 Southbound Overpass
Only 2 Lanes of Travel Open on I-93 Southbound
Travel Lanes in Roosevelt Circle (Route 28) Restricted

The Massachusetts Department of Transportation (MassDOT) is announcing crews are continuing to work around the clock to stabilize the Roosevelt Circle overpass above Interstate 93 southbound in Medford. Interstate 93 southbound is currently restricted to two lanes while work is underway. MassDOT anticipated reopening all lanes on I-93 southbound in Medford at some point Thursday, July 22nd, after temporary repairs were made to the damaged structure. All lanes of travel continue to be open on I-93 northbound as they have been since the incident occurred on Monday, July 19th.

The eastbound rotary bridge

damaged during the incident will also be reopened, when the temporary repair work is complete, which was anticipated to be some point on Thursday, July 22^{nd} , and Roosevelt Circle (Route 28) will be restored to two travel lanes with some lane restrictions until full, permanent repairs are made. These permanent repairs are expected to take several months.

"Stabilization work of the overpass, which began on Monday, is still ongoing and we continue to take a deliberate and systematic approach to ensure that the structure is safe," said Highway Administrator Jonathan Gulliver. "Crews working overnight identified additional damage that risked destabilizing the structure further and we have modified our approach accordingly. Commuters should expect and plan ahead for continued traffic impacts on I-93 southbound on Thursday."

An over height vehicle owned by Dove Transportation LLC of Alabama struck the overpass on I-93 southbound on Monday, July 19th. The company was not permitted for the height of the shipment, did not use the required flag cars, and was traveling an unapproved route when it struck the overpass on I-93 southbound. Dove

Stirpe Nostra

THE BASILICA OF ST. PETER



St. Peter's Basilica, view from Saint Peter's Square, Vatican City, Italy.

Pope Julius II, an outstanding pontiff, statesman, and patriot, ruthlessly pulled down the original Church of St. Peter in order to erect a monument to the papal power, the Christian religion, the Latin race, and to himself. This pope, quick to detect genius, selected Donato Bramante, an Umbrian and Lombard- and Roman-style architect, to prepare the designs for a new St. Peter's and the construction work started in 1506.

Pope Julius died in 1513, and Bramante was replaced by the Florentine architect and sculptor Giuliano da Sangallo, who died after accomplishing very little. Other architects called in at later times to lend their expertise to the project were Fra Giocondo, the world famous painter Raphael, Baldassare Peruzzi from Siena, and Sangallo the Younger. Sometime around 1547, when Michelangelo was 72 years old, he was commanded by Pope Julius III to take over the position of architect for the edifice, which was about fifty percent complete. Michelangelo prepared the design for a central dome set on a high circular drum-like base and strengthened the piers below. Unfortunately, Michelangelo died before the dome was constructed, but it was completed from models that Michelangelo left. He had served the Pope without compensation "For Love of God only," and once again produced one of the great masterpieces of art.

The architects who succeeded Michelangelo were: Giaconda Della Portal, Domenici Fontana,

Vignola, Liborio, Carlo Madera, and Giovanni Bernini. Bernini is the architect who designed the beautiful entrance colonnade, the baldachin (bronze canopy over the altar), and the twisted black marble columns that support the baldachin.

The Basilica of St. Peter is claimed by the Romans to be one of the wonders of the world and perhaps the most stupendous of all. For nearly 200 years, the greatest masters of the Renaissance exerted

their genius and exhausted all of the resources of their art while more than 40 popes lavished their treasures on this unparalleled sanctuary, which stands on the site of Nero's circus where thousands of the first Christians were martyred.

St. Peter's is the most important building of the Italian Renaissance period, and the largest church in the world. Some idea of its tremendous size can be realized when we discover that St. Patrick's Church in New York City will fit inside St. Peter's three times in length, and the Statue of Liberty on its base will fit under the dome of St. Peter's leaving 95-feet to spare. The lettering at the interior base of the dome translates from Latin to "Thou art Peter and upon this rock I will build My Church and to thee I will give the keys to the Kingdom of heaven." The main altar is called the Altar of Confession. It was built over the tomb of St. Peter. The Holy Father or specially authorized cardinals are the only persons permitted to say Mass here. The baldacchino (canopy) over the altar is entirely of bronze and weighs over 700 tons. This canopy is supported by four twisted black marble columns that were copied from Solomon's Temple.

The effects of Michelangelo's dome became so far-reaching that from the end of the 16th century, no important church was built without the central dome, which also became a "must" for every monumental U.S. building, including our national and state capitols.

Transportation had secured permits for a smaller load with a different route. MassDOT intends to hold the trucking company legally and financially responsible for damages and will be reviewing the company's eligibility for obtaining permits in Massachusetts in the future. Massachusetts State Police have released initial information about the bridge collision and their investigation: https:// mspnews.org/2021/07/20/ msp-investigating-medfordbridge-collision/

MassDOT crews are demolishing the damaged portions of the bridge to remove any falling hazards. This work is being done in a way that safely maintains two lanes of traffic under the undamaged portion of the bridge. Engineers are approaching the demolition work carefully to ensure that further damage to the bridge does not occur as damaged portions are removed. This is being done by strategically cutting structural elements to relieve tension and disconnect them from the rest of the bridge structure. As part of work activity on Tuesday night crews discovered additional damage that created an unsafe cantilevered section of concrete bridge deck that must be addressed before more conventional demolition methods can be employed on the remaining portions of the bridge.

Drivers are encouraged to use public transportation if they ordinarily would travel on I-93 southbound in Medford. The MBTA Commuter Rail Station at Anderson in Woburn, at 100 Atlantic Avenue, has parking and the trip on the commuter rail from Anderson to North Station generally takes 25 min-


There is a move under foot to demonize all law enforcement as

The hotel/bar where Brick and Tully work and Rachel and Tammy are staying is run by Marley who has help from Jamal. Marley is quite the gossip as we learn in Coconut Telegraph. Ms Sha'nae uses a lovely patois as she sings while spreading the latest rumors.

From the opening number straight through to the close the energy of the cast was in full force. Mr. Smith when performing Margaritaville begins with a simple acoustic guitar and is then joined by John Antony, Matt Wolpe, Crystal Sha'nae, and Tyler McKenzie who were all marvelous as they build it into a terrific finale for the first act. It almost seemed a shame to have to pause for intermission.

There are two zombie dance sequences that are quite something to see. The zombies are brought on by Brick's anxieties, and sure make for some interesting staging. You wouldn't mind having this gang show up at one of your barbecues.

JD is a 76 year old beach bum who spends his days at the bar telling stories most of the people don't believe. This changes during the touching He Went To Paris, where his life story is told and the non believers have their eyes opened.

Being in the outdoor pavilion has not forced the team at the Playhouse to compromise on lighting and effects. While I am sure it has been a real challenge for them, they have pulled it off marvelously. The volcano eruption sequence is evidence of that.

The staging is impressive and the sets are vividly colorful. I was quite impressed with the acoustics considering this is taking place in an outdoor pavilion. It rivaled what would be heard at the indoor venue.

The show is full of high spots.

A few that were even a bit higher for me were Why Don't We Get Drunk with JD urging the audience to fill in the blank about what to do after imbibing. Come Monday with Brick and Tammy, and of course, Cheeseburger In Paradise where Tammy and Brick bring down the house.

While the audience was clearly thrilled with the production, the cast members showed by their enthusiasm how happy they were to be back on the stage making people happy.

The orchestra, complete with steel drums, gives a solid Caribbean Island flavor to the score that makes you thirsty for a tasty margarita that is available at the bar. Situated high up on both sides of the stage it sounded great.

I must confess that while I grew up during the heyday of Jimmy Buffet and was familiar with some of his songs, I was far from a Parrot Head. After seeing this production I will be listening much more. At this point I'm now probably more JD than Tully, but it is still fun.

The superb cast, the delightful music, the summertime energy make this a must see show. With Ogunquit Beach just down the street and with ocean breezes wafting through the Leary Pavillon, you couldn't ask for a better setting for a musical featuring the music of Jimmy Buffet. Even with all of the challenges it has faced, the Ogunquit Playhouse continues to exceed expectations.

It's time to enjoy life again, to smile and share and connect. Come and take a bite out of this Cheeseburger In Paradise in Ogunquit. You won't be disappointed.

Superstitions Worth Their Salt

Two years ago, I wore a brandnew dress to a close friend's wedding. As soon as I saw it, I was immediately struck by its beautiful pastel-flowered pattern, and I imagined how it would look like a garden in motion against a hot July sky. In addition, the dress, and the event to which it was worn, reminded me of another fact. Summer is here, and for many people that means wedding season. There are many wonderful aspects that I love about weddings: the reunion of family and friends, delicious and intricately decorated cakes, pulsating dance floors, peals of laughter resounding through the room. However, in the midst of this joyous festivity, I am often reminded that Italian weddings carry a sinister side, enveloped in the world of superstition. Because marriage involves such a monumental life change, Italian society ascribes a number of superstitions to weddings, born of natural anxieties and the universal desire to prescribe good luck to the new couple. My family members still hand out confetti, or sugared almonds, as favors at showers and weddings. Supposedly, when wrapped in groups of five, they bestow fertility, health, longevity, happiness and wealth to the newlyweds. However, wedding confetti is merely a portion of the rich tapestry of Italian superstitions.

I love learning about superstitions because they are reminders of the values held dear by ancient societies. The superstitions that survived to this day tap deep into the fears and desires of the human subconscious: worries over our mortality, longing for a good harvest, a need for control in an unpre- to trigger a mountain of bad luck dictable world. People scoured upon them. As such, Italians

good and bad omens, and often the signs were contradictory: a black cat, for example, could be the harbinger of fortune or disaster (on a side note, I have a black cat, and I can attest that there is nothing bad about her!). Gathered below are some Italian superstitions repeated in my family, most from my grandmother. If you think that summer proves an odd time to talk about something as creepy as superstitions, keep in mind that Italian culture begs to differ. Ancient Romans celebrated many festivals honoring the dead during the spring and summer. Odd, perhaps, but in the harsh world of antiquity death was an ever-present companion — along with primal emotions of joy and hope — no matter what the season. So, in honor of both wedding season and the journey of everyday life that continues into the summer, get ready to dive into the spooky side of Italian folklore:

• The number 17 is bad luck: This was an oft-repeated nugget from my grandmother. In the United States, Friday the 13th serves as the quintessential bad-luck day. In Italy, it is the 17th of the month. The roots of this superstition extend to ancient Rome. Author Mirella Sichirollo Patzer theorizes that this belief originated from the fact that the Roman numeral for 17, XVII, can be rearranged to spell VIXI, a Latin word meaning "he lived" that is found carved in many ancient tombstones.

• Malocchio: This translates to "evil eye" and is an extremely popular superstition not only in Italy, but in the entire Mediterranean world. Supposedly, looking at a person with jealousy or anger is enough everyday occurrences for both devised a plethora of charms

to ward away malocchio. One of them is the comicello, a hornshaped amulet found everywhere ranging from necklaces to home decorations, usually colored bright red (when I was little, I thought these were supposed to represent chili peppers). The cornicello is modeled after the cornucopia, a symbol of abundance and fertility in ancient Greek and Roman mythology.

• Birds: My grandmother acquired a very ominous voice when she talked about birds, as they are generally heralds of bad luck in Italy. A bird flying into the house is a death omen, perhaps because ancients viewed birds as being closer to the world of the dead due to their ability to fly. My grandmother mostly feared owls, which Italians also consider a death omen as a result to their intense stare and eerie cry. Conversely, however, owls also represent wisdom and knowledge.

• Salt: Many readers will probably be familiar with the idea that spilling salt is bad luck, since this is a superstition that has reached all corners of the globe. It is also quite popular in Italy, and my grandmother swore by it. This superstition originates from the fact that salt was a very precious commodity in ancient times, and thus spilling it could really result in financial bad luck. Also related to the "precious commodity" line of superstitions are the Italian beliefs that it is bad luck to spill olive oil or throw away bread.

From birds and salt to numbers and amulets, Italian life is peppered with fascinating superstitions. Though most people do not take them as seriously as they did in the past, when uncertainty ruled the most basic interactions of daily existence, these superstitions are still followed out of appreciation of tradition or a sense of fun. Rites of passages and major life events, such as weddings, attract the bulk of these superstitions. As I enjoyed my friend's summer wedding, I also thought about the myriad superstitions that mark the Italian counterparts of these celebrations: the aforementioned confetti, the chiming of bells, which originated as a way to ward off evil spirits, the belief that rain on a wedding day is paradoxically good luck, the granting of the bomboniera, or wedding favor. No matter what occurrence life throws your way, you can be sure that Italian society has some sort of interesting lore attached to it! So as you enjoy the warm summer weather, make sure to watch your saltshakers and guard your eyes, whether or not you are attending a wedding!



CHAPTER 53 Dining Out

Life in the North End during festival season spilled out of the apartments and onto the streets, particularly affecting those whose saint was being honored from their region of Italy. Families set tables of food and drink on sidewalks in front of their buildings, where members sat from early afternoon till late in the evening, conversing with one another. Food offered to a never-ending stream of visitors, honoring the family, and sharing in their regional dishes.

Every year, the Ricci family set up several card tables in front of their doorway on Garden Court Street. Being one of the leading families of fishermen in the North End, they were expected to put out quite a spread and they never disappointed their neighbors. It would take Carla a week to prepare the food for the feast. The tables were covered with red and white checkered tablecloths that she loaded with platters of salami, cheese and all variety of Italian cold cuts, fried calamari, baked sausages, spaghetti and meatballs and calzone, all served in abundance. Large pitchers of chilled wine, peach halves floating in them, were scattered along the tables and refilled as soon as emptied. Papa Egidio would play his mandolin throughout the early evening hours, as if to serenade the guests who visited his tables. The sultry August evenings were magical with the sound of mandolin music and clinking glasses, as guests toasted each other and their patron saint, and always, the laughter drifting on evening breezes. Evenings imbued the feasts with a special magic, shrouding the foreign surroundings of their adopted land for both North Enders and immigrants alike, bringing to



life the sounds and smells of Italy. People who came ashore in successive waves over decades, worn down from their everyday labor, seemed to be reignited like a flame given life through the strike of a match. The colorful lights that hung from the flats in tribute to the saint, cast their warm and familiar glow over worn tired faces. "Carla, we are running out of Sangria. Bring more pitchers of wine for our guests," Egidio demanded, as he put down his mandolin to embrace two of his amici (friends), Roberto and Anna Gallo. "Carla vieni subito" (Carla come quickly), he once again demanded, as the click clack of Carla's sandals could be heard quickly descending the stairs in response to her father's request. "Papa, I'm coming, I'm coming," she reassuringly called out, as she descended the worn wooden flight of stairs leading to the street. Egidio reached out for the wine pitchers, and quickly filled the glasses of his friends. It was late in the evening and many of the platters had been emptied. Egidio slightly embarrassed, asked Carla to bring more cold cuts for the late arrivals. Swiftly, she rushed upstairs to fill two platters with salami, prosciutto

and provolone. Minutes later, the click clack of her sandals could once again be heard, as she descended the stairs, a platter in each hand, much to Egidio's delight. The town with a year-round population of just over a thousand residents has constant drama in its government. The players seem to be continually at war with one another, and quite often, these battles become highly personal. The latest one playing out has to do with the leadership of Ogunquit Ocean

At the end of June this year the interim Town Manager Matthew Buttrick decided to replace the Captain of the lifeguards, JP Argenti, with the incoming Fire Chief Russell Osgood. Even though Mr. Osgood has no experience as a lifeguard and is not certified for the position it was felt he could

handle the job. This was done without public input, and it is unclear what, if any, input the Select Board had with the decision. The Town Manager has said this was done to reduce the amount of department heads responding directly to him. Others have said it was because Mr. Argenti was pushing for pay increases for the lifeguards. The possibility that this was done for personal reasons has also been floated. The Town Select Board has remained silent on the issue other than to approve the appointment of Mr. Osgood as Lifeguard Captain.

The upshot of all of this is that Mr. Argenti, a twenty-year veteran of Ogunquit Ocean Rescue and Captain for the past eight years was dismissed. An additional fifteen lifeguards have either resigned or have signaled they will not be joining the service when scheduled to do so. Among these are the most experienced members of

Ogunquit Ocean Rescue. This has all been happening just as the summer season is kicking into full swing. It is also a year that is seeing a thirty-year high in lifeguard shortages across the nation, and an increase in drownings throughout New

England. Over the past ten years, I have spent a lot of time on the beach at Ogunquit. It is listed as the 7th most beautiful beach in the country, and it certainly deserves that designation. It is a breathtaking seashore with magnificent sunrises and sunsets, wonderful clean water, and a river with a strong current that flows into it. It can also be a bit treacherous as the sands are constantly shifting making for unpredictable riptides. On a typical beach day upwards of 20,000 people will pour onto the 1.5-mile long beach. When staffing is at full capacity there will be 17 lifeguards looking out for the public that is visiting. This out of a full complement of 35. Most years the guards are about equally divided between male and female.

I once remember hearing someone on the beach remark while watching the lifeguards that "These kids get paid to hang around the beach all day. What a racket." I get the feeling that sentiment is felt by the leaders of the Town of Ogunquit. I hope I am wrong, as the job of Ocean Rescue is much more complicated than "hanging around the beach all day."

Lifeguards must be Red Cross certified. At Ogunquit under JP Argenti, they went through extensive training that continues during the season. This training includes ocean rescue techniques, using a board and rescue can, CPR, first aid, AED (defibrillator), radio traffic, numerous workouts involving running, swimming, paddling,

medical rescue scenarios, rules and guidelines.

Guards also have to deal with such things as unruly people, enforcing regulations regarding alcohol and smoking, finding lost children, administrating aid to people suffering from heat related problems, and even hypothermia caused by being in the cold water too long. They help disabled people on and off the beach. While doing all of this, team members also have to keep watch for people who may be getting into trouble in the water. Riptides are a major issue that can prevent swimmers from reaching shore. The lifeguards have to keep constant watch for signs that the water may be becoming more dangerous and remain alert for the dangers caused by these changes.

If all that isn't enough, the members of Ogunquit Ocean Rescue also assist people out of danger and back to shore and prevent them from entering dangerous areas. They provide patrons information, perform water testing for Maine Healthy Beaches, monitor the plovers and the dunes, while on slow days (if there can be such a thing) they clean up the beach and do workouts and more training.

On top of all that, the most dangerous part of the job is springing into action to save swimmers who are in imminent danger of drowning. This is most common near the mouth of the river where the current becomes very strong during the changing tide as the water drops off and becomes colder as it enters the ocean. When jumping in to save a swimmer in distress the lifeguard puts him/her self in extreme danger. This is where the training and proper use of equipment pays off. Knowing how to

maneuver the jet ski and board is a difficult skill to acquire, but pays off when the time comes. When a life is in danger, these "kids" take on a whole different aura of importance. They are highly-skilled professionals, well-trained, with the courage to risk their lives to save others.

In the conversations I have had with JP Argenti over the years, I have not only been impressed with his professionalism and knowledge of the beach, but also how steeped in the history of Ogunquit Beach he is. His dedication to his job and love for the area runs deep. He and members of the team could often be seen there after hours when he felt their services might still be needed.

Ogunquit Beach has a long and colorful history. There is some evidence the first lifeguards served on the beach in 1909 as tourism began to grow. At the time they were a

Saint Peter Julian Eymard ok

Peter Julian Eymard was born in Mure d'Isère in the Alpine mountains of southeastern France on February 4, 1811. His father worked as an olivepresser, His mother inspired Peter's devotion to Our Blessed Mother; she taught him of the Holy Eucharist, and the dangers of sin. The family was poor, but strong in devotion to their faith. As a child, Peter demonstrated great piety and desire to serve the Lord, promising at his first Holy Eucharist that he would become a priest. However, Peter's father wished him to assume responsibility for the family's small olive oil press, and discouraged his desire. Nonetheless, Peter studied Latin on his own, and sought spiritual direction from a local missionary priest.

His father passed away while Peter was a young man, and with his mother's permission, he entered the Oblate novitiate at Marseille. Peter entered the novitiate of the Oblates of Mary Immaculate in June 1829. His first attempt as a seminarian ended because of serious illness. Throughout his life, Peter suffered from poor health, particularly 'weakness of the lungs' and migraine headaches.

In 1831, he succeeded, with the help of his former superior, in gaining admission to the major seminary of the Diocese of Grenoble. On July 20, 1834, he was ordained a priest for the Diocese of Grenoble. He was assigned as assistant pastor at the town of Chatte, and three years later appointed pastor of Mount Saint-Eynard.



A few years later he heard some Marist Priests preach. The Marist order is dedicated to the Blessed Mother. Their message appealed to Father Eymard, and he eventually joined their congregation. He traveled through Europe, giving retreats and missions. In 1856, Father Eymard founded the

Congregation of the Blessed Sacrament. The men who joined the congregation stood watch over the Blessed Sacrament 24 hours a day and soon attracted lay persons to do the same. This practice of prayer and devotion before the Blessed Sacrament became known as Eucharistic devotion.

The congregation struggled and was very poor. But Father Eymard did not give up. Despite continuing problems with his health, he even helped form the Sister Servants of the Blessed Sacrament. Along with the men and women of these congregations, he visited the poor and those in prison, and he tried to educate Catholics in the teachings of the faith.

In 1868, at the age of 57, Father Eymard passed away. He was canonized in 1962 by Pope John XXIII. He has been referred to as "the Apostle of the Eucharist." The Feast Day of Saint Peter Julian Eymard is August 2nd.



But, when the summer of '58 came along, I had no work as a musician. Babbononno assured me that I was ready to venture out and Dad agreed with him, so I called the Ken Reeves office and asked for an audition. The Ken Reeves Orchestra catered to Boston Brahmin, the descendants of Boston Yankees, who by this point in time resided in the northern and western suburbs of Boston: Lexington, Belmont, Weston, Wayland, Wellesley, Dover, Andover, Winchester, Manchester by the Sea, Sudbury, Carlisle, Pride's Crossing, Hamilton, and just a few more upscale communities.

On weekends, many of these folks had social functions and Ken, being part of their circle, often supplied the music. He had many bands out on weekends and the men who played for the "chosen few" were from the first tier of the lot. For reasons I'll explain later, I was chosen to join with the first tier of musicians. The bass player who usually handled the rhythm chore could also lead, and that night, he fronted another group of Ken Reeves players for one of their many weekend jobs.

I was told how to dress, how my hair should look, how my nails should look, how I should speak to anyone who spoke to me. The only thing Ken Reeves never told me was how to play bass. (Thank God)

The first job I was hired to play was at the Manchester Bath and Tennis Club. Before they let me in, I thought they were going to investigate my family's origins, if you get my drift. I was one of

It was July of 1958, and I the first men on the bandstand and felt a bit nervous. I was only 18, and knew that I would be working with men twice to three times my age who were seasoned musicians. I was apprehensive eville Theater in East Boston.

The type of music that the Yankee crowd liked for listening and dancing was a composite of show tunes from the latest musicals on Broadway, up tempo pop tunes of the past and present, and Dixieland from the 1920s and '30s. Fortunately, I could play 99% of it as Dad and Babbononno had me memorize everything in the way of pop music.

Dad had taken me to a men's shop in downtown to fit me for a tuxedo, a mandatory uniform for a musician back then. I next made an appointment at the Frank Fay barbershop behind Jordan Marsh. Frank and his staff catered to businessmen, politicians, and people in show business. A barber cut my hair and a manicurist shaped my nails. My barber was Phil Consolo, the man who gave me my first haircut as a child. He was a pal of Uncle Gino's from the old neighborhood. By the end of the week, I was ready to be put on display as a member of the Ken Reeves Orchestra.

As I removed the cloth cover from my bass violin at the Manchester Bath and Tennis Club, the rest of the band sauntered in and, boy, did I get a few dirty looks. Most were wondering where Frank Ryan was, the bass player who usually worked with, what I later discovered, the number one band of the Reeves office. One of the orders I was given demanded that I was never to introduce myself to any musician on stage nor shake hands with any of them. I was told that it was supposed to look like an organized

The sax player, Don Ellis, was the leader and once he was setup, walked over to me and whispered, "Kid, you better know what you're doing." There were two rows of musicians and I was placed in the second row standing between the piano and drums.

We started playing at 8:00 p.m., and the members slowly began drifting in to the strains of some of the old Tin Pan Alley tunes. We played non-stop until 10:10 and then took a 20-minute break. Upon returning at 10:30, we played non-stop until midnight.

During the break, we headed to a room behind the stage and no one spoke to me until the pianist, who happened to be the man I auditioned for when I tried out for the Reeves orchestras, called me over to where the other musicians were lounging. He then proceeded to tell me why he hired me, "Your folks, I, and many other musicians, all lived in the same neighborhood on the Allston-Brookline line back in the '30s, Brainard Road was called Musician's Row back then. I was quite friendly with your parents and bounced you on my knee when you were in diapers. That's why I gave you a shot. By the way, you're holding your own."

That made me feel a lot better in spite of my fingers getting sore as we approached midnight and played "Good Night Sweetheart." By now, all of the band members had smiled a hello to make me feel comfortable, except the man leading, Don Ellis. He and I were the last two to exit the club, and as I was packing my bass in my car, he walked over to me, and without cracking a smile, said, "Hey kid, you held up your end tonight. You can play with us anytime."

Well that was the beginning of a long run with the Ken Reeves Orchestra. I worked with many different band combos over the next few years under the banner of Ken Reeves. On a couple of jobs that I led for him, I posed as Ken Reeves Junior even though my features are anything but Boston Yankee. A few years later, Don Ellis left the Reeves office and put his own orchestra together. He asked a few of the Reeves musicians to join him including me, and for the next couple of years, we were the band that played all of the functions at Carroll's Restaurant in Medford. They had a function room on the lower floor and we were often there all weekend and several mid-week nights.

Dad had taught me bass with a classical book as the background, and when I was just out of college, I auditioned for the Boston Civic Symphony and made it. We rehearsed at Boston Latin School and played concerts at Jordan Hall or Symphony Hall a few times per year. I prided myself on being able to play both symphonic and pop music.

One summer season in the '60s, Arthur Fiedler needed a few more strings for the Boston Pops Esplanade Orchestra. I auditioned and made it. Babbononno was thrilled as his first-born grandson was now playing the music he loved so much, classical. He, Mom, and Dad came to the concerts I played at the Esplanade and it made me feel like a star. I never told Babbononno, I liked classical music, but I loved jazz.

One of Italy's most famous confections are "biscotti." Biscotti, plural for biscotto, means biscuit or cookie, and named "bis" and "cotto" or twice baked, after their original method of baking. The second bake draws moisture out of the dough and increases their shelf life. Food historians credit Tuscany, specifically Antonio Mattei for creating the first biscotti, Cantuccini (made with almonds). Perfect for traveler's years ago, biscotti were known to be a staple of sailors, soldiers, shepherds and fishermen. Legend claims they were even eaten by Christopher Columbus on his long voyages at sea. The biscotti you find in this country can be made from soft and crunchy, to dry and hard, and from plain to flavored. The varieties are endless, and I can't think of an Italian coffee bar that doesn't serve them. Italy's preferred method of eating the hard, dry biscotti has always been to "dunk" them in a glass of Vin Santo. Today, "dunking" them in coffee is also widely accepted. Those on the softer side tend to go well with an espresso

My Nonna has countless recipes for *biscotti*, and because most of my family preferred a soft crispy over a hard dry version, many she made reflected this preference. She used various dried fruits, nuts and sometimes even chocolate to make most. It was hard to choose a specific dough recipe or flavor to share because one is honestly more delicious than the next. I choose a firm crisp version that can be once or twice baked (depending on your preference, I do these once baked) and because it is summertime, I thought the combination of pineapple and coconut with a hint of rum, would be just perfect. "Pineapple Coconut Biscotti" have a firm outer layer, and a crumbly inner that is filled with delicious flavors. If twice baked, they are fabulous to dunk in a Vin Santo, and whether once or twice baked, they make a perfect accompaniment in the summertime to a Caffe Freddo or a Caffe Shakerato!

PINEAPPLE COCONUT BISCOTTI

Biscotti Ananas Cocco



- 3 eggs
- 1 cups sugar
- 4 teaspoons butter, melted and cooled
- 1 teaspoon pure vanilla extract 3 Tablespoons of rum or 1
- teaspoon of rum extract 2 cups all-purpose flour
- 1 teaspoon baking powder
- ½ teaspoon salt
- $1\ \mathrm{cup}\ \mathrm{sweetened}\ \mathrm{flaked}\ \mathrm{coconut}$ $^{3}\!\!/_{4}\ \mathrm{to}\ 1\ \mathrm{cup}\ \mathrm{dried}\ \mathrm{pineapple},$
- ¾ to 1 cup dried pineapple chopped
- **Egg wash** (optional) 1 egg beaten with 1 tablespoon water
- Icing (optional) 2 cups of confectioners' sugar and ½ cup pineapple juice
- 1 cup sweetened flaked coconut (to sprinkle over icing)
- ½ cup confectioners' sugar (optional)

Line two cookie sheets with parchment paper and set aside. In a large bowl, beat eggs and sugar until light and fluffy. Add cooled butter, mix well. Add rum and vanilla, beat well. In a medium bowl, sift flour, baking powder and salt together. Gradually add the flour to the wet mixture, mix well and then fold in the coconut and pineapples. Cover the dough and refrigerate overnight (this is necessary).

Remove the dough from the fridge and divide it into 4 pieces. Roll each section into a log about $1\frac{1}{2}$ inches in diameter, and the length of the cookie sheet. Place two logs, spread apart, on each of the prepared cookie sheets. Pat down so they are even in height, and If you are *not* icing them, brush egg wash over the top and bake at 350° for about 25-30 minutes, or until light golden brown. If icing the biscotti, just eliminate the egg wash and bake as directed. Remove from oven and let cool.

If twice baking, slice and place slices face down on cookie sheets and second bake at 350° to lightly toast for about 3-4 minutes on each side (this recipe wasn't intended for a long second bake).

If icing the biscotti, mix the confectionary sugar with pineapple juice, a tablespoon or two at a time, until you have an icing consistency. Dip the tops of the cooled biscotti in the icing and immediately sprinkle with coconut, let dry. If you choose to eliminate the icing and brushed with egg wash, you can slice them and leave plain or sift some confectionary sugar over the tops. If twice baked, they are best if left plain. Store in a cookie tin to retain crispness.

volunteer group. In 1925, the Village of Ogunquit took control of the beach through eminent domain and it was designated a public park. The following year, the Ogunquit Village Improvement Association set up the first publicly funded lifeguard service. A young Bette Davis was a member of that original group of lifesavers and wrote about her time with them in her autobiography.

For many years only five lifeguards patrolled the beach. They would use a lifeboat when attempting to save people, but the techniques were not what they are today. In 1946, a lifeguard drowned and with the boat in disrepair, funding was increased.

Another incident in 1981 led to a further increase in funding when a child was pulled out to sea and never recovered. Over the years funding has been increased, but at times it has also been reduced. When JP took over as Captain, he fought to increase funding and improve training and equipment. He did this to ensure the public would be safe by having the best lifeguards possible.

The current starting pay rate for lifeguards posted on the Town of Ogunquit website is \$18.00 per hour with a maximum of \$21.50. There are no benefits included. I also looked to see if any bonus was given to those who worked last year in the midst of the pandemic while the beach was still crowded and the risk of infection was high. There was none even though parking revenue to the town was at a healthy level.

What draws a person to seek employment as a member of Ogunquit Ocean Rescue? JP told me it is a combination of working at the beach along with the camaraderie, adventure, risk of the job, an interest in the medical fields, as well as the friendships that are built. The biggest satisfaction is found in knowing the role they all play in keeping people safe.

Pay is an important factor especially among the older and

more experienced lifeguards who may have families to support, but it is not pay alone that draws them. They take extreme pride in their profession. As with any professional, they expect a good measure of respect, something that is lacking in the town.

The veteran guards play a very important role in helping the younger and less experienced members of Ocean Rescue learn the profession. It is vital these veterans are there to pass on their wisdom. This is very serious work and there is no substitute for the skills that have been gained by having been on the job for a period of time. It looks like most of these top lifesavers are now gone.

The revenue brought in from fees charged for parking in the lots near the beach is a major source of income for the town. The fees have been raised and the hours when they are required have increased. People who pay these charges expect to have a level of protection while on the beach. That safety net is now in question.

Those active in town politics squabble over just about anything. The old saying that it takes a village doesn't appear to apply in this hamlet of just four square miles. Most of the time these arguments and the petty backbiting that goes along with them don't mean a lot. However, in the case of Ocean Rescue, people's lives are on the line. It is a time for leadership and full transparency in the Town of Ogunquit. I have to wonder how much time the members of the Select Board have spent on the beach observing Ocean Rescue in action. I can only hope it doesn't take a tragedy to bring people to their senses.

Ogunquit Ocean Rescue has been an elite force for years now. You would be hard pressed to find another lifeguard service that comes close to how the team under JP Argenti has performed. Ogunquit was lucky to have them; it's too bad they don't realize this.



Pitcher Dick Tidrow, 74, who played 13 seasons for the Indians, Yankees, Cubs, and White Sox and worked for many years after retirement with the Giants passed away unexpectedly.

The six foot four right-hander won 14 games in each of his first two seasons with the Indians who drafted him. He was traded to the Yankees in 1974 and was converted into a reliever and proved quite valuable as a member of the Yankees bullpen in their World Series years of 1977 and 1978, saving 10 games in the former year and winning 11 games in the latter. In 1979, he went back to starting.

The former pitcher also helped guide the Giants' three World Series championship seasons of 2010, '12 and '14. The 2010 championship was the first for the franchise since moving west in 1958.

IT'S TIME FOR HOOPS WITH FIVE RINGS—That would be the basketball tournament in the Summer Olympics. But why in the summer and not during the Winter Games? That question always comes up when the Summer Games are upon us.

The answer is that according to the guidelines put in place by the International Olympic Committee (IOC), a winter sport is one that is played upon or contested over a snow or ice surface. Thus basketball is not considered a winter sport for the purposes of the Olympic Games. So the game that started in Massachusetts is assigned to the summer.

AND HOCKEY IS ON THE HORIZON—As athletic activities begin to assume more normal parameters, it was nice to learn that the Bruins have announced a slate of six preseason games that will be played during the traditional late September-early October window.

The Bruins will open their preseason schedule on the road against the Washington Capitals on September 26.

Four nights later, on September 30, the Bruins will be at home in the TD Garden, hosting the Philadelphia Flyers, in the first of a trio of home exhibition games. Additional home contests on Causeway Street will see the B's playing the New York Rangers on October 2 and having a rematch with Washington on October 6.

The Black and Gold will also meet the Rangers in New York City on September 28 and the Flyers in Philadelphia on October 4.

And just before we went to press, there were published reports that the National Hockey League intends to create a pause in the upcoming regular season from February 5 through February 22, 2022 that would coincide with the upcoming Winter Olympics in Beijing, China that are scheduled to get under way on February 4. The men's hockey tournament is scheduled to begin on February 9.

Even if a pause is written into the regular season schedule, that does not necessarily guarantee that NHL players will participate. Commissioner Gary Bettman has raised some concerns, including monitoring the Covid-19 situation as it continues with varying intensities both in the U.S. and overseas.

AS JAROSLAV HALAK LEAVES THE B'S JUST WHERE DOES THAT LEAVE THEM?—As the last full week of July comes upon the stage, it leaves them without a name brand goaltender. And that may not be a good position to be in.

Halak, who did a quality job as the backup to first line netminder Tuukka Rask over the past three years, is a free agent as of July 28 and has indicated that he will not return to the Hub. He was out due to Covid-19 protocols for a month this spring, long enough for rookie Jeremy Swayman to step in and swipe his roster spot away from him with some outstanding performances.

There's no doubt that Swayman performed well in his rather brief audition with the Bruins this past spring.

He came to Causeway Street after playing three years for the University of Maine. During his junior year (his final season) with the Black Bears he posted a 2.07 goals against average and a .938 goals against average that resulted in 34 victories. Those results were good enough to win the Mike Richter Award, emblematic of the top Division 1 goaltender in the nation.

Because of the pandemic, the Hockey East Tournament, the NCAA Tournament and the AHL Calder Cup Playoffs were not held in 2020. Assigned that spring to Providence, his professional career did not begin until this past January with the P-B's.

While there he played in nine games during the shortened regular season, going 8-1-0 with a 1.89 goals against average and a .933 save percentage.

When things got tight in the Hub, he got the call and proved he could handle the crease at Causeway, at least over a 10-game span in the pandemic-shortened regular season. He made his NHL debut on April 6 with a victory over Philadelphia and posted his first NHL shutout 10 days later in a 3-0 win over the Islanders. He wound up with a 7-3 record accompanied by a sterling 1.50 goals against average and a .945 save percentage.

With Rask out until at least January (and possibly February) as he recuperates from hip surgery, Swayman definitely deserves another view from the coaching staff (see preseason schedule above) and probably a roster spot to start the season.

And who should be the backup? That is a really significant question that needs to addressed. Plus, will Rask even return after he recovers? Along with Halak, he is also an unrestricted free agent as of July 28. And as for goalies who have had 10-game hot streaks over the course of NHL history, well, that's a mighty long line.

But right now, unless there are transactions over the summer, the immediate future of Bruins goaltending may have been on view back on April 6 when Swayman posted that win against the Flyers.

The backup on the bench that night was Dan Vladar, another goalie from the Providence Bruins, although one with a more extensive record than Swayman. He's played portions of four seasons with the P-B's and probably first came to fans' attention in the Hub when he was elevated to be Halak's backup in the 2020 pandemic-delayed "summer playoffs" after Rask left the team, citing a family emergency.

This past season he played five games with Boston, four of them near the end of the regular season.

As for Rask, he says he wants to be back, stating in published reports that he does not want to play for any team other than the Bruins. He noted also that his three children are enrolled in local schools and have friends there.

But as of this writing he has yet to sign a contract, meaning that as of July 28 Swayman and Vladar comprise the top tandem available for net duty, at least on paper (and computer screens). But that leaves over two months before the bell rings for the start of the regular season, leaving room for changes brought on by a plethora of different reasons.
