Consul General of Italy, Boston Liborio Stellino and Educational Director of Consul General Office of Italy, Boston Carlo Cipollone have completed their professional duties in their respective roles in Boston.

Consul General Liborio Stellino arrived in Boston to begin his role in September, 2006. I had the pleasure of interviewing Liborio Stellino after ten days of being in office. He talked about his previous posts and outlined his goals for the Italian community of Boston. He discussed his ideas to increase trade and communication between Italy and America. # Mayor's Column

Boston is a city known for its history, but we are also a city focused on growth and on becoming a leader in technology and innovation in the 21<sup>st</sup> century. As technology evolves and people and business increasingly rely on connecting electronically, it is a priority to provide access to this important technology to as many residents as possible. Boston has an excellent digital infrastructure and Boston Broadband offers wireless access in many areas of the city, from the Rose Kennedy Greenway to Grove Hall, but there is still a lot of work to be done. Local families and students will now be able to use the updated technology to gain basic work skills online, apply for jobs, study for the MCAS and access multimedia. These critical skills will help them move forward and succeed in an increasingly digital world and give them an edge in a competitive job market. This is just the first example of what the rest of the sites and neighborhoods will soon benefit from.

With this funding, the Boston Broadband program will provide 627 new computers and job training software for the public at 48 computing centers located in public housing developments, community centers and libraries across the city, with installation to be completed by early 2011. When complete, nearly 18,000 people a week will be able to access broadband internet as well as updated, state-of-the-art equipment and software designed for various subject matters and to meet the needs of residents of all ages. This innovative, multi-agency effort across city agencies demonstrates a great use of federal stimulus money to benefit neighborhoods all across the city, from Hyde Park to East Boston.



#### AT HOME IN OLD ROME, THE PALACES OF THE EMPERORS

We can define a home as the "Via Sacre." The princia place where a family lives, dwells or maintains livings quarters. The Roman dwelling places fell into four groups or categories. There were the palaces of the emperors, villas or large pretentious suburban residences, insula or tenement houses and the domus or private houses.

Our column for today will confine itself to the palaces of the emperors which are still quite impressive even in their present ruinous condition. There is still sufficient evidence to show their immensity and imposing character. Excavation work for the purpose of examining the remains of these great structures was started in 1863 by Napoleon III, nephew of Emperor Napoleon I. Archaeological work was continued by the Italian Government and has revealed the remains of palatial structures that were built by Augustus in 3 A.D. and further enlarged by Tiberius, Caligula, Vespasian, Titus, Domitian and Septimius Severus. This group of palaces occupied the crown of the Palatine Hill, which overlooked all of the civic life below. The emperor's palace was

usually approached by an in-

pal entrance was through a portico (a porch with roof supported by columns), which led directly into a "Tablinium" or throne room. The throne room was flanked by a "Basilica" or Hall of Justice on one side and a "Lararium" or imperial chapel for household gods on the other side. According to tradition, this showed that the power of the emperor was firmly fixed between religion and justice, or we might say, between the church and the state.

Beyond the throne room there was usually a square garden surrounded by marble columns. This garden area along with its beautiful colonnade was called the "Peristylium" it is where much of the pageantry and court life occurred. Then there was the "Triclinium," a beautiful banqueting hall where world leaders and their guests feasted and were entertained. The daytime meals were light and usually taken in other areas, but the big spread, reserved for evenings, was called the "Cena." The length of the "Triclinium" was twice its width and gets its name from three reclining couches, which were a part of the normal furniture clined slope that led up from in any well furnished Ro-

man dining room. Each couch was designed to accommodate three guests who dined, by tradition, in a reclining position. At the end of the meal, the diners were always more "overstuffed" than the furniture and usually had to be carried home in a litter by their slaves. Some people were light eaters and their "Cena" was over by 9:30 P.M. Nero's "Cena" lasted until midnight and others lasted until the wee hours of the morning.

Most palaces also contained a "Nymphaeum" or room with a fountain, flowering plants, statues and small waterfalls. This "Nymphaeum" was usually placed near the "Triclinium" so that the coolness of the water and the scent of the flowers might refresh the guests who were overheated from too much food and wine.

Palaces also contained a "Bibliothecae" or library. Trajan's Palace had two libraries, one for Greek and the other for Roman manuscripts. Still another room was called the "Academia" and it was used for recitations or for other literary purposes. Finally, there were beautiful crystal stone mosaics on the floors and frescoes on the walls, while ceilings were arched or vaulted, and wall niches for marble

Additionally, there were the countless suites or apartments for those in residence, the service and servants quarters, and also those extra rooms for invited guests or possibly the general, everyday, run-of-the-

"The recent announcement comes only two short weeks after the race track at Plainridge laid off nearly 160 workers at its facility."




Many economists are predicting a "double dip" recession so it's time to pick a few stocks to buy at these prices. The company that makes devices, pharmaceuticals and other healthcare products is Tyco International. The shares sell @ a 40% discount to what analysts think they are worth. As for banks, you might think they would get killed again if the economy slows and as deficits rise. But the weaker the economy is, the longer interest rates remake money on the spread as (JPM) JP Morgan and Wells Fargo are my favorites. Wells Fargo (WFC) has pulled back 20% since April. Others stocks are Proctor & Gamble (PG) with an ROE of 20%. Companies that have an ROE of 15% or better are considered highly efficient. Others are Abbott Lab with a 27% (ROE) and Emerson Electric with a 20% (ROE). These stocks should do well in a slow market, which we expect.

For those that live in Massachusetts, tax free municipal bonds are attractive, which hold their value very well. By going out 15 years you can make 5% on state and agency bonds, which is

for the last three years and they are doing well. The danger is if interest rates go up prematurely, they could go down in value, but no one is looking for higher rates at the present time.  $8\frac{1}{2}\%$  is a great rate and the 5% is better than U.S. Treasuries. An  $8\frac{1}{2}\%$  is the tax equivalent of 5% tax free in the state.

The centerpiece of the new financial reforms is the Consumer Finance Protection Bureau (CFPB), which will write and enforce consumer protection rules for most loans including credit cards, student loans and mortgages. The agency will be housed in the Federal Reserve but the director will be appointed by the President. The bureau will consolidate consumer protection staffs from a half dozen regulators and should be up and running within a year. The bureau has no authority over car dealers, but will apply to all banks and lenders with less than \$10 billion in assets. The financial stability can override any agency rule if 2/3 of members feel it threatens the stability of the financial system. "Consumers won't have to wait for Congress to pass a law to be protected." The CFPB is the biggest thing in consumer protection since the FDIC," says Ed Miezwinski, director of the U.S. Public Interest Control Group.





It was on his return to Africa that Augustine lost his mother who fell sick passing away at Ostia, Italy in 387. Augustine arrived at Carthage in 388 and settled in Tagaste where he began to live in community with some of his friends. He was ordained a priest in 390 and moved to Hippo where he established another community. Five years later he was consecrated Bishop succeeding Valerius as Bishop of Hippo the following year.

Augustine became a staunch defender of the Faith, he preached and wrote against the Manicheans, Donatists, Pelagians and other heresies of his time. Shortly before his death the Vandals under Genseric invaded Africa and Augustine witnessed the desolation and destruction that followed in their tracks. It was early in the siege of Hippo by the Vandals that Augustine was stricken with a fatal illness passing away at the age of 76 on August 28, 430.





Nothing to brag about! Despite the recent decline in crime, the U.S. is still the most violent of affluent democracies. The annual U.S. murder rate of five per 100,000 people is down from 9.8 in 1991, but still twice that of, say, France. Historian Randolph Roth recently surveyed U.S. homicides over the centuries and concluded that violence rises whenever citizens develop a strong distrust of the government and feel powerless over their own lives. Murders soared just before the Civil War, when anti-Washington fever reached its peak. Crime has never settled back to European levels. The homicide rate among white Americans, Roth notes, soared again in the late 1970s, when "malaise" was widespread. "Our high homicide rate started when we lost faith in ourselves," he says, "and each other." With polls showing a growing distrust in government, that's a worrisome thought. What married couples are really arguing about are about all kinds of things, from money to whose turn it is to take out the garbage. But in reality, says Scientific American, all fights come down to two basic issues that have little to do with the contents of the arguments: One person feels that he or she is being unfairly controlled or feels neglected. Researchers concluded that the tension that sparked the arguments almost always involved deeper issues relating to whether the partners felt understood or valued. Appreciating this dynamic might help couples figure out how to improve communication. "Unless you're fighting with someone overseas," apologizing via e-mail is "never wise." Not only is it "impersonal and cold" — you also won't even be able to tell if your apology was accepted.

It has been reported fish oil may fight breast cancer. Women who already take hearthealthy fish oil may also be lowering their risk of breast cancer. Researchers at Seattle Fred Hutchinson Cancer Center surveyed 35,000 cancer-free postmenopaulsal women and found that those who took omega-3 fish oil supplements had a 32 percent lower incidence of breast cancer.

Huh? Drinking alcohol appears to be linked to a reduced risk of developing severe types of arthritis, including rheumatoid arthritis, osteoarthritis and spinal arthritis. A study at Holland's Leiden University, involving 7,000 people, found that alcohol consumption reduced people's risk of developing these conditions by 62 to 73 percent. "These are very interesting findings," says Dr. Paul Emery, president of the European League Against Rheumatism, but he also notes that alcohol should be consumed in moderation. Doctors, however, are not suggesting that people take up drinking. # Recipes from the Homeland

Baked or Fried

1 medium size eggplant

2 cups prepared breadcrumbs

2 beaten eggs

34 cup olive, vegetable or canola oil

Remove dark eggplant skin with paring knife or potato peeler. Slice eggplant into one-quarter inch rounds. Layer slices on a flat dish and salt lightly. Beads of liquid will appear on the slices as they rest one on top of the other. Cover eggplant with wax or plastic paper and place in the refrigerator for at least a half-hour.

FOR FRYING: With paper towels, wipe beads of liquid from each eggplant slice before dipping into beaten eggs. Then coat with prepared breadcrumbs and set aside in a platter.

Heat one-quarter cup of oil in a skillet. Place breaded slices in heated oil and fry until brown on both sides. Place fried eggplant slices on paper towels to absorb oil. Then set aside on a clean platter. Because eggplant slices absorb oil while frying, additional oil may be needed in the skillet as vou fry.

FOR BAKING: Place breaded eggplant slices on a lightly sprayed baking tray. Drip small amount of oil on top of each eggplant slice in the tray. Bake in a preheated 350F oven for fifteen minutes. Turn over all slices that have browned. Return to oven and bake another ten to fifteen minutes. Check often in order not to burn. Remove from oven when browned and tender to your liking. Continue baking remaining breaded eggplant slices in this fashion.

Serve hot or cooled. Remaining cooked eggplant slices can be refrigerated. Reheat in microwave for a later serving.

NOTE: Some North End neighbors planted eggplant seeds in large containers on their fire escapes or on the roof. Some grew them in their rented garden lots in Revere or Woburn. Others waited to purchase eggplants in produce stores on Salem, Cross and Blackstone Streets. Today they are available throughout the year.


When baked, they are a tasty and nutritious snack that can also be served as a hors d'oeuvre.

It was at this point in time in 1960. I had graduated college that June and Babbononno, who didn't understand higher education and what it could do for someone's future, was proud of the accomplishments of his first born grandson.

His nostalgic comments included, "I justa wisha Nanna coulda live to see you fineesha schoola. She be so prouda whata you do." I smiled and acknowledged that Nanna would have been proud. She passed away in 1958 due to terminal breast cancer.

Gus Sullivan, the coach at Boston State College, had gotten me a tryout with a Cincinnati Reds farm team and I was ready to head to the Midwest. Dad asked me what I was going to do for a job if I didn't survive double A baseball. I didn't have the answer until a friend from college, Paul Ciccarelli, called and told me that Tewksbury High School was looking for two shop teachers. We both applied for the jobs and after the interviews, were offered contracts, Paul to teach woodworking and I to teach drafting and design. I never mentioned anything about baseball to the people in Tewksbury but signed the contract anyway.

Baseball in the Midwest was fun and I did rather well as a middle infielder. I did have three problems in front of me, Pete Rose, Dave Concepcion and Joe Gordon. I was good, but they were great and I didn't stand a chance. That September, I reported to Tewksbury High School for my first real job as an adult.

I, like my father before me, who played with the Reds as a utility catcher for one season, decided that I would make more money playing bass than baseball, and began to teach that fall and play music on the side.

The problem with my job in Tewksbury was that I lived in East Boston. Paul Ciccarelli called me to say that there were two teachers from Winthrop who were on the the hotel with Mr. Masseri faculty at Tewksbury High School and we could car pool with them. Joe Crotty and Jim Dimento outlined their routine and Paul and I joined in right after Labor Day. As I said, my problem was the distance. With having to get up at 5:30 AM, I couldn't play music during the week and get enough sleep to

would have to be a weekend activity.

I did receive a call from a bartender friend of mine asking if I and my group would like to audition for a weekend job at the Charterhouse Hotel, where he worked. For those of you not old enough to remember the place, it was just over the line from Point of Pines as you enter Lynn. There was China Sails on the right, followed by the Charterhouse, just about where Building 19 is today. When I called the manager, I was told that they only wanted a piano and a bass in the lounge. I called Tony Poto, a fellow East Bostonian who had been with me playing college functions for four years and we headed to Lynn to audition.

The manager was a man named Marvin Newmark, and for whatever reason, took an immediate dislike to Tony and me. We played some of the tunes in our repertoire but the man wasn't impressed and made negative comments after each selection. There was another couple who joined him to listen after the first song was played. They were fortyish and looked Italian. The woman asked if we knew a tune named Joey-Joey. Tony asked if they would like him to sing the lyrics and they smiled and nodded with approval. We played the song and Tony sang the words with Mr. Newmark making a negative comment once we finished. The couple that requested the song applauded with the man giving Newmark a dirty look. The woman whispered in her companion's ear and he nodded back in the affirmative. He then turned to us and said, "My name is Dante Masseri and I am the CEO of this hotel. You are hired." With that, Newmark walked out of the audition.

The Masseris commented that they had a young son named, Joey, and that littleknown song that we played was his favorite. A bit later, I signed a contract to play at Tewksbury. Paul and I had bus duty in both the morning and afternoon and seven classes in a row with only twenty minutes for lunch. We were the new kids on the block and stuck with the worst schedules imaginable. Needless to say, I wasn't able to play during the week seeing that most musical engagements ended at 12:00 midnight or later and I had to be up at 5:30 in the morning. The job at the Charterhouse Hotel was from 8 to 12 on Friday and Saturday nights and didn't interfere with teaching.

One problem did occur, though. Around Christmas time that year, Mr. Masseri asked if I could add a female singer to the group and I called someone I had worked with in another group. Her name was Arlene Bailey and she fit in beautifully. Her voice and our style of playing blended perfectly. The only problem was that this was in the early 1960s, and racially mixed groups were something that was considered a "no-no." Mr. Newmark was ready to fire us that first night that Arlene sang with us, but knew that we answered directly to Dante Masseri. Once that first evening's performance ended, Masseri called me to the office to discuss the situation. My answer to him reflected my views, "Mr. Masseri, Arlene is the best local singer I know of. I think with her added to my duo, your cocktail lounge audience will look past the color line and accept us as three qualified performers, not an interracial group trying to make a statement.' Fortunately, he responded with a positive attitude and I now had a trio.

Within a month, we had a packed house every Friday and Saturday and the subject of color never came up again.

Both jobs lasted about a year. The Masseris sold out of the hotel business and the new owners decided to eliminate the lounge. The group broke following the engage-

Growing up in Roxbury during the sixties, we all owned record players and we all bought those 45 records and would listen for hours to our favorite singers and musical groups. I actually saved many of those old 45 platters but not the record machine which makes them nice to look at but not much else. You think I would have saved my record player too.

Hey, enough of me. Let's get back to Skippy White, the legendary music giant in the 'Bury. Today, his shop is up in Egleston Square near the Jamaica Plain-Roxbury line but for me when I think of Skippy White's I think Lower Roxbury where I came from.

All the hits that various groups brought to the top of the charts would not have happened but for the likes of Skippy White. Listening to them on the radio was a random stroke of luck. You need a record player and those 45 platters to really get into the music.

I plan to attend the  $50^{\mbox{\tiny th}}$  Anniversary of Skippy White's impact on music in Boston and you should too if you're a Roxbury baby boomer who kept Skippy in business decades ago when he first opened shop.

The event is planned for September 4 at Russell Auditorium on Talbot Avenue at 7:30pm with show time to start at 8:30pm. For further details call Finesse at 617-839-3824.

Back in the day when it came to my music there was Arnie Woo-Woo Ginsberg and the Night Train Show on WMEX and Skippy White's on Washington Street. Then, there was the music itself. The Temptations, The Four Tops, The Supremes, Robert Knight and we can't forget white soul too like Fee-fee-fi-fi-fo-fo-fum Mitch Ryder or Ron Barry doing 1-2-3.



#### A few months ago Romano Prodi, former Italian Premier, former President of the European Commission (the ruling Body), and presently a professor at Brown University, RI, delivered a lecture at the prestigious Princeton University, at the Harold Elm Auditorium, packed solidly with professors, but mainly students. The theme was: "The Role of Europe in a Multilateral World."

Prodi described proudly the basic steps that led to the establishment of the European Union and to its subsequent expansion over the last year. Prodi illustrated the European Union's progress as an innovative "political laboratory" after observing the transformation of the European countries as a huge change within all member countries. Professor Prodi then added that the Union's expansion toward East Europe, the object of an earlier criticism, was later endorsed as a necessary move for the stability of all of Europe. The Nations that have joined the Union recently, although less competitive, both economically and institutionally, have recorded a growth after their move, due mainly to cultural and social challenges. Prodi then observed that the decision-making process within the Union requires that any decision be unanimous. Because of that, if a Nation abstains from voting or votes "no," everything stops. Prodi added that this kind of decision-making is "undemocratic!" The "unanimous" clause doesn't allow to go any further, thus everything comes to a stop.

At the end Prodi answered many intriguing questions from the large audience, particularly one that concerned the Union's evolution toward the creation of a great European Nation, even though economic, social, cultural and political differences vary from one Nation to another. In closing, the challenge that brought together the large European Nations to form the Union was the need to exchange their resources and be competitive. Unlike the U.S., Russia and China!

#### **Bobby Thompson** Giants Hero in 1951 Dead

Bobby Thompson whose 'Shot Heard 'Round the World" in 1951 is still remembered after all these years as perhaps the most famous homerun in postseason history passed away recently at age 86. When he connected off the Dodgers Ralph Branca for a three-run homer in the bottom of the 9<sup>th</sup> in Game 3 of a National League playoff, he lifted the NY Giants over the Brooklyn Dodgers into the 1951 World Series. At one point the Giants were 131/2 games behind their rivals the Dodgers. The Giants had other plans and won 37 of their last 44 games and forced a playoff to win the NL pennant.

Thompson retired in 1960. He was a three-time All-Star. He hit .270 lifetime with 1,264 home runs and 1,026 RBIs and played from 1946-60. He played along side Willie Mays and called himself the "accidental hero."

I would put his homerun up there along side Bill Mazeroski's homerun that won the World Series for the Pirates over the Yankees in 1959 and the Carlton Fisk homerun in Game 6 of the 1975 World Series against the Mets that took the Red Sox to Game 7 where there were no great homeruns for the Sox.




