

New York to Ban the Word "Inmate"



CALIGULA THE BUTCHER



Wild beasts were used during many of the gladiatorial shows and had to be fed cattle meat to keep them alive while in captivity. There was a time when cattle meat became expensive, so Caligula's crafty mind devised a system whereby he would go to the prison camps and make random selections of prisoners to be devoured. Many men of honorable rank who uttered the slightest criticism of his actions were seized and disfigured with branding irons. Some were forced to work in the mines or on public roads, and others were fed to the wild beasts. Incredible as it may sound, we are told that many of these unfortunate individuals were shut up in small animal cages and forced to move around on all fours before being fed to the beasts.

People did not have to commit a crime in order to be punished. Some of this punishment was handed out to persons who would not swear by the genius of Caligula. He forced some parents to attend the execution of their sons and he actually invited one pair of parents to dine with him immediately after an execution, just as a friendly gesture.

Those readers who are squeamish should not read this next paragraph. But if you insist, he had the manager of his gladiatorial shows beaten with chains in his presence for several days in succession, and didn't have him killed until all were disgusted from the stench of the man's putrefied brain.

A husky and handsome young man named Colosseros was a spectator in the amphitheater. Without provocation, Caligula ordered the man to be dragged from his seat and led into the arena where he was forced to fight one gladiator and then a second. He was victorious in both of these contests, so he was then dressed in rags, bound, and led through the streets for all of the women to view. Later, this handsome but unfortunate Colosseros was put to death because he was more desirable to women than the emperor.

At different times Caligula is reported to have caused the death, not only of his grandfather, but most of his other relatives as well. Such indignities and annoyances were heaped upon his grandmother that it is reported to have caused her death. There are others who claim that she was poisoned. He paid her no honor at death, but instead watched her burning pyre from his dining room. He had his brother put to death without warning or provocation, and harassed his father-in-law to the point where the elder Silanus slit his own throat. All of the relatives who helped this man to the throne were rewarded for their kinship and faithful service by a bloody death. With friends like this, who needs enemies?

Caligula seemed to be obsessed with the power of his office which permitted him to inflict bodily harm, torture, and even death upon others. Decapitation was his special pleasure. At one time he is reported to have said "I wish that all of Rome had but one head, then I could lop it off with one blow." He was unmerciful in his killings. Whenever possible, it was by numerous slight wounds first. His standing order was "Strike so that he may feel that he is dying."

Committee in Support of EAST BOSTON HAUL ROAD

The Committee in support of an East Boston Haul Road has been launched. Its purpose will be to create a Haul Road and Waterfront Pedestrian and Bike Pathway from the abandoned MassDOT property along Chelsea Creek. The result will remove significant truck traffic from McClellan Highway and neighborhood streets and create a publicly accessible Chelsea Creek waterfront to benefit East Boston residents for the first time

The unused land along East Boston's waterfront near Route 1A has been ignored for more than forty years with only the slow collection of trash occurring on what is valuable waterfront land in our community. A better use of the property is for a Haul Road and Waterfront Access that will directly benefit East Boston.

Since several islands were connected to create what we now know as East Boston, the rail line defined the boundary with Chelsea Creek. Yet, with the abandonment of the rail line in the 1970's, nothing has happened to re-use this property. The Commonwealth, Mass DOT, Massport and the City of Boston have never done anything to put this property to use.

Residents of East Boston are, once again, wondering why other communities, e.g., South Boston and Chelsea, have haul roads that lessen the negative impacts from truck traffic. The Marty Coughlin Bypass built by Massport on a portion of this very same abandoned railway in 2012, reduced truck traffic on neighborhood streets going to and from the airport and Chelsea; yet, no steps have been taken to extend this bypass to alleviate the many more trucks going to and from the airport and all parts North of the city, i.e. the rest of New England. The process utilized by MassDOT itself determining the property was of no use back in 2017! The committee will be advocating for action from our elected representatives and city and state agencies to put this property to use now. The committee will directly advocate for an extension of the Coughlin Bypass from its current endpoint to the Revere city line, and the parallel creation of a waterfront pedestrian walkway and bike path. The Haul Road will provide an ideal alternate route for trucks, as evidenced by the success of the Marty Coughlin Bypass.

Committee members recognize the environmental negatives of idling trucks within the residential areas of East Boston. Fewer emissions near homes, schools and parks will create a healthier environment for all.

When you are sitting in severe traffic in the next thirty days, due to MBTA shutdowns and weekends due to tunnel shutdowns look to your left and to your right. Imagine how traffic could be improved by providing a Haul Road for commercial/truck traffic. We have the solution for **OUR** community, a community that has solved our problems successfully in the past.

Resident's impassioned civic engagement will send a clear message that they want to steer the conversation and planning on how bet to alleviate the daily stressed that McClellan Highway traffic causes the community. At 8:46 a.m., On Tuesday, September 11th, 2001, five hijackers took control of American Airlines Flight 11 and flew it into the heart of New York City and

the northern facade of the World Trade Center's North Tower (1 WTC).

At 9:03 a.m., five other hijackers flew United Airlines Flight 175 into the southern facade of the South Tower (2 WTC).

At 9:37 a.m., another five hijackers flew American Airlines flight 77 into the western facade of the Pentagon in Arlington County,

At 10:03 a.m., four hijackers crashed United Airlines Flight 93 into a field in Stonycreek Township near Shanksville, Pennsylvania.

Members of the WAA family, including staff, volunteers, Gold Star and Blue Star Families. and veterans, will join to share in the patriotic act of waving the flag, and sharing the stories of those who raised their hand to serve following the events of that fateful day. The flag waving will start at 8:46 a.m. ET, when on Tuesday, September 11, 2001, five hijackers took control of American Airlines Flight 11 and flew it into the heart of New York City and the northern facade of the World Trade Center's North Tower (1 WTC) and end at 10:03 a.m. ET when four hijackers crashed United Airlines Flight 93 into a field in Stonycreek Township near Shanksville, Penn., on the same day.

You too can join by tuning in to the organization's Official Facebook page, to share pictures and videos from your own community flag waving. Participants are encouraged to take video and pictures of their participation in the national flag waving and share them with WAA, their family, and their friends to help REMEMBER, HONOR and TEACH the generation born after 9/11, how hard times can strengthen us as a nation. WAA waves the American Flag every Tuesday morning between 9:00 - 10:00 a.m. ET and encourages the public to join them. Each week,



messages of unity and remembrance are shared and the legacy of the "Freeport Flag Ladies" who took to the Hill in Freeport on 9/11/01 following the events of that morning to hoist the flag and share a message of strength — lives on as it did each week for 18 years. After they retired on September 11, 2019, WAA took over the tradition and continues the weekly flag waving along U.S.

Route 1 in Jonesboro, Maine.

"Each Tuesday, we are joined by dozens of members of the local community and curious people stopping to be part of something meaningful," said Karen Worcester, Executive Director, Wreaths Across America. "I hope people will join us this year, both on the anniversary of 9/11, as well as each Tuesday moving forward. This flag waving has taken on new meaning for us all and given a spark of hope for unity and patriotism during this difficult time in our country."

Following the events of 9/11, three patriotic women (Elaine Greene, Joann Miller and Carmen Foote) were moved to find an old American flag they had stored at home and stand on a hill in Freeport, Maine, waving that flag to honor victims. These women became nationally known as "The Freeport Flag Ladies," and proudly hoisted the Stars and Stripes every Tuesday morning for the following 18 years. After they retired on September 11, 2019, (their last 9/11 remem**brance)** the following Tuesday, September 17, 2019, Wreaths Across America took the helm and continued the weekly flag-waving tradition along U.S. Route 1 in Jonesboro, Maine.

L'Anno Bello: A Year in Italian Folklore

Say Hello to September!

Lately, I have been paying special attention to the trees in my backyard. If I look at the leaves closely enough, I can detect the slightly perceptible hues of fall — crisp reds and golden yellows tickling the borders of still-green fronds. Small breezes lift a few orange leaves and blow them gently to the ground as they swirl around like tops. These sights, both the delicate colors and the falling of the leaves, are reminders that autumn is here, the season of cooler weather and harvest and the rhythms of nature. The month of September starts this wonderful season, bringing with it the smell of juicy apples and the purring motors of big yellow school buses. The beginning of September is always a very busy time for me, as it coincides with the commencement of the school year and all of the preparations that that entails. Nevertheless, when I stop to pause and really think about September, I feel a rise of excitement bubbling inside me. This is a month full of rustic holidays and old-country proverbs that highlight September's prominence as a seasonal turning point.

The first September holiday to occur in America is Labor Day, falling on September 5th this year. A festival honoring the contributions of working people, Labor Day also signifies the unofficial end of summer, as many schools return to their sessions after this long weekend. As such, Labor Day is often celebrated with a picnic or barbecue, and this year I will add to the food tradition by baking a sparkling apple cider pound cake or an applecream cheese crisp to honor the seasonal flavors of this month. Over in Italy, September heralds a flurry of feasts and activities that will last until the holiday season in the winter. It begins in a regal fashion, with Venice's Regatta Storica occurring on the first Sunday of the month. In this renowned boat race, a parade of elegant gondolas introduces an intense competition where skilled rowers in various different categories vie for first place. This event has a royal pedigree, as it is modeled after the welcome procession given to the queen of Cyprus, Caterina Cornaro, when she returned to Venice in 1489.



in Naples celebrate the feast day of Saint Gennaro on September 19th, when spectators wait to see the mysterious liquefaction of the saint's blood, and then hold an eight-day party as stalls selling trinkets and candy line the streets. This holiday has become so popular that many Italian-American communities hold their own Festa di San Gennaro. Autumn intensifies around the fall equinox, arriving on the 22nd of the month, after which the balance between daylight and night tips towards the edge of darkness. Finally, the Feast of St. Michael the Archangel, or San Michele l'Arcangelo, closes out the month on September 29th. Also known as Michaelmas, this ancient feast features the autumnal themes of balance the scales of St. Michael echo the equal hours of day and night during the equinox — and harvest, as ingredients like carrots and ginger are traditional on this day.

For our Italian ancestors of yore, September meant collecting the harvest, enjoying the bounty of the Earth, and preparing food for the winter. In this deeply agricultural society, proverbs reminded farmers to pay attention to the weather and their crops in order to ensure a successful harvest. Rain in September proved a mixed blessing. One proverb bluntly states that "La pioggia di settembre è veleno per l'uva," meaning that September rain is like poison for grapes. However, another proverb happily declares "A settembre pioggia e luna, è dei funghi la fortuna," advising farmers that rain and moonlight made favorable conditions for collecting mushrooms, such as the delectable Italian truffles. Other dictums Later in the month, the people reflect the changing weather of

the month, as summer turns to autumn. A delightful little ditty proclaims: "Aria settembrina fresco la sera e fresco la mattina." According to this proverb, September air is cool during both the evenings and the mornings. This axiom reminds me of the autumnal mist I often see rising above fields like lace on crisp mornings, or dark evenings huddled under a blanket and drinking a cup of apple cider. Italian truisms even mention the autumn equinox. "Di Settembre la notte col dì contende" roughly translates that night competes with day during September, a reminder of the long winter evenings to come.

From holidays to proverbs, September is a month brimming with great significance as a seasonal milestone. Whether you enjoy the changing foliage or admire the taste of a fresh apple, be sure to pause and be grateful for all that the autumn has to offer. For it is autumn that teaches us humility before the gifts of the Earth and an appreciation for the cycle of the year. Therefore, no matter how you desire to honor September, let us toast to a month full of bountiful blessings and new beginnings!

The official name was the Eustis Street Playground, now it is Clifford Park but always called "The Prairie" for its huge size.

Now the city says it is looking to reclaim "The Prairie" as it becomes a garbage can for public sex, needles and God knows what else. I agree with Domingos DeRosa, a community activist who says that the community is dving. I don't know about the community, but this park I used as a kid is definitely dying from benign neglect by Boston; the same kind of benign neglect that allows the homeless encampment down on nearby Southampton Street to fester and grow. It is easy to talk. The city's answer to the overcrowding on the streets near the highway ramps is to seemingly use more fencing as a solution. Not the answer.

The City appears useless in

dealing with the metastasizing of negative activity. You can't keep pushing the problem from here to there. Drive near the encampment that starts on the I-93 onramp and slides down to both Southampton Street and Mass Ave. I am not surprised that the issues at one end of the "mile" has travelled down to Shirley Street and "The Prairie". It was only a matter of time.

It is time to stop worrying about how it got there and time to find the solution to get it gone from there. I still don't think the City of Boston, especially our politicians; have a clue as to what to do next.

If the city wishes to "fix' this issue, it needs to stop doing the same things that doesn't work over and over again. There is a difference between actually helping those meandering souls and simply enabling them to continue their roam through life.

Doing nothing hasn't worked but until the powers that be do something, nothing is all we get. Never enough. Not by a mile. Just look around at the homeless encampments. Does anyone really know what they are doing at City Hall? Are we just getting blue smoke and mirrors? Will it ever change? Can they even clean up the Prairie?

Saint Simeon Stylites the Younger

Stylites were solitaries and ascetics who made their home upon the tops of a pillar.

Simeon was born at Antioch in 521. His father, John, was a native of Edessa, his mother, named Martha was later revered as a saint. When Simeon was six, his father was killed in an earthquake, after which he and his mother moved to the outskirts of the city.

Simeon was drawn at a young age to a life of austerity. He attached himself to a community of ascetics living within their enclosure and to a pillar-hermit, named John, who acted as their spiritual director. Simeon while still only a boy had a pillar erected for himself close to that of John.

In the course of this period, however, Simeon several times moved to a new pillar, and on the occasion of the first of these exchanges, the Patriarch of Antioch and the Bishop of Séleucie ordained him deacon during the short space of time he spent upon the ground. For his efforts, Simeon received from God the gift of healing. For eight years until John died, Simeon remained near his master's column, so near that they could easily converse. During this period, his austerities were kept in some sort of check by the older hermit.

After John's death, Simeon gave full rein to his ascetical practices. From the rising of the sun until mid-afternoon, he read books and copied Holy Scripture. Simeon was ordained priest and was thus able to offer



the Holy Sacrifice in memory of his mother. On such occasions, his disciples one after another climbed up the ladder to receive Communion at his hands. As in the case of most of the other pillar saints, a large number of miracles were believed to have been worked by him. In several instances, the cure was affected by pictures representing. Simeon Simeon maintained this kind of life for 68 years.

Towards the end of his life, the saint occupied a column upon a mountainside near Antioch called the "Hill of Wonders" (due to his miracles), also known as the "Wondrous Mountain" or the "Admirable Mountain." It was here that he passed away in 596. The Feast Day of Saint Simeon is May 24.





The Criminal Life of Archibaldo de la Cruz is executed in traditional Bunuel fashion, where macabre meets comedy. The story begins when an overindulged young boy of "privilege" is shown a music box, which is a family heirloom, alleged to cause the death of an enemy when played. A Nostalgic Remembrance



Labor Day will be with us in a couple of days, but other than it being the practical end of summer, it has another significance for me. I met someone during the Labor Day week-end 49 years ago and we've been hangin' around together ever since.

Babbononno always used to say, "You can't pick your relatives; you're stuck with them.

But, you can pick your friends, so do so wisely." Over the years, I discovered his visions were right on target. My story begins around July 4th, 1973. I had been in Hollywood doing some extra work at Paramount Studios and with the summer coming in, most of the production companies housed on the Paramount lot were shutting down for July and August. As a result, I decided to head home. The folks greeted me with open arms, and after settling in, I headed to East Boston to visit Babbononno. He was now in a nursing home and ready to turn 98. When I arrived at the Columbus Nursing Home on Saratoga Street, Uncle Nick was there visiting his father. The three of us chatted, and when it was time to leave, Uncle Nick said, "Oh, by the way, there's a Motown group passing through Boston minus a bass player ... you interested?" I said yes and

let it go at that. A day of so later, I received a call from one of the leaders of the Uniques, a Motown group that was heading north for the summer. Eddie Jackson called at the suggestion of Uncle Nick. He said that the band was heading to Maine and needed a bass player. Knowing from what Uncle Nick had said, I told Eddie that I wasn't African-American. His comment was, "What color's your talent?" I replied, "What do you mean, it's colorless." He then asked, "What color's your bass guitar?" I replied, "Black." Eddie's comment was, "Close enough." So, I joined the Uniques for the summer. I did let the guys know that I would be leaving around Labor Day as I had decided to return teaching in the Boston Schools and playing music locally. They had no problem with my decision, and so, I headed to the Portsmouth Circle, met the band at the then Howard Johnson's Motor Lodge and followed the caravan northward to Caribou, Maine.

When we arrived at the location, we brought our equipment

into a supper club that was part of a motel complex. The room was large, decorated like a Vegas nightclub and the people already in attendance having dinner were well dressed, multi-racial and many of them were in air force uniforms. It did not compute. As far as I knew, that-part of Maine had only white people or native Americans (Indians), and most were involved in Maine's potato and fishing industries. What I discovered later that evening was that there was a SAC base in Caribou, the Loring Air Force Base, the east coast's most strategic missle site. The patrons I saw were employees and servicemen and women from the base. There was nothing else in the way of entertainment for them except the performers at Things went well. I fitted

in and learned their tunes and routines rather quickly. The man I mentioned, Eddie Jackson, became my roommate and we hit it off. The money was good, but as August pushed forward, I told everyone that I would be leaving around Labor Day. Around the beginning of the last week of August, Jerry Cobb, the other leader of the band told me that a New York based bass player was available and I could leave after the last show on that Friday evening. I was delighted. I had been invited to join a bunch of guys who were going to spend the holiday weekend on the Cape. I called one of the guys and told him I would be able to make it and asked for the directions. I left Maine, stopped at the house in Belmont, packed some Cape Cod clothing and headed for Hyannis. I arrived in the middle of the night exhausted. Paul Blair, the friend who had invited me, showed me my bedroom and told me that there were some other folks coming later in the night. It seems that they all worked at a Boston nightclub and were leaving after work. When they arrived, I was awakened and looked out the window. What I saw made me curious. A gray Jaguar XKE two seater pulled up with about six people wedged into it. The driver got out and looked like a little kid with a mustache. My comment to myself was, "Oh, what the Hell," and I went back to sleep.

Late the next morning, someone yelled out brunch is ready.

Everyone staying at the cottage headed for the kitchen, and I was introduced to all of them. The one who looked like a little kid with a mustache was named Dean Saluti. We sort of hit it off. He was a doctoral candidate at Boston University, working his way through the program as a bartender at Lucifer's, one of three nightclubs located in a complex called The Kenmore Club situated in the middle of Kenmore Square.

As the weekend progressed, Dean and I had many conversations about our back-grounds, growing up in Italian families, both having multiple college degrees, and our likes and dislikes in women, music and food. It seemed that we were always on the same page. When the weekend came to an end, we swapped phone numbers and I headed back to Boston and returned to teaching drafting and engineering subjects at Hyde Park High School by day and playing music at night. 
GOD BLESS AMERICA



In Italy, it is typical to have debates over where certain dishes originated. However, when it comes to Caponata, there are none! This delicious so-called "eggplant relish" is rooted in Sicily. In fact, many refer to this delicacy as Sicily's version of ratatouille. Though they may be similar, Caponata is far tastier. Caponata was originally served in Sicily as an accompaniment to fish and today it can be found alongside octopus, poultry and even as a delicious topping on a Bruschetta.

Every family has their own special way of making Caponata and some families even have more than one recipe they use. My Nonna usually made hers without a recipe and varied the ingredients based on the tastes of those she was serving it to. So when she made it for anyone that didn't like raisins and pine nuts, she'd just eliminate them. The recipe I am sharing is easy to make and always turns out perfect. It is especially delicious when used as a topping on a bruschetta. Enjoy!

CAPONATA Sicilian Eggplant Relish



1 large or 2 medium long eggplant

(the fatter, the more seeds)
½ to ¾ cups olive oil
1½ cups celery, chopped
2¼ cups onion, chopped
6 ounce can tomato paste
¾ can of water

1/4 cup red wine vinegar

2 tablespoons sugar 2 tablespoons capers, rinsed 12 Sicilian olives, sliced salt and freshly coarse ground black pepper to taste

*Optional:
3 tablespoons raisins and
a handful of pine nuts

Wash, dry and cut eggplant into 1-inch cubes. In a sauté pan add about ½ cup of the olive and the eggplant. Cook over medium heat until softened. Remove the eggplant, set aside and add the onions and celery to this pan. Sauté over medium heat, adding more of the oil if needed, until the onions are translucent and the celery softens. When cooked, add the eggplant back into this pan along with the tomato paste and ¾ can of water, reduce heat to a medium low and cook for about 15 minutes. Reduce the heat to low and add the vinegar, sugar, capers, olives, (raisins and pine nuts, if preferred) mix and cook covered for about 20 minutes. Cool well and enjoy served over octopus, fish, poultry or as a delicious topping on a Bruschetta!

Note: In Sicily many even add a teaspoon or two of pure cocoa powder to this mixture!

Unanswered Questions Surround Death Of Woman At Ogunquit Beach

On August 15th a woman was pulled from the water at Ogunquit Beach and after resuscitation efforts were performed she was pronounced dead. The woman has been identified as 62 year old Margaret Kelley from Harwinton, Connecticut.

The events that led to her death remain unclear. The situation happened at high tide in the water near the ramp leading down to the main beach. There is a lifeguard stand at that location. The cause of death hasn't been disclosed awaiting a report from the Medical Examiner's Office. Her body is still in Maine. The Ogunquit Fire Department issued a press release about the incident that stated:

"At approximately 3:00 P.M. on August 15, 2022, a patron visiting our beach had what is described as a medical event while in the water. The 62-yearold Connecticut woman was quickly removed from the water by lifeguards and by-standers. Resuscitation efforts were initiated by our lifeguard and EMS staff. Ogunquit Fire and Ogunquit Police Departments responded immediately to assist. Unfortunately, despite the efforts of the emergency responders the patron did not survive. The event remains under investigation by the Ogunquit Police Department and no further information is available at this time."

I spoke with Chief Osgood of the Ogunquit Fire Department to try to get clarification of what happened that day. Chief Osgood is also head of the Ocean Rescue Team. He told me he arrived about 30 minutes after the initial call. He said he believed the description of the woman having a medical event came from her husband who was on the beach while his wife was in the water. He added it appeared she had become dizzv and was making her way to the shore. Chief Osgood said lifeguards immediately responded when they heard the commotion and pulled the woman from the water and performed CPR.

A woman who was on the beach at the time wrote "Her husband pulled her from the

water ... she was under for a while". Another person who was there told me "It was her husband who had to pull her out when he realized she had gone under. He and bystanders pulled her to the edge of the water ... they rolled her on her side and began CPR. By then lifeguards were watching, not participating. A nurse who happened to be nearby asked the lifeguards if she had a pulse. They said they didn't know".

These accounts differ from those of the Fire Department. I asked Chief Osgood if the lifeguards had written a report about the event. He said they had. I asked what was in it and he said he couldn't remember. I asked for the names of the lifeguards who went in to pull the woman out. He didn't know offhand. I asked for the name of the bystander who initiated CPR. He didn't know. When I asked what the medical event was he said he couldn't disclose that due to medical privacy issues. He said he would look at the lifeguard report and get back to me if there was information in it he could share. I also requested a copy of the report.

Earlier I spoke with Police Captain John Lazanecz of the Ogunquit Police Department. The police department is conducting the investigation into the tragedy. He gave me the name of the woman who died but didn't have much more information to share. He said they were waiting for the Medical Examiner's report. He

did not know if an autopsy was being performed, and said the Examiner's Office is backed up with cases.

In response to a question about when the results of the investigation would be released, Ogunquit Select Board member Heath Ouellette said he was told the police were waiting on the results of an autopsy and that could take up to two months. Captain Lazanecz told me he didn't know if an autopsy was being performed.

There is much that remains to be learned about the terrible event that occurred on August 15th. It is still not known for certain the role of the lifeguards in aiding the woman (she is referred to by the OFD as a patron of the beach). There are conflicting accounts of what happened that day. Neither the Fire Chief nor the Police Chief were there when it happened. The people who were there tell a different story of what occurred. When witnessing a traumatic event such as this it is not unusual for people to become confused about what they saw. That it is why it is so important for a thorough investigation to take place and be made public.

My heart goes out to the family of Margaret Kelley. Not having closure must be terribly painful. Margaret Kelley was more than a "patron of Ogunquit Beach". She was a human being who tragically lost her life that day.

I will be following up this story as I learn more.





Instead, these geniuses, most of whom knew nothing about my experience in the sport, accused me of knowing nothing about boxing. One said I shouldn't be writing as I had never set foot in a boxing ring (untrue), another said I was pursuing a vendetta against Big George (in fact I have always had admiration for him), while others just went on about what a moron I am.

I am not writing this because I have thin skin and was somehow deeply hurt by these comments. Instead, I am deeply disappointed by what occurred. Since I was a kid, I have engaged in arguments over who would win an upcoming fight, who was the best fighter that ever lived, and who would come out victorious in matches such as Joe Louis and Jack Dempsey or Rocky Marciano and Muhammad Ali. These "discussions" would become heated but never personal. They were fun and forced the participants to think through their positions and defend their stands.

Looking back over the years, I have changed my opinion many times. In fact, I could have some great arguments with my young self over what I thought about different fighters. Boxing is the most subjective of sports, and because of that, a person can view a fight or fighter differently over time. That's what so much fun about talking fights. At least it used to be.

The poison we have seen in recent years that is infecting our colleges and now getting into the mainstream is also creeping into boxing. As I read the responses to my article, I thought how similar it was to the crowds I had seen at our institutions of higher education where today many views are no longer allowed to be aired. Debate is stifled, and everything is personal. I also thought that the people so offended by what I wrote should probably seek shelter in a "safe space."

Heck, I don't care about being called names. Most of the comments were so ridiculous as to be comical. What does concern me is how many believed I should not have given my opinion at



all. That I had somehow crossed a line and my words were so offensive that they should not be heard. I thought people who followed boxing were made of better stuff than this.

After a few days of these attacks, I responded. Things slowed down after that and a number of people wrote positive things. These positive comments were not all in agreement with what I wrote, but in defense of my having written them and respectful of my viewpoint. These responses were heartening, but I fear the tide has already changed in favor of those who would stifle speech.

Now, I am not saying the republic is in danger of falling because a number of angry voices were raised in response to my questioning George Foreman's status as an all-time great fighter. What I do see going on here is a connect-thedots scenario where people in so many circles are indignant over anything they hear that is disagreeable to them. It has been happening on campuses, and I have seen it taking over the arts world, particularly in theatre. Corporations have falling prey to what has become known as "wokeness." It is unhealthy. For some reason people feel virtuous when they feign indignity and call for the stifling of ideas. There is a bullying aspect to this as well. This is more concerning when they do it while joining in with a mob. It also leads to a dullness of the mind. I am saddened to see it infiltrating boxing, but boxing has always been a reflection of society, so it is only natural, I suppose, for this to be happening.

I am reminded of the old Monty Python skit where the man is going to an argument clinic. He walks into a room he was directed to and is immediately met with a barrage of nasty insults. He shouts, "I came here for an argument." The man who's yelling at him responds, "Oh, this room is for insults, arguments are down the hall." I think I'll go down the hall.

HOOPS and HOCKEY in the HUB

FOR THE RECORD: PHIL KESSEL RETURNS — Yes, sometimes things do work in strange ways. Back on June 6 there was Bruce Cassidy, the head coach of the Bruins, figuratively being shown the back door of the TD Garden by Bruins GM Don Sweeney in a face-to face meeting between the two men.

But another door opened soon thereafter for Cassidy when the Vegas Golden Knights, a few years removed from their first-year-of-existence lengthy Stanley Cup run in 2018 had also decided to make a change behind the bench.

And a roll of the dice, so to speak, brought Cassidy, a veteran 14-year employee of the Bruins organization, westward to a take-all-chances town where one thing, at least, was guaranteed — his multi-year contract. "I have no problem with that," noted the former B's mentor in his introductory press conference.

Further to the south, in another western community, another scenario also was being played out.

Phil Kessel, a former defenseman for the Bruins back in the first decade of the current century, had become a free-agent after a three-year stint with the Phoenix Coyotes — a team that certainly was having its own on-ice difficulties in the National Hockey League.

Ordinarily, Kessel not being re-signed might just be called a fact-of-life move. After all, the Wisconsin native, who will be 35 on October 2, is a borderline senior citizen by NHL playing standards.

But over the course of his career, Kessel had proven to have an outstanding attribute. He is a most durable performer. Every night he has been there to take his shifts and turn in a quality effort. He led the Coyotes with 44 assists last season.

That is the Phil Kessel way. One that has brought him to the doorstep of claiming the Mount Everest of records: most consecutive regular season games played in the history of the National Hockey League. By signing with Vegas on August 24, he is on schedule to break the record early in the 2022-2023 season.

When the whistle sounded last spring to end the Coyotes final regular season contest, Kessel's streak stood at 982 consecutive games, just seven behind that of Keith Yandle.

Yandle, a Boston native who played at Milton High School and later at Cushing Academy, had compiled a streak of 989 consecutive games. He saw his run come to an end last April 2 when Philadelphia coach Mike Yeo held him out of the lineup as a heathy scratch in a game against Phoenix. That ended a 22-game "lead" he had on Kessel.

With the season running down and Philadelphia out of the running for a playoff berth, Yeo stated that there was a need to see what younger players could do in preparation for the next season. Yeo stated that Yandle, who had not missed a regular season game sinch March 22, 2009, took the decision "like a pro."

Still, the fact that his streak was broken had to be a big disappointment to Yandle, who had moved into first place by surpassing the 964 consecutive games played total of Doug Jarvis when he took the ice for his 965th straight contest last January 25 in a game against the New York Islanders.

If Jarvis' name sounds familiar that is because he later served as an assistant coach with the Bruins from 2010 until 2016. He won four Stanley Cups in the 1970s while playing for the Montreal Canadiens.

As an assistant to head coach Claude Julien, he was in Vancouver on that June night in 2011 when the B's defeated the Canucks in a seven-game series to claim their first Stanley Cup since 1972.

On a personal note, we should add that on numerous occasions we shared an elevator ride with coach Jarvis to the ninth floor of the TD Garden. We would take our seat in the media section while he would sit in a booth reserved for Bruins staffers, leaving between periods from his "eye-in-the-sky seat" to return to the locker room where he would impart information gleaned from his observations to the team.

Coach Jarvis never mentioned his consecutive games streak nor the part that made it most distinctive. You see, while compiling his streak of 964 games, he never missed a single regular season game in his entire NHL career. Think about that for a minute. His streak began on October 8, 1975 and continued through October 10, 1987.

It ended when the Hartford Whalers sent Jarvis down to Binghamton, their minor league affiliate, causing him to miss a game against the Bruins on October 12. Jarvis would not be called back up and would play 24 games with Binghamton before retiring. Today, he is a senior advisor with Vancouver.

And so Kessel is the last active player standing in what is called the "iron man" category. If all goes well, he will tie Yandle's record of 989 on October 20 in a home game against Toronto. He would then move into first place with 990 in a road matchup against San Jose the next night (October 21).

Going into the 2022-2023 season, Kessel has not missed an NHL regular season game since his streak started way back on November 3, 2009 when he was with Toronto. The closest it came to being terminated was this past spring when a road trip appeared to create a conflict: whether to be at home for the birth of his first child or play. But some swift planning by a generous owner meant all went well.

Kessel played one shift in the Arizona's game at Detroit on March 8, thus preserving the streak. He then boarded a charter flight back to Phoenix provided by Coyotes owner Alex Meruelo. He was with Sandra for the birth of their daughter Kapri.

He rejoined the Coyotes for their game in Toronto on March 10, contributing an assist as he kept the iron man streak alive, another step towards his quest of reaching the summit of hockey's Everest.
