JUVENAL

Our second distinguished scholar from the Silver Age of Latin literati is Decimus Junius Juvenalis, generally referred to as Juvenal, and considered to be the most representative satirical poet of this age. Satire as you know is that kind of writing which ridicules a person's vices or follies.

Juvenal was born in Aquinum, in the southern part of Italy, sometime around 63 B.C., was well educated in his rhetorical studies, and started writing satire when he was about forty years of age. He lived a simple lifestyle in a country estate near Tibur (Tivoli), and at various times in his life held the office of Tribune, and of Flamen. He was exiled to Britain or to Egypt because of a satirical attack on a favorite of the emperor, and he died while in exile about 130 A.D.

The total works of Juvenal are unknown, but sixteen of his

The Energy and Excitement of the Equinox

homage to the bounty of the Earth. In Europe, the last collection of harvest takes place around the time of the equinox. Our Italian ancestors, living off the land in a primarily agricultural society, may have waited until the Harvest Moon to finish harvesting their crops. The Harvest Moon, or the full moon closest to the equinox, illuminated the fields sufficiently so that farmers could work well into the night. This year, the Harvest Moon occurred on September 14th, and as usual I celebrated the occasion by baking my appropriately-named Harvest Moon cookies, or almond cookies half-dipped in melted chocolate. As the harvest ended in Europe, many cultures would ritualistically cut the last sheaf of grain, a practice which stems from ancient times, when people believed that the goddess of the grain was embodied in the final remaining bundle. It was then time for cozy feasts known as "Harvest Home," which still exist to this day and can be seen in the harvest fairs that dot event calendars throughout the fall. For Harvest Home, the community gathers together at tables laden with the foods of autumn — apples, pumpkins, pears, carrots, nuts, ginger, spices — and celebrate the generosity of the land and the fruits of their labors. In Italy, these kinds of feasts often take the form of sagre. Derived from the Latin word "sacrum," which also lends itself to the English word "sacred," sagre are festivals devoted to a specific crop or product. Italians love their sagre, and the various regions of Italy each have feasts that honor a local delicacy. Villages in Northern Italy, for example, may host sagre di mele — apple festivals - while Southern Italians often honor grapes in



Boston's Neighborhood Museum

New Exhibit Revives Spirit of Legendary Old Howard Theatre

On Tuesday, September 24th, The West End Museum premieres a new exhibit, "The Old Howard Theatre," in celebration of Boston's oldest and best-loved playhouse, which stood in the heart of Boston's Scollay Square just steps from the old West End. The Howard's origin, glory days, and ultimate demise are recounted through photographs, artifacts, and graphic panels. The **show reception** takes place on Thursday, October 17th from 6:30 to 8:00 p.m. Concurrent programs — a film screening, an author talk, and an evening of burlesque music — complement the show, which runs through February 15, 2020. The exhibit and reception are free; concurrent programs require admission for non-Museum members.

"Scollay Square and the Old Howard will always be connected to the history of the West End," said Duane Lucia, the Museum's executive director and exhibit curator. "By the 1950s, the Old Howard had become synonymous with vice and 'burly,' and like the West End, a symbol of a bygone Boston deemed by the powers that be as incompatible with the vision of the 'New Boston' and urban renewal."

Once a tabernacle for a doomsday sect, the building became a playhouse in 1845 only to burn down a few months later. Funds from a local brewery financed the construction of a new Gothic-like building, which opened its doors in October 1846.

The Old Howard (officially, the Howard Athenaeum) enjoyed a heyday of opera, ballet, and serious drama performances through the late 1860s when its audience dwindled in favor of other local theaters. To claim new patrons, the theater ushered in an era of vaudeville starting in 1869. By the early 1900s, however, variety and burlesque had become the order of the day at the Howard. featuring such legendary performers as Gypsy Lee Rose, Fanny Brice, Sophie Tucker, and Ann Corio. (On October 10th, the Museum honors Corio as part of its Italian Heritage Month Honoree Night.) Other renowned entertainers who graced the Howard's stage during this period include Abbot and Costello, W.C. Fields, Jackie Gleason, and Jerry Lewis

As the burlesque performances grew more risqué, denouncement by the Watch and Ward Society and vice raids by the Boston Police escalated. Indecency charges forced the theater to close in 1853. Seven years later, the Howard National Theatre and Museum Committee formed with a mission to return the Old Howard to its more "legitimate" age. Before those efforts could get off the ground, the building suffered a small and suspicious fire. Already in the swing of urban renewal, the City quickly swooped in and demolished the building, sealing the Howard's fate forever.


The following synopsis provides an overview of the book to be followed by selected chapters that will appear in this column.

Four Women is a historical fiction taking place in Boston's colorful North End, "Little Italy" in the summer of 1949, a time when families lived together in a close-knit community, slightly larger than one square mile.

Four Women touches on two cultures, the Italian world with its customs and traditions and what was termed the American world existing just beyond its boundaries, focusing on the spontaneity that so often arose through their interaction.

Four Women is about family bonds and the central place the Church played in establishing worship, continuity, community and a feeling of safe harbor.

This is the story of Lucia, matriarch of her family, widowed for 9 years, and her intense relationship with her three daughters: Angie, Stella and Carmela. Into this mix arises the unexpected love story of Pietro, the son of Velia Conte, a Roman noble woman, and



Gerardo Petruzelli, a successful Lawyer, brother of Lucia. Pietro is sent to America to live with his Aunt Lucia and her family for a three-month vacation prior to entering the seminary in Italy.

Plans change, however, when Pietro falls in love with Carla, the overprotected daughter of Egidio Ricci, a local fisherman, upsetting the plans of Pietro's parents and forbidden by Carla's family.

The book showcases colorful characters, events and vignettes, and touches on plans to disrupt the romance leading to situations that are sometimes comical, sometimes threatening, sometimes tender, but always motivated by love.

Four Women is a love story, the intense love between a mother and her daughters, the forbidden love between Pietro and Carla, the love for neighbors in an immigrant neighborhood and the love for the Church they all shared.

Saint Kuriakose Elias Chavara

Kuriakose was born on February 10, 1805 at Kainakary, Kerala on the Southwest coast of India He came from an ancient Nasrani Christian family. His parents were Iko Kuriakose and Mariam Thoppil. Kuriakose was baptized on February 17, at St. Joseph's Syro-Malabar Catholic Church, his parents dedicated him to Mary.

From age 5 to 10, he attended the village school to study languages, different dialects, and elementary sciences under the guidance of a Hindu teacher. Desiring to become a priest, he began his studies under the parish priest of the church of St. Joseph. At the age of 13 in 1818, he entered the seminary at Pallipuram where he studied with Father Thomas Palackal who was it's rector. Fr. Palackal hoped to establish the Carmelites of Mary Immaculate, which would be the first religious institute in India founded by native people.

A few years after joining the seminary, a major tragedy occurred in Kuriakose's life.

His father, mother and his only brother died in a small pox epidemic that devastated his village. Kuriakose, who was just 13 years old at that time came to know of their deaths three weeks after the incident and was unable to attend their funeral. He was heart- broken. He returned to the seminary and rededicated himself to his studies.

He was ordained priest on November 29, 1829, and celebrated his first Holy Mass at Chennankari Church. After his ordination he was engaged for some time in pastoral ministry. In time. he became co-founder and first prior-general of the Congregation of the Carmelites of Mary Immaculate. The main work of the Congregation is education aiming at the intellectual, social, economic, moral and spiritual advancement of people, especially women and children; it is carried on today in eight countries with almost

5,000 members.

He founded several seminaries, introduced annual retreats for priests and people, started forty-hour adoration and gave special attention to catechumens. Taking into account the needs of the people of that time, he also established a house for the dying and destitute and schools for general education. It was only because of St. Kuriakose who was appointed the first Vicar General of all the Syro-Malabar Catholics in 1861 that the Church could withstand the many threats to ecclesial unity caused by various schisms.

Kuriakose passed away on January 3, 1871. He was Canonized by Pope Francis on November 23, 2014. The Feast day of Saint Kuriakose Elias Chavara is February 18th.



A Nostalgic Remembrance

The day after I graduated English High in 1956, I received a call from a close friend whose father had found us jobs working on construction. According to my friend's father, his son was going to drive a bull dozer and I was going to drive a tractor, and both of us were going to earn \$15.00 an hour (not bad for 1956). Considering the minimum wage was \$1.00 an hour, we were going to get rich quick.

The next morning, my friend and I reported to the job site and the contractor handed us pick and shovel. We worked the entire day and I headed home with blood blisters covering the palms of my hands. Babbononno filled a basin with warm water, salt and Epsom salts. And as I soaked my hands and grimaced due to the pain, Babbononno had a couple of choice words, "Idiota, stupido, perche non hai indossati I guanti?" (Idiot, stupid, why didn't you wear gloves?)

Just then Dad came home, dressed in his usual suit and bow tie. I showed him my hands and said, "Dad, you were right all along. I'm going to college." The only problem was that I had not taken the SAT exams, a prerequisite for almost any college. Plus, my grades were fair at best. Dad made a couple of calls and told me to report to the dean at Boston State College on the following day. Dressed in a suit and tie, I headed to the corner of Huntington and Longwood Avenues in Boston's Fenway district and entered the lobby of the college. I asked the security guard where Dean Reagan's office was.

When I was ushered to his inner office, he looked me up and down and said, "You certainly look like your father." After a few more pleasantries, we got down to business. When he understood my lack of preparation, he had his secretary bring in an entrance exam for me to work on. When I finished it, I left it with the secretary who informed me that the dean would be in touch. I received a call the next day ... I made it ... I was in.

In late August, we closed up the cottage in Maine and headed home. A couple of days later, I was standing in the main auditorium of Boston State with a group of 17 and 18 year olds who were to be my classmates. We were the recent high school graduates. When we were assigned to freshman sections depending on our majors, I saw

several older men, some in their 20s and others in their 30s filling in our ranks. Later I would discover that they were vets, taking advantage of the G.I. Bill before it ran out for Korean War veterans

I stayed close to a friend who also attended English High, Bob Pesce, also a fellow East Bostonian. Our group was all male as we were majoring in Industrial Arts, hoping to become shop teachers in four years. The person calling the roll was a new teacher from the midwest where the most difficult names to pronounce might be Smith, Jones, Brown or Johnson. The first four names on our list were Abburzzese, Christoforo, Ciccarelli and Civili. It took the midwesterner ten minutes to mispronounce all of them. Later when he hit LaBolita and Pesce, he really screwed up. The rest of the names were either Irish or English in origin and much easier to pronounce. There were 42 of us that started Boston State that first day of college in September of 1956.

Pesce and Ciccarelli had cars and a schedule was worked out as to who would drive and when. We became known as the "East Boston Express." I had to immediately change my image as I dressed like a street hood: One button roll suit, pegged pants, suede shoes and a very curly D.A. haircut with the makings of a thin mustache hanging down above my upper lip. So, I headed to Filene's Basement to see the man who had been selling me my clothes since I started English High. Lowell, the salesman assessed my needs and I soon had an Ivy League appearance. I next headed to Frank Fay's barbershop behind Jordan Marsh. He catered to the show business crowd and gave me a college haircut. I was all set to attend class a couple of days later.

Everyone was shocked on that first day as I now looked like I belonged on a college campus. Where I would no longer belong was hanging on a street corner. Once I began, all of the studies took up a lot of time. Combined with my schedule at the Seville Theater, I didn't have much time for the corner of Brooks and Bennington Streets any longer, and I slowly began backing away.

Dad was proud, Mom was proud, Babbononno was happy I was going to be working with tools, especially woodworking tools. He had hoped I would take after him and design and make furniture. None of his sons were interested in working with wood and I was the last resort. Especially proud was the manager of the Seville Theater, a Mr. James F. Ray. I had been working for him since August of 1952, and after four years there was the head usher. Dave Turner, the stage manager at the Seville insisted that he knew I had it in me to head to college and all was well.

By the end of that first year, half of the class (21 students) had dropped out. Some had families and had to work to support them; others couldn't handle their studies all that well and failed almost everything. Beginning in September of our sophomore year, there were 21 of us who would stay together and all graduate in June of 1960. On campus, they referred to us as Club 21.

After graduation, I took the exams to teach in Boston. I topped the list taking the Industrial Arts exams, but I had two problems, the veterans were given preference, and ahead of them, disabled veterans. I knew that, regardless of my grades, I wouldn't have a job. Paul Ciccarelli and I accepted jobs at Tewksbury High School. He was to be the new woodworking teacher, and I the new drafting man. I would stay there for a year, and bargained for a better salary and work situation at the end of that first school year. I didn't get anything in writing, just a firm handshake. This meant a lot to Italians back in East Boston and the North End, but when I returned that next September; no one could remember what I was promised.

Two weeks later, I received a call from Boston. They had a job for me at Boston Tech and I handed in a two week notice to the principal at Tewksbury High School. I would spend the next 42 years in the Boston Schools ... I guess I couldn't keep a steady job!

Recipes from the Homeland

SPIZZATEDU (Spiz-za-thay-doo) Chicken in Bianco

1 three- or four-pound cut-up chicken

1/4 cup cooking oil Grated Romano cheese Water

1 medium onion chopped2 tablespoons chopped fresh or dried parsley

Heat oil in a six-quart pot. Brown chicken portions on both sides. Do not burn. The browning of chicken parts in the oil and the browning residue remaining at the bottom of the pot gives the flavor to this recipe. Add chopped onion and parsley to the chicken in the pot after all chicken has been browned. Stir until onion is opaque. Remove from stove. Add enough water slowly to cover chicken contents. Cover pot and return to heat. Bring to a boil and then lower heat. Continue to cook slowly until chicken is tender. A chicken bouillon cube can be added if desired. Salt to taste.

Cook pasta of your choice according to directions on package. Place cooked pasta in a large serving bowl. Pour chicken broth over pasta and stir before serving. Sprinkle grated Romano cheese over each serving. Chicken can be served with pasta or separately, with fresh garden salad and garlic bread.

Serves four to six people.

NOTE; This is a recipe taught to me in 1949 by my mother-in-law, Mary Sinopoli. The family had migrated to this country in 1892. Her mother had taught her as a youngster how to prepare this "Spizzatedu" recipe that they had enjoyed in Messina, Sicily. It was a favorite of the family in the 1800s and continues to be so for the generations that have followed.





HOOPS and HOCKEY in the HUB

AN ANNIVERSARY THAT IS NOT GOLDEN — That is perhaps the proper way to think about one of the most dreadful incidents that has ever taken place during the National Hockey League's annual preseason period.

As now, the preseason was, in reality, the commencement of a lengthy line of games that would eventually culminate in the Stanley Cup Final.

But 50 years ago, back on September 21, 1969, as the Boston Bruins and the St. Louis Blues took the ice for a preseason contest in Ottawa, the national capital of Canada, few were thinking that far ahead. It was probably just a thrill to have two NHL teams competing in the building, since the franchise we now know as the Ottawa Senators would not take the ice until the start of the 1992-1993 season — with former Bruins head coach Rick Bowness directing them from behind the bench.

Back the fall of 1969 the Blues were regrouping after having been swept in the Stanley Cup Final the previous spring by the Montreal Canadiens. Months down the road, in May of 1970, these two teams would meet again in the Stanley Cup Final. The Bruins would sweep the series 4-0 with Bobby Orr scoring his famous goal in overtime to give the Bruins their first Stanley Cup Championship in 29 years.

But on this night, there were still the remnants of a summer just concluded — and memories throughout the nation's heartland of a Stanley Cup championship that had once again gone to an historic franchise rather than an expansion team in its second season — the Blues having entered the league at the 1967-68 campaign.

As we mentioned last week, the preseason often pits veterans against newer players on the same ice — players having established themselves facing those seeking to earn a roster position in the NHL.

This would be one of those nights. At age 29, Bruins defenseman Ted Green was an established veteran, known throughout the league as the team's enforcer. He was not afraid to engage any player from the opposition. He had been assessed 133 penalty minutes during the 1967-1968 season and drew 99 more over the course of the 1968-1969 campaign.

Wayne Maki, at 24, was one of those players seeking to make an impression on the Blues coaching staff. He was also trying to follow in the footsteps of his older brother — Chico Maki — a veteran star with the Chicago Blackhawks.

In fact, he had tasted the good life of the NHL while playing briefly with his brother in Chicago during the 1967-1968 season. But he had been sent down to the minors where he had languished for most of the past two seasons. Now was his chance to show he was worthy for a return to the life of an NHL player.

It was about the 13 minute mark of the first period when it happened. A puck went into a corner and so did Green and Maki. Pushing, shoving — and this time more than that — ensued.

During that era, NHL players did not wear helmets during games. The rule requiring them would not be put in place until 1979. And it would be phased in, meaning that only new players entering the league were required to wear them. Veterans had the option to continue to play without helmets if they chose.

Things escalated in those close quarters (as they sometimes do) but on this occasion, the proceedings went beyond the normal. There was stick swinging involved and Ted Green wound up with severe head injuries.

Rushed to the hospital, Green would undergo two operations to stop hemorrhaging in his brain. He would later have a metal plate placed in his head.

Both players were charged with assault. They were acquitted. Last week we noted that hockey players are resilient when it comes to injuries. Ted Green would come to epitomize that statement. He returned to the ice for the B's in time for the 1970-1971 season, playing 78 regular season games, the most he played in a single campaign during his 10 years as an active player with the Bruins.

And yes, he experienced the ultimate thrill, playing 54 games during the Bruins 1971-1972 season that saw the B's continue on to win their second Stanley Cup in three years. It was the second time Green had his name engraved on the Cup. The first had come in 1970 — the year he did not play because of his injuries. His teammates saw to it that his name was placed on the Cup.

Ted Green later switched to the New England Whalers, winning the Avco Cup with them in their inaugural season. He played three seasons with the franchise before moving on to play four years with the Winnipeg Jets, concluding his career in 1979.

But Ted Green was not done with hockey. He became an assistant coach with the Edmonton Oilers, winning five Stanley Cups with them in 1984, 1985, 1987, 1988 and 1990. He was named head coach of the Oilers in 1991 and remained in that position for two plus seasons. Today, Ted Green is 79 years old and retired.

Wayne Maki never really caught on with the St. Louis Blues. He served a 30-day suspension following the incident and then played 16 regular season games with the Blues before being sent down to the Buffalo Bisons of the American Hockey League.

However, he was claimed by Vancouver in the 1970 expansion draft and went on to make his mark with the franchise. He scored 25 goals and added 38 assists for a total of 63 points in 78 games with the team (1970-1971). He then went 22-25-47 in his second season (1971-1972) over a span of 76 games.

Sometimes there are sad ironies in life. During his third season with Vancouver, Wayne Maki, the player who was not seriously injured in the incident with Ted Green, would be diagnosed with brain cancer in December, 1972.

Wayne Maki died on May 12, 1974. He was 29 years old.
