I Am So Tired of This **Confederate Flag Controversy**

VIRGINS VESTALES (continued from October 30, 2015 issue)



House of the Vestal Virgins (Atrium Vestae).

Evidence of the luxurious life-style of the Vestal Virgins has been gained from the remains of the "Atrium Vestae" (House of the Vestal Virgins), with its spacious court, splendid decorations, baths, and hot air flues. They were granted the privilege of keeping horses and carriages, and when in public they were preceded by a lictor who cleared their way. Their presence was expected where no other women, as a rule, might go; such as places of public amusement, the circus, the theater, and even the amphitheater where the best seats were permanently at their command. The only superior whom they acknowledged was the "Pontifex Maximus" who, representing their king of the ancient village, had a parental authority over them and who alone was responsible to administer corporal chastisement if any Vestal neglected her duties.

There were only two offenses which a VestalVirgin could commit and these were most rare. The first offense was to neglect the sacred fire, so that it became extinguished. For this kind of carelessness, the Vestal was scourged by the Pontifex. The second offense was to violate her vow of chastity. Those who were found guilty of this act were carried on a bier to the Campus Sceleratus, near the Colline Gate, beaten with rods and buried alive. Her seducer was also rewarded by being scourged to death.

Vacancies in the ranks of the Vestals were always filled by girls under ten years of age, and each in turn retired at the age of forty.

Every girl possessing the necessary qualifications was liable to be called on to

undertake the duty, and no exception was granted except upon very strict conditions. The age limit to qualify for selection was not less than six and not more than ten years of age; without personal blemish; of free, respectable family, whose parents were still alive; and residing in Italy. Twenty girls were nominated by the Pontifex, and the final selection was made by lot. The selected candidate was immediately taken to the Atrium Vestae, her new home, properly attired and shorn of her hair. Her time of service was set by law at thirty years; ten for learning, ten for performing, and ten for teaching.

There was always a variety of ages in the household of the Vestals. There was the little girl with close-cropped head, running around the garden or up and down stairs, learning her duties in bits and pieces, for she had a long time to learn them. Then there were those in their twenties, by now well acquainted with all of this luxury, social consequence, political influence, and freedom of action. Lastly, of course, there was the oldest of the group, with all of the years of accumulated honor and the distinctive title of "Vestalis Maxima." At the end of their 30 years of service, leave was granted to lay aside their priesthood, return to private life, and marry if they desired. What else can be said, other than "Figlio maschile e cento anni."

Saint Agnes of Assisi

Saint Agnes was born in 1197. She was the younger sister of Saint Clare of Assisi and one of the first abbesses of the Order of Poor Ladies. Agnes was the younger daughter of Count Favorino Scifi. Her saintly mother, Blessed Hortulana, belonged to the noble family of the Fiumi, and her cousin Rufino was one of the celebrated "Three Companions" of St. Francis.

Clare, eldest sister of Agnes, inspired by the example of St. Francis of Assisi, left home in secret on March 18, 1212 to become a follower of the saint. Sixteen days

later, Agnes ran off to the Benedictine Monastery of St. Angelo, determined to join her sister and share in Clare's life of poverty and penance. Their father, angry at the loss of his daughters, sent his brother Monaldo, and several armed followers to the monastery to force Agnes to return home, but the sisters refused to leave, even when soldiers tried to force them to do so, they were so certain that God was calling them to this new life. Francis later established a cloister for Clare and Agnes at the rural chapel of San Damiano, where they were soon joined by other noble women of the city, and the Order of Poor Ladies, later known as the Poor Clares, began with Clare as its abbess. Agnes thrived as a nun. She was eventually named abbess, and in 1219 was sent by St. Francis to direct the Poor Clares at Monticelli, near Florence. She went on to establish other communities in Mantua, Padua and Venice.

In 1253, Agnes was summoned to Clare's deathbed at San Damiano and assisted at her funeral. Agnes followed quickly as Clare had predicted, dying three months later on November 16 of the same year. Her mother, Hortulana, and a younger sister, Beatrice, had already died, and Agnes is buried near them in the Church of St. Clare of Assisi.

Saint Agnes was canonized by Pope Benedict XIV in 1753. Her feast day is celebrated on November 16^{th} .

The release of the Boston Permits & Licenses platform will focus on supporting businesses, homeowners, and contractors through the entire permitting process. It has been in development over the past year, and will provide a more modern, easy-to-use interface.

The following features will be part of the initial release of Boston Permits & Licenses, for the first time providing customers with the ability to:

- Apply for multiple permits at once and group permits together in a single project.
- Build a team of project partners homeowner, contractors, and licensed professionals who can together advance all permits needed for a project to move forward.
- \bullet View enhanced information about project review statuses.
- Create accounts through Google Mail and other common login providers.
- Identify project location on an intuitive map-based interface.

"This technology will make it easier for our customers to do business with the City of Boston," said Jascha Franklin-Hodge, chief information officer. "Our goal is to deliver digital services for Boston that are as good as those from the best private companies."

This release has been preceded by a series of interim improvements to permitting that the Mayor has rolled out over the past year, which stemmed from the city's first HubHacks event in August 2014.

L'Anno Bello: A Year in Italian Folklore

November 11th: Exploring the Heart of the Month

The month of November encompasses two faces, similar to a copper penny. One face of November involves the countdown to the frenzy and joy of the holiday season. Commercials featuring jangling jingle bells and shiny wrapped Christmas gifts are already beginning to inundate television channels. When my best friend and I visited the mall the day after Halloween, evergreen boughs and whitegold electric lights draped along every balcony and

column. The second face of November is its most immediate however. This is the gray November of early winter, when cloudy skies disguise the earlysetting sun. This is the November when chill winds blow the last scraggly yellow leaves off the trees and geese plaintively call from above as they fly south. Too often, we only pay attention to the bright holiday face of November, trying desperately to rush into the festivities of November that we forget to appreciate the beauty of the present month. The blustery days of November carry their own sense of beauty and significance. They encourage us to reflect on the cycle of nature, the memory of the past and beckon us to spend time with loved ones. Right in the middle of the month, the special date of November 11th encapsulates all that is powerful and meaningful about this time of the

When I was preparing my desk calendar for November, I drew a little American flag on the eleventh day of the month. I wanted to honor Veterans' Day, the most well-known commemoration taking place on this date. Originally Armistice Day, Veterans' Day celebrations began as a way to honor the end of the First World War, when peace was declared on the eleventh hour of the eleventh day of the eleventh month. Nowadays, this holiday serves as reminder of the heroic sacrifices our veterans — of all wars — have undertaken on behalf of the country. One of my coworkers is a veteran and conducts an assembly every year along with other teachers who had served in the armed forces. The assembly includes speeches by those who witnessed war first hand, music provided by the school's band and chorus, and testimo-



nies from veterans of all ages. I am eager to bring my classes to this event so that my young students will grow in gratefulness and appreciation towards these brave men and women, and so that knowing the horrors of war they will be more likely to strive towards peace. Veterans' Day can also be a somber occasion, honoring the soldiers who died in duty. Indeed, in ancient Europe the whole month of November was completely dedicated to the commemoration of the dead. As the vegetation withers around us and the year sighs its way to a close, our minds drift to matters of memory and the past. This Veterans' Day, we should all keep the sacrifices of our veterans, living and dead, close to our hearts, and express our deepest thanks for the freedoms they provided. Moreover, we should carry this gratitude with us all year long, for the courage of our military men and women is never confined to just one

November 11th is also the date of a holiday which hearkens back to the Middle Ages. St. Martin's Day, often known as Martinmas, honors St. Martin of Tours, a fourthcentury French bishop. All across Europe, Martinmas functions as an agricultural as well as religious holiday, an occasion marking the end of the harvest season and the beginning of the winter. As such, St. Martin's Day is often celebrated with feasts of hearty autumnal delicacies and family reunions. In Central Europe and Scandinavia, goose is the dish of choice, often stuffed with fall staples such as chestnuts. The use of goose stems from a legend regarding St. Martin, which states that the humble man hid in a goose pen when he was reluctant to accept the position

as bishop. In Germany and the Netherlands, children dress up and participate in processions bearing lanterns, while in Poland people feast on croissants filled with poppy seeds and almond paste. However, St. Martin's Day retains a very strong association with wine. In Italy, St. Martin's Day, known as il Giorno di San Martino, is the day when people sample the new wine of the year. My father always repeated

the proverb "San Martino, si fa il vino," meaning that wine is made on Martinmas. Another Italian proverb simply and succinctly declares: "San Martino, castagne e vino," which translates to "St. Martin, chestnuts and wine." These proverbs speak to the Italian love of seasonal food and traditions with deep roots in the old agricultural-based society. I too celebrate St. Martin's Day with comforting Italian autumn recipes. For several years now I have been making pumpkin gnocchi on this day from a recipe in my much-beloved copy of Festa by Helen Barolini. As the scent of nutmeg and browned butter wafts through the kitchen, I feel a special kinship to my ancestors who battled the darkness and cold of winter with cozy meals and the love of family. Martinmas is special to me because it honors both sides of November. Its emphasis on the harvest and the commencement of winter teaches me to appreciate the uniqueness of the month, while its customs of feasting prove a tantalizing foreshadowing of the holiday season to

November is a month of many delights and much significance, despite the fact that many people view it as simply a cold and gray transitional point to the festivals of December. However, if we pay special attention the hidden wonders of the month, we will find them most rewarding. The sight of bare branches across a cloudy sky and the pale yellow light of the afternoon sun encourage me to pause and reflect on the past year, evaluating my goals and desires. The cold evenings beckon me back home, creating treats in my kitchen or enjoying the irreplaceable company of loved ones. November 11th is a special date for recognizing the uniqueness of the month. During Veterans' Day, we honor the bravery, courage, and sacrifice of America's military men and women, an action we should undertake all year long. On Martinmas, we prepare for the coming winter while reveling in traditional foods and feasts with our family. By observing these commemorations, we will discover the warm and loving heart beneath November's chilly exterior.

Many experimental hair straightening solutions failed, leaving girls vulnerable to ridicule and running to Woolworth's wig department! The shop acted as a refuge to hide from the problems made by the war. It was a place of comfort and

The memories of my Mom and Nana's Beauty Shoppe came flooding back as memories told by my Mom so long ago. The familiar "tools of the trade" from the era in the play were very much the same, as well, including the scenarios that women pull through by expressing their inner thoughts to hear advice or a kind word. 

LYNDON B. JOHNSON

(August 27, 1908, Stonewall, Texas-January 22, 1973, Stonewall, Texas):

Tragedy Blinds Victory



Johnson largely shed the image of his Texas upbringing upon assuming the presidency.

Lyndon B. Johnson deserves the credit for many of the things that John F. Kennedy is applauded for. Like Woodrow Wilson, Johnson found himself following a hard act. Kennedy was a beloved president and the youth, who were developing a stronger political pull in the early '60s than ever before, lionized him as a champion of the growing civil rights struggle and (to his credit) de-escalating the Cuban crisis. True, Kennedy was a promising president with many great ambitions. Because his presidency was cut short by a tragedy, it remains unknown how many of those promises would come to be realized. Johnson inherited both the growing domestic and foreign conflicts and big shoes to fill.

On a social level, Johnson followed in Kennedy's footsteps with little difficulty. From the start, Johnson told his economic advisor Walter Heller that abolishing poverty would be one of his first challenges. He would adapt Roosevelt's New Deal policies, bending them into what would become Medicare and Medicaid. Indeed, Johnson got right to work on this promise.

On the advice of United Automobiles Workers President Walter Reuther, Johnson began what he would describe as a cost-effective, though "unconditional," war on poverty which would work more like a "hand up" than a "hand out." Aptly titled "War on Poverty," Johnson's program expanded public school funding, as well as Head Start (an educational program for underprivileged children), legal services, and job training programs. Johnson was less successful, however, in actually creating jobs and developing a livable wage for workers, but his initiatives did reduce poverty. Economically speaking, Johnson's greatest accomplishment was the development of Medicare and Medicaid, which went hand in hand with the creation of community-based hospitals.

It was in advancing the civil rights struggle, however, where Johnson ultimately accomplished what Kennedy had set out to do. He did so by evoking the late president only four days after the assassination.

"No memorial oration or eulogy could more eloquently honor President Kennedy's memory than the earliest possible passage of the Civil Rights Bill for which he fought so long," Johnson said. He entered into a fragile but ultimately fruitful alliance with Dr. Martin Luther King and other leaders. Forward thinking was not immediate for President Johnson, who descended from a Confederate soldier and grew up in Texas with little exposure to the struggles of the urban black American. Indeed, one of the most discussed disputes between the President and Dr. King came in February of 1965, when Johnson advised the civil rights leader to hold off marches in an effort to win over the more conservative wing of the party. King refused, somewhat insulted, but Johnson understood his point and the two reached an agreement.

Whatever his motivations, Johnson seemed committed to passing the Civil Rights Act, famously stating, "We shall overcome." As Bill Moyers said, "Lyndon Johnson was no racist, but he had not been a civil rights hero, either. Now, as president, he came down on the side of civil disobedience, believing it might quicken America's conscience until the cry for justice became irresistible, enabling him to turn Congress. So King marched, Johnson maneuvered and Congress folded."

Johnson deserves a higher place in American history simply for getting the Civil Rights Act passed in 1964, but he didn't stop there. Within a year, he had the Voting Rights Act passed, which removed roadblocks for many potential black voters, especially in the South.

It's safe to say that economically and socially, the legacy of Lyndon Johnson is secure. Where we get into murkier waters is with the escalation of the Vietnam War. Early on, Johnson took advice he would later regret. His advisors opted for a more aggressive approach to Vietnam, to strengthen the Southern Vietnamese Army.

Johnson was torn. He knew sending in troops would mean a serious drop in his approval rating, which he could not afford with the 1964 election coming. But he also wanted to reassure South Vietnam leader General Khanh that he would back him up. Pressure was coming in from the U.S. military, Congress, and South Vietnam for troops on the ground. In a way, the Vietnam issue did come back to haunt Johnson in the 1964 election when Barry Goldwater used it as a point to chide the president for his weaknesses. Nonetheless, Johnson won the election by a landslide and, from there, wasted little time sending American troops into Vietnam.

His first move was 1965's Operation Rolling Thunder, a whole-scale bombing of North Vietnam. He originally intended it as a short-lived retaliation against NLF (National Liberation Front) forces. But it lasted three years and, once in, Johnson found he needed to continue sending in more troops to defend against enemy forces. One month later, he sent in 3,500 Marines into the combat zone.



DR. BEN CARSON REMEMBERS HIS BOSTON 1959-61

In his autobiography, Dr. Ben Carson describes his years in Boston (1959-61) as a child. He talks about a really rough neighborhood with plenty of hopelessness and violence in the Grove Hall section of Roxbury and Dorchester, up near Franklin Park Zoo.

The Boston Globe sent out a reporter seeking to find folks who remember those areas of Boston over 50 years ago. The attempt to do so seemed to contradict Carson's remembrances. I grew up in Lower Roxbury and the South End during the '50s and '60s and, as I remember, those neighborhoods Carson recalls became progressively more dangerous. Violence became an overwhelming common theme. By the early '60s, my parents who always took us to the zoo in the summer for suntans and animal visits stopped taking us there as the violence outside the zoo's gates starting crossing over into the zoo area.

Carson's views reflect my views of that area. To pretend things were so much better is nothing but a case of denial.

However, today that area is better than it was back then. Grove Hall has come back from its violent past. Families call it mostly a safe environment today. But everywhere else, guns, violence, drugs and homicides happen too often.

What really got to me was Carson's reflection that after a



QUICK VEAL OR CHICKEN SPECIAL

1 pound cubed veal stew meat or chicken breast

1 large ripe tomato

1 medium chopped onion 2 cloves chopped garlic

2 small sprigs bay leaf (optional)

1 fresh mint leaf (optional) 1 or 2 *julienne potatoes 1 or 2 *julienne carrots (optional)

3/4 cup frozen or canned green peas

2 tablespoons red wine

1 chicken bouillon cube

3 tablespoon olive oil

1 can sliced mushrooms or mushrooms of choice

*(Julienne) cut into thin long strips

Heat oil in skillet and add cut-up veal or chicken breast. Stir and simmer to brown meat lightly. Remove only meat from skillet and set aside. Add cut-up onion and garlic to oil in skillet and simmer until onion is opaque. Add cut up tomato. Stir and simmer over medium heat. Cover and continue to simmer for two or three minutes before adding one cup of water and a chicken bouillon to skillet. Stir, cover and continue to simmer mixture slowly for another two minutes. Then add veal or chicken breast to tomato mixture and bring to a slow boil. Add bay leaf and mint (optional) to skillet and stir. Continue to simmer at low heat for ten minutes

Meanwhile, remove skin from carrots and potatoes and *cut into thin long strips (julienne). Set aside in water in separate bowls.

When meat has cooked about ten minutes in skillet, add carrots first. Cover and cook for about five minutes. Then add potato and mushroom slices. Stir and cover. Continue to simmer until potatoes and carrots are tender to your liking. Add wine, cover, bring to a slow boil and then remove from burner.

Serves two

NOTE: It was meals like this that I remember Mama surprising us with at various times. I often wondered — now where did she find this recipe? She loved creating meals that might be different. It was a great lesson that encouraged me to create meals with meats and vegetables that my family enjoyed.

It was difficult, but I could make out Ray leading, Uncles Nick and Paul on saxes and my father on bass.

The band was a fixture at the Oceanview and, when I was in high school, I would go to either their Friday or Saturday night dances. One of my friends, a kid named Bobby, would borrow his brother's car and would pick me up for the event. Back in the day, we would dress for a weekend dance, in a suit, tie, shined shoes, face smelling of Old Spice aftershave lotion and a friends. We danced the fox-trot package of SenSen in our pockets to keep our breath from smelling like stale cigarettes.

According to the FTC's Consumer Sentinel Network Data Book, 37,422 Massachusetts residents reported being scammed last year. So-called "imposter scams" — in which scammers pose as IRS agents, and more — topped the list of consumer complaints. Age-wise, those in their 50s filed the most complaints — about one in five — while 18 percent of complaints were made by those in both their 40s and 60s. People age 70 and older filed 10 percent of complaints.

Massachusetts saw 5,116 complaints of identity theft from victims in 2014, the majority (43 percent) stemming from government documents or benefits fraud. The second most common ID theft complaint concerned credit card fraud.

Comes to Hartford

REVIEW: REAR WINDOW



Hal (Kevin Bacon), Thorwald (Robert Stanton) and Mrs. Thorwald (Melinda Page Hamilton)

Rear Window, now playing a sold out run at the Hartford Stage, is not an adaptation of the Alfred Hitchcock movie. This version has been adapted for the stage by Keith Reddin from the original story by Cornell Woolrich. The leading character, Hal Jeffries, played by Kevin Bacon, is much darker than the one in the movie. He is an alcoholic who is dealing with many demons that at times lend a dreamlike quality to the play.

I doubt there are many of you who do not know the story, so I will not go into detail other than to describe some of the differences. Instead of a beautiful girlfriend, Hal has Sam, a handsome young African-American man who met Jeffries in a bar (though Hal claims not to remember the meeting.) The homicide detective is now Lt. Boyne, a homophobic racist who immediately has it in for Sam. The back and forth between the two is not pleasant to watch.

Robert Stanton does a marvelous job of playing Thorwald, the man Hal believes has murdered his wife. He is a milquetoast guy married to an alcoholic woman in a relationship that has no chance of improving.

The actors in this production are all great. There is no doubt it sold out before its first performance because of Kevin Bacon. But it is unfair to say this is a hit because of the big name on the marquee. Yes, Mr. Bacon is fantastic in the role, hobbling about on crutches, maneuvering around his flat in a wheelchair, and deducing that a crime has been committed all while he is either drunk or hung-over. The sexual tension between Hal and Sam is also slightly ambivalent, as Jeffries has dreams of his former wife whom he confuses with the murdered Mrs. Thorwald. But there is no doubt where his desires truly lie.

The script by Keith Reddin, direction by Darko Tresnjak, and the amazing sets all stand on their own as reasons to see *Rear Window*. The Hartford has made Film Noir into Stage Noir, and the darkness and sultry moods play as well live as they do on the big screen. Seeing a mystery while already knowing the outcome, or at least thinking I did, is something I thought would spoil the whole story. But midway through I was not sure

I was going to see the same ending as in the movie. This had me moving more to the edge of my seat as the story progressed.

Now to the sets. I have been very impressed in the past by the extraordinary job the team at the Hartford Stage has done, but in this case they have far surpassed even their own high standards. Alexander Dodge has designed a stage that in just a couple of seconds transforms from Jeffries living room to a view into the courtyard where he can see into the windows of his neighbors. Walls appear and disappear, rooms spin around so they can be seen into, and then are neatly tucked back into place. It is just amazing to see. Lighting by York Kennedy and sound by Jane Shaw add so much to the mood of that hot August night in 1947 that I wanted to put my face in front of the one fan in Hal's apartment to cool myself off. The sound and lights of the train passing outside the window add to the feel of living in a New York City tenement in the days before air conditioning was a household item. Looking at the side of the building with the occupants searching for ways to cool off reminded me of the George Bellows' painting Cliff Dwellers.

My readers who are fight fans will appreciate how this story fits so well on a stage just as boxing is perfect for the television screen.

This run is sold out and I don't know if it will move on to another theater or have any performances added at the Hartford. I would urge my readers to sign up for to the Hartford Stage mailing list in order to have a chance at any tickets that become available.



The Lies of Boxing

I once read that to be a good boxer you have to be a good liar. The reasoning behind this comment was that a boxer has to hide his fear when getting into the ring, that he must not show he is hurt when he is feeling pain, and must show confidence when he is filled with self-doubt. All of this requires fooling people into believing something other than what they see.

The fighter lies to the fans when he enters into the ring looking cocky and defiant, while inside he is wondering if he did enough road work, sparred enough rounds, if he is really ready to face battle.

He lies to his opponent when he is hit by a shot that causes him to see stars, but shakes his head as if to say he didn't feel a thing.

He lies to the referee when he is asked if he is okay and wants to continue after being floored by a power shot to the chin. There is a part of him saying it might be a good time to go home, but that is outweighed by the shame he will feel if he guits.

A boxer could not survive the sport if he didn't become skillful at deception. It is a key survival skill that is embedded in us. To show fear is to show weakness, and showing weakness gives predators a signal that they have an easy prey. It is a lesson learned by the earliest of cavemen.

The lies I have described are those good lies that are said in order to save the fighter from harm. Just ask any married man how he responds when his wife asks him if she looks fat in a certain dress. I think you will get what I mean.

But what happens when a fighter starts to lie to himself? I think of the pug that has seen his best days pass him by tells himself he still has that one good fight left in him, that chance to make it big. How many times does he step back into the ring only to take more punishment? When I think about the fighters who have done this, who have continued on only to end up damaged for life. I am reminded of the lyrics from the Simon and Garfunkel song:

"In the clearing stands a boxer, and a fighter by his trade, and he carries the reminders of ev'ry glove that laid him down and cut him till he cried out in his anger and his shame, 'I am leaving, I am leaving,' but the fighter still remains."

In many sports, older athletes lie to themselves about Father Time somehow passing them by as if they are immortal only to be embarrassed on the field or the court. They miss that easy catch or are unable to beat the throw. I am certain they feel shame, but the boxer suffers much more.

Boxers who convince themselves, or are convinced by others, that they still have the ability to go on are almost certainly assured of risking serious injury. Boxing is the most unforgiving of sports, and those who don't walk away in time are destined to live life in the "boxer's fog." The game demands a high price from those who try to beat it.

A few weeks ago, I wrote a column about why I believe Rocky Marciano retired. Some people thought I was trying to tarnish Rocky's reputation. On the contrary, I feel the fact that he walked away while on top, and with his brain intact, adds to his greatness. And his ability to resist the offers to come out of retirement show how he exhibited the same resolve about his own wellbeing that he had in the ring.

Read Budd Schulberg's great book *The Harder they Fall*, or watch the movie of the same name, and you will see the reality of the dark side of boxing. It is the story of the fighter who believes the lies that are told to build him up. The people, the promoters, the managers, and the publicity agents convince him he is great and can be a superman. It is easy to lie to a boxer as he is already lying to himself.

That story is not far from the truth, and it is one that is repeated over and over again: Men who are treated as commodities and worse. It is a side of boxing I despise. Sure, it happens in all professions and is a part of life; the difference is, in boxing it is so blatant and cruel.

As I said, boxing is a sport where it is easy to lie to the people who practice it because they are already conditioned to believe untruths from what they tell themselves. It is also easy because when you question a man's desire to get into the ring, you are questioning his very manhood. His honor and courage are called into question. Even in this touchy feely politically correct world we live in, there is still no greater insult to a man than to question his courage. The unscrupulous promoters and managers know this and they know it is a powerful tool they have at their disposal that can be used to manipulate fighters into making decisions that will cause them harm.

I hope the day comes when the well-being of the boxer is put ahead of the profit made off of them. It would be nice if the time came when promoters and managers told them when it was time to quit and get out while the getting is good. I doubt that day will come, but until it does we are all part of the tragedy that befalls so many who take part in this very tough game.

HOOPS and HOCKEY in the HUB

When Bruins center Chris Kelly went down on the ice during his first shift in the recent game against the Dallas Stars at the Garden, one could picture the Bruins chances of having a memorable season also diminishing as he lay in pain

There is a saying in all pro sports that it's not who starts the long regular seasons, but who is standing in good health at the end of them. As the playoffs approach that really matters. With Kelly, who fractured his femur and is expected to be out anywhere from six to eight months, that means he will not be in the lineup when the regular season concludes in April.

Kelly was a player of multiple dimensions for the Bruins. He could play all three positions on the lines, he possessed a leadership presence in the locke room and he could monitor and tutor the several young players that the B's have brought aboard this season. He was also a good interview in postgame situations, explaining with candor and detail what either went right or wrong in the contest that had just concluded on a particular evening.

Quite often, when a player is injured in pro sports, the coach will often seek to keep a stiff upper lip, if you will, saying the team will come together to get through the crisis.

To his credit, Bruins Head Coach Claude Julien did not really do that. From the moment he entered the press conference area and assumed his position on the podium, it was obvious that he realized his team would be deeply affected by the loss of Kelly.

"You hope you can somehow compensate for his loss, but I think people are going to realize how important he is to our hockey club, not just on the ice but also in the dressing room and around the team," said Julien as he addressed the members of the media. "He's a guy that is extremely respected by his teammates. On the ice he's given us everything we've asked for. He's been moved around in all different positions, never says a word, but just thrives on the opportunity to play in those spots that we've put him. He was a versatile player that we really counted on."

The coach added that while Kelly was "an important part" of the team, it was not just about stepping up and setting the tone, but how much the B's relied on him for the crucial part he played on the penalty killing unit — one that was ranked one of the worst in the NHL at the time of Kelly's injury.

"He's blocked so many shots," stated Julien. "He's extremely good. He was one of those guys that was offering us some hope in those (penalty killing) solutions. We will definitely miss him there and we'll definitely miss his leadership."

The Bruins now must play the remaining 72 games of the regular season without Kelly, a reality that may go on to cost them come April. While no one

skater is responsible for all the victories or all the losses, one can agree that a player can be the deciding factor in a few of them.

Thus, it seems reasonable to assume that Kelly, who will turn 35 on November 11, easily could have been the decisive player in three or four games between now and April, perhaps even a couple of more. If the Bruins just miss the playoffs (as they did last season) the absence of a player like Kelly could be the deciding factor.

Think back to last season when Captain Zdeno Chara missed 19 games in with a leg injury in the first half of the season. When the

Bruins were eliminated from a berth in the Stanley Cup Playoffs on the last day of the season on April 12, it wasn't a stretch of the imagination to believe that Chara could easily have been a factor in converting some of the losses into victories the B's sustained while he recuperated.

The 96 points the B's amassed last season were the most accumulated in NHL history by a team that did not advance to the playoffs. It's not hard to believe that Chara's presence would have been worth another few points (and thus a playoff berth) if he could have played in the stretch of games he missed while he was recuperating.

Similarly, wouldn't Kelly's presence for the entire 2015-2016 season have been worth a few points for the B's. Of course it would have. And thus his absence may turn out to be a decisive factor in not only whether the B's make the playoffs, but if they do, how high a berth they earn as the postseason begins.

Kelly's season-ending injury overshadowed the 5-3 loss to the Stars, a game that saw former Bruin Tyler Sequin lead Dallas to victory by scoring his seventh career hat trick. It was the familiar scenario in the NHL of The Traded One coming back to haunt his former team.

The other scenario that played out was the continued disappointing performance (at least in home games) of goalie Tuukka Rask. Several of Dallas' goals drew boos from the crowd while a number of easy saves by Rask drew rounds of derisive applause from fans.

Where all this will lead no one knows but things haven't been going well during home games on Causeway Street thus far. The drama and speculation continues.

We Hope it Isn't All Downhill from Here — Tyler Randell scored his first two career goals in his first two games on his first two shots — October 14th at Colorado and October 17th at Arizona. That made him the first Bruin to score in his NHL debut since Blake Wheeler accomplished the feat back on October 9, 2008 against Colorado.

Randell is the first Bruins player to score in his first two games since Dmitri Kvartalnov started his career with a fivegame goal streak way back in 1992.
