Rome Welcomes Back Stolen Art Works

Italy's long campaign to retrieve some tooted art works has succeeded. Last week American Ambassador John Phillips joined carabinieri art police in Rome to show off 25 returned items. which included Etruscan vases from the Toledo Museum of Art and the Minneapolis Institute of Art, 17th century botany books from Johns Hopkins Museum in Baltimore, a 16th century manuscript stolen from Turin in 1990 which had ended up in the special collections of the University of South Florida, and some first century frescoes.

Some items were spontaneously turned over to 0.5. authorities when their provenance became questionable. Others were seized by police after finding them in auction house catalogs. Still more have come to light as a result of customs searches, court cases, or tips from the public. Boston border patrol agents seized a 17th century Venetian cannon as it was being smuggled from Egypt concealed inside construction equipment.

"Italy is blessed with a rich cultural legacy, and therefore cursed to suffer the pillaging of important cultural artifacts," said Phillips, adding that Interpol estimates the stolen cultural heritage trade produces more than \$9 billion in profits annually.

Italian dealers Giacomo Medici and Gianfranco Be-cchina, who have been convicted of trafficking in plundered Roman artifacts, were identified by police as having allegedly sold several of the items.

Police at the restoration of the works emphasized that most collectors and museums are prepared to give up art works once the thefts are known. Authorities at the museum in Minneapolis directly contacted the Italian cultural minister after reading about one suspected piece.

Ambassador Phillips noted close collaboration between U.S. Homeland Security and border patrols with Italian police. The United States has returned more than 7,600 objects to more than 30 countries and foreign citizens since 2007, said Phillips.

Stirpe Nostra

ROMANO VS. RAPHAEL

While we are on the theme of Cupid, Psyche, and art, a very interesting story tells us about the community of Mantua in northern Italy, the birthplace of Vergil. He glorified the city's palace in his four books entitled "Georgica" This is the work which exhibited such a high artistic perfection in Latin poetry that it confirmed his position as the foremost poet of the "Golden Age of Latin Literati."

Mantua played an important part in the turmoil of the Middle Ages when the Gonzagas obtained its mastery. This is also when the city attained importance and prosperity. The Gonzagas were genuine lovers of art and literature, and they made their court a brilliant center of culture, deeds, arts, and letters. One wife of a succeeding Gonzaga was the gentle Isabella d'Este, so wise and accomplished that she was called the first lady in the world. She corresponded with the most eminent men of her time, charmed all hearts and her requests were never refused. Whatever activity she undertook was well done and her high spirits never failed her. As a great connoisseur of art she collected books, gems, rare brocades, musical instruments, paintings and other works with which she decorated her apartment. It was appropriately called "Il Paradiso".

The Gonzagas also built a summer residence which they called "Palazzo Del Te." Here, they decorated the walls with sensational and occasionally indelicate mythological and allegorical frescoes that were designed by Giulio Romano and executed by his pupils. One room, for example, shows the notorious "Overthrow of the Giants." Colossal figures are

shown crushed between enormous masses of rock. Another chamber's frescoes relate the story of Psyche as told by Apuleius in "The Golden Ass". Here, however, the incidents in that fable are illustrated with every variety of fantasy and insolence that freedom permitted. In spite of their erotic nature, the compositions are important, not only for a study of the life and manners of the people who frequented the residence, but for the influence that those pictures exercised on future

Another very interesting series on this same subject is located in Rome's Farnese Palace. The structure was started in 1500 A.D., giving Michelangelo, Giacomo della Porta, and Antonio da Sangallo an opportunity to contribute to its design. The owner of the palace was a banker, an enthusiastic admirer of the arts, and patron of Raphael. The ceiling of one large vestibule contains twelve fascinating frescoes displaying the same famous fable of Cupid and Psyche, but here it is told in a manner which is most graceful

in conception and treatment. The entire composition was designed and started by Raphael but completed by his pupils. This work is rated on a par with the most charming creations of the master. The scenes are neither coarse nor sensual; a nobility of proportion which never oversteps the bounds of refinement. This, of course, explains why most people know Raphael for the great master that he was, while at the same time think of Romano, as a distributor of grated cheese. The next time you get to Rome you

Day. It commemorates the adoption of the flag of the United States by the Second Continental Congress in 1777. It's a good time to reflect on the meaning of the flag and of the Pledge of Allegiance that many of us recited daily in school.

I pledge allegiance to the Flag of the United States of America, and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all.

The Pledge of Allegiance to the Flag of the United States of America should be rendered by standing at attention facing the flag with the right hand over the heart. When not in uniform men should remove their headdress with their right hand and hold it at the left shoulder, the hand being over the heart. Persons in uniform should remain silent, face the flag, and render the military salute (U.S. Code Title 4 Sec. 4.)

The original Pledge of Allegiance, "I pledge allegiance to my flag and the Republic for which it stands - One nation indivisible — with liberty and justice for all," was written in September of 1892 by Francis Bellamy for The Youth's Companion magazine in Boston. The phrase was printed on leaflets and sent to schools throughout the United States. The first organized use of the Pledge of Allegiance came on October 12, 1892, when some 12 million American school children recited it to commemorate the 400-year anniversary of Columbus' voyage.

In 1923, the first National Flag Conference in Washington D.C. voted to change the words "my flag" to "the Flag of the United States of America." Congress officially recognized the Pledge of Allegiance in 1942, but in 1943, the Supreme Court ruled that public school students could not be forced to recite it. The words "under God" were added in 1954 by then President Eisenhower, who stated at the time, "In this

Sunday, June 14th, is **Flag** way we are reaffirming the transcendence of religious faith in America's heritage and future; in this way we shall constantly strengthen those spiritual weapons which forever will be our country's most powerful resource in peace and war."



Kudos go out to Mike Giacoppo, longtime president of the Massachusetts Italian American Police Officers Association, who welcomed all present to the awards banquet.



Mad About Months

At the beginning of the month, I have a special ritual. I open to the new page on my desk calendar and look through the days of the month, decorating holidays or anniversaries with quirky doodles. Each new month is like an unwrapped gift, quivering with anticipation and a sense of mystery. Indeed, I have always been fascinated by months and, more importantly, their essence. In my mind, every month of the year has a unique character, an underlying trait that sets its days apart from those of other months. Holidays, saints' days, superstitions, family occurrences — all of these events add up to a rich and particular tapestry that typifies any month. During the olden days, when society was primarily based on agriculture, people viewed months as separate entities, depending on the weather and cycles of the sun and moon to help them plant. This is a much more romantic view than the way we perceive months in the modern era, when calendars are synonymous with busy schedules and frozen fruits allow us to eat out of season. I believe that we should reclaim the aura of uniqueness that surrounds each month, enjoying them for their own properties and emotions. For a model on

Take our current summery month of June. In Italy, the peasants of yore bequeathed a number of weather-related proverbs that looked ahead to the harvest of late summer, or simply commented on the climate that characterized the month. One saying declares: "Giugno ventoso, porta presto il grano sull'aia," meaning that a windy June will soon bring the grain to the farmyard. Another proverb, which reads "In giugno, in bene o in male, c'é sempre un temporale," warns that in June, no matter how good or baskets laden with pastel bad the weather has been, eggs. to the feast days of the saints, which dot the Italian calendar and provide people with a focus for religious devotion and a reckoning system for determining important dates in the agricultural year. Italians may repeat the rhyme "Per San Barnabá, il piú lungo della 'sta." This roughly translates that the feast day of St. Barnabas, or June 11th, is the longest day of the summer, referring to the fact that this date actually coincided with the summer solstice in the years before the Gregorian calendar reform. A charming yet slightly foreboding dictum declares: "La notte di San Giovanni, ogni erba nasconde inganni." This means that on June 23rd, the eve of St. John the Baptist's feast day, every herb hides some form of deceit — a callback to the old tradition of gathering herbs on this night. when it was believed that the magic of the summer solstice imbued them with mystical healing properties. Finally, other proverbs simply relish the bounty of nature available in June, such as "Giugno ciliege a pugno," which means that cherries are plentiful in June. What a lovely month these proverbs reveal!

Now, whenever I think of the months of the year, I try to focus on the exceptional qualities of each. January means deep drifts of snow and sparkling ice under an ever-lightening sky. February brings an explosion of red hearts and lace, and eerie masks for Carnivale. March is the month of green, of brisk winds and shamrocks. April recalls daffodils peeking out from the ground and storm! Other proverbs relate the first hints of summer

heat from a brightly shining sun. June is the end of the school year, a month of outdoor excursions and mysterious evenings eating out under the pale twilight of late evening. July includes fireworks bursting across a starry dark sky, trips to the rolling ocean waves or the energetic city. August is golden, like ripening grain, with mornings that smell like the woodsy charm of autumn. September means harvest and rhythm, red and yellow leaves and the glorious crunch of apples. October is synonymous with shadowy nights and glowing pumpkins, with the wind spookily whistling through bare tree branches. November simultaneously means the chill of early winter and the warmth of family gatherings, sharing an abundance of food. Finally, December envelops jingling bells and flickering candles, holidays of light and family and goodwill. Collectively, all of the months complement each other, adding to that indelible cycle

we call the year. This month, think of all the wonderful feelings and sensations that June brings to you, whether they relate to the summer season, a birthday or anniversary, or even a food you enjoy. We all would reap the benefits of living each month for its uniqueness, as this allows us to focus on the present moment and relish all the beauty that life and nature afford. Let us go on to look at each month not simply as a page on a calendar, but an opportunity ripe for celebrations and markings of the passage of time. That way, every month is a proverbial gift for us, granting us both the transience and endurance of time.

As a police officer, I do not condone the actions of bad cops doing bad things. All professions have bad apples. Over 27 years on the job, I ran into a few, but too few to count or worry about. There are bad surgeons, bad plumbers, bad bankers and yes more than a few bad politicians too.

Since last summer in Ferguson, we have seen a rush to judgment against law enforcement that would never be considered against other professions out there.

The deconstruction of our police departments by the media, community rabblerousers and high profile elected leaders has been a national disgrace. Starting at the top last summer with President Obama, former A.G. Eric Holder, NY Mayor Bill de Blasio and whats-hername, the mayor of Baltimore have been tearing down the police to the point that many wonder why they ever became police. Think about it, since all the copbashing, police officers have been getting killed much too often and when they do their lives matter not to anyone anywhere or at least that is how it feels.

THOUGHTS BY DAN ABOUT THIS & THAT

with Daniel A. DiCenso

MARIE ANTOINETTE

(November 5, 1755 - October 16, 1793)

A Victim of Circumstance



Oh the tragedy that was the life of Marie Antoinette. If ever there was someone whose life seemed headed for a tragic crash course almost from birth it was the fifteenth child of the Empress Maria Therese of Austria. Even if upon her birth on November 15th of 1755 her mother was open to anything other than her being Queen, the events of the following year sealed both the Empress's commitment to raising a future monarch and, sadly, the fate of Marie Antoinette.

The Seven Years War, which began the following year, proved a critical time for Austria as it found itself allied for the first time with France in its battle with England for colonial territory. It was a thin alliance, but one that Austria was determined to keep even after the end of the War in 1763.

During that time, the Empress took charge of Marie's schooling, always with the emphasis on the aspects (politics and etiquettes) that she would need to learn to one day be queen. The young Marie Antoinette, however, seemed to take more naturally to the arts than languages and traditional lessons. She often entertained the royal families with her harp playing and dance skills.

Marie Antoinette mentioned fearing her mother and, from the looks of it, had good reason to. The Empress afforded her little room for free-will and as the Seven Years War dwindled she arranged her marriage to Louis-Auguste, grandson of France's Louis XV. It wasn't until April of 1770 that the Empress sent her 14 year old daughter to meet her husband and on the way to becoming one of the most famous queens in history.

It's hard to tell what Marie Antoinette thought of this, given her free-spirited nature as a child. In France, however, the marriage caused a stir that may have taken her by surprise as many French citizens remained distrustful of outside unions

The main thing to recognize here, however, is the impossible responsibilities that were placed on the young bride. Here was a 14

year old woman who demonstrated little interest in politics and governing but with an affinity for the arts, thrown into ruling not only a country but a country that up until relatively recently had been Austria's enemy. She was, as can clearly be seen, a young woman set up to fail. In this regard, her execution can only be seen as a tragic inevitability. She was a scapegoat to the poor and struggling working-class of France, which was growing increasingly agitated with the structure of the French government toward the end of the 16th century. them, she was the symbol of everything that was wrong with the French monarchy and executing her was more a statement than a solution. It's hard to imagine Marie Antoinette understanding much of what was going on outside the palace or of the complex causes and solutions to poverty and inequality in a political system. Nor is it likely she had the political knowledge to find much of a solution. In the end, she was a clueless child put into a deadly situation they had no knowledge of how to control.

Tellingly the first years of her marriage to Louis XVI were occupied with frivolities which had little to do with the state of France. She preferred the life of parties, music, and social events more so than the court, parliament, and government. The poor French citizens were understandably enraged at the lavish expenses of the royal family while they struggled to feed their families, but the main thing to remember is that politics were never in Marie Antoinette's conscience and as offensive as her cluelessness may seem, she too remained in the dark about how her decadence was perceived. Neither she nor King Louis could have guessed that outside of their palace walls a revolution was brewing. To be sure, her joyous lifestyle also gave pause to the French aristocracy as did her inability to give her husband a child until eight years into their marriage when she gave birth to Marie Therese Charlotte.

As animosity toward the Queen mounted, she found happiness in her growing family. Between 1781 and 87 she gave birth to three more children. By all accounts she was a loving mother and devoted most of her free time to her children. But to the starving peasants, this was simply another excuse to ignore their situation. Once again, her eccentric behavior made her no friends amongst the nobility who spread gossip about her character out of spite.

Unfortunately, 1787 proved a disastrous year for the





royal family when a poor harvest season created a shortage of crops and made their cost prohibitive for many, bringing France (the most populous country in Europe at the time) close to bankruptcy. This, however, did inspire Louis XVI's first action in response to France's struggling Third Estate (the majority of the citizens, which were neither a part of the clergy or nobility) allowing them simply as much voting power as the noble-class majority.

We've seen this story over and over and continue to see it today. When a poor majority remains ignored they form a group which starts out with noble intentions before forgetting what they were fighting for to begin with. Case in point, after the Estate-General meetings in Versailles in 1789 where the nobility, the clergy, and the general populace united to reach a compromise, the Third Estate became the Jacobin Club, a more vocal and organized group than what they had been before. Of course, they started out simply as a look-out for the poor, fighting for better wages, more rights under the king, and better living conditions. But their impatience grew and they became increasingly violent, moving toward a full-fledged revolution inspired by the one they saw having success in America.

Of course, Louis XVI did little to prevent their radi-calization. When the nobility locked out the Jacobin Club from the Estate-General, they rebranded themselves as the National Assembly, meeting in private, defying the king's orders, and vowing not to back down until a new constitution was adopted.

A revolution was inevitable in the climate of France from early on and Louis XVI's tactical moves against the New Assembly (he swore to uphold the new constitution, the Declaration of the Rights of Man too late and by force, after the storming of Bastille) only added flame to the fire. The final breaking point may have been the King's dismissal of several Jacobin ministers, replacing them

Blessed Margaret Pole

Margaret was born at Castle Farley, near Bath, on August 14, 1473. She was the daughter of George Plantagenet, Duke of Clarence, and Isabel, eldest daughter of the Earl of Warwick (the king-maker), and the sister of Edmund of Warwick who, on November 28, 1499 under Henry VII, paid with his life the penalty of being the last male representative of the defeated Yorkist line of the Plantagenet family. He battled for the throne of England against the Lancastrian branch of the family in the Wars of the Roses.

About 1491 Henry VII gave Margaret in marriage to Sir Richard Pole, whose mother was the half-sister of the king's mother, Margaret Beaufort. At her husband's death in 1505, Margaret was left with five children, of whom the fourth, Reginald, was to become Cardinal and Archbishop of Canterbury, and also the indirect cause of his mother's martyrdom. Henry VIII, on his accession, reversed her brother Edmund's judgment, created her Countess of Salisbury. and an Act of Restitution was passed by which she came into possession of her ancestral lands: the king considered her the saintliest woman in England,

After the birth of Princess Mary, daughter of Queen Catherine, Margaret became her sponsor in baptism and confirmation and was later appointed governess of the princess and her household. As the years passed, there was talk of a marriage between the princess and Margaret's son Reginald, who was still a layman, but when the matter of the king's divorce from Queen Catherine began to be talked of Reginald Pole boldly spoke against the affair and shortly afterwards was forced to leave England. The princess Mary was still in Margaret's charge when Henry married Anne Boleyn, but when he was opposed in his efforts to have his daughter Mary treated as illegitimate he removed Margaret from her post, although she begged to be allowed to follow and serve Mary at her own expense. Margaret returned to court after the beheading of Anne Boleyn in 1536. It was during the same year that her son Reginald who had become Archbishop of Canterbury sent to Henry his treatise "Pro Eclesiasticae Unitatis Defensione that denied the Act of Supremacv which made Henry the head of the English Church. Henry imprisoned Margaret in the Tower of London for two years and beheaded her on May 28, 1538 at the age of seventy. Margaret was beatified in







EYE ROAST OF BEEF

4 pounds eye roast of beef 1 large onion chopped


2 chopped celery sticks

3 tablespoons olive, canola, or vegetable oil

1 beef bouillon Aluminum foil or roasting bag Salt

Heat oil in a skillet. Add chopped onion and celery. Simmer until onion is opaque. Remove onion and celery from skillet and place in a bowl. Add eye roast of beef to the skillet and sear all sides to retain juices in the meat. Cut a wide piece of aluminum foil in which to bake the roast. Place foil in roasting pan. Place seared roast in center of aluminum foil, or in a roasting bag. Gently add the oil from skillet. Place chopped onion and celery over the roast. Salt to taste. Cover roasting pan with aluminum foil to fully seal roast and contents (or place in a roasting bag). Bake in 350°F preheated oven for thirty minutes.

Meanwhile, add a beef bouillon cube to one cup of water and bring to a boil. Stir and turn off burner. Check roast after thirty minutes. Add a small amount of beef bouillon liquid and baste the roast. Cover and continue baking, basting every 15 minutes. Bake to tenderness of beef desired. (Approx. baking time — about 90 minutes)

Nanna & Babbononno

by John Christoforo

A Nostalgic Remembrance



Recently, I've been talking about cars. I think that my life-long love affair with old cars has something to do with the happy experiences of riding with Mom, Dad, Nanna and Babbononno so many times when I was a child. Each time we were headed to somewhere special. When we were all together in Dad's '37 Plymouth or his '49 Chevy, it was to visit people, to attend a wedding, a christening or an anniversary, all positive events. When it was just Mom, Dad and me in the car, it meant dinner at a restaurant or to visit one of Dad's musician friends, most of whom had kids my age. As I said, those old cars represented good times.

There was someone who hated automobiles, Babbononno. He was born before the auto era. As a child in Foggia, horses and donkeys were the means of transportation. When horseless carriages became automobiles and practical in his adopted land, Babbononno was pushing 40 and not about to learn how to drive a car. He could understand public transportation, the train, the trolley car, the bus. He didn't have to know anything about them except that you paid your fare and you could go from point A to point B with no problem. Just as an example, when he moved Nanna to East Boston from the North End in the early 1900s, he would go to work in the following manner: walk from Orleans Street to the ferry docks which were near Maverick Station. For one cent, he would take either the North or South Ferry to Boston and then walk to work or take a trolley car to where he was going. He would repeat the process on the way home with the possibility of stopping at a friendly place on either Hanover Street in the North End or in Maverick Square in East Boston and have a glass of wine or two.

Years later, his sons, Paul, Nick and Gino, all learned to drive. Paul and Nick became professional musicians which made it necessary to own cars to get to where their bands were playing. My mother, Angelina, never learned how to drive. Babbononno was old fashioned to the extent that he didn't believe that women should experience independence. Therefore, my mother wasn't allowed to

drive or finish high school, for that matter ... but that's another story. When she married my dad, a musician, there was another car in the family.

When Babbononno got a bit older, he relied on his sons, and later his son-in-law f or rides. When his sons moved away, my father was his chauffer. Unfortunately, there was one problem, Babbononno hated cars. He didn't understand them, how they worked, what made them run and how to drive them. As a result, every car he met hated him, too. As an example of what I mean, I would like to re-tell the story of Babbononno riding in Dad's '37 Plymouth to see Zi'Antonio one Saturday morning in the fall of 1948.

Babbononno woke me up one Saturday morning and asked me to drive him to his brother-in-law's house on the other side of East Boston, "Jenny, you take-a-me in la macchina a houza di Zi'Antonio? I wanna buy summa hizza vino." You can call this either Engliano or broken, no, fractured English. My reply was, "Babbononno, I'm only ten years old. I can't drive a car. You'll have to ask Dad."

He awakened my sleeping father and asked him the same thing. Dad agreed to the task only after a cup of coffee.

When we exited the house, I jumped into the back seat of Dad's 2-door Plymouth, and Dad climbed in behind the wheel. Babbononno held on to the open right door and attempted to bend down to enter and sit on the right front street. He didn't bend down far enough, hit his head on the roof line and knocked his fedora onto the side walk. As he picked up his hat, a barrage of profanity in two languages cursed Dad's car through eternity. He refitted his hat on his head, turned down the brim, carefully entered the car and slammed the door with enough force to rock the car. The closed window of that right door hit the brim of his hat and knocked it into Dad's lap. Again a few choice words that a ten-year-old shouldn't hear.

Once the door was closed, my grandfather held onto the door handle so tightly that the knuckles on his right hand began to turn red. Dad told him to hold on to the arm rest rather than the handle as it was a lot safer.

When Babbononno complied, we headed down the Eutaw Street hill and headed south on Meridian Street. When we approached Maverick Sq., Dad had to go left onto Maverick Street to get to Orleans Street where Zi'Antonio lived.

Chelsea Street ran parallel to Meridian with both ending at Maverick Square. As Dad began the left turn to travel on Maverick Street, Babbononno let go of the arm rest and grabbed the door handle. As a result, he opened the right door in the middle of a left turn. Centrifugal force came into effect and my grandfather started heading out the door. Dad reached over and grabbed Babbononno by the jacket collar and pulled him back in the car. As he did this, Babbononno reached over and grabbed the steering wheel for safety sake, but it prevented my father from moving it one way or the other. As a result, instead of taking a left, the car made a U turn onto Chelsea Street. Dad wrestled the wheel away from Babbononno but my grandfather fearing falling out, grabbed it again. The car made the U turn but wound up on the side walk on the right side of the street. Right near the beginning of that first block of Chelsea Street was Rapino's Funeral Home. A group of people were standing in front of the main entrance and Dad's car moving halfway on the sidewalk made them scatter in all directions.

When he finally regained control, Dad made me swap places with Babbononno. Climbing into the back seat produced the same problems: hat falling, hitting his head on something, curse words in two languages, you name it and it happened.

Babbononno then grabbed hold of the loop shaped strap that hung down from the pillar that separated the door window from the right side rear seat window. This he held onto for dear life until his hand was red again. Dad made a U turn, headed back to Maverick Square, took a left and then headed for Orleans Street.

When we arrived at Zi'Antonio's house, Babbononno sampled several glasses of his brother-inlaw's best home-made wine before he calmed down. From that day on, my grandfather rode only in the back seat of cars and only after he had taken his medicine, a glass or two of strong red wine. GOD BLESS AMERICA

Feuilants. Perhaps the most threatening danger that the Royal Family didn't see within the growing revolution was how easily it fell into the hands of extremists like Maximilien Robespierre, who saw no hope for change if the monarchy remained in place.

On August 10 of 1792, the Royal Family was arrested and put under the supervision of the New Assembly. In this climate there could have been no hope for a fair trial and their fates were sealed from the start. King Louis XVI was beheaded on January 21, 1793 after being charged with treason. Marie Antoinette's remaining children were taken away, one of them left to die of malnutrition in Temple Prison.

There was no question that the judges and jury wanted to execute Marie Antoinette and her trial was a mere show. Her own law-

with the more moderate vers spread false rumors about her and her family and, despite her appeal to other mothers in the court who could sympathize with her having lost her children, the judges decided to make a statement through her and sentenced her to death, a sentence carried out in October of 1793.

> It's not hard to sympathize with the anger of the French citizens and even their hatred of the Royal Family and everything they stood for. While a country starved to death a small minority, represented by the Royal Family lived in decadence and waste. At the same time, the young unlearned woman who became queen of a turbulent nation without say or foreknowledge can only be pitied. Through no fault or control of her own she was thrust into a deadly situation and made to pay for the sins of others by a mob desperate to make a statement.

AND THE REAL SHERLOCK HOLMES IS ... A book recently appeared in bookstores in the United Kingdom, authored by Angela Buckley, titled "The Real Sherlock Holmes," with a picture of the investigator right on the front page. According to the author, who owned a house on London's Baker Street, Jerome Caminada (the real name of the celebrated detective) used his sharp intuition, science, and various disguises while investigating criminals had Italian blood in his veins. The author Sir Arthur Conan Doyle of all the books on Sherlock Holmes was inspired, at the times, by this famous detective since the publication of the first book in 1887, with a mysterious title, "A Study in Red." Sherlock used his vast network of informers to unmask the criminals. He was able to capture 1,225 people in his career. Angela Buckley found out in her research that Caminada, not Sherlock, came out of the criminal world of Manchester's slums where he was born in 1844. He lost his Italian father when he still was a little boy, and lived with his Irish mother. His learning environment was the "streets," in the company of small criminals. At the age of 23 he joined the police, and his fine sense of intuition propelled him onto a brilliant career. Soon he was assigned important investigations, including organized crime and homicides. One day a young criminal, Bob Horridge, stole a watch, and Jerome (Caminada) was the detective who arrested him. Horridge never forgot Jerome's deed. He swore retribution. But when Horridge killed two policemen Jerome was put in charge of the investigation. A cat-and-mouse race evolved. Jerome was unable to come close to Horridge, he was always surrounded by bodyguards. However, the resourceful Jerome came up with a disguise that put him beside Horridge. Before the gangster realized what was happening, Jerome put a revolver on Horridge and arrested him. Ah, the heroics of the "good" Italian blood!

HARVARD SQUARE: THE NEW EMPIRE OF GERALD CHAN. This gentleman is one of the new billionaires in Hong Kong, the former British colony. Chan was a student at Harvard in his youth, and is now about to purchase most of the real estate surrounding the famous square in Cambridge. The first news of Chan's acquisitions was disclosed in an article published by the Harvard periodical Harvard Crimson, the noted publication of the student body. 
THE GLOVES ARE ALWAYS LOADED



Jack Dempsey

May 31st was the 32nd anniversary of the death of the great Jack Dempsey. On social media people marked the date by showing clips of Jack winning the Heavyweight Championship in brutal fashion from Jess Willard. In that bout Dempsey floored the giant Willard seven times in the first round administering one of the most severe beatings ever seen in a boxing ring. By the end of the third round Jess was unable to continue having suffered broken bones in his face and ribs. For years it had been rumored that Dempsey's hands were loaded (something heavy was put into his gloves along with his fists) for the fight. His former manager, with whom Jack had had a falling out, fed the flames by claiming to have taken part in the scheme. His accusations were driven by a desire to hurt his former champion. This controversy has been argued to exhaustion by fight fans over the years with most agreeing the fight was on the up and up, so I will not rehash the arguments here.

What has not been discussed much is the fact that in reality all boxers enter the ring with their gloves loaded, and I don't mean with just their fists. It is interesting to learn just why the boxing glove and the taping of the hands came into existence, as most people believe it was to make the sport safer. That couldn't be further from the truth. In reality, the boxing glove has made the sport more dangerous. I will give a very short history of how the boxing glove evolved and I think you will begin to understand what I mean.



The Cestus

The first version of a boxing glove appeared in ancient Greece. The boxers of that era found they were

breaking their hands when enough so they could land a hitting each other in the head, so they began wrapping pieces of leather around their fists as a way to give more support to the bones in their hands. The ancient Romans, being the innovators they were when it came to making sports more barbaric, started adding small spikes to the leather hand wraps in order to make them even more deadly. There is an excellent example of this hand wrapping, or what was to become known as the cestus in the remarkable statute of "The Terme Boxer" or as it is more commonly known "The Boxer at Rest" in Rome. I have written about this incredible work of art before and include a photo of it with this article.

I will now skip ahead a couple of millennia to the period in England when boxing started to become very popular. In the 18th century, James Figg, who has become known as the "Father of Boxing," began developing a style of boxing, that while quite different from what we know it as today, set the stage for what would later develop into the modern sport of boxing. Figg incorporated many moves from the art of fencing into the sport that was to become known as boxing. This early version allowed for punching, but that was not the main emphasis. Grappling was also a big part of what went on in these matches. One of the reasons for the lack of punching was the fact that the combatants would break their hands hitting each other on the head. Our hands are made up of many small bones that break and bruise easily. Just ask anyone who has suffered from carpal tunnel syndrome and they will tell you how delicate the human hand can be.

As the sport moved on into the 19th century, fighters continued to deal with the best way to avoid breaking their hands. In many ways boxing became more primitive as many of the fencing moves were lost and the grappling increased. Many of these later bareknuckle matches would last for hours as neither participant would want to take a chance on throwing a knockout blow until they were sure their opponent had slowed down

clean shot on the jaw, thus not injuring their hand.

Eventually, many of these fighters began wrapping their hands and wearing light gloves in order to allow

them the freedom to land more head punches without fear of hurting their hands.

As boxing moved into the 20th century, hand wrapping became much more sophisticated and the gloves improved quite a bit. At no point were the gloves improved with the idea of making the sport safer. They were further developed in order to allow for more head punching. This actually made the sport much more dangerous, for it was now possible for a large number of punches to be thrown at and landed on the head. This resulted in an increase of head injuries.

At the beginning of this article I stated that boxing gloves are always loaded. I will explain. If you have ever had your hands properly taped for a fight you will know that first a roll of gauze is wrapped around the hand. This is followed by having the gauze secured with a goodly amount of tape in order to keep it in place and to greatly strengthen the hand and protect the bones. Once this taping is done, that "loaded hand" is placed into a boxing glove which gives it even more protection. Take a well wrapped hand encased in a boxing glove and you can throw a full throttle blow at a brick wall and not hurt your fist. I have actually done that. Now, just think of how much harder you can hit another human being in the head with this set-up.

The modern boxer does not go into the ring with lead weights in his gloves, but he does enter the ring with a fist that is greatly enhanced for the purpose of causing more damage to the head.

Dempsey's hands were not illegally loaded the day he destroyed Willard, but I can guarantee you he would not have been able to land those head punches if his hands had not been wrapped.

The idea that somehow the boxing glove was developed to make the sport safer is a myth. The boxing glove, along with hand wraps, have made boxing more dangerous. An argument can be made that if you wanted to make boxing safer you would ban hand protection.
