NFL Suspends Brady Four Games for Under Inflating Footballs

In a move that sent shockwaves throughout the New England region and promises to change the landscape of the upcoming NFL season, Tom Brady, arguably the greatest quarterback in the history of professional football has been suspended for the Patriots first four games of 2015.

The ruling, released on Monday stems from the underinflated footballs scandal that formulated following the Patriots 45-7 demolition of the Indianapolis Colts in last January's AFC Championship game. Over the course of the past three months, the NFL entrusted Criminal Attorney Ted Wells to oversee the investigation into the matter. The report found that it was "more probable than not" that Brady ei-

ther knew of or ordered the deflation of footballs.

Including the Brady suspension, the Patriots organization has been fined \$1 million and were stripped of 2016 first round and 2017 fourth round draft picks. The \$1 million fine is the largest imposed in NFL history.

In no way does the following serve to defend the Patriots; far from it. They have pushed the envelope extensively during the

Bill Belichick era. They were caught illegally taping opponent's signals in 2007, this after the league sent out memos to all 32 teams to cease and desist from the practice. During the Wells investigation, Brady and the



organization were not as willing to hand over evidence as investigators would have liked. Belichick and the Patriots are no angels, but this ruling wasn't needed to amplify the Patriots transgressions. However, what it does do is magnify the hypocrisy of NFL Commissioner Roger Goodell and

Where do I start? First of all, Goodell and the league come out of this sorry episode looking like absolute jokes. They wasted no time in disparaging the Patriots in the weeks leading up to the Super Bowl, a game whose outcome must have eaten away at Goodell (Thank you Malcolm Butler!)

They dragged the name of the preeminent franchise of the past 15 years through the mud and reduced Tom Brady to nothing, leaking stories that labeled him to be dishonest, a liar. Former Tampa Bay Buccaneers Quarterback Brad Johnson admitted to having paid to have the footballs he used prior to Super Bowl XXXVII doctored to his lik-

Stirpe Nostra

A weekly column highlighting some of the more interesting aspects of our ancestry . . . our lineage . . . our roots.



MUSEUM

A good knowledge of Greek and Roman mythology is necessary in order to understand why the ancient Romans built all of those beautiful temples. Since that time we have been examining the legends surrounding the various Greek deities and their Roman counterparts. Last week we covered the Muses, those nine goddesses that became the representatives of epic poetry, history, lyric song, dancing, erotic poetry, sacred songs and astronomy. We now examine the origin of the word museum and identify it as originally a temple of the Muses, then as a place dedicated to the work of the Muses.

The most celebrated museum of antiquity was established in the ancient city of Alexandria (Egypt), early in the third century B.C. It was a spacious and magnificent edifice that contained a library, observatory, public lecture rooms, dining rooms for the professors, botanical gardens, and zoological gardens. The structure was built near a beautiful temple of the Muses. Scholarly men were supported by the State and permitted to devote their full time to teaching and additional study without interruption. These scholars fell into four academic groups letters, medicine, mathemat-

ics, and astronomy. As many as 14,000 students were also in attendance. The institute continued to be the center of learning under many of the emperors during the Roman domination, but finally, about 200 A.D., the Roman Emperor Caracalla confiscated the pension fund that was reserved for the professors, and the structure was completely destroyed about 75 years later during the civil wars which occurred while Aurelian was emperor.

There is little doubt that most of the museums which were founded during later years took much of their design and operating principles from the Alexandrian Museum. The Vatican in Rome, for example contains the most splendid of the public museums in the world today. The displays originated

with the works collected by the Renaissance pope and were continued by all other pontiffs. They enriched the collections with more than 200 works of art and then built new buildings to contain those collections. Even today while wandering through the galleries, it is difficult to decide whether to admire the magnificence of the collections or the beauty of the buildings in which they are housed.

Magnificent collections are also contained in other Italian museums, such as the Palazzo dei Conservatori, which houses the famous Wolf with Romulus and Remus; the Capitoline Museum, which houses busts of the Roman emperors and other celebrated men of antiquity; the Museo Nazionale at Naples which is famous for its Pompeii collections; and the Galleria degli Uffzi at Florence which houses the Venus de' Medici.

Still other famous museums of the world which cannot go unmentioned are: the Louvre in Paris with its Venus de Milo and Mona Lisa; the British Museum in London which houses the Elgin Marbles, and the Royal Museum in Berlin which contains objects found at Trov.

Not Machiavellian at All

Niccolò di Bernardo dei Machiavelli (May 3, 1469 – June, 21 1527) was an Italian historian, politician, diplomat and philosopher. He was a high official in the government of the Republic of Florence during the times when the Medici family governed the republic.

He wrote several books and it is from the content of one of his books, *The Prince*, that we get the adjective **Machiavellian**, which *dictionary.com* describes as "characterized by subtle or unscrupulous cunning, deception, expediency, or dishonesty." For example —

In Chapter 5 he advises the conquering prince that a conquered republic must be utterly reduced, because history shows that more clement treatment fails to hold the territory.

In Chapter 7, rather than condemning, he cites the notorious Cesare Borgia as one to be imitated.

In Chapter 8 he says that a prince who rises through wickedness may, nevertheless, hold his principality securely if injuries are inflicted all together and not spread out over time.

In Chapter 15 Machiavelli advices the prince to follow vice if so doing brings security and virtue would bring ruin.

In Chapter 17 he says it is better to be clement than cruel, however, some cruelty is necessary and justified to maintain order and to withstand the violence that will break forth when there is not firm leadership.

In Chapter 20 he says that sometimes it's a good idea to pick a fight with another prince, just so you can look good when you defeat him.

If the only thing from Machiavelli you read is *The Prince*, then you might well conclude that his political philosophy is diabolical. That would be unfortunate, for Machiavelli's writings in support of republics and of freedom are much more extensive than his one, thin volume on how a prince may conquer and hold territory.

The key to understanding Machiavelli's The Prince is in the final chapter. It's a call for a reunited Italy, free of oppression by foreign occupiers. Italy was cut up into several city-states that were constantly at war with each other. The French and the Spaniards seeing opportunity invaded and ruled extensive tracks of the peninsula. Machiavelli dedicated the book to Lorenzo di Piero de' Medici (September 12, 1492 - May 4, 1519) the ruler of Florence, and exhorted Lorenzo to raise an army, drive out the foreigners, even if that meant crushing some of the independent republics and principalities. To Machiavelli, the choice was clear, either the nominally independent states would be forever in peril from each other and from foreign invaders, or they could lose their independence but gain freedom. Lorenzo did not take up Machiavelli's cause of a united Italy, and Italian reunification had to wait until the 19th century.

I met Andrew Biggio a few years ago at the 3rd Annual Wounded Vets Ride. He had an idea five years ago to raise needed funds so that the family of a fellow Iraq war veteran could adapt their home to meet their son's physical needs. Then a movement was started as the 23-year-old Marine got the word out among fellow motorcycle riders and a movement was born. Five years ago, 400 riders showed up and each year the number of riders grow. This year, the number was estimated at 6,700 riders. This past Saturday morning, May 9^{th} , there was Biggio standing on the usual flatbed trailer in the parking lot of the new Harley-Davidson dealership in Revere. Thousands and thousands rode from as far away as California for this year's 5th annual Wounded Vet Ride. Said Biggio, "It has gotten bigger than I ever could have imagined. This year's ride wound its way to towns up in the North Shore and ended up as usual at Suffolk Downs where Governor Charlie Baker waited to welcome all the riders. Baker noted, "I think (the ride) is a wonderful way of expressing support for those who have given so much."

As Peter Gelzinis stated in the Sunday Herald, "For a few hours yesterday (May 9th) a dormant East Boston racetrack came alive with ... stories of heroism, sacrifice and recovery."

Andrew Biggio is the commander of the ITAM Post 6 in East Boston and an outspoken advocate of veterans and their special needs. I was impressed with his energy and I am now a member of his Italian American Veterans Post.

As Vietnam veterans replaced the old World War II and Korean veterans in the veterans community, today more and more Iran and Afghanistan veterans move into leadership positions in the American Legion, VFW and the ITAM posts.

Andrew Biggio continues to serve his country today as hard as he served on the battlefield yesterday.

He retired after 40 years with the Boston Public Schools. While teaching, John ran a small business and commuted back and forth to Hollywood as an actor/model. All these years, John was also an accomplished professional musician.

He is deeply involved in Boston's Italian community. He is the Chairman of the Board of "October is Italian Heritage Month." He has been an officer in the Renaissance Lodge of the Sons of Italy for 25 years. He has also served as a Sons of Italy State Trustee and Treasurer. He holds the most prestigious award given to achievers in Boston's Italian community, the Pirandello Lyceum's "I Migliori in Mens et Gesta," the best in mind and

Baltimore — a Case Study in Racial Perceptions

watched the recent unbridled violence on the streets of Baltimore following the funeral of Freddy Gray who ended up dead after getting arrested. The prosecutor in the case charged all six police officers who were involved with the arrest of Mr. Gray. The driver of the police transport van was charged with second degree murder and the other five officers with manslaughter. The decision to bring charges against these officers brought people out into the streets to celebrate, because most of those happy with the news appear to have already judged all the officers as guilty without even knowing any of the facts. It is clearly a rush to judgment by many in Baltimore.

Comments so different don't surprise me and only provide clues as to how each of us process information and add our own perception to it. In the case of the Baltimore police, as Kathleen Parker, a syndicated columnist observes "... In this case, as in too many others involving police, perception seems to be black and white."

Too often reality is clouded by our own biases, mostly unintentionally. Mayor Stephanie Rawlings-Blake of Baltimore stated, 'We know that Baltimore continues to have a fractured relationship between the police and the community ... We have to have a foundation of trust."

My own self, was relieved when I found out that three of the cops were black. I still remember that the O.J. Simpson jury wouldn't convict him of murder and that the black jury let him walk regardless of the evidence. I thought they proved him guilty beyond a reasonable doubt. Blacks backed that jury's not guilty verdict while most whites thought he got away with murder.

In this most recent Freddy Gray case, it was clearly not a racial act, since after all, as I previously stated three now, we hear the latest. or white? Was it ever?

I am sure that all of us These police aren't racist, they are police who view those they deal with as scum regardless of color. If all the cops had been white, you can bet that Rev. Al Sharpton would be pushing the race card.

I grew up in the projects of Roxbury in Orchard Park back when the place was still pretty diverse. Growing up I had friends, not white friends or black friends. It was different, and looking back from today perhaps a better time of racial growth. However, when you left my world for the larger world, you did wonder.

I still remember a trip I took to see friends in Natick out in Metro West. We took the MBTA Riverside streetcars to a private bus company. As we were walking around the town common, a cruiser drove up and stopped. The sergeant began questioning us as if we were perps or something. Did I mention, I was with two black friends of mine? He advised us he had gotten reports about us and askedwhat we were doing in his town. We told him we were meeting up with some friends from his town, but he didn't seem to care. He advised us to board the next bus out of town for the Riverside streetcar back home.

My brother and I completely didn't understand what had just happened, but my black friends laughed and said the police encounter was about them not us. That was my first time I really understood why some of my black friends had a chip on their shoulder. I would too had I been in their shoes. My friends took such things for granted, I didn't. They were used to it, I wasn't.

I would hope that 50 years later things would have gotten much better, but in many ways stereotypes continue as do assumptions. Forget what tears us apart and find ways to bring us together. Baltimore shows how far away from that dream we still are.

Perceptions, if they die, die of the cops were black. So hard. Is anything really black

"Mothers & Sons" **A Very Powerful Production**

From first moments of Terrence McNally's "Mothers & Sons" your emotions are stirred up. Katherine Gerard (Nancy E. Carroll) has stopped in to visit Cal Porter (Michael Kave) at the apartment he shares with his husband and son on Manhattan's Central Park West. It is December 21st. They are enjoying, no that is not the word for it, taking in the beautiful view of Central Park outside the windows. Katherine has a heavy fur coat on that she seems to using for protection. Her face looks like it would break if you touched. She is angry and cold. Cal is trying to make her comfortable, but is having no luck. It turns out Cal was Katherine's son Andre's partner years ago in the days before gay marriage was legal. Andre died of AIDS and Cal and Mrs. Gerard have not seen each other since the memorial service for her son. I could sense that many in the audience at the performance I attended, fittingly on Mother's Day, felt hate and anger for Mrs. Gerard from the moment they saw her. She had not been able to deal with her son being gay and having died of AIDS. She repeatedly uses the word hate to describe so many of the people and things in her life. My feelings towards her were more of pity. She grew up in a different time and just couldn't understand all that had happened. She was filled with hurt and confusion. Cal is doing his best to ease the tension but with little success.

This play is deeply powerful. It is emotionally draining to watch as you see and hear Cal and Katherine talking past each other for so long as they start to open up very

slowly about their pain. Cal's ies to his friends. They husband Will (Nile Hawver) and son Bud (Liam Lurker) walk in as this back in forth is taking place. Will is much younger then Cal but mature. He is doing his best to handle all the talk of Cal's former partner whom he knows Cal was deeply loved. He is jealous but understanding. Bud is an upbeat young boy who seems, in an innocent way, to grasp much of what is going on and to show kindness to Katherine who starts to soften.

As the tension builds and then abates just a bit only to return even more intensely I was wondering if this situation could ever resolve itself. Fortunately, Mr. McNally added just enough humor to keep this play from becoming unbearable. Believe it or not, it is actually quite funny at times. There were tears and laughter all through it.

Nancy E. Carroll is positively outstanding in her role as Katherine. Her performance contains so much emotion. The hate and bitterness that is driven by hurt and loneliness, by the feelings that she was never able to understand all that had happened and was grappling with the question of whether everything was her fault. Once Katherine's story is told it is possible to feel for her. In a very telling line she tells of how when Andre was young she would give cook-

always referred to her as "Andre's mother". She wanted to be called Katherine and felt deprived of closeness with the children because this did not happen. She has felt alone for most of her life with the exception of the time she raised Andre, only to see him move away and live a life she just could not understand.

Michael Kaye gives a convincing performance as Cal who's own anger shows as he tries to explain what it was like being in a love with another man during the period when AIDS was ravaging the gay community and how he cared for Andre during his slow and painful journey to


death. Nile Hawver and Liam Lurker are perfectly suited for their roles as Will and Bud. There is not a moment in this play when my mind wondered away from what was happening on the stage. I was deeply engrossed in the roller coaster ride of emotions it took me on.

Does the situation get resolved? We really never get to know, but there is hope at the end. In the talk back after the play Nancy C. Carroll referred to what she called "The Oreo Moment" in the play when Katherine and Bud share Oreos and milk while Bud tells her a story. There is hope.

Don't be scared away from this play because of the dark parts I have described. While it is emotionally stirring, it is also a touching, funny, and thoughtful play. I have said this before about a SpeakEasy production, that when you leave you will be reflecting for quite awhile about what you saw. That is a good thing, and makes this fine performance worth seeing. I highly recommend it

Saint Simon Stock

Saint Simon was born in England in the early thirteenth century. Little is known about Simon Stock's early life, legend has it that beginning at age 12, he lived as a hermit in a hollow trunk of an oak tree. It is also believed that, as a young man, he went on a pilgrimage to the Holy Land where he joined a group of Carmelites with whom he later returned to Europe.

In 1254 he elected Superior-General of the Carmelites at London. Simon Stock is remembered for an apparition he had in Cambridge, England, on July 16, 1251, at a time when the Carmelite Order was being oppressed. In it, the Virgin Mary appeared to him holding the brown scapular (Scapular of Mount Carmel) in one hand. Her words were: "Receive, my beloved son, this scapular of thy Order; it is the special sign of my favor, which I have obtained for thee and for thy children of Mount Carmel. He who dies clothed with this habit shall be preserved from eternal fire. It is the badge of salvation, a shield in time of danger, and a pledge of special peace and protection."

Under his leadership, the Carmelites became widely spread in southern and western Europe, especially in England; above all, he was able to found houses in the university cities of that era, as in 1248 at Cambridge, in 1253 at Oxford, in 1260 at Paris and Bologna. This action was of the greatest importance both for the growth of the institution and for the training of its younger members. He passed away in Bordeaux, France on May 16, 1265. Saint Simon Stock's Feast is celebrated on May 16th.



AMERICA IS A BEAUTIFUL ITALIAN NAME

Parla Come Mangi!

(Speak as You Eat!)

Benvenuti! The arrival of the warm weather inspired me to "drive" south to the region Campania but instead of driving along the breathtaking Amalfi coast or stopping for a pizza, caffe' e limoncello a Napoli, I have decided to pay a visit to the fertile plains of the Volturno river, southwest of Naples in the area between Salerno, Eboli and Paestum, where the many black water buffalo farms make me wonder whether I am in the midwest instead. Campania is the land of mozzarella di bufala (buffalo mozzarella) an Italian food excellence recognized with the DOP mark of protected denomination of origin. Neither pizza napoletana nor insalata caprese would taste the same without mozzarella di bufala. Mozzarella gets its name from the actual process of cutting or chopping off (mozzare) the milk paste into balls, braids or other shapes. The paste is formed by stirring and kneading the pieces of curd produced after the separation of the milk's protein. Mozzarella in carrozza (mozzarella in a carriage) is one of the most traditional dishes of Campania - a slice of mozzarella fried between two slices of bread. It is found on pizzeria menus throughout Italy but is usually made with fior di latte (milk flower) a fresh soft cheese made from cow's milk instead of buffalo mozzarella. The original recipe calls for genuine mozzarella di bufala as it has a higher fat content and it is much less watery so it will stay between the slices of bread without leaking out when fried. Veramente deliziosa! (truly delicious).

Mozzarella In Carrozza (Serves 6)

6 eggs 1 ½ lb buffalo mozzarella (or fior di latte) Salt Milk Flour Vegetable oil for frying 1 loaf Italian bread

Preparation: in a bowl beat the eggs together well with some salt and a little milk. Cut the bread into 12 slices, each about ½ in thick. Cut the mozzarella into 6 equal slices. Place 1 piece of mozzarella between two slices of bread to make 6 sandwiches. Coat each sandwich in flour and soak in the egg mixture for a few seconds. Fry in hot oil until golden brown and serve hot. Buon appetito!

700 g di mozzarella di bufala 3 иога (o fior di latte) Sale Latte Farina 1 filone di pane Olio vegetale per friggere

Nanna & Babbononno

A Nostalgic Remembrance

Exactly 24 years ago today, May 15th to be exact, the first story called Nanna and Babbononno appeared in this paper. When it began, I was not a novice at writing. Several years before, the Director of Vocational Education of the Boston Public Schools had asked me to head up a new project. A growing number of patients in Boston hospitals spoke only Spanish, but almost all of the medical personnel did not. I wrote a book for them called Spanish for Medical Personnel. It was a book that taught the reader how to speak the language, but with the conversational end centered around all things medical. Using my text book, I actually taught a course or two at Boston State Hospital, when it existed in Mattapan.

A decade later, I was at the Boston Musicians' Union when the then president approached me asking me if I knew a particular musician. When I replied that I didn't know the man, I asked why he asked. Sam Marcus, the then president stated that the man had passed away. My comment was, "Well, if he was your friend, my condolences." Sam replied with, "No, that's not why I mentioned his name. If you've read our monthly magazine, you've probably read his column called A La Breve. I was familiar with the column, but never connected the deceased man's name and the magazine. Sam, at that point, asked me to take over the column. Considering that I was a 3rd generation musician in my family, I took over the column which was a commentary on Boston musicians and the local music scene. Babbononno, Dad, Uncles Nick and Paul helped out with stories of the '20s, '30s and '40s, when Boston was in its entertainment heyday.

In the spring of 1991, I met Pam Donnaruma at a Renaissance Lodge get together. Dean Saluti had become the lodge President and I the orator. We were on a recruiting campaign and I was introduced to Pam. I had remembered the paper when it was called La Gazetta. Babbononno would bring it home once a week and read it to Nanna who couldn't read or write. He taught me how to read Italian and after I was proficient in the language, he would give me the paper once he was he finished with it. He

would do the same with "Il Progresso," the national Italian paper, and the *Boston Post*, a great local paper that published its last edition in 1955.

Dean mentioned to Pam that I was a writer for the musicians' union magazine and Pam and I talked about me joining the staff of the Post-Gazette, which was being published in English by then. A writer had just left the paper and they needed a column to fill the space that, otherwise, would remain blank. I said OK and then began to wonder what I was going to write about. I knew that speaking Spanish in Boston hospitals was not something of interest to the Italian readers, and neither would they be interested in the inner workings of Boston's music scene, which included bios on some of the famous and infamous local musicians past and present.

A day later, I sat with my father and Uncle Nick discussing what I could write about that might be of interest to the people that read this paper. All of them were in agreement. I should write nostalgia, stories about growing up Italian or Italian American (no hyphen). They all started reminiscing about the Sunday dinners, how the family managed during WWI, the Great Depression, WWII, and the successes each generation experienced beyond these tragic times. My memory is such that I remembered just about every event in my life as if they occurred just yesterday. And so, on Monday 11th of 1991, the first story entitled Nanna and Babbononno appeared in this paper. It centered on Babbononno. Most of my stories from that point on were centered around him and Nanna, my mother's parents. Due to problems in the family, I didn't meet my father's parents until I was about eight or nine years old, but that's another story.

That May 15th story detailed Babbononno's arrival in America in 1896, actually, the year this paper came into existence. He was a young man who had joined the Royal Italian Marine Corps and became the timpanist in the Marine band.

It seems that there was a tradition started by President Thomas Jefferson that ended after Harry Truman left office. Once a year, the Royal Italian Marine Band would

serenade the brass in Washington, D.C. Babbononno, or should I say Michele Contini, was in that band playing drums. While here he was notified by the Reuter's Service, an international cable company back in the day that his young wife died during child birth.

When the band headed back to Italy, he did not. He left Washington soon after the band's departure and headed for New Orleans. Fearful of the treatment of Italians there, he left and headed north to New York. New York was too busy for him and he headed for Portland, Maine, which at the turn of the 20th century, was just an outpost of civilization.

Next he headed to Boston and wound up in Boston's North End district, which back in the day was mix of Jewish, Irish and Italian. Stopping at a coffee shop, he struck up a conversation with a man named Antonio Ceruolo, Ceruolo and three other Italians shared an apartment on Salem Street, but one of the men was leaving to get married. Babbononno was asked if he was interested in taking his place. He was and moved in that same day. Antonio Ceruolo was a plasterer who did hand carved scroll work long before there were forms that did the same thing. As a result of his talent, he was well paid, a financial base that allowed him to send for his siblings, one by one, from Avellino.

Michele Contini had been trained to work with wood, and soon found a day job building and finishing furniture. He was able to hook up with an Italian band and worked both day and night. In the process, he decided to Americanize and learned to read, write and speak English. His first name was spelled the same as Michele, a woman's name. So, he changed his name to English, and he became Michael Contini.

Antonio Ceruolo showed him a picture of one of his sisters who was slated to be the next sibling of his to head to America. Michael liked her looks and accompanied Antonio when he headed to New York to pick her up at Ellis Island. When he met Giovannina, it was the beginning of a love affair that would establish my family in the United States. Changing her Italian name to Jenny, she and Michael were married at the Mt. Carmel Parish in East Boston, a section of Boston where they would eventually live and raise their family, Paul, Anne (my mother) Nick and Lou.

I know that many of you have similar stories regarding your own families, and all I can say is thanks for being so loyal to this column and may GOD BLESS AMERICA!

ing. Just this past November, the Minnesota Vikings were found to have heated footballs on their sidelines. The leagues reaction in November was the equivalent of please don't do it again.

"You can't do anything with the footballs in terms of any artificial, whether you're heating them up, whether it's a regular game ball or kicking ball, you can't do anything to the football," said NFL Vice President of Officiating Dean Blandino. "So that was noticed during the game, both teams were made aware of it during the game and we will certainly remind the clubs as we get into more cold weather games that you can't do anything with the football in terms of heating them up with those sideline heaters.

the "integrity of the game" as Brady. Rice was suspended for only two-games. Goodell later admitted that he erred in his lenient judgment of Rice. But how could he have? Security tapes caught the entire beat-down on film and Goodell had the opportunity to view it prior to his decision.

Make no mistake, Goodell sought out to make an example of the Patriots and Tom Brady. He and the rest of the "best and the brightest" on Fifth Avenue had to make up for the Rice situation and the many, many others they got wrong since he took over as commissioner in 2006. Ol' Rog had to flex his muscles and he had the ideal situation to do so in front of him. He had to satisfy the rabid masses, which he created and cultivated by his initial reaction in January. SEAN STELLATO:

Tackling the Cut Throat World of Sports Agent with Familial Approach

From his Wellesley, Massachusetts office he manages his life in the same regimental pace he grew accustomed to on the gridiron. Long hours, are labors of love for a man that ventured outside the life of helmets and pads over 10 years ago, but never really left the game he loves.

Sean Stellato, author and President of SES, LLC. (Stellato Enhanced Sports) is a proud Italian-American and Salem, Massachusetts native who has become a highly-respected sports agent with clients scattered across the National Football League landscape as well as here locally with the Super Bowl Champion New England Patriots.

Unlike many of his peers, Stellato promotes his clients by giving them a "small town," up close and personal treatment.

"When I came into the league I didn't have the biggest name and didn't want an agent that would treat me as such," said client Jonas Gray, running back for the Patriots. "From day one, Sean has been all in for me; everyday he's there for me."

The backup quarterback and placekicker in his Salem High School football days, Sean petitioned his coach Ken Perrone for a chance to prove himself on a full-time basis. That season would end up being a memorable one for Salem. That 1994 season is the basis for Stellato's second book *No Backing Down*, written by which was foreworded by another local football legend Doug Flutie.

Following Salem High School, Stellato made his

way down to Connecticut to attend highly renowned preparatory school, The Gunnery during his postgraduate year. After that year at Gunnery, Sean was ready to bring his talents to Marist College where he excelled in Division I football and basketball. At Marist, Sean knew he wanted to pursue a professional career on the gridiron, an opportunity that presented itself in the Arena Football League. But first Sean would need to learn a new position.


During a two-year stretch between 2002-2004, Sean called the AFL home, converting to wide receiver and defensive back while playing for the Florida Firecats, Louisville Fire, Memphis Explorers and New York Dragons. It was life in the Arena League that inspired Stellato to make a foray into the world of player marketing as a sports agent.

"I got into the pros and hired agents, but never felt that personal attention. Hearing stories from teammates and other players broke me up and hit me hard."

In 2013, two groups that hold a special place in his heart recognized Sean with an induction into the Salem High School Hall of Fame along with high school Coach Ken Perrone as well as the Italian American Sports Hall of Fame, honors he dedicates to his family and heritage." Vellano, a defensive lineman with the Patriots and another Stellato client believes it was this family centric athmosphere that led him to Sean. "Being Italian myself, family is key. 

ALI vs. FOLLEY Another Phantom Punch?

March 22, 1967 would turn out to be the date of Muhammad Ali's last bout for three years. He had been classified as 1A by the draft board and ordered to show up for induction in the coming months. Before the bout Ali spoke about this possibly being the last time for the public to see him in the ring "Live and in living color". The bout was held in Madison Square Garden and his opponent was the veteran contender Zora Folley from Chandler, Arizona. The fight was televised on home TV, so it was guaranteed to be seen by a large audience.

As a young boy I remember watching the fight, and what stands out in my memory from that night was the fact that, even at such a young age, I thought there was something odd about what happened. I didn't know what, but it just seemed that things weren't quite right.

Looking at a recording of this fight, now I know why I felt that way. There were a number of things that went on before, after, and during this fight that were not typical of a Muhammad Ali fight.

For one thing, this was one of the only black opponents whom Ali faced where he didn't demean him and come up with some disgraceful name for him. He a definite lack of urgency to called Ernie Terrell an Uncle Tom, Floyd Patterson a rabbit, and Liston was the ugly bear. In the future he would use the term gorilla to describe Joe Frazier and also call him an Uncle Tom. Ali showed no restraint in using racist language to insult his black opponents.

With Zora Folley he took a very different tone. He was subdued and spoke respectfully of his challenger. He brought up how Folley was a good family man with many children. This was a very different Ali. Even after the fight he continued to praise him and even reached out to one of Zora's sons telling him to be proud of his father.

If Ali's behavior seemed odd, things were also a bit strange in the Folley Camp. Historian Mike Silver visited the gym where Folley was training and describes the atmosphere there as being filled with "... an air of depression." Even though Zora was past his prime and getting his first shot at the title late in his career, he should have been embracing this moment. Finally, his dream of fighting for the championship had come true. Silver mentions others who didn't get a chance until very late in their careers; fighters like Jersey Joe Walcott and Archie Moore, both of

whom went all out once their long overdue opportunities finally arrived. There was none of this excitement in the Folley camp.

On the night of the bout Folley entered the ring quite a while earlier then Ali. He just remained seated on his stool while former champs and current contenders were introduced to the crowd (a great tradition that is now lost). When Ali made his entrance, Folley finally got up and loosened up a bit, but not much, odd behavior for

a slick boxer who would normally want to break a sweat and be loose before the opening bell. Zora looked more like he would rather be someplace else then in the ring. It wasn't a look of fear, but rather one of resignation. This was also strange behavior coming from a veteran of over 80 fights who had been in with most of the top contenders of his day including Sonny Liston whom he showed no lack of confidence with.


The fight itself looked almost surreal. Ali danced and circled for the first three rounds while Folley jabbed to the body and threw a few right hand counters that grazed Ali's chin. There was Zora's moves, but I suppose that can be attributed to patience as he was a methodical boxer, though I think it was something else. Those three rounds could be given to Folley but more because of the lack of any aggression on the part of Ali.

The fourth round was interesting. Ali hit Folley with an overhand right that did not seem to carry much power, and Zora went down flat on his face. He appeared to be out cold, and usually when a fighter is stretched out like that he is unconscious, but miraculously, at the count of four Zora suddenly came back to life. He did a push up and got onto one knee. From that position he carefully listened to the referee count to nine before getting up. He was clear as a bell. I have never seen

anything like this since. This seemed more like something from pro wrestling than boxing. Was Folley thinking of taking the full count and then had second thoughts? That's what I believe.

Once he regained his feet, he went right after Ali landing a good right that he did not follow up on. It was the only time in the bout where it looked like he wanted to really win, but it was short lived.

The next couple of rounds were fairly slow though Ali did pick up the pace and won them. Between the sixth and seventh rounds, Ali's manager Herbert Muhammad climbed up to the champion's corner and whispered something in his ear. Afterwards, Ali would say that Herbert told him to stop play-

ing around and get to work. In the seventh round Ali came out and hit Zora with two overhand rights that were carbon copies of what he threw in the fourth. Again, Zora went down on his face, and again he came back to life, only this time instead of taking a knee he stumbled around the ring while the referee counted him out. He left the ring quickly after the announcer gave the official time of the ending of the fight.

In a New York Times wire story filed after the fight, Robert Lipsyte described the punch that floored Folley as a phantom chop and compared it with the punch that dropped Liston in Lewiston, Maine. Ali himself briefly described it as the Anchor Punch, the term he had used for the blow he hit Liston with. He quickly backtracked on that statement. MSG matchmaker Teddy Brenner later wrote "He seemed to be an awfully good swimmer when he fought Ali."

After watching this fight a number of times, I believe Zora Folley took a dive. Why would he do that? Well, it is pretty well known that most of Ali's opponents received death threats before facing him. I think this happened to Folley and that it really had an effect on him. I think the Zora Foley who stepped into the ring that night was in fear of his life. Not because he was facing the fists of Ali, but because of what went on leading up to the fight.

HOOPS and HOCKEY in the HUB

Once they faced each other on the court — in friendly games of tennis. Of course, that was not their main athletic endeavor.

No, these two played another game with sticks, just as they did when playing tennis back in those days — the era when racquets were also made of wood.

So, back and forth they would go, volley after volley. And, of course, it had the feeling of being somewhat different. Here they were outdoors on warm weather days when their chosen line of work called for them to be indoors on cold winter ones.

Yes sir, those were the stress free times for the off season days back in the late 1940s and early 1950s for these two hockey teammates playing north of the border. It was the days of the Original Six in the National Hockey League, where each team had only five opponents and trades often meant that you were now playing with someone you had played against (and perhaps fought with) just a few days earlier.

It was a time when everybody knew everybody else in hockey. Many of the fans in the Hub were on a first-name basis with the players on the visiting teams that stayed at the old Madison Hotel that was located right next to the Garden — on the spot occupied today by the O'Neill Federal Building.

Thus it was that these two hockey lifers spent about eight months of the year playing a game where the object was to put a puck in the net, not to send a ball over them. That time on the ice proved to be the main source of identity and income for one Maurice "The Rocket" Richard and Hal Laycoe.

Richard was revered in Montreal and would go on to play 18 years for the Canadiens. By contrast, Laycoe had started his NHL career with the New York Rangers and had been sent to the Habs via a trade for the start of the 1947-1948 season. There he would remain until 1951 when he would come to Causeway Street and finish out his career with the Bruins, retiring at the end of the 1955-1956 campaign. Along the way, he helped the B's reach the Stanley Cup Final in 1953.

Look on the internet and you will see something amazing — an image of Laycoe skating in his Bruins uniform while wearing glasses — all this in an era where players took to the ice without helmets, visors or even mouthpieces. It was a rough time in a rough league and by the hand of fate or circumstance, Hal Laycoe would be remembered for his involvement in one of the roughest nights of all.

It was March 13, 1955 just over 60 years ago — and the B's were playing their archrival in the old Garden, the spot that serves today as the front parking lot for

the present facility. During that contest Laycoe and his old tennis buddy had a meeting on the ice and things didn't go so well. The Bruin delivered a hard check to his former tennis partner and cut his face with a high stick, something that wouldn't happen in that summer game.

Richard retaliated smashing Laycoe on the shoulder with his stick. The two proceeded to mix it up, but in the swinging back and forth Richard injured linesman Cliff Thompson with a blow to the face, resulting in an eye injury to the official. There was a lot of blood all around. Referee Frank Udvari, who had seen some gruesome scenes in his off season position as an undertaker, assessed penalties that had both players done for the night — there was less than five minutes remaining in the game. But as it turned out Richard would be done for the rest of the year. He was suspended for the final three games of the regular season and the entire Stanley Cup Playoffs by NHL Commissioner Clarence Campbell — an action that came to mind in the wake of all the news about suspensions in the NFL over the past year.

Richard was finished, but the Montreal fans were not done. Four days later the Habs hosted Detroit at the Forum. When word got around that Campbell would be in attendance, things got so bad that the game had to be halted in the first period — and forfeited to the Red Wings. Outside a fullscale riot broke out, complete with looting, broken windows and damage to stores. As with most of these affairs, the damage done was to the rioters' own home area - where their fellow citizens lived and worked — not an area occupied by some perceived outside enemy.

It marked one of the few times that an NHL game was not played because of nonweather related reasons. Another, more recent, comes to mind — the Bruins-Senators game that was scheduled for April 15, 2013 — the day of the Marathon bombing.

As it turned out the B's would soon face Montreal in the Stanley Cup semifinals and would wind up losing the series, 4-1. By the end of the next year Laycoe would retire as a player, but not from the game. He coached Portland of the WHL for nine years, was briefly the head coach of the Los Angeles Kings in 1969 and then was behind the bench at Vancouver from 1970-1972. He later served as the team's GM.

Though best remembered for that one brief incident with Richard, Laycoe remained in the game throughout his life, later serving as a scout for the New York Islanders. He passed away on April 28, 1998 — at the age of 75.
