HADES, THE PLACE

ancient mythology believed Hades to be the name of a god, and also the name of a place. We then examined the legend surrounding Hades, the god. He was the brother to Zeus, ruler over the infernal regions, and over the ghosts of the dead.

Today, our attention is directed to Hades the place; that mythological world of the dead. According to the belief of the ancients, this world of the dead and the abode of the god Hades was located in the depths of the earth. It was considered to be a place where all dead souls went while they awaited their judgment and final commitment. It compared with the place, we now assume to be Purgatory, represented as a grove of barren willows veiled in darkness or clouds, and where the sun never shone. The ground was covered with asphodel, a dreary plant of

Last week we learned that trance to Hades was on the far side of a wide river named Oceanus or Acheron (both names have been used).

> The burial of the dead was a most solemn duty among the ancient Romans. It was incumbent upon anyone who found an unburied body, at least to cast earth upon it three times. If no funeral rites had been performed, the soul of the dead person could not be received in Hades, but wandered homeless upon the earth for one hundred years. Other ancients believed that children who were released from all other obligations to unworthy parents were nevertheless bound to bury them. The neglect of burying one's relatives was frequently mentioned by orators as a grave charge against the moral character of any man.

Charon was the name of the boatman who conducted the souls of the dead across

charged for this service was one obolus (a coin of low value), and in order that the ghost might meet this demand, the ancients placed that coin under the tongue of the deceased person. To this day we are told of the countless members of skeletons that have been found with coins that had been placed in their mouths.

The entrance to the kingdom of Hades was guarded by a dog named "Cerberus", a terrible monster with three heads, a tail of three serpents, and a body bristling with vipers. He was friendly to all who entered, but if a ghost tried to escape, the dog would seize that shade and hold him, fast. Brrrrr.

SADLY VOTER FRAUD WILL LIKELY DETERMINE PRESIDENTIAL ELECTION

If you are a conservative or moderate voter, after reading this piece you will join me in the demand that every voter in every state be required to show a photo ID before you are allowed to vote.


The activist group ACORN long associated with voter fraud is at it again this year in several states but most notably in the key swing state of Ohio the most important state in presidential elections. Ohio has 20 electoral votes and is a must win state for Republicans since no Republican has ever won the presidency without carrying Ohio.

Voter fraud is real. And it's an on-going problem. In many cases those implicated are members of leftleaning groups run by unions, George Soros, illegal alien activists and in each election the far left has an army of operatives padding the voting rolls. During the 2000 elections about 5,700 felons voted in Florida. In St. Louis election officials discovered that pets and deceased were being registered to vote. This year Ohio voters can cast absentee ballots without having to cite a specific reason for voting early, which had limited the practice in past presidential elections. It is the reason the Obama campaign chose to set up camp here to entice voter fraud. Senator Obama's campaign brought singer John Legend to college campuses Monday for early voting rallies. Volunteers for Obama pitched tents and waited all night outside polling places so they could be among the first to register and vote same day. Many residents lacked proper identification. Hundreds of thousands of residents including homeless were shuttled to polling places.

It is interesting to note Barack Hussein Obama was legal counsel for ACORN.

Two court rulings, one in U.S. District Court in Cleveland and the other in the Supreme Court of Ohio in Columbus, cleared the way for Ohio residents to register and vote simultaneously during a oneweek window from Tuesday through October sixth.

Italian Vocal Superstar Elisa Poised to Launch First-Ever U.S. Tour

In Support of Her Debut North American Album "Dancing" Released on Sugar/Universal

Elisa's pure, angelic voice and gift for melody first came to the attention of American audiences last year when her song "Dancing" was featured on Fox's hit TV show So You Think You Can Dance. An ethereal, emotional ballad, "Dancing" hit #16 on the iTunes Top 20 Songs chart immediately following the show's broadcast. A threesong EP featuring the song is currently available for purchase on iTunes.

Italian-born singer-songwriter Elisa, a multi-platinum, award-winning star in her native country, will launch her first tour of the Italian United States and Canada on October 29. As acclaimed internationally for her powerful live performances as for her inspired, emotionally direct pop-rock recordings, Elisa has appeared on various world stages with music legends including Andrea Bocelli, Luciano Pavarotti and Tina Turner. To date, though, her only North American engagements have been singing the Italian national anthem at the closing ceremony of the 2002 Salt Lake City Winter shows at NYC's Joe's Pub in April 2008.

The tour kicks off with a show in Toronto, followed by one in Montreal the next night. The remainder of the tour encompasses coast-tocoast dates in the U.S., beginning with a Boston-area show at Great Scott in Allston, Massachusetts on November 1st.

"Having the opportunity to play here, especially, is very important because for me. it really comes down to the face to face with an audience,' says Elisa. "I'm very curious about what that will be like on the tour. I believe that we are all the same, that the world is one place. I want to see if that is true: Elisa Toffoli was born in Trieste, Italy, on December 19th, 1977. When Elisa was 16 years old a demo tape of hers was heard by Caterina Caselli, owner of the label "Sugar Music". She immediately recognized Elisa's talent and arranged for her to go to the USA to improve her English, and to record her first album, "Pipes & Flowers". Released on Caselli's label in 1997, the album was produced by Corrado Rustici (Whitney Houston, Zucchero and more). Critics and the public were struck by this small, shy girl who closed her eyes while singing, and still was able to set herself free through her voice and her music. The debut was later released in other European countries. In Italy, it received many awards such as the prestigious Tenco Award given by critics to the best records of the year and the PIM, the Italian Music Award.



pop star Eros Ramazzotti offered Elisa the opportunity to open his gigs across Europe and she accepted. In 2000 and 2001 Elisa released two albums, "Asile's World" and "Then Comes the Sun". The first was a giant step away from her debut, with experimental, electronic arrangements and collaborations with many different producers, yet the second reprint contained one of her biggest hits to date, and her first song to be sung in Italian, "Luce (tramonti a Olympics and two sold-out Nord Est)". (International listeners may well have heard the song before with its original English lyrics entitled "Come Speak to Me".) The second album marked a return to more traditional arrangements and a new col-

laboration with Rustici. An international version simply titled "Elisa", containing a collection of songs from her three first albums, were released in more than twenty countries. Her fourth album "Lotus" was released in 2003, followed by an ambitious tour in Italian theaters.

In 2005 Elisa went to L.A. to record her fifth album, this time produced by Glen Ballard (Alanis Morissette, Anastacia, Christina Aguilera and more). The result was "Pearl Days", ten energetic tracks featuring musicians as drummer Matt Chamberlain (Tori Amos, Macy Gray) and guitarists Tim Pierce (Phil Collins, Rod Steward) and Michael Landau (Seal, Miles Davis). In addition to this already impressive career, Elisa has sung at the Winter Olympics closing ceremony in Salt Lake City, USA, dueted with Luciano Pavarotti at Pavarotti & Friends, played the lead part in Giovanni Sollima's opera "Ellis Island", and recorded a duet with Tina Turner entitled "Teach Me Again", written by Elisa for the film "All the Invisible Children" — a collaboration featuring work by directors such as Spike Lee and John Woo. In late 2006 the album "Soundtrack '96-'06" was released.



HISTORIC BAILOUT PASSED

law an unprecedented \$700 billion plan to rescue the US financial system, one of the largest ever government interventions in the US history. The Treasury is expected to move quickly to buy distressed assets from struggling banks although this will take time and will not be felt for several weeks according to some experts. Many details such as who will administer the program are still to be worked out. All news are not good as Nancy Pelosi says, "this was only the beginning" as companies shed 150,000 workers in September. The Federal Reserve could cut interest rates and make sure there is enough credit and spending on infrastructure and new regulations on hedge funds, private equity firms and investment banks, which will be under investigation by the Fed for abuses. The plan mandates the government to take equity stakes in companies' participation in the rescue and would limit "golden parachutes" for executives. Among the biggest issues is which assets to buy and how much to pay for them! The Treasury needs care in that it doesn't overpay for truly worthless securities. The department will hire about two dozen full-time employees including lawyers, accountants



> The good thing about this economic disaster is that oil prices are coming down. Gas is selling @ 3.33 gallon and crude is selling @ 8.781/bll, this is the lowest in 8 months. The decreases demand is prevalent with unemployment and a drop off in consumer spending. Experts are forecasting a price of 75-80/ bll in the near future on par with last year's price.

> Tighter credit will exacerbate unemployment in coming months. US employers shed jobs last month at the fastest pace in 5 years with weakness in the job market. Many farm payrolls declined by 159,000 in September more than double the average during the years. The 6.1% is the highest this year. This suggests a recession or going into one. "We are adjusting to major excesses in housing and finance so it's spilling over into other sectors of the economy. Says Mickey Levy, Chief economist at Bank of America. 



tional opportunities possible. Over the coming weeks, Dr. Johnson will personally take the plan to the neighborhoods by holding meetings in your community to discuss and explain the mission and goals of this initiative.

In its current state, there are unfilled seats in some of our elementary programs, but we've seen an increase in demand at our high schools. Superintendent Johnson has spent the last year listening to parents, students, teachers, and school leaders to develop this pathway to academic success, and her proposal shows her commitment to the children and families in the BPS system. The proposal was based on extensive data about the viability of all programs and facilities, including: parent choices during registration, school and student achievement, facilities condition, utilization rates, anticipated repair costs, availability of programs by neighborhood, and other factors.

By looking at successful schools with impressive re-

sults and high parent demand, Pathways to Excellence identifies programs that have worked best and aims to replicate and expand them throughout the neighborhoods in Boston. The plan creates new K-8 programs, expanding the current structure by 60%, to provide families with fewer transitions and more educational continuity. Three new pilot schools, combined with an expansion of the existing three pilots, would offer families more choice and access to these innovative institutions. Reorganizing the current programming will also allow us to increase opportunities across the board for innovation and enrichment, including music, arts, and sciences.


Building on Boston's national reputation as an innovator in public education, the plan creates many new programs to meet the changing needs of our students. A Newcomers Center for immigrating students, a Transition/Truancy Center to stem the dropout rate, and International Baccalaureate I bought hundreds of board games over the years, most of them at Hurwitz. 

A Time for Mavericks



Many were erected in the late 19th century to commemorate the four hundredth anniversary of Columbus's first voyage. They were generally commissioned from Italian sculptors working in Italy. Many American monuments to Columbus share stylistic traits and represent Columbus as young, with shoulder-length hair; wearing a short tabard, or sleeveless coat; holding a globe or a map and standing near an anchor. BROILED OR BAKED HADDOCK ALLA SICILIANA

Broiled Haddock Sicilian Style

1 pound haddock fillet

1 medium onion

1 large chopped garlic clove or garlic powder

2 fresh tomatoes

1 tablespoon oregano flakes

1 or 2 tablespoons grated Romano cheese (optional)

2 tablespoons olive, canola, or vegetable oil

Salt and pepper

Spread some oil on bottom of a broiling tray or baking pan. Place haddock fillet skin down on tray or baking pan. Cut tomatoes into ¼-inch slices and place over haddock fillet. Cut onion in ¼-inch slices and layer over tomato. Sprinkle oregano, salt and pepper to taste over onion. Spread chopped garlic, or garlic powder, over contents. (Optional) sprinkle grated cheese over contents. Next, sprinkle oil of choice over all. Cover and place at least two inches below broiling coils. Broil for about fifteen minutes. Remove from broiler. If dry, add a small amount of water. Cover and return to broil for about ten minutes. Remove from oven. Baste haddock with the liquids that accumulate in the broiling tray or baking pan. Return uncovered and brown onions and tomato. Check frequently to prevent burning or drying out.

*Cooking time for the haddock fillet depends on the thickness of the fillet.

NOTE: When Mama prepared this meal, I remember enjoying the fragrances of garlic, tomato, oregano and broiling fish that spread throughout the kitchen. Mama liked adding some Romano grated cheese occasionally over the contents. She referred to this meal as "Haddock alla Pizzaiola."

As the haddock cooked, I checked to be sure that we had plenty of bread available at home. I enjoyed dunking my bread in the juices while eating the broiled fish, and I still do.





A Nostalgic Remembrance

I had been rehearsing

with an accordionist, Mike

Santilli and asked him if he

was interested in playing for

and Boston College. To make sure there would be an abundance of young ladies, they added in the New England Telephone Company

and the John Hancock build-

ing. I liked everything they

said and we shook on the deal. For the next three and a half years, we ran dances at least two Friday evenings per month experiencing successes beyond our wildest dreams. To prevent the crowd from becoming rowdy, I switched to piano, bass, drums and sax. This combo lent itself to a cocktail lounge atmosphere and even the non dancers would be able to hold their own on a dance floor. Several people saw our success rate and tried to compete with us, but none succeeded. I don't know what we did that they didn't do but we were successful every time we had a weekend event.

I discussed my successes with Babbononno and Dad. They were happy for me, but Babbononno thought I would do even better if I put in some Italian music. I lied and told him I would, but I knew it never would happen. As I said, we were in business for three and a half vears. After each event, my two partners and I would sit down and figure what we owed, hotel function room rental, one-day licenses, security, music and advertising. More often than not, because of the size of our crowds we cleared \$150 to \$200 each per event as our profit. This was a great week's pay for a 40 hour week back in the mid 1950s, and we were working just one night a week to make it.



We played for private functions but soon found a home at a pub on Chelsea Street, just south of Day Square. They made pizzas, sold only beer and wine, and attracted a local weekend crowd. We were popular in that everyone knew each other. The job paid \$50.00 a night. No, not per musician; the job paid \$50.00 for the whole band. We received \$9.00 dollars each and the leader, \$14.00. If we played the private functions, the going rate was \$10.00 to \$12.00 per musician for four or five hours of music. If this doesn't sound like much, it wasn't even "back in the day," but it was a start.


When I started my freshman year at Boston State, I joined the Newman Club. It was like the CYO, a Catholic youth organization, but affiliated with college youth, only. 

ITALIAN CULTURE HERITAGE MONTH: 2008: NEW YORK. For 32 years, the Italian Cultural Institute Committee (686 Park Ave., N.Y.) which organizes the yearly events in the month of October in the Big Apple, also organizes the big Columbus Day Parade to showcase Columbus' achievements. The Committee has chosen, this year, to honor the memory of a celebrated architect who began working at the age of 13 as a stone cutter, and at the age of 16 he worked as a brick layer. The genius, talent and versatility of this young boy was noticed by a member of the Italian nobility who distinguished himself not only as a noble man but also as a sponsor of a growing talented boy who increasingly showed the unique artistry we admire today, and how many try to imitate him, both in Italy and in the world. The special talent we have mentioned above so briefly is no other than Andrea Palladio who was born in Padova (Padua) in 1508, precisely 500 years ago. The Committee, presided by Joseph Sciame, the newly elected presiding officer and also former National President of the Order Sons of Italy in America, made the choice at a special meeting. The outgoing President of the Committee, Angelo Gimondo, the founder of the October Cultural Celebrations which originally ran only a week, later expanded to the entire month of October, complemented the newly elected President, a great lover of Culture. During the meeting it was pointed out that the man who bankrolled Palladio's studies was the Count Gian Giorgio Trissino who had discovered the young Palladio's talent when the boy was working near the city of Vicenza. Count Trissino sent Palladio to study and work in Rome where he fell in love with the classical Roman Art of architecture, and began to build columns, arches, porticos and cupolas (domes) by imitating the classical Roman style, and eventually using this technique in the building of monumental palaces. Count Trissino encouraged Palladio to work for rich families in Vicenza where he built beautiful mansions in the new style he had perfected. Palladio eventually was inspired by the Greek style in his architectural creations, which he used in the reconstruction of the Basilica and in the building of the Olympis Theatre, in Vicenza. In Venice he built the beautiful 'Basilica di San Giorgio the Major' and the Church of the Redeemer. Of course, the patrician villas he built through the Veneto territory were very famous. He wrote four volumes of Architecture, and his works inspired Thomas Jefferson who followed the Palladian style in the design of the University of Virginia's major building closely imitating Palladio's style. Jefferson had traveled in Northern Italy extensively, precisely to see and study the Palladian buildings with frontal columns. The world now realizes why the buildings with frontal columns are called 'Greek Revival', but only thanks to Palladio.

threat to our sponsorship base today in the dollars that we see from our corporate partnerships. He added that "if we see a further pullback in the markets and a further crunch in our credit markets we could be in for some tough times."

However, both the Bruins and Celtics are probably much better off when having to consider these concerns since financial commitments for this season have already been made, contracts with sponsors have been signed and an impressive amount of season tickets have been purchased. According to an October 6 report in the Boston Globe the defending NBA champion Celtics are completely sold out for the season except for some 300 upper deck tickets that are made available only at the box office on the day of a game. On the Bruins' side. Charlie Jacobs has indicated several times that the season ticket renewal rate for the Black and Gold has exceeded 90 percent.

But both men are correct when they say going forward may be a different story. What will happen if, in the future, a business buys a smaller number of season tickets, opts for smaller signage within the arena (or none at all) and possibly decides, through corporate belt tightening, not to have a business relationship with the B's or C's for the foreseeable future. Obviously, things could be very different around here.

Through his comments, the senior Jacobs alluded to Greater New York and the various venues that are under construction - including the new homes of the Mets and Yankees that will open next year to be followed by a brand new shared stadium for the Giants and Jets in 2010. The top ticket at Yankee games next season has been priced at a whopping \$2,500 per game — and that was before the economy went south. Granted, there aren't too many of those but one wonders how many potential takers will back away now. Does a corporation really want to spend that kind of money on tickets while it is laying off rank and file employees? It's certainly not the best move for public relations.

Jeremy Jacobs also revealed that per the terms of the current collective bargaining agreement "the

players get 56 percent of what we take in right now, relatively speaking." He then cited the negative stating that for every dollar not taken in the players, in essence, lose the most "so there's a real reason for us to work together and move forward — reasons that didn't exist before."

MONDAY NIGHT CLASH -That will come on October 20 when the Bruins host Pittsburgh in the B's home opener on the same night that the Patriots are playing the Denver Broncos in Foxboro. Charlie Jacobs indicated that once potential dates at the Garden become known, the schedule makers at NHL headquarters in New York "slot teams and our opponents according to their availability and schedule. Of course, it's not an optimum situation to be playing the same night as the Patriots, but I was looking at some numbers and our box office is very strong for our opening night."

The Bruins aren't for sale and they aren't going to be sold. Somebody that has a lot of money and really wants to own one can buy a team. I think that the day of making bargain purchases, particularly in football, are long gone. I'm in it for long haul with the Bruins as you've seen."

But with the stiff winds of economic downturn blowing in from Wall Street, Jacobs foresees some difficulties. "I think all sports are going to be exposed to this economy, maybe a little less in hockey because the season ticket base has so many participants."

Jacobs added that he thinks "going out into the future, we are looking at difficulty. I think sponsorship is under attack. I mean look at the financial organizations that have participated in the past that don't even exist anymore. I'd say that nobody is going to see that more than New York. They've got three new stadiums going up and I think there are going to be a lot of questions marks with a lot of the participants they were depending on and looking forward to."

In fact, Jacobs' son Charlie, the executive VP of the Bruins, was somewhat more direct in his comments. "There is a material
