Obama's Weak Diplomatic Instincts

One of the consequences of electing an inexperienced, naïve novice to the highest office in the land is that you get a president who doesn't know the true meaning of diplomacy. And

it shows — quickly. Real diplomacy means dealing with allies and adversaries alike from a position of strength, much as you would deal with an opposite party in business negotiations. The objective is not to give things up for the sake of being nice and making friends. The objective is to skillfully get to an agreement that works for you and you can't do that unless the other side believes it would be foolish not to reach a deal.

President Obama appears to believe in the naïve, leftwing definition of diplomacy, which is simply being eager to make concessions for the sake of avoiding disputes and disagreements.

We see this in Iraq, where Obama has gone ahead and announced a date certain -August 31, 2010 — when the U.S. will remove the last of its combat troops. This satisfies the hankering of his political base, which has always been more concerned with leaving Iraq than with winning there. But even more so, it satisfies any insurgent movement that might still have ideas of promoting chaos and mayhem within a burgeoning, democratic U.S. ally.

Eighteen months from now, U.S. forces will be gone. The president has already given up the game. If you're a would-be Iraqi insurgent, you've got 18 months to plan what you're going to do.

Obama has applied the same thinking in his dealings with Russia, where he has already signaled his willingness to give up the planned missile defense shield in Poland. The Russians have been denouncing the planned shield since 2001, when former President Bush pulled out of the Anti-Ballistic Missile Treaty for the purpose of pursuing it. The U.S. insists that the shield is designed to protect against a rogue state that might get its hands on nukes (think Iran), and the Russians admit to no designs on attacking the U.S. or its western allies.

Still, the Russians don't want the shield because they fear it weakens their strategic position. And they're right. That's exactly what it does. In diplomacy, anything you can do to weaken your adversary's strategic position makes you more effective. This is why Ronald Reagan refused to give up missile defenses in the 1980s, when

Mikhail Gorbachev was begging him to do so. Missile defense put the U.S. in a position of diplomatic strength.

Obama is only too willing to put the U.S. in a position of diplomatic weakness by letting the Russians know that missile defense is on the table. Supposedly, missile defense is the chip Obama is willing to play in exchange for the Russians' help in preventing a nuclear Iran. But why give away our missile defenses in exchange for Russia's help when we have an ally, Israel that is ready, willing and able to undertake an air campaign to take out Iran's nukes?

Unleashing Israel is the much stronger play. It gives you the opportunity to eliminate the Iranian nuke threat and still keep your missile defenses. Instead, Obama appears willing to give up our defenses and trust to two not-all-thattrustworthy gentlemen -Vladimir Putin and Mahmoud Ahmadinejad — to eliminate a nightmare scenario that could threaten the security of the entire world.

Finally, in Afghanistan, President Obama recently made the extraordinary pronouncement that we are "not winning" the war.



EROS

was the fairest of all male deities. He subdued the hearts of gods and mortals. His brothers and his sister were Anteros, the god of requited love, Deimos, the god of fear, Phobos, the god of fright, and Harmonia, the goddess of friendly relations. All were the offspring of Ares and Aphrodite (Mars and Venus in Rome). Eros was not only thought of as the god of sensual love, but armed with bow and arrows, he was thoughtless, unpredictable, and showed no pity for anyone. One of his companions was the goddess named Pitho (Persuasion). The Roman name for Pitho was Suada or Suadela and it's interesting to note that the Latin word "suadere" means suggest, or urge. Probably the most ancient seat for the

Eros, the Greek god of love worship of Eros was the fairest of all male Grecian city of Thespiae. This was also the location of a large pillar-shaped stone that was worshiped as his image.

> Additionally, Eros personified the bond of devoted friendship between boys and men, especially in war or any kind of bold adventure. The warring Spartans sacrificed to him before a battle, and a sacred band of youths was dedicated to him at Thebes. Also, at Samos, a freedom festival was dedicated to Eros as the god who bound men and youths together in honor and friendship.

The most solemn of the ancient festivals to Eros took place in the city of Thespiae every fifth year with great ceremony, gymnastics, and musical con-

tests. We are told that even domestic quarrels which had caused marital discord were resolved at this time.

Works of art usually showed this god as a beautiful youth with bow and arrows, or burning torches. The Roman counterpart to Eros was named "Amor, Cupido, or Cupid." They also represented him in art carrying a bow and wearing a quiver of arrows. Even though Greeks and Romans considered Eros and Cupid to be one and the same, the name of Psyche (a female companion) appears to have been associated with Cupid rather than with Eros. During the next two issues it will be my pleasure to relate the story of Cupid and Psyche.

Massachusetts Miracle?

If Republican National Committee Chairman Michael Steele is serious about restoring the GOP's power in the Northeast, he should keep his eye on developments in Massachusetts, where beleaguered Governor Deval Patrick could face a strong Republican challenger next year.

Bay State Republicans — short on numbers, long on hope — felt their spirits rise recently after Harvard Pilgrim Health Care CEO Charles Baker announced that he was considering a gubernatorial run. Baker, who served admirably in the administrations of former Republican Governors William Weld and Paul Cellucci, told the *Boston Herald* on February 18 that a run would be an "uphill climb"; however, considering Patrick's weaknesses, such an effort might not be as hard as it would appear.

Patrick promoted himself as a man who would change the way things worked in Massachusetts. Things have certainly changed in the state: taxes are escalating, jobs are disappearing, and corruption is growing.

If Baker gets in the game, Patrick will be in for a bruising — losing? — contest. Sure, the incumbent (assuming he survives a likely primary challenge from State Treasurer Tim Cahill) will have some advantages: big-money Democrat donors, the support of the President and members of the state's all-Democrat Congressional delegation, the hardcore loyalty of certain Democrat constituency groups. However, Patrick won't have much of a record to run on: his greatest accomplishment as governor was the termination of efforts to democratically nullify the Massachusetts Supreme Court's 2003 ruling authorizing same-sex marriage. Baker, on the other hand, is well-respected for his work during the Weld-Cellucci years. As a 1998 Boston Globe Magazine profile noted, "[Baker] is a conservative who has won over many liberals; he is the brains behind welfare and Medicaid reforms

again make the GOP competitive in the Northeast. If Baker challenges Patrick in 2010, Steele will have a perfect opportunity to fulfill that vow.

Massachusetts residents are being pounded by Gov. Patrick's rough fists. Baker has the skills necessary to hit Patrick with a knockout blow that will send him into retirement. If he gets in the ring, Steele should be in his corner.

SECRET BALLOTS ARE THE FOUNDATION OF DEMOCRACY

Liberal Icon George McGovern called the proposed "card check" legislation an open invitation to abuse and ought to be opposed by Congressional Democrats. "My Party Should Respect Secret Union Ballots." Consider, In McIntyre v. Ohio Elections Commission (1995), a case about political pamphleteering, the Supreme Court called the secret ballot the "hard won right to vote one's conscience without fear of retaliation.'

There is no reason why labor unions must be given monopoly status. Both political parties should support reform of the law so that individuals are free to join unions, just as they are free to join or quit churches, clubs, or any other organizations. If unions are beneficial, they will survive without coercing workers who prefer independence.

What happens when an industry is unionized? Take a look at classic union industries: steel, a ghost of itself, circling the drain with most American steelworkers jobs gone: autos, flailing about gasping from abroad, with continued loss of market share, stock value and jobs; airlines hemorrhaging money and powerless to reorganize for life-saving effectiveness because of union constraints; and education, failing to teach Johnny to read while the union defends those who failed him rather than assisting the dedicated ones who can help him.

Unions consume companies and industries, and they destroy the jobs of the people they claim to represent.

The Employee Free Choice Act is anything but free choice for employees, free choice is what we have now, and this act seeks to take that away by doing away with secret ballots. Consider having your local and national election votes made public so that your neighbor, co-workers, employer and government knew how you voted.

If this bill becomes law, there is no question America will lose jobs.

The Secret Ballot Is the Foundation of Democracy and considering the Labor Unions contributed \$67 million to the Democratice Party, they expect the party to sell out the American people regardless of how many jobs will be shipped overseas because industry will remain unprofitable.

SIGNS OF STABILITY DRIVE UP STOCKS

The Stock Market reached its best week since November as scattered bits of news gave some reason to believe that the economy may be getting closer to the bottom. The DOW Jones rose 600 points or 9% to 7223, after hitting a low on Monday. News from shopping malls, metal markets, etc., gave a rosy feeling about the economy. Consumers are still cutting back, but not as steeply as before, and General Motors didn't need as much money for the month as previously thought. Oil prices were up 23% to \$46.35/bll., and a sign that demand may be firming. U.S economists are now predicting a 5% decline. Ben Bernanke, Fed Chairman, said the economy is not that bad, and should recover this year.

Barack Obama, President, said "he was confident that the economy would get through the crisis but warned that it would take some time for the economy to "catch up" and Larry Summers "predicted a cautious approach and consumer spending is up and stabilizing." Freight rates are rising. The Index collapsed last year but so far this year it has tripled. Doug Stotlar, CFO of Conway, a trucking firm, told investors that his firm has seen a pick up this month. "We hope we are at the bottom," he says. Retail sales

Inc., a semi-conductor company said orders are rising this week and recently raised its forecast. Texas Instruments said orders have risen this quarter, and raised its forecast. There are signs that the economy is nearing the bottom as prices of metals are rising. Copper has risen 8.7% this month and up 18% so far this year. Copper usually is an indicator as it is widely used in construction and an array of electronics and telecommunication equipment. The reading on the Michigan Survey of Consumer Confidence for March increased to 56.6% from 56.3% in February.

Immigration got tough rules resulting in beefed up security, including erecting barriers and deploying more agents. Most Americans are appalled that a mother will be separated from her children. There are deep divisions on how to handle the 12 million undocumented immigrants in the U.S. The President has to deal with this issue.

Mortgage Cramdown Plan hits turbulence in Senate. The bill which has passed the House, would allow judges to write down mortgage debt for people in bankruptcy. Apparently, in doing so seemed to have pushed City Councilor Stephen Murphy's buttons because he responded back with his own letter to the editor. I understand where Murphy is coming from but I also remember back in 1977 when I made an attempt to collect signatures to run for the old citywide Boston School Committee. As a 29-year-old resident of Charlestown, collecting the then necessary 2,000 valid signatures was too much to collect.

Today, Stephen Murphy says he is concerned if the number of signatures is too low, joke candidates will run for office. To him, it means big waste of taxpayer dollars. However, just what is a joke or non-serious candidate to use Murphy's terminology? We live in a representative democracy and shouldn't be talking about "non-serious" candidates being a tax burden. When Althea Garrison surprised everyone getting elected as state representative, she surely was considered a non-serious candidate but that surely wasn't how she saw herself. Historic Downtown Clock Keeps on Ticking Important Downtown Crossing Icon -Old South's Tower Clock to be Fully Restored

On March 16, restoration work began on the magnificent 1766 tower clock at Old South Meeting House at the corner of Milk and Washington Streets in Downtown Crossing. The pre-Revolutionary War clock will be completely restored, including its two exterior clock faces, interior gears and wheelworks. Installed in 1770, the tower clock at Old South Meeting House is the oldest tower clock in New England still in operation in its original location. It stood high in the steeple when Old South Meeting

House was the site of massive protests following the Boston Massacre and the fiery tea tax debates that led to the Boston Tea Party. The clock is still wound by hand once a week, as it was over 200 years ago.

Built in 1766 by clockmaker Gawen Brown, Old South's tower clock is a beloved sight in Boston's busy Downtown Crossing neighborhood. Gawen Brown created the clock for public use and wanted to place it on the



Old South Meeting House tower because of the building's prominent central location in the heart of Boston. In the days before wristwatches and cell phones, the Town of Boston paid for the clock to be installed at Old South Meeting House as a public service. Since 1770, the clock, known for its accuracy and regularity, has been a valuable neighborhood icon for both tourists and locals alike.

Emily Curran, Executive Director of the Old South

Meeting House said. "Thanks to the generosity of an anonymous donor, the Old South Meeting House is able to undertake a much needed restoration project of this remarkable Boston treasure." Work has already begun on the clock hands, which have been removed to be rebuilt and gilded. On March 16 the original interior mechanism will be disassembled to be cleaned and restored offsite by clock preservation and restoration expert David Hochstrasser. Later this spring the two clock faces on Washington Street will be restored and gilded.

Clock repair specialist David Hochstrasser is owner and operator of The Clock Shop in Hanover, MA. Interested in clocks since he dismantled his grandfather's wristwatch as a child, Hochstrasser has worked for many years on the tower clock at Old South Meeting House, as well as tower clocks at many of Boston's other historic buildings.

Massachusetts Republicans Look to Gains in State House

Earlier this month the Massachusetts House Republican Caucus released its vision of **A Better Deal for** the Commonwealth: An Alternative Voice on Beacon Hill. The agenda has several specific proposals under each of eight areas where Bay State residents deserve a better deal. Some of the proposals put forward are -

Restoring Public Trust in Elected Officials by increasing penalties for violating lobbying laws, for giving or receiving bribes, for participating in a matter in which a state employee has a financial interest, and for violating the conflict of interest law.

Overhauling the Pension **Program** including preventing any retirement allowance from being more than four times the average retirement in the Commonwealth. This will eliminate extremely exorbitant retirement packages.

Providing an Efficient & Effective Transportation System by merging the Massachusetts Turnpike Authority with Mass Highway, while transferring all assets and personnel to the state. Savings are estimated at \$190 million initially with \$23 million per year saved in administrative costs and reduction in personnel expenses.

Affordable Ensuring Healthcare by temporarily suspending the Minimum Creditable Coverage requirements until July 1, 2010. Those who have insufficient insurance currently face a tax penalty.

Renew Commitment to Commonwealth Communities by targeting underperforming school districts for charter school expansion, while lowering the annual financial burden on communities.

Rein in Spending & Promote Sustainable Budgeting by repealing the constitutional provision mandating legislator pay raises.

Protect Your Finances While Putting Money Back in Your Pocket by respecting the will of the voters and reduce the state income tax from 5.3% to 5% by 2012.

Stimulate Business in a Tough Economy by providing a tax credit to small businesses that creates at least five new direct jobs in the Commonwealth.

There is no better time than now for people of all parties and ideologies to accept and embrace the core values promoted by the Republican Party. Our state needs to learn the lesson we've been preaching for years, which is to live within our means. Last legislative session, the Majority party spent far too much, the Governor vetoed too little and the Legislature overrode too much. The failure of Question 1 last November was not a sign that residents want to be taxed more, but instead a call for Beacon Hill lawmakers to put their tax dollars to good use in the most efficient and transparent manner possible.

Hon. Dott. LIBORIO STELLINO, Consul General of Italy in Boston

Born on October 5, 1965 in Alcamo (Trapani), Italy, he is married to Teresa Abbundo - an Italian diplomat as well - and they are the parents of two daughters, Chiara and Francesca.

After receiving his degree in Political Science from LUISS University in Rome, he entered in February 1990 the diplomatic service and was assigned to the Department of Political Affairs of the Italian Ministry of Foreign Affairs, dealing with the main crisis areas of Sub-Saharan Africa in that period (Ethiopia, Somalia, Mozambique, South Africa).

In November 1992 he was assigned to the Embassy of Italy in Nicosia, Cyprus, as Deputy Head of Mission.

In January 1997 he was designated Chief of the Economic and Commercial Office of the Italian Embassy in Rabat, Morocco, with an extended competence with the Cooperation and Development bilateral Program field where he obtained meaningful success.

In February 2000 he returned back to Rome as Counselor for International Affairs of the Minister of Higher Education and Scientific and Technological Research. In this capacity, he was able to coordinate the complex organization of international gatherings.

In June 2001 he was appointed to the Parliamentary Relations Desk of the Cabinet of the Minister of Foreign Affairs, Rome, working side by side with the Minister and the Undersecretaries of State for the daily governmental fulfillment in Parliament of the several obligations concerning the Italian foreign policy.

In August 2002 he was assigned to the Embassy of Italy in Moscow as First Counselor and Chief of the Press Office. There, he took the responsibility of the press aspects concerning all the high-level bilateral visits followed one another from 2002 to 2006 (including the ten missions carried out in that period by the Italian Prime Minister to the Russian Federation), during one of the most flourishing periods in the Russian-Italian cooperation.

On August 28, 2006 he assumed the duties of his new post as Consul General of Italy in Boston with jurisdiction over the States of Maine, Massachusetts, New Hampshire, Rhode Island and Vermont, with a special, renewed commitment towards a more incisive and aggressive cultural and commercial Italian presence in the Region.







At least since the Reagan years, Americans had the gall to think of themselves as "a city on the hill," with incorruptible moral supremacy, destined to civilize the world." The U.S. has long believed that it has the right and the ability to "shape the world according to its own idea of good and evil." Will President Obama be able to dismantle this "toxic belief system?" It may be too big a task.

Eat more grapes! Grape seeds extract holds promise as a potent anti-cancer agent, a new study has found. University of Kentucky researchers found that natural substances called proanthocyanidins found in grape seeds killed 76% of leukemia cells within one day without damaging healthy cells.

Women may diet more often than men, but they're not nearly as good at it, says a new study. To test hunger responses in men versus women, researchers at the Brookhaven National Laboratory asked 23 volunteers to fast for 17 hours. Each participant was then presented with a heaping portion of his or her favorite dish, from pizza to chocolate cake, and asked to ignore it for 40 minutes. In brief, the women could not stop thinking about eating the forbidden food, and felt waves of emotion about being deprived. In men, the cravings faded once they decided not to eat. "We didn't expect such a striking difference between males and females," researcher Nora Volkow tells Scientific American.

Robyn Waters of Swampscott, says, "A diet is another thing a woman vows to stick to through thick and thin."

The brilliant Lisa Cappuccio thinks dieting is merely a matter of keeping your mouth shut at the right time — such as breakfast, lunch, and dinner.

Scornato! In Orchard Park, New York, the founder of a television network devoted to improving the image of Muslims was charged with beheading his wife. Police said Muzzammil Hassan, 44, confessed to the crime. The decapitated body of Aasiya Hassan, 37, was discovered at the station were she worked as a programmer. Giving the finger! A Portuguese businessman cut off his own finger in court to protest a judge's ruling. The judge had just ordered Orico Silva to sell part of a farm he owns to settle a \$225,000 debt. Opening his briefcase to retrieve some legal papers, Silva spotted a recently purchased butcher's knife and decided on a whim, to amputate his index finger and chop it into three sections in front of the horrified judge. "I didn't feel anything," said Silva. "It was an act of despair."

NONNA MARY'S RICE AND PEAS in Tomato Sauce

1 twenty-eight ounce can of crushed tomatoes

- 1 medium onion chopped
- 1 garlic clove chopped (optional)
- 1/3 cup vegetable, canola or olive oil

1 teaspoon dried basil

1 cup uncooked rice

1 cup frozen, fresh, or canned green peas

Heat oil in a saucepan. Add chopped onion, garlic, and basil. Simmer until onion is opaque. Garlic should not brown. Add crushed tomatoes and stir thoroughly. Add half a cup of water if mixture appears to be too thick. Cover and bring to a slow boil. Simmer for about twenty to thirty minutes over medium/low heat. Check frequently.

Two cups of tomato sauce will be needed to cook one cup of uncooked rice. Set remaining tomato sauce aside.

In a separate saucepan, add rice to two cups of simmered sauce and stir. Cover and cook slowly for ten minutes. All the liquid will be absorbed in cooking the rice. Check frequently. Add more sauce or a little water to the rice if needed. Add frozen, fresh or canned peas. Stir and cover. Allow cooking until rice and peas are tender to your liking.

If desired, top each serving with a tablespoon of the remaining heated sauce. Serves two.

Optional: Precooked rice can be used in this recipe by substituting tomato sauce for water in preparing the rice. Stir, cover and cook the precooked rice in the sauce the length of time directed on the package. When using precooked rice, allow peas to cook in the tomato sauce for about ten minutes prior to adding the precooked rice. Remove from burner and set aside until ready to be heated and served.



A Nostalgic Remembrance



Last week, I was talking about my first vacation as a young adult. It was the February school vacation. I was teaching at Boston Tech that year, playing music several nights per week and attending graduate school. When the Presidents week vacation approached, I made sure I was going to head south to a warm climate. I left off where Ralph Porras, a former East Bostonian and band leader and I happened to run into each other at the Doral Hotel. He invited me to join him the next day at the Doral Country Club for lunch, and without me knowing it, joining up with an entertainer he worked with at that point in time, Jackie Gleason.

I met Ralph at his home in North Miami and he drove to the country club. Once inside, we headed for a corner of the club dining room and lunch with Mr. Gleason. I was awestruck but tried to be as casual as possible. I was introduced to Gleason after which he and Ralph began a business meeting. We were soon joined by Sammy Spear, the music director for the Jackie Gleason Show. The three men discussed business while we ate. When we left, I felt like I had rubbed shoulders with the big time. I knew that I had one heck of a story to tell Babbononno, who watched the Jackie Gleason Show faithfully.

On the way back, Ralph asked me about the girl I introduced him to the night before. I told him the story about how we coincidently were in three consecutive places and struck a conversation at the third. Once I mentioned her grandfather's name, Ralph said, "Hey kid, you're hangin' out with heavy-duty money and power." I responded with, "Yeah, I found that out last night when we arrived at the Doral and I was treated like visiting royalty.'

I picked up my car at Ralph's house and headed

What I had not mentioned was that southern Florida was in the middle of a winter's heat wave. The temperature was in the mid to high 80s, a bit warm for that time of the year, even in Florida. As a result, I even attempted the ocean to cool off. The water was about the same as you would find at Revere Beach during the early summer, cold. I didn't mind, it was refreshing, that was until something almost happened that might have shortened my vacation.

South Beach in those days was not the South Beach of today. The art deco hotels that you find located from about 2nd Street to 14th Street were small inexpensive hotels that catered to an older Jewish crowd. Most of them were Kosher and most of the occupants were part of the New York working class that spoke mostly Yiddish. There was always a parking space and anything I might want to buy was cheaper than what you might find near the more fashionable hotels a bit farther north on Collins Avenue, the tourist hotel strip on Miami Beach.

I mentioned that something almost happened that might have shortened my vacation. Due to being acclimated to the Boston winter climate, the 80 something degrees of the Florida heat wave had me sweating as I lay on my towel sunning myself. After a bit, I decided to try the water. I found it cool but refreshing and swam around cooling myself all the while. At one point, I was standing chest deep with my back to the sea to allow the low level waves to roll up my back. A little old man was facing me and began to yell in my direction splashing water with his hands as he yelled. The only problem was that he was yelling at me in Yiddish. I tried to tell him that I didn't understand but he became more excited and pointed to something behind me. I turned to look and jumped back toward the shoreline as fast as I could. About a foot behind me was the biggest Portuguese man of war I ever saw. The round purple head was about 8 inches in diameter and the streamers trailing behind were at least 10 feet long. If I had been stung by this creature, I would have been a candidate for a ride to the nearest hospital.

I thanked the little old man for warning me. I used what little German I knew to thank him, knowing that German and Yiddish are very close. He understood. People near me in the water gave the man of war a wide birth and once the waves carried it to the shore, a life guard disposed of it. Just then, my school teacher friends from Boston spotted me and came running over to calm me down. Once my heart slowed to a normal rate, I told them about my adventure at the Doral Country Club and the people I had lunch with. As a result, I was a local celebrity as far as they were concerned.

When the sun started to head west, I headed back to the apartment hotel and called home. I told Dad that I had run into Ralph Porras. He and Dad were close friends and had played together many times. Dad knew that Ralph was spending more and more time in Miami, taking advantage of his musical skills and Latin looks. When I told my father about Jackie Gleason, he asked me what he was like in person. After I told him, he put Babbononno on the phone as my grandfather was a big fan. After I finished with him, he yelled, "Hey, Jenny, you tell you mamma bouda you bee widda Jacka Geazona, she no believa you." My mother got on the phone and I went through the story for the 3rd time. Finally, I said, it's time to hang up; these long distance calls are expensive.

I rested for an hour before getting cleaned up and heading out. I was to meet Maryann for dinner and then we were going to hook up with the Boston crowd. I arrived at the Fontainebleau and was told by the parking manager that he was told to put my car in the garage as Maryann's cousin was joining us for dinner and he would be using his car. I left him my keys, headed to the lobby and found my friend and her cousin waiting for me. I was introduced to a young man about my age called, "Cousin Harry," who asked, "Did y'all ever try southern barbecue?" I nodded in the negative and we headed back to the parking area in front of the hotel where Cousin Harry pointed to a Rolls Royce convertible and said, "Jump in, the ribs is waitin' for us." LO SAPEVATE CHE ...

DID YOU KNOW THAT ...

Over the first 8 months of 2008, the Treasury Police have uncovered \$27 billion, exactly \$26.5 billion of revenues literally stolen from the Fiscal Authority, with an increase of 44% vis-à-vis the same period of 2007, and identifying a total of 5,100 of tax evaders, authentic mini-firms totally unknown to the Treasury. These are some of the data of the budget of the 'Fiamme Gialle' (Red Flames, as the treasury police are known), announced recently during the installation ceremony of the new Second-in-Command of the Corp: General Mino di Paolo, in place of the retiring General Angelo Ferraro. In the first 8 months of 2008, there have been a total of 71,000 controls and identification which have made it possible to identify, in addition to the revenues never reported to the 'tax man', and the IVA (the added goods value) evaded for a whopping \$4 billion. In this operation there is the reality of the underground economy and also evading workers' insurance and labor laws with 25.000 workers never reported to the authorities. International fiscal evasion is also on the increase. The 'Yellow Flames' have discovered unreported revenues for \$4 billion, more than double the ones uncovered in 2007. A whopping 5,750 individuals have been charged, as well as other 3.300 people involved in the disappearance of European funds for public works., in the amount of \$750 million. Goods valued about \$1,85 billion have been confiscated because of recycling, usury, fraudulent bankruptcy, while another 3.126 individuals have been charged. The total of people charged for crimes connected with smuggling falsified goods are 11,000, 250 of whom already arrested for contraband of cigarette, while 17 web sites used for 'on line' sales of falsified goods have been eliminated. 


