101st Anniversary of the Great Molasses Flood in Boston's North End

January 15th is the anniversary of the Great Molasses Flood of 1919 in Boston's North End. The United States Industrial Alcohol Company constructed a faulty 50-foot high steel tank in 1918 on Commercial Street near where Langone Park is located today. Twenty-one people were killed and another 150 injured when the tank ruptured and exploded.

A huge wave of the syrupy brown liquid moved down Commercial Street at a speed of 35 mph over two blocks destroying all in its path. In today's dollars, the property damage is estimated at over \$100 million. Purity Distilling Company, a subsidiary of U.S. Industrial Alcohol Company, built the tank, 50 feet high and 90 feet wide.

The tragedy in the densely populated, largely Italian-

American immigrant North End neighborhood at the time, was initially believed to be the result of a terrorist act. Taking advantage of the anti-Italian sentiment at the time, company attorneys for the tank-owner tried to blame sabotage by political anarchists. The resulting investigation and legal hearings — involving 125 lawsuits — was the longest up until then in the history of the Massachusetts court system. It ended in 1926 with a conclusive judgment: the tank had been improperly designed in the first instance and its failure was due entirely to structural weakness, not to a terrorist attack.

A 2016 research study on the Great Molasses Flood of 1919 in Boston's North End says that January's cold weather made the molasses extra deadly. The cooling increased the thickness

of the sweet syrup, making it incredibly hard to escape.

The disaster brought nationwide attention to the lack of industrial safety standards. Complaints of cracks and leaks in the tank were literally covered with brown paint by the company that initially said anarchists blew up the tank. Later, a lengthy class action lawsuit brought forward damaging evidence resulting in a settlement of \$600,000 (\$11 million in today's dollars). Although Purity used the molasses for industrial alcohol, some hypothesize that the tank was overfilled because of the prohibition threat for possible use later to distill rum. Neighborhood folklore has it that you can smell the ill-sweet remains in the summer's hottest weather. (Sources: Wikipedia, Mass Moments, Wired)

New Anti-Robocall Laws Protects Consumers by MAConsumerAffairs

In recent years, robocalls have disturbed, cheated, and scammed constituents, stealing nearly \$1 billion from consumers in 2018 alone. Scam callers may pose as various government agencies or other organizations requesting money, personal information and other data in hopes to steal from or harm the person on the other line.

In December 2019, there were 147.3 million robocalls made to people nationwide per day. Massachusetts consumers alone received 1.6 million spam calls per day. It's very likely that you have answered a robocall at some point. Robocalls have become not only a consumer nuisance, but also an extremely dangerous practice, as your private information and hard-earned money can potentially end up in the hands of someone with malicious intentions.

The Office of Consumer Affairs and Business Regulation hosted the New England State Symposium on Robocalls with Governor Charlie Baker, Housing and Economic Development Secretary Mike Kennealy, and Federal Communications Commission (FCC) Chairman Ajit Pai in November 2019. A panel of industry experts led an important discussion on what is being done at the federal, state and local level to combat robocalls.

Just a few days into 2020, the Federal Government signed new anti-robocall legislation

into law, dubbed the TRACED act. The legislation aims to counter robocalls in its mission to protect consumers. While completely ending robocalls will be difficult, here is how the TRACED act protects you from fraud and theft:

• The act requires phone companies to create processes or systems to recognize calls and block them before they can reach you, the consumer. Phone companies must also block calls without charging you extra for these services. Instead of ringing through to your phone, the calls will go straight to voicemail. Some phone companies have already initiated and implement processes to reduce spam calling to consumers.

• While the law has provisions to protect the consumer directly, it also does so indirectly, through its empowerment of the FCC. The FCC is given stronger enforcement ability, allowing an increased financial penalties for robocall abusers. Furthermore, it gives the FCC greater jurisdiction to apprehend scammers and extend the state of limitations by up to four years.

• Finally, the law empowers the Department of Justice to deliver stronger criminal prosecutions to scammers after receiving appropriate evidence from the FCC.

As these new laws and regulations are being implemented, you may still receive scam calls. Do not share any personal information or money with callers without appropriate verification. Be sure to report any suspicious phone calls to the FCC or the Federal Trade Commission (FTC). Stirpe Nostra

The "Titanomachia," or War of the Titans, was brought about mainly because of the attitude that Cronus had developed toward his sons and daughters. We remember Cronus as the leader of the Titans who swallowed the first five of his six children at birth because he was warned that he would be overthrown by one of his offspring. Zeus, the sixth child, was not swallowed because a large stone was substituted in his stead. Later Zeus succeeded in getting Cronus to drink a potion which contained a powerful emetic. This caused the stone to become disgorged, and it was followed by the five brothers and sisters of Zeus. Opposition to the rule of the Titans was started by Zeus, who convened a meeting on Mt. Olympus. He announced that anyone who aided him in overthrowing the Titans would be permitted to reign as a god until the end of time.

Styx, a goddess who dwelt in a lofty grotto at the entrance to Hades, was the first to pledge her support of Zeus. She also pledged the support of her four children, whose names were Bia (Force), Cratos (Strength), Nike (Victory), and Zelus (Emulation). Prometheus (the savior of man-

kind) aligned himself with Zeus, as did all of the Olympian gods.

All of the Titans except Oceanus supported Cronus. They took their position in the Othrys Mountains of Southern Thessaly and the forces of Zeus occupied Mt. Olympus, about fifty miles to the north. The broad plain between these two mountains became the scene of a gigantic battle which continued for ten years without either side gaining a victory. Finally, in desperation, Zeus sought the advice of Grandmother Gaea. She advised aid from the Hecatoncheires (hundredhanded monsters) and the Cyclopes whom Cronus had previously imprisoned in the dungeons of Hades. Zeus immediately went to the lower world, slewed the dragon that was guarding these dungeons and released the prisoners.

The liberated Gargantuan creatures stormed onto the plains; their thunder, lightning, and great strength provided just the added power that was necessary to gain a victory for Zeus. Those defeated Titans were then hurled down into Hades and enclosed within walls of brass. The hundred-handed monsters were designated to be their relentless jailers for the rest of time. Atlas, a secondary Titan, was punished by being forced to hold the heavens upon his shoulders for all of eternity.

Contrary to a popular belief, Atlas was not required to hold the earth.

Trump Has Our Back

A little more than a year into Trump's presidency I had dinner with a friend who is the pastor of a church in the Reform tradition, but who came from the Evangelical tradition. I'm a Catholic, so our combined experiences cover most of the Christian experience in America. We were talking about how clueless the media is about Trump and his appeal. My friend noted that the media doesn't understand why Evangelicals support Trump. I responded, "I can sum it up in one word, 'Cy' and my friend responded with, "rus." We were referring to Cyrus the Great, the Sixth Century B.C. king of Persia who released the Jews from their Babylonian captivity, returned them to their homeland, decreed that the temple in Jerusalem be rebuilt, and provided the money to build it. You can read the account in the Bible, in verses one though eight of the first chapter of the Book of Ezra, as well as several favorable mentions in the Book of Isaiah.

There is no record, not even a hint that Cyrus became a worshipper of the God of the Jews. His policy of religious tolerance was applied across his empire to all religions. He took the golden temple vessels that the Babylonians had seized from the Jerusalem temple and returned them to the Jews, but there is also an account of his paying for the restoration of a Babylonia idol. In short, he seems to have understood that the best way to rule a multi-ethnic empire with many religions was to be the guarantor of freedom to any and all religions. He wasn't a Jew, but as we say, he had their back. In fact, according to the Bible, he was chosen by God.

Fast forward about 850 years to the Year of Our Lord 313. That's when the persecuted Christians in the Roman Empire gained their freedom of religion. Emperor Constantine the Great issued the Edict of Milan which, like Cyrus' policy, established freedom of religion in the Empire for all faiths. In the Eastern Church Constantine is recognized as a saint. In the Western Church he is highly revered, but not officially recognized as a saint. His personal life was hardly saintly, he had his wife and child murdered, and was otherwise cruel when he believed the situation called for cruelty. Perhaps his knowledge that governing the Empire would require ruthless acts was why he delayed Christian Baptism until he was on his deathbed (Baptism washes away all sins). During his life, Constantine was favorable to Christians, but he was not one himself and — he had their back.

In 2012, President Obama pushed for an Obamacare mandate that if enforced in the way he wanted would have forced the closure of Catholic and many Protestant hospitals and schools. It was clearly unconstitutional, but the legal battles alone would likely have been crippling to faith institutions. In response, here in heavily Catholic Boston Cardinal O'Malley urged us to pray:

"Almighty God, Father of all nations, for freedom you have set us free in Christ Jesus. We praise and bless you for the gift of religious liberty, the foundation of human rights, justice and the common good. Grant to our leaders the wisdom to protect and promote our liberties; by your grace may we have the courage to defend them for ourselves and for all those who live in this blessed land. We ask this through the intercession of Mary Immaculate, our patroness, and in the name of your Son, our Lord Jesus Christ, in the unity of the Holy Spirit, with whom you live and reign, one God, for ever and

In the workplace, Smoki overcoming rampant sexism, serving as a scientific illustrator who sketched the conceptual drawings for the forerunner of the internet and helping illustrate the missing minutes of the Watergate tapes.

Smoki was the life of every party, the star of every show, and at the center of every fray. She will be remembered as a fighter, activist, and adoring grandmother who loved playing cards, debating politics, and bringing people together for each of her incredible adventures.

Renowned Organist Leonardo Ciampa

To Perform Concert of Italian Organ Music

On Sunday, January 26th, from 3:00-4:00 p.m., at St. Leonard Church, internationally renowned organist Leonardo Ciampa will perform a concert of Italian organ music, showcasing the church's new pipe organ. Installed last spring by the Peragallo Pipe Organ Company of New Jersey, the organ contains over 1,000 pipes.

Ciampa has played organ recitals in important cathedrals and basilicas in Italy, Austria, Germany, and Switzerland. Last October, he performed a concert of his own compositions at the Cathedral of St. John the Divine in New York, the largest church in the Western Hemisphere. Yet of all these concerts, Ciampa's upcoming performance at St. Leonard has deep meaning for him. He is dedicating the concert in loving memory of his grandparents, Carmine Ciampa (1890-1956) and Maria Ciampa (1893-1981), who joined St. Leonard's Parish exactly 100 years ago. "My grandparents arrived in Ellis Island in 1920," Mr. Ciampa explains. "They came directly to Boston and lived on Snow Hill Street. However, my grandfather's older brother Giuseppe had already been living in that house for 15 years. Giuseppe arrived in the North End back in 1902. He met Maria De Pasquale in Boston and married her in 1905 at St. Leonard Church. The celebrant was Fr. Alphonsus Parziale. They were married and lived on Snow Hill Street. My grandparents moved into that same house in 1920. In 1921, they had a twins, one of whom was Fred Ciampa, who became a famous sportswriter in Boston. Uncle Fred was baptized at St. Leonard. After that my grandparents moved to East Boston, where I was born. However, Giuseppe and Maria remained in the North End and had nine children in that same house. The three youngest were Lina, Evelyn, and Josie Ciampa. They were quite a trio! They were well known throughout the North End. Their entire lives they lived on Snow Hill Street and attended St. Leonard. They were huge fans

of mine, attending most of my concerts. I regret only that they did not live to see the stunning restoration of St. Leonard and hear the new organ."

The meticulous restoration of St. Leonard was spearheaded by Fr. Antonio Nardoianni. He arrived at St. Leonard in 2004, a challenge time in the parish's



history. The North End parishes had recently been reconfigured, causing much tension. The buildings and grounds were in deplorable condition, with little money in the bank to fix them. Over the course of 15 years, Fr. Antonio raised more than \$6 million, insisting that \$3.5 million of it be used to restore the church interior. The new pipe organ was made possible by the generosity of Carol and Nick Ferreri, and family.

"I was stunned," Ciampa recalls. "All too often when a church wants to do a quoteunquote 'restoration,' they get someone's cousin to throw some paint around. When I walked into the restored church, I just couldn't believe it. It was as beautiful as any church I have ever seen in Italy. What an astonishing restoration they carried out, and much of the credit really goes to Fr. Antonio. He really did not want to cut corners on the church interior. We now have a beautiful building that tourists and parishioners alike can walk into and have their jaws drop." Fr. Nardoianni left St. Leonard at the end of 2019. The new pastor is Fr. Michael Della Penna, who was born and raised in the North End.

Ciampa's concert will feature six centuries of music by Italian composers — everything from a piece by Andrea Gabrieli written in the 1500s, to a piece by Fabio Pietro Di Tullio composed last August. Ciampa will feature compositions that would have been heard in an Italian church in 1920. Ciampa will also perform a couple of his own compositions, including a fantasy on "Quel Mazzolin de' Fiori." "My cousin Lina told me it was my grandmother's favorite song. So I wrote it in honor of my grandparents. I played it as an encore at a concert at the Basilica of Santa Prassede in Rome. But this will be the first time I perform it in the United States."

Admission to the concert is free. St. Leonard Church is located on 320 Hanover Street in Boston's North End, on the corner of Hanover and Prince Streets.

L'Anno Bello: A Year in Italian Folklore

Over the Moon!

Every January, I look forward to a certain kind of dark and still night. During a night like this, a mystical hush infuses the air, as if the whole Earth stands holding its breath, interrupted only by quiet wafts of chilly wind. Gray clouds scuttle across the dusky sky, obscuring the stars. I hear the gurgling of melting snow as it rushes down the drainage system, a sound indicative of the frequent January thaws and the cyclical turning of the year. Indeed, the sensation of the coming spring permeates this night, as only short hours before the sky had been a jewel-like hue of deep blue. However, the sight which makes me shiver with the most awe on this night is the full moon suspended above me. She glows with a pearly white incandescence as she winks from behind the passing clouds, adding to the enigmatic mood of the evening. Seeing such a moon reminds me of all the reasons why this heavenly orb resonates so strongly with me: her mysterious beauty, her link to powerful femininity, even her patronage of my zodiac sign, Cancer. The January moon has always been particularly meaningful for me, as she brims with the energy of the new year and forms an elegant and radiant counterpoint to the dark winter skies. She carries the anticipation of the spring, much in the same way as womencentered January holidays like St. Agnes's Day. In all of manifestations and stages, the moon has captured the attention of societies worldwide, boasting her own slew of folklore and superstitions.

quently sing a catchy pop hit he remembered from his Italian boyhood, whose lyrics intoned: "La luna, la luna, ti portará fortuna" — meaning "the moon will bring you luck." Several Roman deities, the majority of them women, presided over the moon. Diana, the forest-dwelling huntress, was associated with the crescent moon, perhaps because it resembled the shape of her bow. The darker side of the moon belonged to the goddess Trivia, most commonly known by her Greek name Hecate, who ruled over witchcraft, crossroads, and all the spooky aspects of night. Finally, the goddess Luna served as the very personification of the moon, and her name lent itself to the Italian name for "moon." Contemporary Italians still include mentions of the moon in their folklore, especially in the realm of superstition. The most famous Italian moon-related superstition, also repeated frequently in the United States, declares that the full moon exerts an influence over human behavior, encouraging romance but also lunacy. In fact, the word "lunacy" shares the same root as "luna." Italians also whisper stories of the lupo mannaro, or werewolf, who changes into a frightening beast under the full moon. Sundry moon superstitions include cutting one's hair during a waxing moon, to ensure that it will grow back lusciously as the moon gets bigger, and that pointing at the moon is considered rude and unlucky. These pieces of lore speak to moon's immense cultural significance.

One January holiday in In part, my love from the particular boasts the same moon appears woven into my sense of magic and mystery DNA, a characteristic of my I associate with the moon. Italian heritage. When I was January 21st is St. Agnes's Day, or la Festa di Sant'Agnese

virgin and martyr killed in the early fourth century. By sheer chance, this year the full moon and St. Agnes's Day coincide! In Italy, this feast is linked to lambs, possibly because of the similarity between the name Agnese and the Italian word for lamb, agnello. Every year, the Pope blesses two lambs brought to Rome on January 21st specifically for the feast of St. Agnes. Significantly, sheep begin birthing lambs and commence the process of lactation around the middle of January. Therefore, la Festa di Sant'Agnese is one of those January holidays that looks ahead to the promise of spring, that honors rebirth and the new life blossoming under the winter snow. However, in addition to livestock, old St. Agnes's Day celebrations sparkled with enchantment and secrets. In the England of yore, the eve of St. Agnes's Day was set apart for romantic divination. Since St. Agnes is the patron of young women, girls would seize this opportunity to perform a plethora of charms in order to dream about their future spouse. These charms involved mysterious activities such ranging from silently walking backwards to bed, baking a cake at night without uttering a word, or repeating a magical rhyme while throwing grain into the soil. The romantic, supernatural nature of St. Agnes's Day perfectly accentuates the frigid, moonlit nights of January, when the moon illuminates the shadowy skies and hints at the spring to come.

Though she is often eclipsed by the warm and fiery sun, the moon provides us with a unique blend of mystical beauty and starry-eyed magic. She is a prominent figure in folklore and mythology, having long amazed people with her changing faces and powerful nocturnal presence. Wielding the mighty ability to affect tides but gentle enough to form lacy patterns of moonlight through the bare winter tree branches, the moon continues to enjoy her place in superstition, as people still repeat tales of her influence on human behavior. I encourage everyone to take time out of their busy lives to glance at moon in all her splendor — whether she stands as a full white orb, or a glimmering sliver in the sky, or shyly peeks behind slate-colored clouds. One of my favorite moon moments was years ago, when I was driving back home with my mother after visiting my grandmother. As we passed a lake whose waters gleamed like polished glass in the nighttime, we immediately noticed an enormous full moon suspended in the sky, sending her spangles of light flitting across the tranquil waters. This moment reminded me that there is still so much beauty, magic and mystery in our world, which will only continue to be revealed as the winter melts into the renewed life of spring.


In the next few weeks this column will feature excerpts from this book.

East Boston in the 1940s was like the North End, a population totally made up of Italians. It was unlike the North End because of its rural quality. Elena was an earthy woman, rough around the edges, with survival instincts honed out of a need to support her eight children. Her husband, Gaetano, loved tending their garden. He was never able to find a job that paid enough to support the family, leaving it up to resourceful Elena, a true daughter of Naples. The two sisters were opposite in every way. Grandma was petite, reserved in dress and manner. Elena was heavyset with a grease-splattered apron permanently wrapped around her waist. Saint Mechtilde

Mechtilde also known as Matilda von Hackeborn-Wippra, was born into one of the noblest and most powerful families in Thuringia (German State); in 1240 or 1241. Her sister was the illustrious Abbess Gertrude of Hackeborn.

Mottled became a nun at Rodersdorf, Switzerland. She moved to the Helfta monastery in 1258 where her sister served as abbess. As a nun, Mechtilde was soon distinguished for her humility, her fervor, and her extreme amiability and piety which had

characterized her from childhood.

She joined the convent and eventually became the headmistress of the convent school. Mechtilde was employed in the convent looking after the library, illuminating scripts, and writing her own texts in Latin. Mechtilde wrote many prayers.

In 1261, the abbess committed to her care a child of five who was destined to shed fame upon the monastery of Helfta. This was Gertrude who in later generations became known as St. Gertrude the Great. Mechthilde and Gertrude of Helfta, became ardent devotees and promoters of Jesus' Heart after it was the Subject of many of their visions.

Mechtilde had a great gift for understanding and writing Latin and became famous for her musical talents. She was gifted with a beautiful voice and was called the "Nightingale of Helfta." Learned Dominicans consulted her on spiritual matters. It may have been from St. Mechtilde that St. Gertrude the Great discovered that the many gifts she possessed were from God.

At the age of 50, Mechtilde went through a spiritual crisis when she learned that two nuns in whom she had especially confided had written of the spiritual favors granted her. After much prayer, she had a vision of Christ holding in His Hand the book of her revelations, and saying: "All this has been committed to writing by My Will and Inspiration; and, therefore you have no cause to be troubled about it." He also told her that He wished this book to be called *The Book of Special Grace*, because it would prove such too many. When she understood that the book would tend to God's Glory, she stopped being troubled, and even corrected the manuscript herself. Some authorities believe that St. Gertrude the Great co-authored it. Immediately after her death, it was made public, and copies were rapidly distributed.

Boccaccio tells how, a few years after the death of Mechtilde, the book of her revelations was brought to Florence and popularized under the title of *La Laude di donna Matelda*. Promoting the devotion to the Divine Mercy of the Sacred Heart of Jesus. She May have been the inspiration for the character Matelda in Dante's Purgatorio.

Mechtilde passed away on November 19, and although she was never formally canonized, the Benedictine convents have permission from the Church to celebrate her feast on November 16th.

Columbus met Isabella in May 1486. She was clearly taken with him. She, too, was partial to the Franciscans, and was also interested in the recovery of Jerusalem, as her grandfather and uncle had made that pilgrimage. She was quick to agree with Columbus's plan because

the Pope had given to Portugal all the land along the coast of Africa [as well as the right to enslave any Muslims or pagans they encountered.] That decree is known as Romanus Pontifex.

Isabella submitted Columbus's proposal to a committee for further study. It would be a long wait. During this time, Columbus met Beatriz de Harana. Though the daughter of peasants she was educated and could read and write — qualities that appealed to Columbus. They soon became a couple and in 1488, their son Ferdinand was born.

In 1490, the Commission rejected Columbus's proposal. So did a second commission. Columbus had been waiting six years and thinking about his project for a decade. He decided to go to France and was already on the road when a confidant of the Queen rushed to find him and brought him back telling Isabella she was losing a great opportunity at little cost.

She signed the papers in April 1492, and told the people of Palos to prepare ships for the voyage. As you know these were the *Nina*, the *Pinta*, and the *Santa Maria*.

Once underway Columbus began to keep a diary — very unusual at the time, since not all sailors could write, and even



if they could, they jotted down only wind, direction, and speed. At the beginning of the diary, he recapitulated his understanding of the voyage. He wrote that he hoped to meet the person who "is called the Grand Kahn which means in our Spanish language "King of Kings." To see how the conversion to our Holy Faith might be undertaken because so many times he had asked for men learned in our Holy Faith in order that they might instruct him in it and how the Holy Father had never provided them; and thus so many people were lost, falling into idolatry and accepting false and harmful sects. And you commanded that I should NOT go to the East by way of land. But by the route to the West, by which route we do not know for certain that anyone previously has passed."

The purpose of the voyage was to set up a **trading post** to obtain gold and spices that would finance the crusade. There was absolutely **no intention** of enslaving or killing the people belonging to the greatest empire in the world.

Finally, on August 3, 1492, the small fleet slipped away from Palos into the unknown. Columbus was confident and began to think of himself as Christ-bearer, like his namesake Christopher, carrying the Christian faith across the waters. But the men were afraid

they might run out of food before they reached land and may also run into monstrous races described by Pliny.

Their anxiety increased when the rudder of the *Pinta* came loose on their way to the Canaries. Then there was an eruption of a volcano on the nearby island of Tenerife — Not good omens. But finally,

they set out on the unchartered ocean and sailed due West.

Late in September, they were entangled in the Sargasso Sea and saw some birds so they thought they might be approaching land but the crew became anxious and demanded that if they did not find land within three days, they should turn around before they ran out of food. Amazingly, in the next couple of days there were more signs that they were getting close. Late at night on October 11th Rodrigo de Triana, on board the Pinta called out, Tierra -Land. They sat out the night in great anticipation.

Their vigil was rewarded. Early morning a veil of mist opened and Columbus and crew "saw an island ... full of green trees and abounding in springs with a large lagoon in the middle." Columbus was relieved: he had crossed the ocean no one thought possible and done so in 33 days — a feat that few sailors in small boats have surpassed — and had instinctively chosen the route that such sailors continue to follow.

October 12th is the date that Columbus wrote in his Diary **but** — he was using the Julian calendar whereas we use the Gregorian which was not adopted until 1582. Between the two is a difference of 10 days.

So, actually our holiday commemorates a day when he was still at sea.

2. Look into shelter adoption first.

3. Don't be an impulse buyer. A puppy might look cute in the window, but once you take it home you could end up with a lot more than you bargained for. With a reputable breeder, you might have to wait for a puppy to be

born or to grow old enough to take home, but health guarantees are worth it.

4. If you make a decision to go with a purebred, try to stay local. Make sure to check the background and get references for the breeder, and visit the home where the mother dog and her puppies live to you can be sure it is an ethical breeder.

5. Speak out! Tell your friends, family, and social networks about the danger of puppy mills. Education is the best solution for most any wrong.

6. Know your state's dog breeding and selling laws. If you have a puppy from a puppy mill, know how to protect yourself and enforce the laws that are already on the books. Start here: www.animallaw.com.

7. Support and recommend legislation that regulates the breeding and selling of animals.

8. Support organizations that act

as watchdogs over breeders. This can either be with your money, time (volunteering for shelters and rescue groups), or talents (writing letters, organizing events, vaccination programs).

THE ROOTS – THINGS FALL APART (3LP-Vinyl) Geffen + Urban Legends

With all-star features from Erykah Badu, Common, Mos Def a.k.a. Yasiin Bey, Jay Dee, DJ Jazzy Jeff, Dice Raw, Eve, Beanie Segal, Jill Scott, Lady B, and Ursula Rucker, Things Fall Apart received numerous accolades and awards. A Nostalgic Remembrance



It's hard to believe, I am now the senior person in the family. I sat with my son John's fatherin-law at Christmas dinner and we talked about the roles we are now expected to play in life. He's a lot younger than I, and along with his wife, travel the country to visit their other children. It's a short hop from New York (where they are from) to Boston to visit their daughter, Beth, granddaughter, Lina, son-inlaw John, and the rest of us. But, his comments are the same as mine, "We are now the senior citizens.

I wanted to make sure I was there when my boys played basketball and baseball. Then Mike added in, "We always knew when you and Mom were there. You could hear her yelling to us from the stands and we could see you standing at a doorway of a gym or behind home plate quietly watching. Many or most of the kids didn't have parents who were there, but John and I had a comfort zone with our parents watching. It wasn't the quality of time; it was the amount of time, and today, we know what it did for us.'

After we headed for bed, I began thinking about my experiences as a youngster, Dad worked day and night. Whenever he could, he was in the stands when I played

During the summers, when he played the county fairs throughout the northeast, Mom and I were almost always with him. There was always that close connection, a connection I see between son John and granddaughter Lina. He has altered his schedule to accommodate being with Lina as much as possible.

I think John and Michael's successes in life are due, in part, to parental closeness. I see it in the next generation and hope I am still here when my grandchildren are old enough to realize that their successes are due, in part, to their parents always being there. It's not the quality time, it's the amount of time spent that sends kids on their way to success, and I will argue the point.

Oh, not to change the subject, but I have to mention something I experienced recently. Loretta and I were returning things that were duplicate presents or not needed. One of the places we stopped at was Walmart. I wandered around and stopped at their BB gun display. And, sure enough, there was a Daisy Red Ryder lever action rifle sitting on one of the shelves. Of course, Ralphie of the A Christmas Story film immediately came to mind. My mind raced back to when I was his age and wanted a BB gun and was told by Nanna, "Carabina ad aria compressa, ti spavera l'occhio." Translated, it comes out to what Mom repeated, "BB gun, you'll shoot your eye out!"

They never did buy me the BB gun, but I saved enough money from birthday and Christmas gifts to buy my own. The cellar became my shooting gallery, and I became quite good at hitting my targets. The box I saw at Walmart hasn't changed over the years and I wondered how many generations of wood-be cowboys owned one. Of course, there were other gas powered air rifles and pistols on display that have been improved over the years, but that Daisy Red Ryder box was the same in appearance as when I bought my gun in 1948 at the age of 10. I didn't ask the cost, but I think I paid \$5.99 for the gun back then. Red Ryder was a fictional cowboy in newspaper comic strips that appeared each week from 1938 until 1965.

OK, I read the funnies in the papers and bought comic books, too. I guess I was no different from most kids from East Boston and the North End. (Thank God)

One of Italy's most famous sweets are biscotti. Plural for biscotto, which means biscuit or cookie, and named "bis" and "cotto" or twice-baked, after their original method of baking. The second bake draws moisture out of the dough, and increases their shelf life. Biscotti were perfect for traveler's years ago, and known to be a staple of sailors, soldiers, shepherds and fishermen. Legend claims they were even savored by Christopher Columbus on his long voyages at sea. Food historians credit Tuscany for creating the first



biscotti, Cantuccini (made with almonds). Today, biscotti appear to be favored more than ever. I can't think of an Italian coffee bar that doesn't serve them. Ranging from soft and crunchy, to dry and hard, and plain to flavored, the varieties are endless. Italy's preferred method of eating the hard, dry biscotti has always been to "dunk" them in a glass of Vin Santo. "Dunking" in coffee is now also widely accepted. Those on the softer side tend to go well with a coffee or cappuccino.

Sifting through my Nonna's recipes, I found one I remember her making often. It is titled "Italian Biscotti," and in the upper corner, she wrote "Lovie's recipe." She was referring to her older sister, my Zia Nancy. This recipe must have been given to her well over 60 years ago. Flavored with the perfect balance of anise and vanilla, "Zia Nancy Delia's Italian Biscotti" are crisp on the outside, soft on the inside, and absolutely delicious. Much too soft to dunk, but positively a perfect accompaniment, as my Nonna served them, to a fresh brewed cup of coffee or espresso!

ZIA NANCY DELIA'S ITALIAN BISCOTTI Biscotti Italiani di Zia Nancy Delia

3 eggs

1 ½ cups sugar

½ cup shortening, melted

½ pound butter (1 stick),

1 ½ teaspoons anise extract 1 tablespoon vanilla extract ½ cup milk

5 cups all-purpose flour 4 ½ teaspoons baking powder

Preheat oven to 350°. Line two cookie sheets with parchment paper and put aside. In a large bowl, beat eggs and sugar until light and fluffy. Add cooled shortening and butter, mix well. Add milk, anise and vanilla extract, beat well. In a medium bowl, sift flour and baking powder together. Take 2 cups of the flour mixture and add to the wet mixture, beat until smooth. On a wooden board, pour remaining flour mixture and make a hole in the middle. Add liquid batter and mix well with your hands, until dough forms. Divide dough into 4 pieces. Roll each section into a log about 1 ½ inches in diameter, and the length of the cookie sheet. Place two logs, spread apart, on each of the prepared cookie sheets. Pat down so they are even in height, and bake at 350° for about 25-30 minutes, until light brown. Remove from oven; slice each log into 3/4 inch pieces. Place slices face down on cookie sheets and second

The Bear of Sankebestu

Powerful predators though they may be, bears, like most carnivores, tend to avoid humans and turn aggressive only when they or their young are threatened or they are too injured to hunt their natural prey. Unfortunately, due to their size, strength and intelligence, when bears do attack, the results are often fatal.

Among the worst bear attacks in history, certainly, the worst in Japan, occurred in December of 1915, in the small agrarian village of Sankebetsu, in the island of Hokkaido. Between the 9th and the 14th, a rogue Ussuri brown bear woke up early from hibernation and, with a shortage of food, terrorized a small village resulting in the death of seven farmers.

The incident, perhaps, turned deadlier than it needed to be due to the ignorance of the locals and, in fairness, some bad luck. The bear's haunts started out harmless enough and could even be attributed to normal bear behavior given the circumstances. In mid-November, the bear awoke from sleep and prowled the surrounding area for food. Not finding any in the wintry forest, it wandered into a nearby farm owned by the Ikeda family. Yells from the frightened horse alerted the family, but the bear ran off taking only harvested corn. Finding the farm a secure source of food, the bear returned on November 20th and again made off with corn.

Having now seen the bear, the family's second son Kametarō hired some local gunslingers to stay on watch for the bear's inevitable return. Ten days later, with a snowstorm pending, the bear returned. The watch shot the bear, wounding it and the beast ran off into the forest. The next morning, a small hunting party was assembled and followed the bear's blood stains into the forest until the snow became too heavy. The party assured themselves that having been injured, the bear was now too frightened to return. They could not have been more wrong. The bear was now enraged and too weak to scavenge for food. Unwittingly, the hunting party likely ensured the tragedy that was too come.

On the morning of December 9th, the bear returned and this time the results were horrific. This time, the bear wandered into the Ota family farm where the wife, Abe Mayu, was babysitting a local infant named Hasumi Mikio. The bear attacked the infant, killing it, and then turned toward Mayu. Although the woman threw firewood at the animal, the powerful predator dragged her off into the forest.

It was not until the next day that a search party was organized to track down the bear and recover Mayu. The hunters encountered the bear soon enough and five fired shots at it, but only one managed to hit it and the bear once again escaped with only a bullet wound. The remains of Mayu were found, however. The bear had buried them in the snow

to hide them from other predators and scavengers.

The hunters regrouped that night and returned to the Ota farm expecting the bear to return. Sure enough, the bear reappeared and the one hunter to fire at it missed with the bear once again running off into the wilderness. The group of fifty or so hunters, however, took off in pursuit.

Little did the hunters know, however, that another tragedy was in the making. Instead of heading for the forest, as the hunters presumed and took off for, the bear ran off to a neighboring farm owned by the Miyouke family. News of the massacre at the Ota farm had already reached the Miyouke family but, nonetheless, Yayo, the farmer's wife, remained home along with other mothers and children from the village. She was cooking dinner for the small group that had taken refuge in her cabin while the men hunted the animal when she heard a strange noise coming from outside the cabin. Before she could head out, the bear broke through the window, extinguishing the lantern and throwing the cabin into darkness. Yayo's first instinct was to flee the cabin carrying her son Umekichi but, in the darkness, tripped over her other fleeing son Yujiro. The bear pounced on Yayo and Umekichi but, a lone guard that stood behind to watch the cabin drew the bear's attention away, giving Yayo a chance to escape the cabin with her children. The bear wounded the guard and killed two of the local boys that had taken shelter in the cabin and wounding one other. The bear's final victim in the cabin was a pregnant farmer's wife whose husband was among the hunters tracking the bear

Meanwhile, the hunting party realized they were not on the bear's trail and turned back toward the settlement. En route, they encountered Yayo who told them of the bear's attack on the Miyouke farm. The hunters hurried back and found the cabin in disarray. They could hear the animal moving inside and proposed setting the place on fire, but Yayo pleaded them not to thinking there may be survivors inside. Agreeing not to set the place ablaze, the hunters, instead, surrounded it with their guns pointed, awaiting the bear's exit. When the bear ambled out, the hunters went into a panic, with guns misfiring, and the animal escaping into the night once

The first order of business was searching the cabin for survivors and two children (a boy and a girl), both injured, were rescued. Along with other wounded victims, they were sent to a nearby farm for treatment and other locals simply left the village.

Two locals who were away on business during the attacks, however, Miyoke Yasutarō and Saitō Ishigorō, whose families were among the dead, returned to the village and, speaking to wounded survivors and other



locals began to gain information on the bear's movements. The two men decided to enlist the help of the police. Police Chief Suga, organized a sniper team of sixty men to track down the bear. First, the crew returned to the village and found evidence that the starved bear returned to the by-now abandoned Ota farm, where it devoured the supply of harvest. With a professional team accustomed to combat in rugged terrain, the village set off to hunt the animal in the mountains.

The 13th passed relatively uneventfully, but on the morning of the 14th, two of the snipers, Yamamoto and Ikeda Kamejirō, took off in a solo search for the bear. Yamamoto soon found the animal resting beneath a tree. With two shots, he finally managed to kill the animal.

What caused the bear to act in such a manner? Encounters with wildlife, though sometimes fatal, seldom bring so much carnage. Perhaps it's important to note that details of the incident are scarce as little was recorded of the case for decades. By the time historians and scientists attempted to create a record of the case, most of the villagers who lived during the attacks had since died or couldn't be found. The remains of the bear also have disappeared and brown bears and humans have coexisted with little conflict in Japan since.

Two things, however, seem likely. Naturalists wildly believe that the bear had woken from hibernation early in hunger. A bear's natural prey is always scarce in winter but the area of Sankebetsu proved especially devastating for a predator as heavy deforestation following the Russo-Japanese War had decimated both land and food for the local wildlife. Further, some blame must be put on the villagers who first encountered the bear, wounding the animal and failing to finish it off. Animals are at their most aggressive when wounded and leaving a starved bear to roam around the village with a bullet wound adding to its pain is a sure-fire recipe for tragedy.

What is Wrong With Red Sox Ownership?

Earlier this week, the MLB Commissioner's office released its findings in a report of cheating during the 2017 season involving the World Series-winning Houston Astros. Baseball lowered the boom on the Astros, suspending both the team's general manager and manager. Within 24-hours, the owners of the team FIRED both these guys. Then, they started a housekeeping operation.

Days later, Red Sox owners John Henry and Tom Warner released a statement saying that the Red Sox and Alex Cora have mutually agreed to parting ways. No mention of the signal-stealing scandal or any apologies from either side. They seem to be hugging and kissing each other as they parted ways. What an insult this is to Red Sox fans anywhere here or in Puerto Rico.

I expected more from the Red Sox operation. More on this story next week when I am a bit less angry.

Looking at that One Day In Larsen's Career

Back in the 1950s, I was just becoming baseball fan, I kept a close eye on our Red Sox no matter how badly they performed. However, I was closely watching the NY Yankees who always seemed like winners back in those days. My favorite slugger was Mickey Mantle, my favorite starting pitcher Whitey Ford, and my favorite second baseman Bobby Richardson. In fact, I could rattle off the top of my head both teams' starting

lineups and starting rotation.

I remember Don Larsen, who pitched a perfect game against the Brooklyn Dodgers in the 1956 World Series when I was 8 years old. The Yankees acquired Larsen on November 17, 1954, but being only 6 years old at that time. I barely remember it. I do remember the trade between the brand-new Orioles and Yankees involving 17 players; I kid you not. It remains to this day, the largest deal in baseball history.

The Yankees got Darrell Johnson who would end up a Red Sox manager in 1974-1976 including the 1975 Red Sox Pennant winners who lost to the Big Red Machine. The Yankees also received Bob Turley who won the Cy Young in 1958, and was the 1958 World Series

Larsen was 45-34 with a 3.50 ERA in five seasons with the Yankees. He also had a 2.67 ERA in seven World Series games and picked up two rings along the way. The Yankees traded him to the Kansas City Athletics after the '59 season as part of a seven player deal that included the Yankees getting Roger Maris.

Overall, Larsen was 81-91 with a 3.78 ERA in 14 seasons with 7 teams. However, it was that one game in that 1956 World Series when 27 Dodgers came up to bat and 27 Dodgers walked back to the dugout after getting out. A perfect game: no runs, no hits, no runners. No nothing! Forget his other stats; this is the only stat that counted in this one game when he was invincible.

As we are now heading into our own Roaring 20s, I wonder if we will ever again see the likes of another Jack Dempsey? I very much doubt it.
















HOOPS and HOCKEY in the HUB

EAGLES ARE EXCELLENT —

With so much continually going on with professional sports in the Hub, a major athletic achievement in the college basketball ranks was somewhat overlooked earlier in the month.

We refer to the triumph by the Boston College men's basketball team over defending national champion Virginia 60-53 up at the Heights shortly before the second semester commenced.

The relatively low scoring game was in keeping with Virginia's defensive strengths—the Cavaliers entered the contest as the top ranked defensive team in the nation.

At one juncture midway through the second half BC actually led by 12 points at 42-30. Then the Cavaliers went on a 20-3 run — including a streak of 10 unanswered points — to take a 50-45 lead with just over five minutes left in the contest.

But then the Eagles went to work on a run of their own — outscoring Virginia 15-3 down the stretch. The go-ahead three point shot was scored by Jared Hamilton with a little more than half a minute to go. He finished with 16 points, one behind teammate Jay Heath who scored 17, including nine on a trio of three pointers.

What sealed the deal was BC's foul shooting down the stretch. The Eagles were a perfect four for four from the charity stripe in the final half minute as they claimed one of the most significant victories by a Boston College team in quite some time.

And, by the way, those 60 points that the Eagles scored against Virginia in the win were the most a BC team has put up against the Cavaliers since 2011. As of January 14th, BC had a 9-7 overall record and was 3-2 in the Atlantic Coast Conference.

ALL-STAR MEMORIES — It was 63 years ago (January 15, 1957) that the seventh NBA All-Star game in history was played at the original Boston Garden. The East All-Stars defeated the West All-Stars by a 109-97 count in a contest that was witnessed by 11,178 fans.

Three players from the Celtics took part in the game. Bob Cousy was named the Most Valuable Player, scoring 10 points while assisting on seven other baskets and capturing five rebounds.

Bill Sharman provided the highlight of the game in the closing seconds of the first half when he attempted a long 70-foot pass to Cousy that instead wound up going into the basket for two points — there wasn't a three-point shot way back then.

Current Celtics TV broad-caster Tom Heinsohn also saw action, scoring 12 points and coming away with seven rebounds. Ed Macauley, who had played the six previous seasons in Boston, saw action on the West team as a member of the St. Louis Hawks. He had seven points, five rebounds and three assists. Bob Pettit, one of Macauley's teammates on the Hawks, led all scorers with 21 points.

Mendy Rudolph and Sid Borgia, who would go on to have long careers as NBA referees, officiated the game. Legendary Celtics Coach Red Auerbach directed the East All-Stars from the bench.

Seven years later (January 14, 1964) the 14th All-Star Game in the history of the NBA was played at Boston Garden before 13,464 fans.

This time the West won 111-107 with three Celtics players participating for the East team. Bill Russell scored 13 points, grabbed a game-high 21 rebounds and had two assists while teammate Sam Jones had 16 points, four rebounds and three assists.

Tom Heinsohn was in the mix once again with 10 points and three rebounds. The BIG O-Oscar Robertson from the Cincinnati Royals — also played for the East squad, leading all scorers with 26 points and earning MVP honors in the process. Red Auerbach was in charge of the East team once again with Mendy Rudolph and Sid Borgia officiating as they did in 1957.

The West team featured a glittering array of basketball talent. Wilt Chamberlain of the San Francisco Warriors had 19 points and 20 rebounds plus one assist while Bob Pettit from St. Louis had 19 points and 17 rebounds. Jerry West — whose outline later became the official logo of the NBA — had 17 points while Elgin Baylor had 15 tallies and Walt Bellamy added 11.

Interesting, two players who would figure in the one of the most famous plays in the history of the Celtics were members of the East squad — Hal Greer and Chet Walker of Philadelphia.

Some 15 months later — on April 15, 1965 — in the seventh and deciding game of the Eastern Conference Finals against Philadelphia at the Garden, it was Greer who attempted an in-bounds pass to Walker in the closing seconds of the game, only to have it intercepted by John Havlicek who directed the ball to Sam Jones, preserving the 110-109 victory for the C's.

The radio call of the play by legendary Celtics broadcaster Johnny Most ("Havlicek Stole the Ball") remains one of the iconic broadcasting moments in the history of the team.

Sadly, this was the last time an NBA All-Star Game was played in the Hub. It's been 56 years since the NBA All-Stars left Boston's famed parquet floor at the conclusion of the game on that January day back in 1964.

The 2020 NBA All-Star Game will be held at the United Center in Chicago on February 16th. Last year's game was in Charlotte. Going forward, the 2021 contest is scheduled for Indianapolis, while in 2022 it will be played in Cleveland, and in 2023 it will move to Salt Lake City.

That means that the earliest the NBA All-Star Game could return to the Hub would be in 2024 — a full 60 years since it was last played on Causeway Street.

When (or whether) the NBA All-Star Game will return is anyone's guess. But at the minimum you'll be at least four years older if it does.
