# Local Police Officers Graduate from the MPTC Police Academy

On January 16th, the Municipal Police Training Committee (MPTC) Executive Director Robert Ferullo and Plymouth Academy Director Eileen Goodick announced the graduation of 48 police officers from the MPTC Plymouth Police Academy's 75th Recruit Officer Class (ROC). The graduates successfully completed over 20 weeks of intensive, standardized training in all aspects of law enforcement and will now serve as full-time officers representing 27 police agencies across Massachusetts.

"The latest MPTC graduating class represents our investment in the future generation of public safety leaders who are well-prepared to protect and serve their communities and advance public safety across the Commonwealth," said MPTC Executive Director Robert Ferullo (Ret. Police Chief). "I commend their commitment to meeting our statewide professional training standards, which has prepared these officers to provide communities with exceptional policing services by putting into practice

the advanced skills, values, and principles engrained throughout their training."

In a graduation ceremony at the Plymouth Memorial Hall, members of the 75th ROC took an oath and received their badges for service. The new officers represented several police departments and agencies, including Attleboro, Auburn, Barnstable, Bourne, Bridgewater, Brockton, Bunker Hill Community College, Duxbury, Eastham, Emerson College, Foxborough, Harwich, Leominster, Marlborough, Massachusetts Environmental, Middleborough, Milton, Nantucket, Needham, New Bedford, Northeastern University, Pembroke, Plainville, Plymouth, Provincetown, Truro, and Whitman. They join over 300 officers who have graduated from MPTC-operated academies in training year 2023-2024.

As part of the MPTC's commitment to academic excellence and world-class police training, the Recruit Officer Course (ROC) provides over 800 hours of course curriculum designed to prepare student officers for the safe and effective performance of their duties. In keeping with mandates established by the landmark 2020 police reform law, the MPTC curriculum includes de-escalation training based on new use-of-force policies and regulations. Student

training based on best practices related to essential modernday policing needs, including effective communication skills, victim-centered and traumainformed incident response, missing persons and human trafficking investigations, mental health-related emergency response, active shooter and hostile event response, patrol duties, and officer safety and wellness.

Upon successful completion of the Academy, student officers have met all training

#### Veterans Pay for Illegals

The Department of Veteran Affairs is helping pay out millions to medical providers who treat illegal immigrants while a backlog of benefit claims from veterans has grown. The VA's Financial Services has been contracted by ICE since 2002 to process reimbursements claims by providers who offer services to detained migrants.

In fiscal 2022, FSC processed \$94.3 million in claims, according to a July 2023 DHS report. Meanwhile, the pile of claims by veterans and their families has grown to 317, 855 according to the VA..

water but by molasses and its devastation has gone on to become part of the city's fascinating history known as the Boston Molasses Flood.

The Purity Distilling Company in Boston's North End was a local producer of alcohol that had a 2.3-million-gallon tank, fifty feet high and ninety feet wide, which was used to store molasses that was used in the production of industrial alcohol. The tank was often filled to capacity with molasses pumped from ships docked on the river and during the year before the disaster there were several obvious cracks and leaks in the tank that not only dripped the sticky molasses that was collected by the local residents for use at home, but which was never addressed by city inspectional officials.

On Wednesday, January 15th, a typical winter day in



Boston, the temperature was below freezing at dawn but by noontime it was unseasonably warm; the molasses tank sides exploded at the height of the day causing a huge wave of sticky molasses ten feet in height that cascaded down fifty feet from the collapsing tank at thirty-five miles per hour flowing down Commercial Street towards the Mystic River, pushing everything in its brown path from humans, dogs and horses to wagons, carriages, buildings and assorted street life towards the edge of the

river, and killing twenty one people and injuring over a hundred.

The incredible devastation took less than a few minutes to wreak utter havoc and sweep everything in its path and it was to bring nationwide attention to the lack of industrial safety standards, especially in the crowded residential neighborhood of the North End. The cleanup of such enormous quantities of molasses, which was literally two to three feet

### SUMMER OPERA

Just a "saltellare, saltellare, e saltare" (hop, skip and jump) behind the famous Roman Colosseum is the well known "Via delle Termine di Caracalla" which skirts the famous seventeen-hundred-year-old bathtub. During the Months of July and August, natives and tourists alike vie for a seat at the opera, magnificently staged under the stars amidst the ruins of this once majestic structure. It was named for Aurelius Antonius Bassianus Caracalla, the eldest son of Emperor Septimius Severus.

Caracalla was born at Lugdunum (Lyons) France in 188 A.D. and was appointed to be his father's co-ruler at the age of thirteen. It is said that even at this tender age, his treacherous nature was revealed through his attempt to murder his father. Severus died in 211 A.D. and was succeeded by his two sons, Geta and Caracalla. They hated each other from early childhood and an attempt to divide the empire between them met with great opposition so Caracalla resolved to get rid of his brother by assassination. After several unsuccessful attempts, Geta was eventually stabbed while seeking protection in his mother's arms.

Caracalla bribed the Praetorian Guard to proclaim himself emperor and to declare Geta an enemy of the State. Any persons who had been connected or associated with Geta including their children were executed. One historian estimated the number of executions to be at least 20,000.

Caracalla maintained his popularity with the soldiers by showering expensive gifts upon them and by pay raises which exceeded 280 million sesterces a year (about 14 million dollars). It is also said that his cruelty and contempt for the people was equal to that of Caligula and Nero. His greed for more money caused him to grant citizenship to all freemen of Rome and then to send them a tax bill.

His greatest folly was in his admiration for Alexander the Great. From the time of his still stands majestically at one early childhood, Caracalla admired Alexander and imitated him wherever and whenever possible. He even organized a



Macedonian-style infantry unit of 16,000 men who were all born in that ancient kingdom and commanded by officers who were given the same names as those who had served under Alexander. He treated the memory of Achilles with the same kind of veneration, even to the point of poisoning his favorite freedman so that he could imitate Achilles in his grief for Patrocles, the great warrior.

His conduct during wars with other nations revealed his cruel and treacherous nature. He called together the young men of one Germanic tribe as if to reward them and then had them surrounded and butchered by his troops. Friendly kings were invited to his camp, then put in chains and their estates confiscated.

Caracalla offended a Prefect of the Praetorian Guard and was assassinated at Edessa, a city in ancient Mesopotamia, in 217 A.D. after a degrading reign of slightly more than six vears.

What seems to be most remarkable about this emperor are the great monuments which he left behind and which characterize the nature of his lavish expenditures. The first of these great monuments is now in ruinous condition and, of course, we know it as "The Baths of Caracalla." The second monument is the triumphal arch dedicated to his father Septimius Severus and which end of the Forum Romanum.

# L'Anno Bello: A Year in Italian Folklore The Mystery of Our Magical Moon

Every January, I look forward to a certain kind of dark and still night. During a night like this, a mystical hush infuses the air, as if the whole Earth stands holding its breath, interrupted only by quiet wafts of chilly wind. Gray clouds scuttle across the dusky sky, obscuring the stars. I hear the gurgling of melting snow as it rushes down the drainage system, a sound indicative of the frequent January thaws and the cyclical turning of the year. Indeed, the sensation of the coming spring permeates this night, as only short hours before the sky had been a jewel-like hue of deep blue. However, the sight which makes me shiver with the most awe on this night is the full moon suspended above me. She glows with a pearly white incandescence as she winks from behind the passing clouds, adding to the enigmatic mood of the evening. Seeing such a moon reminds me of all the reasons why this heavenly orb resonates so strongly with me: her mysterious beauty, her link to powerful femininity, the way her graceful silver light whispers promises of the changing seasons. The January moon has always been particularly meaningful for me, as she brims with the energy of the new year and forms an elegant and radiant counterpoint to the dark winter skies. She carries the anticipation of the spring, much in the same way as women-centered January holidays like St. Agnes's Day. In all of her manifestations and stages, the moon has captured the attention of societies worldwide, boasting her own slew of

heritage. When I was a child, my dad would frequently sing a catchy pop hit he remembered from his Italian boyhood, whose lyrics intoned: "La luna, la luna, ti portará fortuna" — meaning "the moon will bring you luck." Several Roman deities, the majority of them women, presided over the moon. Diana, the forest-dwelling huntress, was associated with the crescent moon, perhaps because it resembled the shape of her bow. The darker side of the moon belonged to the goddess Trivia, most commonly known by her Greek name Hecate, who ruled over witchcraft, crossroads, and all the spooky aspects of night. Finally, the goddess Luna served as the very personification of the moon, and her name lent itself to the Italian name for "moon." Contemporary Italians still include mentions of the moon in their folklore, especially in the realm of superstition. The most famous Italian moon-related superstition, also repeated frequently in the United States, declares that the full moon exerts an influence over human behavior, encouraging romance, but also lunacy. In fact, the word "lunacy" shares the same root as "luna." Italians also whisper stories of the lupo mannaro, or werewolf, who changes into a frightening beast under the full moon. Sundry moon superstitions include cutting one's hair during a waxing moon, to ensure that it will grow back lusciously as the moon gets bigger, and that pointing at the moon is considered rude and unlucky. These pieces of lore speak to the moon's immense cultural significance.

St. Agnes's Day, or la Festa di Sant'Agnese in Italian, honoring a Roman virgin and martyr killed in the early fourth century. In Italy, this feast is linked to lambs, possibly because of the similarity between the name Agnese and the Italian word for lamb, agnello. Every year, the Pope blesses two lambs brought to Rome on January 21st specifically for the feast of St. Agnes. Significantly, sheep begin birthing lambs and commence the process of lactation around the middle of January. Therefore, la Festa di Sant'Agnese is one of those January holidays that looks ahead to the promise of spring, that honors rebirth and the new life blossoming under the winter snow. However, in addition to livestock, old St. Agnes's Day celebrations sparkled with enchantment and secrets. In the England of yore, the eve of St. Agnes's Day was set apart for romantic divination. Since St. Agnes is the patron of young women, girls would seize this opportunity to perform a plethora of charms in order to dream about their future spouse. These charms involved mysterious activities such ranging from silently walking backwards to bed, baking a cake at night without uttering a word, or repeating a magical rhyme while throwing grain into the soil. The romantic, supernatural nature of St. Agnes's Day perfectly accentuates the frigid, moonlit nights of January, when the moon illuminates the shadowy skies and hints at the spring to come.

Though she is often eclipsed by the warm and fiery sun, the moon provides us with a unique blend of mystical beauty and starry-eyed magic. She is a prominent figure in folklore and mythology, having long amazed people with her changing faces and powerful nocturnal presence. Wielding the mighty ability to affect tides but gentle enough to form lacy patterns of moonlight through the bare winter tree branches, the moon continues to enjoy her place in superstition, as people still repeat tales of her influence on human behavior. I encourage everyone to take time out of their busy lives to glance at the moon in all her splendor — whether she stands as a full white orb, or a glimmering sliver in the sky, or shyly peeks behind slate-colored clouds. One of my favorite moon moments was years ago, when I was driving back home with my mother after visiting my grandmother. A few weeks back, while reading a news story concerning high school football games being curtailed in White Stadium's new plans I remembered back this summer, city officials announced plans to lease White Stadium to a professional women's soccer team and allow this team to play 20 games there. During the time leased to a private soccer league, football games reportedly would not be allowed to disturb the pristine soil. The soccer league is paying the city to both use and rehab this urban football oasis. The city opened White Stadium, formally known as George Robert White Stadium back in 1949 when I was one years old.

How many successive mayors and city councilors have just stood by like fans in a stand allowing this field to fall into such disrepair? I graduated English High School back in 1966 and already then, I saw this stadium site aging. Here we are 58 years later and now the City comes up with a plan to put White Stadium back together again like Humpty Dumpty. Only this time, city officials have decided to lease out the site to the professional soccer team who then would fix this aging stadium in need of much repair. However, there is a tradeoff here, that I believe does an injustice to our city high schools and schoolboy football athletics. Football seemingly gets kicked into the end zone.


I so agreed with Fatima Ali-Salaam, who chairs the Greater Mattapan Neighborhood Council, who stated, "They can't just all of a sudden lose access. If we're giving away the rights to use a public facility, that's a problem. You can't put the needs of students behind that of a private team."

As a member of the English High School Association, I urge all members of the alumni, of whom there are many, to start flooding the City Hall office of Dion Irish, the city's chief of operations and while you're at it, also to Mayor Michelle Wu.

Basically, Irish said that football cleats and the texture of the turf apparently do not go together well. There's also \$50 million going into fixing White Stadium between the soccer league and the city but seemingly a professional women's soccer team trumps high school football players.

One last note, while I rarely if ever support anything District 7 City Councilor Tania Fernandez Rodreiguez says or does, she is correct that the neighborhood surrounding the zoo is in the middle of several plans which appear to be piling up on area residents and, like her, I don't like that most of the city's engagement with this community's future. They are mostly only to be on Zoom with little time for actual public testimony. You say something they don't want to hear, they just mute you. They can't mute you in person.

Government is our business. Either we run it or it runs us. I grew up in Roxbury during the 50s and 60s. If you've grown up in Boston, you know how the system works. Usually, it never works that well too often for any of us. Never give up, never, never, never as Winston Churchill once said, "Stand up, speak out and never take NO for an answer."

This initiative has many facets and components that complement one another in a grand program to highlight the arts of terrazzo and mosaic and to commemorate the important role of Vicenzo Pellarin in the transfer of technology, expertise and artisans from Italy to the New World.

The Foundation will present the City of Union City with a specially crafted Sun Dial measuring 4 feet in diameter, to be placed in Ellsworth Park The site has particular significance because the family of Vincenzo Pellarin settled in Union City, where his son was physician to the City school system for decades. That family home is situated opposite Ellsworth Park on New York Ave. Dedication is scheduled to coincide with Earth Day 2024 festivities.

The Foundation is actively cooperating with The William Musto Cultural Center of Union City and the Mayor's Office to involve the schools and the general public in various projects relating to the art of terrazzo. For example, students may engage in poster contests, essay writing, independent workshop activities and treasure hunts. This latter activity will uncover various places in the local area that showcase terrazzo workmanship. The Foundation hopes to inspire media coverage of as many activities as possible.

Terrazzo is a mixture of stone, marble, glass and quartz chips mixed into a bonding agent (mortar or special cement) which can be applied to various surfaces ranging from floors -Grand Central Station in NYC has fairly new such flooring - to walls and fixtures in homes and public buildings. The Hollywood Walk of Fame employs terrazzo for its star plaques. The mixing, application, curing and polishing are subtle arts known only to the artisans who to this day are trained in special schools like the Scuola Mosaicisti di Friuli in Spilimbergo, Italy. The Foundation hopes to open a line of communication between this special school and students from New Jersey.

The Silvio Laccetti Foundation is widely known in New Jersey for bestowing its Garibaldi Award to high school students who excel in Italian Studies and community accomplishments. 

under the guidance of Angelita, named "Mother Angela of the Cross," lived an authentically recluse contemplative life when they were not among the poor.

From 1885 to 1894, she lived at the Mercy Home run by the Carmelites of Charity. In the nine years she lived with the sisters and with other children, Angelita deepened her life of piety. She dedicated her free time to writing a detailed spiritual diary that revealed the style and ideal of life she was being called to live.

Mother Angela of the Cross passed away on March 2, 1932 in Seville. She was Canonized by Pope John Paul II on May 4, 2003. The Feast Day of Saint Genoveva Torres Morales is January 5th.



she came to understand that true happiness is doing God's will, and it was for this reason

that each one of us is created. This became her rule of life.

At the age of 13, Genoveva's left leg had to be amputated in order to stop the gangrene. The amputation was done in her home, and since the anesthesia was not sufficient, the pain was excruciating. Throughout her life her leg caused her pain and sickness, and she was forced to use crutches.

On November 1, 1871, at the foot of the Cross, she made a private vow to live the evangelical counsels, and in 1873 she received the call from God that would mark the beginning of her "new mission." During prayer, Genoveva saw an empty cross standing directly in front



of the one upon which Jesus was hanging. She understood immediately that God was asking her to hang from the empty cross, to be "poor with the poor in order to bring them to Christ."

On August 2, 1875, three other women joined Genoveva now called Angelita. From that day on, they began their visits and gave assistance to the poor day and night. These Sisters





A Nostalgic Remembrance



The winter of 1960-1961 was very cold if I remember correctly. I had graduated college in June of 1960 and began teaching at Boston Tech that September. I was told that it would be a one-year assignment followed by a position at Hyde Park High School replacing a retiring drafting teacher. That sounded good to me, as Hyde Park High was called the "Country Club" back then.

Many of the faculty members were skiers and would head north on weekends right after the first snowfall. I started graduate school right away, and stayed living with my folks to keep the expenses as low as possible. As a result, Babbononno, who lived with my folks, spent a lot of time with me. As February approached, I had a chance to head to Florida during Presidents Week, as we would have that week off from school.

Babbononno had never been to Florida but knew that there were palm and coconut trees wherever you looked, and the winter temperatures in southern Florida were in the 70s and 80s. He advised that I go to Florida and not to a ski resort in New Hampshire where I would freeze to death. He didn't phrase it that way, but I am being polite.

A musician friend invited me to stay with him in a part of Miami called Coconut Grove. I knew that most tourists to Florida dressed at night in that the Miami Beach hotels required suits or sport jackets. I packed appropriately and was on my way just as soon as I left school on the Friday before the vacation week. When I arrived, I rented a car at the airport

My piano player friend greeted me with open arms but had a problem that I was going have to deal with. It seems that his sister was coming to stay with him without an invitation and he only had one guest room.

I put together a list of Miami Beach hotels that I could afford and tried each of them, but the coming week was the busiest of the year. In desperation, I tried the hotels I couldn't afford (I had a Diner's Club Card). The results were the same ... sold out. Then, I got an idea. I headed to an apartment hotel not on the beach and walked in. I asked a bellhop the manager's name, walked to the front desk, and asked the clerk if I could see him. Of course, the response was, "Whom should I say wishes to speak with him?" I gave the man my name and told him to tell the manager that I was a friend of Jack Kramer who suggested I stay there.

The man at the front desk left for a minute and returned with the manager. I was in a suit and tie and looked professional in spite of my youth. The manager looked me over and then asked how Jack Kramer was. I explained that he was doing so well in business that it prevented him from leaving the Boston-New York corridor. The manager instructed the desk clerk to set me up in a first floor room that they kept vacant most of the time unless there was an emergency. I was all set. The only thing was I had no idea if there was a Jack Kramer in existence. The hotel manager probably didn't know who Jack Kramer was either, but didn't want to make any mistakes, so he played along.

I unpacked and headed across the street to the beach. The sun was hot and the air even hotter. It seems that a heat wave was hitting south Florida to the extent that the water temperature which was usually 70 degrees during the winter was over 80 degrees. I spent a good part of the day in the water and the rest of the time working on a tan. Due to the change of climate and the subsequent loss of appetite, I lost ten pounds over night. When I tried on one of my suits to head out that night, it was quite loose. I went from 168 to 158 pounds. (I wish I was close to that weight now) As a child, I had been to Miami Beach with my folks and Uncle Nick, but this was the first time I was on my own and paying my own way. We spread our blankets out side-by-side and planned a series of activities important to two young Bostonians both on our own for the first time. My friend was staying with relatives who had retired and moved to Miami Beach. After the afternoon at the beach, I headed

back to his relatives house and met the family. They laid out a list of restaurants and nightclubs we should think about to accompany our fun in the sun.

Back then, Miami Beach was one of the most popular resort areas in the country, and during the winter months, it rocked. My friend and I parted company but planned to meet for dinner and the exploration of several clubs one of his cousins put on a list.

That night, I was standing on the corner of Collins Ave and Lincoln Road waiting for my friend to pick me up, and was approached by two young ladies roughly my age. They looked familiar and it turned out that they were from Revere, attended Boston State graduate classes, and were friends of the guy I was waiting for. As a matter of fact, he had asked them to look for us. As a result, we had informal dates for the rest of the week.

This was in the heyday of Miami Beach, as I mentioned before, and every major hotel had a Hollywood name or Vegas act in their main room. That week, I saw some of the greats. Even the second tier hotels had main rooms or cocktail lounges with great entertainment. One place we happened to wander into was a nightclub called Murray Franklin's. The comedian was Freddy Ross from Boston (anyone remember him???) and he was followed by a female ventriloquist. Her dummy spoke with a Jewish accent and they were hilarious. When the act finished, the woman thanked the audience and did so with an Italian accent. When the next act came on, the ventriloquist sat down at the bar. I couldn't resist as curiosity was getting the best of me. I approached her and asked her about the dummy's Jewish accent and her Italian accent. She was Italian from Naples. I asked where she picked up the Jewish accent. It seems that when she arrived in the U.S., she settled in Brooklyn. Anyway, the vacation was a success and when I returned to Boston, my folks were supposed to pick me up at the airport. They drove past me twice,

Many people in this country tend to use overripe bananas to make banana bread. However, I prefer to use them to create an "Italian Banana Donut Cake." This tasty soft and moist banana bread donut cake is perfect when served without icing for breakfast and delicious when iced, as an after-dinner dessert!

#### ITALIAN BANANA DONUT CAKE Torta Ciambella Italiana Alla Banana



#### Cake:

- 1 cup (2 sticks margarine)
- <sup>1</sup>/<sub>4</sub> cup granulated sugar
- 1 cup light or dark brown sugar
- 2 large eggs
- 5 small or 4 large overripe bananas, mashed
- 1 cup full fat sour cream
- 1 <sup>1</sup>/<sub>2</sub> teaspoons pure vanilla extract
- 3 cups all-purpose flour
- 1 teaspoon salt
- 2 teaspoons baking soda

#### Icing:

- 4 tablespoons or 1/4 cup softened butter
- 4 ounces full fat softened cream cheese
- 1 ¼ cup confectioners' sugar
- 1 ¼ teaspoons vanilla extract
- Preheat oven to 350°.
- Grease and flour a 12-cup ring pan and set aside.

In a large mixing bowl, cream together softened margarine and sugars until light and fluffy. Add eggs, beat well and then blend in bananas, sour cream and vanilla, mix together. Sift flour, salt and baking soda together and stir into mixture.

Pour batter into the prepared ring pan and bake for 50 minutes to an hour, or until a toothpick inserted comes out clean. Cool in pan for about 10 minutes before transferring onto a cake platter. Serve plain or generously drizzle with icing. To make icing, cream together butter, cream cheese, salt and vanilla. Add confectioners' sugar until a thick icing consistency results. Generously drizzle over cake.

Whether you enjoy tomatoes sliced, sauced, or cooked in ies suited to your growing your favorite recipe, they taste best when grown and harvested from your garden or container. With more than 10,000 varieties available it can be difficult to select the best ones to grow in your garden.

Start by looking for those varieties best suited to the intended use whether for slicing, cooking, preserving, or snacking. Most seed catalogs and websites as well as plant tags and garden centers provide recommendations.

Bite-sized tomatoes are great for salads, relish trays, and snacking. Trailing varieties like Lizzano, Tumbling Tom, Litt'l Bites Cherry, and Red Robin also grow well in hanging baskets and even window boxes.

Paste and sauce tomatoes have meatier fruit making them perfect for sauces, soups, and preserving. Roma is the traditional favorite with an eggshaped fruit that has thick walls and few seeds. The All-America Selections Early Resilience Roma has excellent disease and blossom end rot resistance and does not require staking. Use paste tomatoes during the growing season for sauces, chop and add them to an omelet, can or freeze them for future use.

Grow a few slicing tomatoes to enjoy on sandwiches, grilled, or on their own. Beefsteak and Better Boy are longtime favorites while Iron Lady, Galahad, and the colorful Chef's Choice series are more recent additions to this category.

Perhaps you are looking for an heirloom tomato, one that

Look for tomato varietconditions. Check with your University Extension for a list of recommended varieties for your area. You will also find helpful information on the best time to start tomato seeds indoors and when to place transplants in the garden.

Start enjoying the harvest sooner with fast-maturing tomatoes. These are perfect if you have a short growing season or are just anxious for your first garden-fresh tomato. Early Girl is a longtime favorite, Bush Early Girl produces more fruit on a compact plant, and New Girl produces bigger fruit and has better disease resistance. Glacier, Alaska, and Juliet are a few of the many others to consider. Check the catalog description or plant tag for the number of days to harvest.

garden space and gardening style. Determinate tomatoes are perfect for small space gardens and containers. Indeterminate tomatoes continue to grow throughout the season producing flowers and fruit until you prune out the tip or frost kills the plant. Stake or tower the plants to save space, reduce disease and insect problems, and make har-

deep throughout the area before it seeped through the streets, was to take about two weeks and was undertaken by the city of Boston fire department that began by washing the molasses covered cobblestone streets with salt water from fire hoses sunk into the river for weeks, trying to wash away the residue of the sweet but devastating substance.

Previous complaints by North End residents of cracks and steady leaks in the tank, which had been covered with brown paint by the company to obscure the evidence, were brought to the public's attention and a lengthy class action lawsuit brought forward the damaging evidence that resulted

in a settlement to those whose family had been killed.

Today, the site of the molasses tank is now Langone Park and Puopolo Park, two open spaces overlooking the Mystic River that offer many amenities for the community residents. It is said by many North End residents that even to this day, that on warm, humid summer days you can still smell the sweet aroma of molasses during the city's hottest weather.

P.S. You can read the actual words and descriptions of this catastrophe as eyewitnesses by actual North Enders in Anthony Riccio's book Stories, Streets, and Saints. Also you should consider purchasing Stephen Puleo's book the **Dark Tide**.





#### Footloose in US Says DHS

The Department of Homeland Security admitted "about 85 percent" of migrants apprehended at the southern border and are being released into the United States. DHS Secretary Alejando Mayorkas made the admission at a private meeting with border agents at the overrun Eagle Pass crossing in Texas. The Del Rio sector, where Eagle Hill lies, saw more than 81,000 migrants hand themselves over seeking a new life here in America in October and November alone.

#### **The Bigger the Better** Three Great Heavyweight Champs Had Their Most Difficulty When Facing Smaller Opponents

The old saying "The bigger they are, the harder they fall" is true when it comes to the careers of Jack Dempsey, Joe Louis, and Muhammad Ali. All three champs had some of their most decisive wins over opponents bigger than they were while having some of their toughest fights against those who were smaller.

Jack Dempsey became known as "Jack The Giant Killer" because of his ability to mow down fighters who outweighed him by huge amounts. Yet, the fighters who gave him the most problems were those who were smaller than he was.

Before winning the title, Jack beat 6'4" Carl Morris three times. In their third fight, Morris outweighed Dempsey by at least 35 pounds. Morris was no match for the fast moving and hard punching Mauler.

In a fight that has become one of boxing's most legendary, Dempsey inflicted a brutal beating on champion Jess Willard. Willard stood over 6'5" and outweighed Jack at 245 pounds to 187 pounds, nearly 50 pounds. In the fight, Dempsey was like a lion attacking its prey. Again, he used incredible speed combined with ferocious power to mow down the Pottawatomie Giant.

Dempsey also did well against Luis Angle Firpo who had nearly 25 pounds on him. The fight is best remembered for Dempsey being knocked out of the ring, but other than that exciting moment, it was a pretty one sided affair with Firpo hitting the canvas nine times before being counted out.

Whom did Dempsey have the most difficulty with? It was the fighters smaller than he was or about the same size.

While Jack won a fairly one-sided decision over 175 pound Tommy Gibbons, he not only could not kayo the smaller man, and he was unable to hurt him. Of course, it must be noted Gibbons fought just to survive and go the distance. Given that, Tommy still had the speed and skill set to avoid Jack's vicious blows.

The man who defeated Jack for the title was about the same size as the champion. Gene Tunney had spent most of his career campaigning as a light heavyweight. Fighting at that lower weight he developed more skills than the bigger heavyweights while also having great speed. And while Dempsey was very fast, that quickness wasn't as effective when he was in with an opponent who could match him or out speed him. The bigger guys were a much easier target for him. Even in his winning fight against Jack Sharkey, which took place between the two Tunney fights, Dempsey was taking an awful beating before kayoing Sharkey with a controversial left hook. The two Jacks were pretty even in height and weight.

After winning the title, Joe had some pretty one-sided wins over much larger men. He twice kayoed Abe Simon, who weighed over 250 pounds. He also won two fights with 6'6" Buddy Baer. The first by disqualification and the second via a first round knockout dropping Baer three times.

As with Dempsey, Joe's toughest fights were with the smaller men. His legendary first fight with Billy Conn was the closest he came to losing the title at that point in his career. And in 1947, Jersey Joe Walcott who was 20 pounds fighter lost a very controversial split decision to the champion.


In Joe's ill-fated comeback in 1950 he was beaten by champion Ezzard Charles. Ezzard was over thirty pounds lighter.

When it comes to the heavyweights most people seem to think the bigger the better. However, history doesn't bear that out. Muhammad Ali had a relatively easy time beating big men such as Sonny Liston and George Foreman while struggling with the smaller Doug Jones and Jimmy Young. It was the lighter Sonny Banks, Henry Cooper, and Joe Frazier who were the only men to deck him.





Back from an extended trip to Wisconsin for the holidays that encompassed three weeks between the trips out and back plus time with relatives.

This may surprise some people seeing how Buffalo has made the headlines of late because of all the stormy weather but in our two trips through the area we had no problems whatsoever. Both going out and coming back the roads were excellent in that area with the weather cold but clear and dry. It certainly didn't seem like the Buffalo we saw online after we returned with over two feet of snow on the ground plus bitter cold temperatures.

But by and large the trip back was a challenge, especially around Cleveland on the way back with fog, rain, and spray put up by passing tractor trailers. When it was all over it seemed odd that the best part of the trip home was the area around Buffalo — a region that would become snowbound just a few days later.

By the way, the two left lanes on Interstate 80 just south of Chicago could be a training ground for the Daytona 500. We drove in the far right hand lanes but glancing over to our left, it appeared to be a whole different world with high speed vehicles, tailgating, and risky passing maneuvers. In reality, it did not seem that there was a speed limit in those lanes. That certainly was not for us.

After we returned we saw a still photo of the snow-covered New York Thruway near Utica. We found it hard to believe that the highway was the same one we had driven down just some four days earlier.

While we were in Wisconsin we celebrated a "Green Christmas" with no snow on the ground, although a few inches arrived just days later. But all in all, there wasn't any challenging weather during the time we were there.

Athletically, we are not in favor of the outdoor "icebox" football games that often accompany the weather in the northern regions of the U.S. this time of year. We think it takes away from showcasing the true athletic talent that could be much better put on display in geographical areas where playing conditions are more favorable.

If executives were really thinking of the fans, outdoor games would never be scheduled in these areas for this time of year. In addition, you have the possibility of accidents as both fans and people who must work at the games attempt to drive through such conditions.

A STAT THAT MAY STING THE BRUINS — It is there in the standings every day but because the B's are currently in first place in the Eastern Conference, it may go unnoticed. Until it rears its somewhat ugly head near the end of the regular season.

It is the column headed "OTL" in the standings — short for overtime losses. And the Bruins have a bunch — nine to be exact through games of January 16th. That was second to the New York Islanders who had a league-leading 10.

You can look at it as a positive of sorts, even though you lost, the team still earned a point, which it better than a regulation loss. But by not picking up that extra point in overtime, you are losing a precious tally in the standings.

No, it will not determine whether the Bruins will make the playoffs. The Bruins are a quality playoff team. But those OTLs could determine whether the Bruins have an extended playoff run with home ice advantage. Simply put, if the B's had won five or six of those games by this time, those additional points would place them further ahead of both Florida and the New York Rangers two teams that are nipping at the heels of the Bruins for overall leadership in the Eastern Conference.

It is also an odd stat in that some teams do not have many OTLs — perhaps because they have lost many games in regulation without going into OT. For instance, Ottawa, the last place team in the Atlantic Division, did not have a single OTL through January 16th. In the Western Conference, Anaheim had one while San Jose had four.

On the other hand, Edmonton a team with a winning record in the Western Conference, also had only one, proving that by winning most of your games in regulation (and some in OT) you can avoid the possibility of those pesky OTLs.

WOMEN'S BEANPOT AT THE GARDEN — It will be Commonwealth Avenue versus Huntington Avenue at the Garden on January 23rd as Boston University and Northeastern University face off in the first Women's Beanpot Championship game to be held on Causeway Street.

Joe Louis and Muhammad Ali also had the most difficulty with smaller and faster opponents while having it relatively easy with the bigger guys.

On his march to a title shot Joe Louis took out 6'6" Primo Camera who outweighed him by over 60 pounds. Carnera, who fought courageously, was helpless when the fight ended in the 6th round.

Louis also easily handled Max Baer who was taller and heavier than he was. The very hard punching Baer went down in the 4th round and stayed on the canvas for the full count.

It was the smaller Max Schmeling who proved to be a problem for the fast rising Brown Bomber. In their 1936 fight, Schmeling gave Louis a good going over before kayoing him in the 12th round.

While Dempsey, Louis, and Ali were given the most trouble by smaller fighters, the three were also dominant in their divisions because they all had great speed and movement.

When it comes to the heavyweights, speed is a major advantage.
