

# 46<sup>th</sup> U.S. Commander in Chief JOSEPH R. BIDEN, JR.

On Wednesday, January 20, 2021 on the steps of the U.S. Capitol Joseph R. Biden, Jr., was administered the oath of office by Chief Justice John Roberts as the 46<sup>th</sup> president of the United States as wife Jill proudly looked on.

#### Lizzie Borden's House On the Market

## NY Sues NYPD Over Handling of BLM March

NY Attorney General Letitia James has filed a civil rights lawsuit against the New York Police Department for its handling of a Black Lives Matter protests.

Citing "a pattern of using excessive force and making false arrests against New Yorkers during peaceful protests," James said the lawsuit "specifically charges the NYPD, the City of New York, Mayor Bill de Blasio, NYPD Commissioner Dermot Shea, and NYPD Chief of Department Terence Monahan with failing to address this longstanding pattern of abuse by not properly training, supervising, and disciplining officers to prevent misconduct, despite knowledge and public admission that it violated the rights of New Yorkers."

# ITALIAN AMERICAN MUSEUM OF WASHINGTON DC IS INAUGURATED


The newly-constructed Italian American Museum of Washington DC (IAMDC) was officially inaugurated in our nation's capital on December 15, 2020, in a symbolic ribbon-cutting ceremony that included Italian Embassy First Counselor Domenico Bellantone, Commendatore Robert A. Facchina, whose generous grant made the museum possible, Fr. Ezio Marchetto, chairman of the Casa Italiana

Sociocultural Center, Inc. (CISC), and Francesco Isgro, president of CISC, the non-profit organization that created and oversees the museum. CISC was established in June 2017, to preserve and promote cultural activities for the Italian and Italian American community through educational, historical, and cultural programs.

Earlier in the day, Italian Ambassador Armando Varricchio hosted a celebratory luncheon for the IAMDC committee members and donors Robert and Susan Facchina at his D.C. residence, Villa Firenze. In his remarks Varricchio expressed his excitement at the reality of finally having a museum to showcase "the contributions that Italians and Italian Americans have made in the nation's capital."

#### THE SACRIFICIAL ALTAR



The practice of sacrificing to God before an altar is one of great antiquity, and it probably started prior to the time of Noah. In the case of other personalities out of the past, Homer (about 1100 B.C.) tells of the Greek leaders sacrificing before an altar prior to the start of the Trojan War, while others tell of Romulus and of Alexander the Great engaging in similar practices. We also note that the root of the word altar goes back to the Latin "ara, altare, altus," and "altaria," meaning height.

In the base of the sacrificial altar, the altus was of greater height than the area. The former being erected in honor of superior gods, and the latter to inferior gods. Sacrifices too the infernal (underground) gods were usually offered in trenches or cavities that were excavated in the ground. Altars that were constructed on the spur of the moment were generally made of earth, turf or stones. Otherwise, when time was not a factor, stone or brick masonry was used. The top of the altar usually contained a depression, pan, or brazier, upon which was burned the sacrificial fire.

One point of interest that bears mention at this time was the scholarly activity of

a writer, engineer, and architect, who served as a military engineer under Julius Caesar. His name was Marcus Vitruvius, and while in the twilight of his career, he composed his famous work entitled "Do Architecturea Libri X" (the Ten Books of Architecture), in which he detailed the orders of architecture and set down rules for temple design. He also directed that altars should never be set higher than the statues of the gods before which they were placed.

Another interesting point is that in time all of these ancient altars also became places of refuge. The refugee who prayed before such an altar was considered to have placed himself under the protection of the god or goddess to whom the altar was consecrated. Any violence toward the unfortunate refugee, even to slaves and criminals, under such circumstances, was generally regarded as violence toward that particular god.

The ancients also developed the practice of taking solemn oaths before these altars. During the oath, they took firm hold of the altar or the statue of the deity that it was dedicated to.

## **Commuter Rail and Ferry Schedule Changes** Take Effect January 23rd

Commuter Rail Weekend Service Only on Select Lines Effective January 23rd. Many Commuter Rail Lines to Have Train Service at Regular and Predictable Intervals, Hingham Direct Ferry Service and All Charlestown Ferry Service Temporarily Suspended. Weekday Hingham/Hull Ferry Service Will Operate with Reduced Frequency

The MBTA is reminding customers that Commuter Rail and ferry schedule changes will take effect on January 23, 2021, as approved by the Fiscal and Management Control Board (FMCB) in December 2020.

For a full and complete listing of all upcoming service changes, including all changes to bus routes, Commuter Rail lines, and subway frequency, please visit: mbta.com/ForgingAhead.

#### Commuter Rail Schedule **Change Information:**

The new Commuter Rail Winter Service Schedules are available within specific Commuter Rail line's webpage's at: mbta.com/CommuterRail, and print copies are being made available at major stations this

The new Winter Service Schedule starts to align service with lower ridership levels experienced during the pandemic. Starting January 23, 2021, Commuter Rail will only offer weekend service on the Newburyport/Rockport, Framingham/Worcester, Fairmount, Providence, and Middleborough Lines. These lines experienced more ridership gains over the last several months compared to other lines and serve transit-critical communities. All other Commuter Rail lines will not have weekend service. Ridership has remained low during the pandemic with approximately 8% of regular weekday ridership in the fall of 2020 compared to fall 2019.

The new Winter Service Schedule includes additional trains on the Middleborough Line, Fairmount Line, and Newburyport/Rockport Line. These added trains help to fill in service gaps that existed in the previous schedule and help to offer more consistent train intervals, such as clockface service which makes riding simpler for passengers.

For instance, on the Fairmount Line, the new Winter Service Schedule offers clockface service every hour. From Readville, a train will depart on weekdays every hour at 30 minutes past the hour between 6:30 a.m. and 10:30 p.m. This consistent interval is maintained for all stops on the Fairmount Line, and during higher ridership times additional trains are available.

Since March, Keolis and the MBTA have introduced new technologies, such as electrostatic sprayers, to help sanitize passenger areas quickly and thoroughly. As part of this enhanced cleaning, added attention is given to touch surfaces, employee areas, and air filtration systems. All coach cars continue to be cleaned at least every 24 hours as a protection for passengers and

#### **Ferry Schedule** Change Information:

The complete schedule of upcoming Hingham/Hull ferry trips effective January 23, 2021, is available at: mbta.com.

With ferry ridership approximately 12% of pre-COVID levels, these changes in ferry service effective January 23, 2021, aim to align service with the lower ridership levels experienced during the pandemic. On January 23, 2021, the following changes will occur to ferry service:

• Direct Charlestown (F4) and Hingham (F1) ferry service will be temporarily suspended.

· Weekday Hingham/Hull service will operate with reduced frequency. A total of 17 weekday trips to Boston will make stops from Hingham to Long Wharf (nine trips directly to Long Wharf with two trips also stopping at Hull for a total of 11) and from Hull to Long Wharf (six direct trips total) with the first trip from Hingham at 5:40 a.m., the first trip from Hull at 6:00 a.m., the last trip from Hingham at 7:00 p.m., and the last trip from Hull at 4:20 p.m. Seventeen weekday return trips to Hingham/Hull will make stops between Long Wharf, Hull, and Hingham with

the first trip from Long Wharf to Hingham at 6:30 a.m. and the last trip between Long Wharf, Hull, and Hingham at 8:00 p.m.

• There will be no weekend Hingham/Hull ferry service.

#### **Additional Information:**

The FMCB will assess service needs again on all modes by no later than March 15, 2021, and will allocate additional resources to meet ridership demand if feasible. The timing of all service restoration will also depend on public health guidance (including guidance on the continued need for social distancing) and the timing of the Commonwealth's postvaccination re-opening plan.

The MBTA and FMCB continue to discuss how the MBTA will re-add, rebuild, and increase service. Ridership will be monitored with MBTA staff returning to the FMCB every month to show where ridership stands compared to service planning scenarios. Other data sources will also be monitored, including passenger surveys, employer surveys, roadway data, general travel data, and economic recovery planning. FY22 service levels will be planned beginning in February/ March 2021 as part of FY22 budget process.

The MBTA's Forging Ahead initiative aims to preserve access and quality of service for transit-critical communities and to match service to existing ridership levels. Commuter Rail ridership is approximately 10% of its pre-COVID levels with ferry ridership at approximately 12% of its pre-COVID levels. As part of its Forging Ahead initiative, the MBTA organized a monthslong process to solicit the public's input, including more than 7,000 comments from riders and stakeholders and which was used to shape the final plan approved by the FMCB.

## Over 1,000 Homes Will be Reconstructed At **Boston Housing Authority's Bunker Hill Redevelopment** in Charlestown

community process and with support of local elected officials and the Charlestown Resident Alliance, the BPDA Board has approved the Boston Housing Authority's Bunker Hill Housing Redevelopment in Charlestown, representing an innovative new public-private real estate financing model that will result in the renovation of over 1,000 income-restricted public housing units. Existing residents will be provided with replacement housing during the construction process, and will be allowed to return to a BHA replacement housing unit following the completion of construction.

The newly-approved project will construct a new, multiphase, mixed-use development that will include 15 residential

Following a nearly five-year buildings. Once complete, the project will consist of 2,699 residential units, 1,010 of which will be deeply affordable, BHA replacement units and 1,689 of which will be market-rate. An additional 100 BHA units will be relocated off-site in Charlestown.

The project site is located on an approximately 1.15 million square foot area of land currently occupied by 1,110 BHA public housing units across 41, three-story buildings. Once complete, the project will also create approximately 2.7 acres of publicly-accessible open space, approximately 50,000 square feet of commercial space, an approximately 14,000 square foot community center, up to 1,400 vehicle parking spaces, and up to 2,699 bicycle

storage spaces (1:1 unit to bicycle storage ratio).

Construction of the project will begin with Phase One, which will demolish 6 existing buildings that contain 111 BHA public housing units and construct 2 new residential buildings with 358 mixed-income residential units, 158 of which will be direct BHA replacement public housing units.

The project is located in Charlestown where the BPDA is currently leading the PLAN: Charlestown planning initiative. Guided by Imagine Boston 2030, PLAN: Charlestown seeks to establish a comprehensive and coordinated plan to support neighborhood needs in the areas of transportation, parks and open space, climate resilience, education, and affordable housing.

President of the North End Waterfront Health, affiliated with Massachusetts General Hospital




and a member of the Old North Church.

## L'Anno Bello: A Year in Italian Folklore Sweet and Seasonal Italian Desserts

Note: L'Anno Bello is reprinting articles that were written before the Coronavirus pandemic. Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing (and mask wearing!) is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.



I recently noticed that the culinary world is at war, a drawn-out conflict between cooks and bakers. If one believes the Internet, cooks deride bakers for their supposed lack of spontaneity and creativity; bakers prefer the comfort of following a recipe. This conflict never manifested in my childhood — my mother cooked up a hearty meal of orecchiette with broccoli rabe as easily as she baked my scrumptious birthday cakes. However, as I grew older and developed my own identity in the kitchen, I realized that I am definitely more of a baker. I love the magic of turning the basic essentials of human life, flour and water, into substantial treats. I adore the way the oven warms my kitchen and embraces me with tantalizing scents. Finally, I do see the creativity in baking, in the way one simple recipe can be adapted, tweaked and altered to yield a myriad of delectable results.

A lot of praised has been heaped — justifiably! — on how wonderful Italian entrees are, but oftentimes traditional Italian desserts go unnoticed. So, in honor of my love for baking, I have compiled a list of desserts from the Old Country that stir passion and nostalgia through my veins. Since Italian desserts are plentiful, I will try to focus on desserts that pertain to the current month of January and the upcoming a few hops away. My grandmonth of February, a very sweet mother has always called these

Valentine's Day and Carnival! I hope you enjoy this trip down memory lane as much as my stomach does!

• Cannoli: Arguably the most famous Italian dessert, cannoli are a staple in cookbooks and supermarket aisles everywhere. To find an authentic cannolo, however, your best bet is a small family-run bakery or restaurant, of which Boston's Italian neighborhoods have plenty! The traditional filling for cannoli is ricotta, and the shells must be freshly filled with it to order. Leaving a cannolo languishing with cream inside will make the shell turn from a decadent crisp to a mushy mess. Interesting facts about cannoli: they originated in Sicily, specifically the Palermo region, but they are now enjoyed all over Italy and around the world. Cannoli were originally treats for the Carnival season, when dishes made of rich ingredients were eagerly consumed before the austere period of Lent. The name "cannolo" means "little tube" in Italian, speaking to their distinctive shape!

• Cenci: Known as "angel wings" in English, these fried strips of dough covered in powdered sugar are a real Carnival delicacy in Italy. I loved making them with my grandmother on an early-spring day, when the joyous sensation of Carnival penetrates my bones and the promise of Easter seems just stretch of time indeed due to St. little goodies cenci, but they are known by different names according to the region of Italy. Many of the names reflect the whimsical nature of Carnival, as you will also find them called bugie (lies) or chiacchiere (chatter)!

- Crostata: A crostata is an Italian tart or pie, whose name derives from the word "crust." Crostatas are rustic, free-form pastries, and the beauty of this treat is that the filling can change according to the season. January can call for crostatas stuffed with orange marmalade, tart lemon curd or a fresh pear compote. Next month, why not celebrate St. Valentine's Day by making a romantic crostata with ruby-red strawberry or raspberry preserves, or - my favorite! — Nutella?
- Pizzelle: Hard or soft? Vanilla, anise or lemon extract? No one can agree on what makes perfect pizzelle or the waffled cookies so popular among Italians and Italian-Americans. When there is this much debate about a dessert, it must mean that it has permeated deep into the culture. I am partial to soft pizzelle, but honestly all forms are so good that I would rather eat them than fight about them. Pizzelle are often associated with holidays, like Christmas or Easter, or special events like weddings and baby showers, so much so that I cannot think of pizzelle without imaging some kind of party in my mind. Fun fact: pizzelle originate from Abruzzi, the part of Italy from which my father hailed!
- Tiramisu: I always thought tiramisu was an old Italian dessert, but quick research tells me it is a mid-twentieth century invention. That could be why tiramisu, in its modern incarnation, never appeared in any of my grandmother's childhood cookbooks. One would think that because it is a more contemporary dessert its origins could be easily investigated, but the creation of tiramisu is actually shrouded in legends and myths. Some say the earliest tiramisu was prepared in 17th century Siena for Cosimo de Medici. Others say it was created in the 1960s in the Veneto city of Treviso. All that is certain is that the name of this mascarpone-and-ladyfinger layered dessert means "pick me up," which its servings of espresso will certainly do! A citrus tiramisu made with a lemon-mascarpone cream would be a perfect seasonal treat for the chilly month of January. Meanwhile, traditional tiramisu is a romantic pick for St. Valentine's Day.

What is your favorite Italian dessert? Let me know what makes your stomach grumble and your heart melt like a chocolate zabaglione. Until then, keep cooking!

The sixties up to then had been interesting years. As someone very interested in politics, I thought I could help shape the future. Young people of every generation do that, but my generation thought we were going to be the best.

The year 1968 was going to be special for me because in May I would turn 20 years old and no longer a kid whose age ended in "teen." My heroes back then were Rev. Martin Luther King, Jr. and Robert Kennedy, two rather young leaders trying to make America better for all. Dr. King was an inspirational civil rights leader just trying to improve life for everyone regardless of their color or circumstances. In very many ways, Bobby Kennedy in his political life was trying to also make America what it ought to be about: hope and not hate. About the future of mankind! About justice and equality!

Then, one month before my birthday, King was assassinated on a motel balcony, and a month after my birthday Kennedy was assassinated in the kitchen area of a hotel after winning the California presidential primary election. Just like that, poof, both voices silenced.

I still remember their two voices and how the world moved on in their passing. The trajectory of the future seemed altered overnight with their deaths. How much better might America have changed with King and Kennedy alive.

I decided to stay politically active and did. I became what

Dr. King once said, "Now is the time to lift our national policy from the quicksand of racial injustice to the solid rock of human dignity (Letter from a Birmingham jail)."

There were many cataclysmic moments in those 12 months of 1968. I have been a liberal and a conservative, but mostly remained a political centrist just trying to do what seems right to me.

Alex De Tocqueville once stated, "The evil that one endures patiently because it seems inevitable, becomes unbearable the moment its elimination becomes conceivable."

I did not lose my youthful hope and I carry it to today. You know, someone once said, "The world we inherit is better because those before us struggled for justice, and those changes will survive only if we continue to fight for them."

I never walked in Dr. King's shoes, but my shoes did get close to his shoes back in April 27, 1965, when I met him in Roxbury marching on his way to the Boston Common for a civil rights rally and speech inside the State House.

Now more than ever following the reckoning of racial justice and the 2020 pandemic, we all must find a way to reach the top of that mountain Dr. King spoke of the night before he left us and we must do it all together.

The mantle I grasped as a young college student in the sixties, I still hold with the same enduring hope. That the generations that follow will continue to improve life for tomorrow's

Happy birthday to Dr. King! You had a life worth living and worth remembering. We are all the better for you having traveled with us in our lives.

## Grow Quick, Easy and Nutritious Microgreens

Small grow light kits make growing herbs and microgreens indoors easy and convenient for harvesting and cooking.

Add fresh flavor to your meals year-round with microgreens. These easy-to-grow greens need minimal space and no special equipment for a flavorful and nutritious harvest in little more than a week.

Use microgreens on salads, soups, pizzas, omelets, in stir fries or as a snack. These tiny seedlings are packed with more nutrition than their mature counterparts.

Add a bit of spice to soups and sandwiches with radish and mustard microgreens. Try red cabbage, chard, beets and amaranth for some added color. Sunflower's somewhat nutty flavor makes it perfect for snacking. Let some of your pea microgreens grow a bit taller to use in stir fries.

Fill a shallow container with a two-inch layer of moist potting or seed starting mix. Sprinkle seeds over the soil surface and lightly cover with potting or seed starting mix. Water gently to ensure good seed-to-soil

Continue to water often enough to keep the soil slightly moist. Reduce your workload and keep the planting mix consistently moist by covering freshly planted containers with plastic. Once the greens break through the soil, remove the cover and move the container to a sunny location or under artificial lights.

Increase the fun and success with a microgreen growing kit like the *Organic Herb* and *Microgreens Grow Kit* from Gardener's Supply (www.gardeners.com). This set up is the perfect size for your countertop or other small space. The full spectrum light is adjustable so you can raise or lower it as needed whether growing short microgreens or taller herbs.

Or skip the growing mix and mess with a Jute Microgreens Starter Kit. Set the jute mat in the shallow tray, add seeds, and water. Then compost the jute mat after harvesting your greens.

Follow the planting directions on the seed packet. You typically need two to three tablespoons of seeds for an 11" x 21" tray. Buy enough seeds to make additional plantings every week or two to ensure a constant supply. Microgreens like most vegetables taste best and are most nutritious when eaten fresh. And these tasty bundles do not last long in storage.

The microgreens are ready to harvest once the plant forms the first set of true leaves. These are the leaves that resemble those of the mature plant. This takes anywhere from 7 to 14 days, depending on the room temperature and type of microgreens you are growing.

Use scissors to clip the greens off at ground level. If you prefer to use the whole seedling, roots and all, you will need to wash off any of the seed starting mix clinging to the roots.

Once you harvest all the greens, it is time to replant. Save money and be kind to the environment by composting the used planting mix and reusing containers. Convert shallow fast-food containers into planting trays. Disinfect these or other planting trays before using them for subsequent plantings. Just soak the containers in a 10% bleach and water solution for ten minutes. Then rinse in clear water before planting.

Gardening doesn't get much easier than this. You will enjoy the fresh flavor all winter long as you wait for the outdoor growing season to begin.

#### Celebrating a Culture

The four museum lobbies provide a wealth of information in a beautiful, intimate, and welcoming presentation. The content, artifacts, displays, and exhibitions remind us that "La cultura non si ferma." "Even during this year of a pandemic, we were able to create in record time, the first Italian American museum of Washington DC, dedicated to celebrating the legacy of the Italian culture in the nation's capital," said Isgro.

#### The Museum Themes

IAMDC displays reflect on the following themes: how Italians and Italian Americans influenced the design, construction, and beautification of the capital; the lives, struggles, and achievements of Italian immigrants in the area; the creation and historic evolution of Holy Rosary Church and Casa Italiana; and galleries exhibiting and promoting the works of local Italian and Italian American artists.

#### A Tour of the Four Levels

A quotation on the entry wall by Supreme Court Justice Samuel Alito sets the tone: "It's important for us as Italian Americans to remember the stories, to remember the people who came before us, and on whose shoulders we stand." In this lobby is a unique plaque of individuals who donated funds as part of the CISC Founders campaign, and a marble plaque dedicated in gratitude to the museum donor Robert A. Facchina.

A large wall-size map of Washington DC tells a fascinating story. The map is dotted with locations throughout the city that were inspired by, built by, or beautified by Italian immigrants - monuments, statues, buildings, and other sites that were touched in some way by Italian hands or influenced by Italian minds. This is the Italian legacy in our nation's capital.

Next to the map, a large case displays tools used by Italian stonemasons, including those used to construct the Vietnam Memorial. On display is an actual piece of the original ornate columns constructed by Italian immigrants in the 1860s, which still stand at the Capitol today. The specimen is a gift from the Architect of the Capitol to the museum.

An outstanding feature in the case is a 3-D reproduction, done by local Italian sculptor Davide Prete, of a column he created using hundreds of photographs in the style used by Italian sculptors working inside the Capitol building in the early 1800s.

A large reproduction of Constantino Brumidi's famous mural, The Apotheosis of George Washington, is displayed on the right wall. The original is in the Rotunda of the U.S. Capitol.

The second-floor lobby is dedicated to the lives, struggles, and contributions of Italian immigrants in the area. A large timeline shows important historical events and images that tell the story of Italian immigration and highlight Italian Americans who have made significant contributions to the city and beyond. A large case displays historical objects, documents, clothing, and more, given to the museum by members of the local community.

This floor also includes the Marconi Project of oral histories, another CISC Inc. program. Visitors can sit at two booths and listen to recordings of interviews of local Italian Americans, such as the grandson of an Italian president, an engineer at NASA, and a late pillar of the local business community.

The third floor of the museum is dedicated to the history of the 100-plus year-old Holy Rosary Church and the Casa Italiana community. A timeline visually relates the significant events in the community; a large case displays religious objects, including a silver chalice given to Holy Rosary by King Vittorio Emanuele III. On one wall, various intricate banners of the early religious societies at Holy Rosary Church are on display; some date to the founding of the church. Another case displays the memorabilia, including his early 1900s microscope, of an immigrant from Sicily who set up a medical practice in DC and served the Italian American

community and Italian Embassy staff until 1944. A wall of photographs reflect the work of the Casa Italiana Language School.

On the fourth floor, overlooking the large Piazza Italiana, are two galleries dedicated to the arts and culture. IAMDC has sought and received gifts from more than 30 Italian and Italian American local artists, who created pieces ranging in style from classical to contemporary. The collection also includes exquisite mosaics, ceramics done in several Italian regional styles, and a large pastoral scene done in pietra dura by a member of famous Florentine family.

One of the aims of these galleries is to promote local Italian and Italian American artists, and toward that end, the museum will host art shows and other cultural events as soon as it is safe to gather. "We hope you will get a chance to visit and be inspired

by the many, many stories the museum tells about the Italian heritage in our nation's capital — its past, present, and future," said Isgro.

#### Museum History

When Fr. Ezio Marchetto, pastor of Holy Rosary Church and a history afficionado, first arrived in Washington, DC, he was impressed by the many monuments and public buildings that were inspired by or created by Italians and Italian Americans. He had a vision of creating a museum in the lobbies of the new building at the Holy Rosary and Casa Italiana complex. In 2018, Robert Facchina, an entrepreneur, philanthropist, and descendant of an early local family, made a generous contribution toward helping turn the dream of an Italian American Museum of Washington DC, into a reality.

An all-volunteer museum committee was established to carry out the project. The committee conceptualized the thematic plans for designer. The committee then embarked on Domenico Bellantone the process of further conceptualization,



and researching and writing the content for wall panels on all four floors of exhibits. They also solicited and acquired historical images and artifacts, as well as the artwork donated by more than 30 local Italian American artists for the art galleries. The committee reached out to many members in the community for input, advice, and review of data. Invaluable service was provided by historian Mary Brown, who provided many images through the Scalabrinian archive in New York City.

#### About Casa Italiana Sociocultural Center, Inc.

The Casa Italiana Sociocultural Center Inc., is a nonprofit organization, established in 2017 with the principal purpose of promoting and preserving programs and cultural activities for the Italian American Community in Washington DC. On December 14, 2020, CISC inaugurated the Italian American Museum of Washington DC (IAMDC). CISC has also launched The Marconi Project, a series of interviews of local Italian Americans, which can be accessed at the museum. Other projects include an archive, both physical and soon to be virtual, of the history of the local Italian American community, and the establishment of an Italian American library. IAMDC is located at the Casa Italiana and Holy Rosary Church complex extension, located at 229 F St. NW (3rd St. and F St. NW) Washington, DC. Attendance to the museum is currently highly restricted.

## The Year of St. Joseph

Pope Francis, in a new Apostolic Letter entitled Patris corde ("With a Father's Heart"), marks the 150th anniversary of Blessed Pope Pius IX's declaration of St. Joseph as Patron of the Universal Church that occurred on December 8, 1870. To celebrate the anniversary, Pope Francis has proclaimed a special "Year of St. Joseph," beginning on the Solemnity of the Immaculate Conception December 8, 2020, concluding on December 8, 2021.

Why does the Church have years dedicated to specific topics?

The Church observes the passage of time through the liturgical calendar — which includes feasts such as Easter and Christmas, and seasons such as Lent and Advent. In addition, however, popes can

set aside time for the Church to reflect more deeply on a specific aspect of Catholic teaching or belief.

Why did the Pope declare a year of St. Joseph?

In making his declaration, Pope Francis noted that this year marks the 150th anniversary of St. Joseph's declaration as Patron of the Universal Church. Pope Francis said the coronavirus pandemic has heightened his desire to reflect on St. Joseph, as so many people during the pandemic have made hidden sacrifices to protect others, just as St. Joseph quietly protected and cared for Mary and Jesus. "Each of us can discover in Joseph — the man who goes unnoticed, a daily, discreet and hidden presence — an intercessor, a support

and a guide in times of trouble," the pope wrote. He wanted to highlight St. Joseph's role as a father who served his family with charity and humility, adding, "Our world today needs fathers."

What special graces are available during this year?

As Catholics pray and reflect on the life of St. Joseph throughout the coming year, they also have opportunities to gain special indulgences during the year of celebration.

Why does the Church honor St. Joseph?

Catholics do not worship saints, but ask for their heavenly intercession before God and seek to imitate their virtues here on earth. The Catholic Church honors St. Joseph as the foster father of Jesus. In addition to his role as patron saint of the Universal Church, he is also the patron of workers, fathers, and a happy death.

## Nanna & Babbononno

A Nostalgic Remembrance



I can't lie, I escaped. I'm in Florida for a while writing my stories. I guess I couldn't handle the cold any longer. After we were tested and came out negative, Loretta and I spent the Christmas holidays with son John and his family. Right after that, we escaped.

The winter of 1960-1961 was very cold if I remember correctly. I had graduated college in June of 1960, and began teaching at Boston Tech that September. I was told that it would be a one-year assignment followed by a position at Hyde Park High School replacing a retiring drafting teacher. That sounded good to me, as Hyde Park High was called the "Country Club" back then.

Many of the faculty members were skiers and would head north on weekends right after the first snowfall. I started graduate school right away, and stayed living with my folks to keep the expenses as low as possible. As a result, Babbononno, who lived with my folks and I had a lot of time together. As February approached, I had a chance to head to Florida during Presidents Week, as we would have that week off.

Babbononno had never been to Florida, but knew that there were palm and coconut trees where ever you looked, and the winter temperatures in southern Florida were in the 70s and 80s. He advised that I go to Florida and not to a ski resort in New Hampshire where I would freeze to death. He didn't phrase it that way, but I am being polite.

A musician friend invited me to stay with him in a part of Miami called Coconut Grove. I knew that most tourists to Florida dressed at night in that the Miami Beach hotels required suits or sport jackets. I packed appropriately and was on my way just as soon as I left school on the Friday before the vacation week. When I arrived, I rented a car at the airport and headed for Coconut Grove. My piano player friend greeted me with open arms but had a problem that I was going have to deal with. It seems that his sister was coming to stay with him without an invitation and he only had one guest room.

The next morning, I put together a list of Miami Beach hotels that I could afford and tried each of them, but the coming week was their busiest of the year. In desperation, I tried the hotels I couldn't afford. The results were the same ... sold out. Then, I got an idea. I headed to an apartment hotel a short walk from the beach and walked in. I asked a bell hop the manager's name, walked to the front desk and asked the clerk if I could speak to him. "Of course," was the response, "Whom should I say wishes to speak with him?" I gave the man my name and told him to tell the manager that I was a friend of Jack Kramer who suggested I stay there.

The man at the front desk left for a minute and returned with the manager. I was in a suit and tie and looked professional in spite of my youth. The manager looked me over and then asked how Jack Kramer was. I explained that he was doing so well in business that it prevented him from leaving the Boston-New York corridor for his annual winter vacation. The manager instructed the desk clerk to set me up in a first floor room that they kept vacant most of the time unless there was an emergency. I was all set. The only thing was, I had no idea if there was a Jack Kramer in existence. The hotel manager probably didn't know who Jack Kramer was either, but didn't want to make any mistakes, so he played along.

I unpacked and headed across the street to the beach. The sun was hot and the air even hotter. It seems that a heat wave was hitting south Florida to the extent that the water temperature which was usually 70 degrees during the winter, was almost 80 degrees. I spent a good part of the day in the water and the rest of the time working on a tan. Due to the change of climate and the subsequent loss of appetite, I lost ten pounds almost over night. When I tried on one of my suits to head out that night, it was quite loose. I went from 168 to 158 pounds. (I wish I was close to that weight now)

As a kid, I had been to Miami Beach with my folks and Uncle Nick, but this was the first time I was on my own and paying my own way. The next day, I was back on beach and stopped in front of a young man who looked familiar. He looked at me and yelled out my name. I did the same thing and we shook hands. He was a friend from one of the courses I was taking at Boston State College. We spread our blankets out sideby-side and planned a series of activities important to two young Bostonians both on our own for the first time. My friend was staying with relatives who had retired and moved to Miami Beach. We stayed on the beach until late afternoon, and then headed to his relatives house and I met the family. They laid out a list of restaurants and night clubs we should think about to accompany our fun in the sun activities.

Back then, Miami Beach was one of the most popular resort areas in the country, and during the winter months, it rocked. My friend and I parted company but planned to meet for dinner and the exploration of several clubs one of his cousins put on the list.

While I was standing on the corner of Collins Ave. and Lincoln Road waiting for my friend, I was approached by two young ladies roughly my age. They looked familiar and it turned out that they were from Revere, attended Boston State graduate classes and were friends of the guy I was waiting for. As a matter of fact, he had asked them to look for us. As a result, if we wanted, we had informal dates for the rest of the week

This was in the heyday of Miami Beach, as I mentioned

before, and every major hotel had a Hollywood name or Vegas act in their main room. That week, I saw some of the greats. Even the second tier hotels had main rooms or cocktail lounges with great entertainment. One place we happened to wander into was a nightclub called Murray Franklin's. The comedian was Freddy Ross from Boston (anyone remember him???) and he was followed by a female ventriloquist. Her dummy spoke with a Jewish accent and they were hilarious. When the act finished, the woman thanked the audience and did so with an Italian accent. When the next act came on, the ventriloquist sat down at the bar. I couldn't resist as curiosity was getting the best of me. I approached her and asked her about the dummy's Jewish accent and her Italian accent. She was Italian from Naples. I asked where she picked up the Jewish accent. It seems that when she arrived in the U.S., her family settled in Brooklyn, New York. Anyway, the vacation was a success and when I returned to Boston, my folks were supposed to pick me up at the airport. They drove past me twice, and on the third go round, I flagged them down. It seems that I was so tanned, they didn't recognize me. Oh well ... GOD BLESS AMERICA

Every Italian Nonna has her own favorite way of making a ciambella. These traditional Italian ring cakes typically consist of flour, butter or oil, sugar, eggs, milk, essence and leavening. The flavors vary from Nonna to Nonna, as well as the texture and density. Some prefer a citrus flavor while others opt for vanilla, or sometimes even anise. Many Nonna's prefer a dense cake, others like to make a soft and moist one. Some bake their ciambellas in a bundt or tube while many continue to use the old-fashioned ring pans. Regardless of the flavor, texture, or what pan these Italian ring cakes are baked in, nothing could possibly taste better with an espresso or hot cup of cappuccino than a slice of "Torta Ciambella Italiana!"

I cannot begin to tell you just how many versions of these Italian ring cakes or *ciambellas* my own Nonna created. She made lemon, orange, vanilla and sometimes even marble, chocolate or pistachio flavored. Nonna often added ricotta, sour cream or yogurt to her recipes, and each *ciambella* always ended up being incredible. The recipe I am sharing today is one I remember her telling me had been passed down throughout the years. This "Italian Donut Cake" is anise flavored and surprisingly enough, when baked and iced the flavor very much resembles that of an egg biscuit. This slightly different, but oh so delicious "Torta Ciambella Italiana" is one I am confident you are absolutely going to love!

## Torta Ciambella Italiana



4 eggs

3/4 cup sugar

1 cup oil (I used sunflower)

1 cup whole milk, warmed (not hot)

 $2\ 1/2$  to  $3\ tablespoons$ 

anise extract

2 1/2 cups flour

2 teaspoons baking powder

Icing:

2 cups confectioners sugar


2 tablespoons butter, melted 4-8 tablespoons whole milk

1 1/2 teaspoons anise or lemon extract (I prefer lemon)

Preheat the oven to 350°. Grease and flour a ciambella, bundt, or tube pan. In a large mixing bowl, beat eggs and sugar until fluffy. Add oil, then warm milk and extract, blend well. Sift in flour and baking powder, mix together until smooth. Add mixture to the prepared pan, and bake in a preheated oven for 50-60 minutes. Cool well.

**To make icing:** Place confectioners sugar in a large mixing bowl. Add butter and extract, then gradually add in milk (less for a thicker icing, more for a thinner version). Ice cake and sprinkle with colored nanpareils



## Italian Superstitions Explained

Did you know that in Brazil its bad luck to let your wallet or purse hit the floor, as it means you'll lose money? Or that in France it's actually considered to be good luck to step in dog poop with your left foot? Like many countries, Italy also has its fair share of wacky superstitions — and here are some you will have fun knowing about. No sense taking chances.

Don't take a bath when you're sick: When you're feeling under the weather, chances are you want to take a nice hot bath to soothe your pain. According to Italian traditions, however, taking a bath when you're sick will only make you sicker as will going outside with wet hair.

The unlucky number 17: Some hotels in Italy don't have a 17th floor. It's because the number is considered unlucky. The Roman numeral for 17 is XVII, but when rearranged to look like VIXI it means "I have lived," a symbol that's placed on ancient tombstones and associated with death.

Don't place a loaf of bread up-side-down: According to Italian traditions, a loaf of bread must always be placed facing up. This superstition is based on the religious fact that bread is considered a symbol of life, therefore, its bad luck to turn the bread up-side-down or stick a knife into it.

The Evil Eye (Malocchio): Every culture seems to have their own version of the Evil Eye and their own ways to fight it. One thing they all have in common is that the Evil Eye is caused by jealousy and envy. If a person envies you or your family fortunes, s/he may cause a malocchio curse, even without actually meaning it.

Women can "diagnose" the evil eye by dropping olive oil in a bowl of water. If the oil formed one large drop in the middle of the bowl, it is a sure sign of the Evil Eye, but after chanting prayers (that only women were allowed to speak) the oil breaks up into tiny droplets and spreads out. The ritual is said to break the curse of the Evil Eye immediately.

Watch where you lay your hat: After a long day of sightseeing you might be tempted to toss your hat onto your bed — but DON'T!

Putting a hat on a bed is considered unlucky because it's associated with death. According to tradition, when priests visited the dying to give them their last rights, they would remove their hat and put it on the bed.

Never seat 13 people at a dinner table: If you find yourself sitting at a dinner table with 12 other people, then consider yourself unlucky.

Having 13 people around the table at mealtime is considered bad luck, as there were 13 people at the Last Supper.

Single people, avoid brooms: If you're single and you see someone sweeping the floor, make a run for it. If someone brushes over your feet by accident, then you're destined to be single for the rest of your life.

Don't toast to bad luck: When it comes to toasting, there are several things that can cause you to have bad luck. For example, never raise a glass that's full of water and don't cross arms with the person next to you when you clink glasses. Stay clear of air conditioners: Some Italians

believe that these contraptions blow dangerously cold air in your face, leading to "colpo d'art" or a "punch of air."


Touch iron to avoid back luck: In the U.S., people knock on wood to avoid tempting fate. In Italy, it's common for people to "tocca ferro" or "touch iron." Just don't touch a hot iron.

Bless a new home: It's common for people moving into a new home — especially newlyweds — to rid evil spirits and bless their home. Superstitious rituals call for sprinkling salt in the corners of all the rooms.

Eat plenty of lentils on New Year's Every culture has its own set of New Year's traditions. According to Italian traditions, it's customary to eat lentils after the clock strikes 12:00. Also, don't forget to wear red undergarments, as this too will bring you luck in the coming year.

**Carry a cornicello charm:** If you want to protect yourself against the evil-eye, carry a corincello charm around with you at all times. The charm, which resembles a chili pepper or a small horn, represents the horns of the Old European Moon Goddess and will bring you luck.

**Don't spill salt:** This superstition has it that one must toss a handful of salt over their left shoulder to get rid of bad luck-is also common in the U.S. In Italy, it's also customary when passing the salt to place it on the table first before handing it over.



Meanwhile, in New Orleans another young prospect was making a career for himself. Tony Licata, trained by the legendary Bill Gore and managed by Lou Viscusi, was also compiling an impressive record. Tony was also a smart boxer/ puncher whose lightning fast combinations earned him the name "Machine Gun Tony." Tony began his pro career a little ahead of Coiley and was facing stiffer competition than the New England Champ.

In 1971, John Coiley's manager agreed to have his young prospect travel to New Orleans, Licata's hometown, to face Machine Gun Tony. The wisdom of taking this fight could be questioned. While both fighters had similar record, Licata at 29 fights with 1 loss and 1 draw, and Coiley with 24 fights, no losses, and one draw, the level of competition was quite

Out of the opponents Coiley faced only two had winning records. By far his biggest and most impressive win was over Mike Pusateri, and that was a major victory for him. Licata had also defeated Pusateri.

Out of Licata's 29 opponents, only five had losing records and these were fighters he faced early in his career. By the time he was signed to fight Coiley he had wins of such solid fighters as Gene Wells, Walter Opshinsky, Danny McAloon, Luis Vinales, Dave Adkins, and a knockout victory over Lowell's very tough Larry Carney.

Despite this vast difference in the quality of their opposition, Johnny's manager still agreed to the fight with Licata, and on October 27, 1971 they fought over ten rounds with Tony winning a one sided decision. John was cut under his left eye in the fight.

Soon after returning to Boston, Coiley's manager was offered a return fight with Licata by promoter Sam Silverman. The fight would be held at the Hynes Auditorium in Boston. The Coiley team immediately accepted the fight, despite the fact that Johnny was still cut under his eye. The fight would take place just six weeks after the New Orleans battle, hardly enough time for the cut to fully heal. The cut prevented Coiley from sparring in preparation for the fight for fear it might worsen the injury. The only ring work he got was 3 rounds with a heavyweight a week before the contest. In contrast, Licata put in 70 rounds and was injury

Why on earth would Johnny's manager agree to the rematch on such short notice and under these conditions? He shouldn't have. This was gross mismanagement, the kind that results in bad things happening to young fighters. It is boxing malpractice. John was clearly out of his league when he fought Licata the first time. He was given a boxing lesson in New Orleans where Machine Gun Tony's superior experience showed. There was no shame in losing to a fighter of Licata's talent in his hometown, Coiley needed to reset and work his way up facing the type of opponents Licata did with his career. Instead, he was back in on short notice with the man who was his better.

At the time, I spoke with people who were close with Licata's management team.

They told me Tony had actually carried Coiley for the ten rounds in their first match. Their strategy was to get a rematch in Boston where they felt Licata would get more exposure and be able to advance his career.

> His trainer Bill Gore had trained Willie Pep and had connections in the Northeast. It was a smart move on their part abetted any the horrible decision by Coiley's manager.

As for the rematch, it was sad to watch. Licata gave it his all this time. That, combined with the fact that Johnny was

poorly trained for the fight and still injured from the first fight, led to a blowout. Tony gave Coiley a beating for seven rounds. In the eighth he dropped him with a left hook, that knockdown caused a bone separation in John's lower back. In the ninth John would once again hit the canvas. In serious trouble he would now be saved by referee Jimmy McCaron who stopped the fight.

Coiley was shattered by the loss both physically, and more seriously, emotionally. He was back in the ring less than four months later stopping Danny Perez in Boston. That would be the last time his hand would be raised in victory. He had six more bouts after that, being kayoed five times with one fight ending in a draw. I saw him kayoed in Waltham, MA by Stan Johnson. It was an even more brutal beating than the one he got from Licata. This punishment took a severe toll

Back to the question of why his manager took the rematch with Licata? Well, I suppose it could be chalked up to stupidity. Maybe it was greed, but we aren't talking a million dollar fight here. Boxing is different than other sports. Stupid management in baseball or golf results in losing and embarrassment. In boxing it results in brain injuries and even death. There is no excuse for what was done to a handsome and intelligent twenty-one year old middleweight from Cambridge, MA in 1971.

#### HOOPS and HOCKEY in the HUB

A SPLENDID SILVER SETTING — That perhaps is the way to think of the 25th anniversary of the most recent National Hockey League All-Star Game to be played in the

It was the  $46^{th}$  annual showcase of the game's greatest stars with the Eastern Conference defeating the Western Conference 5-4 on a last minute goal by Bruins veteran star defenseman Ray Bourque back on January 20,

The game took place in the same arena we go to today now called the TD Garden but then, in its first year of operation, known as the FleetCenter. The building had opened with an inaugural concert in September, 1995 followed a few days later by a preseason game between the Bruins and the Montreal Canadiens.

As always with a change, some found it difficult to accept a different location. Over the decades they had grown used to the idiosyncrasies of the only pro sports arena they had ever known. But time and technology had placed the handwriting on the wall.

Opened in the 1920s, it simply could no longer meet the expectations of a more modern era. In addition, media members from other cities were often writing articles comparing amenities of the newer facilities in their home communities with the conditions they experienced in the Original Garden.

The All-Star contest was only the second in the Hub, the first coming way back in 1971. There had been a nice promotional buildup to the event starting in the fall when a press conference was held at the FleetCenter to unveil the official logo that would be featured on souvenirs and sportswear.

In addition, the two honorary captains for the contest were on hand, a pair of NHL performers who were central to perhaps the most remembered moment in Boston's long and storied hockey history.

Opponents on that occasion, both Bobby Orr and Glenn Hall both wore broad smiles as they were introduced at the press conference. Their presence brought back memories of May 10, 1970 when Orr had scored his immortal goal by putting the puck past Hall, the goalie for the St. Louis Blues — giving Boston its first Stanley Cup Championship in 39 years.

As the weeks wound down towards the date of the game, expectation ramped up at a fever pitch. Although there were 17,565 seats in the arena, it was estimated that only about 1,500 would be available to the general public.

Most went to Bruins season ticket holders while others went team executives from throughout the league as well as high-ranking officials at NHL headquarters. A good number also were reserved for sponsors and the league's "corporate partners."

At the time it was thought to be the toughest ticket to obtain, only to be exceeded three years later by the 1999 Major League Baseball All-Star Game at Fenway Park. There wasn't a public sale for that game. Only Red Sox season ticket holders could purchase tickets.

The game at the FleetCenter was a good one, in contrast to some later matchups that seemed just to feature high scoring and little else.

But the one in the Hub was competitive, with the Eastern Conference gradually building up a 3-0 lead by early in the second period on goals by Eric Lindros, Pat Verbeek and Jaromir Jagr. But then the Western Conference came to life, scoring a trio of goals by Brett Hull, Paul Coffey and Paul Kariya against a lone marker by the East's Brendan Shanahan. The second period ended with the East holding a slim 4-3 lead.

The final period was scoreless until the West's Teemu Salanne found the range with about three and half minutes remaining. That would have provided an ending worthy of the game. But there was more to come.

In a storybook ending Bourque got possession of the puck in the crease and put it past Western Conference goaltender Felix Potvin with 37 seconds left, giving the East a 5-4 victory. For his heroics, Bourque was named the MVP of the game.

Thus, Boston had not only hosted a highly successful event but the winning goal had been scored and the MVP honors had been awarded to one of the best players in Bruins history on the home ice of the B's. If you had written that in a novel, they would have said you made it up. Yes, at times, reality is truly better than fiction.

Bourque was the center of attention in the postgame press conference. The only time he paused a bit was when someone asked about the check he put on Kariya, the former University of Maine standout then playing for Anaheim.

There is an "understanding" by the players and team executives that the All-Star Game will essentially be a nonchecking event. After all, no general manager would send his best players to an All-Star Game to expose them to the possibility of injuries.

Bourque's check on Kariya came during a brief quiet interlude and the resulting contact with the boards was heard throughout the arena. When asked about it, Ray put his head down for a moment and then faced the media with a somewhat sheepish smile on his face and said "I forgot."

Cam Neely, now the President of the Bruins, was the only other member of the B's, to play in the 1996 All-Star Game. Jagr, who played a portion of one season plus the playoffs with the B's in the spring of 2013, is believed to be the last player on either roster to still be playing competitive hockey. At age 48 he now plays overseas for HC Kladno in the Czech League.
