Governor Baker Delivers 2020 State of the Commonwealth Address

On Tuesday, January 21, 2020, Governor Charlie Baker delivered his State of the Commonwealth address from the House Chamber of the Massachusetts State House.

Governor Baker began the Address with vaping, stating "We led the nation in responding to the growing body of evidence concerning this relatively new activity. As the warning signs of sudden illness, injury, and death here in Massachusetts and across the country became clear, we acted.

We proposed to expand the Medicare Savings Program. Starting this month, 40,000 low-income seniors will save

On Tuesday, January 21, thousands of dollars on their 020, Governor Charlie Baker out of pocket drug costs.

"Our economy is booming, our unemployment rate is below 3% and we have more people working than at any time in our history.

"Strong fiscal management and a robust economy have resulted in back to back billion-dollar budget surpluses, which we used to double down on our Rainy Day Fund. Today, that fund balance stands at \$3.5 billion.

"We also cut taxes for working families, and delivered on a promise made to voters 20 years ago to reduce the state income tax rate to 5%.

"Finally, we've taken bold action to tackle the opioid crisis, and have shown the rest of the nation the way forward.

"We've been able to do all of this by finding common ground, by refusing to engage in the par-



tisan nonsense that consumes so much of our national politics and by putting the people of our Commonwealth first.

"We have to align our health care policies with the nature of illness, and the 21st century hopes and expectations of our residents.

"We're a national leader on climate policy, but we have to take more decisive action.

"Our economic success means we have to address long-standing issues in transportation and housing.

"We have to continue to reduce the skills gap between people looking for better work and the needs of many of our employers.

"And we must ensure that every child, regardless of who they are or where they live, has access to a high-quality education.

"We've maintained access to women's health services in the face of federal cutbacks.

"A Health Connector that had become a national punch line now stands as a model for every other state, providing affordable health insurance coverage to over 300,000 people.

"We've cleaned up the out of control MassHealth program, dramatically.

"Federal disaster relief spending today is almost 10 times higher than it was 30 years ago.

"From fishing and farming to critical public infrastructure and basic necessities like clean drinking water, there's no dispute that the consequences of climate change are real and potentially devastating.

"We created the first Municipal Vulnerability Program in the country, so local communities would have the ability to address future threats before they occur.

"Massachusetts also leads the nation in procuring clean, renewable energy.

"Tonight, I'm committing the Commonwealth to achieving

an ambitious climate goal: netzero greenhouse gas emissions by 2050

"In addition, the Transportation Climate Initiative will deliver millions of dollars in needed investments in our transportation infrastructure. It's a critical part in expanding public transportation, transforming our highways and reducing congestion.

"Decades of underinvestment in the T have combined with the skyrocketing growth of our workforce, and 100 million Uber and Lyft rides every year, to put tremendous pressure on every part of our transportation system.

"We were the first Administration in state history to invest more than \$1 billion a year to Build a Better T.

"We're also the first to fund an unprecedented 5 year, \$8 billion infrastructure modernization program, to improve reliability and add thousands of seats to the system.

"To build on these improvements, we filed an \$18 billion transportation bond bill last year, the largest ever.

"Traffic is also a problem and it's no longer just at rush hour. Transportation Network Companies provide a valuable service, but they clog our roads and operate with very little oversight.

"The sooner we have access to both the tools and the funding, the sooner we can make our transportation system safer, better and more reliable.

"Five years ago, we made a commitment to significantly increase state investments in affordable, workforce, and transit-oriented housing.

"18 months ago, you passed and we signed the largest housing bond bill in state history.

"We are making progress, but demand is outpacing supply.

"Our current zoning laws aren't working.

"We say we want to make

Massachusetts more affordable. And yet, thousands of units of desperately needed housing get majority support from their local communities, only to fail to be built because current zoning laws require a supermajority vote.

"For the sake of our communities, our young people, our seniors and our families, let's find the common ground on housing policy that must be in here somewhere. And let's get this done.

"To keep our economy strong, we're focused on two important initiatives.

Lieutenant Governor Polito just spent a year touring the Commonwealth, hearing from local leaders, legislators, private companies and non-profits, as we drafted our economic development plan for this term.

"The finished product is appropriately called "Partnerships for Growth," because we succeed when we work together. Legislation based on the report will be filed for your consideration next month.

"The second initiative will focus on addressing the persistent skills gap we have, between people looking to work their way up the jobs ladder and the needs and expectations of many of our employers.

"To address this, we'll launch a \$15 million partnership with our vocational schools to give thousands of people, adults and high schoolers, 'hands-on' educational opportunities.

We can lead and represent the very special people of this very special place we call home.

We can focus on progress. Build on what we have. And live up to the ideals, courage and appropriately high expectations of our neighbors.

"Let's make them, and each other, proud.

"God Bless This Commonwealth of Massachusetts.

"God Bless The United States of America."




ATLAS, OTHER VERSIONS

Stories about Atlas are told at least three times in tales from mythology. The first one identifies him as a son of the Titan Iapetus. Atlas supported the Titans in their war against the forces of Zeus, and of course we know that the Titans were defeated. As punishment, Atlas was forced to hold the heavens on his shoulders for all eternity.

The second story is quite involved: It starts with three sisters called the Gorgons. They were awful beings, with hair and girdles of snakes, and anyone who gazed upon them was immediately turned to stone. One sister, named Medusa, was mortal, but the other two were immortal. Perseus, a Greek hero, was successful in a mission to cut off Medusa's head, and was bringing it back to his homeland in a leather bag. After traveling for a full day he came upon the realm of King Atlas. The king was a huge man, who possessed great wealth in herds and land. Most precious to him was a beautiful garden which contained golden fruit, hanging from branches of gold.

Perseus sought only food and a place to rest for the night. Atlas remembered an old proverb about being robbed of his golden apples, so he refused




hospitality to the stranger. Greatly angered, Perseus then held up the Gorgon's head for Atlas to gaze upon, and this bulk of a king was immediately turned into stone. His hair and beard became wild forests, his arms became the sloping sides of a mountain, and his head became the summit. According to the pleasure of the gods, heavens, with all its stars was then caused to rest upon the shoulders of Atlas.

The third story from mythology concerning Atlas is centered around the celebrated "Labors of Hercules." His ninth labor was to fetch the golden apples of the Hesperides. These golden apples grew in the sacred garden of Hera, wife of Zeus, and the Hesperides were three daughters of Atlas, who were assigned to cultivate and watch over the garden. The final item, setting the stage for this last

act, was that of Hercules being informed not to enter the sacred garden, but to send Atlas, father of the Hesperides, instead.

Hercules journeyed a great distance and finally came to the sacred garden of Hera. It was located near the spot where Atlas was holding the sky on his shoulders. Remembering the advice that had been given to him, Hercules offered to relieve Atlas of the weight temporarily if he would gather the golden apples from the garden. Atlas agreed, fetched the apples, and returned shortly. Hercules soon discovered that Atlas did not intend to resume his great burden, but instead, offered to deliver the apples himself. Having this great weight on his back prevented Hercules from resorting to any kind of force against Atlas. Through caution and wit, Hercules pretended to agree to the proposal of Atlas, but begged him to hold the sky just long enough to permit a pad to be placed upon his head. The gullible Atlas laid the apples on the ground and took back the sky. As soon as the weight was transferred, Hercules picked up the golden fruit and started his journey home.

The successful Bidder will be required to furnish a performance bond and a labor and materials payment bond, each in an amount equal to 100% of the Contract price. The surety shall be a surety company or securities satisfactory to the Authority. Attention is called to the minimum rate of wages to be paid on the work as determined under the provisions of Chapter 149, Massachusetts General Laws, Section 26 to 27G, inclusive, as amended. The Contractor will be required to pay minimum wages in accordance with the schedules listed in Division II, Special Provisions of the Specifications, which wage rates have been predetermined by the U.S. Secretary of Labor and/or the Commissioner of Labor and Industries of Massachusetts, whichever is greater.

Critical Type O Blood Shortage:

Red Cross Urgently Needs Donors

Donors of All Blood Types are Urged to Give Now And Help Restock Blood Supply

The American Red Cross has extended its urgent call for donors of all blood types to give blood or platelets. With influenza escalating across the country and preventing some donors from giving, and winter weather threatening to cancel blood drives, the Red Cross now has a critical shortage of type O blood and urgently needs donors to restock the shelves. O so needed

Currently, the Red Cross has less than a threeday supply of type O blood available for patient emergencies and medical treatments. Type O positive blood is the most transfused blood type and can be given to Rh-positive patients of any blood type. While just 7% of the U.S. population has type O negative blood, it can be transfused to patients with any blood type and is what hospital staff reach for during emergencies when there isn't time to determine a patient's blood type.

Help replenish the blood supply — Every day, the Red Cross must collect nearly 13,000 blood donations and more than 2,600 platelet donations for patients who rely on blood to survive. Shortfalls in donations can cause delays in essential medical care for patients like 12-year-old Dagan Hawkins.

Diagnosed with acute lymphoblastic leukemia in November, Dagan has required platelet and blood transfusions during his cancer treatments. "There was a time when they needed to have blood products delivered from another hospital because they were unavailable there," said Dustin Hawkins, Dagan's father.

L'Anno Bello: A Year in Italian Folklore

Lighting Up Springtime

January has gone by quicker than a windswept snowdrift. It seems that just a short while ago, I was cheering the start of a New Year and packing away the last Christmas decorations. This past month has been an unusual mixture of bitter cold spells followed by mild weather, of furiously falling snowflakes and pleasant days filled with the scent of newly-turned soil. I can sense the dueling seasons of winter and spring dancing around me, struggling to maintain their individual grip over these transitional, changeable months. However, February will soon arrive with its bevvy of festivals that decidedly welcome the spring. St. Valentine's Day cuts through the snowy monotony in bursts of red and pink, ushering in the season of rebirth through images of hearts and flowers and Cupids. The revelry of Mardi Gras, replete with mysterious masks and colorful beads, promises to chase the ghosts of winter away. I look forward to the joy and gaiety of these holidays. February starts, though, with a less recognized feast that introduces the month, and the season of spring as a whole, with powerful symbolism. This ancient, rustic holiday is known as Candlemas, and its worldwide traditions evoke the spring with anticipation and light.

Candlemas, which occurs on February 2nd, commemorates the date on which the Virgin Mary presented Jesus at the temple, forty days after His birth. The name of the feast derives from the widespread usage of candles during the religious services marking this and feasting. Pancakes are the holiday, which symbolize the traditional dinner of choice in light that Jesus metaphorically brings to the world. However,

many of Candlemas's folk customs predate Christianity. The Celts celebrated February 1st as Imbolc, a festival heralding the first day of spring. Imbolc, which some scholars theorize translates to "in the belly," honors the lactation of sheep and the beginning of the birthing season for lambs. This ancient Celtic holiday survives as St. Brigid's Day in modern Ireland, where people light candles, make Crosses out of vegetation, and visit holy wells. Indeed, since it serves as a welcome precursor to spring, Candlemas bursts with quaint customs and superstitions everywhere. European folklore states that a warm and sunny Candlemas portents harsh wintry weather, while a cold and blustery Candlemas promises an early spring. Immigrants from Europe brought these traditions over to America, where they melded into the festival of Groundhog Day. Like Candlemas, Groundhog Day is also celebrated on February 2nd, and it further pays homage to the end of the hibernation period for many animals. An Italian dictum repeats this well-known superstition, proclaiming "Candelora con sole, tarde primavera," or "sunny Candlemas, late spring." These practices speak to the universal desire for spring and rebirth, whether it manifests in newborn lambs or candles flickering in the windowsills.

In addition to functioning as a turning point between winter and spring, Candlemas also provides people with an opportunity for celebrations France, possibly because their round shape and golden color

resemble the spring sun, which is now remaining for a longer time in the sky. Superstition claims that a cook who can flip a pancake with one hand while turning a coin in the other will be blessed with luck. In Mexico, people eat tamales on Candlemas, provided by the person who found the hidden bean in their Epiphany King Cake. Italians honor Candlemas, or Candelora, with local festivities and regional customs. Though Candlemas traditions vary across Italy, each honor the arrival of spring and the theme of light breaking through the darkness. In the Sicilian city of Catania, Candelora festivals segue into parades held in honor of the town's patron saint, St. Agatha, where people make offerings of large candles that illuminate the dark late winter sky.

The people of Montevergine, a village located in the southern region of Campania, organize candlelit processions which honor gay rights and pray for increased tolerance. Meanwhile, Neapolitans celebrate Candelora with large street parties boasting torches and fireworks displays. Indeed, all throughout Italy, a visitor will find homes, churches and town squares illuminated by candles or bonfires on Candelora, the flames both providing warmth against the cold February air and reminding people of the light of the coming spring. Candlemas always makes me think of the long walks I would take on my old college campus at the start of the spring semester, propelled by the wind as I took note of the new buds adorning the otherwise bare tree branches. Nowadays, I bake orange cheesecakes on Candlemas, a seasonal recipe whose color and shape resembles mini sunbursts. How exciting it is to greet spring in all its myriad forms!

As winter slowly melts into spring, we should all take a lesson from Candlemas and search for the beacons of light in our own lives. What are the symbolic candles that illuminate our way out of our personal darkness? Which elements of our lives remind us that rebirth and hope are always near, even in the midst of a literal and metaphorical winter? To me, these "candles" include spending time with loved ones, the smell of baked goods wafting through my kitchen, hearty belly laughs, and warm sunsets. These signs remind me that the world holds so much beauty and promise, even when all appears bleak. Candlemas teaches us to look for these signals in nature as well: a frost-encrusted snowdrop flower, the flash of a robin in flight, a night lit with candles. When we hold on to the hope of spring and appreciate the moments our natural world has to offer, we will always hold the beauty of each season inside us - and that knowledge of Mother Earth's endurance will comfort us always.



Saint William of York

Born William fitzHerbert in York, William was the son of Herbert of Winchester, chancellor and treasurer of King Henry I. It is believed his mother was Emma, half-sister of King Stephen or possibly daughter of Hunger fitzOdin, who held lands in Dorset. William was born sometime before the 1090s, but the date of birth is unknown.

William seemed destined for great things. His uncle was next in line for the English throne though a nasty dynastic struggle complicated things. Treasurer of the church in York, England while still young William became a priest and Chaplain to King Stephen.

William was elected Archbishop of York in 1140. His selection was challenged by reformers, especially a group of Cistercians, and William was accused of simony and being unduly influenced by his connections to the royal court. The Vatican investigated, and Pope Innocent cleared him of all charges, and confirmed him as Archbishop on September 26, 1143. However, the charges resurfaced a few years later under Pope Eugene III, a Cistercian; suspended William from his See, and in 1147 removed him as archbishop, replacing him with Henry Murdac, abbot of Fountains. Some of William's supporters took to the streets to defend him, and during a riot, they attacked and burned the monastery of Fountains. William, however, retired to Winchester, and became a monk, noted for his austerities and active prayer life.

In 1154, in the reign of Pope Anastasius IV, William, it's believing was poisoned; it's more likely he died from fever.

Despite all that happened to him, William did not show resentment toward his opponents. Following his death, many miracles were attributed to him. He was canonized 73 years later in 1227 by Pope Honorius III. The feast day of Saint William of York is June 8th.

The Real Christopher Columbus Story

by Carol Delaney, Ph.D.

The following excerpt is taken from Anthropologist Carol Delaney, Ph.D., book Columbus Quest for Jerusalem. Part three of a six part series.

PART 3 THE LANDING

The crew scrambled ashore, kissed the ground, and thanked God for bringing them safely across the great water. Columbus called it San Salvador for their salvation.

Soon "a multitude of people hastened to the shore astounded and marveling at the sight of the ships."

Columbus's impulse towards the people was one of benevolence and friendship motivated by a concern for their conversion.

"I, in order that they would be friendly to us — because I recognized that they were a people who would be better freed and converted to our Holy Faith by love than by force gave them red caps and glass beads and many other small things in which they took so much pleasure and became so much our friends that it was a marvel."

They "came swimming to the ships." And brought us parrots and cotton thread and many other things, and they traded them to us." Then his description of the people, reflecting an almost anthropological attention to detail, comes across as objective, writing what he saw with his own eyes:

"All of them go around naked as their mothers bore them. They are very well formed, with handsome bodies and good faces. Their hair is coarse. Almost like the tail of a horse — and short except for a little in back which they wear long."

The natives must have been astonished to see such heavily dressed men with beards since they had very little facial hair. Columbus also marveled at their small swift boats that he would soon call by the native name "canoe."

We now know that they had arrived in the Bahamas, but Columbus imagined they had landed on one of the many islands described by Marco Polo and was eager to find the land of the Grand Khan.


So they continued on, passing islands all "very green with sweet smelling breezes."

Columbus's eyes pained him and his descriptions give a sense of the therapeutic value of their beauty.

"I also walked among those trees, which were more beautiful to see than any other thing that has been seen. I do not know where to go first; nor do my eyes grow tired of seeing such beautiful verdure and so different from ours ... and the smell of the flowers or trees that came from the land was so good and soft that it was the sweetest thing in the world."

He was overwhelmed not only by the beauty of the trees and flowers but also of the fish and the birds and uses the words "marvel" or "marvelous" too many times to count.

He also marveled at the natives' houses and especially at their "hammocks" which would soon solve the sleeping problems of all sailors.

my household." They headed toward a large island called Cuba which he thought might be Cipango [Japan] and thus thought he would soon reach China because he wrote: "I have decided to go to Quinsay and give Your Highnesses letters to

the Grand Khan." Columbus noted how generous the natives were and demanded from his men that there be an **exchange** of goods. This would become a common refrain as the sailors were rapacious. But while he had control of them he said: "I did not allow anything to be taken, not even the value of a pin."

In early December they reached Haiti which he named Hispanola and when those natives came aboard he "ordered that they should be treated courteously because they are the best and most gentle people in the world, and especially because I have much hope in Our Lord that Your Highnesses will make all of them Christians."

But he was becoming very much annoyed with his sailors when he sent them ashore to explore and compared them unfavorably with the dignity and generosity of the natives. News of his arrival traveled fast and soon he received an invitation from Guacanagari, chief of another area.

On December 24th, they set out in his direction but they arrived last. So they anchored outside the harbor to wait out the night.

The person on watch was careless and before dawn Columbus felt his ship go aground. They were unable to save the ship and he named the place Navidad because it was born" from the Santa Maria.

As soon as Guacanagari saw what happened he sent his people to help unload the ship and had their goods safely stored. Columbus invited him to dinner on the Nina but the chief had already ordered a feast for his men and he and Columbus exchanged gifts.

Robert Fuson, one translator of Columbus's diary wrote:

"Columbus expresses nothing but love and admiration for the Indians. His affection for the young chief Guacanagari, and vice versa is one of the most touching stories of love, trust, and understanding between men of different races and cultures to come out of this period in history."

Columbus had equally effusive praise for the islanders:

"I believe that in this world there are no better people or better land. They love their neighbors like

themselves, and they have the sweetest speech in the world and are gentle and always laughing."

To him, they had already seemed to be natural Christians and he hoped that the friars would be sent to teach them about the faith so they would become true Christians and thus saved.

But his situation was precarious. Martin Minzon, the captain of the Pinta had taken off weeks earlier hoping he would be the first one to find gold so they had only the tiny Nina left. Some men would have to be left behind while Columbus returned to Spain to get a rescue ship. He wrote in his diary that when he returned he hoped to: "find a barrel of gold that those left behind would have acquired by exchange; and that they would have found the gold mine and the spicery, and those things in such quantity that the sovereigns, before three years [are over] will undertake and prepare to go conquer the Holy Sepulchre: for thus I urged Your Highnesses to spend all the profits this my enterprise on the conquest of Jerusalem."

The phrase "for thus I urged" implies that they had already discussed the ultimate goal.

Columbus told the men who would remain to strip the Santa Maria and to build some lodgings for themselves and ordered them to "do no harm to the people and to respect chief Guacanagari to whom they owed so much." Guacanagari held a farewell feast inviting other chiefs to attend.

On January 4, 1493, Columbus said good bye to the chief and the men who would remain. He also took six of the natives, one of whom was a relative to the chief. He said more wanted to come. They were definitely not slaves as many have claimed. On their way they caught up with Pinzon who had captured "four native men and two young girls by force," and Columbus ordered they be returned to their homes."

Sometime later they met a very fierce group of natives who attacked them with bows and arrows. These were the Caribs and the natives on board were clearly afraid of them. Columbus noticed that their language, hair styles and body ornamentation were different, as was their demeanor,

One scholar believes that "The most advanced concept Columbus offered was that of a cultural region - unified by language and customs" — obviously aware that not all the people he was encountering were the same.



THE CAKE

Nobody Has the Corner on Self Righteousness

I almost declined the invitation to review The Cake, now playing at the Lyric stage in Boston. Many works today are taking on societal issues, and getting people to think about what is going on around them while being more open to listening to the views of others is a good thing. It is healthy when we challenge ourselves and our, very often, deeply held views. It doesn't mean we will necessarily change them, but understanding where others are coming from and why they feel the way they do helps to prevent us from putting up walls between one another and feeling anger. As hard as it is to believe, we can actually get along with people with whom we disagree.

The problem with much theatre that I attend today is that it is self righteous. Instead of posing questions that will make us consider other views, many of the works I see tend to preach, and worse, demand that the audience members fall in line with a particular view point. I have received press packages that are filled with materials that all but tell me what I am supposed to feel about the play and about myself. Frankly, I find this insulting and disrespectful. It is also counterproductive.

This used to be rare, but it is becoming too common today probably due to the polarizing times we live in. One exception to this is Ayad Akhtar's *The Who & The What* that played at The Huntington Theatre in 2017 and dealt with the issues facing a Muslim family living in America. It was thought provoking but not preachy. Mr. Akhtar has said "Advocacy is not art, its advertising." I couldn't agree more.


In The Cake, author Bekah Brunstetter takes a similar approach. The play is about a gay couple living in New York, Jen (Chelsea Diehl) and Macy (Kris Sidberry), who have traveled to Jen's original home in North Carolina where they plan to get married. Jen wants the ceremony to take place in the same venue where her parents were wed. Her mother has passed on but it is apparent she is looking for acceptance as she can not know, but does suspect, how her mother would feel about this

The play opens at Della's Sweets, a bakery run by Della (Karen MacDonald) who was close to Jen's mother and has known Jen since she was little. Della is very excited about having become a contestant on *The Great American Bake Off*, and is describing what it takes to make a good cake. Jen wants Della to bake the wedding cake for her and Macy. Macy arrives at the

Della in conversation.

At this point it all seems to be very predictable; the dumb and bigoted hick will respond with hate and disgust at the request while the enlightened couple will be both victim and moral superiors to the backwards folks living down south. That is not at all how this plays.

Ms Brunstetter shows empathy for all of the characters and allows that many issues are not that cut and dried. In a twist, Macy turns out to be the self righteous one who has no room for differing views, while Della is willing to face the conflicts she faces with her beliefs. It is refreshing to see a Southern Evangelical treated with respect. And while Della is willing to question herself, Macy is very judgmental and believes "If you don't want to be a bigot you have to think like me."

Jen is the most conflicted as she had been close to Della and was brought up in the same cultural environment. It is clear that Della is a mother figure to her. Having Della bake the cake for the wedding is important to her, but Jen is also understanding, while hurt, when Della makes excuses for not doing so. Della is also feeling pain as she loves Jen. There is a lot of emotional conflict here that spills over into the relationship between Macy, who grew up in New York, and Jen.

Karen MacDonald is perfect as Della, a woman without an inch of hate in her heart but views that are considered backwards, and even hateful. by big city liberals. Tim (Fred Sullivan, Jr.), Della's husband, is a plumber. This is where I felt things could fall apart as the stereotype so often portrayed of white working class men is not usually flattering. While Tim is set in his ways, he is also a decent man who deeply loves Della. He also enjoys mashed potatoes which makes for a very funny scene, but you will have to see the play to find out what that is all about.

The interactions between Macy and Jen as well as between Della and Tim are both insightful into why they believe the things they do and what they believe about others. It is these hard facts back and forth

that occurs between Della and Jen that really digs into the conflicted feelings they both are dealing with as well as a way to start understanding each other.

Chelsea Diehl digs deep down into Jen emotions, those of a woman with a foot in two cultures. Jen does not agree with Della, but she understands her, while Della's moral code precludes her from baking the cake, her heart tells her it is good that the little girl she has always loved has found someone she is in love with. They truly care for each other.

The one fault I found with the play is in the character of Macy. Kris Sidberry gives us a character that is so certain of her beliefs that she has an almost religious fervor about them, and many of us will recognize that person; the take no prisoner true believer. However, by the time the play moves to where the characters are beginning to find common ground it is too little too late for Macy. She has done something particularly cruel that gets brushed off and shouldn't. And though she finds some common ground toward the play's end, her journey there is not fully developed.

The Cake may involve a baker and the choice not to bake a cake for the wedding of a gay couple, but it is not about the right or wrong of making that choice. This is a play about how listening, and more importantly, treating one another with respect is the way to finding a way to understand one another. A way not to react with hate at that which we do not agree. That goes for all people.

This is a sweet play baked with warmth and humor about people being, for the most part, kind and understanding of one another without having to compromise their beliefs. This is not a dig in your heels political diatribe, but rather a thoughtful look at how we are all human, and of how we really can get along. *The Cake* is refreshing and delicious and is certainly worthy of being tasted.

Now restored, this broadcast has not been seen in full since its original airing. Among the subjects discussed were the current state of the American Civil Rights Movement and the then recent events in Birmingham, Alabama. On that Sunday night in June, WPIX-TV (NY) cleared this extraordinary interview between Susskind (host of Open End) and the Dr. King. Open End had recently been removed from the schedule of WNEW-TV because of the station management's reluctance to air discussions regarding race relations in America. WPIX picked up the ball, and the rest, became history. Susskind and Dr. King discussed the gamut of racial issues of the day, particularly Dr. King's disappointment at the speed at which the Kennedy Administration was moving regarding Civil Rights legislation. "The decision to go into Iraq was, I think, without debate, the worst foreign policy blunder of a generation and I think for any politician, any public servant, your record is your record, and it has to be justified."

Markey hit back, saying he is proud of his record in Congress, and blamed former President George Bush for lying to law-makers in the run-up to the war in Iraq.

A Nostalgic Remembrance



It was a cold January day in the in the mid-1960s, and the phone rang. The man making the call introduced himself as Tony, the manager of Piety Corner Gardens, a complex in Waltham that hosted a restaurant, a nightclub, a function hall, and a men's bar. He told me that I was recommended by a friend and that he was looking for a trio or quartet to play three nights per week in the nightclub for the dancing customers and could back the entertainers who sang, danced, or told jokes on weekends.

A day later, I met with the man at the complex and he wanted an audition before we talked any further. A couple of days later, on an off night my trio and I played a couple of sets for dancing and listening. Tony liked what he heard, and we later talked about a contract. I discussed it with my musicians, and a couple of weeks later we were advertised as the new house band. It was a union contract and Uncle Nick, then the vice president of the musicians' union, became involved. We were all set to go within a two-week period and that first weekend, we played for dancing and backed a female singer, a tap dancer, and a comedian.

I did not like the way the manager treated his help. He was rude, crude, and vulgar, and those were his best qualities. I did not see this side of him leveled at me until one night about a half hour after we started playing. My piano player was as white as a ghost and began shaking. He evidently was coming down with the flu and really couldn't function.

On the next break, I called home looking for Dad. Babbononno answered and I explained my problem. Dad, fortunately, hadn't left for work yet and told me he had a pianist who was free that night, and would immediately call him. Within minutes, Dad called me back (I was in a phone booth). His pianist was on his way. I knew the man and felt confident that he could play all my selections and cut the show with ease.

The minute I returned to the nightclub, I sent my pianist home. I then found the manager and explained the problem and how it would be handled. Once the pianist arrived, which was fifteen minutes late, there was no problem. He cut everything at sight. At quitting time, the manager came over to us, screamed at the pianist for arriving late, yelled at me, and then fired the band. Always the gentleman and businessman. I tried to reason with the man, a Spanish singer from Madrid

but to no avail. We packed up and headed out leaving the dancers with no music except the recorded background elevator music the restaurant used on off nights. This also meant that the entertainers had no background music for the rest of the weekend.

The next day, I called Uncle Nick and told him of the situation. He told me to wait until he was at work on Monday and could review the contract. I later received a call from him telling me that the manager didn't sign my contract. It was signed by the owner of Piety Corner Gardens, a man named Steve Santamaria. Uncle Nick assured me that the union would handle things from there, and let me know the results.

Later that day, I received a call from Mr. Santamaria. He told me that he wanted my group to return to his club that week. I said, "No, my men and I won't work for your manager," and I explained why. He cut me short stating that the manager was his nephew and he had fired him, knowing all the while how he treated the help. I guess his treatment of us was the last straw. That afternoon, I dropped in to the restaurant to meet the owner. We shook hands and conversed for an hour. When I returned home, I called my musicians and told them that we were returning to Piety Corner Gardens and working for the owner, not the manager. I later called Uncle Nick and thanked him for his involvement.

By the night we were to begin, my pianist was back in good health and all went well from that point on. We were to play for dancing only on Thursday nights. A petition that separated the restaurant and the nightclub was kept open and the folks in the dining room danced among the dancers in the nightclub. Once the dining room closed, many of the diners were seated in the nightclub and stayed to listen and dance to our music.

On that next night, a Friday, a new show was to begin. All of the entertainers arrived late due to a snowstorm and there was no time for a rehearsal, not even a talk through.

We backed an Englishman named Clive Baldwin, who sang and sounded like Al Jolson. He was followed by a tap dancer named Lucky Lewis and then a comedian named Teddy English, one of the funniest comedians I had ever heard. All the entertainment progressed as if it was completely rehearsed.

On the following weekend,

was the entertainer. (I don't remember his name) He arrived late (another snowstorm) and we had to cut his show without ever seeing the music ahead of time. It went so well that the Spaniard asked us to go on the road with him. Mr. Santamaria overheard the offer and told the singer that the band was under contract and under no circumstances were we going to leave. Later that night, Mr. Santamaria called me to his office and told me that he was going to raise our salaries hoping that we wouldn't leave. A handshake was the new contract. What I didn't tell him was that none of us could travel. All of the musicians had day jobs, and I was teaching at Hyde Park High School at that point in time. Music was my avocation. Teaching was my profession, and I wasn't about to change things.

We were actually there for a year or two cutting shows on weekends and playing for dancing. When I was called by one of the Hollywood studios and had to fly to the west coast, Dad took my place and became quite friendly with Mr. Santamaria. They were both golfers, and belonged to a brotherhood I still can't understand. After that second year, Mr. Santamaria changed his venue. We were replaced by a group called the Kopy Kats, that were a show in themselves and could also play for dancing. My band was moved to the first part of the week, playing for dancing on Monday, Tuesday, and Wednesday nights.

This new agreement was perfect for me and my band. We were now able to freelance on weekends, something that made us more money than playing at

Unfortunately, it all came to an end as the boss's son locked up one night and fell asleep at the wheel on his way home. He was killed and his father was never the same. Within months Piety Corner Gardens closed, and would never open again. It was a great time in my life with a sad ending. Everyone I've mentioned is gone now but I thought you might enjoy the story.

Sicily prides itself on its amazing street foods, and one of the most popular is the sfincione (or sfinciuni in dialect) of Palermo! Taking its name from the Latin word "spongia" meaning sponge, this thick spongy crusted pizza bread is absolutely amazing.



Made with caciocavallo cheese, a rich tomato, onion and anchovy sauce, seasoned with oregano, and topped off with freshly made breadcrumbs, sfincione are extremely sought after. Throughout the streets of Palermo you'll find sfinciunaros (street vendors that sell sfincione) almost everywhere. If you don't find them, you will certainly hear them as they ride by in their three-wheeled motor vehicles shouting phrases to attract patrons to their sfincione carts. Street vendors sell a significant amount of sfincione. However, it's told that some of the best tasting are made from the bakeries in Palermo or better yet, homemade.

My family came from Sicily, so growing up sfincione was the only pizza that I knew of. Thin crusted pepperoni and cheese never existed in my world. There are a few different ways to make sfincione. I'm sharing my favorite, which is almost identical to how my Nonna made hers. Though it's a bit of a process to put together, trust me, the end result will make it completely worth it. After all, how could anything possibly compare to a slice of Sicily!

SICILIAN SFINCIONE Sfincione Siciliano

Sauce:

1/4 cup olive oil

3 1/2 large sweet onions, sliced thin

1 (2 ounce) containers of anchovies in oil

Dough: (or 2 pounds store bought)

3 1/4-4 cups 00 flour 1 packages of yeast (2 1/4 teaspoons)

Breadcrumbs: (or 2 cups plain seasoned with 2 teaspoons oregano and $\frac{1}{2}$ - $\frac{3}{4}$ cup pecorino romano cheese) 1 loaf Italian bread ½ - ¾ cup grated pecorino

romano cheese

2 (6 ounce) cans tomato paste

3 (28 ounce) cans san marzano whole tomatoes, crushed by hand

1 ½-2 teaspoons Sicilian oregano (or oregano)

2 tablespoons olive oil 1 tablespoons sugar

1 ½ teaspoons salt

1 ½ cups warm water (not hot)

2 teaspoons oregano

1/4 cup olive oil

3/4 pound caciocavallo cheese (or provolone), diced into small 1/4 inch pieces

olive oil

Sauce:

In a large saucepan, warm olive oil over medium heat. Add onions, cook until soft. Add anchovies and their oil, cook for about 15 minutes, allowing them to break up and melt into the mixture. Add tomato paste, cook 10 minutes more. Add crushed tomatoes, oregano, and cook for several hours, stirring often. Sauce should be deep red, thick, and sweet to taste, when done. Cool and place aside (can be made a day in advance).

Place the yeast and sugar in a medium bowl, pour the warm water over it and whisk until the yeast dissolves. Let stand for 5 to 10 minutes and stir in the salt and olive oil. Add 3 cups of the flour and stir with a wooden spoon until the dough comes together. Mix well and continue to knead by hand or using a dough hook on a mixer, adding additional flour a few tablespoons at a time, until slightly sticky, but not clinging to your hands. Knead for 7-10 minutes until dough has a silky consistency. Put dough into a greased bowl, cover and let rise about 1 ½ hours. Punch down and let rise another 30 minutes. Take the dough and stretch to fit in a generously oiled 13x9x2 pan. Cover and let rise for another

Breadcrumbs:


Slice bread into 1 ½ inch slices. Place on a cookie sheet. Bake at 300° for 30 minutes to dry out. Break dried bread into pieces. Place in food processor and process until crumbly. Mix 2 cups of the crumbs with the oregano and grated cheese. Mix in the olive oil, set aside.

Assemble the Sfincione:

Preheat oven to 425°. Take pan of dough, lightly brush olive oil over the top of the dough. Layer diced caciocavallo cheese evenly over dough, generously layer with sauce and finally, sprinkle breadcrumbs over the top and lightly drizzle with olive oil. Bake 25-30 minutes, or until golden brown on bottom. Slice and serve with a metal spatula.



Select a Quality Potting Mix for Gardening Success

Quality potting mixes should be light, fluffy and moist to keep plants, like this coleus, healthy.

Improve your indoor and outdoor container gardening success with a quality potting mix. This can be more difficult than it sounds since you can't see or feel the product you are about to buy. Ask your gardening friends for recommendations and once at the garden center, check the package, and compare label information before making a purchase.

You'll find a variety of bags labeled as planting mix, potting mix, container mix and more. Check the label to see what the bag contains and recommendations for its use. Look for mixes; we'll refer to as potting mixes, blended for growing indoor, ornamental and edible plants in containers. They are a mix of organic and inorganic materials that retain moisture while draining well. Some mixes include sand and mineral soil while many are labeled as "soilless." These lightweight mixes consist of peat moss, sphagnum moss and compost for moisture retention, vermiculite or perlite for drainage but do not contain mineral soils such as sand or

Potting mixes may be modified to accommodate the needs of certain plants. Orchid mixes often contain more bark for better aeration, cacti and succulent mixes have more sand or perlite for better drainage and African violet potting mix contains more organic matter to create a moist, rich growing medium.

Organic potting mixes are also available if you prefer to know the ingredients are free of pesticides and other contaminants. Check for the word organic and OMRI listed on the bag.

Potting mixes may or may not be sterilized to kill weed seeds and pests. If it doesn't say sterilized, it probably isn't.

As you narrow down your choices, continue checking the label for more details. Potting mixes often contain a "starter charge" of fertilizer. This minimal amount of fertilizer is usually gone after two or three waterings. Some include additional fertilizer that provides small amounts of nutrients over a longer period of time. The label may say controlled-release, time-release or slow release fertilizer, providing nutrients for the allotment of time specified.

Natural or synthetic wetting agents are often included to reduce the surface tension of water, so it's better able to penetrate and evenly moisten the potting mix. Organic mixes often use yucca extract as a wet-

Potting mixes should be light, fluffy and moist. Avoid bags that are waterlogged and heavy. The mix can break down, become compacted and some of the slow release fertilizer may be pre-released and damage young seedlings when saturated with

Moisten the potting mix with warm water before potting your plants. This helps ensure even moisture throughout. If the potting mix becomes overly dry, you may need to do a bit more work to rewet all the mix in the container. Set the pot in a container of warm water and wait for the potting mix to rehydrate. Or water thoroughly, wait 20 minutes and water again. Repeat until vou achieve success.

Take the time to do a bit of research before buying your next bag of potting mix. Your efforts will be rewarded with healthy plants, beautiful blooms and a bountiful harvest from your indoor and outdoor potted

HOOPS and HOCKEY in the HUB

BRUINS AT THE BREAK — It has been pretty smooth sailing for the Bruins over the past few months as they've sat atop the Atlantic Division for quite some time and have engaged in a spirited competition with the Washington Capitals for the overall lead in the Eastern

But for now — at least until the last day of January when the B's next drop the puck at Winnipeg on January 31st things will, to use a maritime term from the age of sail, "stand becalmed" as action ceases across the landscape of Bruins Nation for the extended All-Star break. The next time you'll see the B's in Boston will be on February 4th when they take on Vancouver.

So, in the wake of the Bruins 3-2 victory over the Vegas Golden Knights, as most team members scatter for parts farther afield, we thought it might be a good time to take a brief look at the B's from a statistical point of view before things resume for what will amount to the final stretch drive to the playoffs.

For starters, the Bruins are where they are because of goaltending. They wouldn't be in the top position they are in today without the stalwart performances of Tuukka Rask and Jaroslav Halak in the nets.

Rask has been under a concussion protocol leading up to the break but skated during the morning practice the day of the game against Vegas, meaning he should be ready to go when action commences again after the break.

As for Halak, as a backup, he has been more than equal to the task for most of the season. He's played in 24 games, has a 12-6-6 record to go with a 2.47 goals against average and a .918 save percentage. He's notched three shutouts on the season, one more than Rask.

When he does return, Rask will begin the stretch drive with a 17-4-6 record backed up by a 2.27 goals against average and a .925 save percentage. What it means is that the Bruins have allowed the third fewest goals in the NHL to date -128.

On the scoring side of the ledger, David Pastrnak continues to lead the NHL in goals with 37. He is fourth in points with 70. Veteran Brad Marchand is fifth in the league in assists with 44.

Pastrnak and Coach Bruce Cassidy will be the only members of the Bruins heading to the All-Star events in St. Louis. We hesitate to use the word "game" anymore since the introduction of what is essentially a mini-tournament format a few years ago.

Before leaving Cassidy took the opportunity to assess his team in a positive way, noting that it is not a halfway break since the Bruins have already played 51 games of the 82-game regular season schedule.

"I think that the state of the team is that we're in a solid position," said Cassidy after the Vegas game. I don't think anything has been given to us. I do believe that there is room for growth for the 60-minute effort from start to finish."

As in all contact sports, the health of the players is of utmost concern. So the news that Rask was skating again was a good sign. "Health wise, were trending well. It looks like Tuukka is going to be fine so that's a very good sign," said Cassidy.

The coach also said it was a good sign to have some younger players who are starting to make their mark. "They are pushing the group. I've always said since I got the job that it would be good to have some of that to keep everyone on their toes in the right way. So that part I like about the team, that we have some depth down

Cassidy also cited balanced scoring as a positive, noting the efforts of Charlie Coyle, Jake DeBrusk and Anders Bjork, stating that "you know what I mean — that we can have nine forwards that can all kind of pitch in. That's something that at the start of the year we weren't sure where we would be at — so that's a positive. Now let's see how we do with our full set of forwards and where

The coach also indicated that he realized that a number of players will utilize the break as vacation time. He indicated that he's comfortable with that. He said that his message to the team after the victory over Vegas "was pretty brief." Noting that "we did some good things in the first stretch of the season," he stated that he told the players to "enjoy yourself and get away wherever you're going, mentally cleanse yourself. But understand that when we get back, we get back at it pretty quick."

There was also a cautionary note. "Be a professional. By that, you do have to look after yourself in terms of your conditioning. But again, it is more about enjoying it, but be ready to get ramped up in a hurry."

CELTICS CLAIM BIG **VICTORY** — In what was the most exciting regular season game to date in the 2019-2020 campaign, the Celtics blew away the L.A. Lakers at the Garden, 139-107 on January 20th.

It was the largest margin of victory by a Celtics team over the Lakers since November 27, 1963. The contest had a playoff feel to it. Could this be a preview of the NBA Finals in June?
