Governor Baker Delivers 2021 State of the Commonwealth Address

Governor Charlie Baker delivered his State of the Commonwealth address on Tuesday, January 26th from his office at the Massachusetts State House. Remarks as prepared for delivery:

"Good evening. And thank you for joining me for a very different State of the Commonwealth address.

"In a normal year, I'd be delivering this speech in the House Chamber to members of the House and Senate, the Cabinet, the Governor's Council, and our friends and families.

"But this is not a normal year. So, I'm sharing my thoughts with you from my office here in the State House.

"Tonight's address is just one more example of a gathering — a ritual of coming together —that's been put on hold by the pandemic.

"But better days are coming. And like you, Lieutenant Governor Polito and I are looking forward to being able to join with family, friends and colleagues. Because as we all know, there's so much joy in being together.

"2020 was a year like no other. The pandemic changed everything. And it was much more than just the worst public health crisis of the last hundred years. It came with economic



calamity. Severe job loss. Business closures. Anxiety. Fear. Civil unrest. Riots. Racial injustice. Isolation. Death. And Loss.

"COVID turned everyone's life upside down. And did so in a way that oftentimes crippled our ability to share our fears and our loss with those we love.

"Like many others who have family members in senior living, I went over 100 days last spring without being able to see my dad. It was awful. At the same time, my best friend lost his mom to COVID. That was so much worse.

"Over the past year, thousands have lost their lives and thousands more have been hospitalized. And we all worry that our loved ones could be next — but because of COVID, we can't visit or hug them.

"Back then, our mission was — and still is — clear and compelling. Do the best we can to protect the health and wellbeing of everyone, keep our economy as open as possible and keep our kids in school.

"And as the federal vaccine distribution program kicks into high gear over the next few months, anyone who wants a vaccine will be able to get one at a site near them. And we can start to put this pandemic behind us

"And while COVID returned this fall with a vengeance, here in Massachusetts, we are seeing our way through it. Our entire health care community, while stretched, has the gear it needs to take care of patients, and far more knowledge about what works and what doesn't than they did ten months ago. While we still have challenges, our testing infrastructure is far more robust than it was in the spring. Our employers have adopted the guidance we issued to keep their employees and customers safe.

"And schools remain open, despite the continued presence of COVID.

Mayor Walsh Announces UPDATES ON BOSTON'S REOPENING PLAN

Boston to Return to Step One of Phase Three Of the Reopening Massachusetts Plan As COVID-19 Testing and Vaccination Efforts are Expanded

As Boston's COVID-19 numbers trend modestly downward and Massachusetts continues to expand access to vaccination against COVID-19, Mayor Martin J. Walsh announced on January 26th the City of Boston will return to Step One of Phase Three of the Reopening Massachusetts plan on February

"I want to thank everyone who continues to do their part to protect our city," said Mayor Walsh. "While there has been some improvement in recent weeks, it's still vital that everyone remains vigilant. Wear your masks. Avoid gatherings. Wash your hands and disinfect surfaces. Think about the simple steps you can take on a daily basis to protect yourself and your loved

As of January 17, 2021, the City was averaging 415.6 COVID-19 positive cases per day, down from a high of 590.4 in mid-January, and the City's positivity rate was at 7.2 percent, down from a high of 8.9 percent in early January. 
Given the improvement in the number of COVID-19 cases and the City's positivity rate, the City of Boston will return to Step One of Phase Three of the *Reopening Massachusetts plan* on February 1, 2021. Boston had been in Step One of Phase Three of the Reopening Massachusetts plan since July 6, before returning to a modified Step Two of Phase Two on December 16, 2020. This was done to help reduce the spread

of the virus during and after the holiday period when more people were traveling or gathering with others from outside of their household.

Massachusetts recently announced an extension of the existing 25 percent capacity limits for most businesses through Monday, February 8, 2021. All gatherings and events remain subject to current capacity limits of 10 people indoors and 25 people outdoors. The gatherings limit applies to private homes, event venues and public spaces. The state's website has a list of sectors subject to the extended capacity restrictions.

The following industries in the City of Boston may reopen on February 1, 2021, at 25 percent capacity:





THE ETERNAL FLAME



The whole concept, which reveres the sacrificial fire, the candlelight vigil, and every manner of eternal flame, appears to have been born with Greek Mythology. It all started with Hephaestus, blacksmith of the gods; then the flame passed to Prometheus, one of two brothers who were charged by the gods to create man, and to provide him with the means necessary for his preservation. Zeus became angered when Prometheus tried to trick him, so the mighty one threatened to destroy the human race by withholding fire, and to create other beings in place of humans. Prometheus was so concerned about saving those poor mortals that he went up to Mt. Olympus, stole fire from the gods, and brought it back to mankind in a hollow reed. When this act was discovered, Zeus ordered that Prometheus be seized and chained to a rock high on a mountain. Each day a monstrous eagle tore at his liver, which grew whole again each night.

As man developed his facilities to control the use of flame, the fireside became the center of family life, and the Greek goddess Hestia was worshipped as the protector of the family hearth and the founder of the family unit. Meanwhile, the reverence, which had developed for Hephaestus in Greece, encouraged the worship of Vulcanus or Vulcan in Rome. Also, after learning about Hestia, the Romans developed their worship of Vesta, goddess of the Roman hearth. She was worshiped by the Romans during ancient times independently of any connection with Greece.

The worship of Vesta goes back to the time when it was difficult but necessary to obtain fire. Then, as well as now, among some primitive tribes, the custom of always keeping a fire alive for use in the community was developed, and even to carry it to new settlements. This custom was preserved in the religion of later Greeks and Romans even after more modern technologies had been developed.

The sacred fire, the source of all Roman life and power, was kept alive in a structure known as the Temple of Vesta, the subject of next week's column.

MBTA and MassDOT Announce Launch of Study **Extending Silver Line Service To Everett, Somerville, Cambridge, and Boston**

The Study Follows Recommendations from the Mbta's Focus40 Plan, Everett Transit Action Plan, and the Lower Mystic Regional Working Group To Extend Silver Line Service Throughout the Region

The MBTA and the Massachusetts Department of Transportation (MassDOT) today announced the launch of the Silver Line Extension Alternatives Analysis to assess the feasibility, utility, and cost of various alignment and service frequency options for extending Silver Line service to Everett and neighboring communities.

"We're excited to collaborate with MassDOT on this analysis of Silver Line service," said MBTA General Manager Steve Poftak. "Studying the extension of the Silver Line to Everett and beyond is a key objective of Focus40 and an important step in improving service to essential workers and transitcritical populations that live far from the Orange and Blue Lines and rely on bus service to get to work and other destinations."

"This study builds off years of work and collaboration between the City and the MBTA to improve bus services in Everett," said City of Everett Mayor Carlo DeMaria. "Extending the Silver Line to Everett will transform our city by unlocking economic opportunity in the Commercial Triangle and along the Broadway corridor and give residents more direct access to jobs, health care, and services in Boston and Cambridge. We are extremely excited to continue to work with the MBTA

best way to implement rapid bus service in Everett."

"Many residents of Chelsea are the essential workers who have reliably kept the Commonwealth running during the COVID-19 pandemic," said City of Chelsea City Manager Thomas G. Ambrosino. "As an environmental justice community, Chelsea residents deserve fast, dependable transit service. Extending Silver Line service presents an opportunity to enhance transit service for our residents and combat the growing impacts of climate change."

"In Somerville, we pride ourselves in aligning transportation policy with housing and economic development policy," said City of Somerville Mayor Joseph A. Curtatone. "Our advocacy for one-seat mass transit service connecting Logan Airport with Kendall Square via East Somerville is rooted in a firm commitment to addressing current and historic inequities in our City and in our region."

"Kendall Square and East Cambridge have experienced incredible growth in recent vears and more housing and jobs are being added to the area with the redevelopment of parcels along Binney Street, the Volpe site, and North Point," said City of Cambridge City Manager Louis A. DePasquale. "Improving transit services in the area is crucial to ensure new residents and workers have sustainable and reliable ways to travel to work, home, and other destinations."

"It's more important than ever to invest in public transit and ensure that residents of Boston have reliable, safe, and convenient options for traveling throughout the city and the region," said City of Boston Mayor Martin J. Walsh. "We're excited to work with MassDOT and the MBTA on this study and

and MassDOT to determine the to improve transit for Boston residents traveling to jobs, schools, and other destinations throughout the region."

The study follows recent recommendations by the Lower Mystic Regional Working Group and the Everett Transit Action Plan to extend Silver Line service to Everett and neighboring communities in order to provide service at near rapid-transit levels for those living just beyond the reach of the Orange and Blue Lines.

Existing bus routes serving Chelsea and Everett have maintained some of the highest ridership levels in the system during the COVID-19 pandemic. During the week of January 4, 2021, six of the top 10 bus routes in the MBTA system in terms of ridership recovery served Everett and/or Chelsea.

Recent recommendations by the Kendall Square Mobility Task Force have also called for improving transit services and connections within the area in order to accommodate new growth in housing and jobs in East Cambridge.

The MBTA and MassDOT are working in partnership with the cities of Chelsea, Everett, Somerville, Cambridge, and Boston to determine the potential alternatives and benefits of a Silver Line extension. In addition to convening a Stakeholder Working Group comprised of municipal staff, community members, and elected officials, the project team will conduct an extensive public engagement process throughout the course of the study to gather input from residents, MBTA customers, and other stakeholders. The study is anticipated to be completed in spring 2022.

AARP Massachusetts Calls on Governor Baker to Establish **Toll-Free Number for COVID-19 Vaccine Registration**

Since the start of the pandemic, nearly 95 percent of the deaths from COVID-19 have been among people 50 and older. Residents over age 50must be prioritized to receive COVID-19 vaccines and the system they access to receive vaccines works efficiently.

Mike Festa, State Director of AARP Massachusetts, and Sandra Harris, State President of AARP Massachusetts, sent this letter to Governor Baker and the Massachusetts Legislature today urging for increased access to information about where, when and how people can sign up for the vaccine.

"Dear Governor Baker:

Since the start of the pandemic, nearly 95 percent of the deaths from COVID-19 have been among people 50 and older. The data clearly show that the older people are the higher risk they face if they contract COVID-19. Given that older individuals are at a greater risk of death from COVID-19, we strongly urge you to ensure that Bay State residents age 50 and older are prioritized to receive a vaccine. These individuals must be given priority access to vaccines, in addition to those individuals receiving care in nursing homes and other long-term care facilities.

Older Massachusetts residents must be prioritized to receive COVID-19 vaccines - and that the system they access to receive vaccines works, and works efficiently. Individuals need to know where, when and how they can receive the vaccines.

We continue to hear from members that they do not know when, where or how to schedule an appointment. This is unacceptable to AARP and should be to all Bay Staters. Massachusetts can and must do better.

In many instances, our members cannot access the internet. AARP urges you to immediately establish a dedicated 1-800 number for seniors to call to receive assistance in signing up for a vaccination.

We cannot stress enough how eager people are in Massachusetts to receive a COVID-19 vaccine, which offers so much promise for a return to normalcy. There is incredible demand from our members for more information about when, where and how they can get a vaccine. AARP Massachusetts stands ready to work with you and support your efforts to get information to people as quickly as

AARP is calling upon your leadership and your proven record of cutting through bureaucracy to benefit those in need. The current system must be fixed as soon as possible. The state's website must be improved. There must be a state run tollfree telephone number to make an appointment for a vaccination.

Furthermore, we are also hearing from some older Massachusetts residents about confusion on how to schedule their second shot. The failure to schedule an appointment for the needed follow-up shot when the first shot is administered is causing confusion and delays and may result in some not receiving their second shot.

Massachusetts should require uniform standards across the state to ensure that an appointment for the needed follow-up shot be made when individuals receive their first shot, regardless of whether the first shot was administered by a state-run vaccination site or a private site.

Thank you for your leadership and dedication to the people of the Commonwealth. AARP stands ready to help.

Due to Covid restrictions, a larger celebration of her life will take place at a future date.



L'Anno Bello: A Year in Italian Folklore The Many Lights of Spring

Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing (and mask wearing!) is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.



January has gone by quicker than a windswept snowdrift. It seems that just a short while ago, I was cheering the start of a New Year and packing away the last Christmas decorations. This past month has been an unusual mixture of bitter cold spells followed by mild weather, of furiously falling snowflakes and pleasant days filled with the scent of newly-turned soil. I can sense the dueling seasons of winter and spring dancing around me, struggling to maintain their individual grip over these transitional, changeable months. However, February will soon arrive with its bevvy of festivals that decidedly welcome the spring. St. Valentine's Day cuts through the snowy monotony in bursts of red and pink, ushering in the season of rebirth through images of hearts and flowers and Cupids. The revelry of Mardi Gras, replete with mysterious masks and colorful beads, promises to chase the ghosts of winter away. I look forward to the joy and gaiety of these holidays. February starts, though, with a less recognized feast that introduces the month, and the season of spring as a whole, with powerful symbolism. This ancient, rustic holiday is known as Candlemas, and its worldwide traditions evoke the spring with anticipation and light.

Candlemas, which occurs on February 2nd, commemorates the date on which the Virgin Mary presented Jesus at the temple, forty days after His birth. The name of the feast derives from the widespread usage of candles during the religious services marking this holiday, which symbolize the light that Jesus metaphorically brings to the world. However, many of Candlemas's folk customs predate Christianity. The

Celts celebrated February 1st as Imbolc, a festival heralding the first day of spring. Imbolc, which some scholars theorize translates to "in the belly," honors the lactation of sheep and the beginning of the birthing season for lambs. This ancient Celtic holiday survives as St. Brigid's Day in modern Ireland, where people light candles, make Crosses out of vegetation, and visit holy wells. Indeed, since it serves as a welcome precursor to spring, Candlemas bursts with quaint customs and superstitions everywhere. European folklore states that a warm and sunny Candlemas portents harsh wintry weather, while a cold and blustery Candlemas promises an early spring. Immigrants from Europe brought these traditions over to America, where they melded into the festival of Groundhog Day. Like Candlemas, Groundhog Day is also celebrated on February 2nd, and it further pays homage to the end of the hibernation period for many animals. An Italian dictum repeats this well-known superstition, proclaiming "Candelora con sole, tarde primavera," or "sunny Candlemas, late spring." These practices speak to the universal desire for spring and rebirth, whether it manifests in newborn lambs or candles flickering in the windowsills.

In addition to functioning as a turning point between winter and spring, Candlemas also provides people with an opportunity for celebrations and feasting. Pancakes are the traditional dinner of choice in France, possibly because their round shape and golden color resemble the spring sun, which is now remaining for a longer time in the sky. Superstition claims that a cook who can

while turning a coin in the other will be blessed with luck. In Mexico, people eat tamales on Candlemas, provided by the person who found the hidden bean in their Epiphany King Cake. Italians honor Candlemas, or Candelora, with local festivities and regional customs. Though Candlemas traditions vary across Italy, each honor the arrival of spring and the theme of light breaking through the darkness. In the Sicilian city of Catania, Candelora festivals segue into parades held in honor of the town's patron saint, St. Agatha, where people make offerings of large candles that illuminate the dark late winter sky. The people of Montevergine, a village located in the southern region of Campania, organize candlelit processions which honor gay rights and pray for increased tolerance. Meanwhile, Neapolitans celebrate Candelora with large street parties boasting torches and fireworks displays. Indeed, all throughout Italy, a visitor will find homes, churches and town squares illuminated by candles or bonfires on Candelora, the flames both providing warmth against the cold February air and reminding people of the light of the coming spring. Candlemas always makes me think of the long walks I would take on my old college campus at the start of the spring semester, propelled by the wind as I took note of the new buds adorning the otherwise bare tree branches. Nowadays, I bake orange cheesecakes on Candlemas, a seasonal recipe whose color and shape resembles mini sunbursts. How exciting it is to greet spring in all its myriad forms!

As winter slowly melts into spring, we should all take a lesson from Candlemas and search for the beacons of light in our own lives. What are the symbolic candles that illuminate our way out of our personal darkness? Which elements of our lives remind us that rebirth and hope are always near, even in the midst of a literal and metaphorical winter? To me, these "candles" include spending time with loved ones, the smell of baked goods wafting through my kitchen, hearty belly laughs, and warm sunsets. These signs remind me that the world holds so much beauty and promise, even when all appears bleak. Candlemas teaches us to look for these signals in nature as well: a frost-encrusted snowdrop flower, the flash of a robin in flight, a night lit with candles. When we hold on to the hope of spring and appreciate the moments our natural world has to offer, we will always hold the beauty of each season inside us — and that knowledge of Mother Earth's endurance will comfort us always.

Low Light, Low Maintenance Houseplants

Don't let a lack of brightly lit windows stop you from gardening indoors. Include some low maintenance, low light houseplants and maintenance strategies to boost your success.

Low maintenance gardening starts with proper plant selection. Match the plant to the growing conditions and your gardening style.

ZZ plant is a favorite low light, low maintenance plant. You will see it in hotels and shopping malls where light and care are often limited. Avoid overwatering that can lead to root rot and death of this plant.

You will need to do a bit of searching to find a few of the newer ZZ plant varieties. Zenzi is compact with curled leaves while Raven has dark purple black foliage that contrasts nicely with green and chartreuse leaves of nearby plants.

Peace lily is another popular low light plant found in a variety of public places. It requires moist soil to thrive, making it the perfect plant for those that tend to overwater. Increase your success by mixing organic Wild Valley Farms' wool pellets (wildvalleyfarms.com) into the potting mix. This sustainable soil additive retains moisture, reducing watering by up to 25 percent. It also adds air space, improving the growing conditions for all indoor plants and helps reduce the risk of overwatering.

Pothos and philodendron are traditional low light favorites. New cultivars provide a fresh look to these indoor beauties.

Neon pothos has vibrant neon green foliage sure to brighten any spot in your home. Pearls and Jade has smaller cream and green variegated leaves. It is slower growing but just as tough as other pothos. Show off their trailing habit in a hanging basket, container displayed on a shelf, or set upon a pedestal.

You'll find a variety of philodendrons for your indoor garden. Brasil has dark green heart-shaped leaves with a golden stripe down the middle. Brandi, another trailing philodendron, has olive green heartshaped leaves with silver splashing. These can be allowed to trail or trained up onto a trellis.

Golden Goddess has larger chartreuse leaves that make a dramatic statement in a home or office. When small, it is great for desks and tabletops, but you will need to transition it to a floor plant as it climbs its support, growing up to six feet tall. Or add a subtle touch of orange with Prince of Orange. The new leaves of this shrubby philodendron emerge a coppery orange and eventually age to green. It grows 24 or more inches tall.

The name says it all. Cast iron plant is tough and tolerant of low light and benign neglect. Individual long strappy leaves sprout from the ground to create a mass of greenery. This growth habit has made it a popular groundcover in milder climates. Variegated varieties with splashed or striping can be difficult to find but add to its beauty.

New varieties of Chinese evergreen have found their way into many garden centers. Their green leaves may have silver highlights like those of Calypso. Cecila and Golden Bay. Or add a bit of red to your indoor garden with be Red Gold and Ruby Ray Chinese evergreen.

Low light indoor plants allow you to add greenery where you once thought it was not possible. Their added beauty will help lift your spirits, reduce stress, and increase focus while improving your indoor air quality.

"Study after study makes clear that kids need to be in school. Their educational and emotional development depends on it. And while in person learning is especially challenging during this time, many schools have found a way to get it done.

"Relying on state guidance, as well as federal and state funding, many special education programs, early education providers and some school districts have been able to make in person education work safely since the fall.

"The Commonwealth's parochial schools – many of which serve primarily black and brown children and their families in many high-risk communities have been delivering mostly in person education to over 45,000 kids since mid-August.

"Many teachers, parents and staff throughout Massachusetts are making it happen.

"To encourage more public school districts to reopen their classrooms, we've been working with a number of lab partners to develop a weekly COVID testing program for kids, teachers and staff. The goal is to get as many kids as possible back in the classroom as soon as possible. This first-in-the-nation COVID testing program will help more school districts make the call to offer full time, in person instruction now.

"Finally, I want to talk about the light at the end of this dark tunnel - vaccines.

"Thankfully, the scientific community — many from right

COVID-19 Vaccination and Testing Efforts

The City is working with the Commonwealth of Massachusetts to vaccinate residents against COVID-19. The Reggie Lewis Center will open as a vaccination site during the first week of February to anyone who is eligible under the State's vaccine distribution timeline. In Boston, two mass vaccination sites have been announced: Fenway Park and Reggie Lewis Center. Following the State's lead, the Boston Public Health Commission in partnership with the Mayor's Office of Health and Human Services is working to create equitable access to the COVID-19 vaccine across all populations and neighborhoods in the city.

"In these unprecedented times, we must work together and find new ways to support each other and our community," says Roxbury Community College president Dr. Valerie Roberson. "It's crucial to have a mass vaccination center that is accessible via public transportation in a location that is familiar and comfortable. We are pleased to have the opportunity to provide such tangible support to the City and State efforts to combat the spread of COVID-19."

"Getting tested regularly and taking the vaccine when you have the opportunity to are key to helping us defeat this virus, said Mayor Walsh. "We have over 30 testing sites open across the city that are quick and easy to utilize. We know people have lots of questions about the vaccine, and we're committed to making this information as clear and accessible as possible. I want to thank Roxbury Community College for working with us and the Commonwealth to open a mass vaccination site at the Reggie Lewis Center. We'll continue to work collaboratively to direct resources to where they're needed most."

Together with the Office of Arts and Culture, the Office of Health & Human Services, and the Boston Public Health Commission, Mayor Walsh today announced the Strand Theatre is now serving as a COVID-19 testing site. The testing is being conducted thanks to a partnership between the City of Boston, The Strand Theater, the Brookside Community Health Center, Brigham and Women's Hospital, Southern Jamaica Plain Health Center, and Upham's Corner Community Health Center. Testing at the Strand is available to anyone at no cost and regardless of symptoms. Insurance is also not required.

The Strand, which is located at 543 Columbia Road in the Upham's Corner neighborhood of Dorchester, is open for testing on Mondays and Wednesdays from 8:30 a.m. - until 4:00 p.m. There is no prior registration required, and testing is walkup only. Individuals arriving for testing should enter through the main entrance of the building and will wait in line inside the theater. Testing will occur outside at a mobile van in the back parking lot of the Strand. There will be no public parking available at the Strand during testing.

Saint William of Dijon

by Bennett Molinari and Richard Molinari

William was born in the family castle on San Giuglio Island, Lake Orta, Novara, Piedmont, northern Italy in the year 962. He was the fourth son of Count Robert of Volpiano. He was born during a battle in which his father defended the island against Emperor Otto. When the island was lost, the Emperor became William's sponsor and patron.

He began his education at the Benedictine Abbey at Locadio at the age of seven. In 987, he became a monk at the Abbey of Cluny. William was an ardent proponent of the Cluniac reform, and he founded (1001–03) the Abbey of Fruttaria in Lombardy with the help of his brothers and of his uncle, King Arduin of Italy. Among other monasteries, William reformed Mont Saint-Michel.

He reorganized St. Sernin Abbey on the Rhone, was ordained in 990, named abbot of St. Benignus



at Dijon, and built the Abbey into a great center of spirituality, education, and culture, and the mother monastery of some forty monasteries in Burgundy, Lorraine, Normandy, and Northern Italy. William was noted for his zeal for the Church, his tender concern for the poor, his resolve and lack of intimidation when dealing with the politically powerful. He traveled widely, spreading the Cluniac reform.

By the time of his death William headed 40 monasteries, and in all the houses reformed by him, he had attempted to establish a tradition of learning. He also promoted the spread of Romanesque architecture in France, and rebuilt the abbey church of Saint-Bénigne.

He died on January 1, 1032, at Fe'camp Monastery in Normandy which he had rebuilt. His feast day is celebrated on January 1st.



Nanna & Babbononno

A Nostalgic Remembrance



I love to talk about the things I remember from my childhood. My grandparents, (Nanna and Babbononno), my parents, and my uncles all survived the Depression of the 1930s. Fortunately, they didn't suffer because they had jobs that, in spite of the economy, didn't disappear. Babbononno was a carpenter/furniture maker by day and a musician at night. Uncle Paul had learned the printing trade in high school and worked through the Depression. Oh, by the way, he was a musician, too. Uncle Nick became a musician like his older brother and father, and worked through the worst of times. Uncle Gino, the youngest went to work at the Chelsea Navy Yard after graduating high school and played music at night like his father and brothers. My father graduated from East Boston High School's machine shop program in 1929, and went to work for an iron works company. He too, was a musician at night, playing bass violin and tuba.

Thinking of the iron works. I passed the new Seville Building on Meridian Street just before Christmas, and remembered that Dad helped put up the super structure of the Seville Theater when it was being built in the late '20s. There is a synagogue on Beacon Street in Brookline that once had a six-point star on the top of its dome. That star is called the Star of David. Dad, at his job with the same iron works, had no fear of heights, and climbed atop the dome of the building and fastened the star at the highest point. It was a hot summer's day and the star burned his hands. This event kept him on the sidelines for a couple of weeks, but years later, his Jewish musician friends called that religious marker, Johnny Christie's "Star of David."

Not long after he recuperated, Dad left the iron works to concentrate strictly on music.

As I said, the men in my family did well during the Depression, but were super cautious about spending, just in case. Dad and Uncle Nick went on the road with the big bands, the swing band of the 1930s, while Babbononno, Uncle Paul, and Uncle Gino stayed home and worked at their day jobs and played music, locally, at night. Those were the days before DJs and all social functions had live music.

Years later, when I observed the members of my family conducting their daily routines, I discovered that they still had what was called a "Depression Mentality." As an example, one day when I was about ten, Babbononno sat on a chair with another chair facing him. On the other chair was a sheet of wood that was his mini table. On it, my grandfather was cutting up a rectangular chunk of compressed tobacco. It was called a plug and Babbononno, once he cut up the plug into small pieces, intended to smoke them in his pipe. The tobacco was named Edgeworth and could be purchased in plug form

(compressed tobacco) or ground up for immediate use in a pipe. When I asked Babbononno why he was chopping up the tobacco plug rather than buying a ready cut pouch of Edgeworth, he replied that the plug was cheaper, and he saved money.

Nanna and my mother hunted for bargains, a carryover from the dark days of the 1930s.

There was a kosher slaughterhouse on Lewis Street near Maverick Station. Even though East Boston's Jewish population had all but disappeared, the establishment still survived. Jewish grandmothers and mothers, who wanted their chicken's slaughtered kosherstyle, came back to Eastie on a weekly basis. Italian women had discovered the place, and remembering fresh killed chickens in the old country, picked their chickens, and argued the price, and then had them slaughtered. Nanna was one of these Italian women who frequented the Lewis Street slaughterhouse.

With me by her side, she entered the establishment, picked her chickens, argued the price with the salesperson, then had the birds prepared for her to take home. I now know that she argued the price in Italian and the salesperson argued in Yiddish. I don't know how they understood each other, but I guess they did. Nanna always got her price, an amount that fit into her budget. My grandmother couldn't read and write in either Italian or English, but she knew her numbers better than most and could figure her spending right to the penny.

Whether it was food, clothing, anything for the house, there were never a lot of extras, but what they had was always of good quality. Babbononno used to say that good quality lasted longer, and as a result things were cheaper in the long run. I would discover, years later, that my grandfather was right again.

One day during WWII, I watched Nanna as she sat at her Singer sewing machine, pumping the footplate that allowed the mechanism to operate. She was reversing the collar and cuffs of one of Babbononno's white dress shirts. They had become frayed and reversing them would give the shirt new life for a period of time ... money saved.

Being the first-born male in an Italian family, I grew up as a young prince, and loved it. At thirteen, I went to work at the Seville Theater, a job I would keep from 1952 through 1962. When I first started, I lied about my age, but they kept me on, anyway, a story for another time, but Dad was afraid that my young age and immaturity would cause me to spend every dollar I made. I wanted a new one-button roll-collar Zoot suit that corresponded to the style of the day. I also needed a new raincoat. I was going to buy the two garments with the money I saved from my salary at the Seville, but Dad, with his Depression mentality, made sure I bought the raincoat first and the suit later. To him, this was the sensible way of doing things.

My grandparents and parents never splurged. Dad needed a car because he was a musician, but always bought something sensible and slightly used. He often said that he was in the low-priced three category. This meant that he would only buy a Chevy, Ford, or Plymouth a couple of years old, and that is what he did most of his early life. Only later when disposable income was in abundance did my father ever buy a new car. I once talked him into buying a Cadillac. A year later it was stolen and he told me that it was God's will that it disappear due to his trying to show off.

Those days seem so long ago, and they are part of the distant past. We've never come close to those troubled times of the '30s that molded the mentality of so many Americans. I don't know if this is good or bad, but some of us old folks can remember the way our parents and grandparents thought things out to survive. They must have been right, because we survived, thank God. They lived through the Spanish flu epidemic of the early 1900s, and I wonder what they would have to say about the COVID-19 virus we are now experiencing a hundred years

Wintertime is the perfect time to indulge in a delicious *Gatto di Patate or* Italian Potato Cake. The name *Gatto*, derived from the French word "gateau," translates to "cake." This savory dish is said to have originated centuries ago in Southern Italy from French cooks working in the homes of noble families. This tasty *tortino*, made from boiled riced potatoes and a combination of breadcrumbs, butter, eggs, cheeses, and Italian ham or prosciutto, is one you'll rarely find in Italian American restaurants. However, many people of Neapolitan backgrounds have maintained it as part of their own home cooking. Traditional Neapolitan style has always been to serve *Gatto di Patate* as a *primi* or first course. Yet, I assure you it is equally as pleasing when served as a *contorni* or side dish!

I learned to make *Gatto di Patate* using an old family recipe that had specific instructions for molding it in a springform pan, and suggested using only the freshest ingredients available. It recommended homemade breadcrumbs, parsley that was fresh not dried, cheeses to be fresh and freshly grated, and as for the potatoes, it read "russet always works best." Every time I've ever made this recipe, the results have been amazing. With a soft and stringy inside and a golden crusted outside, it's the perfect blend of taste and texture. I guarantee that once you try this succulent Italian Potato Cake, you too are going to find it simply irresistible!

ITALIAN POTATO CAKE Gatto di Patate



3 pounds potatoes (yukon or russet), peeled and cut in half

12 tablespoons butter4 ounces parmesan cheese, freshly grated

2 ounces pecorino cheese, freshly grated

1/2 pound prosciutto, chopped into bite size pieces

3 large eggs, beaten salt and pepper 1/3 cup chopped fresh parsley 3/4 pound fresh mozzarella, chopped 4-5 tablespoons olive oil

Breadcrumbs made fresh from Italian bread

Place potatoes in a large stockpot, fill with water and allow to come to a boil. Salt and cook until tender. Drain potatoes and put them through a potato ricer over a large mixing bowl. Place 8 tablespoons butter into the hot potatoes and mix well. Add the parmesan and pecorino cheeses, prosciutto, eggs, and parsley. Blend all ingredients together and season lightly with salt and pepper.

In a medium bowl, toss together the mozzarella with the olive oil and season with salt and pepper. Set aside and preheat oven to 375°.

With the remaining butter, grease the bottom and sides of a 9-inch springform pan. Coat bottom and sides completely with breadcrumbs. Spread 1/2 of the potato mixture in the bottom and up the sides of the pan, being careful not to remove the breadcrumb coating.

Evenly layer the mozzarella over the potato mixture. Now cover the mozzarella with the remaining potato mixture. Sprinkle generously with breadcrumbs, and place pieces of the remaining 4 tablespoons of butter evenly over the top/breadcrumbs.

Place the Gatto di Patate in the oven and bake at 375° for 40 to 50 minutes, or until golden on top. Cool for 20-25 minutes, unfold sides of pan, slice and serve.

Blockbusting and the Fall of the Cities

Blockbusting did not last long, relatively speaking, and there were outcries about its practices as early as 1962, but its effect on cities has proven hard to fully shake off.

It started soon after WWII when growing middle-class families discovered the possibility of life beyond the city limits in the suburbs. However, many chose to still remain in the cities for the professional opportunities while others chose to maintain their family home from generations past.

On the other hand, many lower-income families, (disproportionately black and Latino thanks to segregation and lack of opportunity) were priced out of the more affluent city zones. However, talks of desegregation combined with the increasing suburban sprawl (as middle-class families grew larger) gave unscrupulous real estate agents the perfect storm to flip neighborhoods. The plan: scare white families out of middle-class urban areas in cities like Boston, New York, Philadelphia, Chicago, Detroit, and Baltimore (among the cities hardest hit by the practice) by suggesting, sometimes with visual evidence, that demographics in their neighborhood were changing. Sometimes word-of-mouth would suffice, but in extreme cases, realtors would pay blacks to pace around a block and sometimes bring their children along as proof that whole families were moving in. This, realtors would remind reluctant homeowners, would decrease the price of their property. If they sold below market, they could get the property off their hands before the situation got worse. Many white families took the bait, starting off the phenomena of white-flight, in which many of the holdovers finally took that flight to the suburbs.

The blacks and Latinos, I cannot stress enough, were the real victims of this scam. Because many of them were denied traditional bank loans, realtors would sell them properties at a cost they knew the buyers could never afford via land installment contracts. Through these contracts, the buyers would pay the seller directly and not receive legal title to the property until the loan was paid off. A lot of these homes resulted in being foreclosed and sold again, repeating the cycle. This was part of the plan and the destruction of the cities collateral.

It cannot be denied that racism was a motivating force for many of the owners who originally sold their house in fear. To be fair, however, many thought of it simply in terms of economics rather than bigotry. In the end result, however they may have felt about new demographics moving in, was a depreciation of the neighborhood, taking an opportunity to sell, they figured, was the best

Be that as it may, by the late '60s entire neighborhoods had been transformed. Here in Boston, the Jewish population which once dominated Mattapan had practically disappeared from that neighborhood by 1970. Jews, Italians, and Germans were leaving Dorchester and Roslindale in droves into the 70s and early

So drastic was the economic effect of blockbusting in the cities that in 1968 the Fair Housing Act outlawed many of its tactics, effectively outlawing the practice. Some of the measures were indeed severe. Realtors were "discouraged" to mention evolving demographics when offering to buy a property, documentation of the movements of neighborhoods was also discouraged (in some cases even posting For Sale signs was prohibited) for fear this would give way to speculation that the block was shifting, and door-todoor salesmanship was cracked down on.

Still, many realtors found work arounds and blockbusting did not begin to subside until the mid-'80s.

Forty years later, the legacy of blockbusting can be seen in many ways. Short-term effects included racial animosity between the new residents and the white residents who did remain (many of which were senior citizens too old and with too few options for finding a new home), the depletion of once strong family neighborhoods (the new residents seldom lasted

long enough to form strong bonds with their neighbors) and, due to the depreciation of city zones, a decrease in taxes, which precluded infrastructural and residential maintenance of certain areas. Long-term effects include the shattered dreams of many of the black and Latino families who seized the longawaited opportunity to build a better life only to have been short-changed again.

Nothing lasts forever and by the 1990s, Boston and New York had rebounded remarkably (thanks to good governance) and another trend started to emerge by the late '90s. This was the counterpart of blockbusting: gentrification ... but that's another story.



Hank Aaron Has Left the Ballpark

As I read of the passing of Hank Aaron, I thought back to my younger days growing up in lower Roxbury living in between Northampton and Dudley Stations where life was what you made of it. None of the kids I hung out with had a lot but we had each other and we all had watchful parents too who instilled values into our thick skulls at times.

I can remember walking down Lenox Street to Tremont Street where we caught the streetcar into Boylston Station and switched over to another streetcar for Kenmore to go see the Red Sox at Fenway Park. With cheap bleacher ticket prices, we would do this about twenty times a season and could still have some loot left over for tonic and popcorn.

We were always playing baseball or softball all the time and collecting plenty of baseball cards, too. We all had our favorite players. Our favorite team was the Red Sox even though they were pretty pathetic growing up in those years of exile between their glory years of past and what was to be.

Back then the three biggest players were Willie Mays, Mickey Mantle and Hank Aaron. Oh, and coming up fast behind them was Frank Robinson. With the recent passing of "Hammerin' Hank," all four have now left us for that sandlot in the sky and maybe playing a team of real angels, too.

When I think of Aaron, I still consider him the King of HRs with his 755. I don't care if Barry Bonds has the new record with 762. Actually, I think Aaron just got five more homers added to his lifetime number from his one-year in 1952, when he played in the Negro League before being called up by the then Boston Braves in 1952.

You know the night Hank Aaron broke the Babe's 714 HR record, I was watching that game on TV and rooting for Aaron to hit Home Run #715 and I was not disappointed. The game took place on the night of April 8, 1974, I was 25 years old. On his third trip to the plate against Al Downing of the Dodgers at exactly 9:06 p.m., he smashed a fastball out

deep. Bill Buckner made a great leap to catch it, but it sailed overhead for Home Run #715 and passed the great Bambino. It would be years later that I learned of all the hate mail and threats Aaron received as he inched closer and closer to the Babe's one time record.

Thinking back to that night in April 1974, I now understand the significance of those words by Vin Sully as that 715th homer sailed into baseball history, "What a marvelous moment for Atlanta and the state of Georgia. What a marvelous moment for the country and the world. A black man is getting a standing ovation in the deep South for breaking a record of an all-time baseball idol."

I feel lucky still that during my youth growing up in the South End and Roxbury, I didn't have white friends and black friends. I had friends and we always had each other's backs too. Which is why it still bothers me to still see all this racial tension out there tearing at our nation's seams. You know, Dr. King was and remains right; it is always about character and not color. Maybe someday we can get this right. It starts with each of us reaching deep into ourselves.

My generation, born after WWII, after Jackie Robinson broke baseball's color line, sadly did live through those dark days of segregation during the Civil Rights era. My generation isn't excused from pushing America forward into a world where skin color becomes an irrelevance in our shared humanity. Not just at the ballpark but everywhere we gather. In the end, we all play for the same team in this life of ours that passes by so quickly.

Oh, getting back to Hank Aaron. He still holds the alltime records in RBI with 2,297, in extra base hits with 1,477, total bases 6,856 and is fourth in hits with 3,771. No wonder he got into the Hall of Fame on his first try.

One final note. Weeks before he passed at 86, he received the COVID-19 vaccine because he did not want African Americans to hesitant taking the vaccine to know he wouldn't be taking it if it was unsafe. He said, "It is just a small thing that could help zillions of people in this country."

Tony Licata **New Orlean's Boxer Fought Monzon For The Title**

Last week I wrote about the fight between Tony Licata and John Coiley and the tragic consequences for John. Mismanagement left to a young life being ruined. This week I thought I would recap Tony Licata's career.

Tony Licata was born on

February 10, 1952 in New Orleans. His mother was Chinese and his father was Italian. Tony's uncle was Ralph Chong a well known middleweight who fought mostly during the 1930s and was good enough to take on such names as Billy Conn (twice), Ken Overlin, and Solly Krieger.

After a very brief career Tony turned pro and in 1969 made his debut defeating Bernie Bennett by TKO in two rounds. Licata quickly ran his record to 10 and 0 and then faced his first real test when he took on veteran Iron Mike Pusateri. He proved worthy of the step up by winning a ten round decision.

Two fights later he would be held to a draw by the slick Luis Vinales, but Tony would come back to score a decisive win in their rematch. Under the care of the very capable Bill Gore Licata would gradually face more experienced competition while not being put in too deeply. Gore had trained Tony's uncle Ralph as well as Willie Pep.

In his 24th fight he took on Johnny Coiley in New Orleans, one of the fights I wrote about in my previous column. Up to that point in his career Tony's fights had been held in Louisiana or Florida. The rematch with Coiley in Boston was his chance to get exposure in the Northeast.

Licata proved to be popular with the Boston fans. He was a very smooth boxer with lightening fast combinations and accurate punches that carried power. He would fight three more times in Boston over the next two years culminating in a fight with former great middleweight champion Emile Griffith in 1974.

The fight with Griffith was held at the Boston Garden and was an outstanding fight. Tony started off fast but in the middle rounds Griffith began scoring heavily to the body. It looked as if those body shots were really slowing Machine Gun Tony down and the question became whether or not he would have enough left in him to last the twelve rounds. That doubt was removed during the last three rounds of the fight when Licata not only showed he was going to stay in the fight to the end, but came on strong to land heavily on Emile and pull out the win. This was a major victory that really put the Tony on the map.

There was some talk of fight between Licata and another young middleweight prospect fighting out of Brockton by the name of Marvin Hagler. Marvin was still in the early days if his career so the fight never materialized.

As much of a draw as Tony was, he never fought in Boston again. After the win over Griffith he traveled around and continued adding up wins. With victories over Gene Wells, Willie Warren, and Vinnie Curto, Licata was ranked number five in the world by Ring Magazine. He had become a contender.

It was at this point he was offered a title shot against Carlos Monzon. Tony had been very well managed up until this point in his career when his team had to make the decision to put him in with one of the all time great champions.

They decided to accept the fight.

For some reason, his management (Bill Gore was now out of the picture) decided to have him a fight in Milan, Italy in the meantime. It was an odd decision, but maybe they thought a warm-up fight was in order. It wasn't a wise move as Licata was dropped on his way to losing a ten decision to Ramon Mendez. One month later they fought again, this time in New Orleans with Tony coming away with the decision. The victory salvaged his chance of facing Monzon.

The fight took place on June 30, 1975 at Madison Square Garden. It was a co featured live attraction sharing billing with the Victor Galindez vs Jorge Ahumada light heavyweight title fight along with the closed circuit televised bout between Joe Bugner and Muhammad Ali. Eddie Futch was now training Licata. Bill Gore had passed away that same year.



Licata Lands a Jab On Monzon

Licata out on a game and impressive performance taking the best the champion could dish out while firing back with said right hands of his own. He just wasn't in the same league as Monzon. Who was at that time? In the ninth round Tony took a bettering but still managed to land some solid shots on the Champion. Tony came out gamely for the tenth round but was dropped by a series of hard punches. He got to his feet and did his best tom get back into the fight. He was dropped again and badly hurt when the referee wisely stopped the bout. Tony had nothing to be ashamed of. He did his best against a legendary champion.

Should Licata have been put in with the champion at that point in his career? I believe Tony had gotten as good as he was going to get. Unfortunately, getting a title shot at that time didn't mean a huge payday. Licata walked away with more glory than money. He took some awful shots which could take a toll on him in the future. The question now was whether or not he should continue with his career.

The decision was made to continue on. Licata's next fight took place nine months later in Paris when he was stopped in the 9th round in a fight against Jean Mateo. He was dropped three times

Tony fought again a month later stopping Jose Luis Duran in 10 rounds. His biggest wins in the next few years were over Mike Rossman and Mike Nixon. All told, in his seventeen fights after Monzon Licata won eleven times while losing five bouts and having one draw. He was stopped five times. He took a terrible beating from future champ Alan Minter who stopped him in six rounds. He retired after losing to Tony Chiaverini in 1980.

Tony Licata was a very good fighter. However, being very good was not enough back then when you fought the top echelon of fighters. When he fought Monzon he had gone as far as he could. The seventeen fights he had after that must have taken a toll on him. It's hard to walk away from boxing, but it was clear after the Monzon fight he would never become champion, and without a title there would be no big money. If Tony had quit then it would have been the wise thing to do. The beating he took from Minter never should have happened. It is sad to watch.

Even though Tony was much better managed than John Coiley, he still took too much punishment over the course of his career. In 2008 Tony Licata died of a heart attack at the age of 56. He will always be remembered by Boston fight fans from the 70s as a class act.

Correction: In last week's column I stated Tony Licata had a loss on his record when he fought John Coiley. He was undefeated at the time.

THE COOZ STARS IN GOTHAM — If there was any doubt that Bob Cousy would be a star those thoughts of negativity were erased at Madison Square Garden in New York City on January 21, 1954.

The occasion was the fourth All-Star Game for the NBA that attracted some 16,427 fans to the historic arena 67 years ago to see the league's best battle it out head to head in the latest annual version of Boston sports executive Walter Brown's incarnation of a winter sports classic. That had it's origins in 1951.

And battle it out they did. With just seconds remaining in the game the East held a slim 84-82 lead. But then the West's George Mikan was fouled. Living up to his designation as the league's first superstar, the center for the Minneapolis Lakers calmly sank both free throws to send the game into overtime.

It was then that one Robert Joseph Cousy took over the proceedings. Having scored only 10 points during the span of the 48-minutes of regulation time, the former Holy Cross standout who was born and raised in New York City came out firing, scoring 10 of the East's 14 points in overtime to pace a final 98-93 victory over the West. This was the last time both teams failed to break the 100 point mark in an NBA All-Star Game.

When it was all over Cousy had played 34 minutes — the most of any player on the Eastern Conference roster. A significant component of his 20 points was his performance from the charity stripe where he had converted all eight of his free throw attempts. He also captured 11 rebounds and dished off for four

For his outstanding play, especially in the overtime session, he was named the game's MVP.

HOCKEY EAST'S ENHANCED ESTEEM — As we all know Hockey East is one of the best college hockey leagues in America. Never was that more evident than on the eve of the current NHL season when a record 79 former Hockey East players were spread across the rosters of the 31 National Hockey League clubs.

It was the ninth straight year that Hockey East led all college conferences in terms of having the most former players on NHL rosters. It is a number that has steadily grown. Back in 2011, Hockey East had 44 former players on NHL opening night rosters.

As play began in mid January, every National Hockey League team had at least one former Hockey East player on its roster. Boston University led with 17 former players now seeing action in the NHL ranks while Boston College had 15 and UMass-Amherst had 10. Maine, Northeastern and Providence had six players each in the NHL while UNH had five. UMass-Lowell was next with four while UConn, Merrimack and Vermont each had one. In addition, seven players who played for Notre Dame when that school was in Hockey East are in the NHL.

IT'S TAMPA'S TIME — Yes, even in this challenging time of uncertainty, a bright beacon of positive light shines across a certain portion of the southern landscape. That would be in Tampa, Florida where the sports spotlight once again focuses its golden beams for a third time in just a few short months.

Recall, it was back on October 9th when the Tampa Bay Lightning won the Stanley Cup by defeating the Dallas Stars 2-0 in Game Six at Rogers Arena in Edmonton with no fans on hand because of Covid-19 restrictions.

Just a few weeks later on October 27th the Tampa Bay Rays made it to the World Series where they lost in six games to the Los Angeles Dodgers in Arlington, Texas — a neutral site chosen by MLB and turned into a modified bubble location in order to minimize the risk of Covid-19 transmissions.

Although the Rays lost the World Series, they provided one of the most exciting comebacks in World Series history, winning Game Four by scoring two runs in the bottom of the ninth inning for an exciting 8-7 victory — and hopefully putting to rest the argument in favor of seven-inning games.

And now come the Buccaneers, piloted by NFL G.O.A.T. (Greatest of All Time) quarterback Tom Brady, leading a team that was 7-5 at one point and now is preparing to play in the Super Bowl against the Kansas City Chiefs. That's three pro sports teams representing a single metropolitan region advancing to the championship stage in just a four month span. Some sports headline writers have renamed Tampa Bay "Tompa Bay" in Brady's honor.

As if that isn't enough, there remains the possibility of a fourth Tampa Bay team advancing to a championship final. That's because the Toronto Raptors of the NBA, who normally play their home games in that Canadian city, are currently playing the home portion of their 2020-2021 schedule at Amalie Arena in Tampa because of Covid-19 travel restrictions north of the border.

The Raptors won the 2019 NBA Championship defeating Orlando, Philadelphia and Milwaukee in the playoffs before facing Golden State in the NBA Finals. Toronto captured the crown by winning the series in six games. Harvard grad Jeremy Lin, much admired by fans in the Boston area, was a member of that team in a reserve capacity.

Last year (2019-2020) the Raptors finished the regular season with a 53-19 mark — second best in the Eastern Conference, just behind conference leader Milwaukee and five games ahead of the third place Boston Celtics. They then lost to the Celtics in a second round playoff series that went the full seven games in the Orlando bubble.

This season Toronto has had a bit of a rough start, owning a 7-10 record through January 25th. But it is a 72-game schedule so there are many opportunities left for improvement. And if they make the playoffs then it is a whole new season then anything can happen. But whatever happens, the championship lights will still be shining brightly down by Tampa Bay.
