Watch Out for La Befana!

If we were only to take a quick glance around us, the Christmas season appears to have basically finished. Scraggly trees stand forlornly next to dumpsters and dusty ornaments once again occupy shelf space in the closet. Dwindling leftovers and stale cookie crumbs speak of the great holiday feasts the previous week. However, according to both religious and folkloric calendars, we are still in the midst of the Christmas sea-

son! Christmas lasts for twelve days, up until January 6th, which is the feast of the Epiphany. In Italy, the Epiphany, or *la Epifania*, is a significant holiday with traditions that equal those of Christmas Eve. An ancient feast day, the Epiphany honors the visit of the Three Magi to Baby Jesus. On the eve of this holiday, Italian children excitedly head to sleep, knowing that in the morning they will find their stockings full of

presents from *La Befana*, Italy's premiere gift-bringer. Along with the arrival of *La Befana*, the Epiphany also ushers in the Carnival season, a joyous time of mischief, which paves the way for spring. With its appealing imagery of magical witches and playful silliness, the Italian Epiphany bursts with unique and fascinating customs.


Nowadays, Italian children will receive presents on Christmas from Babbo Natale, or Santa Claus. However, La Befana has still retained her status as Italy's most famous folk figure and favorite gift-bringer. So who exactly is this mysterious character? La Befana, whose name derives from a corruption of the word "Epifania," is a fairylike witch who, like her male counterpart, drops presents in the stockings of good children while leaving behind coal for the naughty. She is typically depicted as an old woman in raggedy clothes mounted on a broomstick. A well-known legend explains La Befana's connection to the Biblical story of the Epiphany. According to

THE CENSUS TAKERS

The name "censor" is of Roman origin. It was the title that was conferred upon only two officials and these persons were elected by the people for a one and one half year term of office. Once installed in office, they exercised extraordinary powers over the people. It was the most honored office in the Roman Republic. The censors were far less conspicuous than the consuls because they were never sent into the fields with the armies as the consuls were. In the interior administration of the city, the censors were almost autocratic, and answerable for their actions only to each other.

The censors ordered and supervised the quinquennial (five-year) census registration. They determined the obligation of each Roman citizen to the state, financial, or otherwise. They had the power to degrade anyone and even remove his name from the roll of free citizens. The censors could prohibit the publication, distribution, or the display of anything that they might consider detrimental to the morals or safety of the public, even this column.

References to the methods used to count the population go back to ancient times in almost all nations. The counting differed from our modern census because the main purpose of the ancient count was for taxation and conscription. Widespread resentment towards the census started during those ancient times and has continued through the years to today.

During regal times in ancient Rome, the census was taken by the kings when they came into power, and then by the censors during the Republic. Messengers called all of the people together in a central public area. Each tribe presented itself and the citizens were called individually according to the previous or existing register. Each person was required to state under oath, his age, name and the name of his father, wife and children. He was also required to tell where he lived and the amount of his property. All of these facts were compiled by assistants to the censors. The lists for the distant provinces were sent to Rome by the provincial governors, while a special commission provided the count for any armies that might have been engaged in war outside of the empire. The last census of this type was taken by the Emperor Vespasian in 74 A.D.

I suppose we should count our blessings. When compiling the ancient census, they took into consideration not only a man's property, but his moral conduct as well.

Energy Bill Scams

As temperatures drop, thermostats begin to rise and many consumers begin to see their heating bills increase. It should come as no surprise then that scammers capitalize on the changing seasons by offering lower energy bills or preying on fears about paying for service.

Usually initiated by a phone call, or less commonly by door-to-door solicitations and even the occasional fax, scammers suggest their company can offer lower utility bills than larger providers, such as Eversource, National Grid, or Unitil, and ask for account information and/or billing information to "review" the account.

Our Office isn't immune to these calls. We wrote about this scam last winter after staffers received multiple calls on both personal and work phones about our accounts. We made up account numbers and provided false addresses, but the scammers had no trouble locating our accounts! After being conferenced in with someone from their billing department, we disconnected the call. We also recently received a fax from a company offering lower rates. We called the number on the fax and requested information about their company and where they are headquartered. The scammers didn't appreciate our questions and quickly hung-up the phone.

These scam calls and doorto-door solicitations can be confusing because many times they stem from something real. Massachusetts residents have a choice in who provides their electric supply and the Department of Public Utilities has information on their website where consumers can learn about competitive energy suppliers and choose an alternative to their service. In an effort to help combat scammers and protect consumers, the DPU issued an order requiring that all legitimate door-to-door marketing campaigns file a notice with the Department and follow specific guidelines when conducting business. Those individuals doing the solicitations must also produce and display identification clearly stating the competitive supplier or electricity broker's name, logo, and the individual's first name, photo, and identification number; Provide a phone number on request that the customer can call to verify the identity of the individual and competitive supplier or electricity broker they are representing; Identify the competitive supplier or electricity broker which he or she represents upon commencement of the sales call; and cannot suggest affiliation with the local utility.

In other variations of a utility scam, the scammer threatens

immediate shut-off of the utility unless payment is made. Often, they demand a payment, typically a prepaid debit card from a store. Utility companies will never demand a specific kind of payment.

IF YOU EVER RECEIVE THESE SOLICITATIONS, YOU SHOULD:

- Be cautious. Utility companies will seldom call you or visit your home without you first initiating the call or visit.
- Get your most recent utility bill and ask the caller to recite your account number. If they cannot, that's a sign they're a scammer.
- Ask for identification. Utility employees will ALWAYS carry identification. Don't let anyone in your home who cannot provide proof of who they say they are.
- Remember your shut-off rights. Utility companies must follow strict rules and processes before turning off your service. A call or unexpected visit will never be the first time you're learning that you owe money.


Saint John Southworth

John Southworth was born to a Lancashire family who lived at Samlesbury Hall near Preston in 1592. His family, being Catholic, chose to pay heavy fines rather than give up the Catholic faith. He studied for the priesthood and was ordained a priest in 1618, at the English college Douai in Northern France.

In 1585, a law had been passed making it a treasonable act for any priest to return to England. The law was later extended to all who assisted priests. Southworth was ordained a priest before he returned to England. He returned in October of 1619, where he remained until 1624, when he was recalled to serve as chaplain to Benedictine nuns in Brussels.

After about a year, he returned to Lancashire, where he was arrested in 1627, and imprisoned in Lancaster Castle. Southworth was later moved to The Clink in London. He was sentenced to death for pro-



fessing the Catholic faith, but in 1630, at the insistence of Queen Henrietta Maria, he and seventeen others were delivered to the French ambassador and deported to France.

In 1636, he was reported to be living in the Clerkenwell district of London where he frequently visited the plague-stricken victims of Westminster to administer the sacraments and comfort the sick and the dying.

In 1654, an informer told the authorities that a Catholic priest was working in Westminster. Southworth was arrested and tried at the Old Bailey. There was little evidence against him and friends advised him to deny being a priest, however, he would not deny his priesthood and was condemned to be hung, drawn and quartered at Tyburn on June 28, 1654.

The Spanish ambassador returned his corpse to Douai for burial. His corpse was sewn together and parboiled, to preserve it. Following the French Revolution, his body was buried in an unmarked grave for its protection. The grave was discovered in 1927, and his remains were returned to England. They are now kept in the Chapel of St. George and the English Martyrs in Westminster Cathedral in London.

Southworth was canonized on October 25, 1970 by Pope Paul VI. The Feast of Saint John Southworth is on June 27th.

this folktale, La Befana was sweeping her house when the Three Magi approached her, inviting her to accompany them on their way to find Baby Jesus. La Befana initially declined, saying she was too busy with her cleaning. However, she later changed her mind and hopped on her broomstick, flying through the sky in an effort to find the Magi. Unfortunately, she was never able to locate them, and still soars through the air with her broom to this day, depositing presents for children as she continues to search for Baby Jesus and the Magi. When I was a little girl, I was frightened of La Befana. whose stern and haggard countenance formed a sharp divide to the jolly and merry-faced Santa Claus. My apprehension was amplified by the haunting traditional melody my grandmother sang, which intoned "La Befana vien di notte/Con le scarpe tutte rotte/Col vestito a la Romana/Viva, viva La Befana!" (Translation: "La Befana comes at night/With her shoes all broken/Dressed in the Roman style/Long live La Befana!"). However, I now love La Befana for her powerful symbolism of feminine strength and her unique sense of magic. Many scholars believe that the figure of La Befana originated from old folk goddesses who oversaw the transition from winter to spring, which intensifies her cultural significance.

As a matter of fact, the Epiphany as a whole functions as a threshold to the arrival of spring. The winter solstice has already passed, and the hours of sunlight slowly lengthen. The sapphire-blue skies and golden sunsets of these midwinter evenings instill in me an excitement over the turning of the yearly cycle. Though we can of course expect more months of snow and cold, the promise of spring now unfolds quietly before us. The Epiphany ends the Christmas season, as is evident in an Italian dictum, which proclaims "La Epifania tutte le feste le porta via" ("The Epiphany sweeps all the feasts away"). However, the Epiphany does introduce another season, that of Carnival, Carnival, the precursor to Lent and Easter, extends from the Epiphany to Mardi Gras, or the Tuesday before Ash Wednesday. As such, Carnival serves as a spring festival, a herald to the still far-off festival of Easter. All over the world, people bake King Cakes on Twelfth Night, or the eve of the Epiphany. King Cakes are bread made specifically for the Epiphany and Carnival season, with variations differing worldwide. In France, King Cakes contain a flaky crust and an almond frangipane filling. Spanish King Cakes are adorned with candied fruit. Louisiana-style King Cakes are ring-shaped, with a cinnamonsugar swirl inside and a colorful topping. I make this kind of

King Cake every Twelfth Night, decorating it with the traditional Carnival colors of green, purple, and yellow. I follow the folk custom of hiding a chickpea inside the cake — whoever finds it will receive good luck in the coming year! With such a cheerful dessert promising good times ahead, the revelry of Carnival can officially begin!

Though the Twelve Days of Christmas are nearing their close, the celebrations do not have to end. The Epiphany provides us with ample ways to bring more festivity into our life. We honor the arrival of La Befana, the magical witch who fills children's stockings with presents under the cover night, who symbolizes the ancient strength and power of women while also ushering the change of the seasons. We can celebrate Carnival, that long welcome to spring that fills our days with color and laughter. As the Christmas season yields to the bright new days of January, we should always maintain our childlike wonder and our love for the magic and mysteries of Mother Earth inside us. So let us get ready for La Befana, for she lights our way to a joyful season of hope and promise!

Visiting Giarratani Family Roots



In 1906, my grandfather migrated to the United States to start a new life in America for his family. He boarded the Mario Manghetti and set sail across the Atlantic Ocean, finally arriving in Boston's North End where his wife's family was already living on Fleet Street.

My grandmother's family had arrived in the North End in the early to mid-1890s.

Recently, my nephew Dominic and his family came up from Austin, TX for Thanksgiving with my brother's family from Roslindale. On November 24th, I became a tour guide, showing him and his family where the Giarratani family started in America. Basically, it was at the Sacred Heart Parish, the parish of many immigrants from Sciacca in Sicily.



It all began with the Sacred Heart Church.

The first stop was Sacred Heart Church in North Square. Upstairs in the back of the upper church is a large plaque dated 1928, marking the restoration project of the upper church. My family name is up there on the plaque with the Giarratani spelling. More on this to come!

"F and N Giarratani," The F is for my grand-mother Filippa and the N is for my Uncle Nick.

This plaque marks the beginning of the "GIARRATANI" name. When my grandfather Salvatore Giarratano passed away in 1915, he lived his whole life as Giarratano.

The change in spelling occurred in the North End, not at immigration processing. When he died the records at St. Michael's listed him as Giarratano. This is a big mystery that the family has never solved and mostly stopped caring about since Giarratani sounded okay to us.

I showed my family where my grandparents first rented a room in America was. It was in a large tenement building to the left of the Paul Revere House. The building was long ago demolished for an extension of the historical site. I showed them where grandpa lived as a little boy. Today, it is the playground across from the Paul Revere House, but back then it was the Sorrento Hotel. I showed them 46 Lewis Street, where his dad and I lived in 1953 as little kids.

We ended the tour by having a late lunch at Bencotto Restaurant at the corner of Fleet and Hanover streets. I had never eaten there before and I thought it could be a great experience for all of us and it was. The pizza we had was great and we loved those ravioli, too.

My nephew wants me to pick up the tour on his next visit back to the Giarratani North End neighborhood.

My love for swimming was born at the Dorchester House, still sitting on Dorchester Ave. When I was a toddler, my parents enrolled me in a swimming program which I continued well into elementary school. Little did I suspect as I had the time of my life splashing away that I was part of the story of a building that has been a community landmark for, now, over a hundred years.

For generations, the Dorchester House has served the community's medical and recreational needs and, as its colorful walls stand testament to, an after-school beacon for the local children.

Memories of my earliest days at the pool are foggy, but I do recall that after the swimming exercises with the supervisor my dad would often jump in and play in the water with me.

More serious lessons started when I got into first grade and I was joined by many of my classmates from St. Mark's.

Lessons included jumping into the deeper end of the pool, jumping into the water with your clothes on (no kidding), and submerging your head underwater. For me, the biggest thrill (since it had long been off-limits when I was young) was learning to jump off the diving board. As much as I had fantasized about it when I was young, my first few jumps spooked me. The height was something I could not appreciate until I climbed to the top and looked down at the pool below me.

The Dorchester House for me remains not only the place in which I developed a fondness for swimming but the first institution that made me feel part of a community. Today it still stands, welcoming a new generation of kids that will likely build a foundation there.

Nanna & Babbononno

A Nostalgic Remembrance



When I was a kid in East Boston, the hectic lifestyle my family would lead during the Christmas season would come to an abrupt end after New Year's Eve. Dad and my uncles would return to just playing during the evenings of the midweek and definitely on weekends. Dad would also be back to work days at his job in the Boston School Department, Uncle Nick was back in his office at the musicians union as the vice president, and Uncle Paul would rejoin the printing company he worked for. Babbononno, long retired, would reconnect with his pals at the storefront societies in both the North End and East Boston. The one exception to Babbononno's activities was the Christmas season of 1958. Just before the holidays arrived that year, Nanna passed

During WWII, my grandmother had a heart attack, and after a long stay in the hospital, she recuperated to the point where she resumed normal but abbreviated activities. During the mid-1950s, she developed breast cancer and after operations that seemed successful, went through the primitive recuperative steps that were necessary for survival at the time. She was often in pain and succumbed to the disease after it spread to her lungs late in 1958. Christmas 1958, was not a happy time.

Toward the end of WWII, after Nanna's heart attack, Babbononno sold the big house on Eutaw Street in East Boston as it was too much for Nanna to handle. They rented an apartment on Princeton Street for a few years, and later moved to Lexington Street, where they were living when Nanna passed away. Babbononno was up there in years and the decision was made for him to move in with us. Backtracking again, when Babbononno sold the house at 70 Eutaw, Dad and Mom rented a third floor walkup at 74 Eutaw, two doors away. The house was, and still is attached to number 72 Eutaw. 74 was owned by the parents of a woman Mom had grown up with and her husband was someone Dad had grown up with. They had the 3rd floor apartment available and we moved the distance of two houses away from where I was born.

The apartment consisted of four connected rooms, a hallway bathroom and a small room at the end of the hallway near the staircase that brought us to the third floor. That room was occupied by a single brother of the landlord's wife. When he moved

out, wanting to try his luck in California, Dad rented the room to be used as either a workshop or a music room. It would serve as both until Babbononno moved in with us early in 1959. My room was a small one just off the kitchen, but when Uncle Gino and Aunt Ninna were married after the war and were just starting out, they moved in with us. For almost a year, they took over my bedroom and I had the living room couch. When they finally found an apartment, I had my bedroom back. When it was Babbononno's turn, the tools headed for the cellar and the spare room became the bedroom my grandfather would

was in college and often studied at the kitchen table. Dad would play almost every night leaving both Mom and Babbononno at home. Mom had a circle of lady friends in the neighborhood and a couple of evenings a week, would tie up with them for tea and gossip. That left Babbononno with me and he developed a curiosity about the things I was studying, especially history, which was one of his favorite subjects. As a result, we had many conversations of the historical developments of the world, but I often met with a couple of East Boston friends that attended college with me. We had an informal study group that was ongoing and I often had to leave Babbononno alone at night. When this happened, I felt sorry for him, as he would sit in front of the TV, which bored him, or he would reread one of the Italian newspapers he loved, including this one.

Parking at night became a problem not long after WWII ended. With everyone on the street buying new cars, Dad had to hunt for a parking space when he came home after playing with his band at night. Seeing he had to get up early the next morning, he was often upset if he had to drive around the neighborhood until he could park. By the time the '60s rolled around, things got worse. I had just started on a teaching career, was playing music as many nights as I could afford and began taking courses toward a master's degree. One winter's night Dad couldn't find a parking space on our block. It was snowing, and by the time he drove home from his job, it was late due to slow moving traffic. He searched for an hour and finally found a spot on another street blocks away. He then trudged home in several inches of snow with a bass violin under his arm, swearing all the way in two languages.

It was difficult at times as I

He told Mom at dinner the next night that he wanted to buy a house with a garage and a driveway somewhere outside the city. My mother was so attached to East Boston she didn't want to move. When the scenario was repeated, Dad told Mom that he was going to move and he would pay for the Eutaw Street apartment for her and Babbononno. Mom knew he meant what he said and knew that her place was with her husband. That spring, they bought a house in Belmont. We were familiar with the town as Uncle Gino and Aunt Ninna had built a house there not long after my aunt delivered a set of twins to this

Babbononno didn't want to leave East Boston either, but didn't want to stay alone. He gave in and on Easter weekend of 1961, we left East Boston for Belmont. At first, I couldn't sleep at night ... it was too quiet: no sirens on the streets, no planes landing at Logan after flying directly over the house ... no noise at all, just crickets and birds to entertain us. Mom and Dad learned to love it, but Babbononno hated it. Back in East Boston, he could go to his clubs and play cards several times during the week. He could also head to Central Square where he could buy the Italian newspapers he loved along with the Di Nobili cigars he smoked. Belmont Centre, which was a close distance from our house, offered nothing Italian back then and Babbononno, as I said, hated it.

Finally, the decision was made after long conversations with my uncles, Babbononno was to head back to East Boston. An apartment was found near Maverick Square and we moved him there. My mother was off the wall one day when I returned home from work. When I asked her what was the matter, she said, "I called your grandfather a while ago and an Irish woman answered. It turned out to be a neighbor near his age and seeing he was in his mid-90s and she pushing 90, I told my mother that the most erotic thing that could happen would be them holding hands. Mom had to accept the relationship

Recipes from the Homeland

1 large onion sliced (optional)

2 fresh tomatoes sliced

(optional)

BROILED LAMB CHOPS

4 lamb chops 2 garlic cloves chopped or crushed

3 tablespoon olive oil

Chopped mushrooms (optional) Salt and black pepper 1 teaspoon oregano

In a bowl, mix chopped or crushed garlic with oil and oregano. Using pastry brush, spread the mixture onto both sides of each lamb chop. Marinate lamb chops in extra marinating mixture in a dish for at least thirty minutes.

TO BROIL: Lightly spray broiling tray with oil before placing chops on the tray. Place tray with chops in oven at least two inches under the broiling coils, broil fifteen to twenty minutes, depending on thickness of chops. Turn chops occasionally in order to cook on both sides. Broil chops until they reach the consistency desired. Before serving, brush extra marinating mixture over chops. Salt and pepper to taste.

OPTIONAL: Place tomato slices over marinated lamb chops in broiling tray. Then spread onion slices over tomato slices. Sprinkle a little oregano and oil over the onions. Chopped mushrooms can also be added. Cover broiling tray with aluminum foil before placing in the oven at least two inches under the broiling coils. Broil about twenty to thirty minutes depending on thickness of chops. Check for desired tenderness. Remove cover to allow browning. Salt and pepper to taste. Serves two.

NOTE: I have grilled marinated lamb chops many times on our charcoal gas grill following this recipe. When I add tomato and onion slices, I arrange everything in a throwaway broiling tray, cover it with aluminum foil and cook over the grill. Then uncover them and brown slightly on the grill.





The Night Louis Took on Baer

Joe Louis turned professional on July 4, 1934, when he kayoed Jack Kracken in the first round. He would fight 11 more times in the remaining months of that year for a total of 12 wins. To say his rise was meteoric would be an understatement. Louis, in very a short time, was crashing into the top ranks of the heavyweight division. Not only was he winning fights, he was beating solid fighters. To close out 1934 he stopped the very highly regarded Stanley Poreda.

In his second year as a pro, 1935, he would accelerate his rise to the top, beating Lee Ramage (this was his second win over Ramage), Don "Red" Barry, and Natie Brown to name just a few.

In June of 1935, in only his 20th fight, Joe took on former heavyweight champ Primo Carnera. Louis stopped the giant Carnera in the 6th round with a devastating attack. It should also be noted that while this was not a title fight, it was scheduled for 15 rounds. Louis was a force to be reckoned with and there were other former champs he wanted to add to his record.



Louis vs. Baer

After easily defeating King Levinsky in his next fight, Louis was matched with former champ Max Baer. The two would face off at Yankee Stadium on September 24, 1935. At this point Joe had only been fighting pro for a year and a half. The fight was scheduled for 15 rounds.

Max Baer had lost the title to Jimmy Braddock three months earlier. The year before he floored Primo Carnera 11 times in as many rounds while winning the championship. Even after losing the title Baer remained immensely popular with the public. His outgoing personality was the opposite of the laid back Louis. Baer was also one the hardest punching heavyweights to ever lace on the gloves.

The fight drew tremendous interest among the public. Over 84,000 tickets were purchased leading to a gate of \$932,944. Numbers like that had not been seen since the days of Jack Dempsey. What makes that figure even more impressive is this was during the Great Depression when money was very scarce. Joe Louis had captured the imagination of the public, and now they wanted to see if he was real. Baer appeared to be the man who would truly test him. Even though he had lost to Braddock, it was thought he had not taken that fight seriously and lost because he was not motivated. The Louis fight would be his chance to reestablish himself as being worthy of another shot at the title.

The stakes were high for Louis as well. Would his lack of experience lead to problems if he were to be tagged with a solid punch from Baer? Would facing such a powerful puncher be intimidating to him? Which Baer would show up, the Baer who brutally destroyed Max Schmeling a couple of years earlier, or the lackluster Baer of the Braddock fight? Fight fans didn't know but they were anxious to find out.

Jack Dempsey was working Baer's corner that night, and in the dressing room before the fight Max was showing signs of being overcome with fear. Baer had hurt his right hand in training and told Dempsey because of that he felt Louis would "kill him". Dempsey had to work hard to keep him together and told him he would be fine once the bell rang for the start of the fight.

When the two fighters entered the ring it appeared Bear had his nerves under control. Legendary fight announcer Joe Humphreys was brought in to make the introductions. Having just recovered form a stroke, this would be

Humphrey's last time stepping into the ring. His voice was still strong as he called out the names of the contestants as well as all of the ring officials without using notes. Louis weight 198 pounds while Max came in at 210.

At the opening bell Baer came out tentative, pawing with his left hand. Louis parried Baer's jab and came back with solid jabs of his own. and at one point hurt Baer with a vicious hook followed by a right uppercut. At this point it appeared Baer's fears were being realized and the fight would be a short one. However, midway through the round Baer went on the attack. This would be the test for Louis. Baer landed a very hard right to Louis's chin followed by a series of solid punches to the head and body that shook the Brown Bomber. Here's where Louis showed what he was made of. He stayed calm and immediately fired back with punches of his own, throwing them inside of Bear's shots. At the end of the exchange Louis had taken control of the fight and it would just be a matter of time until the end came. He had taken Baer's best shots and fired back like a champion.

Baer did rally one more time at the end of the second round, but it did not slow Louis down. In the third round Louis dropped Bear with a left right combination. While on the canvas Baer gave Louis a salute. When he got to his feet Louis

decked him again with two hooks. It appeared Baer was not going to get up, but then the bell rang and he made it to his corner.

In the fourth round Baer was taking a lot of punishment. Louis was landing with very hard left jabs that were busting up the former champ. Louis, while landing these jobs was also slipping his head to the outside of Bear's left and finding the distance to land with his right hand counter. Near the end of the round Louis landed with a terrific right hand over Baer's left. The punch landed square on Bear's chin dropping him to a half seated position. Baer was conscious but clearly had no intention of getting up. As referee Arthur Donavan was counting, Max waved his hand signaling he was all through. After the fight he said "I could have struggled up once more, but when I get executed, people are going to have to pay more than twenty-five dollars a seat to watch it." You can't blame him as he was taking an awful beating.

There are two other well known quotes to come from Max Baer regarding the Louis fight. It has been reported that between the second and third rounds Jack Dempsey told Baer "You're doing great Max, he hasn't laid a glove on you." to which Baer responded "Well, in that case you'd better keep an eye on the referee because someone's beating the hell out of me."

The other, which I think any of Joe Louis' opponents would agree with, was "Fear is standing across the ring from Joe Louis and knowing he wants to go home early."

Baer went on to win his next 19 fights and had hoped to have a rematch with Louis for the title, but losses to Lou Nova and Tommy Farr put an end to that dream.

Joe Louis would go on to win the heavyweight title, but not before running into his own setback. On the night he faced Max Baer he showed the skill and fortitude that would make him the greatest heavyweight champion of all time.

HOOPS and HOCKEY in the HUB

There was a first, there was a third, and there was the capstone to a multi-year championship run plus something that had not been accomplished before in the regular season.

And most of all it was indeed more than all those things. For they, the individuals that strung together this series of accomplishments comprised one of the best basketball teams of all time.

They were the 1985-1986 Celtics and wow did they set the basketball world on fire, winning nearly everything on their march to the playoffs and then breezing their way through the first three rounds before engaging in a challenge for the title.

The first seeds toward a successful season were sown in the summer when G.M. Red Auerbach traded Cedric Maxwell to the Los Angeles Clippers for Bill Walton. The big center had been hobbled by injuries for the past two seasons but Auerbach thought there was a lot to like in Walton. He wound up playing 80 games in that memorable season for the Green and White, earning the coveted Sixth Player Award in the process.

The season would also mark the high plateau of the original Big Three — consisting of Robert Parish, Kevin McHale and Larry Bird. Throw in a shooting guard named Danny Ainge plus the versatile Dennis Johnson and you had one of the best quintets ever to take the court.

First off came the regular season and what an experience it was — a historic campaign — especially at home — that produced a first in NBA history and would not be equaled again for another 30 years (until the 2016 San Antonio Spurs).

It's very rare in the 82-game regular season that it might come down to a singular focus — but that is in effect what happened. The Celtics posted an unbelievable 40-1 record at home en route to a 67-15 overall mark. For those old enough to remember that enviable home record would be split between two venues since the C's were 37-1 at the Garden and 3-0 at the Hartford Civic Center.

The lone setback came rather early — against Portland on December 6, 1985 at the Garden — but would not take on that singular significance until much later. The Celtics entered the contest with a fine 17-2 mark while Portland took the floor at 12-10

The difference in the contest came down to scoring by the bench players. While all five Celtics starters — Ainge, Bird, McHale, Parish and Johnson scored in double figures, none of the Celtics players coming off the bench did so, contributing only 26 points as a group.

By comparison, not only did four of the five Portland starters score in double figures but two of the Trailblazers' bench players — Steve Colter and Jerome Kersey — each scored 22 to account for 44 of the 56 points tallied by Portland's reserves.

But in the grand scheme of things it really didn't seem to matter at that point in time. It was only early December with another four and a half months of the regular season left to play. The Celtics still owned a sky high 17-3 record. At the time, it just seemed like one of those nights that all good teams in the NBA have now and then over the course of the 82-game schedule.

The Celtics easily captured the Atlantic Division crown by 13 games over the Philadelphia 76ers as well as the regular season Eastern Conference title by 10 games over the Milwaukee Bucks.

Then it was on to the NBA Playoffs. Today all four rounds are best-of-seven affairs but that was not the case some 33 years ago. The first round in the spring of 1986, for example, was a best-of-five series. And, while the Celtics swept the Chicago Bulls 3-0, once again it was another instance where the opposition would be remembered for feats accomplished.

The first two games were played at the Garden with the Celtics escaping with a 135-131 victory in the second one that went into double overtime. This would go down in history as the famous contest where Michael Jordan would set a playoff record by scoring 63 points, an NBA mark that still stands.

In the second round against Atlanta, the C's took a commanding 3-0 lead in games before Atlanta came back for a victory in game four. But the Green and White dashed any hopes of the Hawks with a 132-99 triumph in game five at the Garden to close out the series.

The Eastern Conference finals against the Milwaukee Bucks wouldn't even go that far with the Celtics sweeping the series, 4-0. The Bucks only came close in Game three where Boston prevailed for a four point victory, 111-107.

Many thought that Boston would face the Los Angeles Lakers in the 1986 NBA Finals. The Celtics were looking forward to a rematch with L.A., a team that had beaten Boston for the title in the 1985 finals. But the Houston Rockets upset the Lakers in the Western Conference Finals.

That set up an All-Celtics coaching matchup in the finals pitting Bill Fitch, who guided the Celtics to the 1981 NBA Championship, against K.C. Jones, the former player who was now coaching the team.

The format for the finals was 2-3-2. The Celtics won the first two games at the Garden, came away with a narrow victory in the second of the three games in Houston and then wrapped things up with a victory in Game 6 at the Garden on June 8th.

It was Banner 16 and would be the culmination of special year in a special way. Even though succeeding years and decades would bring additional stars and accomplishments, the players on the 1985-1986 squad continue to shine forth with a special radiance within the galaxy of great accomplishments by NBA franchises.

The historic 1985-1986 season marked the first time an NBA team would lose only one regular season game at home plus the first time an NBA team
