Stirpe Nostra

THE TOMB OF CECILIA METELLA

This week's Stirpe Nostra was a quest column from Fr. Rocco. Fr. Rocco was born in the Province of Frosinone, Italy. He joined the Don Orione Order when he was 14 years old and was ordained a priest at the age of 28, in Tortona, Piedmont. Fr. Rocco was the Administrator of the Don Orione Home and the Madonna Queen National Shrine, that familiar landmark on the hill in East Boston. It should be mentioned that the title of this column, Stirpe Nostra, was his suggestion.

One of the well-known circular tombs in Rome is that of Cecilia Metella. She is now known as St. Cecilia. The structure is a landmark on the Via Appia and it is still standing, though it has suffered from neglect and violence. The tomb is said to be the oldest Roman building where marble was used. The original cone-shaped roof has been removed and all of the marble facing has been stripped off. Some of the marble has been reused at the Fountain of Trevi.

The Mausoleum is about 70 feet in diameter and 100 feet high. The thick stonewalls leave a little space on the inside for a simple circular room which is open to the sky. The sarcophagus was removed long ago.

Cecilia is said to have been the wife of Valerian, a young man chosen by her father. Immediately after the wedding ceremony, she managed to convince her husband that an angel of God was watching over them and that if her virginity was respected and maintained, God's love and blessings would come to both. Valerian was convinced and converted to Christianity. These were bad times and an outward display of his new Christian faith soon resulted in his execution. Shortly thereafter, Cecilia chose not to repudiate her faith and she was condemned to death by suffocation in the bathroom of her home. The hot air furnace was loaded with about seven times

its usual amount of fuel and she remained locked in the room for over twenty-four hours. Cecilia survived the ordeal with little or no ill effects. An official was then sent to behead her. As a novice, he struck with a trembling hand the three blows, which the law at that time allowed, but left her still alive. She remained where she had fallen for two days before death mercifully took her.

St. Cecilia was originally buried in the Catacombs of St. Calixtus. The Church of St. Cecilia was later built over the site of the house in which she was martyred, and in 821 A.D., her body was transferred into that church. The legend of St. Cecilia tells us that as a result of a vision or a dream,

which occurred about 1,500 years after her death, the tomb was reopened. She was found to be lying on her right side as a sleeping maiden and not on her back in the usual death position. The body showed no visible signs of decay and appeared to be in a perfect state of preservation.

The sculptor-architect, Carlo Maderna was commissioned to carve a statue representing her exact position. The body of St. Cecilia now lies in a white marble sarcophagus in the confession beneath the high altar of the Church of St. Cecilia in Trastevere. The statue carved by Maderna is also beneath

In addition, Del Rio has brought on a few veteran political campaign operatives as her general consultants. Brian Muldoon, V.P. of Erikson Communications Group, had served as senior strategist for such historical elections as race and Julia Mejia's campaign for Boston City Council Group partners Doug Chavez justice.

and Eldin L. Villafañe, who previously were senior strategists for such winning campaigns as Boston City At-large Julia Mejia's first initial campaign and that of the U.S. Senator Ed Markey's latest race against Joe Kennedy.

This announcement builds on a strong second half of December for Del Rio's campaign. Since her campaign announcement on December 16th, Del Rio has raised thus far roughly \$27,000, with close to 200 unique donors.

A BPS mom and immigrant, Del Rio currently resides in East Boston with her two children and husband. Prior to announcing her candidacy, Del Rio served as Executive Director of YWCA Cambridge, which provides safe housing for lowincome women and emergency shelter units for families. After her campaign announcement, Del Rio resigned from her YWCA post to fully commit to her city council campaign.

Previously, Tania served as the Executive Director of the Boston Mayor Office of Women's Advancement, under former Mayor Martin J. Walsh. She is most proud of her work to launch the Childcare Entrepreneur Fund, a program that provides funding and technical assistance to family childcare workers, to ensure their well-being and maintain the supply of quality childcare options available to Boston's families.

COVID-19 Vaccines & Testing at



Family Vaccine Clinic and Added Weekend Testing

Due to high demand, NEW Health will offer two COVID testing sessions on Saturday, January 8 and again on Saturday, January 15 at their North End site from 8:30 a.m. – 12:00 p.m., located at 332 Hanover Street, Boston, MA 02113 — entrance on North Bennet Street. Appointments need to be scheduled in advance by calling 617-643-8000.

Testing is available for anyone who is showing symptoms or who was exposed to someone who tested positive, regardless of insurance; the ongoing schedule at the North End and Charlestown locations is noted below.

Vaccines, boosters and third dose vaccines can still be scheduled at regular Primary Care Physician appointments for existing NEW Health patients and at designated times for all Boston residents ages 12 years and older. Boosters are now available for anyone ages 16 and older. The ongoing **appointment schedule is available** at https://newhealthcenter. org/covid-vaccination-info/.

Appointments are required and individuals must be registered with Mass General Brigham; individuals interested in making an appointment can reach the dedicated phone lines by calling 617-643-8000 for the North End location and 857-238-1100 for the Charlestown location.

NEW Health is offering Pfizer vaccinations for children (ages 5 and older), Pfizer boosters for teenagers (ages 16 and older), and both Pfizer and Moderna vaccinations and boosters for adults. They are also offering a booster shot to any individual who received Johnson & Johnson vaccine at least two months

NEW Health continues to offer a third dose of Moderna or Pfizer vaccine to anyone with a weakened immune system, and at least 28 days since the second shot of either vaccine they received initially. NOTE: Booster shots are different dosages than third

Grow Herbs Indoors for Year-round Enjoyment

Add garden fresh flavor to your meals yearround. Grow a few of vour favorite herbs indoors, harvest and enjoy.

Select a variety of herbs you and your family enjoy and use for cooking, decoration, or fragrance. Basil, chives, cilantro, oregano, marjoram, mint, parsley, sage, and thyme are some of the easier herbs to grow indoors. Purchase plants or seeds from your local garden center, favorite garden catalog or produce section of the grocery store.

Most herbs need six to eight hours of bright light each day. A southfacing window in winter is best but an east- or west-facing window may be sufficient. Increase success with artificial lights. Set the timer for 14 to 16 hours a day and keep lights 6 to 12" above the plants.

You will find lots of energy efficient and stylish options for just about any space. Sleeker designs like Gardener's Supply Micro Grow Light Garden can be placed on the kitchen counter or a small table. Furniture grade options like *Bamboo LED Grow Light Garden* (gardeners.com) make it easy to grow herbs in just about any room in the house.

Use a variety of plants to create an attractive display in a large windowsill planter. Combine plants that have the same growing requirements to ensure success.

Or place each herb plant in its own container. A four- to seven-inch pot is a good size when starting with smaller plants. Growing individual plants in their own container allows you to provide the specific watering, care and transplanting they need.

Select containers with drainage holes or reduce maintenance and increase success with self-watering containers like Viva selfwatering planters. Just fill the water reservoir that gradually releases water into the soil for the plants to use. You will need to water less often.

Fill the container with a well-drained quality potting mix. Many contain a slow-release fertilizer, providing weeks or even several months of nutrients for your plants. Just check the label for details and adjust fertilization as needed.

Water the containers thoroughly whenever the top inch of soil is dry. Pour off excess water so the plant does not sit in the excess and succumb to root rot. Or place pebbles in the tray to elevate the pot above any water that collects in the saucer or tray. This means less work for you and better growing conditions for the plant.

Incorporate a slowrelease fertilizer or use a dilute solution of any indoor houseplant fertilizer once the nutrients in the potting mix are

spent. Follow label directions and do not overdo as too much fertilizer can harm your plants.

Begin harvesting most herbs when they reach six to eight inches in height and as needed. Use a sharp pair of garden scissors, snips, or hand pruners. Make cuts above a set of healthy leaves so the remaining plant is neater and tidier in appearance. As the plant grows, you will be able to harvest larger quantities and more often.

Start with a few of your favorite herbs and expand your collection as you gain experience. Soon you will be confident and eager to try more challenging favorites.

L'Anno Bello: A Year in Italian Folklore

Keep Your Eyes Open for La Befana!

If we were only to take a quick glance around us, the Christmas season appears to basically have finished. Scraggly trees stand forlornly next to dumpsters and dusty ornaments once again occupy shelf space in the closet. Dwindling leftovers and stale cookie crumbs speak of the great holiday feasts the previous week. However, according to both religious and folkloric calendars, we are still in the midst of the Christmas season! Christmas lasts for twelve days, up until January 6th, which is the feast of the Epiphany. In Italy, the Epiphany, or la Epifania, is a significant holiday with traditions that equal those of Christmas Eve. An ancient feast day, the Epiphany honors the visit of the Three Magi to Baby Jesus. On the eve of this holiday, Italian children excitedly head to sleep, knowing that in the morning they will find their stockings full of presents from La Befana, Italy's premiere giftbringer. Along with the arrival of *La Befana*, the Epiphany also ushers in the Carnival season, a joyous time of mischief which paves the way for spring. With its appealing imagery of magical witches and playful silliness, the Italian Epiphany bursts with unique and fascinating

Nowadays, Italian children receive presents on Christmas from Babbo Natale, or Santa Claus. However, La Befana has still retained her status as Italy's most famous folk figure and favorite gift-bringer. Who exactly, then, is this mysterious character? La Befana, whose name derives from a corruption of the word "Epifania," is a fairylike witch who, like her male counterpart, drops presents in the stockings of good children while leaving behind coal for the naughty. She is typically depicted as an old woman in raggedy clothes mounted on a broomstick. A well-known legend explains La Befana's connection to the Biblical story of the Epiphany. According to this folktale, La Befana was sweeping her house when the Three Magi approached her, inviting her to accompany them on their way to find Baby Jesus. La Befana initially declined, saying she was too busy with her cleaning. However, she later changed her mind and hopped on her broomstick, flying through the sky in an effort to find the Magi. Unfortunately, she was never able to locate them, and still soars through the air with her broom to this day, depositing presents for children as she continues to search for Baby Jesus and the Magi. When I was a little girl, I was frightened of La Befana, whose stern and haggard countenance formed a sharp divide to the jolly and merry-faced Santa Claus. My apprehension was amplified by the haunting traditional melody my grandmother sang, which intoned: "La Befana vien di notte/Con le scarpe tutte rotte/Col vestito a la Romana/Viva, viva La Befana!" (Translation: "La Befana comes at night/With her shoes all broken/Dressed in the Roman style/Long live La Befana!"). However, I now love La Befana for her powerful symbolism

of feminine strength and her unique sense of magic. Many scholars believe that the figure of La Befana originated from old folk goddesses who oversaw the transition from winter to spring, which intensifies her cultural significance.

As a matter of fact, the Epiphany as a whole functions as a threshold to the arrival of spring. The winter solstice has already passed, and the hours of sunlight slowly lengthen. The sapphire-blue skies and golden sunsets of these midwinter evenings instill in me an excitement over the turning of the yearly cycle. Though we can of course expect more months of snow and cold, the promise of spring now unfolds quietly before us. The Epiphany ends the Christmas season, as is evident in an Italian dictum which proclaims: "La Epifania tutte le feste le porta via" ("The Epiphany sweeps all the feasts away"). However, the Epiphany does introduce another season, that of Carnival. Carnival, the precursor to Lent and Easter, extends from the Epiphany to Mardi Gras, or the Tuesday before Ash Wednesday. As such, Carnival serves as a spring festival, a herald to the still far-off feast of Easter. All over the world, people bake King Cakes on Twelfth Night, or the eve of the Epiphany. King Cakes are breads made specifically for the Epiphany and Carnival season, with variations differing worldwide. In France, King Cakes contain a flaky crust and an almond frangipane filling. Spanish King Cakes are adorned with candied fruit. Louisiana-style King Cakes are ring-shaped, with a cinnamonsugar swirl inside and a colorful topping. I make this kind of King Cake every Twelfth Night, decorating it with the traditional Carnival colors of green, purple, and yellow. I follow the folk custom of hiding a chickpea inside the cake — whoever finds it will receive good luck in the coming year! With such a cheerful dessert promising good times ahead, the revelry of Carnival can officially begin!

Though the Twelve Days of Christmas are nearing their close, the celebrations do not have to end. The Epiphany provides us with ample ways to bring more festivity into our life. We honor the arrival of La Befana, the magical witch who fills children's stockings with presents under the cover of night, who symbolizes the ancient strength and power of women while also ushering the change of the seasons. We can celebrate Carnival, that long welcome to spring that fills our days with color and laughter. As the Christmas season yields its way to the bright new days of January, we should always maintain our childlike wonder and our love for the magic and mysteries of Mother Earth inside us. So let us get ready for La Befana, for she lights our path to a joyful season of hope and promise!



Zygmunt Gorazdowski

Zygmunt Gorazdowski was born on November 1, 1845 in Sanok, Poland. His father was Szczęsny Gorazdowski and his mother Aleksandra Łazowski. In his childhood, he suffered a lung ailment that became tuberculosis; this did not prevent him from considering the needs of others and offering his help wherever he could.

Zygmunt studied law for two years, but quit to enter the seminary at Lviv, Ukraine. he was Ordained in 1871. He became pastor of the parish of Saint



In his parish, Father Zygmunt organized The Affordable Public House and The House for Workers, shelters for the poor, hungry, and homeless. He Built a dormitory for poor students of a teacher's college so they could concentrate on study. Founded The House of the Child Jesus, a shelter for abandoned children and single mothers and their children. He founded a convent for the Sisters of Mercy of Saint Joseph in 1884 so the sisters could help with these organizations; their mission was to work in boarding schools, and to care for the aged and sick. He wrote catechisms and other educational works.

Father Zygmunt died in 1920. Those who knew him called him the "Father of the poor and priest of the homeless". In 2008 his order had 508 religious in 71 houses in places as far flung as the Democratic Republic of Congo and France; it became part of the Order of Friars Minor Capuchin in 1922. It received the papal decree of praise from Pope Pius X on April 1, 1910 and full pontifical approval from Pope Pius XI on August 3, 1937.

He was Canonized on October 23, 2005, by Pope Benedict XVI. The Feast day of Saint Zygmont Gorazdowski is January 1st.

Nanna & Babbononno

A Nostalgic Remembrance



When I was a kid in East Boston, the hectic lifestyle my family would lead during the Christmas season would come to an abrupt end. Dad and my uncles Nick and Paul would return to playing music a few evenings during the week and definitely on weekends. Dad would also be back to work days at his day job in the Boston School Department, Uncle Nick was back in his office at the musicians union as the vice president, and Uncle Paul would rejoin the printing company he worked for. Babbononno, long retired, would reconnect with his pals at the storefront clubs in the North End and East Boston. The one exception to Babbononno's activities was the Christmas season of 1958. Just before the holidays arrived that year, Nanna passed away.

During WWII, my grandmother had a heart attack, and after a long stay in the hospital, recuperated to the point she resumed normal but abbreviated activities. During the mid-1950s, she developed breast cancer and after operations that seemed successful, went through the primitive recuperative steps that were necessary for survival. She was often in pain due to radiation treatments and succumbed to the disease after it spread to her lungs late in 1958. The Christmas season of 1958 was not a happy time for us.

During WWII, after Nanna's heart attack, Babbononno sold the big house on Eutaw Street in East Boston as it was too much for my grandmother to handle. They rented an apartment on Princeton Street for a few years, and later moved to Lexington Street, where they were living when Nanna passed away. Babbononno was up there in years and the decision was made for him to move in with us. Backtracking again, when Babbononno sold the house at 70 Eutaw, Dad and Mom rented a third floor walkup at 74 Eutaw, two doors away. The house was and still is attached to number 72 Eutaw. 74 was owned by the parents of a woman Mom had grown up with and her husband was someone Dad had grown up with. The 3rd floor apartment was available and we moved the distance of two houses away from where I was born. We called it the penthouse.

The apartment consisted of four connected rooms, a hall-way bathroom and a small room at the end of the hallway near the staircase that brought us to the third floor. That room was occupied by a single brother of

the landlord's wife. When he moved out wanting to try his luck in California, Dad rented the room to be used as either a workshop or a music room. It would serve as both until Babbononno moved in with us early in 1959. My room was a small one just off the kitchen, but when Uncle Gino and Aunt Ninna were married just after WWII, and were just starting out; they couldn't find an apartment and moved in with us. For almost a year, they took over my bedroom and I slept on the couch. When they finally found an apartment, I had my bedroom back. When it was Babbononno's turn to move in, the tools headed for the cellar and the spare room became the bedroom my grandfather would sleep in.

It was difficult at times as I was in college and often studied at the kitchen table. Dad would play almost every night leaving both Mom and Babbononno at home. Mom had a circle of lady friends in the neighborhood and a couple of evenings a week, would tie up with them for tea and gossip. That left Babbononno with me and he developed a curiosity about the things I was studying, especially history, which was one of his favorite subjects. As a result, we had many conversations on the historical developments of the world, but I often met with a couple of East Boston friends that attended college with me. We had an informal study group that was ongoing and I often had to leave Babbononno alone at night. When this happened, I felt sorry for him, as he would sit in front of the TV, which bored him silly, or he would reread one of the Italian newspapers he loved, including this one.

Parking at night became a problem not long after WWII ended, with everyone on the street buying new cars, Dad had to hunt for a parking space when he came home after playing with his band at night. Seeing he had to get up early the next morning, he was often upset if he had to drive around the neighborhood until he could park. By the time the '60s rolled around, things got worse. I was still working at the Seville Theater a couple of nights a week, had just started on a teaching career, was playing music as often as I could, and began taking courses toward a master's degree. One winter's night Dad couldn't find a parking space on our block. It was snowing, and by the time he drove home from his job, it was late due to slow moving traffic. He searched for an hour and

finally found a spot on another street blocks away. He then trudged home in several inches of snow with a bass violin under his arm and snow in his shoes, swearing all the way in two languages, Italian and English.

He told Mom at dinner that next night that he wanted to buy a house with a garage and a driveway somewhere outside the city. My mother was so attached to her East Boston roots she didn't want to move. When the parking problem was repeated, Dad told Mom that he was going to move and he would pay for the Eutaw Street apartment for her and Babbononno. Mom knew he meant what he said and also knew that her place was with her husband. That spring, they bought a house in Belmont. We were familiar with the town as Uncle Gino and Aunt Ninna had built a house there not long after my aunt delivered a set of twins to this world in 1950.

Babbononno didn't want to leave East Boston either, but didn't want to stay alone. He gave in and on Easter weekend of 1961, we left East Boston for Belmont. At first, I couldn't sleep at night ... it was too quiet: no sirens on the streets, no planes landing at Logan after flying directly over the house ... no noise at all, just crickets and birds to entertain us. Mom, Dad and I got to love it, but Babbononno hated it. Back in East Boston, he could go to his clubs and play cards several times during the week. He could also head to Central Square where he could buy the Italian newspapers he read along with the Di Nobili cigars he smoked daily. Belmont Centre, which was a close distance from us, offered nothing Italian back then and Babbononno, as I said, hated it.

Finally, the decision was made after long conversations with my uncles; Babbononno was to head back to East Boston. An apartment was found near Maverick Square and we moved him there. My mother was off the wall one day when I returned home from work. When I asked her what was wrong, she said, "I called your grandfather a while ago and a woman answered with a thick Irish brogue. It turned out to be a neighbor near his age and seeing he was in his mid-90s and she was pushing 90, I told my mother that the most erotic thing that could happen would be them holding hands. Mom had to accept the relationship ... When the woman passed away, Babbononno needed 24/7 assistance, and the family moved him to a nursing home on Saratoga Street. He received the attention he needed and made it to age 99. I hope I've inherited Babbononno's longevity ... who knows?

In Italy, *Torta dei Sette Vasetti* (Cake of the Seven Jars) is a well-known *ciambella* both for its soft, light and delicious taste, as well as its utter simplicity to prepare. This yogurt-based cake uses 125 mg of yogurt in the recipe, and the yogurt container becomes the "jar" in which you measure the remaining ingredients. Flour, starch, eggs, citrus zest and a sachet of yeast are all that are additionally needed to prepare this *torta* (cake). Made without butter, it is perfect for a traditional Italian breakfast, quick midday snack, or even as a dessert. While the origin of the recipe remains unknown, most Italian families have their own version of this delightful *torta* that can be completely made in less than an hour!

I cannot begin to tell you how many times my Nonna Mary made this cake. It was definitely one you would often find tucked away in her wine cellar just waiting for company to appear! When Nonna initially made this *torta*, she followed the traditional method and used yogurt. However, she eventually replaced the jar of yogurt with an equal amount of ricotta and found this gave the cake a lighter texture and amazing flavor. Nonna sometimes even added chocolate chips, replaced the icing sugar with a glaze, or even stuffed it with fresh whipped cream and strawberries. The possibilities are endless, and you will definitely be grateful to her for this fast, fabulous, and foolproof recipe. The soft light texture and pleasing taste, will make it believable to many that the *Torta Sette Vasetti con Ricotta* came straight from a *pasticceria* in Italy!

SEVEN JARS CAKE WITH RICOTTA Torta Sette Vasetti con Ricotta



1 container yogurt (125 to 141 ml size) ONLY the container will be used, NOT the yogurt 3 eggs, room temperature 2 jars granulated sugar zest of 1 organic lemon 1 jar of whole milk ricotta 2 jars '00 or all-purpose flour 1 jar potato starch

- 1 jar sunflower seed or vegetable oil
- 1 16-gram sachet Italian baking powder with vanilla flavoring (may substitute 2 ½ teaspoons baking powder and 1 teaspoon vanilla)
- ¹/₄ to ¹/₂ cup confectioners' sugar

Preheat oven to 350°. Take a 22 cm baking pan (I use a *ciambell* pan), grease and flour, set aside. Empty yogurt and wash and dry the container as this will now become your measuring jar (vasetti). Place eggs and 2 jars granulated sugar in medium bowl, beat fluffy and pale yellow. Add lemon zest and 1 jar of ricotta, whisk together. While whisking, slowly add 1 jar of oil. To this mixture, gradually add the 2 jars flour, 1 jar potato starch and mix together well. Finally, add the sachet of baking powder and continue mixing until everything is thoroughly mixed together. Place batter in prepared pan, and even with spatula. Bake for 35-45 minutes or until golden brown and a toothpick inserted comes out clean. Cool and remove from pan. Sprinkle with confectioners' sugar, slice and serve.

Gile was a catcher mostly, but came up in 1959 on a team loaded with backstops (Russ Nixon, Jim "Pag" Pagliaroni, and Bob Tillman). He was born on March 5, 1921, and arrived at Fenway when he was already 38 years old. He stayed with the Sox for one full season and parts of three others between 1959 and 1962. He was used as a catcher from time-to-time, but mostly saw action as a utility

By the way, I was actually sitting over in the right field grandstands with my younger brother during that game.

Gile left the game at 41 years old and I haven't forgotten him, not because he was so bad, but for a short time he wore the uniform of a major league baseball player and he never gave up, right up to his last atbat when he hit his third home run of his short career. He survived a rough career but never really gave up. In that sense, he was a real baseball player.

And now with that last at-bat of his, his career will forever be tied to that of Ted Williams. One guy batted .406 and the other .049. I don't know which of the two is more challenging, do you?



Rest in Peace GASPAR ORTEGA

Great Welterweight

From the Golden Age of TV Boxing Answers His Final Bell at the Age of 86



The Contender

Gaspar "Indio" Ortega became known as the Friday Night Fighter because of his many appearances on the *Friday Night Fights* during the 1950s and early 1960s. It was a time when many fighters, not just champions, were known by the general public. They were as much celebrities as the Hollywood stars who appeared in the television shows of the time.

Names such as Holly Mims, Henry Hank, George Benton, Gomeo Brennan, and many others made frequent appearances on the weekly boxing programs broadcast across the country. Gaspar was one of the most popular and most often seen. His boxer/puncher style and his talent for slipping punches made him a joy to watch in action. I'm not sure, but Gaspar may have held the record for most Friday Night Fight appearances. If not, he was certainly a contender in that category. He was also a solid contender in the welterweight ranks at a time when being a contender truly meant something.

Gaspar Ortega passed away on December 13, 2021 in Naples, Florida. He was 86 years old.

Originally, Ortega had set out to become a bullfighter in his native Mexico. He later turned to boxing where he made his mark turning pro in 1953. His first year in the ring was spent fighting in Mexico, but by 1954, he was traveling up to Madison Square Garden to fight in the preliminary bout before the main events. He moved from four rounders to six rounders and then had his first big test in 1956 going ten rounds against the very capable and experienced Isaac Logart. Gaspar lost the decision but would come back later that same year and win a rematch by decision.

He would go on to defeat Tony DeMarco in two out of three bouts and also win against the reigning Welterweight Champion Benny Kid Paret in a non-title match. In 1960, Gaspar lost a split decision to an up and coming prospect by the name of Emile Griffith. Griffith would go on to win the title the following year.

By virtue of his split decision loss to Emile and a second win over Paret, Gaspar was given a shot at the champion. The fight was held in Los Angeles where a huge throng of Mexican fans showed up to cheer their hero Indio on. Unfortunately for the challenger, Griffith was a vastly improved fighter and Ortega

was stopped in the 12th round. It would be his only title shot. It was only one of two stoppage losses over a long career.

Gaspar fought often. In 1963, he stepped into the ring twenty-two times. In 1964, he climbed through the ropes an astounding twenty-nine times. He finally retired in 1965 with a record of 176 total fights including 131 wins with 69 knockouts, 39 losses, and 6 draws. In addition to Demarco, Griffith, Paret, and Logart, he also faced Carmen Basilio, Ted Whitfield, Stan Harrington, Nino Benvenuti, Florintino Fernadez, Ralph Dupas, Don Jordan, Kid Gavilan, and Denny Moyer.


In retirement he worked with troubled youths in New Haven, Connecticut where he had settled. His son Mike is a well known and very competent boxing referee. Gaspar was one of the last from a great age of boxing. A time when boxing was

HOOPS and HOCKEY in the HUB

When certain circumstances arise, they open up opportunities.

That's one way to frame the recent withdrawal of the National Hockey League from its participation in the 2022 Olympics. Now that approximately 150 NHL players and a number of the league's coaches won't be going to China, others will take their places, giving them a chance of a lifetime at an Olympic medal.

Expect both Team USA and Team Canada to have the most extensive revisions since they had been expected to feature squads made up exclusively of NHL players.

Now, Americans playing on European-based pro teams and in the AHL, plus a few college hockey stars (and perhaps a recently retired NHL player or two) will get their opportunity to compete in the Five-Ring Festival.

The first moves, however, involved coaching, with the changes having a number of Boston-themed angles.

Former Boston University mentor David Quinn, who most recently coached the New York Rangers for three seasons before being let go back in May, was named the head coach of Team USA. Quinn had been slated to be an assistant on former Bruins coach Mike Sullivan's Olympic staff. He was elevated to the head job after the NHL withdrawal.

Sullivan, who went on to win two Stanley Cups with Pittsburgh after leaving the B's, will now continue to coach Pittsburgh since the so-called Olympic Break will now become a makeup period for games postponed by COVID-19 protocols.

Quinn, who has previously coached at the international level, said he realized that his taking over came at "a bittersweet moment," since numerous players were looking forward to competing in the Olympics. But he also said he considered it "an incredible honor" to be named the head coach and pledged to do all in his power to put together a quality team.

The NHL's decision not to participate also means that former Bruins player and current Minnesota general manager Bill Guerin, who had been named Team USA GM, also won't be going to China.

Before he took over the Rangers in 2018, Quinn was the head coach at Boston University for five seasons (2013-2018). Following in the footsteps of legendary coach Jack Parker, all Quinn did was lead the Terriers to four NCAA tournament appearances, including a berth in the 2015 Frozen Four championship game.

Providence College won that game at the TD Garden, two days after Quinn's best remembered victory. It came in the semifinals when the Terriers took down national powerhouse North Dakota, a team that featured 14 NHL draft picks on its roster.

The NHL's decision also had impacts north of the border as Team Canada also is undergoing significant changes. Much like Team USA, an entire new roster featuring non-NHL players must be put together.

In addition, there are coaching changes that have meaning for Boston fans.

The most important one is that Bruins head coach Bruce Cassidy, who had been slated to be an assistant coach with Team Canada, will now lead the Bruins through a number of postponed games that need to be made up. Now in his sixth season as the head coach on Causeway Street, he has accumulated more than 200 victories (and counting).

He has guided the B's to berths in the Stanley Cup Playoffs in each of his five full seasons behind the bench, including the Stanley Cup Final in 2019. In 2020, the Black and Gold won the Presidents' Trophy (most points accumulated during the regular season on the strength of a 44-14-12 record. That year Cassidy was also named the winner of the Jack Adams Award (NHL Coach of the Year) as the B's led the league in points (100), wins (44) and goals against average (2.39).

But while Cassidy won't be going, one of the most familiar coaches in recent Boston Bruins history will. Claude Julien, who was the bench boss on Causeway Street for over nine seasons, will direct Team Canada's fortunes.

A native of Blind River, Ontario, Julien did not have an extensive NHL playing career. It lasted all of 14 games over the course of two seasons with the Quebec Nordiques during the middle of the 1980s.

But the duration of his coaching career has more than made up for the brevity of his time on the ice. Some people (in all sports) are meant to be players. Some are meant to coach. Claude was meant to coach.

He came to a franchise in 2007 that had not captured a Stanley Cup since 1972. He turned the Bruins into champions again, winning the Cup in 2011 by beating Vancouver and coming close against Chicago in the 2013 Stanley Cup Final.

Even though he was dismissed in February 2017, Julien's legacy lives on since Cassidy was on his staff during the 2016-2017 season and had previously coached many of the Bruins for several years as the head mentor in Providence.

Team USA will play China and Team Canada will face Germany in their respective opening games. The Gold Medal Game is scheduled to start at 11:10 p.m. on February 19th.
