

# State House Celebration Commemorates 20th Anniversary of Italian Heritage Month Committee

October 1st marked the start of Italian-American Heritage Month, coinciding with the 20th Anniversary of the Italian Heritage Month Committee.

Last week a festive program was held in the House Chamber of the State House, followed by a reception in Memorial Hall. Coro Dante, New England's all-Italian repertoire chorus of the Dante Alighieri Society which was celebrating its own twelfth anniversary, performed the U.S. and Italian national anthems.

Following opening remarks from House Speaker Robert DeLeo, the President of the Italian-American Heritage Month Committee Richard Vita read the proclamation issued by Governor Baker. The proclamation honored the legacy of Christopher Columbus, actress Anna Magnani, inventor Antonio Meucci, Leo Liotta and Yolanda Cellucci. Liotta, better known as boxer Tony DeMarco, received a standing ovation, along with Cellucci who became a trailblazer in the world of fashion with her Waltham-based bridal shop opening in 1967.

Federica Serini, Consul General of Italy, reflected on the value gained from engaging with the Italian-American community. Identifying common traits such as warmth, resilience and industriousness, she observed how important family factors into the cultural identity and experience of Italian-Americans. Sereni concluded by sharing excerpts from President John F Kennedy's 1961 speech celebrating the centennial of Italian reunification.

Massachusetts OSIA State Vice President Denise Furnari spoke about the role of the Order of the Sons and Daughters of Italy in promoting, protecting and preserving Italian heritage. Describing the founding vision of Vincenzo Sellaro, Furnari also mentioned Lodge #2996, based in the North End, which celebrated its founding last October. President of the Italian American Alliance James DiStefano reported an increase in membership from 400 in 2018 to over 1,100 as of this year, with an additional 22,000 members in affiliated associations.

Scholarships were given to five students from throughout the Commonwealth: Daniel

Di Chiara from Revere High School, Zachary Dieciudue from Everett High School, Alec Ross from Wakefield High School, Benjamin Lee from Boston Latin, and Ana Faiole. Scholarships were supported by the Italian Consulate, East Boston Savings Bank, Club Italia, CASIT, and Donne 2000.

Awards were presented to Italian-American Heritage Month Committee Co-Founders Judge Joseph V. Ferrino Sr. (Retired), Judge Peter W. Agnes Jr., and Comm. Lino Rullo for their role in forming the Committee and collective body of work. Massachusetts State Senator Sal DiDomenico received a Distinguished Public Service Award.



# Stirpe Nostra

### PLINY THE ELDER

Gaius Pinius, called Pliny the Elder, was born at Novum Comum (now called Como), in northern Italy, and moved to Rome at an early age. When he was twenty-three years of age he entered the military forces and served as a cavalry commander under Emperor Claudius, then as a Provincial Governor under Vespasian, and lastly as Fleet Commander under Titus. His fleet was stationed at Misenum (near Naples) in 79 A.D. when Mt. Vesuvius erupted. His deep interest in such scientific phenomenon caused him to sail across the bay to the doomed city of Stabiae for a closer inspection of the volcano. He evidently had gotten too close and died by suffocation from the strong volcanic fumes.

During most of his life, Pliny was occupied in his military or civic duties; however, he was able to carry an extensive scientific study which occupied all of his leisure time. He wrote many books on military, grammatical, rhetorical, and biographic subjects. About two hundred manuscripts of this work are still in existence. He also composed two great historical works. The first of these was a history of

the Germanic Wars in twenty books. The second history is his masterpiece, and this is the "Historica Naturalis" (Natural History) in thirty-seven books.

The last history was originally dedicated to Titus and published in 77 A.D. but he continually worked to improve it right up to the time of his death.

We are told that he prepared

his encyclopedia of natural history from approximately twenty thousand notices or facts, and these were taken from about two thousand published works or writings by more than four hundred authors. His work ran the full gamut of subjects which included astronomy, physics, geography, ethnography, anthropology, zoology, pharmacology of vegetables and animals, mineralogy, and commentaries on the history of art.

Some minor defects in his work are excused or quickly dismissed due to the enormity of his accomplishments and the short amount of time he required to finish it. The facts and information contained in his work are a gold mine and storehouse of inestimable value, and a monument to the industry of this great scholar.

Pliny the Elder was a good soldier, statesman, and outstanding author. He has often been referred to as the Roman representative of encyclopedic learning, and the most knowledgeable man in the Silver Age of Roman literati.

### L'Anno Bello: A Year in Italian Folklore

The Spinetingling Side of Italy

Halloween season is officially upon us! An old-fashioned holiday wreath hangs upon my door, boasting Victorian images of smiling pumpkins, girls sporting pointy witch hats, and bats in mid-flight. Jack-o-lanterns and arched black cats grin mischievously from store shelves, with thin lights flickering inside them like little captured sunbeams. The cornstalks and scarecrows

that adorn my neighbors' front steps speak of the concluding harvest season, while the colorful leaves that flutter to the ground against the backdrop of a slate-gray sky remind us that the year itself now winds down to its close. Halloween is the time to revel in all these examples of a world turned upside-down, of the pleasure of the unknown and the thrill of everything that is mysteri-

ous and spine-tingling. Though modern Halloween celebrations are largely an American phenomenon, the United States does not have a monopoly on spooky imagery or mythical creatures. Across the ocean in Italy, people also ready themselves for Halloween, and may draw upon their own unique mythology and folklore. So in the spirit of Halloween, let's dive into the eerier side of Italy, the side that you may not find in tour books but certainly plays an important part in the Italian character!

Italy has long had a fascination with the occult, stretching back to the days of Ancient Rome. The modern Italian prejudice against the number seventeen, similar to the American superstition of unlucky thirteen, stems from the burial customs of the Romans. The Roman numeral for seventeen is VIXI, the same as the Latin word meaning "he lived"a phrase frequently carved into ancient tombstones, and therefore linking the number with death. Ancient Rome's penchant for the macabre did not end with numbers, however. Romans shivered with fear over the *lemures*, or terrifying ghosts. These ethereal beings haunted certain houses or roads because, as many ghost stories stated, they could find no rest due to an improper burial or some sort of injustice committed against them during their lifetime. The Romans even devoted the month of May to a holiday called Lemuria which sought to appease these spirits, and this creepy feast may form the origin of an olden superstition that advised against marrying in May. Ancient Romans also resorted to supernatural omens in order to predict the future. Priests known as augurs





### Saint John Stone

Little is known of Stone's early life and education. It is believed that he joined the Augustinians at Canterbury, England, where the Order was founded. The place where the Augustinian friary once stood on St. George's Street is still called Whitefriars. Stone was a native of Canterbury. After his ordination, he was sent to Droitwich, where he filled the office of professor and Prior for some time before returning to Canterbury. Stone was a doctor of theology.

In December 1538, a former Dominican, Richard Ingsworth, one of Cromwell's men, appeared in Canterbury. He closed both the Franciscan and Dominican houses on December 13th, and the following day appeared at Austin Friars. Each friar had to sign an explicit acknowledgement of Henry VIII as head of the English Church. When Henry VIII finally decided to take matters into his own hands to solve his marital problems, he had himself declared the Supreme Head and Governor of the Church in England in 1534. (The Act of Supremacy).

Stone refused to sign the document and made a lengthy attack on Henry's usurpation of the Church's rights. He was taken prisoner, brought to London to Cromwell, but refused to recant. After a year's detainment, on October 27, 1539, he was sent to be tried and executed at Canterbury. Stone was brought to a hill outside the city walls. From his place of execution, Stone declared to the spectators "Behold I close my apostolate in my blood, in my death I shall find life, for I die for a holy cause, the defense of the Church of God, infallible and immaculate."

He was not only hanged there but also drawn and quartered. His head and body were exhibited at the entrance to the city for everyone observing as a warning to other rebels.

Stone was Canonized on October 25, 1970, by Pope Paul VI. The Feast Day of Saint John Stone is December 23rd.



In the next few weeks this column will feature excerpts from this book.

Grandpa Bernardo was known in the neighborhood as a "Dapper Dan." Tall and good looking, he dressed like a banker in hand-made suits. He spent his early years in America carrying hinds of meat on his shoulders through the streets of the North End, which he sold to the local restaurants. When Grandpa finally made enough money, he bought a pony and wagon, which served both the business as a delivery wagon and the family on buggy rides through the streets of the neighborhood. The family lived modestly, and Grandpa worked hard. At the age of forty-five, he was able to put together enough money to open

a little butcher shop. Grandpa only worked in the morning, leaving the shop midday in the hands of Grandma and his children, while he served as ambassador to the coffee shops of Hanover Street, earning in his mind, the right to semi-retirement. There was a little theatre named the Casino, located in Scollay Square, which often showcased traveling Italian plays and musicals. Grandpa loved these little reviews, and on the first day of their arrival, he would perform a certain ritual. At about 12:00 in the afternoon, he would walk to Garden Court Street, stand in the middle of the street and whistle, a whistle immediately recognized by Grandma. She would come to the window of their fourth-floor flat and signal to him, she'd be down in a minute. Whatever their situation, happy or sad, they would stroll together, her arm entwined in his, in a manner typically Italian. They made their way from Garden Court Street over to Hanover, up to the Casino, growing increasingly happy as they approached the theater. Two immigrants, if only for an hour or two would come close to their homeland. When the Neapolitan Sciantosa (Diva), Gilda Mignonette, headlined the show, no power on earth could keep them from attending. Emotions, which for Italians are



always near the surface, would flow from the audience the moment Gilda sang out, as she turned to a scene of the Bay of Naples, just behind her, "Napoli, io vengo a te." (Naples, I'm coming back to you). The all-Italian audience would cheer, applaud, and toss flowers at the Diva, Grandpa enthusiastically shouting from the balcony, much to Grandma's embarrassment: "Bravo Gilda! Bravo Gilda!"

Italy's most beloved dumplings are called "Gnocchi" and while this name is truly of an unknown origin, it's speculated to have come from the Italian word nocca, meaning knuckle. These delicious little lumps of dough reportedly originated in the Northern part of Italy and several regions feature their own specialties. To name a few, Rome is known for it's baked semolina gnocchi, Gnocchi alla Romana and the capital city is also home for the traditional celebration Gnocchi Giovedi, or Gnocchi Thursday, where many of the trattorias make an abundance of homemade potato gnocchi and serve them throughout the day. Tuscany's delicacy is a "naked ravioli" ricotta gnocchi, Gnocchi Gnudi and Florence's specialty is the acclaimed Strozzapreti (priest-stranglers), a spinach and ricotta gnocchi said to be so delicious that famished priests have been known to choke from eating them too fast!

As a very young girl, Gnocchi is one of the first things I remember my Nonna teaching me to make. We would gather the ingredients on a floured wooden board and using our hands, mix the dough until it was just the right consistency (soft but not sticky), roll it into ropes, cut the ropes into small pieces and then roll these pieces along the tines of a fork. While the most common way to prepare gnocchi is typically with potatoes, my Nonna always preferred to make them with ricotta. She claimed they were "much lighter and airy" and I must say, I completely agree! These delicious little pillows of dough can be served with a variety of sauces, anything from butter and grated cheese or a creamy gorgonzola to your favorite marinara or a hearty meat sauce ... the possibilities are simply endless!

### RICOTTA GNOCCHI Gnocchi di Ricotta


1 pound ricotta(I use Polly-O or Impastata)1 1/2 cups flour (00 works best, All Purpose can also be used)

1/3 cup Parmigiano Reggiano, Parmesan or Romano grated cheese 1 large egg

Proprietor

Mix ricotta, grated cheese and beaten egg together, add flour and turn onto a floured board. Mix until you have a smooth, elastic dough that is soft but not too sticky. If you find the dough sticky, you can add flour in small increments at a time. Roll the dough into ropes about 1-inch wide. Using a knife or a pastry cutter, cut the ropes into ½-inch pieces. Use a gnocchi board or roll on the tines of a fork to make the gnocchi indentations/shape. Place onto a parchment lined floured cookie sheet. Repeat with the remaining pieces of dough. The gnocchi can now either be cooked or frozen. If you are freezing them, freeze on the cookie sheet and later transfer to a zip lock freezer bag. If cooking, bring a large pot of salted water to a boil and add about 1/3 of the gnocchi to the boiling water, making sure you don't add too many at a time. As soon as they float to the top, they are done. Remove with a slotted appear drain and together the gnocchi into your foverite square.

### The Assasination of President McKinley

Our nation was shocked by four presidential assassinations. Two of the unfortunates have since become pillars of American history, but both James A. Garfield and William McKinley have faded significantly in the pantheon of America's presidents. McKinley was in a way overshadowed by his successor, Theodore Roosevelt, but his presidential track record was rather impressive up to his assassination on September 6, 1901 while visiting the Pan-American Exposition in Buffalo.

The Spanish-American war that closed the 19th century had been a success and his second term looked promising. McKinley was very enthused and confident about delivery a speech in front of a crowd of 116,000 spectators. His personal secretary, however, George Cortelyou, was not as confident and feared the possibility of an assassination, particularly at McKinley's last stop at the World's Fair, the Temple of Music theater. McKinley, however, persisted and refused to cancel the appearance.

By 4:00 in the afternoon, the crowd was making its way toward the Democrat to shake his hand. Blended into that crowd was a 28-year-old Michigander by the name of Leon Czolgosz who, since losing his job at a steel factory after the crash of 1893, had become very active in anarchist causes and organizations. Outside of politics, Czolgosz was a very shy and taciturn young man who seldom ventured outside of his family home. But the writings of Emma Goldman and the assassination of Italy's King Umberto I on July of 1900 by anarchist Gaetano Bresci, radicalized him and on August 31, 1901, he travelled to Buffalo with a .32 caliber Iver Johnson revolver with President McKinley as his target. On September 6, Czolgosz waited patiently in line to shake hands with the president.

When his turn came and McKinley extended his hand, Czolgosz fired two shots point bank. For a while the crowd froze, perhaps confused about what had happened, until

James "Big Jim" Parker, a tall black man in the crowd, dealt the gunman a blow, knocking him down before he could fire a third shot. In an instant the soldiers and police also pounced on Czolgosz and would likely have pounded him had the stunned McKinley, with blood gushing from his abdomen call out, "Go easy on him, boys." The president then turned to Cortelyou and said, "My wife. Be careful how you tell her. Oh, be careful."

Immediately after, McKinley was rushed to the Pan-American Exposition's hospital and into emergency care. One of the bullets had caused only minor damage, ricocheting off of his suit button. The second had passed through his stomach and the doctor was unable to locate it.

Nonetheless, things were looking well for McKinley through the next few days. By all accounts he seemed strong, was talking lively, and reading newspaper coverage of the shooting. Vice President Theodore Roosevelt was optimistic, telling reporters at the Adirondacks, "You may say that I am absolutely sure the president will recover."

However, on September 13<sup>th</sup>, tragedy came in. The bullet brought on a case of gangrene and, ultimately, blood poisoning. On the morning of the 14<sup>th</sup>, President William McKinley died with his wife Ida by his side.

All Leon Czolgosz had to say about his act while in prison was, "I don't believe in the Republican form of government, and I don't believe we should have any rulers. It is right to kill them. I killed President McKinley because I done my duty."

His trail began on the 23<sup>rd</sup> of September and he was found guilty on the 26<sup>th</sup>. On October 29<sup>th</sup>, he was executed in the electric chair at New York's Auburn Prison.

"I killed the president for the good of the laboring people, the good people. I am not sorry for my crime."

In 1907, McKinley's remains were moved to a mausoleum in Canton, Ohio, now known as the McKinley National Memorial, which holds a bronze statue of the President's final speech at the Pan-American Exposition.

A Nostalgic Remembrance



The date attached to this column brings back both fond and sad memories. I have mentioned in the past that I grew up with the Manfredonia family. Their oldest son, John, who was my contemporary, was born on October 14th, and I on the 21st. Both his parents, Grace and Ralph, and my folks knew each other from the time they were kids and remained life-long friends. When I was four, Babbononno sold the big house at 70 Eutaw Street and he and Nanna moved into an apartment on Princeton Street. We moved two doors away to 74 Eutaw, then owned by Grace's father, Angelo Barranco. When he passed away, Grace's husband, Ralph Manfredonia, became our landlord and the first three of the four Manfredonia children, John, Fred and Adelaide and I became inseparable. Josephine, the fourth would be born many years later. Beginning when we were four years old, Mom and Grace started holding joint birthday parties for John and me, a tradition that remained in place until we started high school.

The neighborhood was filled with people the families became friendly with, most with kids at or near our ages. As a result, especially at birthday parties and at holiday time, it seemed like an extended family rather than a bunch of close neighbors. As pre teens, every Saturday was special. Grace would give each of her three children a quarter and I would receive the same from Mom. At a designated time, we would walk to Bennington Street and head for the Central Theater. On Saturday afternoons, the Central would have a kid's matinee, usually a Tarzan feature and ten cartoons. If the main feature wasn't Tarzan, it might be a John Wayne western ... just as good as far as I was concerned. At times, people ask me what I watch on TV. I usually tell them I like the old films I remember from when I was a kid. One comment that accompanies this is, "I saw an old John Wayne film that was so old, he wasn't shaving yet and Gabby Hayes got the girl; now that's old, especially if you remember who Gabby Hayes was."

We kids would get in line to get in to the Central, John or I usually leading the way. After we paid our admission fee of 12 cents, we were each given a free comic book. They were all out of date and the top of each would be cut off so there might be no indication as to what month or even year the book was published, but they were free and they were handed out by a man named Harry Ashton, who was mean looking and no kid ever questioned him. He would be dressed in a theater uniform with a captain's hat on. The one thing I couldn't understand was why he had a piece of clear plastic around his shirt collar with part of it tucked inside. I guess it was to keep the collar of his white dress shirt clean, but as I said, he was mean looking and no kid ever questioned him.

Once inside the theater, we would line up in front of the candy counter. When it was our turn, we would buy either a box of popcorn for ten cents or two candy bars for five cents each. Let's see twelve cents to get in and ten cents for popcorn or candy ... that meant we had three cents left over that would be spent after we left the theater two and a half to three hours later. During the warm months, there was a slush stand right across from the Central. It was actually set up in a doorway and run by the Bellavia family. The price of the one flavor they made, lemon, was ten cents for a large, five cents for a medium and three cents for a funny shaped envelope that they would fill for the remaining three cents. They would close up during

the winter months, but on the way home, there was a penny candy store, and we could spend our three cents each on the many selections the store had. I don't remember the name of the store, but it was on the corner of Bennington and Marion Streets. We bought things like root beer barrels, sheets of narrow paper with dots on them-half spheres of colored sugar, Boston baked beans — oval shaped brown colored candy, little wax bottles filled with colored sugar water, chocolate babies-brown colored child shaped candies, or other forms of candy not as upscale as these offerings. These other forms might be two or three for a cent, and if we bought these, the man behind the counter might just add a few more to our bags just to get rid of them. We didn't care, as long as we got three cents worth, and then

Back inside the Central, it would be pandemonium. Kids coming out of the woodwork, yelling, screaming, running around, that is, until the lights started to dim. The feature was usually the first film to be shown and we would scramble to our seats and quiet down. As the feature would approach a climax, most of us would be finished with our popcorn which came in boxes. We would fold the boxes flat and scale them at the bad guys on the screen. The flattened boxes would sail beautifully and hit our targets on the screen. At times, if the trajectory was just right, the box would actually stick in the screen and we would all applaud when we saw this happen.

Following the feature, they would put on the trailers, previews of coming attractions and a group of ads from local businesses in the neighborhood. We would look at the coming attractions and boo the people in the ads, or they would become the targets for the rest of sailing popcorn boxes or uneaten candy. In retrospect, I pitied the person who had to clean up the stage between the afternoon matinee and the evening show.

The one thing we had to be careful of was the kids who would walk around stealing comic books from other kids who were smaller than they were. Often, kids would sneak back in the line of children being handed the free comics. As a result, if you were careful and worked the system just right, you might wind up with several free books. When John Manfredonia and I would try the line for the second time, we would swap coats and hats to try to fool the man handing out the comics. If there were other kids we knew and they were willing to swap clothing, we might wind up with a half dozen or more give aways.

Come October, Grace Manfredonia and Mom would begin to plan the one big birthday party for both her John and me. It was often held in the basement of their Monmouth Street house, which had a partially finished basement. Relatives and friends would bring us gifts and there was always enough food to feed and army. At a given time, two birthday cakes with lit candles would be placed on an antique kitchen table and everyone would sing happy birthday to both of us. After the cakes were cut up, the kids would devour them like piranha on a food craze. Several bottles of Saraford tonic were available to wash down the cake and we kids were then ready to resume whatever game we were playing, only now with the addition of new toys we had received as birthday gifts. How about those memories???

Before I close, my Aunt Ninna sent me this for my readers to try. She claims this phenomenon happens once every thousand years: Add your age to your **year** of **birth** and they will add up to 2019. Try it, it worked for me: 81+1938=2019.

### A Big Name is not the Secret Ingredient

A talented horror story writer can masterfully turn a happy occasion into a bone chilling tale of terror. When you start a dream job, mismanaging your existing 401k can be the opening paragraph of another unnerving story.

Let's consider a short story penned by Boston native Edgar Allan Poe, The Cask of Amontillado. Taking place in an unnamed Italian city during the festive Carnival celebration, this is a tale of fatal revenge. The narrator and murderer, Montresor, felt insulted by his "friend" Fortunado and lures him into the catacombs for a private wine tasting. The already inebriated Fortunado was so excited to sample the fine Amontilldo sherry he could not resist the invitation - but Montresor quickly chained him to the wall, and built another wall enclosing Fortunado in the space, effectively burying him alive.

Similar scary stuff can happen to your legacy 401k if you are not careful. Maybe you're imagining I will recite this gory tale: You travel down a corridor to the Haunted Human Resources Department. While the ground fog and eerie organ music alerts your survival instincts you are unable to speak. A ghoulish, Lily Munster looking benefit manager hands you some parchment document written in terminated employees' blood and demands you sign it. Once you have passed the point of no return you fall through a trap door while

A talented horror story writer an masterfully turn a happy ccasion into a bone chilling witch's laugh. (That's the VP cackling!)

It does not happen this way. Usually the start of a new job is a time of great optimism. You got a raise and you're looking forward to new challenges. The company is happy to have you and they want to keep you happy. The human resources manager is not a financial planner but it is their job to be the cheerleader for the company's 401k plan. With good intentions, they may offer to roll your old 401k into the new company plan to reduce paperwork and make your life easier. After all you're at a good company with a great benefits package; you simply assume the firm has a great 401k. So you fall into the "convenience trap" and move your existing retirement fund

Most likely this is a big mistake and years later it will sully this happy occasion. When you leave a job you have the opportunity to move your 401k fund to an IRA account without tax consequences. You have the choice of almost anything from the universe of mutual funds. The new company's plan is limited to a much smaller amount of choices. It will be tough, if not impossible; to build a portfolio that takes advantage of low investment costs, a broad range of asset classes, and global diversification. Proven factors like these provide optimal returns over the long run. If you simply fall

into the "convenience trap" and roll it into the new company's s plan you have somewhat buried this money alive. It will be stuck in that plan until you leave the company. The opportunity costs could be huge. For example, \$100,000 with an annualized return of 6% totals \$320,714 after 20 years. Getting an extra 2% annual return is possible, and if this calculated risk pays off, you could accumulate \$466,096. The difference is about \$145,000, nothing to

Boo! at.

Avoid the convenience trap; invest some time into researching the best options and maybe you'll be giggling through an earlier retirement picnic on the lush lawns of Castle Island. I'd be careful though, Poe was stationed at Fort Independence and he based "Cask" on a legend taken place within those gloomy walls

Mark Lane plays the giant Toro Moreno, a South American heavyweight who is brought to the States and built up through a series of fixed fights. In the end, he is sent home broke both financially and emotionally.

It is interesting to note that Max Baer plays a part based on himself, and he takes on Moreno, who is very similar to Carnera, to whom he gives a vicious beating. What is most curious about Baer's character, Buddy Brannen, and something I find very disturbing about the movie, is the comparison with the real life incident when Earnie Schaaf died after a fight with Primo Carnera.

It is believed Schaaf really died from injuries he received in an earlier bout with Max Baer, and that he was already in bad shape when he went into the fight with Carnera. In the 2005 Ron Howard movie Cinderella Man, Baer is portrayed as a ruthless man who was proud of what he had done to Schaaf and wanted the credit for the tragedy. There was an outcry about that portrayal from the public and from Baer's family. Most believed Max to be a kind man in a brutal sport who was deeply hurt by what happened.

In The Harder They Fall, Max's character Steve Brannen is much more like the Baer of Cinderella Man, which is interesting since Max is playing him. Why would Baer, who

supposedly felt terrible about what happened to Schaaf, as well as Frankie Campbell whom he killed in an earlier fight, play a character that was based on himself in such a ruthless way? I do know Budd Schulberg was very distressed by this. If he truly felt terrible about what happened to Schaaf and Campbell, how could he act this way?

The movie had two different endings written for it. One where Willis writes that boxing should be investigated, and a second where he calls for the abolition of boxing. The version shown on television usually goes with the first version while the DVD release has the second and stronger one.

My final two choices are the film noir classic The Set Up, starring Robert Ryan, and Fat City with Stacy Keach and Jeff Bridges. Again, two movies which show the darker and more common side of boxing. Both are well done and avoid the old formula of fighter makes good, fighter wins girl, fighter gets corrupted, fighter loses girl, fighter finds redemption and wins back girl. That theme makes for a nice story, but to get a real taste of what boxing is all about watch Requiem for a Heavyweight, The Harder They Fall, The Set Up, and Fat City. Gentleman Jim is the feel good movie on the list. All are must see boxing movies.



interpreted the flight of birds to divine looming events and outcomes. Haruspices had to report the future with a much yuckier method: they scoured the entrails of sacrificed animals for omens! While modern Italians are certainly less superstitious than their ancient counterparts, many remnants of Rome's mysterious folklore persist to this day, such as the ubiquitous charms against the evil eye and the popular red horn-shaped amulets said to bring good luck.

Though Ancient Rome's love for the mysterious is wellstudied, contemporary Italy nevertheless brims with a plethora of scary monsters and eerie folktales. Werewolf stories abound in Italy, where the hairy shape-shifting beast bears the name licantropo. The fear of the *licantropo* hearkens back to the time when the wolf stood as the most dreaded predator in the forests of Europe, especially during the nights of the full moon, when certain men could morph into this formidable animal. My father frequently spoke of hearing the plaintive howls of wolves in his secluded Italian village, and such a chilling memory is a testament to the strength of the werewolf myth. Similarly, the witch, or strega, constitutes a complex symbol in Italian society, sometimes functioning as an example of evil and other times signifying benign and astute female power. The gift-bringer of the Italian Christmas season, La Befana, is even depicted as a kindly fairy-witch figure. Unique mythological creatures also roam localized areas of Italy. The Badalisc is a large, hairy beast that inhabits the Alpine woods of Lombardy in northern Italy. It can only be captured on the Epiphany, and this event forms a part of the region's folksy holiday celebrations to this day. Visitors to Naples may

Jarvis was in the news this past week because Florida Panthers defenseman Keith Yandle played in his 800th consecutive game during the NHL's opening week. He is the only active player with a chance of surpassing Jarvis. He would need to play in every single game both this year and next season to have a shot at it. He is 33, in and of itself, should not be a factor.

Jarvis, by the way, scored 139 goals and added 264 assists for a total of 403 points during his career. He was a member of five Stanley Cup winning teams as a player. As a member of the Bruins coaching staff, he was a fixture in one of the booths on the ninth floor of the TD Garden, communicating via a head set with then Head Coach Claude Julien who was stationed behind the bench. And yes, he was in Vancouver (as an assistant with the B's) back in 2011, when the Bruins defeated the Canucks to win the Stanley Cup.

Ward Bond and Errol Flynn


With the days getting shorter as winter approaches it is a good time to plan on some solid home entertainment. With the easy availability of just about any movie ever made, I thought I would recommend some must see boxing movies. You may have viewed many of these before, but great movies are always worth another look. If you haven't seen movies on this list, you have missed out and should definitely take them in. Either way, I am confident you will enjoy each one of them.

This is a short selection and I could certainly suggest many more. What I have done here is to pick out the best of the best.

For pure entertainment the 1942 film Gentleman Jim is a sure winner. Starring Errol Flynn, Alexis Smith, and Ward Bond, this highly fictionalize story of the life of Heavyweight Champion James J. Corbett is a pleasure to watch.

Directed by Raoul Walsh, with a supporting cast that includes Alan Hale, Jack Carson, William Frawley, and Arthur Shields, the Corbett story gets the full Hollywood treatment. The role was one of Flynn's favorites, and mine too, but it has to be said that Ward Bond came close to stealing the movie with his outstanding portrayal of John L. Sullivan.

I always thought it was unfortunate a full-length Sullivan biopic was never made starring Bond, as he was perfect in the role. His final scene where he wishes new champion Corbett well is superb and

There are two versions of Requiem for a Heavyweight, and both should be seen. The original was a teleplay that aired live on Playhouse 90 October 11, 1956. It was written by Rod Serling and starred Jack Palance as Harlan "Mountain" McClintock, a washed up former heavyweight contender pushed by his manager Maish, played by Keenan Wynn, to take up pro wrestling. Wynn's father, Ed Wynn, played trainer Army. Both Palance and Serling had experience as boxers, which helped add to the authenticity of the production.

While a dark story, the Playhouse 90 version had a happy ending. The feature movie made in 1962 was darker. It starred Anthony Quinn as Luis "Mountain" Rivera, and Jackie Gleason as his sleazy manager. Mickey Rooney played his trainer Army, a man with a heart.

Requiem for a Heavyweight delves into the dark side of boxing, which is more common than not. In both versions, while it is not clearly mentioned, the effects of pugilistic dementia are clearly shown. Unscrupulous managers and promoters are seen squeezing every last nickel out of a broken fighter and then leaving him to fend for himself. While fiction, the story is very true to life about the exploitation that is done, and that brain damage is caused by the dark business of boxing.

A British live television version was made starring Sean Connery. I'm not sure if that one is available, but it would be interesting to see. There was also a Yugoslavian TV version made in 1974.

Budd Schulberg's novel The Harder They Fall was made into a feature film in 1956, with a screenplay by Philip Jordan. Directed by Mark Robson, it starred Humphrey Bogart in his final role. Bogart plays unemployed newspaper reporter Eddie Willis, who sells his soul by taking on a job working as a public relations man for promoter Nick Benko, played by Rod Steiger.

Loosely based on the career of Primo Carnera (who later unsuccessfully sued the studio for invasion of privacy), this is another look into the sordid world of professional boxing.

### HOOPS and HOCKEY in the HUB

FAST STARTS — When Mika Zibanejad became the 10th player in NHL history to post a total of at least eight points in the first two games of the season he joined a list that included a good number of Bruins.

Four players who have donned the Black and Gold at some point in their careers have achieved the feat over the past 74 seasons, with three of them exceeding the total posted by Zibanejad.

In fact, two Bruins rang up a total of nine points in the first two games of the season in the same year — 1973-1974. That's when both Ken Hodge and Phil Esposito got off to rip-roaring starts for the B's.

Kevin Stephens, who played for the Bruins during the 1995-1996 campaign, also found the range for nine markers in the first two games of the 1991-1992 season while playing for Pittsburgh.

A year later Jaromir Jagr, who would play one solitary spring (2013) on Causeway Street in the twilight of his career, put up eight while also playing for the Pens.

MR. OCTOBER — That is what New York Yankees star outfielder Reggie Jackson was called during his career in Major League Baseball since he always seemed to perform at his best during the playoffs.

But October is also a hockey month in the NHL, a period filled with regular season games night in and night out. For those in Boston we propose another Mr. October, this one for Causeway Street.

You see, one Cameron Michael Neely, currently the president of the Bruins, surely has the statistics to stake his claim for the Black and Gold. During his active playing career, most of which took place while with Boston, Neely played in 92 regular season games in October, scoring a total of 55 goals in the first month of the season.

A current player on track to do much the same is David Pastrnak. As of press time, he had 43 career October games under his belt, having found the range for 25 tallies as he entered the fourth season with the Bruins.

### **CHRIS SNOW PROMOTED**

— For those of you who read the Boston Globe sports pages on a regular basis, you may remember Chris Snow, who was the Red Sox beat writer for the paper in the 18 or so months following their 2004 World Series triumph.

A native of Melrose, who graduated from Malden Catholic in 1999 and Syracuse University in 2003, Snow has just been promoted to assistant general manager of the Calgary Flames, one of the strongest teams in the Western Conference.

Although the Red Sox beat is considered a dream job by many members of the fourth estate in this area, Chris decided to pursue another path away from the diamond game.

Actually, it was while covering the Sox and the front office operation of Theo Epstein that Chris became interested in the field of analytics - and how it might be applied to his first love in sports — ice hockey.

Chris had also worked at the Minneapolis Star Tribune, so when a position opened up in the front office of the Minnesota Wild, the franchise brought Chris aboard. He worked there for four seasons before switching over to the Calgary Flames in 2011. Once in Alberta, he built out Calgary's analytics program into a robust venture.

ALREADY THEY ARE **HISTORIC** — It sure didn't take long for the 2019-2020 edition of the Bruins to etch their way into the record books. As we went to press, the Bruins had opened the season with three consecutive road victories. And that, according to those who work in the NHL statistics department "marks the first time in franchise history that the Bruins have won each of their first three games of a season-opening road trip.'

WILL HE CATCH DOUG JARVIS? — Everyone associated with the National Hockey League is well aware that injuries are an unfortunate fact of life. In an average regular season where it is common to have three games (and sometimes more) in one week, could cause a player to miss a game or two over the course of an entire 82-game campaign seems like normality.

That's why what Doug Jarvis, a former assistant coach with the Bruins, accomplished seems so far out there that it defies comprehension.

For you see, Jarvis — who is now a senior advisor with the Vancouver Canucks — went nearly the entire length of his 15-year NHL playing career without missing one single contest. Starting on October 8, 1975 and continuing through until October 10, 1987, Jarvis was on the ice for every single game — some 964 of them — a streak that was broken only in the twilight of his career when he was a healthy scratch in the third game of the 1987-1988 season.

For this outstanding achievement of resilience, Jarvis was presented the Bill Masterton Trophy in the spring of 1987,


