

Stirpe Nostra

FRUMENTUM



Frumentum is the Latin word for corn, and from the days of antiquity, one of the duties of the Roman government was to maintain it in good supply. Even during times of scarcity, it was expected that the administrators would buy the corn from other countries and sell it to the people at a moderate and stable price. Permitting the supply of corn to dwindle or the price to rise was considered to be an act of total irresponsibility and a neglect of one of the government's most important duties.

Economic conditions, of course, were not "totus consolatio" or always in a consoled state of affairs. During periods when the indigent or extremely poor population increased, they could not afford to buy corn even at moderate prices, so the demand was to be fed at the expense of the State. On very few occasions, wealthy persons in search of popularity made donations of corn to the people. State subsidies to supply corn and wheat below their market values started about 123 B.C. Strangely enough, these subsidies were not restricted to the poor; every citizen had a right to them, but distribution was made through fathers of families. Each recipient was required to apply for the subsidy in person, and this in itself

deterred most of the rich. In time, this system taught the poor to become paupers of the State and such a vast idle population soon emptied the treasury. This situation could never happen in the U.S.A. because we would just print more money ... How simple can you get.

The amount of the food subsidies fluctuated until about the time of Julius Caesar when corn was then distributed to the people free. The cost for this caper came to approximately twenty percent of the total revenue of the State. Caesar affected some economies by requiring proof of citizenship. This reduced the number of eligible persons by about fifty percent. Having gone this far he then enacted laws which set a ceiling on the number of recipients and permitted new additions only by lottery as the old-timers died off. History implies that in time the free corn was supplied only to the utterly destitute. These persons were first issued tickets called "tesserae Nummariae" which entitled the holder to receive the corn without payment.

When a tessera was issued, it became the property of that person for life. He could keep it, sell it, or even will it to one of his heirs. Any Roman citizen, except a senator, was eligible to hold a tessera, provided that he could show a need.

Eventually, instead of distributing the corn every month, wheaten bread was made by the State and given to the people. The bread was baked by "pistores" (millers or bakers), delivered to special elevated depots which were approached by "gradus" (steps) and ... you guessed it ... the bread was called "panis gradilis." After 2,000 years, we removed the steps, installed escalators, and changed the name to "panis gratuitus." **NEXT WEEK:**Political Ambition

Saint Peter Faber

Peter Faber was born in 1506, to a peasant family in the village of Villaret, in the French Alps. As a boy, he was a shepherd in the high pastures of the Alps. He had little education, but a remarkable memory; he could hear a sermon in the morning and then repeat it verbatim in the afternoon for his friends. Peter had a strong desire to be educated. His early education was entrusted to the care of a priest at Thônes, and then to a neighboring school. Although without any definite plans for the future, he resolved to go to

Paris. His parents consented and in 1525, Peter arrived in Paris. In 1525, he was admitted to the Collège Sainte-Barbe, the oldest school in the University of Paris, where he shared his lodgings with Francis Xavier. Faber and Xavier became close friends and both received the degree of Master of Arts on the same day in 1530. At the university, Faber also met Ignatius of Loyola and became one of his associates. He tutored Loyola in the philosophy of Aristotle, while Loyola tutored Faber in spiritual matters.

Xavier, Faber, and Loyola all became roommates at the University of Paris and are all recognized by the Jesuits as founders of the Society of Jesus. Faber was the first among the small circle to be ordained, having become a priest on May 30, 1534. He met with Ignatius and his five companions at Montmartre on August 15th, of the same year.

To these first six volunteers, three others were added. Ignatius appointed them all to meet at Venice, and charged Faber to conduct them there. Leaving Paris November 15, 1536, Faber and his companions rejoined Ignatius at Venice in January 1537.

Faber went to Rome, and after some months of preaching and teaching, the pope sent him to Parma and Piacenza, where he brought about a revival of Christian piety. Recalled to Rome, Faber was sent to Germany to uphold Catholicism at the Diet of Worms convoked in 1540. Faber was startled by the ruin which Protestantism had caused in Germany, and by the state of decline presented by Catholicism; and he saw that the remedy did not lie in discussions with the heretics, however, in the reform of the faithful — above all, of the clergy. For ten months, at Speyer, at Ratisbon, and at Mainz, he conducted himself with gentleness and success. It was above all by the Spiritual that he accomplished most of his conversions.

Faber, at forty, was exhausted by his incessant labors and his constant journeys always made on foot. The Pope, however, thought of sending him to the Council of Trent as theologian of the Holy See. Faber, weakened by fever, arrived in Rome on July 17, 1546, to die in the arms of St. Ignatius on August 1st.

Those who had known him already invoked him as a saint. Saint Francis de Sales, never spoke of him except as a saint. Pope Francis canonized him on December 17, 2013. The Feast of Saint Peter Faber is August 2nd.

L'Anno Bello: A Year in Italian Folklore

Spooktacular Italy

Halloween season is officially upon us! An old-fashioned holiday wreath hangs upon my door, boasting Victorian images of smiling pumpkins, girls sporting pointy witch hats, and bats in mid-flight. Jack-o-lanterns and arched black cats grin mischievously from store shelves, with thin lights flickering inside them like little captured sunbeams. The cornstalks and scarecrows that adorn my neighbors' front steps speak of the concluding harvest season, while the colorful leaves that flutter to the ground against the backdrop of a slate-gray sky remind us that the year itself now winds down to its close. Halloween is the time to revel in all these examples of a world turned upside-down, of the pleasure of the unknown and the thrill of everything that is mysterious and spine tingling. Though modern Halloween celebrations are largely an American phenomenon, the United States does not have a monopoly on spooky imagery or mythical creatures. Across the ocean in Italy, people also ready themselves for Halloween, and may draw upon their own unique mythology and folklore. So in the spirit of Halloween, let's dive into the eerier side of Italy, the side that you may not find in tour books but certainly plays an important part in the Italian character!

Italy has long had a fascination with the occult, stretching back to the days of Ancient Rome. The modern Italian prejudice against the number seventeen, similar to the American superstition of unlucky thirteen, stems from the burial customs of the Romans. The Roman numeral for seventeen is VIXI, the same as the Latin word meaning "he lived" — a phrase frequently carved into ancient tombstones, and therefore linking the number with death. Ancient Rome's pen-

chant for the macabre did not end with numbers, however. Romans shivered with fear over the *lemures*, or terrifying ghosts. These ethereal beings haunted certain houses or roads because, as many ghost stories stated, they could find no rest due to an improper burial or some sort of injustice committed against them during their lifetime. The Romans even devoted the month of May to a holiday called Lemuria which sought to appease these spirits, and this creepy feast may form the origin of an olden superstition that advised against marrying in May. Ancient Romans also resorted to supernatural omens in order to predict the future. Priests known as augurs interpreted the flight of birds to divine looming events and outcomes. Haruspices had to report the future with a much yuckier method: they scoured the entrails of sacrificed animals for omens! While modern Italians are certainly less superstitious than their ancient counterparts, many remnants of Rome's mysterious folklore persist to this day, such as the ubiquitous charms against the evil eye and the popular red horn-shaped amulets said to bring good luck.

Though Ancient Rome's love for the mysterious is wellstudied, contemporary Italy nevertheless brims with a plethora of scary monsters and eerie folktales. Werewolf stories abound in Italy, where the hairy shape-shifting beast bears the name licantropo. The fear of the licantropo hearkens back to the time when the wolf stood as the most dreaded predator in the forests of Europe, especially during the nights of the full moon, when certain men could morph into this formidable animal. My father frequently spoke of hearing the plaintive howls of wolves in his secluded Italian village, and such a chilling memory is a testament to the

Similarly, the witch, or strega, constitutes a complex symbol in Italian society, sometimes functioning as an example of evil and other times signifying benign and astute female power. The gift-bringer of the Italian Christmas season, La Befana, is even depicted as a kindly fairy-witch figure. Unique mythological creatures also roam localized areas of Italy. The Badalisc is a large, hairy beast that inhabits the Alpine woods of Lombardy in northern Italy. It can only be captured on the Epiphany, and this event forms a part of the region's folksy holiday celebrations to this day. 
He seems to check all the current boxes as far as his constitutional view for sitting on the U.S. Supreme Court. But is that alone enough?



Lenny Kravitz's first five albums Let Love Rule (1989), Mama Said (1991), Are You Gonna Go My Way (1993), Circus (1995), and the album 5 (1998), were released in 2LP sets. On November 30th, Kravitz's Let Love Rule will be released on its 30th anniversary. Each album exhibits the ongoing evolution of Kravitz's considerable talents as a multifaceted singer, songwriter, producer, and guitar player. Let Love Rule established the template for Kravitz's exploratory nature as an artist. The complete 13-track album was issued on vinyl for the first time. Mama Said continued the thread, with the mid-tempo ballad "It Ain't Over Til It's Over," and the soul-drenched "Always On The Run." Are You Gonna Go My Way sealed Kravitz's wideranging appeal, thanks to the abject ferocity of the title track and the international chart hit "Heaven Help." On its 25th anniversary, the main album will be available on commercial vinyl for the first time and includes eight bonus tracks on vinyl for the first time. Circus, on vinyl for the first time in the U.S.. continued Kravitz's climb with the undeniable punch of "Rock And Roll Is Dead," while the album 5 took Kravitz to newer heights with the universal yearning of "Fly Away" which hit No. 1 on the Mainstream Rock Tracks and Modern Rock Tracks charts in the United States. "Fly Away" earned a Grammy in 1999 for Best Male Rock Vocal Performance. Celebrating its 20th anniversary, also on vinyl for the first time ever.

Back in 2013, Mayor Menino put a retirement package together to thin out the ranks of administration in the police, fire and school department. I was at the McCormack School in Dorchester in charge of transportation and heading up the technology department. When I saw the Menino package I grabbed it, as it was too much to leave behind. I had been teaching at Cambridge College a couple of nights per week, and when the president was told I was leaving the Boston schools, they gave me a lot more to do. Added to this, Cambridge opened a campus in Lawrence, and the president asked me to help the new campus director get the show on the road, and I did. This level of commitment filled the gap left by retiring from Boston.

At the same time, I was still playing music on weekends. Unexpectedly, my partner, pianist Marty Goldman, passed away. I tried a few other pianists on remaining jobs, but it wasn't the same, and I began to back off from a commitment to music I had since turning professional in 1958. Not long after that point in time, I was faced with neuro surgery and that set me back a peg or two. But, I do stay active with my own lodge, the Greater Boston Renaissance Lodge, headed by Dr. Dean Saluti, and the OSIA Culture Commission, also headed up by Dean.

So, let's see, I'm pushing 80, and am down to teaching at two colleges, writing this column, working on two books, trying to convince the world of the integrity of Christopher Columbus, trying to spend time with the family (I love being called, Nonno, by my granddaughter) and maintaining a military commitment, to the Veterans Organizations of the First Corps of Cadets. Oh yeah, I have a few antique cars that I like to drive when I have a bit of time to myself.

I have to be realistic about things. Age is a factor and it's a young person's world out there. Until I'm incapable of handling all of the things on my plate, I guess I will continue to stay connected with the things I feel are important in life, being a husband, father, grandfather, friend, and someone who loves and cherishes his heritage. I have heard the term used for people who multi-task, "Yankee

But we still have a lot to overcome. I was sitting having coffee at one of the colleges the other morning, and as usual, I was dressed with a suit and tie. A Clockwork Orange

Before Brazil there was A Clockwork Orange, which caused a greater stir in Great Britain and was banned in its country of origin for almost thirty years.

Based on Anthony Burgess's dystopian novel, A Clockwork Orange was, among other things, a commentary on the British penal system and misguided over medication of troubled youth telling the story of Alex (played by Malcolm McDowell), a young thug and member of London's "droog" gang who do little more than rape and attack locals. Director Stanley Kubrick, who had, by this time, been living and working in England for some time, described the essence of the film as, "A social satire dealing with the question of whether behavioral psychology and psychological conditioning are dangerous new weapons for a totalitarian government to use to impose vast controls on its citizens and turn them into little more than robots."

Although a financial success (as controversial titles usually are) on both sides od the Atlantic upon its initial release, A Clockwork Orange did not escape controversy anywhere. In America the film met with much praise, but some critics were put off by what they perceived to be the unredemptive violence.

Writing in The New Yorker, American critic Pauline Kael said, "Literal-minded in its sex and brutality, Teutonic in its humor, Stanley Kubrick's A Clockwork Orange might be the work of a strict and exacting German professor who set out to make a porno-violent

cold antipathy toward the movie than horror at the violence — or enjoyment of it, either."

In the United Kingdom the film's reputation would head into murkier waters. When it was released in December of 1971, the film passed all censor boards. The following year, however, the film was linked to two murder cases in which teens charged with manslaughter and murder respectively mentioned the film during the

Kubrick defended the film, "To try and fasten any responsibility on art as the cause of life seems to me to put the case the wrong way around. Art consists of reshaping life, but it does not create life, nor cause life. Furthermore, to attribute powerful suggestive qualities to a film is at odds with the scientifically accepted view that, even after deep hypnosis in a posthypnotic state, people cannot be made to do things which are at odds with their natures."

Nonetheless, by 1973 Kubrick had persuaded Warner Bros. to withdraw the film for circulation in Britain. It remained a hard film to see until after Kubrick's death in 1999, after which the film was given its first showing in 2001 on Britain's Sky TV.

A Clockwork Orange, however, has seen its reputation grow and the impact it had on both cinema and society continues to be discussed. In Great Britain, particularly, it has gone from a pariah production to a cultural icon, making the list of the BFI's 100 Greatest British films and receiving a new reappraisal from national critics.

Here in the States the film accomplished two goals. It was the ultimate token of the downfall of the Production Code and a timely critical glance at the innovations of juvenile psychology from the previous two decades.

Writing in *The Atlantic*, Adam West summed up the film's legacy best saying, "Kubrick's film had set off a debate at the time over whether it would ever be virtuous or permissible to use science to deprive someone violent of free will. It's not surprise fact that this debate hasn't gone away, given that A Clockwork Orange has never gone away. The film's legacy has been chewed over plenty, and at 40, it remains many things: a cultural touchstone, a blueprint for artistic emulation and fashionable imitation. Decades later, the diffusion of the film's iconography through pop culture continues unrelentingly; its images have been copped and borrowed by everyone from David Bowie and Led Zeppelin to Madonna, Lady Gaga, The Simpsons, Usher, and Metallica.

And yet A Clockwork Orange remains in some ways misunderstood and some of its innovations still haven't been given enough due: its strength as a genre-less film, its insurgent marketing plan, its stylized violence, and its unprecedented use of music, all of which shaped both film and pop culture as well as influenced society at-large for decades to come.'

The Night Rocky Cried LOUIS vs. MARCIANO



Rocky Marciano cried the night he knocked out Joe Louis. Louis had retried in 1948 after defending his title against Jersey Joe Walcott. Louis stopped Walcott in the 11th round. Seven months earlier Louis had won a controversial 15 round decision from "Jersey Joe", so winning decisively was a great way to cap off his career and make a dignified exit.

Unfortunately, money problems forced Louis to embark on a comeback. He had a huge outstanding debt with the IRS, and the only way he knew how to make money was by stepping back into the ring. His first bout back after a two year layoff was against Ezzard Charles in an effort to regain the crown now held by the "Cincinnati Cobra". After 15 brutal rounds Charles prevailed by earning a unanimous decision.

That fight did not earn Louis the money he needed to pay off his debts, so he continued fighting in the hope of getting another shot at the title. Louis fought often over the next year engaging in 8 fights with 8 wins. He still flashed signs of greatness, but it was clear his reflexes had slowed. At 36 years of age and after a lifetime of hard training his body was just worn down. On top of this, even with fighting so often, he could not earn enough money to pay off his debt. The interest kept compounding, and he was up against a tide that would not recede

His bout against Rocky Marciano, which took place on October 26, 1951, was a classic match of the young up and coming star versus the fading Veteran. It's a script that has played out many times, but in this case it was cloaked in sadness. Joe Louis was well loved by the public. Everyone knew that he would rather have been enjoying a richly deserved retirement but had no choice other than to fight. So it came to be that a man who was arguably the greatest heavyweight who ever lived would face a future great.

Even after all of these years it is still painful to watch the footage of that October night 67 years ago at Madison Square Garden.

Even after all of these years it is still painful to watch the footage of that October night 67 years ago at Madison Square Garden. Louis, now 37 years of age, entered the ring a 6 to 5 betting favorite against the unbeaten Brockton Blockbuster. Many felt experience would win out over youth, but the years had caught up to Louis.

When the bell rang for the first round a balding Joe Louis moved out in his classic stance. Marciano came out very aggressively and won the first two rounds big, landing numerous overhand rights that Louis just could not avoid. He had not been hit like this since his first fight against Max Schmeling in 1936, 15 years earlier.

It is a testament to Louis's championship heart that he was able to become competitive against his younger opponent when he won the 4th and 5th rounds. Even though he took those rounds it was obvious he was a shadow of his old self. He was throwing combinations but his punches were not firing off like they used to. It was taking just that much longer for his body to respond to what his brain was telling it. While Louis outweighed Marciano by nearly thirty pounds he could not keep the younger man off of him. The fifth round

would be the last round Louis would win in his career.

In the sixth round you can see how Louis's legs appeared stiff. He lost the bend in his knees and could not move away from Marciano. Marciano was no spring in his legs. At this point he began to take an awful beating. Marciano was landing rights to the head while punishing Louis's body. It was just a matter of time before the end. Suddenly, Louis became an old man. Boxing is a cruel sport where old age strikes early.

When the bell rang for the 8th round an exhausted and bruised Louis stepped forward slowly. He was not only worn out from the blows of Marciano, but also from the years of fighting and training. Louis had been fighting professionally since 1934 and as an amateur before that. He had always trained hard and he had fought often, only taking time out to serve his country during WW II. He had never failed to give his all and was doing it again on this night. However, his tank was now empty and his opponent was relentless.

About a minute and a half into the round Marciano floored Louis with a short and powerful left hook. Louis stayed on one knee while taking an eight count. When Louis rose Marciano went in to end the fight. He backed Louis up to the ropes and landed two left hooks. After the second hook, Louis's hands dropped to his side and Marciano landed a right that drove Louis down and through the ropes. As he landed on his back members of the press sitting at ringside reached up to help him. You can see the look of sadness on their faces. A police officer jumped onto the ring apron. Cornermen and the ring doctor rushed to him and made a protective circle around the fallen champ. There was a sudden outpouring of grief that can still be felt while watching the old black and white footage. The scene made me think of a line from Shakespeare's Richard II, "For God's sake, let us sit upon the ground and tell sad tales of the death of kings.'

As you look at Marciano's face as they announce him the victor, you see no joy. It has been reported Marciano wept in his dressing room. He said to Louis, "I'm sorry Joe." Louis responded "What's the use of crying? The better man won. I guess everything happens for the best."

Joe Louis would retire for good after this fight, but his financial problems continued. He turned to professional wrestling for a time and did some refereeing. He eventually ended up working as a greeter in Las Vegas. While his life didn't turn out the way it should have, he never lost the love and admiration of the American people. He was buried in Arlington National Cemetery, a fitting tribute to a man who gave so much to his country.

Rocky Marciano went on to win the championship and retired undefeated. The Rock remained retired, being one of the few who were not lured back into the ring. Tragically, he died in a plane crash in 1969, at the age of 45.

Joe Louis and Rocky Marciano were two of the greatest heavyweight champions. Both displayed class and dignity in and out of the ring. That class was displayed by each man when they met in the ring. If you want a lesson in how to be a good winner, how to be a good loser, just follow their example!



HOOPS and HOCKEY in the HUB

COMMONWEALTH AVENUE AFTERTHOUGHTS — That's what just might be going through the mind of former Boston University head coach David Quinn, who left the Terriers last spring to take over behind the bench of the New York Rangers.

Quinn had put together a quality resume in the five years he presided over the Terriers — two Hockey East Tournament Championships, a pair of HE regular season titles, four consecutive appearances in the NCAA Tournament and a berth in the 2015 national championship game. He is the first head coach in the long history of the Rangers — an Original Six team — to come directly from the NCAA.

But working one's magic in the college ranks does not necessarily translate to the same level of success in the pros. Quinn's Rangers wobbled out the NHL starting gates and were 0-3 through the first full week of the regular season.

One week does not a season make. But still, for a man who is used to success — he was 105-68-21 in his five seasons following legendary coach Jack Parker at BU — the early season view from the NHL cellar must be quite a different perspective.

The first game this season between the Bruins and the Rangers won't take place until January 19th, at the Garden. By that time, we'll have a better understanding of how Quinn is faring in his rookie season at the helm of one of the NHL's most historic franchises.

CAUSEWAY COMES ALIVE—

It was a cool, overcast day with a bit of a breeze and a slight hint of a drizzle as we traversed the steps of Center Plaza, crossed the street and boarded the Green Line for North Station.

In truth, the weather felt more like November than early October. But it also brought many positive thoughts as well. It was the perfect weather for the start of hockey season in

Unlike a good number of years in the past, this edition of the Bruins already had played a couple games on the road. But still it was, for all intents and purposes, the real opener — the one on Causeway Street — a thoroughfare alive with the vitality of construction that points to the future, much as the Bruins displayed in creating their 6-3 victory over the visiting Ottawa Senators.

It was good to be back in the building," said B's head coach Bruce Cassidy with a look of satisfaction on his face as he opened his postgame press conference. "The last time we were here for a meaningful game it was pretty disappointing."

Cassidy noted that the Stanley Cup Playoff series with the Tampa Bay Lightning last spring "got away from us. So it was nice to be back in the win column here, back in front of our fans. It's a good feeling. We need to play well here. We need to try to establish that identity. I thought we did that for the most part."

Every player on the opening night roster was introduced with the fanfare of flames and lights while all the coaches also were individually recognized by name. When you think of it, that is probably the one and only time this season that the assistants will probably be literally in the spotlight — even if it is just for a few seconds.

Yet the time they spend with the players is invaluable. Cassidy should know. He toiled for years as the coach in Providence, plus as an assistant at the B's training camp, before being brought up to the big club as an assistant for the 2016-2017 season.

It was his complete knowledge of the players — many had played under him in Providence — that helped assure a smooth transition and led to the team qualifying for a Stanley Cup berth in the months following the dismissal of Claude Julien in February, 2017.

For this year's home opener, the B's got right down to business with Patrice Bergeron lighting up the scoreboard just 30 seconds after the game commenced. It's always nice to see Bergeron do well — he would wind up with his fourth career hat trick plus an assist on the day — not only because he is a team leader but because of the way he came back from the devastating concussion he suffered 11 years ago at the Garden.

Bergeron was checked from behind by Philadelphia Flyers defenseman Randy Jones and sent into the end boards at the Garden on October 27, 2007, a play that knocked him unconscious and took him out of action for the rest of the season,

He had suffered a grade three concussion, an injury that would not allow him to play again until the first preseason game in September, 2008. For the first few weeks, normal activities were a challenge. He was not allowed to drive for several months and it would not be until the spring that he would return to on-ice drills.

"I've been impressed with everything Bergy does to be honest with you," stated Cassidy when asked for an assessment of his star's performance. "He plays at both ends. We use him in every situation. So good for him to get us going on time. Usually, we rely on him to give us a good start. We like to start him because his line usually gets the puck and gets going on the other end, putting them (the opponents) on their heels. You know Bergy is going to lead. He's been around this league a long time."

Bergeron was selected 45th overall by the Bruins in the 2003 NHL Draft and essentially never looked back, playing nearly his entire career to date on Causeway Street, The exceptions have been the two lockout situations. During the first (in 2004-2005) he played 68 games for Providence, the team's AHL affiliate. He went overseas for the duration of the second (in 2012-2013), playing 21 games for a team in Switzerland.

Other than that it's been all Bruins all the time, something that continued in a remarkable way as the Bruins returned once again to Causeway Street for yet another opener in their storied history.
