# **VESPASIAN'S COLOSSEM**



Vespasian died on July 23, 79 A.D., after a brief illness, just one month before the eruption of Mt. Vesuvius. He was a hardheaded man, of great common sense, ambitious for power, shrewd, determined and, above all, practical. Although his reign was marked by great economy, the Colosseum or Flavian Amphitheater that he started in 70 A.D. was probably the most extravagant expenditure for public amusement ever made in the world. It was opened and dedicated by his son, Emperor Titus, in 80 A.D. and finally completed by his second son, Emperor Domitian, in 82 A.D. These three emperors, a father and two sons, all carried the family name "Flavius" as part of their imperial title and are known to us today as the Flavian

Emperors. Consequently, this structure is properly called the Flavian Amphitheater. The name Colosseum came into use because of the colossal statue of Nero that stood near it in ancient times.

The Colosseum is oval shaped, about six hundred feet long, five hundred feet wide, one hundred and sixty feet high, and covers six acres. The central combat area was called the arena, which, interestingly enough, is the English translation for "harena," the Latin name for the sand that was spread to absorb the blood of the contestants and the animals. The air was kept fresh smelling by spraying perfumes or by spreading costly powders around the structure.

Eighty arched openings in the exterior walls of the first story formed the entrances, but

these corresponding arches in the second and third stories contained beautiful sculptures. A total of 160 statues were displayed in the upper facade alone. There was seating capacity for fifty thousand spectators and standing room for about thirty thousand more. Seating priority was strictly by social class and all seats and tickets were numbered. The present day system of numbered seats and tickets in places of amusement began here. The emperor's ringside platform or box contained the imperial throne and seats for government officials and dignitaries. The lowest tier of regular seats was reserved for the noble and wealthy, while the second tier was reserved for the middle-class. The third tier was for poor people, and the last, upper tier was for unescorted women.


A skillful arrangement of corridors, stairways, ramps, and walls made it possible for each class of spectators to reach their own seats or to exit without coming in contact with their social inferiors. The eighty exits were referred to as "vomitoria" because they permitted the spectators to spew or flow right out into the street. A full Colosseum could be emptied in less than ten minutes. The structure was intentionally built as an arena where the wholesale destruction of human and animal life took place for the amusement of the spectators. They witnessed these scenes of murder hour after hour, day after day, and month after month.

# **North End Columbus Day Celebration** honoring Sal Di Masi and Sal LaMattina

Former House Speaker Sal DiMasi and District 1 City Councilor Sal LaMattina were honored with the Michael A. Nazzaro, Jr., Public Service Award at this year's Columbus Day Celebration Reception. Boston Mayor Marty Walsh took part in the presentations, as did State Rep. Aaron Michlewitz, State Sen. Joe Boncore, Register of Deeds Steve Murphy, and City Councilors Michelle Wu, Michael Flaherty and Ayanna Pressley.

While serving in the state legislature, Sal DiMasi lived on Commercial Street and served as State Representative for the Third Suffolk District. Presenters of the award praised DiMasi's leadership at the State House, particularly in championing Universal Health Care and Marriage Equality, legislative victories that were first in the U.S. and became templates for national programs.

Outgoing District 1 City Councilor Sal LaMattina started his 29-year city career as a neighborhood liaison for the North End, rising to become a major political figure in the District 1 neighborhoods of the North End, Charlestown and East Boston. LaMattina played a key role in defending urban quality of life as development and gentrification brought major changes to the North End and downtown Boston. The expansion of the Eliot K-8 Innovation School will be a lasting legacy for the Councilor. LaMattina also worked closely with Boston Police on reducing crime and other public safety issues. He was a key force in pushing to save the North End Nursing Home for local seniors. Representing three waterfront neighborhoods, LaMattina has been an advocate for water transportation and a new ferry

system to connect East Boston, the North End, and the Seaport to help alleviate traffic congestion. In his latest term, he secured funding to study a new North End community center.

The award was named after the late North End State Rep. Mike A. Nazzaro, who was born and raised in the North End, was a small business owner, and served as State Representative. During his tenure, Nazzaro protected the neighborhood from the era's urban development push and helped make the neighborhood the vibrant community it is today. Representing the late Mike Nazzaro at the event was his daughter Carla D'Orio.

Former recipients of the Michael A. Nazzaro Public Service Award include the Friends of Christopher Columbus Park (2015) and the late Boston Mayor Thomas M. Menino (2013).

# L'Anno Bello: A Year in Italian Folklore

Thrills and Chills in Italy

Halloween season is officially upon us! An old-fashioned holiday wreath hangs upon my door, boasting Victorian images of smiling pumpkins, girls sporting pointy witch hats, and bats in mid-flight. Jacko-lanterns grin mischievously from store shelves, with thin lights flickering inside them like little captured sunbeams. The cornstalks and scarecrows that adorn my neighbors' front steps speak of the concluding harvest season, while the colorful leaves that flutter to the ground against the backdrop of a slate-gray sky remind us that the year itself now winds down to its close. Halloween is the time to revel in all these examples of a world turned upside-down, of the pleasure of the unknown, and the thrill of everything that is mysterious and spine-tingling. Though modern Halloween celebrations are largely an American phenomenon, the United States does not have a monopoly on spooky imagery or mythical creatures. Across the ocean in Italy, people also ready themselves for Halloween, and may draw upon their own unique mythology and folklore. So in the spirit of Halloween and this year's Friday the 13th in October — let's dive into the eerier side of Italy, the side that you may not find in tour books but certainly plays an important part in the Italian character! Italy has long had a fascina-

tion with the occult, stretching back to the days of Ancient Rome. The modern Italian prejudice against the number seventeen, similar to the American super-stition of unlucky thirteen, stems from the burial customs of the Romans. The Roman numeral for seventeen is VIXI, the same as the Latin word meaning "he lived" — a phrase frequently carved into ancient tombstones, and therefore linking the number with death. Ancient Rome's penchant for the macabre did not end with numbers, however. Romans shivered with fear over the *lemures*, or terrifying ghosts. These ethereal beings haunted certain houses or roads because, as many ghost stories stated, they could find no rest due to an improper burial or some sort of injustice committed against them during their lifetimes. The Romans even devoted the month of May to a sought to appease these spirits, and this creepy feast may form the origin of an olden supersti-



tion that advised against marrying in May. Ancient Romans also resorted to supernatural omens in order to predict the future. Priests known as augurs interpreted the flight of birds to divine looming events and outcomes. Haruspices had to report the future with a much yuckier method: they scoured the entrails of sacrificed animals for omens! While modern Italians are certainly less superstitious than their ancient counterparts, many remnants of Rome's mysterious folklore persist to this day, such as the ubiquitous charms against the evil eye and the popular red horn-shaped amulets said to bring good luck.

Though Ancient Rome's love for the mysterious is wellstudied, contemporary Italy nevertheless brims with a plethora of scary monsters and eerie folktales. Werewolf stories abound in Italy, where the hairy shape-shifting beast bears the name licantropo. The fear of the licantropo hearkens back to the time when the wolf stood as the most dreaded predator in the forests of Europe, especially during the nights of the full moon, when certain men could morph into this formidable animal. My father frequently spoke of hearing the plaintive howls of wolves in his secluded Italian village, and such a chilling memory is a testament to the strength of the werewolf myth. Similarly, the witch, or strega, constitutes a complex symbol in Italian society, sometimes functioning as an example of evil and other times signifying benign and astute female power. The gift-bringer of the Italian Christmas season, holiday called Lemuria, which La Befana, is even depicted as a kindly fairy-witch figure. Unique mythological creatures also roam localized areas of Italy.

The Badalisc is a large, hairy beast that inhabits the Alpine woods of Lombardy in northern Italy. It can only be captured on the Epiphany and this event forms a part of the region's folksy holiday celebrations to this day. Visitors to Naples may hear tales of the Monaciello, or "little monk," a gnome-like creature who resides in the city's old abbeys, monasteries, and canals, playing harmless tricks on people and offering help to wayward travelers. Meanwhile, the famous Lake Como boasts its own version of the Loch Ness Monster, a living dinosaur known as the Lariosauro! With all of these fascinating legends and beings, Italy is a prime destination for Halloween thrills and spooky

adventures. Halloween provides us with the wonderful opportunity to have fun with the mysterious. From witches to ghosts to vampires, all of the hidden, spookier aspects of society come out to play during this chilly autumnal night. This Halloween season, I will also be thinking about the mythical creatures and unnerving legends that form a part of my Italian heritage, old and new. After all, folktales and myths do a lot more than just give us a thrill. They connect with the universal fears, concerns and desires of people across generations, emotions made manifest in guiding superstitions and metaphorical monsters. So let's celebrate the unknown on Halloween and reflect on how it impacts our lives as humans and our collective unconsciousness. Halloween teaches us that there is far more to the world than immediately meets our eye, and the legends and beings of yore are prime examples of this

# Puerto Ricans are Not Second Class Citizens

As someone who voted for President Trump last November, I am very concerned and frustrated by President Trump's crude tweets attacking Mayor Carmen Yulin Cruze of San Juan, P.R. I heard the mayor's cry for help for her city and her island in the wake of the devastation of Hurricane Maria, which pretty much leveled all of Puerto Rico.

A crisis of this magnitude is not about Donald Trump; it is about the people — U.S citizens who are suffering in the biggest hurricane to hit the island nice 1932. President Trump acts like everything is going just beautifully to use one of his favorite terms. But if you look at the photos, things are not beautiful or getting there quickly enough. The federal relief effort to date leaves much to be desired. Who are we going to believe, Washington, D.C., or our own lyin' eyes as that old song goes? We are first cousins from the Irish-American side of my family. If my Uncle Joe were alive today, he would be appalled by those recent words from President Trump. To him, Puerto Rico was as much a part of America as was Charlestown, MA, where he was born and raised.

On a recent radio show, Jeff Kuhner was badmouthing Puerto Ricans. He thinks we should cut the island loose and let it become its own nation. He added it was time for Puerto Ricans to get up on their own two feet and take care of themselves. Listen, back in 1898, following the end of the Spanish American War, we TOOK both Cuba and Puerto Rico. We cut Cuba loose but kept Puerto Rico as our property. Puerto Ricans at that time had no say in the matter. They were war spoils. Personally, I think they need statehood, but if they choose independence I would support that, too.

Helping Puerto Rico is not a Democratic, Republican, liberal or conservative thing, this is a humanitarian task needing all working together. No time for politics.

# Not Lost, But Unseen: The Legal Limbo of Letty Lynton

On all accounts, Letty Lynton is a typical MGM drama from the early sound era with an A-list cast and glamour all around. Joan Crawford gives one of her most radiant performances as the titular New York socialite living in Uruguay with a hotheaded Latin lover, Emile Renaul (Nils Asther). When she meets American traveler Jerry Darrow (Robert Montgomery), she sees a chance for escape. Unfortunately, when doubt is cast on a future with Jerry, Letty resorts to suicide by poison as the only way out of her dreadful existence. By a strange chance, Emile unwittingly drinks the poison intended by Letty for herself and dies. Seizing the opportunity, the newly liberated Letty travels back to New York with Jerry and meets his family. But then a detective starts trailing her for the murder of her lover back in South America

The film was a box-office success, resulting in a \$390,000 profit for MGM, and was responsible for a fashion trend inspired by the

white cotton organdy gown Crawford wore in the film after Macy's copied it and created 50,000 replicas.

The origins of *Letty Lynton* are complex. It was based on the novel of the same name by English novelist Marie Adelaide Belloc Lowndes, which was itself based on an infamous murder case that shocked Scotland in 1857 when a woman by the name of Madeleine Smith was accused (though found not guilty) of murdering her lover Pierre L'Angelier by means of poison.

However, a complication arose. Two years before the movie's release, dramatists Edward Sheldon and Margaret Ayer Barnes had written *Dishonored Lady*, a play also inspired by the Victorian-era murder but not (like the movie) patterned after the novel.





MGM originally tried to adapt the play as opposed to the novel, but negotiations with Sheldon and Barnes were ended when Production Code overseer Will Hays deemed the subject matter morally objectionable. MGM persisted but eventually gave up when Hays would not bend.

By 1931, MGM wonder-kid Irving Thalberg discovered the novel and got the approval of studio heads for the production. Evidently not realizing it followed the same outline as the play, Hays said nothing and *Letty Lynton* went into production and was released in theaters in 1932.

Perhaps embittered that the studio found an alternate way of adapting the same concept without their play, Sheldon and Barnes sued the studio on the grounds that the film followed their play too closely without giving due credit. In 1936, a federal District Court ruled in the playwrights' favor and three years later MGM was ordered to pay Sheldon and Barnes one-fifth of the picture's profits. That same

year, MGM tried to have this ruling overturned but was unsuccessful and since then the film has been withdrawn from circulation.

Bootlegged copies do circulate, however, and the film also appears on streaming sites. I have actually seen the film through an unofficial DVD release and found it an unremarkable though well-produced drama. Leads Crawford and Montgomery would go on to do better work, but *Letty Lynton* remains an interesting starting point for fans of the stars. Copyright laws being so complicated and, at times, ambiguous, prospects for a future official release in the United States remain uncertain but, in a strange way, its very obscurity is helping *Letty Lynton*. For without the mystery surrounding it, the film would have likely been forgotten.

Honorees and their families were presented citations honoring their roles in making the West End of Boston the greatest neighborhood in Boston (as all West Enders still say).

This year's honorees represented two neighborhoods that became victims of urban renewal. The late Bruno Roberto came from the West End and after the wrecking ball destroyed his community, the Roberto family landed in Brighton. Also honored was Gloria Ganno, who came from the New York Streets section of the South End. For those who forgot where that was, it was where the Ink Block is today along Harrison Avenue.

Two Boston neighborhoods were called slums and razed to the ground. Many think because the land was more valuable to the rich, powerful and politically connected. The New York Streets came down first, starting in 1955. When they finished knocking it down, it was on to the West End around 1958. In the end, folks were forced to run for cover elsewhere. Ganno, by the way, is Italian-Lebanese, symbolizing those melting pot communities where everyone lived side by side learning from each other.

I am old enough to have remembered what both these neighborhoods once looked like. For a time in my childhood, I lived in the South End and I remember all those New York Street names and the people who lived there. I can actually remember going to Mass in the New York Streets community at Our Lady of Pompeii, which sadly was destroyed by fire before the wrecking ball could get to it.

# Saint Robert Lawrence and the Carthusian Martyrs of London

The Carthusian Martyrs of London were the monks of the London monastery of the Carthusian Order known as the Charterhouse. They were put to death by the English state in a period lasting from May 4, 1535, until September 20, 1537. The method of execution was hanging, disemboweling while still alive, and then drawing and quartering. The group also includes two monks who were brought to that house from the Charterhouses of Beauvale and Axholme and similarly put to death. The total was 18 men, all of whom have been formally recognized by the Catholic Church as martyrs.

Robert Lawrence was born in England about 1485. He was a graduate of Cambridge College. After joining the Carthu-sians, in 1531, he succeeded John Houghton as Prior of the Beauvale Charterhouse, Nottinghamshire, when Houghton was appointed Prior of the London Charterhouse.

By February 1535, Parliament insisted that everyone had to take the Oath of Supremacy, declaring Henry VIII to be Supreme head of the Church of England. The Carthusian monks enjoyed great prestige for the austerity and sincerity of their way of life. It was thought



that their acceptance of the Act of Supremacy would have a positive influence on the public. When they refused, the only alternative was to annihilate the resistance, since their refusal put the prestige of the monks in opposition to the king's will.

Robert went with John Houghton to see Thomas Cromwell, who had them arrested and placed in the Tower of London. When they refused to sign the Oath of Supremacy, they were hanged, drawn and quartered at Tyburn, making them among the first Carthusian martyrs in England.

Beatified in 1886, Robert was canonized by Pope Paul VI with thirty-nine other martyrs on October 25, 1970. The Feast Day of Saint Robert Lawrence

# From Here to Eternity: A New Musical

Now through October 29th at the Ogunquit Playhouse


James Jones was at Pearl Harbor on December 7, 1941. He had enlisted in the U.S. Army before the war and was stationed in Hawaii in what seemed like a world away from the war raging in Europe that threatened to include the United States. Army life, even before the war, was not easy. Many of those who enlisted were living very difficult lives in Depression Era America and looked at the Army as being a way out.

Jones wrote about his experiences during this time in the novel From Here to Eternity, which was later made into an Academy Award-winning movie. The novel was a no-holdsbarred look at Army life during that period. It was not pretty. The movie shows much, but not all, of what Jones wrote.

Now, a musical play with lyrics by Tim Rice, music by Stuart Brayson, and book by Donald Rice and Bill Oakes presents us with a work that is much closer to the original novel. It is a painful story, but it is told with understanding and sympathy for those involved. All the characters are based on people James Jones knew while serving.

The set at the Ogunquit Playhouse is atmospheric. With large palm trees and multiple levels with latticework that reaches to the ceiling, the beauty of Hawaii is felt but with a dark overtone. Subtle set changes along with images being projected on the walls are used to set the different moods and they are used well.

The score is outstanding and hits hard and fast with the opening number, "G Company Blues." The choreography is tight and very physical, conveying the hard life these men lived. Other songs include "Thirty Year Man," "Don'cha Like Hawaii," and "I Love the



Army. "Something in Return" is an amazing number that is superbly done. It allows us to experience the hope and despair of those stationed on the island as well as the women who shared this difficult life. These women include prostitutes and the wife of an ambitious and cruel officer.

Those familiar with the book and/or movie will quickly recognize most of the characters. If not, they will quickly become known to you. The outstanding cast plays each as their own and, with their solid acting and beautiful voices, makes this a very powerful work indeed. The story of cruelty and the misuse of power hardly seems the material for a musical but it works and works well here. With an outstanding cast led by Derek Carley as Private Prewitt and Kevin Aichelle in the role of Sargent Warren, the pain and struggles of these individuals is brought to life in a way that is both painful to watch but done with tenderness and compassion.

Robyn Hurder plays Karen Holmes, the abused wife of the ambitious but weak Captain Dana Holmes played by Bradley Dean. They make the ugliness of such a marriage almost too real, but it is necessary. We do get to see the tender side of Karen in her scenes with Sargent Warren with whom she is having an affair. And for those who might be wondering how the famous beach scene from the movie is recreated, I will just

say this is not a restaging of the movie; however, the emotions from that iconic movie movement are captured here.

The wisecracking Private Angelo Maggio has been cast perfectly with Michael Toccini in the role. His rendition of "I Love The Army" is heart wrenching. Reed Campbell returns to the Ogunquit stage after his outstanding performance in Bullets Over Broadway, and proves that he was no one-shot wonder. He again shows his amazing talent as the sadistic Sargent Fatso Judson. By the time Judson gets what is coming to him, there is nobody in the house who feels any sympathy for him.

Jenna Nicole Schoen plays the prostitute Lorene that Private Prewitt falls for. She has a beautiful voice and is wonderful in her part. Ms. Schoen captures in her character a loving woman who has had to turn her feelings off in order to survive in a hard world. Private Prewitt manages to break through the wall she has put up. Malika Cheree as Sandra, the madame of the local brothel, conveys the combination of a jaded life along with compassion and understanding.

The finale showing the attack on Pearl Harbor is spectacular, with slow motion sequences from the actors as well as magnificent use of the projection equipment that brings the audience into that infamous day. It also shows us how life has been transformed by world events and people who wield their power, no matter how small, over others with cruelty that results in such horrific consequences. The song "The Boys of 41," which is reprised at the end of the play, is poignant and moving as we see the names of those who gave their lives projected onto the walls of the theatre.

I do have to mention the amazing job Richard Latta has done with the lighting for this production. The subtle changes are so very effective in setting the mood for the different scenes.

From Here to Eternity at the Ogunquit Playhouse is truly an experience not to be missed. Artistic Director Brad Kenney has closed out the Playhouse's 85th season in spectacular fashion.

Just a final note. This is not a play that would be appropriate for children. It does handle the serous themes in a tasteful way, but I believe it could be disturbing for children.





# Cabbage & Pork Chops

4 pork chops

1 medium onion chopped

- 3 ripe plum tomatoes or 8 oz. canned crushed tomatoes
- 2 dry bay leaf sprigs
- (optional)
- 2 small garlic cloves chopped
- 1 small head of cabbage 3 carrots
- 3 potatoes
- 1 cup of water
- 1/3 cup olive, canola or vegetable oil


Salt and pepper

In a twelve-inch saucepan, heat oil and carefully add pork chops. Brown chops lightly on both sides. Remove them from saucepan and set aside on a platter. Add chopped onion to the saucepan and simmer until onion is about to brown. Add bay leaves, garlic and cut-up or crushed tomatoes. Stir and cover. Simmer over low heat for about fifteen minutes.

Meanwhile, clean and wash carrots. Cut carrots into four-inch lengths and set aside. Peel potatoes and wash. Cut into wedges of one-inch thickness and set aside. Remove soiled or spoiled outer leaves of cabbage. Wash and cut into four or five portions. Set aside.

After tomato mixture has simmered for fifteen minutes, add one cup of water and stir. Add the chops and carrots. Cover and bring mixture to a slow boil. After ten minutes, add the cabbage. Ten minutes later add the potatoes. Additional water may be added if needed. Salt and pepper to taste. Cover and cook over medium/low heat until vegetables are tender.

NOTE: I remember that as soon as the cold weather replaced the warm days of summer, Mama changed her supper menu. The above is one of her winter meals. At times, Mama substituted frankfurters  $\,$ or Italian-style sausages for pork chops. She boiled rice for those who liked it and served it topped with the vegetables and/or meat cooked in this meal.



# Nanna & Babbononno

by John Christoforo



Friday the 13<sup>th</sup>, according to superstition, is an unlucky day. Nanna combined Italian superstitions with American and was cautious all the time. Babbononno used to spit at superstitions and say that they were conjured up by little minds at some point in the past. Nanna would throw salt over her shoulder whether she spilled any or not. She wouldn't walk under a ladder if one was leaning against the front of a building. If she had to, she would walk in the gutter until she passed it. If a black cat was in the vicinity, she would make sure it didn't cross her path. When my uncles or mother would call Nanna superstitious, she would deny it, saying that she was just cautious.

Well, it was October of 1922, and Babbononno had decided to go hunting for mush-rooms before the first frost set in. My uncles Paul and Nick were in school all week and they couldn't go with their father. Uncle Gino was a baby and my 13-year-old mother wasn't allowed on ventures like this. So, Babbononno headed off on his own.

Now you may ask why my grandfather didn't ask one of his friends to go with him. Most of the old timers who hunted for mushrooms had what they considered secret places where they would look for their funghi. If they brought someone along, no matter how close they were — a parente (relative), an amico (friend), or paesano (countryman) — they would know the secret location, and that was like telling the world, "Here are the mushrooms for all of you to find." Considering all of this, Babbononno headed to his location by himself.

He dressed for the occasion, wearing warm fall clothing, long underwear, a wool shirt, heavy work pants, a hat with hidden flaps that could cover his ears if necessary, and high boots, the type used back then for horseback riding or mountain climbing. Warm socks covered his feet under the boots and a pair of woolen gloves could be seen hanging out of his back pocket, just in case.

His mushrooming equipment consisted of a large galvanized bucket, several burlap sacks folded neatly inside, and a large jackknife with very sharp blades. (He had sharpened them himself.) Nanna would have put together something for him to eat. Even though he hated sandwiches, she would have put a few together composed of Italian cold cuts and slices of

food, a pint bottle of Zi'Antonio's best homemade red wine.

My grandfather would leave the house before sunrise, hopefully unnoticed by neighbors who might want to follow him and find his secret location. He would walk from 70 Eutaw Street in the Eagle Hill section of East Boston to the trolley stop on the corner of Meridian and Eutaw Streets and then head to Maverick Square, where he would take the subway (the Boston El) to wherever and then double back, eventually winding up at North Station. This was his diversionary tactic in case he was followed.

At North Station, he would buy a train ticket for one of the towns north of Boston, let's say Beverly. Back then. Beverly would have been sparsely populated. In spite of this, once off the train, he would take a local bus and get off at a wooded area and walk in several directions before assuring himself he wasn't followed and then head into the woods where he would do his mushrooming.

Well, this was Friday the 13th in October of 1922 and Babbononno, not being superstitious, walked for about a mile or so until he was in an area where mushrooms were to be found, and he started to dig them out of the ground. To his surprise, there were hundreds of them just waiting to be plucked and he filled one burlap sack after another, saying to himself that no one had been there before him. This was virgin territory.

He worked at filling the bags without realizing that it was getting darker and colder than when he first arrived. When he finally noticed what was going on, it was snowing. Pretty soon the snow had covered his tracks and he didn't know which way would bring him out of the woods. To warm himself, he had a couple of swigs from the pint of wine he had brought along, but that didn't work. He soon started to feel the cold even more and discovered he was walking in circles in his attempt to exit the wooded area. The snow worsened and the air got colder, causing my grandfather to lower the flaps of his cap to cover his ears. The gloves from his back pocket were now covering his frozen hands.

Walking in circles and knowing he was lost made Babbononno begin to panic. Knowing my late grandfather, he was probably saying a few Hail Mary's under his breath, hoping that would cheese. And, accompanying the help. Just then, a soldier appeared wearing an army uniform of the day. He yelled out to my grandfather, asking where he was going. Discovering Babbononno was lost and at a point of panic, he offered to lead him out of the woods. As they walked, he asked Babbononno his name and said that his was Antonio Merini from Beverly. This calmed my grandfather down a bit and he followed his new friend out of the woods to the road where the hunt began.

Babbononno offered the soldier a sandwich and a swig of the wine from the pint bottle, but he declined, saying that he was in a hurry and had to leave. As Antonio Merini walked back into the woods, my grandfather noticed that it had stopped snowing and it had warmed up considerably from the temperature he experienced in the woods, and there was no snow on the road that he was now on. Just then, he spotted the local bus and hailed it to stop. Gathering his sacks of mushrooms, he climbed into the bus and waited until it reached the Beverly train station. After buying a ticket to North Station, he sat down and waited for the train to arrive and became more relaxed.

An old timer sat down next to him and they struck up a conversation. When Babbononno told the man the story of what happened, the man stared at him in horror. When my grandfather asked the man what was the matter, the man explained and a chill ran up Babbononno's back. "What you've told me couldn't have happened. You see, Antonio or Tony Merini was a friend of mine, a local boy fighting with the 26th Infantry Division. He was killed in action during the battle of Amiens in August of 1918, four years ago!" This was one of Babbononno's stories about Friday the 13th







# When Everyone Knew Who the Heavyweight Champion Was

The Boxing Kings: When American Heavyweights Ruled the Ring

By Paul Beston • Rowman & Littlefield • 356 Pages

From the time of John L. Sullivan up to the reign of Mike Tyson, just about everybody knew who the Heavyweight Champion of the World was. It was the most prestigious of all sporting titles and the man who held it was one of the most famous, if not *the* most famous man on the planet. From 1885 up to 1990, only 30 men were able to claim that title.

Being the Heavyweight Champion went beyond just winning fights. Unlike other sports, the Champ did not compete as part of a team. This was a solitary accomplishment that was the epitome of rugged individualism. It took more than

just physical prowess to win the title; it also took strength of character and a determined will.

People who have come to the sport of boxing in recent years have no idea what an important figure the Heavyweight Boxing Champion was to past generations. In that period, I doubt there was a boy alive who didn't at one time dream of holding the title. The history of those men who did reach that goal is a very rich one that often mirrors society as a whole. While many books have been written about individual title holders, there has been a need for a broad history of the era when everyone knew the names John L. Sullivan, Jack Dempsey, Joe Louis, Rocky Marciano, Muhammad Ali, and many others.

Now, thanks to Paul Beston, the Managing Editor of *City Journal*, that need has been filled. In *The Boxing Kings: When American Heavyweights Ruled The Ring*, Mr. Beston tells the story of these unique individuals with insight and respect while at the same time not glossing over their weaknesses. If you are not already familiar with this history, there is no better book for you to learn from. If you are an experienced boxing fan, you will find this work refreshing and informative. I consider myself to be a bit of a boxing expert and I still found much that was new to me while reading this lively narrative.


It was interesting to find out that John L. Sullivan, who is well known for drawing the color line when it came to defending the title against black challengers, was one of the first people in the ring to congratulate Jack Johnson, the first black champion, when he defeated Jim Jeffries. Sullivan also rode on the railroad car with Johnson and his black supporters after the fight. There may have been an ulterior motive for Sullivan's actions, but it is still surprising to read about this considering the time in which it took place.

There is so much more. Johnson, who is seen today as a man who stood up and broke through the color line, drew one of his own and would not defend the title against some of the finest "colored" heavyweights of his day. Johnson, with his extreme behavior, not only offended whites, but finally even blacks, who did not find him a good example for their children.

To quote the author, "As a black man living on his own terms — not those of whites, not those of blacks, and not those of Booker T. Washington or W.E.B. DuBois — Johnson had no home in the America of his time. But he didn't have to make the choices he made."

Mr. Beston moves through the years concisely but without giving short shrift to any of the personalities involved. In the case of Jack Dempsey, a man who would become one of the most beloved figures in the history of sports, we learn he had problems stemming from his not having served in the military during WWI. It was a stain that would haunt the great champion for years. Yet even with that baggage, his magnetism drew the first million-dollar gates in history. Dempsey also brought boxing out of the shadows and into the mainstream.

Mr. Beston shines in this book in that he not only has done painstaking research, but he is also a great writer who never gives his readers a dull moment. In a chapter entitled *The Substitutes*, he covers the period between Dempsey and Joe Louis. For many, this period is looked upon as a lull between two great champions, but it was actually a fascinating period. It was during this time that



two of the champions were not from the United States, making it truly a world championship. As the world was slipping into chaos, it appeared the Heavyweight Championship was, too. Max Schmelling won the title on a foul, the only fighter ever to do so. Gangsters were becoming heavily involved in the game, and there was even a question of whether or not Jack Sharkey threw his fight with Primo Carnera.

It took Joe Louis to bring stability and honor back to the sport. While reading Mr. Beston's chapter on the Louis years, one is filled with joy and sadness. Louis was not

only arguably the greatest heavyweight of all time, but also one of the most important figures of the 20th Century when it came to unifying the nation and breaking down racial barriers. Louis does not receive the credit he deserves for all he accomplished. He is given his due here. As Mr. Beston writes, "Louis was a light in black America's darkness, and a generation would never forget him for it." When reading that line I can't help but think of how Muhammad Ali would later mock the aging champion.

Louis was the first black golfer to play in a PGA event, another wall he broke through. I have to admit that I was almost brought to tears reading about Joe's days after boxing. This man, who had done so much for boxing and for his country, was hounded for years by the IRS and relegated to being a greeter in Las Vegas. Paul Beston gives this great man the respect he earned and deserves.

Mr. Beston also brings us Rocky Marciano, the Brockton Blockbuster. Marciano possessed the grit, determination, and sheer will that allowed him to overcome his physical shortcomings to become the only undefeated champion in history. He was also a hero to working class America. Following Rocky, Floyd Patterson's rise to the throne ushered in a period when boxing appeared to be fading away. Then along came the colorful and handsome Swede, Ingemar Johnson, who briefly shot some adrenaline into the veins of the sport. Next, we see Sonny Liston, the man whose stare paralyzed opponents and whose lifestyle made him unwanted as champion. Mr. Beston gives us insight into this complicated man who is almost impossible to understand. If boxing were the works of Shakespeare, then Liston would be one of the "problem plays."

In reading the chapter on Muhammad Ali, the man who certainly saved boxing but at a cost, I can't help but think of how different things would have been if Ali had made some other choices. His decision to become part of a radical black separatist movement that preached racial hatred was at great odds with the unifying movement led by Martin Luther King, Jr. This charismatic young champion could have done so much to further race relations but chose to take a different path. It is ironic he is looked upon as a great Civil Rights leader when he preached separation of the races. Mr. Beston gives us much insight into Ali's career, but I think he could write a whole book just on this one subject where he could go into even more detail.

Paul Beston closes his history with the years following Ali and ends with Lennox Lewis taking over as champion. In these chapters, he discusses the bitterness of Larry Holmes and even made me feel some sympathy for Mike Tyson. He gives his thoughts on why the Heavyweight Champion is no longer a recognizable figure.

I read a lot of books on boxing. There are a number of good ones out there. However, some are well researched but poorly written and not well edited, while others are just plain awful. In *The Boxing Kings*, we have the rare book that is well researched, well written, lively, and informative. It fully conveys the author's love for the sport while taking an honest view of it. If books were fighters, some would be tomato cans, some journeymen, some contenders, and a very few would be Champions. Paul Beston's work is truly worthy of the Championship Crown. I highly recommend it.

# HOOPS and HOCKEY in the HUB

Poor Russell Westbrook, the NBA star employed by the Oklahoma City Thunder.

Russell's three-year, \$85-million-dollar contract is expiring next June. That's the one that is paying him \$28.5 million for the season that starts October 16<sup>th</sup>.

So, there was only one thing to do, thought front office executives of the Thunder — present him with a contract extension for five years that will play him a total of \$205 million — or an average of \$41 million per year starting with the 2018-2019 season. It is the largest contract ever awarded to a player by an NBA franchise.

Westbrook had a stellar 2016-2017 season, no doubt about it. He was the NBA's scoring champion and averaged a triple double for the year, with 31.6 points, 10.7 rebounds and 10.4 assists. He set a new NBA single season record with 42 triple doubles.

Let's see. The \$41 million per year works out to \$3,416,666 per month. On a weekly basis that comes to \$788,461 for every seven-day period. Break it down daily and divide \$41 million by 365 and Russell will be earning the tidy sum of \$112,328 each and every day — even in the summer, when basketball is not played.

Of course, everyone has to rest. So, in a hypothetical example, if Russell sleeps for around eight hours a day — say from midnight to 8:00 am — he would earn \$37,442 just by being in dreamland for eight hours every day.

As if that were not enough, Russell also recently signed a 10year sneaker/clothing endorsement deal with Nike (financial terms not disclosed), sending even more money his way.

One thing we haven't been able to discover is if there were any incentive clauses written into the contract with the Thunder. That's the one good sign because, after all, no one should be offered incentives after being awarded such an amount.

In fact, we can't think of one good reason why a contract of such magnitude should be forthcoming for anyone playing a game. Can you?

**A CHOICE THAT SPARED SOME** — The Vegas Golden Knights, the NHL's newest team, came off the ice after absorbing a 5-3 defeat at the hands of the San Jose Sharks.

It was the final preseason game, so the setback did little to dampen the positive emotions generated as the team looked forward to the inaugural regular season campaign that would begin in earnest in a few short days.

As some matchups in the NHL tend to do, this one had started at 5:00 pm on a Sunday. But now, as the game concluded, the players had to decide how to spend the rest of the evening.

One option was to attend a concert, but a good number decided to go out to eat. And thus it was that 10 of the Golden Knights, accompanied by girlfriends of three of the players, decided to go to a nearby restaurant for a meal.

And, it was there, while they were dining, that the horrific events of the night unfolded shortly after 10:00 pm — leaving 58 people shot to death and over 500 injured.

Diners got their first inkling

that something was wrong through social media. The mood inside the restaurant changed significantly when people entered the premises seeking shelter.

"It was just kind of a swing of emotions," Knights forward Erik Haula told the Las Vegas Review Journal. "You just try to avoid complete chaos but you want to be aware. You just want to stay calm and keep your eyes open. It went from this (normal dining atmosphere) to 'Now OK someone's walking in here and here and here. There's more than one.' It's real."

"We thought about going to the concert first after the game," said forward Alex Tuch, who was later sent down to Chicago of the American Hockey League. "Thank God we didn't," the Baldwinsville, N.Y. native told the Syracuse Post-Standard.

Actually, one member of the Golden Knights did go to the concert. That would be backup goalie Calvin Picard, who has since been traded to Toronto. He went on Friday night, the opening night of the three-day event.

But he would have gone back on what proved to be the fatal night. "It was definitely a possibility," Picard told Review Journal writer Steve Carp. He chose to dine with his teammates instead.

The restaurant was placed in lockdown mode with no one allowed to leave until around 1:00 am.

"We were kind of stuck there without much information," noted Picard. "We didn't know what was happening until afterward when it had all come to an end."

It wasn't until the next morning that Golden Knights head coach Gerard Gallant found out that all the players on the roster were fine.

Thus, the Golden Knights and the NHL escaped one of America's worst tragedies.

In the wake of the tragedy, the NHL, the Golden Knights and a charitable trust overseen by Knights majority owner Bill Foley combined to donate \$300,000 to a fund for the shooting victims. Additional contributions raised the amount to \$500,000. All funds will be administered through the Vegas Golden Knights Foundation.

In addition, first responders were honored at the Knights' regular season home opener. The moment of silence comprised 58 seconds, symbolically honoring each victim who died.

All 58 names were projected onto the ice in a moving pregame ceremony. In addition, all advertising along the boards had been removed with only the words "Vegas Strong" being displayed.

The Knights won their home opener that night, defeating the Arizona Coyotes, 5-2, to become the first expansion team in NHL history to start the regular season at 3-0-0.

That would have garnered headlines throughout the hockey world a few days earlier. But that was then and this was now. Somehow, those aspects didn't seem to matter as much anymore as the living sought to come to grips with the reality of so many lives lost, and a community known for frivolity and entertainment coped with a contemporary realism far removed from the world of fun and games.
