\$2.5 Million North Square Reconstruction Project

Mayor Martin J. Walsh celebrated the groundbreaking of a \$2.5 million reconstruction project of North Square in the North End on October 11th. The project, when completed, will transform North Square into a livable, walkable, multimodal, green and sustainable square, developing its identity as a cultural destination, while accommodating all users of this historic space.

"In Boston, we are just as excited about our future as we are proud of our past," said Mayor Walsh. "Today, we begin the next chapter of North Square, one of the North End's most treasured, historic places. I want to thank everyone who lent their voice to this process, and I look forward to seeing the transformation of this square."

North Square is one of Boston's oldest occupied neighborhoods and is a part of a vibrant community fabric in the North

End. A popular tourist destination, North Square features the Paul Revere House and the Freedom Trail, which receives four million annual visitors.

- Project highlights include:
 New, wire-cut brick around
- the perimeter of the project
 A reset of granite blocks in the roadway and center plaza
- area
 New accessible granite paver pedestrian paths throughout
- the square
 Reset nautical chain in roughly the same location
- Moon Street (Sacred Heart Church side) raised to same level as the sidewalk and plaza to ease crossings and call motorists' attention to the large number of pedestrians in the Square
- Enhanced street lighting within the square to improve its functionality and safety

"North Square has been for almost 400 years a working



square, a convening place, and a beloved piece of the North End's rich history," said Nina Zannieri, Executive Director of the Paul Revere Memorial Association. "We are so pleased that the Mayor has made this special space a priority and are looking forward to a fully rejuvenated and accessible North Square that allows it to continue to serve as a critical part of the history and fabric of the North End."

The community design process began in 2014, and priorities resulting from those discussions led to the current designs for the square, which include

Mayor Walsh, Massport Announce New Commitments to East Boston

City and Massport to Partner on Key Projects to Enhance East Boston Neighborhoods

Mayor Martin J. Walsh and the Massachusetts Port Authority (Massport) recently announced new commitments to the residents of East Boston, including Phase II of Piers Park on Boston Harbor, additional funding for the East Boston Foundation, operational funding for a new senior center for East Boston residents, and a traffic study to help mitigate congestion on Neptune Road. These commitments were identified as high impact projects by both the City of Boston and the community members and organizations of the Logan Impact Advisory Group (LIAG) through their review process for both the Terminal E modernization and the addition of 5,000 new parking

"I am proud to partner with Massport to enhance the thriving neighborhood of East Boston. These projects build on our commitment to provide new and additional pathways for economic mobility and avenues to improve quality of life for residents," said Mayor Walsh. "From improving and building upon our green spaces, to enhancing our streetscape, to providing

members of our communities a new place to gather, when we invest in and improve our neighborhoods together, great things happen."

Mayor Walsh announced a new Orient Heights Senior Center to serve the senior residents of East Boston, with Massport providing operational funding for this important project. The City of Boston will help facilitate this plan, with vital input from the community incorporated into all aspects of the project.

"Community spaces and engaging programming create meaningful connections in our neighborhoods that are important for older adults," said Emily Shea, Commissioner on Affairs of the Elderly. "We look forward to continuing to build supports and services here in East Boston."

"As one of Logan Airport's host communities, East Boston has been impacted by the airport in many ways, and today, I'm proud to join my colleagues from the City of Boston and Massport to announce these new commitments which will, no doubt, have positive impacts on East Boston

for many years to come," said State Senator Joseph Boncore.

The award-winning Piers Park is an active community center in East Boston with lush greenscapes, playground equipment, exercise equipment, and a pier extending into Boston Harbor with gazebos highlighting the neighborhoods of East Boston. The park features some of the most spectacular views of the Boston skyline. Opened in 1995, the park won the 2014 "Best of Boston" Award for "Best Green Space" in the city. Several local organizations offer programming in the park, including free concerts from Zumix, exercise offerings such as tai chi and yoga, and the annual Eastie Pride Day.

"These commitments present exciting opportunities for East Boston and are the result of a collaborative, community-driven dialogue among local stakeholders," said State Representative Adrian Madaro. "A ten-year extension and increased funding for the East Boston Foundation, a new senior center, and an expanded Piers Park will have lasting impacts on our neighbor-





VESPASIAN'S COLOSSEUM, PART II

We know that the Colosseum was the scene of fearful barbarities during the persecutions of the Christians; however, it was also used for gladiatorial combats during the first 300 years after it was built. For the provision of this fatal service to the emperor, the Roman Empire, and the glory of the Colosseum, they always kept ready in Rome about 10,000 gladiators who were held as prisoners. They were strong, athletic, well-fed, well-lodged, skilled in the use of combat weapons, and had at one time been soldiers themselves who had fought against the Roman legions and, in some instances, even defeated them. One thing was for sure; they were absolutely certain of an early death. The sheer stupidity of it all seems to be the manner in which these herds of human beings accepted their fate, yielded to the ceremonial atmosphere of the arena, considered this mortal combat as a duty, made the grand procession around the combat area, yelled the famous "Ave!" and then flung themselves against man or beast in a fight to the death.

There are those who have said that while the building was imposing because of the nature of its activity, it was never considered beautiful. The exterior of the structure was faced with the famous Italian travertine. This is the building

stone that shows the characteristic worm-eaten texture. It also had three orders of Roman architecture: Tuscan, Ionic, and Corinthian, superimposed on the first, second, and third stories respectively. The interior had a marble facing on the emperor's ringside platform, as well as a marble throne. Huge masts projecting from the upper story were equipped to hold brightly colored awnings, which protected the spectators from the summer sun.

The last gladiator fights took place in 404 A.D. and the last wild beast fight in 503 A.D. But bullfights were held here as late

as 1362. If it appears to a visitor to Rome and to the Flavian Amphitheater that more than half of the building stones have been removed, it is because the Romans themselves have done more harm to their own city than all of the invading armies put together. We are reminded that, during the Renaissance era, many of these priceless buildings of antiquity were used as quarries to furnish building stones for a number of churches and palaces. This structure has been despoiled by vandals and plundered by the Romans themselves, but majestically it still stands as one of the great landmarks of the world. It has been said many times that while the Colosseum stands, Rome will stand, and when the Colosseum falls, Rome will fall.

In retrospect, it can be said that Vespasian brought Rome out of the chaos that followed the death of Nero, Galba, Otho, and Vitellius. He restored order to the government and public finances and, although he leaned strongly toward autocratic or dictatorial side of administration, he succeeded in restoring a confidence and dignity to Rome that had heretofore been lost. History regards him as a good emperor and I think I'll just have to rate him as a 9½.

Attorney General Sessions Issues Guidance on Protections for Religious Liberty

On October 6th, Attorney General Sessions issued guidance to all administrative agencies and executive departments regarding religious liberty protections in federal law and made the following statement:

"Our freedom as citizens has always been inextricably linked with our religious freedom as a people. It has protected both the freedom to worship and the freedom not to believe. Every American has a right to believe, worship, and exercise their faith. The protections for this right, enshrined in our Constitution and laws, serve to declare and protect this important part of our heritage."

The memorandum was issued pursuant to President Trump's Executive Order No. 13798 (May 4, 2017). The guidance interprets existing protections for religious liberty in federal law, identifying 20 high-level principles.

- 1. The freedom of religion is a fundamental right of paramount importance, expressly protected by federal law.
- 2. The free exercise of religion includes the right to *act* or *abstain from action* in accordance with one's religious beliefs.
- 3. The freedom of religion extends to persons *and* organizations.
- 4. Americans do not give up their freedom of religion by participating in the marketplace, partaking of the public square, or interacting with government.
- 5. Government may not restrict acts or abstentions because of the beliefs they display.
- 6. Government may not target religious individuals or entities for special disabilities based on their religion.
- 7. Government may not target religious individuals or entities through discriminatory enforcement of neutral, generally applicable laws.
- 8. Government may not officially favor or disfavor particular religious groups.
- 9. Government may not interfere with the autonomy of a religious organization.
- 10. The Religious Freedom Restoration Act of 1993 ("RFRA") prohibits the federal government from substantially burdening any aspect of religious observance or practice, unless imposition of that burden on a particular religious adherent satisfies strict scrutiny.
- 11. RFRA's protection extends not just to individuals, but also to organizations, associations, and at least some for-profit corporations.

12. RFRA does not permit the federal government to second-guess the reasonableness of a religious belief.

- 13. A governmental action substantially burdens an exercise of religion under RFRA if it bans an aspect of an adherent's religious observance or practice, compels an act inconsistent with that observance or practice, or substantially pressures the adherent to modify such observance or practice.
- 14. The strict scrutiny standard applicable to RFRA is exceptionally demanding.
- 15. RFRA applies even where a religious adherent seeks an exemption from a legal obligation requiring the adherent to confer benefits on third parties.
- 16. Title VII of the Civil Rights Act of 1964, as amended, prohibits covered employers from discriminating against individuals on the basis of their religion.
- 17. Title VII's protection extends to discrimination on the basis of religious observance or practice as well as belief, unless the employer cannot reasonably accommodate such observance or practice without undue hardship on the business.
- 18. The Clinton Guidelines on Religious Exercise and Religious Expression in the Federal Workplace provide useful examples for private employers of reasonable accommodations for religious observance and practice in the workplace.
- 19. Religious employers are entitled to employ only persons whose beliefs and conduct are consistent with the employers' religious precepts.
- 20. As a general matter, the federal government may not condition receipt of a federal grant or contract on the effective relinquishment of a religious organization's hiring exemptions or attributes of its religious character.

Archbishop William E. Lori of Baltimore, Chairman of the Ad Hoc Committee for Religious Liberty of the United States Conference of Catholic Bishops (USCCB), offered the following statement in response:

"The Attorney General's guidance helpfully reaffirms that the law protects the freedom of faithbased organizations to conduct their operations in accordance with their religious mission. The guidance also reaffirms that the federal government should never exclude religious organizations from competing on an equal footing for government grants or contracts, and religious entities should never be forced to change their religious character in order to participate in such programs."

I can remember doing bingo games with him over at Star of the Sea in Eastie and those old ladies loved him. Back then, he was using his whole name — Bobby Meaney Cappucci — because he wanted Townies to know he was half-Irish like me. However, I must say, "Meaney" may be an Irish name, but it sounded kind of negative to me.

Persistence did pay off for him after John Nucci gave up his school committee seat and Cappucci finally got elected. However, the euphoria was short-lived after Mayor Ray Flynn abolished the school board, thus ending Cappucci's hard fought for campaign victory.

He ended up getting appointed a Boston Police Officer in his fifties. It was all quiet on the political front for a couple of decades, and then he retired. I almost forgot about him until this year when he announced his bid for Mayor of Boston. He had come out of the woodwork. He campaigned hard as usual. Put his own money into the campaign. Went door to door, printed campaign material, and even bought five billboards across the city's landscape — one of them by the onramp to both tunnels by Neptune and Bennington Streets. Every day, on my way into Boston, I would pass his face. Still a very likable guy!

I had to wonder why he picked the mayor's race to re-enter the political arena, especially when Mayor Marty Walsh was up for re-election against District 7 city councilor Tito Jackson. He was just an afterthought along with Joseph Wiley, who was also running for mayor. (I graduated with Wiley in the Class of 1966 at Boston English High School.)

Cappucci finished a distant third place and Wiley an even more distant fourth. I wonder now, why those Cappucci billboards are still up. Will we see Bobby Cappucci back on the ballot again? I think we will. I always thought he was too nice for politics. As I said, those old ladies used to love him, but sadly all those old ladies are dead now. I hope he runs again but lowers his sights. You don't re-enter politics after a long absence by running for mayor. He should have run for a citywide City Council seat. I could see him doing that job. He needs to stay rested and tanned. Who knows, luck might strike him twice. I know he always makes elections interesting and God knows we need candidates who are not so into themselves all the time.

The world doesn't revolve around Bobby Cappucci, Cappucci revolves around wards, precincts and polling places.

Joseph Barisano "Ray Barron"

Ray Barron, legendary Boston advertising, marketing and public relations executive, passed away peacefully on October 15, 2017, at the Edith Nourse Rogers Memorial Veterans Hospital in Bedford, MA. He was 93 years of age. Barron was president and founder of Barron, Hillman and Mellnick, Inc., for close to four decades, among many other roles. But here at the Post-Gazette, he is remembered

as one of its most popular columnists, author of "Ray Barron's 11 O'Clock News." Barron accomplished many things in his life and he certainly made us laugh!

Born in Boston, his given name was Joseph Barisano. He began to use the professional name of Ray Barron at age 16 during his career as a musician and orchestra leader. A gifted and talented drummer and pianist, Barron lived in New York City during the early years of his career, where he would meet his future wife, actress Marilyn Mitchell, then hostess of children's radio and television shows. Together they had two daughters, Karen and Robin. He is a graduate of Boston English High School and Burdett College, and attended (Military) Civil Affairs School in Shriveham, England, as well as Harvard School of Business, SBANE seminar.

Barron was a World War II Army Veteran and served his country in the European Theater. He was awarded four Battle Stars among other citations. As a musician/bandleader he performed at a variety of venues. In the late forties, Barron hosted a weekly jazz show on WVOM and later served as a Talkmaster on WMRE, both in Boston. And for close to four decades, Barron served as President of Barron, Hillman & Mellnick, Inc., of Boston, an advertising, marketing and public relations agency he founded in 1956 (originally named Ray Barron, Inc.). The agency became known as one of New England's leading advertising agencies and received many professional awards for excellence in advertising. Barron was selected by an Ad East magazine poll as one of New England's most creative individuals in advertising and by Madison Avenue as a "mover and a shaker." Upon selling his advertising agency, he accepted an appointment as public relations director of the Massachusetts Registry of Motor Vehicles.

Barron was also a widely read newspaper and magazine columnist for publications such as the Boston Herald, New England Ad Week, Downbeat

Magazine and, of course, the Post-Gazette. He was a marketing instructor for over a decade at the New England School of Art and Design and served as a member of the School's Board of Directors. Barron was also a prolific writer, television and radio commentator, lecturer, and mentor to many people. He was the author of several books and had over forty years of guest speaking engagements at


schools and professional organizations, receiving numerous awards, including Northeastern University's Speaker of the Year Award. He was often referred to as a Renaissance man for his creative accomplishments in addition to his success in business.

A life-long resident of Nahant, MA, Barron was an active member in the local community. He was

the founder of several community organizations, including the Nahant Friends of the Library and the Nahant Arts Association. His other affiliations included Advertising Club of Greater Boston, New England Broadcasting Association, Public Relations Society of America, Italian Americans in Communications, Dante Alighieri Society, North Shore Music Society, and the Dante University Foundation.

Barron was predeceased by his beloved wife of forty-nine years, Marilyn Mitchell Barisano. He is survived by his daughter Robin Waters and her husband Paul of Swampscott and daughter Karen Barisano Gordinas of Nahant. His also leaves his sisters Eve Barisano of East Boston, and Joan DiCenso and her husband Sal of East Boston; his granddaughter Kerry Gordinas Voznyak and her husband Michael, grandson Kyle J. Waters, and great granddaughter Teagan Voznyak; and several nieces and nephews.

L'Anno Bello: A Year in Italian Folklore

Magic in the Air: The Story of Italian Fairy Tales

Magic — the word rolls off your tongue like a charm, filled with wonder and possibility. It conjures images of puffs of colorful smoke and cards that disappear into the air. I particularly think of magic during the month of October, when signs of the mystical side of life surround me. Leaves shining on the pavement after a chilly rainfall, candles flickering inside toothy jack-o-lanterns, the foreboding sky of an early evening, the cackle of witches all these elements make October a month in which to revel in the supernatural and in the spooky sense of the unknown. This longing for the mysterious taps into our primordial collective unconsciousness, as some of our earliest introduction to magic tropes and beings came from our childhood. The wonderful world of fairy tales opened our eyes to a plethora of bizarre, subversive, and enchanting elements. These were tales where powerful women could shape a person's destiny with wishes and spells, where animals and trees talked, where the assurance of a happy ending always came as a result of an arduous and mutable journey. Fairy tales have proved so instrumental in shaping our psyche that modern scholars debate, dissect and study them in the halls of academia. My introduction to fairy tales came as a result of my grandmother, Nonna, whose bedtime stories evoked an Italian countryside full of tricky gnomes, prowling wolves, and wise, grizzled crones. The spooky, magical month of October is perfect for diving into the folktales of Italy and the motifs that make them still so popular today.

Any mention of fairy tales specific names of these stories' protagonists, from Snow

Repeated through oral tradition and echoing across generations, these characters have mutated and morphed to fit the values, mores, and customs of each time period or locale, while still keeping the core of their stories intact. Italy boasts variations of several of our beloved fairy tale protagonists. An early version of Cinderella, called Cenerentola, is present in the collection of seventeenth-century poet Giambattista Basile. In Basile's tale, a girl named Zezolla is forced to work in the kitchen by her stepmother until a fairy living in a date tree magically prepares her for a royal ball. Basile also recorded a story similar to Rapunzel, in which the main character was named Petrosinella, or parsley, and was held captive by an ogress rather than a witch. Another fairy tale named Maria, the Wicked Stepmother, and the Seven Robbers blends elements of Snow White with those of Hansel and Gretel, as a young girl named Maria is abandoned in the woods at the behest of her stepmother, only to stumble across a home belonging to seven robbers and eventually marry a prince. However, my absolute favorite fairy tale, the one most laden with foreboding and symbolism, is Little Red Riding Hood. The Italian version of this tale, La Finta Nonna ("the false grandmother") incorporates all the familiar elements — a girl visiting her grandmother and realizing that something is wrong but also adds other unique components. For example, the creature who eats the grandmother is an ogress rather than a wolf. Furthermore, Little Red Riding Hood herself manages to defeat the ogress and release her grandmother, rather than instantly brings to mind the depending on a huntsman. Talk about girl power!

Fairy tales, whether origi-White to Little Red Riding Hood. nating in Italy or not, endure

archetypes. In fact, I find that the most common fairy tale motifs frequently remind me of my time in Italy over ten years ago, particularly the days spent in my father's quaint hometown of Sulmona in the mountainous Abruzzi region. One such archetype is the enchanted forest, or woods filled with magic, mystery, and the tingling possibilities of both danger and opportunity. In Sulmona, where the forest stretched endlessly in a sea of lush emerald green and trees whispered secrets in the wind up the mountainside, it was easy to imagine elves and gnomes hiding among the foliage. The concept of the crone appears in many fairy tales as well. These immensely powerful, wizened old women wielded their abilities for good, as in the case of fairy godmothers, or for bad, as in the case of sinister witches. These examples of female agency always impressed me, especially in a genre which often took a more traditional approach to gender roles. In their positive iterations, the crones remind me of my own wise and resourceful nonnas. Finally, there is the image of the wolf. The wolf was once the most feared animal in Europe, and as such figured in many folktales as a symbol of menace and the unknown. In fact, though Italy has its own rendering of Little Red Riding Hood, most Italians are also familiar with the famous version in which a wolf swallows the grandmother. My father frequently spoke of having to ride his bicycle home late at night during his childhood, snaking through darkened mountain roads as wolves howled in the distance. Fairy tales tap into our subconscious fears and desires, and therefore their symbolism will always be repeated and reinterpreted with each passing generation. As Halloween approaches, my

thoughts turn to everything that is spooky and, well, magical. Fairy tales perfectly encompass the mood of the wondrous month of October, a month that sees the mystical dance of the harvest and ends with a festival honoring the unknown. From enchanted forests to women who can grant wishes with the wave of a wand, from conniving ogresses to cunning wolves, fairy tales weave a rich tapestry of human anxieties and yearnings made manifest in the most bizarre and metaphorical of ways. The power of fairy tales is so strong that every culture of the world contains unique fables that speak to both localized and universal concerns. This can be seen in the folktales of Italy, which blend familiar fairy tale characters with special twists and motifs. This October, I plan to spend a dark, cozy evening enveloped in the world of folklore, and I hope that the charm and magic of fairy tales touches your lives as well!



OCTOBER 12[™] Day of Disgrace

Letter to the *Boston Globe* in Response to the Article by Roland Merullo:


Good morning. No, not a good morning, especially on Columbus Day!

Poor Columbus! He died in anonymity — the typical announcement of one's death was posted in the local square of the deceased. On the day of Columbus' death, however, there was no such announcement. Thanks to Columbus, however, John W. Henry and Roland Merullo are having the time of their lives. Without Columbus, they would not be here.

In his, Columbus and Italian-Americans — a sad marriage, from his first line, "When I was a boy, my father owned a book called, 'Columbus WAS first'. I never read it. I'm sure he never read It ... " Yet, Merullo condemns "Columbus' record of brutality or his pivotal role in the heinous practice of owning and selling human beings. Torture, punitive amputations, wholesale slaughter of the generally peaceful native peoples he encountered on his four voyages."

In his first voyage, wherein Columbus showed the world how to sail to "China-India" by going west on the unknown Atlantic, Columbus landed in the waters adjacent to two continents unknown to the world. In his Log, he called the new "Indians" and described them as handsome, primitive, and docile — a people who could easily be conquered. (He was made to understand that others were cannibals; and so reported in his Log. They had no religion as such nor knew how to read or write). He took five of them onto his two ships (the third was grounded and the crew left behind in what was to be the first settlement of Europeans in "China-India"). While on board, two jumped off the ship and swam back ashore. The other three became successful icons in the Queen's court where the Europeans saw for themselves that China-India had been successfully reached by his sailing westwards.

In his second voyage, wherein he hit the bull's eye again in reaching his destination, Columbus discovered that those "docile" Indians had massacred the entire settlement. In

that Log, Columbus showed no sign of retribution against anyone. He couldn't, even if he wanted to: The Spaniards were in charge.

In his third voyage wherein he showed the Spaniards how to successfully reach "China-India", Columbus was bound in chains and sent back to Spain.

Acquitted of any charge, Queen Isabella sent Columbus back to "China-India". On his return, Columbus was allowed to live the rest of his life in oblivion. His only wish: in his will, he gave money to the city of Genova, with the hope of sending crusaders to free the holy land from Muslim oppression.

So, what did Columbus do for the native "Indians"? Directly, nothing! Indirectly, the natives did away with cannibalism. They became Christians. They learned how to read and write. They began to record their history. They became active in every aspect of modern life. They became humans having the freedom to evolve into independent citizens — their heads on their shoulders. With the help of their church, they did away with institutionalized slavery unlike the new Christians — from Africa, Europe and America, they exploited those poor souls by capturing and enslaving them by their own chiefs and kings. As important, because of Columbus' discovery of sailing west to reach the east, his discoveries through later immigrations, Columbus put an end to the practice of decapitating hundreds of thousands of individuals by their own "noble" leaders, thus saving the lives of untold numbers of future natives. And, not to forget: because of Columbus, the pervasive practice of human sacrifice by the removal of the heart came to an end. Generations upon generations of human beings have been saved. One is to ask: where is the heart of Mr. Merullo? Finally, Columbus introduced to them, Jesus — their ultimate Savior.

Long after Columbus' death, and because of Americo Vespucci, neither the indigenous people nor the Europeans knew of the existence of the North and South American continents.

The haciendas needing to be manned by "Indian" slaves did not exist; and, the cotton fields of North America requiring slaves from Africa did not exist either. Beyond and after Columbus, himself, there was little humanism among either the Europeans or of the "Indians": they are the ones who turned slavery into the repressive institution we have come to know so well. One should want to know: when, how, and who created this abominable institution; and, even try to discover who dismantled it.

Were it not for Columbus, the 1620 shores of Plymouth MA would never have welcomed that Mayflower!

In its October 12, 2017 edition of the Boston Globe, its editors have one single entry of the day Columbus revealed to the world, on our behalf, how to reach America. On the last page of the Sports section — THIS DAY IN HISTORY: the editors report that "In 1492 (according to the Old Style calendar) Columbus' expedition arrived in present-day Bahamas." Even in this pithy reference, the calendar may be wrong, and that, the expedition — not Columbus landed in the Bahamas.

Mr. Merullo, you said that neither your father nor you read the book on Columbus. Yet, you call yourself a spokesman for the Italian Americans!



Saint John of God

John of God was born João Duarte Cidade on March 8. 1495, in the District of Évora, Kingdom of Portugal. He was the son of André Cidade and Teresa Duarte, who belonged to a once-prominent family that was impoverished but had great religious faith.

One day, when John was eight years of age, he disappeared from his home. Exactly what happened to him is uncertain. John became a homeless orphan in the streets of Oropesa, near Toledo, Spain. He was eventually taken in by a man named Francisco Mayoral and the boy settled down as a shepherd.

The farmer was so pleased with John that he wanted him to marry his daughter and to become his heir. When he was about 22, to escape his master's well-meant, but persistent, offer of his daughter's hand in marriage, Cidade joined the military and fought for Charles V, Holy Roman Emperor. He was sent to fight French forces at Fontarabia. While serving there, John was accused of dereliction of duty. He was condemned to death, and that would have been his fate had not for some more tolerant officer, who intervened to win his pardon.



in Oropesa for the next four years; he then re-enlisted into the military and went to fight in Hungary against the Turks, leaving Oropesa for a final time. For the next 18 years he served as a trooper in various parts of

Cidade experienced a major religious conversion on Saint Sebastian's Day (January 20th) in 1537, while listening to a sermon by John of Ávila, who in time became his spiritual director. Ávila encouraged him to improve the life of the poor. Cidade returned to the farm At the age of 42, Cidade suffered

an acute mental breakdown and was confined to the Royal Hospital. He was visited by John of Ávila, who advised him to be more actively involved in tending to the needs of others rather than in enduring personal hardships. Cidade gradually returned to health and, shortly after, left the hospital to begin work among the poor. He established a house where he tended to the needs of the sick poor, at first doing his own begging. For some time, he was alone in his charitable work, begging by night to secure the needed medical supplies, and by day attending to the needs of his patients and the hospital.

Slowly Cidade drew to himself a dedicated circle of disciples who felt called to join him in his service to the sick and poor. He organized his followers into the Order of Hospitallers, who were approved by the Holy See in 1572. The Brothers Hospitallers of Saint John of God, as they became known, in time would care for the sick in countries around the world. Cidade passed away on March 8, 1555. He was canonized on October 16, 1690. March 8th is the Feast Day of the Saint who would become known as Saint John of God.



Rivers Edge Drive, which travels under Route 16, will also be closed to vehicular and pedestrian traffic, with Wellington Circle and Santilli Circle as the alternate route to reverse direction. Appropriate signs, channeling devices, and traffic control measures will be used to guide drivers through the area.

These impacts are necessary in order to allow for construction operations as part of the \$81.3 million project to replace the bridges carrying Revere Beach Parkway (Route 16) over the Malden River (Woods Memorial Bridge) and over the MBTA/ Rivers Edge Drive.

MassDOT encourages drivers to seek alternate routes, if possible, to avoid delays. Drivers that must travel through the affected area should expect delays, reduce speed, and use caution while traveling through the work zone.

Nanna & Babbononno

A Nostalgic Remembrance



On October 21, 19??, Angelina Contini Christoforo gave birth to a son ... and here I am!

Tomorrow is my birthday and I love birthday parties. But I now have to share October celebrations with my daughter-in-law and grand-daughter. Out of the three of us, my grand-daughter will have the biggest birthday party, because she will be one year old.

Most everyone in the family loved birthday parties, especially Babbononno. He never admitted it nor would he ever tell anyone his true age. I think the reason he agreed to having parties in his honor was the fact that they included birthday cakes and he had a sweet tooth.

Babbononno was a little guy. If he stretched his neck and was measured, he might have made it to five feet even. If his vertical image was shortchanged, he compensated with his personality, and when Nanna was alive, he was always the life of the party. After she passed on, he never partied again. That was his way.

I remember Mom wanting to celebrate his 70th birthday in 1945, but he said, "No, I want to wait until my boys come home." Uncles Nick and Gino were in the service and the war was still raging as the year began. February was the month of Babbononno's birthday, but the war would not end until early fall, when Japan surrendered. So, the only celebration in February was a special dinner that Nanna cooked, which included his favorite foods.

Both my folks liked birthday parties, but preferred just going out to dinner. Dad loved the Red Coach Grill, which was out on Route 20 in Sudbury (I think). He had a love for a thick end cut of prime rib with a baked potato on the side. Mom preferred Chinese food and we always headed for the Cathay House in Chinatown for her birthdays. Dad had played there when they had entertainment in the old days, and knew the owners. Any time we would head there, Dad would call ahead of time and we would be treated like royalty. I remember the owner once saying something to Dad that stuck in my mind: "Johnny, if it wasn't for Chinese and Italian restaurants and the food they offer, the world would starve to death." Until the past few decades, these were the only places where you could sample ethnic foods. There was a Greek restaurant on Stuart Street in Boston, the Athens Olympia, and across the street a German restaurant, Jacob Wirth's, but that was it. Oh, wait a minute,

there was Dinty Moore's in an alleyway that separated Tremont and Washington Streets. It served Irish dishes. And there was the Casbah on the second floor of a building on the corner of Tremont and Stuart. It served Middle Eastern specialties as did the Red Fez on lower Washington Street in the South End. Beyond these places, the only restaurants around town were seafood places or steak houses.

I remember a Taco Bell that opened on Route 1 North back in the '60s. It didn't last six months. No one knew what Mexican food was, and I think most everyone thought what came out of Mexico was too hot to eat.

At one point, a Japanese restaurant opened in the Fresh Pond area of Cambridge. It was June, and Dad's birthday was approaching. When I asked him what he wanted to do on his special day, he mentioned that he had never eaten Japanese food and wanted to try it. I happened to have known the original owners and they were Japanese, but from Argentina, not Japan. When we arrived, I was greeted by the owners in Spanish and they waited on us themselves personally. People at a table nearby heard me speaking to the owners and one of them pointed at me and whispered to the other, "Listen to that guy, he's speaking

Dad, whenever he could, took Mom, Nanna, Babbononno and me out to dinner. Usually it was just Mom and me, and when it was just the three of us, we were daring enough to try different things. Nanna and Babbononno preferred mainly Italian restaurants, but Dad was adventuresome. I remember going to places like Carl's Duck Farm on the North Shore or a couple of Portuguese restaurants on Cambridge Street in Cambridge.

I remember my introduction to Soul Food. Dad had worked

at a few jazz clubs in the South End and Roxbury where a couple of rib places were located and he introduced us to southern style cooking, something I still love today.

But, when it came to celebrating birthdays at restaurants, it was Italian or Chinese, mainly Italian. The only problem was the gravy at each place. Without Mom or Nanna saying anything, they would compare what was served to them with their own. If asked, they would say that their gravies were better. This was true especially where Nanna's was concerned.

We headed for my son John's house last Saturday for Lina's first birthday party. Son Michael just finished filming a new movie in New York and came home for a week's stay. He, Loretta and I headed for John and Beth's place to help celebrate the baby's first year on earth. Many of John's boyhood friends and their families were there, as well as John's in-laws. My brother-in-law Mike and his wife, Lin, came in the late afternoon to help celebrate the occasion. Several of John and Beth's neighbors were there also and this gave John the reason to barbecue, which he did to perfection. Because John's in-laws are American, Loretta and I are Nonna and Nonno. I guess we've come full circle since the days of Nanna and Babbononno.

It's time to talk about my new book, TRUE STORIES. It is out and I will be doing a few book signings for those of you interested in reading about growing up in East Boston in the '50s and my attending English High School, and the things I got away with doing as a teenager.

1/2 pound grated mozzarella

1 tablespoon of parsley flakes

3/4 cups grated Romano or

MAMA'S LASAGNA IMBOTTITA Baked Lasagna with Tomato Sauce

Lasagna:

1 1/2 pounds lasagna

6 cups prepared tomato sauce

Ricotta Chees Filling:

3 eggs

1 two-pound container ricotta cheese

Preheat oven to 350°F.

Place ricotta cheese into a strainer to remove any excess liquids. After ten minutes, place ricotta cheese in a bowl. Add beaten eggs. Use electric mixer only on very slow speed or stir by hand. Do not whip. (Optional) Stir in parsley and salt. Add three tablespoons of grated cheese of choice and (optional) mozzarella cheese. Mix thoroughly and set aside.

Partially cook lasagna following directions on the package. Boil lasagna only for five minutes or less (until the pasta becomes limp). Strain lasagna and return to pan. Add cold water to lasagna to avoid sticking together.

Spread some prepared tomato sauce over bottom of lasagna baking tray. Drain several portions of the pasta at a time from cool water. Avoid excess water in the baking tray. Place lasagna strips over tomato sauce in bottom of tray. With a tablespoon, spread ricotta mixture over the lasagna. Using a ladle, spread tomato sauce over the ricotta. Sprinkle grated cheese of choice over the tomato sauce. (Optional) Any meat in the sauce can be sliced and layered over the first layer of lasagna. Repeat the process until all lasagna has been layered into baking tray. Cover the tray with aluminum foil and set aside. Bake at least ninety minutes before serving time in a preheated 350°F oven for about forty minutes. Remove cover and check firmness of ricotta cheese by inserting a thin knife. If needed, return lasagna to oven until knife comes out clean and ricotta is firm. When thoroughly baked, set aside for at least thirty minutes before cutting into squares for serving.


Serve extra meat from sauce in a separate platter when serving the Lasagna Imbottiti.

Serves six.

NOTE: After the electric refrigerator replaced our wooden icebox in the kitchen, I recall that Mama often prepared her sauce and the Lasagna Imbottiti in the evening. She refrigerated the lasagna-filled tray and baked it the next morning.

Her favorite lasagna meat sauce was using ground beef and pork meat. She fried the ground meat loosely in her favorite saucepot. When the meat browned, she added the chopped onion and other ingredients accordingly to create her tomato sauce.

In the morning she baked the lasagna while she reheated her tomato sauce on the stove. A half-hour or so before serving time Mama cut her lasagna into serving portions. If needed, Mama retuned the lasagna tray to the oven at 250°F to reheat. I adopted Mama's way of preparing this meal because I found it more convenient than preparing everything in one morning.

a safe space where residents and visitors can relax, better amenities where children can play, and a green place to keep cool and enjoy nature in the city. Now under construction, the square is expected to be completed by the end of 2018.

In April, Mayor Walsh announced that A+J Art+Design was selected to create a public art project in conjunction with the reconstruction in North Square. Over the last few months, the artist team has been working with the Public Works Department, the Boston Art Commission, and the North End community to further develop their initial proposal. The artists are developing a series of four sculptures to create an intimate and uniquely North End sculptural gallery.

The North Square reconstruction project aligns with the priorities laid out in Imagine Boston 2030 to enhance neighborhoods by improving the public realm, strengthen neighborhood services, and encourage contextually sensitive development to improve urban vitality.

hood that residents will enjoy for generations."

The extensive planning process for the highly anticipated Piers Park II is already underway as a collaborative effort between Massport and the residents of East Boston. The Piers Park Advisory Committee, an advisory group made up of East Boston residents, will work with Massport and its design and construction consultants to oversee the development of the park. The design, bid and construction process of Piers Park II will cover 4.5 acres of active green space and be located adjacent to the existing Piers Park. When added together, both parks will include over ten acres of green space for the East Boston community.

"The partnership between the City of Boston and Massport on these important promises to the East Boston community will lead to improvements in the lives of a wide range of residents and I am looking forward to seeing these commitments come to life in the coming years," said Boston City Councilor Sal LaMattina.

In addition, Massport will also allocate funds toward the East Boston Foundation to enhance the community of East Boston and the organizations that contribute to the betterment of the neighborhoods within it. Created by Massport in 1997, the East Boston Foundation has provided more than \$10 million in financial support to 95 community programs that benefit children, adults and seniors, from sports and recreation to education, training and child care.

"As both a lifelong resident of East Boston and a member of the Massport Board, today is particularly special as we celebrate these significant commitments to the community," said Massport Board Member John Nucci. "I look forward to seeing Piers Park II grow alongside Piers Park I, one of the centerpieces of community life in East Boston, as well as continued support of the East Boston Foundation, including funding regarding a senior center for our elders, and the commitment to a study of Neptune Road's traffic impacts."

In partnership with the Boston Transportation Department, Massport will also fund a traffic study to help mitigate congestion on Neptune Road extending to Day Square. Nitsch Engineering is working to complete the study, which includes traffic counts at eight intersections and five road segments, completed GIS maps of study area, including identification of land uses, and the building of a digital traffic analysis for the study area.

'We are proud to stand here with the community of East Boston and the leadership of the Mayor and the City of Boston as we celebrate four major commitments that Massport has made to the people of East Boston," said Massport CEO Thomas P. Glynn. Neptune Road is challenging for pedestrians as well as for drivers of large trucks who frequently have difficulty navigating the u-turn from the northbound off ramp to 1A southbound due to an inadequate turning radius. This problem for oversized vehicles contributes to traffic delays on Neptune Road, a key connection for access to Route 1A and Logan International Airport, for shuttle buses and other motor vehicles traveling between East Boston and Chelsea, and for local traffic.

"BTD is pleased to have this opportunity to partner with Massport on this transportation study as it is an opportunity to create a 'complete street' design for Neptune Road that is in keeping with our Go Boston 2030 and Vision Zero goals to provide safe and efficient access for all users of Boston's roadways," said Boston Transportation Department Commissioner Gina N. 

Terry Downes

Former Middleweight Champ Passes On at 81

Terry Downes fought in Boston on two occasions, losing both times in title fights against Paul Pender. In between those two losses, he stopped Pender in England to win the title. While Terry did not hold onto the championship for very long, he did prove to be a popular and colorful champion.

Downes began his boxing career in earnest while serving in the United States Marines. His parents had moved to the United States when he was a teenager in order to be with his sister, who had lost an arm in a traffic accident. During that time, Terry and a friend decided it would be fun to join the Marines. It was a little more than they had counted on. Downes got into a disagreement with his drill sergeant and ended up in the boxing ring. He



the British and Commonwealth Middleweight Championship in 1959. In 1960, he defeated leading contender Joey Giardello. This victory earned him a title shot against Paul Pender. The fight, which took place at the Boston Arena, did not work out well for Downes, who was

stopped in the 7th round. In the return bout in England, Downes won the title by stopping Pender in the 10th round. The rubber match at the Boston Garden was won by Pender on a decision. After the loss to Pender,

Downes went on a seven-bout winning streak that included wins over Mike Pusateri, Don Fuller, and Sugar Ray Robinson. When asked how he felt after his win against the legendary Robinson, Downes replied with great humility, "I didn't beat Ray Robinson, I beat the ghost of Ray Robinson."

Downes moved up to the light heavyweight division and took on Willie Pastrano for the title. Terry was leading on all scorecards going into the 11th round when Pastrano stopped him. Though promised another shot at the title, Downes decided it was time to quit. When asked why he was retiring, Downes responded, "It was and it wasn't a difficult decision to call it a day. I think my last fight was probably my best fight, and if I couldn't beat Willie Pastrano that night, I don't think that I ever would have beaten him."

Terry Downes retired with a very respectable record of 39 wins and 9 losses. He was also smart enough to know when it was time to quit. He and his manager had invested in the recently legalized betting business in England and were

did well as an amateur and was set to represent the U.S. in the Olympic Games when it was found out he didn't meet the residency requirements.


Downes and his family returned to England where he embarked on a professional career. In 1957, in only his third fight, he was matched against future Middleweight Champion Dick Tiger, who stopped him in the fifth round. When asked after the match who he would like to fight next, he responded in true Downes fashion, "The !@!?X%\$!! who made that match!"

Downes would continue fighting, eventually winning

seeing a handsome return from the betting shops they had opened.

Downes would also go on to a career in movies, most notably in The Fearless Vampire Killers, where he played Koukol, the hunchbacked servant. He was also very active in charity work and made a number of public appearances until he was diagnosed with cancer. In 2012, he was awarded the British Empire Medal for his charity work.

Terry Downes leaves his wife of 59 years, Barbara; five children, Terry, Paul, Richard, Wendy, and Melanie; and eight grandchildren.

GORDON'S GONE, BUT IS **THE SEASON?** — Of course not. The "new" Celtics were basically constructed for one purpose: to defeat the two or three teams that stand in their way of winning Banner 18.

When Gordon Hayward went down with a fractured left ankle in the regular season opener at Cleveland, not that much changed, at least with those who speculate on the playoff outcomes in the NBA.

In the NBA, preview sections published by various media outlets all had the Cavs defeating the Celtics in the Eastern Conference Finals this coming spring. We couldn't find a publication that picked the Celtics to advance to the 2018 NBA Finals to face (most likely) the Golden State Warriors or (maybe) the Oklahoma City Thunder. And those projections assumed that everyone on the Celtics roster was healthy.

The Celtics will make the playoffs this season. They are a playoff team without Hayward. And remember, he just might be back for the playoffs, which don't start until the middle of

If Hayward returns for the NBA's "second season," the Celtics would field the team that took the floor to start the regular season opener on October 17th. If that happens, the team as constructed for this year will be the one that competes in the playoffs — assuming all others remain healthy.

If Hayward is not ready, the Celtics will face a stiffer challenge in the playoffs and might even bow out before reaching the Eastern Conference Finals.

But those possibilities are months away. As the events of opening night remind us, the best plans can change in an instant, not only for the Celtics but also for any of their opponents.

There will still be an interest in the Celtics, but now it will be to see how they cope with the adjustments the team must make to the new challenges that have arisen.

COULD ISAIAH RETURN?

- We know it's an off-the- wall possibility, but there is a wayand thus a very remote chance — that Isaiah Thomas could return to the Celtics for the start of the 2018-2019 season.

That's because when he was traded to the Cleveland Cavaliers this past summer as part of the deal that saw the Celts acquire Kyrie Irving, it took place with Thomas only having this season left on his expiring contract.

That means that on July 1, 2018, he will become a free agent and thus will become eligible to sign with any team in the NBA — including the Celtics.

Up until that time, of course, Cleveland will have the exclusive rights to re-sign Thomas, so he could remain with the Cavs.

One aspect of the Thomas situation that has changed since the trade is the projected return of the former Celtics star to the basketball court. Originally thought to miss only the first few weeks of the regular season, he is now not expected to return until at least January.

The longer Thomas remains inactive, the more Celtics Director of Basketball Operations Danny Ainge's once controversial move stands in a positive light. After all, if the ever-popular Thomas had remained with the Celtics, he wouldn't be playing with them now but recovering from off-season surgery.

Essentially, Ainge received Kyrie Irving in exchange for Jae Crowder and an inactive Thomas — and the longer the inactivity lasts, the better the deal looks for Boston this season. The Celts procured a quality player who can take the floor immediately, in exchange for an athlete who can't take the floor for at least a few months.

This takes on a new light following the injury to Gordon Hayward (see above). If Thomas were still with the Celtics, they would be down two quality players at this point. That would have made a big difference.

Thomas missed the season opener against the Celtics and may very well miss the January 3rd game when the Cavs return to the Garden for the first time since ousting the Cs in the 2017 Eastern Conference Finals. The last regular season meeting between the two teams is February 11th on the parquet.

There's no question that Thomas feels emotionally hurt by the trade, given what he feels he did for the Celtics cause during the playoffs last spring. Those included playing in the days immediately following the tragic death of his sister Chyna in a car accident near Seattle back in April plus attempting to play through the injury to his hip.

The injury happened in a game against the Timberwolves late in the regular season as the Cs were vying for the top seed in Eastern Conference. It was aggravated while playing against Washington in the playoffs.

"No doubt about it. I should have sat out the playoffs," said Thomas in a feature article published in Sports Illustrated magazine.

Thomas also feels hurt because he actively participated in the recruiting of Al Horford and Gordon Hayward, doing his part to make the team better going forward.

The Sports Illustrated piece quoted Thomas as saying "I might never talk to Danny again. I'll talk to everybody else. But what he did, knowing everything I went through, you don't do that."

The piece also revealed Celtics head coach Brad Stevens as being at a loss for words. "I've been looking at this wall for five hours, trying to figure out what to say to you," Stevens reportedly wrote in a text message to Thomas.

In addition, Stevens told the Boston Herald: "I'm sure Isaiah knows how I feel about him and how Danny feels about him."

Time (and money, of course) have a healing balm, so the door remains opens a crack for the slim possibility of Thomas' return. It may never happen. But then again, who would have thought that Gordon Hayward would be lost on opening night?
