Community Health Centers in Massachusetts Oppose Question 1

As the leader of a community health center already challenged by a statewide nursing shortage, we are joining the Massachusetts League of Community Health Centers in opposing Question 1. The proposed mandated nurse staffing levels at hospitals would drain nurses from community-based primary care settings. It is at these community-based settings that critical preventive and chronic care take place. Nurses are the backbone of our community health center workforce. Not only are they fundamental to providing patients with the highest level of care, they hold the front line against the opioid epidemic and other public health crises in our communities.

What's more, the threat of service cuts and increased wait

this November to protect patient safety.

times at community hospitals because of the mandated staffing ratios will disproportionately affect our patients. In most cases, community hospitals serve as the single entry point for lower-income residents to receive specialty and inpatient care when they need it. Many of our patients struggle with chronic disease, including diabetes, heart disease and depression — conditions that require attention from all levels of our healthcare system.

While health centers support all nurses in their goals to provide high quality care and ensure safe working conditions, we do not believe that Question 1 is the best way to achieve these aims. The unintended consequences are too far-reaching, placing the health of the state's most vulnerable communities at risk.



Stirpe Nostra

POLITICAL POWER



"Ambitio" or political ambition, the topic of last week's column, now leads us to "potestas" or power. Thoughts of political power recalls to mind the story of three Romans and the way that power, or the quest for it affected their lives.

The first man, Quintas L. Cincinnatus, was a Roman aristocrat who lived during the early period of the Roman Empire. His son was banished from Rome because of violent language which he had used towards the tribunes. This punishment so saddened and disenchanted Cincinnatus that he retired to his ancestral farm, away from the great urban confusion. Shortly thereafter, the hostile action and successes of neighboring tribes, so alarmed the Roman authorities that they felt the need of a dictator and Cincinnatus was chosen for that office.

When the delegates went to announce the decision to the new dictator, they found him

plowing his fields and from the plow he was elevated to the highest office in his country. The new dictator laid aside his farming clothes and took up the office of absolute power. He drafted a new army, conducted an overnight march to aid a Roman general whose forces were surrounded and blockaded in their own camp by the enemy. He quickly turned the tide of battle by surrounding and blockading the baffled enemy who were soon happy to submit to the new dictator's terms. Cincinnatus then returned in triumph to Rome, relinquished his dictatorial power after holding it for only 14-days and returned to his

About 20 years later, Spurius Maelius, one of the richest of the Roman knights, used a great part of his fortune to buy up corn in Etruria (now Tuscany) during the great Roman famine of 439 B.C. He sold this corn to the poor at a small price and in some instances even distributed it free. The aristocrats accused Maelius of aiming at dictatorial power and to combat this threat, Cincinnatus at the age of 80, was once again appointed dictator.

Maelius was summoned to appear before the court of the dictator, but when he refused to go, a high ranking member of the equestrian order rushed out and slewed him. The property of Maelius was confiscated and his house was destroyed. The spot where the house once stood continued to be a memorial to his fate for many years to come. The murderer was tried and convicted for his act, but escaped execution by a voluntary exile.

The story of Cincinnatus is in direct contrast to that of Didius Salvius Julianus, a wealthy Roman who bought the Roman Empire from the Praetorian Guards (about 200 A.D.). The price paid was 25,000 sesterces, which came to about \$1,000 for each guard. After reigning as emperor for about two months he was murdered by his own soldiers while Septimius Severus was marching against the city.

Growing up in Central New York during the 1960s and '70s was not unlike growing up in many of the communities across the Northeast. Manufacturing mills and factories largely hummed along providing thousands of jobs. Municipalities swelled with residents working in hundreds of downtown businesses and governmental agencies.

Yet the era still held strongly to its traditions that brought people together through rough times over the previous decades of two world wars, depression, domestic and international unrest, and uncertainty about the future. Lifestyles remained ironclad despite emerging changes because of pride and tough-minded character.

Halloween proved every bit the big event that placed good fun as the priority to anything out of control of the youth of that time. Costumes with popular plastic masks of Batman and Robin, Frankenstein, Cinderella, Werewolf, Wicked Witch, and other creatures that dazzled a child's imagination for that one important day.

The sturdy orange plastic Jack O' Lanterns, orange and black paper bags with its witch and black cat adorning the cover topped by a strong easy-to-use handle were the usual devices to carry the day and evening's candy collection. Even the old pillow case proved to satisfy a reveler's penchant to haul home as many sweets one could gather.

My childhood neighborhood was known as Trick-Or-Treat street. The quiet tree-lined street with mostly one-family and handful of two-family houses intersected with one of my hometown's six public and parochial high schools. Through the years alumni from the large public high school a block away knew the neighborhood well and brought their children too many of the homeowners whose children they went to school with.

Halloween became that one grand day whereby a reunion of friends who grew up with each other returned to see longtime pals and pass by the high school they crafted lasting memories. That alone became the parents' treat!

The familiar and safe setting saw the World War One generation as the elder neighbors were commonly called — happily greeting youngsters hidden by their favorite costumes. "Now who might you be," Miss Clark asked as she placed a small bag of treats into the tiny hands of trick-or-treaters. The 80-something Miss Clark's brother and sister in-law both lived on my street for over five decades. That way of life was the norm in every section of the medium-size city where I grew up.

Youth of all ages ran through loads of crunching dry leaves swirling across lawns and sidewalks or piled high along curbs awaiting city pickup. Lights shone on nearly every porch or lawn post signifying candy would be given. The warm glow of Jack-O-Lanterns lit up windows and stood guard atop porch steps. From house-to-house we trick-or-treaters went as our bags grew

Time factored into our annual make-believe trek through several streets in every direction. Siblings and friends traveled in groups to ward off the neighbor teens who jumped out behind bushes or dropped from Maple trees scaring us into hearty

We felt safe because neighbors knew neighbors; school chums knew other acquaintances from sports competitions, various club events, neighborhood branch libraries or community gatherings from a few blocks away. Parents were friends with older folks from years at work or church parishes or seeing one another in the neighbor grocery market, corner grocery, pharmacy, shoe store, diner, gas stations, bike shop, restaurants and array of locally owned establishments.

Thoughts of harm never engulfed our innocent, carefree activities of those long ago Halloweens. Fun became the order of the big day. School parties started the festive mood. Some Catholic school students dressed up as saints. Other children wore homemade costumes such as the lion from Wizard of Oz. The cadrè of costumes were endless. The scent of cider filled classrooms The school bell signaling the end of class couldn't arrive soon


Once outdoors, we raced home passing some houses that kept chestnut trees. Burning leaves from a neighbor's backyard filled the crisp air. Chores for supper hour didn't dampen our eagerness. As the end of the family food fare arrived the race was on to change into our favored Halloween creature.

During these uncertain times of adulthood it's okay to reflect on a simpler time in our lives that filled our minds and warmed our hearts with treats aplenty.



L'Anno Bello: A Year in Italian Folklore

The Strange Journey of Halloween

After those chilly and windblown autumnal rains that frequently mark the end of October, the forest outside my bedroom always looks particularly eerie. A few bright yellow leaves cling gingerly to slick black branches, shivering against the cool air. The thick gray clouds blanketing the sky offset the carpet of red and orange leaves strewn on the ground. On my way to work in the morning, jack-o-lanterns grin from doorsteps and cloth ghosts wave playfully from porches. At night, the ominous dark sky and whispering winds propel me indoors to my cozy home, surrounded by soft light and the scent of baked goods. Yes, the time has come for Halloween, the spookiest night of the year, when witches, ghosts, and vampires depart our collective subconscious and enter the realm of the everyday world. During Halloween, nothing is what it appears to be, and the day pulsates with a mysterious, spine-tingling energy. Halloween remains one of my favorite holidays, not just because of the oh-so-welcome prevalence of chocolate, but also because it brims with a sense of wonder and possibility over all that is unknown and unexplainable. At times macabre, and often bizarre, Halloween has an equally colorful origin story. The feast as we know it today took an intriguing and complex journey across continents and ancient traditions in order to morph into the modern Halloween. With roots in a pre-Christian harvest festival and its strong association with the Catholic feasts of All Saints and All Souls, Halloween boasts a history full of fascinating twists and memorable customs.

The story of Halloween begins with the ancient Celts, who celebrated a holiday known as Samhain (pronounced sow-en, where "sow" rhymes with "cow") on November 1st, with festivities commencing on the preceding evening. Samhain was considered the first day of winter, and some scholars theorize it may have functioned as the Celtic New Year. Samhain represented a time of uncertainty and fear for the Celts: the harvest had just finished and the cold days of winter were quickly approaching. A good harvest meant the difference between life and death for their agriculture-based society, so the Celts prayed for a successful crop. As nature itself appeared bare and barren on the blustery days of early November, Samhain retained a potent connection

with death. Indeed, the Celts believed that the veil between the world of the living and that of the dead proved especially fragile on this transitional night, and that both good and bad spirits wandered the Earth during Samhain. Celts built bonfires and donned frightening costumes in order to deflect these spirits, and costumes continue to form an indelible part of modern Halloween. The Celts also hoped to ward off evil spirits by carving jack-olanterns, or hollowed turnips etched with eerie faces and illuminated by a candle inside. When Irish immigrants arrived in North America in the nineteenth century, they carried over this custom, substituting the pumpkin for turnips. Due to the fluidity between the worlds of the living and the dead, Samhain also served as an especially appropriate time for divination. Girls would toss apple peels over their shoulders in order to determine the initial of their future spouse, and people interpreted bonfires for omens concerning the harvest. Meanwhile, unsettling stories of ghosts returning to visit the living could also be found among our ancestors in ancient Rome, who held feasts to appease the lemures, or restless spirits.

Samhain, the pre-Christian holiday commemorating the end of the harvest and the specter of death, received another slew of customs when it merged with All Saints' Day and All Souls' Day, two Catholic feasts which likewise honor the dead. As Christianity spread across Europe in the early Middle Ages, the Church eventually attached All Saints' Day to the date of November 1st in order to bring a religious context to Samhain. All Saints' Day was also known as All Hallows, and the name of the previous evening, All Hallows' Eve, transformed into the name Halloween. While All Saints' Day revered the memory of deceased saints, a new holiday situated on November 2nd, All Souls' Day, sought to honor all the faithful departed. The popular practice of trick-or-treating harkens back to All Souls' Day. During the medieval tradition of souling, beggars and children would traipse door to door and received spiced cookies known as soul cakes in exchange for prayers on behalf of the household's dead. Modern Italians do celebrate Halloween with all the usual trappings of witch decorations, glowing pumpkins and haunted attractions, but All Souls' Day remains the most significant festival of the dead in that country. On il Giorno

dei Morti, or day of the dead, Italians visit and clean graves and attend special Masses for the deceased. In villages across the countryside, grandparents whisper bone-chilling tales of lost travelers who stumble into a church service on the night of All Souls and notice that the pews are lined with the wraiths of long-gone townsfolk. In some regions, children may leave offerings of food for wandering souls on All Souls' eve and find treats the next morning. In other areas, people munch on ossa dei morti, or nutty spice cookies whose creepy name translates to "bones of the dead"! I vividly remember learning about el Día de los Muertos, or the Latin American Day of the Dead, in my Spanish class and making cinnamon-topped anise bread known as pan de los muertos. It seems that spooky holidays know no geographical bounds!

On Halloween, I love to honor old traditions. I keep the ancient motifs of harvest's end and the pervading sense of the unknown in my mind as I celebrate Halloween in a folksy, homey manner. A wooden wreath sporting jack-o-lanterns and black cats adorn my door. I bake pumpkin bread swirled with a ribbon of cream cheese every year, letting the autumnal scent of the spices pervade my kitchen. After handing out candy to trick-or-treaters, I snuggle with a cup of tea on my living room couch, watching special Halloween programs with my husband. These traditions combine to make Halloween one of my favorite and most meaningful holidays. Some people may be put off by the emphasis on death, but this actually stems from the customs of olden, earth-based festivals. As withered branches howl against the dark late October nights, it is no wonder that the ancient Celts turned to matters of mortality and legends of restless ghosts at this time of the year. However, Halloween also functions as a sort of new year, emphasizing the fact that the year is a cycle, with the sun and nature soon returning. By acknowledging the mysteries of the world and their place in the dark half of the year, we can truly learn to appreciate the light.

Saint Maurilius

Saint Maurilius is closely associated with the early history of the church of France, then known as Gaul. He was born near Milan, of an illustrious Christian family, in the year 336.

Maurilius was taught by the man who would become St. Martin of Tours. After Martin had been banished from Milan by the Arians, a heretical sect, he became Bishop of Tours. Before leaving Milan, Maurilius was made cantor for St. Ambrose, the bishop of Milan. However, after Maurilius' father passed away, he left Milan to rejoin St. Martin in Tours, wanting to be instructed in virtue and wisdom.

While there, Maurilius was ordained a priest by Martin who is known as the Apostle of Gaul.

Maurilius was dedicated fervently to the salvation of souls. During his mission, he was led to a pagan temple near Angers. The temple later burned and It was on that site that Maurilius had a church and a monastery built. The monastery was located on a hill called Prisciac, near the village Calon on the Loire, four miles from Angers, to which he often retired, even after he was made bishop, and where he passed away.

Many souls traveled to pray with Maurilius in the new monastery. During this time, Maurilius converted many pagans by preaching to them and performing miracles on the sick, the blind and the possessed. Following the bishop of Angers' death, St. Martin chose Maurilius to succeed him. Maurilius passed away in 426. The feast day of St. Maurilius is celebrated on September 13.



How Often Should You Walk Your Dog?



Determining how often to walk a dog depends on several factors, including your dog's breed, age and energy level. And of course, it also depends on the amount of time you have to walk your dog. Here's how each of these factors weigh in when determining how often to

Dog Breed: First, let's take a look at the breed of dog you have. Sporting or working breed, such as Pointers, Collies and Shepherds may have higher exercise requirements than dogs bred to be lapdogs, such as Yorkshire Terriers and Papillion's. Some dogs are natural athletes, whereas other dogs are mostly couch potatoes, Of course, this can be due to a dog's breed, or it could just be the individual preference of the dog. Most people would not think of the Bassett Hound as the perfect jogging companion, but I have met several Bassett Hounds that lead very active lives with their owners.

Age: Younger dogs have more energy, and in general, will need more exercise than dogs who are middle-aged (5-8 years of age) and senior dogs (9 years of age and over). Younger dogs also spend more time playing than older dogs. But again, there are always exceptions to this rule. Keep in mind that middle-aged to older dogs may have arthritis, muscle atrophy or other diseases, such as hypothyroidism or diabetes that lowers their stamina. Mentally, they may be eager to go, but physically they might not be able to keep up.

Your dog's exercise toler**ance:** How much exercise does your dog need? Most dogs can tolerate 20-30 minute dog walks on a daily basis if they have a relatively good body condition Some dogs in great physical health can tolerate walks up to 2 hours or go hiking for hours at a time. But it may be difficult for overweight or obese dogs to walk 10 minutes without taking multiple breaks or panting heavily due to the exertion. To figure the appropriate amount of time to walk your dog based on your dog's current health state, take your dog out for a walk and monitor her or his energy level. If your dog starts off at an energetic pace and takes you for a walk, invest in a good dog harness, like the Halti dog harness, and sturdy dog leash, like the Halti training dog lead. If she starts to slow down about 25-30 minutes into the walk, she or he may be getting tired. Instead of eagerly striding forward, she or he may start to pant more and take more interest in her surroundings, such as looking and sniffing around more.


Start to head on back home and monitor her or his pace going back. Does it slow down even more, or can she or he keep up the slower pace? If he or she slows down even further, then it means she or he has walked too far. Next time, your walk needs to be shorter because you have to account for the time it takes to walk back home.

Not only should you monitor how long it takes for your dog to slow down, but you also need to watch her or his behavior after the walk once you have reached home. If your dog drinks water and immediately crashes on one of his or her dog beds and does not move for hours, she or he may have over-exerted him or herself. If your dog starts limping during the walk or after he or she has rested from a long walk, then she or he received too much exercise. Next time. you need to go on a shorter walk or hike. A dog's tolerance for exercise can be increased as long as they are healthy. Just like you would not join a marathon if you have not run in years, you should not expect your dog to walk, run or hike for hours if she or he has been sedentary for months or years. Take it easy and gradually increase the amount of exercise you give your dog week by week. By slowly building up her or his stamina and appropriately conditioning your dog's body, you can avoid injury and pain. If your older dog needs more support, you can invest in a dog lifting harness that allows you to support some of her or his weight if she or he becomes too tired such as the Ginger Lead dog lifting harness. You need to be careful not to apply too much pressure or you will wind up hurting her back or abdomen.

Your Schedule if you determine that your dog can walk 30 minutes without being in pain, how often should you take her or him on a walk? The recommendation for people is at least 150 minutes of exercise per week. If you strive to exercise your pet this much on weekly basis, that would be great. But, we live busy lives and sometimes have really long work days. For those who can afford to hire dog walkers, then their dog exercise needs can be eas ily met. If you cannot afford to hire a dog walker, aim for 10-15 minute walk a day, or at minimum, 2-3 times a week. You can also supplement exercise for dogs by playing in a yard if you have one.

If you don't have enough time for leash walking a dog, don't have a yard, or your dog is in poor physical condition, concentrate on lower impact activities through the use of dog puzzle toys. Your dog can spend time rolling a Kong Wobbler all over the house and walk at a slower pace.

Try to have your dog engage in at least 10-15 minutes of continuous activity in your house. If you provide both physical and mental outlets for your dog, she or he will overall be a healthier and mentally more well-balanced dog.







A Nostalgic Remembrance



October is Heritage Month and I hope you have been enjoying some of the programmed festivities around the state that commemorate this month and, especially, a man named Cristoforo Columbo. I try not to get political in this column. I have a friend, Sal Giarratani, who writes several columns in this paper, and he is better than I in that regard. I've been involved with a couple of things along with the rest of the October is Heritage Month Committee (I'm the former chairman of the board), the Sons of Italy, the Italian American Alliance, and most, if not all, of the Italian and Italian American organizations around the state.

My concern is that a few politicians, even a couple with Italian last names, have been lobbying to eliminate Columbus Day from our list of state and federal holidays. Recipes from the Homeland

BAKED MANICOTTI In Tomato Sauce with Meat

4 eggs 2 cups flour $2\ cups\ milk$ Pinch of salt

2 tablespoons olive or vegetable oil

1 small six-inch cast iron or non-stick skillet

Practice is needed to be sure the same amount of mixture is poured into skillet for the same size manicotti.

Prehead oven to 400°F.

Break eggs into a bowl and beat eggs. Slowly add remaining ingredients one at a time in the bowl. Use an electric mixture on slow speed until it resembles a prepared pancake mix.

Rub inside of cast iron or non-stick skillet with some oil. Heat skillet over burner until it is hot. Remove from heat and with a small ladle, drop about two tablespoons of mixture at one end of skillet. Quickly tip skillet to allow batter to spread over the entire bottom. When firm but not browned (about five seconds), remove by lifting round edge with a fork or small spatula. Place in a dish to cool. There should be no need to turn the round over for further cooking. If you do, be sure not to brown the round crepe. Layer eight or ten prepared rounds one on top of the other. Continue making these until all mixture is used. Stir mixture occasionally.

2 pounds ricotta cheese 2 beaten eggs Pinch of salt

Pinch of black ground pepper (optional)

3 tablespoons grated cheese of choice (optional)

In a strainer, remove any excess water from ricotta cheese. Then place in a bowl. Add beaten eggs, salt, pepper and grated cheese of choice if desired. Blend but do not whip with electric mixer.


Taking one manicotti round at a time, place one to two tablespoon of filling in center. Then fold one end of round over the filling. Take opposite end of round and fold over to seal the filling in the stuffed Manicotti.


Using prepared tomato sauce, cover bottom of a manicotti baking tray with the sauce. Line bottom of baking tray with rows of stuffed Manicotti (seal side down). Spread tomato sauce over them and then sprinkle grating cheese of choice over sauce. A second layer of Manicotti can be placed over the first layer or, if preferred you can continue the process by using another baking tray.

Bake in preheated 400°F degree oven for twenty minutes. Check to see if ricotta mixture needs to bake longer before removing from oven. Ricotta is cooked when you pierce the Manicotti with a toothpick and it comes out clean.

Serves six.

Manicotti rounds can be frozen. Wrap cooled manicotti in wax paper in groups of eight or ten. Place in seal-locked plastic bags. Wrap each bag in aluminum foil before freezing. To defrost, remove from freezer and then from wrappings. Prepare a large serving tray with a clean towel. Cover with wax paper and allow defrosting on the towel before stuffing.

A Hard Day's Night



There is no better way to describe *A Hard Day's Night* than as one of the greatest musicals featuring one of the greatest groups in the history of rock n roll. It made waves both in North American and England at the height of Beatlemania and has become a classic since.

Plot-wise, A Hard Day's Night is a spoof of the then-rising genre of spy films. Most of it involves the Fab Four escaping zealous fans on a train to London and then becoming trapped in a hotel. There is then a comical mix-up involving Ringo and Paul's villainous grandfather,

But, as with any Beatles film *A Hard Day's Night* is really all about the music. There is, of course, the titular song as well as "I Should Have Known Better," "All My Loving," "Can't Buy Me

Even in the realm of cinematography, A Hard Day's Night was revolutionary, as roger Ebert observed, "Today when we watch TV and see quick cutting, hand-held cameras, interviews conducted on the run with moving targets, quickly intercut snatches of dialogue, music under documentary action and all the other trademarks of the modern style, we are looking at the children of *A Hard Day*'s *Night*."

A Hard Day's Night remains a lively, funny, and breezy tribute to musical icons and one of the crown jewels of British cinema.



Museum Event to Evoke Boston's Combat Zone

Author Stephanie Schorow
Will Share Lively Stories of Infamous District

For many today, Boston's Combat Zone is the stuff of legends. Barely a trace of the former red-light district remains, which may account for the endless fascination with the topic. The West End Museum aims to help satisfy the public's appetite for tales of the bygone adult playground.

On Tuesday, October 30th, from 6:30 to 8:00 pm, the Museum hosts an evening with Stephanie Schorow, author of *Inside The Combat Zone: The Stripped Down Story of Boston's Most Notorious Neighborhood.* The FREE event will feature a book talk and signing plus a Q&A session. Books will be available for purchase, and light refreshments will be served.

"While some may question spending two years researching Boston's X-rated neighborhood, the Combat Zone is undeniably a part of the city's history. Its emergence as a haven for adult entertainment is inextricably tied to the destruction of Scollay Square," Schorow said. "My research uncovered a host of


colorful characters, from the stripper who derailed a potential presidential candidate to a former nun-turned-lawyer who defended porn merchants. So many Bostonians have memories of the Combat Zone — if they are willing to admit it."

Scollay Square, which neighbored the West End, was home to The Old Howard Theater. Once a leading playhouse, the theater turned to vaudeville and burlesque to reclaim dwindling audiences. Ultimately closed by criminal indecency charges, The Howard suffered a small fire, thwarting a plan to return it to its former glory. While the damage was contained, the city quickly tore down the building at height of urban renewal.

With Scollay Square converted into a business and government district, its adult entertainment constituency found a new home in the Combat Zone near Chinatown. Numerous strip clubs, peep shows, X-rated movie theaters, and adult bookstores populated the area. When the Massachusetts courts declared the state's obscenity laws unconstitutional in 1974, officials feared Boston would become a magnet for pornography. In an effort to confine "red-light" activity, the Boston Redevelopment Authority designated the Combat Zone as the city's official adult entertainment district. Today, however, just a few adult establishments





right behind him, but went unnoticed by most of those in attendance.



FROM COLLEGE TO **CONTRACTS** — Never in the long history of the National Hockey League has college hockey had such a profound effect than it has today.

That was the main topic of an article that recently appeared in the New York Times. The story pointed out that about one third of the league's players have played hockey in college. In addition, nine of the 31 head coaches in the NHL have college experience while 12 of the current general managers also do. In total, about 300 former college hockey players serve within the ranks of the NHL as coaches, front office executives, or scouts.

At least two of the six new head coaches in the NHL have prominent hockey affiliations with New England. One is Dallas Stars head coach Jim Montgomery who played at the University of Maine, and came to Texas after coaching at the University of Denver. Another is David Quinn, who left the Boston University head coaching job last spring to take over the New York Rangers. Quinn, a former player for the Terriers, coached BU to the NCAA Division 1 Championship in 2015.

Among the most successful of the current crop of coaches is former Bruins head coach Mike Sullivan. A former BU player, who was forced to move on when Peter Chiarelli (now the general manager at Edmonton) took over the GM reins of the B's about a decade ago. It took a bit of time, but Sullivan finally got his accomplishments in the NHL record book, leading the Pittsburgh Penguins to consecutive Stanley Cup titles in 2016 and 2017.

Up until the 1980s players and coaches with college experience were relative rarities in pro hockey. The moment that changed that setting came in 1980, when the U.S. men's "Miracle on Ice" Olympic Team beat the Soviet Union and Finland to win the Gold Medal.

"Twenty college kids beat the Russians and the team was run by college coaches," noted Tony Granato, who presently serves as the head coach at the University of Wisconsin (his alma mater). "That was a big shot in the arm for American collegians."

But there is a downside. Many of the college players going on to play in the NHL today do so without staying all four years and graduating. And, since the vast majority of colleges require that coaches be college graduates, that means that down the road, those that left early may never stand behind the bench of a college team.

Wisconsin made an exception for Granato, who returned after a career in the NHL. But only a temporary exception. When he was hired, he was told he had a year to complete his degree or he would be let go. So it was back to class he went, sometimes sitting in classrooms with

students 30 years younger. But, yes, he did finally graduate and became the permanent head coach upon graduation.

A contemporary player who completed all four years is Ryan Donato, now with the Bruins. Donato, the son of Harvard head coach (and former Bruins player) Ted Donato, played all four years with the Crimson, signing to play with the B's after his final varsity game last

He still had to finish his last few weeks of classes, which he did, going to class between games and practices and taking his books on road trips. But he did graduate back in May and now can coach in college later in life (like his dad) if he so chooses.

SOLEMN RATHER THAN **SURE** — It was only the second home game of the new season, but the mood seemed far removed from the excitement and positive attitude that had powered the Celtics to nearly gaining a berth in the NBA Finals last spring.

In addition, that hopefully means a roster filled with players without any significant injuries. Though the Celtics made up for injuries to key players last year through sheer grit and determination, that scenario can't always be counted on.
