### Saratoga Street Halloween Block Party

Over in East Boston this coming weekend on Halloween there will be a Halloween Block Party on Saratoga Street between Brooks and Marion Streets from 4:00-8:00 p.m. They are also asking motorists not to park between Brook and Marion Streets from 4:00-8:00 p.m.

### Aretha Receives Stamp of Approval

Aretha Franklin was given a bit of posthumous R.E.S.P.E.C.T. recently when a post office in her hometown of Detroit was named in her honor. Members of her family, friends, postal workers, and elected representatives visited the former Fox Creek Post Office to celebrate the name change honoring the Queen of Soul.

### Activists Out to Rename Confederate Named Streets

Down in Alexandria, VA in the Seminary Hill neighborhood, activists are going door-to-door to rename South Floyd Street because it was named after former Virginia Governor John Buchanan Floyd, a brigadier general in the Confederate Army. There are at least 40 more streets named in honor of Confederate heroes.

Following last summer's racial justice demonstrations, Alexandria officials lowered the bar on renaming streets. Now only 25 percent of property owners' approval on a given street, down from 75 percent, are needed to get city officials to hear objections of citizens to rename streets.



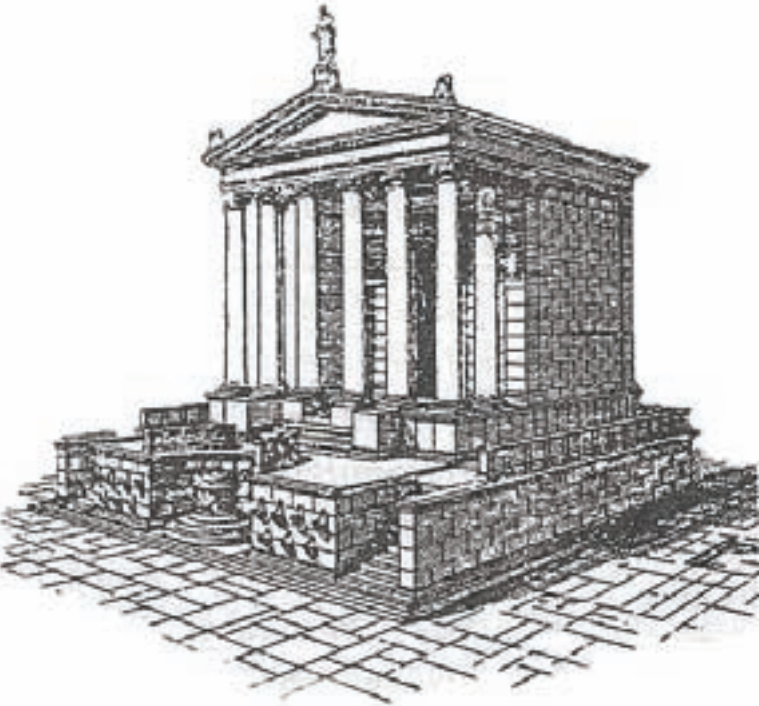

THE ROMAN TEMPLES



The Temple of Julius Caesar

The Romans built rectangular temples and circular temples. They were generally intended to be seen from the Forum, which they faced. The entrance to the temple was usually emphasized by a deep portico (covered porch). The interior was one room with small windows and poor lighting, and was usually quite damp. This room was called the cella and usually housed some statuary or memorabilia. Some temples had a portico only in front and these were known as prostyle temples. Others had a portico front and rear and these were known as amphiprostyle.

A great many temples were built by these pre-Christian Romans. The most noteworthy at this time are:

**The Temple of Julius Caesar** faced the Forum Romanum Magnum and was built by Augustus in the year 42 B.C. History claims that this was the site where Caesar's body was cremated in the presence

of a grief-stricken public. This was the first temple that was dedicated to a mortal.

**The Temple of Vesta** also faced the same Forum and was built about 205 A.D. It was the most venerated of all temples in Rome. The cella contained a sacred fire, which was kept alive by the Vestal Virgins, the Roman Goddess of the hearth. They lived under strict supervision in the House of the Vestal Virgins nearby.

The Vestals were selected at age six to ten from among the noble Roman families and were not subject to the common law, while enjoying many privileges and political importance. At public games, they sat in the seats of honor. A strong similarity has been noted between the House of the Vestal Virgins and the later Christian Nunnery, due to the admission ceremony, the vow of chastity, clipping of the hair and the garments that they wore. They watched over and kept alive the sacred fire in the temple. The fire was considered to be the source of Roman life and power. If the fire was allowed to go out, the Vestal in charge was scourged for her carelessness. If the Vestal violated her vow of chastity, she was condemned to death by being buried alive.

MassDOT Alerts Drivers  
Bus-on-Shoulder Testing on Section of I-93

Intermittent Field-testing with Empty MBTA, Massport and MVRTA  
on Shoulder of I-93 between I-95 and Somerville  
Testing to Continue About Three Weeks

The Massachusetts Department of Transportation (MassDOT) started additional field-testing for the viability of allowing buses to travel in the breakdown lane of I-93, between I-95 and Somerville on October 20, 2021

This testing will last approximately three weeks, occurring on weekdays only, and will involve Massachusetts Bay Transportation Authority (MBTA), Merrimack Valley Regional Transit Authority (MVRTA), and Massport's Logan Express buses. Motorists on I-93 may observe empty MBTA, MVRTA and Logan Express buses traveling in the breakdown lane during the morning on I-93 southbound and in the afternoon on I-93 northbound. The bus on shoulder travel area is 7 miles long in each direction and the MBTA estimates the MBTA Route 354 bus currently gets in traffic congestion for 15 to 20 minutes on I-93. The Bus-on-shoulder route would allow buses to bypass this congestion. No motor vehicle travel is permitted in breakdown lanes with the exception of buses involved in the field-testing.

MassDOT is advising drivers to be aware of buses traveling in the breakdown lane — digital message boards and signage will also alert drivers to testing.

Driver should continue to use the lane in case of emergency or a roadway incident. Should bus operators involved in field-testing encounter obstructions in the breakdown lane, they will safely maneuver to return to the mainline, pass the obstruction, and return to breakdown lane use.

Following several weeks of field-testing, information will be evaluated to determine longer-term viability and potential next steps.

MassDOT and the MBTA have been increasingly taking steps to improve the efficiency of traveling on buses. For example, this past June, MassDOT and the Cities of Medford and Somerville

announced the implementation of a municipal dedicated bus lane pilot between the hours of 6:00 a.m. and 9:00 a.m. on Mystic Avenue. In summer 2020, the Cities of Medford and Somerville were awarded a grant from the Baker-Polito Administration's Shared Streets and Spaces Program to implement a "quick-build" morning peak hour inbound dedicated bus lane, as a trial, on Mystic Avenue.

Other steps taken by MassDOT and the MBTA include the installation of a dedicated bus lane on the Tobin Bridge for southbound buses and a partnership with the City of Boston and the MBTA to install dedicated bus lanes on major routes of travel including a section of Washington Street in Roslindale.

Dedicated bus lanes are effective in increasing the efficiency and reliability of public transportation, decreasing delays, and improving access to regional jobs and other essential services.

## Universal Man ... Davinci's Soul Reborn

As the seasons change, and we are heading into the colder winter months, now is the perfect time to pause and reflect on all that is good and decent that is going on in life...viral antibodies are up, everybody's favorite sports legend just scored his 600th touchdown, the holiday season is right around the corner, and we are at the early onset of an international cultural revival that has been many, many years in the making. To build upon these fine and positive points, while offering a little homage to our shared Italian ancestry, this seems like an appropriate moment and place to champion the works and creative spirit of someone, I would call "special"...not only out of a patriarchal motivation, but from an integral approach as well...

Once upon a not-so-distant time, on the North End's Salem Street dwelt a passionate and talented young artist named Richard Aliberti. Richard opened up a gallery where he honed his design and sculpture skills to the delight and bemusement of many people and establishments the neighborhood. In some ways and with semblance to the pantheon of artists that preceded him, Richard earned a living through private and public commissions, creating functional and decorative art, and maintaining a gallery which was frequented by locals and distant travelers alike who were presented, with his work, something reflective of classical forms and concepts.

*Post-Gazette* readers of all ages may have walked past the churches at Hanover Street and North Square, once or a thousand times, dined in cafe Paradiso, or taken a language or dance class at the Dante Alighieri cultural center nearby in Cambridge. All the while, it is quite possible, even likely, you never took note of where the art on the walls or exteriors originated...Richard played a lead part in all of that. And if you are anything like me, his artistry and some of the deeper thoughts and ideas it is capable of evoking may have been missed on first or second glance. Yet, I maintain that it is well worth making a little time for a closer examination... Not merely as an exercise in aesthetic valuation or appreciation, but for the value that may be gleaned through the process of thoughtful contemplation, awareness expansion, and what may likened to the phrase "inner work."

What I am getting at is personal, but transcendent of that also; Richard calls me his son, after all. Perhaps the narrative around these ideas will take quite a while to work out; probably a lot more than what one could set out to achieve with a short article like this, but it is a story worth sharing all the same. As a young person and now comfortably into my adult years, I have found inspiration, imaginative sanctuary, and a wellspring of creative ideas from looking at and studying some of the cultural treasures and wonders that are rooted during the Italian Renaissance . A formidable pillar along this storied path has been a book authored by Richard entitled "Universal Man".

Initially published in 2019, the concise work of literature offers readers an illustrated glimpse into the lives and times of the Italian Renaissance with a special focus. The book's subtitle reads "Davinci's Soul Reborn." One of the things making this work a little different than all the rest is that it has been told from the perspective of a

living, practicing artist in the post-modern era. For generations, much intrigue and mystery has surrounded the famed creative mind that was and is Leonardo. Our story, with a bit of help from the Divine, may play a small part in reawakening peoples' appreciation of the same Spirit that Davinci and his contemporaries were working with and inspired.

A friend once told me the word "Rinascita" is rebirth in Italian and another closely linked term "Uomo Universale" or Universal Man, was an ideal aspired toward by many of the old masters, including our hero Leonardo of Vinci. In today's technical and digitally accelerated culture, I find that it often helps to pause and take some time to behold and appreciate the finer things life has in store for us & at a pace attuned with Nature. In doing so, one may discover that a fresh and renewed perspective is one of life's greatest treasures. Richard's work is one avenue toward that end. Perhaps you may behold what I am describing. If you should find yourself in the presence of one of his pieces, perhaps the understanding will be found in the seeing. On my way to work in the morning, jack-o-lanterns grin from doorsteps and cloth ghosts wave playfully from porches. At night, the ominous dark sky and whispering winds propel me indoors to my cozy home, surrounded by soft light and the scent of baked goods. Yes, the time has come for Halloween, the spookiest night of the year, when witches and ghosts and vampires depart our collective subconscious and enter the realm of the everyday world. During Halloween, nothing is what it appears to be, and the day pulsates with a mysterious, spine-tingling energy. Halloween remains one of my favorite holidays, not just because of the oh-so-welcome prevalence of chocolate, but also because it brims with a sense of wonder and possibility over all that is unknown and unexplainable. At times macabre, and often bizarre, Halloween has an equally colorful origin story. The feast as we know it today took an intriguing and complex journey across continents and ancient traditions in order to morph into the modern Halloween. With roots in a pre-Christian harvest festival and its strong association with the Catholic feasts of All Saints and All Souls, Halloween boasts a history full of fascinating twists and memorable customs.

The story of Halloween begins with the ancient Celts, who celebrated a holiday known as Samhain (pronounced sow-en, where “sow” rhymes with “cow”) on November 1<sup>st</sup>, with festivities commencing on the preceding evening. Samhain was considered the first day of winter, and some scholars theorize it may have functioned as the Celtic New Year. Samhain represented a time of uncertainty and fear for

the Celts: the harvest had just finished, and the cold days of winter were quickly approaching. A good harvest meant the difference between life and death for their agriculture-based society, so the Celts prayed for a successful crop. As nature itself appeared bare and barren on the blustery days of early November, Samhain retained a potent connection with death. Indeed, the Celts believed that the veil between the world of the living and that of the dead proved especially fragile on this transitional night, and that both good and bad spirits wandered the Earth during Samhain. Celts built bonfires and donned frightening costumes to deflect these spirits, and costumes continue to form an indelible part of modern Halloween. The Celts also hoped to ward off evil spirits by carving jack-o-lanterns, or hollowed turnips etched with eerie faces and illuminated by a candle inside. When Irish immigrants arrived in North America in the nineteenth century, they carried over this custom, substituting the pumpkin for turnips. Due to the fluidity between the worlds of the living and the dead, Samhain also served as an especially appropriate time for divination. Girls would toss apple peels over their shoulders in order to determine the initial of their future spouse, and people interpreted bonfires for omens concerning the harvest. Meanwhile, unsettling stories of ghosts returning to visit the living could also be found among our ancestors in ancient Rome, who held feasts to appease the *lemures*, or restless spirits.

Samhain, the pre-Christian holiday commemorating the end of the harvest and the specter of death, received another slew of customs when it merged with All Saints’ Day and All Souls’ Day, two Catholic feasts which likewise honor the dead. As Christianity spread across Europe in the early Middle Ages, the Church eventually attached All Saints’ Day to the date of November 1<sup>st</sup> in order to bring a religious context to Samhain. All Saints’ Day was also known as All Hallows, and the name of the previous evening, All Hallows’

Eve, transformed into the name Halloween. While All Saints’ Day revered the memory of deceased saints, a new holiday situated on November 2<sup>nd</sup>, All Souls’ Day, sought to honor all the faithful departed. The popular practice of trick-or-treating harkens back to All Souls’ Day. During the medieval tradition of *souling*, beggars and children would traipse door to door and receive spiced cookies known as soul cakes in exchange for prayers on behalf of the household’s dead. Modern Italians do celebrate Halloween with all the usual trappings of witch decorations, glowing pumpkins and haunted attractions, but All Souls’ Day remains the most significant festival of the dead in that country. On *il Giorno dei Morti*, or day of the dead, Italians visit and clean graves and attend special Masses for the deceased. In villages across the countryside, grandparents whisper bone-chilling tales of lost travelers who stumble into a church service on the night of All Souls and notice that the pews are lined with the wraiths of long-gone townsfolk. In some regions, children may leave offerings of food for wandering souls on All Souls’ eve and find treats the next morning. In other areas, people munch on *ossa dei morti*, or nutty spice cookies whose creepy name translates to “bones of the dead”! I vividly remember learning about *el Día de los Muertos*, or the Latin American Day of the Dead, in my Spanish class and making a cinnamon-topped anise bread known as *pan de los muertos*. It seems that spooky holidays know no geographical bounds!

On Halloween, I love to honor old traditions. I keep the ancient motifs of harvest’s end and the pervading sense of the unknown in my mind as I celebrate Halloween in a folksy, homey manner. A wooden wreath sporting jack-o-lanterns and black cats adorns my door. I bake a pumpkin bread swirled with a ribbon of cream cheese every year, letting the autumnal scent of the spices pervade my kitchen. After handing out candy to trick-or-treaters, I snuggle with a cup of tea on my living room couch, watching special Halloween programs with my husband. These traditions combine to make Halloween one of my favorite and most meaningful holidays. Some people may be put off by the emphasis on death, but this actually stems from the customs of olden, earth-based festivals. As withered branches howl against the dark late October nights, it is no wonder that the ancient Celts turned to matters of mortality and legends of restless ghosts at this time of the year. However, Halloween also functions as a sort of new year, emphasizing the fact that the year is a cycle, with the sun and nature soon returning. By acknowledging the mysteries of the world and their place in the dark half of the year, we can truly learn to appreciate the light. **Happy Halloween!**

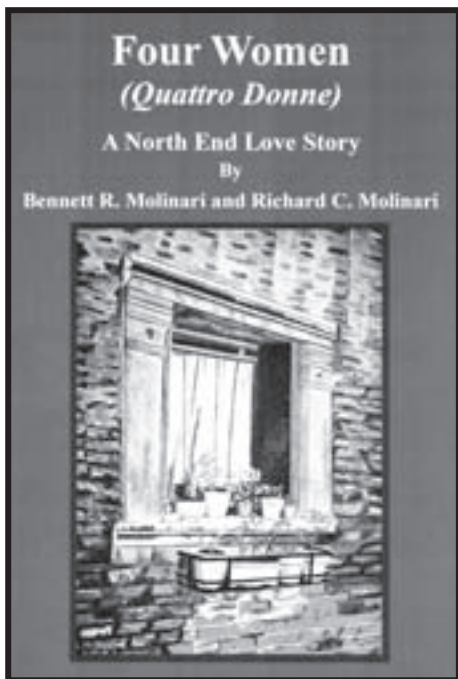

Growing and Reblooming Moth Orchids

Brighten your indoor décor with beautiful blooming orchids. These living bouquets provide months of beauty with minimal care. Just provide the proper growing conditions and success is sure to follow.

Start with a *Phalaenopsis*, moth orchid, that is best suited to the home environment making it the easiest to grow. Purchase a healthy plant with green leaves, a few open flowers, lots of buds on a firm green flower stem and no signs of neglect.

Provide your orchid with proper care, similar to that of an African violet, for the best results. Water thoroughly with room temperature tap water just as the planting mix is beginning to dry. This is usually once a week in most indoor gardens. Pour off any excess water that collects in the saucer to prevent root rot.

Grow your moth orchid in a bright location near an east — west — or slightly shaded south-facing window. Plants do best when they receive 12 to 14 hours of bright light. Give plants growing in low light locations a boost with artificial light. Keep lights 4 to 10 inches above the plants. Placing the plants on a reflective surface helps bounce light back up into the lower parts of the plant. Look for one of the many economical, energy efficient and attractive options for sale. Keep the lights on for 14 to 16 hours if this is the only light the plant receives. You can reduce the time to five or six hours for plants receiving natural light.

Boost the humidity around your orchid while creating a beautiful display by placing it among other indoor plants. As one plant loses moisture from its leaves, it increases the humidity around the neighboring plants.

Use gravel trays to further increase the humidity around all your indoor plants. Fill the saucer or plant tray with pebbles. Set the pots on the pebbles, elevating them above any water that collects in the saucer. When you water thoroughly the excess collects in the saucer. As it evaporates, it increases the humidity around the plants right where it is needed.

Fertilize actively growing

plants when the soil is moist. Use a dilute solution of a complete fertilizer such as a 20-20-20 labeled for use on orchids or flowering houseplants. Avoid excess fertilization that can cause damaged black root tips, green floppy growth, and prevent flowering.

Once your orchid finishes flowering, continue growing it in a brightly lit location and water and fertilize as needed. You can either remove the faded flowers, leaving the flower stem intact and wait for a flush of smaller flowers at the tip of the stem or cut the flower stem back above either the second or third node, the thickened part of a plant stem where new growth appears, from the bottom. A third option is to cut the flower stem back to one half inch above the leaves. This is better for the health of the plant. It results in the best reblooming

and allows the plant to restore energy used for flowering and focus on growing roots.

If forcing your orchid to produce a second flush of flowers seems like too much work, just treat it like a long blooming bouquet. Ease your guilt by gifting the plant to a fellow gardener that would be happy to accept the challenge. Then invest in a new and different orchid to brighten your indoor garden.

# Nanna & Babbononno

A Nostalgic Remembrance



On October 2<sup>nd</sup>, Boston English High School celebrated its 200<sup>th</sup> anniversary. The celebration was virtual due to the the COVID virus still being with us. I was looking forward to attending a get together, but it didn't happen. My brother-in-law and sister-in-law celebrated their anniversary on the same day and I became involved with family rather than former classmates. I tried to zoom in on the virtual 200<sup>th</sup>, but I couldn't get through. Too ease my frustration, my sister-in-law cut me a second piece of her anniversary cake. It worked.

On the 5<sup>th</sup>, I attended a once-a-month luncheon held by English High grads. All of them said the same thing about the virtual reunion ...they couldn't get through either ... so I knew it wasn't just me. Oh well, maybe by next year I will be able to shake the hands of some of my old pals at an actual reunion.

Coming from East Boston and living around the corner from East Boston High School, how did I wind up going to English High? Well, it's a long story that begins with my father's choices in life. Dad was a musician, playing with the big bands, the swing bands, of the '30s and '40s. When I was born, he got off the road and settled in back home in Boston, playing at a night club with a dance band. A friend advised him to look for a day-time career and also to continue playing music as a sideline. Dad taking his friend's advice, took the exams that would allow him to teach shop in the Boston schools. You needed a degree to teach, but trades people could teach with a seven year background working in their specific trade.

Dad had graduated East Boston High with a background in machine shop. He worked sporadically in the trade until he switched to music full time. When he applied to the Boston School Department for a position, he was able to prove he had more than seven years experience in the metals trade. They offered him a job, ironically teaching machine shop at his old alma mater, East Boston High School.

Fast forwarding to the spring of 1953. I was graduating from the Joseph H. Barnes Junior High School and wanted to head to East Boston High with the majority of my friends. Dad having taught there early in his teaching career, said, "NO." He gave me three choices: Boston Latin, Boston English or death.

I had a cousin who attended Latin but he was the type of kid who wore ear muffs in the summer, and I didn't want to be linked with him in any which way ... so, Latin was definitely out. Death seemed too permanent, therefore, English High won out. There were a couple of older teenagers in my immediate neighborhood who attended English High, played football for the school, and were quite popular. Seeing this, in the spring of 53, I applied for entrance to English.

Latin was and still is the oldest school in the country. It was

established in April of 1635 as an exam school for young gentlemen from Boston and offered them a classical education from grades 7 through 12.

English High was established in 1821, two hundred years ago. It was not an exam school, nor was there a tuition attached to attending. It was open to any boy from Boston who wanted to attend high school, and 135 years later, I was one of them. Back in my day, future students were interviewed by representatives of the high school. The man who interviewed me was Bill Stuart, a lovable straight-shooter who was the school's football coach for more than a generation.

I began my high school career in a building located on Montgomery Street in Boston's South End. It had been a fashionable neighborhood back in the day, but by the time I got there it was a slum. Today, it is fashionable once again. The school building was on its last leg, and after my first year, in the spring of 1954, English High moved to Louis Pasteur Avenue right across the street from its long standing rival, Boston Latin.

When Babbononno cross examined me about what I was going to study in high school, I explained English's curriculum to him. He was disappointed that they didn't offer any form of trade shop to their students. I tried to explain that an education from English High prepared one for business or college, but he thought that both were a waste of time. He had taught me how to use hand tools to work with wood, and was hoping I would take after him in his trade of furniture making. Dad tried to convince him that I was studying to go to college, but Babbononno thought that college was a waste of time, too. He felt that a trade was what I needed.

I was not a great student. Actually, I got by-by the skin of my teeth. I was working as an usher at the Seville Theater,

playing CYO baseball, playing American Legion baseball, and in my free time, hanging on a street corner. As I said, I got by-by the skin of my teeth.

In the spring of '56, I graduated and said good bye to the friends I had made at English High, boys from all over the city ... kids from other ethnic backgrounds and races ... something we really didn't experience in East Boston back in the day. I had not taken the SAT exams which prepare you for college entrance and didn't know what I was going to do after graduation and thought about joining the Marines. A friend called to tell me his father got us a job working on construction for \$15 dollars an hour (a fortune back then). He was going to drive a bull dozer and I was going to drive a tractor. The next day when we got to the job site, they handed him a pick and me a shovel, and at the end of the day, I went home with the palms of my hands covered with blood blisters.

Babbononno saw my dilemma and filled a basin with warm water and Epsom salts and told me to soak my hands. When Dad arrived home is a suit and tie, I looked at him, showed him my hands and said, "Dad, you were right; I wanna go to college."

Italy's Aosta Valley or *Val d'Aosta* is renowned for its *Fontina* cheese. This amazing cheese gets its unique flavor from both the Valdostane' cow, and the grass that grows on the mountainside. Val'd Aosta has several signature dishes, and its most famous meat dish is the *Costoletta alla Valdostana* or Veal Valdostana, a breaded veal cutlet stuffed with Parma Prosciutto and Fontina cheese.

Veal Valdostana is an absolutely amazing dish. Though my Nonna made veal cutlets often, she usually saved making the Valdostana for a Sunday dinner or special occasion. This dish is so delicious that it graces the menus of many well-known Italian restaurants. Though it may appear difficult to create, it is actually quite simple to make and its. This is the version of *Costoletta alla Valdostana* I always make, just as my Nonna once made, and I assure you, it's simple but an absolutely fabulous dish!

**VEAL VALDOSTANA**  
*Costoletta alla Valdostana*



6 slices of veal cutlets  
6 to 8 slices of fontina cheese  
6 to 8 slices prosciutto  
3 to 4 large eggs, beaten  
1 to 1 ½ cups all-purpose flour

1 ½ to 2 cups seasoned Italian  
bread crumbs  
1 ½ sticks butter  
1 to 1 ½ cups olive oil  
Salt and pepper, to taste

Preheat oven to 375°.

Take each veal cutlet and pound between two pieces of wax paper, until thin. Lay cutlets flat and place a piece of fontina and prosciutto on cutlet, fold cutlet in half and be sure to tuck in ends to seal.

In a large bowl, add beaten eggs. In another large bowl, add flour. In a third large bowl, add bread crumbs. Place the bowls together side by side, then dredge the veal cutlets in flour, dip in egg, then place in breadcrumbs and using your hands, be sure to coat well with the breadcrumbs.

In a large skillet, heat ¾ cup of the butter with ¾ cup olive oil over medium-high heat. Sear cutlets until golden and crispy about 5 minutes each side. Transfer skillet to preheated oven and cook for another 5 to 8 minutes, just to be sure the meat is cooked through. Do not overcook or they will be dry. *Buon Appetito!*

**Southwest Airlines Flips on Vax Mandate**

Southwest Airlines has dumped its plan to put unvaxxed workers seeking religious or medical exemptions on unpaid leave starting in December if their requests haven’t been approved by them.

The airline stated in a memo on October 15<sup>th</sup>, that if their exemptions weren’t approved by the December 8<sup>th</sup> deadline, they could continue to work until their applications are reviewed.

When Pedro Slam Dunked the Gerbil, Who Can Forget It

One of the all-time strange and disturbing moments in Major League Baseball history occurred in game three of the 2003 American League Championship Series. The series between the Boston Red Sox and arch-rival New York Yankees would go to the bleeding edge, with the Yankees winning the pennant on Aaron Boone's 11<sup>th</sup> inning home run off knuckleballer Tim Wakefield in the 7<sup>th</sup> Game.

Game three matched up all-time greats Pedro Martinez and Roger Clemens at Fenway Park. The Red Sox got two runs in the first inning off Clemens on a two-run single by Manny Ramirez, but as always, New York crawled back into the game. Karim Garcia got a one-run single in the second inning, and then in the third inning, future Hall of Fame shortstop Derek Jeter hit a home run to tie the game.

The Red Sox couldn't come up with any runs of their own, as the Rocket settled down after a tough first inning. The Yankees would pull ahead in the top of the fourth. Catcher Jorge Posada would lead off with a walk, then first baseman Nick Johnson would single off the Green Monster to make it first and second with no one out. Hideki Matsui a/k/a Godzilla, in his first season over from Japan, then hit a ground rule double into the right field stands to go up 3-2.

There were runners at second and third with nobody out, with light-hitting utility player Karim Garcia coming up to the plate. Martinez appeared visually upset about giving up the early 2-0 lead, and was in danger of being given an early hook by manager Grady Little. Pedro lost his composure and apparently hit him in the back to load the bases. Martinez and Garcia glared at each other as Karim started his trot to first base.

The next batter, slugging second baseman Alfonso Soriano hit a ground ball to shortstop Nomar Garciaparra. Garcia proceeded to slide hard into second baseman Todd Walker, who was attempting to complete the double play. A run scored on the twin killing, putting the Yankees up 4-2. The fans in the stands, already restless over giving up the lead, were calling for Garcia's head.

Garcia started yelling at Martinez as he walked back to the bench. Pedro was also jawing at Yankee catcher Jorge Posada, who had come out of the dugout in his catcher gear to defend his teammate. Martinez then pointed at his own head, then at Posada, then back at his own head. This was perceived to be a threat that he would also throw at Posada's head in his next at-bat. Pedro would later state that it just meant he thought Posada was stupid for thinking he would throw at Garcia on purpose, who was a .241 career hitter.

Leading off the bottom of the 4<sup>th</sup> for the Red Sox was big bopper Manny Ramirez. On a 2-1 count Clemens threw a pitch high and tight to back Ramirez off home plate. Manny took offense to this, and started towards the mound, hemming and hawing. The dugouts cleared, and Martinez sprinted out towards the field from the dugout with the rest of the players.

Suddenly, 72-year-old Yankees Bench Coach and baseball elder Don Zimmer rushed Pedro and tried to swipe at the ace's head with his left hand. Pedro grabbed Zim by the melon with both hands and tossed him to the ground. Zimmer rolled to a halt, as the spectacle was almost enough to stop the brawl. Zimmer clearly thought Pedro was head hunting.

The coach was taken by stretcher out of Fenway Park to a hospital for precautionary reasons.

Zim had a reason to be upset. Back when he was batting in the minor leagues, he was struck in the head by a pitch. He was knocked unconscious and was taken to the hospital, where he would require two operations to remove blood clots. He would remain in a coma for two weeks, and the severity of his injury was the reason Major League Baseball made batting helmets mandatory.

When the dust settled, the Yankees were still leading 4-2, despite Pedro's strange slam dunk. The Red Sox would score a run on a ground ball double play by Trot Nixon in the bottom of the 7<sup>th</sup>, but ace closer Mariano Rivera would take the cake, coming in the bottom of the 8<sup>th</sup> inning to get the last six outs. The Yankees won 4-3 to take a 2-1 series lead. The image of Pedro grabbing Zim by the head and tossing him down like a weeble-wobble will live on as an infamous and surreal moment in one of the greatest post-season series ever, even though it ended tragically for the Sox and their long suffering fans.

JACK SHARKEY and PRIMO CARNERA

Birthday Boys



Primo Carnera

Jack Sharkey and Primo Carnera share the same birthday, October 26<sup>th</sup>, though Jack was born in 1902, while Da Preem made his entrance in 1906. The pair would meet two times in the ring with their second match being for the Heavyweight Championship. I'm not sure if two birthday boys ever fought for the crown before or since but found it an interesting fact that they did.

When they met the first time it was shortly after Sharkey had lost in his bid to win the title vacated by Gene Tunney. He lost to Max Schmeling who claimed a foul in the match and thus became champion while on the canvas. A year and a half later Jack would defeat Max via decision. This gave Schmeling the distinction of being the only heavyweight champion to win the title while on the deck and lose it while on his feet.

After the loss to Schmeling, Sharkey took on middleweight champ Mickey Walker who gave him a tough go of it in a fight the ended in a draw. Mickey weighed 169 1/2 pounds to Jack's 198 1/2.

Three months later on October 10, 1931, Sharkey and Carnera fought for the first time in a scheduled 15 round contest. At the time the giant from Italy was being billed as a superman and he weighed in for the fight at 261 pounds.

As for the fight, it was a very one sided affair with Jack doing a number on Carnera. *The Associated Press* reported: "Before the Boston sailor's hand was raised in token of victory after 15 rounds of spectacular milling, Sharkey had floored Carnera for one nine-count, closed one of the Italian's eyes and had given him so savage a beating that Primo was on the verge of a knockout on a half dozen occasions."

It's interesting to note that Sharkey had such a difficult time with Walker whom he had almost thirty pounds on while he easily handled the gigantic Carnera who had sixty pounds on him.

This win led to the rematch Jack had with Max, and after gaining the title he made his first defense against Carnera. Primo had fought 29 times after his loss to Sharkey, losing only twice. All of those fights took place in the span of a bit more than a year.

In the fight before the match with Sharkey, Carnera took on a protégé of the Champ's, Ernie Schaaf. The fight would prove tragic as Ernie went down from what appeared to be a light jab but died later. Many have attributed his death to the beating he had taken from Max Baer three months earlier.

The title fight was quite a bit different from their first encounter with Carnera kayoing Jack in the 6<sup>th</sup> round. Many have believed Sharkey took a dive in the fight, but Sharkey denied doing so till his dying day. "I'd never have done anything like that. I was raised Catholic. I was raised to be honest," he said late in life. He added, "I was on top of the world. Why would I purposefully lose?"

Most of the sportswriters who attended believed the knockout was legitimate. If so, it was certainly a much improved Primo Carnera who fought that night.

I don't know if the two exchanged birthday greetings over the years, but it would be nice to think they did. Primo died in 1967 at the age of 60, while Jack lived until 1994 and passed at the ripe old age of 91. As to whether or not the fight was fixed? You'll have to watch the film of it and decide for yourself.

HOOPS and HOCKEY in the HUB

**REMEMBRANCE OF A SERIES PAST** — The recent elimination of the Red Sox by the Houston Astros in the American League Championship Series brought to mind a somewhat similar occurrence involving the Boston Celtics.

When the Red Sox posted a pair of one-sided victories over the Astros early in the ALCS, talk was rampant among those in Red Sox Nation about a looming Boston pennant triumph and the return of the World Series to Fenway. But such was not to be as Houston rallied to win the next three games in a big way and is now playing the Atlanta Braves in the Fall Classic.

It was not that long ago — many may recall it once their memories are jogged — that a somewhat similar situation had occurred involving the Celtics during the 2018 NBA Eastern Conference Finals. It was then that the C's faced the Cleveland Cavaliers in a seven-game series that would send the winner forward to the NBA Finals.

In the opening contest at the Garden, the C's posted a one-sided 108-83 victory over the Cavaliers, who were led by NBA megastar LeBron James. However, in this opening encounter the C's Jaylen Brown led all scorers with 23 points while Kevin Love was the high scorer for the Cavs with 17.

Two nights later, it was more of the same as the Green and White recorded another big win at the Garden, a 107-94 triumph over Cleveland. Once again, Brown scored 23 to lead the Celtics.

But danger lurked on the horizon. Despite the 2-0 Boston lead in games, James had come alive in that second contest, pouring in 42 points. In the post-game press conference, we recall James saying that he was not overly concerned about losing the first two games of the series.

Some took that statement as a mark of bravado. But it wasn't. In each of the remaining five games James would be the leading scorer and the Celtics would ultimately wind up sitting on the sidelines.

Sure enough, when Game Three was played on the shores of Lake Erie, it was James who found the range for 27 tallies as the Cavs won by 30, 116-86.

A couple of nights later, he poured in 44, leading Cleveland to a 111-102 win. Just like that, the series that once seemed like it was almost in the bank for Boston was now even at 2-2.

Back to Boston, it went for Game Five where the C's managed to hold James to 26 points, prancing off the parquet as 96-83 victors and putting Cleveland on the brink of elimination.

However, some teams do not sink while on the brink. This would be one of those times. In Cleveland for Game Six, James rose to the occasion, torching the nets for 46 points — his highest one-game total in the series — as the Cavs beat Boston 109-99.

It was home to the Hub for a decisive winner-take-all Game Seven at the Garden, whose comforting confines had enabled the princes of the parquet to win every postseason game in the spring of 2018 that had been played upon its surface.

Someone neglected to tell the Cavs about that. In a low scoring, defensive game that featured eight ties and nine lead changes, James hit for 35 points in the 87-79 Cleveland victory. The setback was a bitter pill for the C's since it marked the second year in a row that they had lost to Cleveland in the Eastern Conference Finals. In 2017, the Cavs had won the series, 4-1.

The fall of 2021 and the spring of 2018 will be remembered for two teams — the Red Sox and Celtics — who counted their chickens a bit before they hatched. But the opponents were the ones who eventually closed the latch, preventing the defeated from engaging in a future match.

And finally, it is a bit of a stretch but there is a Boston angle to the current World Series. People of a certain age will recall that the Braves of the National League were once based in Boston. Their last season on the diamond in the Hub was in 1952 — with the franchise moving to Milwaukee for the start of the 1953 season. They became the Atlanta Braves in 1966. The athletic area now known as Nickerson Field — the one ringed by dorms at Boston University is the approximate location of Braves Field where the team played its home games.

The last time the Boston Braves played in the World Series was in 1948, when they faced the Cleveland Indians. The Braves featured the dominating pitching duo of Warren Spahn and Johnny Sain, who won a combined 39 regular season games that year. Their performance is remembered for all time in baseball lore through the saying "Spahn and Sain and pray for rain."

An interesting footnote is that the Indians gained the World Series by defeating the Red Sox in a one-game playoff at Fenway Park for the American League pennant. If the Red Sox had won, Hub fans would have enjoyed an all-Boston "subway series."

Del Crandall, who joined the Braves at age 19 as a catcher in 1949 and also was behind the plate for the 1950 season before leaving to serve in the Korean War, was the last living member of the Boston Braves. Overall, he played 16 seasons in MLB (11 with Milwaukee), serving as Spahn's battery mate in 316 games over the years. He died this past May 5<sup>th</sup> in Mission Viejo, California at age 91.

There are still some fans that are fond of the Boston Braves. Consult "Boston Braves Historical Association" on the internet for more information.

**WINNING WAYS** — Over the long haul the Bruins are proven winners, especially when it comes to holding a lead in regular season games. Through games of October 26<sup>th</sup>, the Bruins owned a superb 318-17-29 record in all games where they took a lead into the third period — since the start of the 2010-2011 season.

In a similar vein but starting with the 2011-2012 campaign, the B's possessed a 345-21-20 mark in games where they held a two-goal lead at some point in the contest. In games where they held a three-goal lead at some point resulted in a sterling 223-2-6 record.
