
ATLAS, OTHER VERSIONS

Stories about Atlas are told at least three times in tales from mythology. The first one identifies him as a son of the Titan Iapetus. Atlas supported the Titans in their war against the forces of Zeus, and of course we know that the Titans were defeated. As punishment, Atlas was forced to hold the heavens on his shoulders for all

eternity.

The second story is quite involved: It starts with three sisters called the Gorgons. They were awful beings, with hair and girdles of snakes, and anyone who gazed upon them was immediately turned to stone. One sister, named Medusa, was mortal, but the other two were immortal. Perseus, a Greek hero, was successful in a mission to cut off Medusa's head, and was bringing it back to his homeland in a leather bag. After traveling for a full day he came upon the realm of King Atlas. The king was a huge man, who possessed great wealth in herds and land. Most precious to him was a beautiful garden which contained golden fruit, hanging from branches of gold.

RUFFLING FEATHERS

In September 2013, Aflac, a nationally known insurance company, filmed its mascot "the Aflac duck" walking around a New York City subway station during rush hour as part of a new television commercial. Did anyone ever see this commercial? Did it boost sales of Aflac's supplemental insurance? The answer to both questions is "no."

The reason? Within minutes of the footage appearing on various social media outlets, the animal rights advocacy group, PETA issued a statement that "a subway station is no place for a duck ... we're hopeful that in the future Aflac will leave live ducks out of its publicity stunts and use its creative power to come up with a kinder way to grab the public's attention.

When an Aflac spokesman was asked that, given the negative feedback, would the company think twice before taking a farm animal into the subway again, he replied, "Absolutely! We didn't mean to ruffle any feathers."

Fast forward one year to New Year's Eve 2014. Aflac unveils a new mobsterthemed television commercial that has the Aflac duck kidnapped by mobsters and

taken for a ride in their or violent since the early limo. One of the actors is that perennial character actor cum "gangster," Frank Vincent of The Godfather and "The Sopranos." The thugs pat down the duck; threaten it; and then shove it from the moving limo.

The Sons of Italy Commission for Social Justice® and other Italian anti-defamation groups contacted Aflac, charging that the commercial stereotypes Italian Americans. Our complaints were ignored as was our request to remove the commercial from the air. Talk about "ruffling feathers!"

Is Aflac more responsive to the treatment of a duck than to the sensibilities of an estimated 18 to 26 million people of Italian heritage? So it seems and unfortunately, Aflac doesn't stand alone. Thanks to the relentless stereotyping of Italian Americans by the media, entertainment and advertising, 74% of adult Americans believe that most Italian Americans have "some connection" to organized crime, according to a poll by the Princeton-based Response Analysis Corporation.

Italian Americans have been battling the typecasting of them as boorish and/

1970s and yet, as the Aflac commercial demonstrates, the stereotyping is as prevalent as ever. Why is that?

Part of the reason is that as European Americans, Italian Americans are considered members of the protected white majority. As such, it is assumed that we do not suffer prejudice or discrimination in housing, employment, and education. No discrimination? Then no sympathy when we protest about commercials like Aflac's or television shows like "The Sopranos." "You've made it," is the typical response. "What are you complaining about? It's only a movie."

They have a point. We have made it. Italian Americans are one of the nation's biggest success stories. More than a century ago, we came here with nothing, to dig the ditches, build the railroads, highways and skyscrapers, sew in sweatshops and do all the other menial jobs that the more established Americans turned

Columbus and the Last Hope of Mankind *October 3, 2014*

"We do not read even of the discovery of this continent, without feeling something of a personal interest in the event; without being reminded how much it has affected our own fortunes and our own existence. It would be still more unnatural for us, therefore, than for others, to contemplate with unaffected minds that interesting, I may say that most touching and pathetic scene, when the great discoverer of America stood on the deck of his shattered bark, the shades of night falling on the sea, yet no man sleeping; tossed on the billows of an unknown ocean, yet the stronger billows of alternate hope and despair tossing his own troubled thoughts; extending forward his harassed frame, straining westward his anxious and eager eyes, till Heaven at last granted him a moment of rapture and ecstasy, in blessing his vision with the sight of the unknown world." — Daniel Webster, First Bunker Hill Monument Oration, 1825

In Boston we are surrounded by familiar sights — Old North Church, the Old State House, Old South Meeting House, and the other stops on the Freedom Trail — that remind us of Boston's unique Revolutionary War history. At 239 years distance from 1775, we are nearly two-and-ahalf centuries removed from the beginning of the American War of Independence. In like manner, 1775 was a bit more than two-and-a-half centuries (283 years to be precise) removed from Columbus' discovery of the New World. Independence and the Revolutionary War mark not the beginning, but the halfway point in the history of European civilization in America.

In his remarks, quoted above, Mr. Webster, on the 50th anniversary of the Battle of Bunker Hill, traced the origins of the United States not to the Pilgrims and Plymouth Rock (although he mentions them in the oration), nor to the earlier English settlement of Virginia (not even mentioned by Webster), but to Christopher Columbus and his first "sight of the unknown world."

Others came here earlier — possibly the Vikings, maybe other Europeans, and certainly the American Indians who arrived most probably from Asia by land-bridge to Alaska. But Webster — and many of us concur — begins our history with Columbus. All month we celebrate Italian-American Heritage and we celebrate the brave and persevering Italian navigator who opened the way for immigrants from every nation to settle in this New World and create the United States that remains, to quote again from Webster's speech, "the last hope of mankind." This is a phrase that will be echoed by Abraham Lincoln in his December 1862 Annual Message to Congress ("the last best, hope of earth") and Ronald Reagan in his January 1974 "We Will Be a City on a Hill" speech ("the last best hope of man on earth"). God willing America shall continue for many years as a beacon of liberty.





THE FOURTH AMENDMENT AND ITS ATTENDANT RIGHT OF PRIVACY WAS BORN IN THE NORTH END OF BOSTON!

While many Americans consider 1776 as the birth year of our nation, it was actually the signing of the United States Constitution in 1789 and its ratification by the last colony in 1791 that established America's governmental structure. Of the many fundamental rights articulated in the U.S. Constitution, the Fourth Amendment's right to be free from unreasonable searches and seizures continues to be just as contested and relevant today as it was during those revolutionary times on the streets of Boston's North End.

On September 24, 1766 near the present day corner of North Bennett Street and Hanover Street stood "one of the most active merchants on the popular side [who] was proportionately hated and abused by the Crown" named Daniel Malcolm against Benjamin Hallowell, the Comptroller of the Customs of the Port of Boston, and a man named Sheafe, the Deputy Collector. The men approached Malcolm's home with a Writ of Assistance, which was an extremely broad general grant of authority to search a colonist's home without any articulable facts showing reason or cause, specificity, or description of what is likely to be found therein. A Deputy Sheriff was also present to search the home and seize goods that Malcolm allegedly failed to pay as requisite customs duties. The men were greeted by Malcolm with "sword and pistols" and "threats of death" if anyone attempted to search his home.

The officers retreated, and shortly thereafter, the Colonial Council, headed by the Governor, convened to determine what they needed to do to enforce the Writ. The Council determined that they possessed the authority to use any means necessary to enforce the writ and could intervene when necessary. Nonetheless, they determined that their action was not necessary because the sheriff has "posse comitatus" authority, which grants law enforcement officers to command any person to assist them with their duties.

Under the guise of such authority, Hallowell, Sheafe, and the Sheriff returned to Malcolm's home. When they arrived, a "great number of people" greeted the officers and "most credible" members of the crowd informed the officers that if they attempted to enter the house, they "would be in danger of their lives." Meanwhile, Malcolm remained in his home with all the windows and doors shut. The Sheriff approached the crowd and calmly attempted to explain the situation, but members of the crowd demanded that the Customs Officer first attest, under oath, to the name of the informant. The crowd remained firm that the customs officer must swear to the identity of the informer before the warrant can be valid. As the sun slowly fell in the sky, the crowd continued to grow while the discourse between the people and the sheriff continued. Eventually, the officers determined that any further attempts to enter Malcolm's home would be fruitless, and they left the scene without successfully entering his home.

Years later on March 2, 1780, the Massachusetts Declaration of Rights, set these principles down as essential rights of the newly independent Commonwealth. John Adams, a staunch opponent of the

unrestricted searches and seizures, drafted the Massachusetts Constitution and was present at Attorney James Otis's speech in 1761 on the Writs of Assistance. Adams used Otis's language, writing, "every subject has a right to be secure from all unreasonable searches and seizures of his person, his houses, his papers, and his possessions". Today the Fourth Amendment to the U.S. Constitution codifies the right to be free from unreasonable searches by stating that:

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no warrants shall issue, but upon probable cause, supported by oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.

Most recently, on June 25, 2014, the U.S. Supreme Court unanimously ruled that officers must obtain a warrant before searching cell phones and other electronic devices. Furthermore, the Court concluded its opinion by recounting the incidents discussed above stating:

Our cases have recognized that the Fourth Amendment was the founding generation's response to the reviled "general warrants" and "writs of assistance" of the colonial era, which allowed British officers to rummage through homes in an unrestrained search for evidence of criminal activity. Opposition to such searches was in fact one of the driving forces behind the Revolution itself. In 1761, the patriot James Otis delivered a speech in Boston denouncing the use of writs of assistance. A young John Adams was there, and he would later write that "[e]very man of a crowded audience appeared to me to go away, as I did, ready to take arms against writs of assistance." According to Adams, Otis's speech was "the first scene of the first act of opposition to the arbitrary claims of Great Britain. Then and there the child Independence was born.'

Modern cell phones are not just another technological convenience. With all they contain and all they may reveal, they hold for many Americans "the privacies of life." The fact that technology now allows an individual to carry such information in his hand does not make the information any less worthy of the protection for which the Founders fought. Our answer to the question of what police must do before searching a cell phone seized incident to an arrest is accordingly simple — get a warrant.

Similarly and earlier, on February 18, 2014, the Massachusetts Supreme Judicial Court reached the same result disallowing warrantless searches of cell phones under the Massachusetts Declaration of Rights.

Today with police searches of cell phones upon arrest without warrants, the revelations of the NSA surveillance of ordinary Americans, secret warrants issued by the FISA courts, and use of drones, it is enough for every American to question and join the debate over the limits of the government's authority and power. The post-9/11 world has made many Americans all too accepting of these searches. As Americans, let us not forget the United States of America arose as a new independent nation from the oppressive grip of the British Empire's general searches and that these freedoms that helped define America's precious liberties were actually born in the North End of Boston.

Is it Twilight's Last Gleaming for America?



Personally I say not, but one can get pretty depressed by the latest news out of the US Ninth District Court out in San Francisco that ruled recently that students don't have the liberty to wear an American flag tee shirt. I kid you not. It might offend Mexican students celebrating Cinco de Mayo. I am far from alone in calling this a direct assault on the First Amendment and our constitutional Republic.

On this past September 17, more than four years after Live Oak High School in Morgan Hill, California sent students home for wearing U.S flag tee shirts an 11-judge Ninth District Court of Appeals panel ruled it was the right choice to make and was "tailored to avert violence and focused on student safety."

This decision upheld an earlier decision in a three-judge ruling in February that justified the school's actions based on tensions between Mexican and American students. The lawyer for the students said this case will end up in the U.S. Supreme Court. By the way, most of the appeal courts usually get overturned by the Supremes and this one probably will too. Does the school now ban "Obama" tee shirts when they upset conservative students?

You know what's really funny about this recent September 17th ruling? September 17th is a part of U.S. history. On the day the ruling was made, it was the 200th anniversary of the first printing of "The Star Spangled Banner." The song celebrated the Battle of Baltimore in which America defeated the British during the War of 1812, September 17th is also the birthday of the U.S. Constitution which was created on that date in 1787.

Our rights and freedoms were born on September 17, 1787 and defended again on September 17, 1814. Americans long ago founded this Republic and over the generations have fought and died to keep us a free nation.

This latest judicial decision should upset all Americans. It is a time to close ranks. Whether you are liberal, conservative, Democrat or Republican, this court decision violated the very principles upon which America's foundation rests. This is something worth standing together over.

The actions of this federal Appeals Court in San Francisco must not be allowed to stand or our Constitution and Bill of Rights become meaningless!

Saint Angela Merici

Foundress of Ursulines, Angela was born on March 21, 1474, at Desenzano del Garda, a small town on Lake Garda in Lombardy. She was left an orphan at the age of 15 and together with her elder sister went to live at the home of her uncle in the neighboring town of Salo where they led simple and holy lives. When her sister passed away suddenly without being able to receive the last sacraments, Angela was terribly distressed. She became a tertiary of St. Francis and offered her prayers and mortifications for the repose of her sister's soul. In her anguish she prayed God to reveal to her the condition of her deceased sister. It is said that in a vision she experienced, she was satisfied her sister was in heaven.

When she was twenty years old, her uncle died, and Angela returned to her home at Desenzano. Convinced that the great need instruction of young girls in the basic elements of Christian Faith, she converted her home into a school where she daily gathered all the little girls of Desenzano and instructed them on the

TIPS FOR ADOPTING A DOG Breeder vs. Shelter

the type of dog you're looking for, the next question is "where do I go to get my dog?" First and foremost, do not get your puppy from a pet shop. Often those puppies do not come from reputable breeders. You don't want to start your new relationship with your puppy having to deal with socialization issues and other kinds of trauma that puppies in sub-par facilities often experience. You want your first days with your new dog to be joyful and fun. And most important of all, you want a happy, healthy, and well-adjusted dog, not a sick or traumatized one.

Getting a Puppy from a Breeder: There are a lot of reputable breeders all around the country. You should be prepared to ask the breeder some questions. If a breeder is unwilling to show you where their dogs are housed or who tries to avoid questions (such as whether or not the puppy has been exposed to different people while growing up) he might be a backyard breeder or a puppy mill. Please be aware that those puppies can be severely traumatized before you get them. A reputable breeder will ask you questions that will reveal your willingness and ability to care for this dog. They should be quizzing you as much as you should be quizzing them! That shows that the breeder cares about their dogs. The more questions you ask about how the puppy has been raised, the better you will know what to expect. Also, be sure to meet the puppy's mother too. Is she a confident, friendly dog? Her demeanor will be indicative of her puppies' demeanor as they age.

Getting a Puppy from a Shelter: If you do not care about having a purebred dog, then visit a shelter. There are loads of dogs that end up in shelters every year that need a home. Puppies usually go fast, but you can still find them in the shelter!

If you are willing to give your heart to an older dog, you will have a great companion. Most of them are so grateful for just a little walk and the companionship; you could have a great match there!

If you can't find what you are looking for from a local breeder or at your local animal shelter, then you might want to check online. There are lots of reputable breeders online as well. And of course, most shelters have websites too. The most important thing here is that

After you have determined you don't just look at the picture, look at the energy of the animal and ask, "Am I the right owner for you?"

You can ask if the dog has any behavior issues and if those issues are going to be a problem if you decide to adopt the dog. Don't be afraid to look at dogs online. It is a great way to practice energetic communications.

Ask Important Questions: The most important thing here is to ask yourself some questions first, and ask your potential dog a lot of questions. Keep in mind, the dog that runs to you and climbs in your lap is not by default "your" dog or the best dog for you. He just might be the most confident or pushy (or dominant) one.


2014 NEAA FALL SOCCER PROGRAM



The History of Animation: Disney's Golden Features



The rewards from Snow White were many for Walt Disney, but the most lasting one was the funding for a bigger expanded studio. If animated features were going to be his future, he needed a production crew, no two ways about it. The \$8 million success of Snow White made this more than a just a wish upon a star and by 1939 Disney was able to begin building a new studio in Burbank to accommodate his growing staff and needs, who began moving out of the old studio on Hyperion Ave. By the spring of 1940, Burbank had become Walt Disney's official headquarters and remains the studio location to this day.

Artistically, 1940 proved to be Disney's best year. Eager to repeat the success of Snow White, Walt got fast to work on his next animated feature. In February of 1940, the world saw Pinocchio. The critics and audiences were equally thrilled. It could not return the same box-office as its predecessor for a reason that Walt did not foresee: WWII, which closed out much of the European market. But the legacy of Pinocchio has survived its initial disappointing financial success. It remains not only Disney's best work, but also one of the very best animated films of all time. Its chief assets are the unforgettable cast of characters from the little wooden boy who dreams of being a real boy, the enduring popularity of Jimminy Cricket, who expanded his role from Carlo Collodi's story for the film and then became an unofficial story-teller for other Disney works, and a delightful rogues gallery ranging from the amusing (Honest John and Gideon), to the conniving (Stromboli and the wicked Coachman), to the terrifying Monstro the Whale.

More than any other work, Pinocchio proves Disney's insight that story mattered more than anything else in the success of his films and his development of a full-fledged story department proved a smart move. Indeed, Pinocchio is a marvelously exciting film. The story moving at a perfect pace as it balances laughs, fears, and terror. The animation is as rich as ever, making great use of the multi-plane camera as it zooms closer into the village where Geppetto's workshop is. Pinocchio has remained an animated classic in the truest sense and may well be Walt Disney's crowning achievement.

Disney's next feature began life as a Mickey Mouse short. By the end of the 30s Walt saw that his star's popularity was being eclipsed by Donald Duck, who had recently been granted his own cartoon series. With the hopes of reviving the Mouse's fame, Walt planned an elaborate short st to classical music employing all of the new innovations developed during Snow White. For advice on this ambitious venture. Walt met with legendary composer Leopold Stokowski at a gala party and proposed his idea. Stokowski suggested turning the whole thing into a sort of "concert feature" made up of several segments featuring animation set to classical music pieces. It didn't take long for Walt to agree and set to work on the project that would become Fantasia. This was unlike anything Disney (or any other



studio for that matter) ever did before. Like Snow White, it would create the need for new technology, including a process for sound amplification Walt distributed to theaters showing the film, a system he called "Fantasound". It was an anthology film featuring not only the music of different composers but varying animation and designs. Abstract images accompany Bach's Toccata and Fugue in D Minor, dancing flowers, mushrooms, and fish frolic to Tchaikovsky's Nutcracker Suite, the gods of Mount Olympus celebrate a harvest festival before Zeus rains on their party in an interpretation of Beethoven's Pastoral Symphony, Stravinsky's Rite of Spring goes to a prehistoric setting where dinosaurs battle, the originally conceived Mickey Mouse short became an interpretation of Paul Dukas's The Sorcerer's Apprentice, and was one of the best sequences along with the delightfully animated dancing hippos and ostriches set to Ponchielli's Dance of the Hours and the brilliant, intense, and atmospheric images set to Mussorgsky's Night on Bald Mountain.

At first audiences and critics were taken aback at the radical new direction of the animated cartoon, but few denied the artistic beauty and stunning visuals of Fantasia, which is, to my estimation, one of the finest examples of the art of animation and its possibilities.



By the early 1940s, Walt Disney had practically eliminated the threat from rival animators that had kept him on his heels in the 30s. He was the undisputed king of animation for the new decade. Ah, but even in the happiest place on earth, there was trouble brewing and the compartmentalization of Disney's staff created a hierarchy that soon led to resentment among the animators. In 1941, the Disney animators went on strike and Walt lost his principles. He became something of a bullying boss, punishing even his best veteran artists like the legendary Art Babbitt for their participation. The strike of 1941 was a turning point for Disney on a personal, if not artistic level. He became far more controlling of the goings-on within his studio and, perhaps as a subconscious form of revenge against unions, became a testifying voice when Joe McCarthy took his witch-hunt to Hollywood a decade later. But even among trouble, great work was done and two other Disney classics appeared during the strike; Dumbo and Bambi. The strike was ultimately settled while Walt was away on a tour of Latin America as part of the Roosevelt Administration's Good Neighbor Policy. The strike went away, albeit with a price (Walt lost some of his best animators as a result), but on December 7, 1941, American life changed forever and so did the animation industry...and not exactly for the worse either. Meanwhile though, it's worth looking at what was up with the growing looney gang at Warner Bros. animation studio.

Parla Come Mangi! (Speak as You Eat!)

Benvenuti! These recipes will end our trip through Sicily. Tonno in agrodolce (sweet and sour tuna) celebrates the tonno, (tuna fish) as Sicily holds an ancient tradition in tuna fishing in the local tonnare (tuna fishery/cannery) whose presence in Sicily is diminishing due to new fishing regulations. Currently two tonnare are struggling to survive: one is located near Trapani and the other is on the beautiful island of Favignana.

Tonno in agrodolce (serves four)

4 slices of fresh tuna fish about one inch thick 6 Tbsp red wine vinegar

2 tsp sugar Extra Virgin Olive Oil salt and pepper

3 white or red onions

Preparation: sear the tuna slices briefly in abundant oil, then transfer to a plate and keep warm. Finely slice the onions, place them in the same skillet in which you have seared the tuna and cook them on medium-low heat until soft. Bring the heat to medium, stir in the vinegar and the sugar and set aside when well combined. Place the tuna slices in a wide shallow pot so they don't overlap, season with salt and pepper, cover with the sweet and sour onions and let simmer (with the lid on) on low heat for 5 minutes. Arrange on a serving plate and serve hot or cold. Buon appetito

Tonno in agrodolce (serve quattro)

4 fette di tonno fresco alte circa 2 cm 6 cucchiai di aceto di vino 3 cipolle bianche o rosse

2 cucchiaini di zucchero Olio Extra vergine di Oliva sale e pepe q.b.

Preparazione: Preparazione: friggi appena le fettine di tonno in abbondante olio e trasferiscile in un piatto tenendole in caldo. Taglia finemente le cipolle e soffriggile fino ad ammorbidirle nella padella usata per friggere il tonno. Aggiungi l'aceto e lo zucchero. Adagia il tonno in un tegame avendo cura di non sovrapporre le fette, aggiusta di sale e pepe, copri con la cipolla in agrodolce e fai cuocere col coperchio a fuoco lento per 5 minuti. Disponi il tonno su un piatto da portata e servilo caldo o freddo. Buon appetito!

In Sicilian dialect, "pipi ardusi cunzati" means roasted peppers that are "cunzati" ("prepared") with some type of dressing or seasoning. This recipe complements very well the "tonno in agrodolce" or any other "secondo piatto" (second course); it can also just be served as an "antipasto" (appetizer). Preserving the many Italian regional dialects and teaching them to the future generations is both important and necessary.

Pipi ardusi cunzati (Sicilian style roasted peppers)

serves 4

6 red and yellow peppers 1 clove of garlic 1/2 sprig of fresh mint

1/2 sprig of basil 1/3 cup extra-virgin olive oil 1 lemon

Preparation: roast the peppers in a 400 degree oven or directly on a gas stove, when they are dark on all sides, peel them, remove the seeds and cut them into strips. Put them in a serving dish and season them with a sauce prepared by pouring in a bowl the oil, mint and basilica finely chopped with garlic and lemon juice. Mix together everything and let rest for half an hour. Serve with crusty bread toasted.

Pipi ardusi cunzati (peperoni arrosto conditi)

serve quattro

6 peperoni rossi e gialli 1 spicchio d'aglio mezzo ciuffetto di menta

100 ml di olio extra vergine 1 limone

fresca e mezzo ciuffetto di

basilico

Preparazione: arrostisci i peperoni in forno o sulla piastra, quando sono arrostiti su tutti i lati, privali della pelle e dei semi e tagliali a striscioline. Mettili in un piatto da portata e condiscili con una salsina preparata versando in una ciotola l'olio, la menta ed il basilico tritati finemente insieme all'aglio ed il succo di limone. Nanna & Babbononno

A Nostalgic Remembrance



It was a Saturday morning at the beginning of October and there was a knock at the kitchen door, the door that led into our 3rd floor apartment on Eutaw Street in East Boston. The only problem was that it was about 5:30 a.m. Dad and I arrived at the door at the same time with both of us grumbling. Dad had played the night before and gotten in about 1:30 a.m. This meant that he was answering the door with about 4 hours of sleep or less. Once the door was opened, the visitor held up a sprig of 3 red grapes. It was Grandpa Christoforo, and it was time to make wine.

Mom was a light sleeper and came out of the bedroom securing her robe as she headed for the stove. There was a sleepy, "Bon Giorno," and within minutes, there were two pots of coffee brewing on the stove, one American and the other Italian. Dad and Grandpa exchanged the events of the week as they sipped their respective cups of coffee. After a sip or two, Grandpa said to me, "Mi nipote, prenda una bottiglia de cognac, per favore." (My grandson, bring a bottle of cognac, please.) After I placed the bottle in front of my grandfather, he poured a decent sized shot in his coffee cup and filled the rest of the space with Italian coffee. After a sip and then another just to make sure, he smiled and said, "Ah, questo e buono." (Oh, this is good.)

Once we were washed, dressed and down the stairs, we climbed into Dad's beat up 37 Plymouth and headed to Grandpa's house on Chelsea Street near Santarpio's Restaurant. As Grandpa headed down the cellar stairs, Dad and I entered the first floor apartment and said hello to Grandma. Within a few minutes, the bacon she began to fry overpowered the smell of wine that surrounded us in the cellar.

Grandpa showed Dad the year, he would order grapes from France or Italy, as he considered American grapes inferior to what was grown in Europe. He and Dad began opening the cases of grapes, and began removing them from the vines. If there were any leaves, they too would be removed. After Grandpa inspected the piles, we placed them in a large cylindrical vat. Above the vat was a

suspended from a frame by a worm gear apparatus. Once the vat was filled to a certain level, Grandpa placed a long iron bar in a round opening in the worm gear and began turning it clockwise. This lowered the wheel shaped lid down onto the grapes. He would continue this operation until the lid crushed the grapes and the juice started filling the vat. Once the grapes were all crushed, he began filling a bucket with the grape juice and poured the liquid into a giant sized cask. He continued this until all of the juice had been transferred, and then had turned the iron bar so the lid could continue to crush what was left of the grapes.

The gauges atop the cask were adjusted by my grandfather and then, what looked like sugar was added into the mix before the plug was wedged into the cask to seal the top.

Just then, Uncle Jim appeared. Jim Dello Russo was Dad's brother-in-law, his sister's Mary's husband. He looked over the operation after greeting everyone, and asked how many gallons were going to be produced. Grandpa told him he was making 50 gallons. Dad said 50 should get you through the year. Grandpa shrugged and said, "Chissa, chissa." (Perhaps, perhaps) And, so it went.

Checking with friends, it seems that almost no one makes homemade wine these days. Grandpa's generation is gone, and for the most part, so is Dad's. I have thought about trying it with my cousin Ralph Pepe, but neither of us have the time. I am not a wine drinker due to a reaction I get from the preservatives that are found in wine in the U.S. The FDA requires additives to be included in imported wines, and I think domestic wines too. If I drink wine with the preservatives, nitrates or cases of grapes he bought at nitrites, I'm not sure which considering our schedules the produce market. Each they add in, but my sinuses begin to get stuffed and my fingers swell. As a result, I will only try a wine if I'm in Europe or at someone's home where homemade wine is available. Usually, neither of these contain preservatives and I can enjoy a red or white with my dinner.

Don't get me wrong. I'm no expert when it comes to wines. I either like or don't like. When I was a kid, I was

wheel shaped cover that was allowed to have a little of Babbononno's wine at Sunday family dinners. By the time I was born, my maternal grandfather had stopped making wine. He would get what he needed from his brother-in-law, and best friend, Antonio Ceruolo. Zi'Antonio made delicious wine and Babbononno considered him the best wine maker in either East Boston or the North End. My great uncle made several types of wine, but a smooth red was his forte. It could be consumed with almost anything except delicate fish. He did make a white wine which was compatible with seafood, but I don't remember what the white tasted like.

> Another thing that I wonder about, especially with American attitudes toward wine, is that red should be served at room temperature. Zi'Antonio and Babbononno used to serve wine a bit chilled. I once asked Babbononno what room temperature meant and he said that wine should be served at around 50 degrees, which might have been the temperature of someone's wine cellar. If he was to drink a table wine that was at room temperature and the temp happened to be 70 degrees or higher, Babbononno would ask for an ice cube. Another drink that doesn't turn me on at room temperature is beer. I tried a warm beer in London a while back and couldn't handle it. But, I'm not a beer lover and that may make the difference.

> When I was a teenager and all the guys were interested in a couple of beers, I had to preface my preference with root. I liked root beer, orange soda, cream soda or lemonade. Even today, I seldom have a beer. If it's a hot summer's day and I'm in the mood for a beer, I will choose something light, like a Corona or Land Shark which is similar.

Loretta and I eat out a lot and during the summer, water with lemon or a good lemonade will enhance the flavor of the food, so that's what I order.

I know that some people will opt for a beer, a glass of wine or something harder on the rocks, accompanied by chips, when they are relaxing or watching a sporting event on TV. I have to confess ... I would rather sit down with a cold glass of milk and a couple of chocolate chip cookies. Oh well.

lived for centuries in towns and villages. And yet, in fewer than three generations, we have become doctors, lawyers, captains of industry, mayors, governors, senators and even U.S. Supreme Court justices. But the image of us as ignorant and ill-mannered persists.

In that sense, we have the worst of both worlds. We are part of the "white majority" and yet we are marginalized by society in a more subtle way than our immigrant ancestors were. But marginalized all the same.

According to the U.S. Census Bureau, two-thirds of the Italian Americans in the workforce are in white collar positions. The average Italian American is 34 years

ing about city life, having old and married with one child. He (or she) has a higher level of education than the national average, and earns a median annual income of \$100,800 — about \$17,300 more than the national median income of \$82,500.

> That is who we are, but it is not how we are perceived. It's time for commercials like Aflac's in particular and for the U.S. entertainment industry in general to portray Italian Americans more realistically. Stop ruffling our feathers and give us the same respect given to a duck.

The air it out approach was a failure, as Brady continued to descend in the NFL quarterback rankings. He now has connected on a league-low 32 percent of passes over 10 yards. He completed

only one such pass in Kansas City, throwing 2 ugly interceptions while finishing with an abysmal 11.6 QBR (Quarterback Rating) in the game. "It was just a bad performance by everybody," said Brady, "We need to make sure we never have this feeling again."

Big Papi on MVPs






Jerry Quarry was born into boxing. His father Jack had him participating in fights starting at the age of five. While still an amateur, Jack Quarry would have his son sparring with professionals who were often much bigger than the young Jerry. Many of these sparring sessions would turn into wars where Jerry would be fighting for survival. It can be argued that starting so young and being thrown in with such experienced fighters at that early age made Quarry into a good fighter. I would argue in return it is what guaranteed his tragic ending, dying at the age of 53 after suffering from dementia for many years. My take on it is that Jack Quarry was a sadistic and cruel man who had no concern for the well being of his son.

After emerging from that baptism of fire and winning many amateur titles, Jerry went on to a professional career that was marked by many triumphs and many disappointments. Jerry Quarry could fight, he could really fight. He could box, he could punch, he moved well on his feet, he was an amazing counterpuncher, and he could take a punch (maybe too well). Watch videos of him at his best and there is no doubt that he had all the tools to be a champion, and a great one. So, why wasn't he?

Jerry Quarry stops Mac Foster


sion to instinct.

HOOPS and HOCKEY in the HUB

It was the summer without fireworks, at least those that might have been associated with the Boston Celtics. But as we drove down Route 128 on the way to the team's annual media day, we knew one thing was for certain: it was time for the men in Green uniforms that inhabit the Hub to get back to work.

The Celtics practice facility at HealthPoint in the western most section of Waltham features a replica of the court that is known to fans around the world.

But here, it is just the floor and the baskets with a small section of seating that looks as if it could hold 200 people at most. Significantly, banners indicating each and every one of the Celtics' 17 NBA Championships are also on display here; but on the walls, rather than hanging from the rafters as they do at the Garden.

Perhaps the most significant difference is the placement of an additional banner on the wall of the practice facility. It is white like the others but entirely blank. It is displayed for all to see — waiting to be inscribed, embossed and emblazoned with the year of the next Celtics Championship. It is Banner 18 and its hanging there is meant to be a challenge — win a championship, take me down and adorn me - filling in this pronounced gap on this wall of championships.

Thus it is that each time the Celtics take to the floor for practice, their challenge is visible, larger in its silence than perhaps it ever could be in oratory, and much more visible and longstanding.

Just how impressive is this scene? Well, we saw one member of the Fourth Estate recording it for posterity on his cell phone.

Media Day is exactly what the name implies — a day for the media members who cover the Celtics to come together and interact with the team, Coach Brad Stevens, GM Danny Ainge and a number of the press officers that assist the media throughout the season.

One large area was set aside for photography. It was there that various photos were taken for display on the TD Garden Jumbotron. In addition, the head and shoulder shots that fans will see on websites and in newspapers were also taken. Still more images were taken for the team's media guide and other publicity efforts.

On the practice court itself, there were a variety of stations, representing numerous media outlets. Some were stops for audio interviews for radio stations, others were set aside for television outlets. One of the more popular — set up in one corner — was the classic press conference configuration.

It was there, one by one,

that Ainge, Coach Stevens and every player made a stop each fielding questions in his own way. The Celtics acquired several new players in September — who knows how many will be on the opening night roster — but all pledged their allegiance to the storied franchise and expressed thankfulness and gratitude for the opportunity of being with the Celtics.

For those who were returning it was a time to look ahead toward the new season — to put the disappointments of the past campaign in perspective and to embrace with vigor and vitality the possibilities of the upcoming 82 games that lay ahead.

All returning players insisted that this year's team would be better than last season's, saying that a year with Coach Stevens had done them good. Everyone was on the same page and many had already participated in informal practices — some throughout the summer and others since Labor Day.

Kelly Olynyk perhaps came up with the best line when some asked him to describe his rookie year experience last season. "It was like having to take a test without going to class," said the seven-foot center, who played his college ball at Gonzaga University.

We had the chance to renew acquaintances with a number of people who cover the Celtics, as well as the members of the media relations staff who have assisted us over the years.

As the afternoon wound down, the pace slowed and the number of reporters dwindled. We took our leave, got back in the car and drove north on Route 128, taking as a positive symbol the better-than-average flow of rush hour traffic.

If the Celtics fare as well as they weave their way through the NBA this season, then this year will turn out better than last, with the prize of a playoff berth becoming a reality at journey's end.
