






PUGILATUS

The first was considered to be the most simple and natural weapon, therefore, it may be taken for granted that boxing was one of the earliest athletic games among the Greeks. Even Apollo, Hercules, Tydeus, and Polydeuces were described as being distinguished boxers. The art of boxing was believed to have been invented by Theseus, the

killer of the Minotaur, and most Homeric heroes were described as being well acquainted with it. Boxing was first introduced as an Olympic sport for men, but later it was introduced for boys.

The boxing matches during ancient times resembled our modern boxing. It was considered to be a point of skill not to attack one's antagonist,





but to remain on the defensive and thus to wear down the opponent until he was obliged to acknowledge defeat. It was also considered meritorious for a boxer to conquer another without receiving any wounds himself. The two main points in the sport were (1) to inflict blows, and (2) not to expose one's self to danger. Arms were extended much in the same fashion as they are today, and the blows were directed against the upper part of the body. The ears were especially exposed to great danger, and with regular pugilists were generally mutilated and broken. Ear covers were used in practice sessions, but never in the actual bouts. The two great differences between ancient and modern boxing appears to have been in the partly opened fists, and in the sounds emitted by the contestants to add force to their blows.

It was not uncommon to cause the death of an opponent in a fair fight, but willful killing of an opponent was severely punished. If both contestants were tired, they were permitted a short pause in order to regain their strength. Ancient pictures often show boxers resting on their knees. The contests normally continued until one of the participants were beaten into unconsciousness or raised his hand as a sign of defeat.

Ancient boxing was governed by rules as it is today, and one rule specifically forbade the taking hold of an opponent, or to use the feet to trip him. Roman boxing appears to have been quite similar to that of the Greeks. These gregarious Latins also introduced a special kind of boxing, not in pairs, but in a general melee, which was called a "grex verberare."


DPU to Hire Independent Evaluator to Assess Statewide Natural Gas Distribution System, Company Policies and Practices

The Department of Public Utilities recently announced their intent to hire an independent evaluator to conduct a statewide examination of the safety of the natural gas distribution system within the Commonwealth. Through authority granted by Governor Baker under the State of Emergency declared on September 14, 2018, the Department's Chair will direct all natural gas distribution companies operating in the Commonwealth to fund the statewide examination. The Chair's decision to take this action is intended to assess, out of an abundance of caution, the safety of pipeline infrastructure throughout the Commonwealth and follows a similar precedent set by the state of California to conduct a third party review following a natural gas incident in 2010.

"The safety and security of all communities is the top priority of our administration, and out of an abundance of caution, I have directed the utilities to work with an independent evaluator to carry out this comprehensive safety review," said Governor Charlie Baker. "This review will help improve accountability for utilities and add another layer of oversight for all natural gas infrastructures."

"The Department of Public Utilities continually works to ensure the safety of residents and the Commonwealth's energy infrastructure, and the independent evaluator's review will further the Department's efforts by performing an additional examination of the physical condition and safety of the distribution system, as well as the operational and maintenance functions of natural gas companies," said Department of Public Utilities Chair Angela O'Connor.

L'Anno Bello: A Year in Italian Folklore

October and the Wonder of Autumn

Every year, I look forward to taking advantage of a crisp, cool weekend day and going apple picking with my family. Everything in our favorite apple farm looks as if it has materialized from a quaint postcard depicting a rustic autumnal scene in New England. Ruby-red apples peek out from under multihued leaves. Corn stalks wave jauntily in the fresh breeze. Pumpkins gleam like bright sunbursts across a vine-studded patch. As I wait in line for a bag of delectable apple cider donuts, I marvel at the signs of fall surrounding me. These signs will only intensify as we enter the month of October. For me, October is the period that best encapsulates what I love about fall. It is the month where I bake apples and pumpkins into everything, from breads to tarts to cakes. It is the month when the carpet of leaves on the ground glows with the same intensity as a fiery sunset. Finally, it is the month of Halloween, when ghosts and witches and black cats adorn doorways, and when winds howl through the dark nights. Over in Italy, October also means feasts of harvest and the last glorious moments of autumn before winter descends on the

land. Italians celebrate this month with plenty of proverbs, traditions and foods, and even introduce the month with a holy day that honors nature itself.

October's very name hearkens to the Italian peninsula. It derives from octo, the Latin root word for "eight." October was indeed the eighth month in the year for ancient Romans prior to the addition of July and August to the calendar. Italians associate October with soft, golden afternoon sunshine, with days marked by cool breezes and pleasant temperatures that encourage travelers to visit. As October also involves the harvest of late-autumn crops like mushrooms and apples, Italians pay homage to the month's agricultural significance with a bevy of proverbs. The meteorological backbone of these traditional dictums demonstrates the importance of farming in olden Italian culture. One famous maxim states: "Ottobre é bello, ma tieni pronto l'ombrello." This proverb means that while October is beautiful, one should always keep an umbrella at the ready as it also tends to rain during this month. Indeed, October rains always seem to fit with the mood of the month, as the slate-gray

skies imbue Halloween decorations with an extra-ominous vibe. However, Italians do not bemoan the rains that periodically interrupt the otherwise serene October weather. Another proverb — "Ottobre piovioso, campo prosperoso," or "rainy October, prosperous countryside" - speaks of the benefits these rain showers have on the harvest. No matter the rain, Italians appreciate October for its overall beautiful climate and the rhythms of the harvest season that sweeps its many fields and villages.

In fact, Italians begin October with a festival that celebrates the natural world. October 4th is the feast day of St. Francis of Assisi, an immensely important figure in Italian culture. The thirteenth-century St. Francis, or San Francesco as he is known to Italians, is not only the patron saint of the country of Italy but also of animals and the environment. St. Francis was known for his respect for all of God's Creation and his kindness to animals, preaching of God's love to an audience of birds. His hometown of Assisi, a beautiful sunbaked medieval city nestled in the hills of Umbria, springs alive with activity on his feast day, boasting parades, folk dances, open-air markets and regional foods. The highlight of the festival is the blessing of animals to commemorate the cherished nature-loving saint. This tradition of blessing pets has crossed the ocean and is an integral part of Italian-American St. Francis Day customs. I think about St. Francis when I observe the plentiful natural beauty that October has to offer. Squirrels scampering up trees, my cat intensely watching the autumn leaves swirl around in the air, geese flying south in v-formations across a cloudy sky — all of these images fill me with both awe and tranquility. St. Francis's Day teaches us that all of nature, from the loftiest tree to the smallest chattering squirrel, is worthy of respect and admiration. By honoring the natural world around us, we can enrich our understanding of the seasons and our gratitude for life's blessings

You Don't Need Long Island to Create Initiatives to Help Those in Recovery

Personally, I still believe that when the City of Boston suddenly closed down Long Island as a home for the homeless and a resource center for those with alcohol or drug addiction it was. for me, a positive move. When the bridge was razed it was even better news! As a police officer for the Department of Mental Health I spent years bringing folks from DMH out to the Island for services better done there. I also knew, however, that this population, which is always at risk, was being placed far away — out of sight and mind.

I always viewed the Island as a social leper colony. Busing folks from the South End next to the old Boston City Hospital (now Boston Medical Center) probably made folks feel better when those taillights headed onto the South East Expressway for the island.


I hear many Boston officials chide the City of Quincy for blocking efforts to construct a new bridge. I hope it never gets built and that everyone in Metropolitan Boston tackles the issue of homelessness and addiction together. The reason Boston has a Methadone Mile in the first place is because most of the services to this population have been always in this environment going back decades; maybe even longer than the old razed bridge

Recently, during a public ceremony near Mass Ave., Mayor Martin J. Walsh was speaking on a new initiative for the community in recovery and began mentioning all the programs and services available. He talked about the Pine Street Inn to the right and Rosie's Place a short distance to his left. He talked about the Health Care for the Homeless Center near the corner of Albany Street and Mass Avenue.

We have a so-called Methadone Mile now metastasizing into Methadone Two-Three Mile spreading toward both Dudley Square and Andrew Square. Even with an opened Long Island facility, the problems in the South End won't disappear overnight. During the day many will gather around Albany Street, Melnea Cass Boulevard, and Massachusetts Avenue, they will huddle on the Mass Ave., on-ramp to the Southeast Expressway or they will walk around in many different directions.

It is time for Boston as the capital city to lead the way, but surrounding communities must help. The bottom line should always be on helping those addicted to drugs or alcohol and those who are homeless survive in our booming society without getting boomed on as usual.

Fighting over Long Island is just a distraction. Not a solution. Not anything!

NORTH WASHINGTON STREET BRIDGE REPLACEMENT PROJECT UPDATE

Off-Peak Lane Closures for Utility Work Beginning in October Series of Public Meetings Being Held for this Project in the Near Future

The Massachusetts Department of Transportation (MassDOT) is reminding members of the public that workrelated activities including utility operations are beginning this month on the \$177 million project to replace the City of Boston-owned North Washington Street Bridge which carries traffic over the Boston Inner Harbor between the North End and Charlestown.

This utility work will require temporary short-term travel impacts including overnight off-peak lane closures, and will be conducted in ways that seek to minimize the impact on commuters and the local community. The major construction efforts for this project will then likely begin in spring

Given the importance of this bridge structure for Charlestown, the North End, and the entire region, MassDOT, the City of Boston, and the contractor are also exploring ways to reduce the overall impact of the construction process. As options are developed and analyzed, MassDOT will host a series of public meetings to discuss construction plans. Details of these public meetings will be provided as they are finalized.

"We are committed to ensuring that construction work on the North Washington Street Bridge is carried out in ways that accommodate residents and commuters throughout this local neighborhood," said Highway Administrator

Jonathan Gulliver. "This bridge is an important connection in the heart of Boston and we appreciate the support and input we have received from local leaders and key stakeholders throughout the design and planning process."

In spring 2019, MassDOT will begin the significant construction operations for this bridge replacement project. At this time, and throughout most of the project, it is expected that motorists will have access to two travel lanes in the inbound direction towards Boston's North End neighborhood, and one outbound lane towards Charlestown, and pedestrian and cyclist access will be maintained. This currently excludes periods when there will be one lane in each direction, to allow the crews to demolish a portion of the main truss span and replace it with a temporary span.

"The North Washington Street Bridge connects two of the most historic neighborhoods in the City of Boston — the North End and Charlestown — and we look forward to working with our local, state and federal partners to build a replacement bridge that offers an enhanced experience for users and preserves the spirit of the neighborhoods," said City of Boston Chief of Streets Chris Osgood. "These improvements to the bridge will provide residents a high-quality and safe bridge that will serve the City of Boston for years to come."

The bridge is a critical link in the MBTA bus network, providing passage for several Haymarket destined bus routes from the north including the 92, 93,111, and 426. MassDOT and the MBTA have been in close coordination and every effort is being made to minimize the travel time delays for these routes. MassDOT has also re-sequenced other projects including work to repair the Tobin Bridge to better accommodate public transit customers.

Construction is currently expected to be completed in 2023, and the full scope of work includes replacing the existing structurally deficient bridge, providing multi-modal amenities including widened sidewalks, separated bicycle lanes, and bus rapid transit lanes, increasing intersection safety and capability, and improving the navigation channel.

This project is being carried out to improve the functionality of the bridge and ensure reliable travel throughout this area. This bridge is 118 years old and carries intercity vehicles as well as local MBTA bus, shuttle, and tour bus routes. The bridge is currently safe for travel, but is nearing the end of its usable life cycle.





Saint Marie-Madeleine Postel

Julie Françoise-Catherine Postel was born on November 28, 1756 in Barfleur, France to the fisherman Jean Postel and Thérèse Levallois. After her elementary education, she received her higher education from the Benedictine nuns at Volognes. There she decided to devote her life to the service of God and her neighbor, and privately took the vow of chastity.

Postel founded a school for girls in Barfleur in 1774, that became a center for underground religious activities during the French Revolution for those who were unwilling to support the new regime. The school had been shut down at the beginning of the Revolution. During the persecution, it played a heroic part in helping the priests who were in hiding or in prison and in strengthening the faith of the loyal Catholics of Barfleur.

She was authorized to keep the Blessed Sacrament in her house, and when conditions grew worse, to carry the Blessed Sacrament on her person and even to administer Holy Viaticum to the dying in cases of emergency.

After the Revolution, she took the religious name, Mary Magdalen, and helped restore the Faith by catechizing young and old, and began to teach school, once more, at Cherbourg. She and two other women established a religious community there in 1805, and two years later they, and another woman who had joined them, pronounced their vows. They called themselves the Poor Daughters of Mercy and




observed the rule of the Third Order of St Francis.

The motherhouse of the congregation was transferred in 1832, from Cherbourg to the former Benedictine abbey of St Sauveur le Vicomte in Courtance: and in 1837, the Vicar General Delamare substituted, in place of the Third Order rule, that of St. John Baptist de la Salle, the founder of the Christian Brothers.

The members of the community were called Sisters of Mercy of the Christian Schools.

Mother Mary Magdalen was almost ninety years old when she passed away on July 16, 1846. Her sisterhood continued to grow and spread also to other countries, especially England and Italy. The original French sisterhood received papal approval in 1901. Mother Mary Magdalen was canonized in 1925 by Pope Pius XI. The Feast of Saint Marie-Madeleine Postel is celebrated on July 16th.





The Story of Boxing Champion Emile Griffith

to Open at The Huntington






In exciting news for both boxing and theatre fans, the Huntington Theatre Company production of *Man in the Ring* will be opening at the Calderwood Pavilion at the Boston Center for the Arts on November 16th. The play, written by Pulitzer Prize winner Michael Cristofer, will run through December 22nd. *Man in the Ring* chronicles the life of former Welterweight and Middleweight Champion Emile Griffith.

Griffith's story will span the time of his humble beginnings in the Virgin Islands, his love affairs, and the tragedy in the ring that forever changed his life. It is a complex story that is both touching and tragic.

I am very excited to hear that John Douglas Thompson has been cast in the role Emile Griffith as an older man. Mr.





Douglas is one of the best actors on stage today, and I had the pleasure of seeing him in the world premiere of Terry Teachout's *Satchmo at the Waldorf* in 2012. He was simply phenomenal that night. Most recently, he played Starkeeper in the Broadway production of *Carousel*. It will be interesting to see him play Griffith as an older man who if suffering from the effects of his years in the ring as well as the emotional turmoil from the Benny Paret fight.

Kyle Vincent Terry will be playing the younger Griffith. Mr. Terry served as fight choreographer for *The Royale* which I saw last year at the Merrimack Repertory Theatre. The fight scenes in that production were very creative and well done. It is a challenge to create what happens in a boxing ring onto a stage, and Mr. Terry work was quite impressive.

Playwright Michael Cristofer won the Tony Award and Pulitzer Prize for his 1977 play The Shadow Box. In his script for Man In The Ring, Mr. Cristofer explores Emile Griffith's struggle with his homosexuality which was an open secret in the boxing world during his career. Benny Paret's taunts of Griffith before their tragic fight have always been thought to have contributed to Emile's fire in the ring that night.

"Emile Griffith was a true hero in my book," says Cristofer. "He was a young immigrant form the Virgin Islands and a man struggling with his identity while in a brutal sport who, as an older man slipping into dementia, worked to find peace amid the love, pain, and joy that was his life."

Huntington Artistic Director Peter DuBois says "One of the hardest things to do in theatre is to tell the full story of a complex person's life. Michael Cristofer beautifully captures the excessive, eccentric, and emotional parts of Emile's amazing story by mixing the champ's easy charm with the raw and traumatic things he experienced."

The cast also includes Victor Almanzer as Luis, Griffith's lover and later his caretaker, Starla Benford as Griffith's mother Emelda, Krystal Joy Brown as his wife Sadie, Gordon Clapp as manager Howie Albert. Sean Boyce Johnson is cast as Benny "Kid" Paret with Carla Martinez playing his wife Lucia. Eliseo Sosa will play Paret's manager Manuel Alfaro.

Man in the Ring will be directed by multiple Tony Award nominee Michael Greif. Michael McElroy is the music director and composer of incidental







Recipes from the Homeland

SHRIMP SCAMPI OVER LINGUINE or as Hors d'oeuvres

1 pound medium shrimp (cleaned and deveined)

5 cloves chopped garlic 3 tablespoons margarine or butter

2 tablespoons olive oil

2 tablespoons chopped parsley 1 bottle clam juice

1/4 cup white wine or sherry

1 pound linguine

Grated Romano or Parmesan cheese

In a skillet, over low heat, melt margarine or butter and add olive oil. Add chopped garlic. Simmer slowly, careful not to brown garlic. Remove skillet from heat. Slowly add clam juice. Return to heat and add cleaned shrimp. Stir and cover to simmer slowly until all shrimp turn pink (about ten to fifteen minutes). Add wine or sherry and parsley to this broth and cover. Simmer to a boil and then remove from heat. Set aside. Reheat if necessary before serving.

For cooking linguine, follow directions on the package. When pasta is cooked, strain and place pasta in a large serving bowl. Add shrimp broth and stir. Serve linguine in individual bowls topped with shrimp and grated cheese of choice. Place additional broth and shrimp on table for guests.

OPTIONAL: To serve as an hors d'oeuvre: Prepare shrimp as mentioned above. Place the prepared Shrimp Scampi in a serving bowl on your table, adding a serving spoon for the guests to help themselves. Also have available plates, forks, and napkins. Garlic bread and/or crackers go well with this hors d'oeuvre.

A Nostalgic Remembrance



It was the beginning of October, and one Saturday morning at about 5:00 am, there was a knock at the kitchen door. Dad woke up first and answered it. It was Grandpa Christoforo, and he was standing there holding a sprig of three grapes. They were not grapes to be eaten. They were wine grapes and the gesture indicated that it was time to make the wine. Dad shook the cobwebs from his head, invited Grandpa in, and then woke me up. Even though I was just a kid, I knew from experience that we were to help my paternal grandfather carry on an annual Italian tradition, even in America.

Before attempting a new batch of wine, Grandpa emptied his barrels by filling dozens of gallon jugs and an assortment of whiskey bottles he had stored in his cellar for just this purpose. Now that his barrels were empty, cleaned, and ready to go, it was time. He had purchased a shipment of imported grapes. I don't remember if they were from France or Italy, but remembering his attitude, I believe he would only use Italian grapes. They would have come in on a freighter from Europe and Grandpa would have gone to whichever Boston pier the ship docked at and bought enough crates of grapes to make about fifty gallons of wine, mostly red and a little white for the summer months.

Dad made breakfast for me, but Grandpa only had a cup of coffee while periodically looking at his Hamilton railroad pocket watch (which I still have in a domed glass display container). When we were done, we headed to my grandfather's Chelsea Street home and Grandpa's wine cellar.

Dad and I uncrated Grandpa's grapes with tools that Grandpa had made just for this type of operation. When enough of the boxes were open, we filled the cylindrical wine press to crush them into juice and pulp. The wheel shaped lid was lowered onto the contents of the vat and the screw mechanism was turned to lower the disc shaped cover downward and the grapes began to be crushed. Neither Dad nor I said anything. We just followed Grandpa's orders. He was the master vintner and that was that.

A siphon was used to remove the juice, letting the dark red liquid flow into one of many barrels that would, over time, allow fermentation. Scooping out some of the crushed grapes, my grandfather then directed us to fill the press with more grapes and the process was repeated. This went on and on until all of the grapes had been crushed and the liquid siphoned into the casks.

Grandpa added something to each cask, possibly sugar to accelerate the fermentation process, I'm not sure. He then adjusted little gadgets that he placed inside the holes atop the barrels. He next pointed to them and told me that they would tell him when the grapes had fermented into wine.

Just then, I heard footsteps coming on the cellar stairs. It was my uncle Jim. Jim Dello Russo was Dad's sister Mary's husband. He and my aunt had married after Jim was discharged from the Navy at the end of World War II. He was there to claim the crushed grapes due to the fact he wanted to make grappa with them. Grappa is an after dinner liqueur that, if made right, would grow hair on your tearing eyes, and he knew how to make it that strong. I think he added in pure grain alcohol to boost the octane, but I'm not sure. I remember he used to by the stuff at the Coast Guard Base in Boston.

We would repeat the wine making process with the boxes of white grapes that Grandpa had purchased. When I asked him why the white grapes, he responded with, "Durante il verano, bebiamo solomente vino bianco, capisce?" (During the summer, we only drink white wine, understand?) I shrugged my young shoulders and then watched as Dad, Uncle Jim, and Grandpa repeated the siphoning process with the white liquid heading for the few empty barrels that my grandfather saved for white wine. Once they had finished, Uncle Jim asked Dad to help him make anisette, one of his specialties. They mixed anise flavoring with food coloring and alcohol and poured the liquid into five-gallon containers that were lined up in a corner of Grandpa's cellar. I didn't know what they were doing, but I liked the colors, green, blue, yellow, violet, pink, and clear. Years later, traveling around the world, I would discover that many cultures, not just Italian, enjoyed a similar drink. Uzo for Greeks, Udda for Christian Arabs, Arak for Turks, Raki for Armenians, aqua vit for northern European and Scandinavians countries, and so forth around the European and Middle Eastern world. They must have picked up the recipe from the Romans a couple of thousand years ago, who knows ...

On this day, Dad and I would have an early dinner with Grandpa C., and sample his wine, made last year and now ready to drink. It was strong, very strong, and dark-dark red.

It didn't kill the taste of the food as Grandpa added hot pepper in all his dishes. He was a great cook, but, years later, when I sampled Mexican food for the first time, I wondered if my paternal grandfather, Nunzio DeCristoforo, learned cooking in Mexico. I still wonder. GOD BLESS AMERICA

Once selected, the independent evaluator will be instructed to examine the physical integrity and safety of the natural gas distribution system and the operation and maintenance policies and practices of all natural gas distribution companies operating within the Commonwealth. Additionally, the independent evaluator will produce a report with any necessary recommendations at the end of the contract. The examination will complement, but will not duplicate, the investigation of the National Transportation Safety Board, which focuses on the gas incident on September 13, 2018 in the Merrimack Valley and its potential causes.

The Department will procure the independent evaluator through an expedited procurement with consultation from the federal Pipeline and Hazardous Materials Safety Administration, the agency that has granted the Department delegated authority to conduct pipeline safety activities.

The scope of the independent evaluator's assessment with respect to physical distribution will analyze each gas distribution companies' respective system designs of low, medium, and high pressure mains and associated service lines to ensure they are compliant with applicable federal and state regulations. The assessment will also seek to identify any weaknesses or deficiencies in the distribution system and make recommendations for changes that are not already underway.


The portion of the assessment related to the operation and maintenance of the distribution system will examine the natural gas distribution companies' written operation and maintenance policies and procedures for their respective distribution systems, including safety protocols and incident response. It will also assess whether there are sufficient personnel, including inspectors, and management structures and communication protocols in place at the gas distribution companies to ensure that safety and incident response protocols can be operationalized. The assessment will analyze operating pressure protocols, including maximum allowable pressures and procedures in the event of abnormalities, compliance with the Dig Safe statute, and record keeping of the natural gas companies.



Ali's Greatest Fight?



Liston vs. Clay

Recently, a discussion was taking place on social media on the subject: What was Muhammad Ali's greatest fight? This was brought up on the anniversary of the Thriller in Manila, the third bout between Ali and Joe Frazier. Many people thought that was Ali's greatest fight. Others disagreed pointing to Ali's victory over George Foreman. Another wrote that it was his victory over Sonny Liston in their first fight.

All three of these bouts were great victories for Ali, but for different reasons. In the third Ali/Frazier fight two over the hill warriors were meeting for the last time with each holding a victory over the other. While Ali was the champion, he was now far from his prime, as was Joe Frazier who was merely a shell of his former self. What made this fight great, and a great victory for Ali, was not seeing two skilled boxers at work, but rather seeing a battle of wills between two old rivals. It was a brutal and grueling fight that Ali described as the closest thing

to death.

Was the fight itself great? Not on a technical level. It was a slugfest more akin to the Gatti/Ward fights. Two relentless warriors standing toe to toe with neither giving any ground. It was dramatic though as the tide kept shifting throughout the bout. Plus, it was Ali vs. Frazier, the greatest rivalry in heavyweight history.

Ali's regaining the title from George Foreman also ranks high on the list of greatest victory for Muhammad. I believe this fight is more deserving of being remembered as his best performance in that hardly anyone gave him a chance going in against the seemingly unbeatable Foreman. In fact, there were many who feared that Ali would not only lose, but would be killed by the powerful George Foreman. Ali did the unbelievable that night in Zaire when he outfoxed and out-punched the champ to regain the title. It was an amazing thing to see. It also was a reminder of a fight earlier in his career that some of put

forth as his greatest fight.

That fight was when Ali won the title from Sonny Liston in Miami Beach. Now, not many would put this up there with the Rumble in the Jungle or the Thriller in Manila, but it certainly should be. It is a fight that has to be looked at in context.

There are many similarities with the Foreman fight. Ali, Clay at the time, was stepping in with a champion who was not only considered his superior, but was considered the hardest puncher of all time. A man who didn't just beat opponents but destroyed them. Liston, like Foreman, struck fear into the hearts of those who faced him. And, like what happened before the Foreman fight, many not only believed Clay would lose, but might also be killed. The context in which to evaluate the greatness of this victory has to be the time in which it took place. Clay was undefeated, but still untested. In his two fights leading up to the showdown in Miami, Clay had struggled to win a controversial decision over Doug Jones, and had been nearly knocked out by Henry Cooper. If Cooper could hurt him with a left hook, just think what Liston would do to him. It seemed you would have to be insane to pick him over the mighty Liston, and hardly anyone gave him a chance.

In winning against Liston, Clay did what seemed to be the impossible. Looking back at it you can say Liston didn't take him seriously and wasn't in shape, which is true, but the fact is Clay fought an unbelievable fight that night. Even when he was blinded by a substance that, most likely by nefarious means, got into his eyes, Liston could not catch up with him. It is also important to remember that while Clay was certainly an outstanding prospect, he was still thought to be at least a year or two away from a title shot, and still had not been really tested.


Looking back at these three fights, which one should be at the top of the list?

I would take the third Frazier fight off the list. While it was an exciting battle, I have always felt it was a bit of a tragedy. Watching two great warriors whose abilities are so eroded pummeling one another was sad. It was a battle of wills not skills.

That leaves two fights, in both of which Ali was a decided underdog. In each fight Ali's life was believed to be at stake, and in both fights he won in amazing fashion.

With Liston it was felt he was to young and inexperienced, and with Foreman it was believed he was too far past his prime. Liston and Foreman were similar in many ways. Both were destructive punchers who had reputations for almost being superhuman. In both fights Clay/Ali did the seemingly impossible.

In many ways Clay's first fight with Liston could, and probably



A FESTIVE FIRST DAY FOR A LANDMARK THIRTY FIFTH

Yes, that's what's the annual Hockey East media day was at the TD Garden as the conference lifted the lid on its 35th season of competition.

Hockey East considers its media day to be one of two bookends for the conference season. The campaign commences with a festive opening at the Garden and comes to an exciting climax in mid-March with the playing of the HE Championship Game on Causeway Street.

This season gets under way with three new head coaches ready to take the reins at their respective institutions. Over the summer months, Associate Head Coach Albie O'Connell assumed the top post at Boston University following the departure of David Quinn, who took over the head job at the New York Rangers.

O'Connell, the captain of the 1998-1999 BU squad, takes over a team that won the Hockey East Tournament last season and has been picked to finish third in the 2018-2019 standings in the media — behind Providence College and top-ranked Boston College. BC finished first in the regular season standings last

Others in the poll include Northeastern (4th), Maine (5th) UMass-Amherst (6th), UMass-Lowell (7th), UConn (8th), New Hampshire (9th) Vermont (10th) and Merrimack (11th).

In addition, Mike Souza, a longtime assistant at the University of New Hampshire, was elevated to the head position following the retirement of veteran mentor Dick Umile. A native of Melrose, Umile had called the strategy behind the UNH bench for 28 seasons.

Up in North Andover, Scott Borek is settling in as the new head coach of Merrimack College. The veteran college mentor, with 33 years of collegiate coaching experience, was named to the position in the spring after Mark Dennehy was let go after 13 seasons at the helm.

Borek, a native of Swampscott, arrives after a three-year stint as associate head coach at Providence College, with the Friars advancing to the NCAA Tournament all three seasons that he was on the coaching staff.

Prior to that, he spent 13 seasons at UNH under Umile where he helped lead the Wildcats to nine NCAA Tournament berths as well as a trip to the 2003 NCAA Championship Game and a Hockey East Tournament crown.

His playing career at Dartmouth College was cut short after he suffered a serious neck injury during his sophomore season.

In other conference news, it was announced that the conference will return to a playoff format that features only the top eight teams advancing to the Hockey East playoffs. This was last used in 2013. For the past five seasons, all conference teams have qualified for the playoffs.

"This new format will only amplify the value of our 2018-2019 regular season," stated HE Commissioner Joe Bertagna in a press release. "Given our recent history, we expect a slim margin

between those who make the playoffs and those who do not. Competition down the stretch is certain to be intense."

The four highest seeds will have home ice for the quarterfinal rounds with the four winners advancing to the TD Garden for the Hockey East semifinals and Championship Game — slated for March 22-23. Ticket information will be made available at a later date.

No Hockey East media day would be complete without the presentation of the Joe Concannon Award. NESN broadcaster Tom Caron was named the recipient of the award, which is presented to a media member "who has demonstrated an outstanding body of work in covering and promoting the interests of the Hockey East Association." The award is named in honor of the late Boston Globe sportswriter Joe Concannon, who died in 2000.

Caron, who serves as the studio host for Red Sox programming on NESN, also calls Hockey East telecasts in the winter and is the voice of the Beanpot Tournament.

This year's Beanpot tournament is scheduled for February 4th and 11th at the Garden. Boston College will meet Harvard in the first game on opening night with Boston University facing Northeastern in the nightcap. The two winners will meet one week later in the championship game.

BOSTON BRUINS MEDIA DAY — was also held, not at the Garden, but at the Warrior Arena practice facility in Brighton.

Fresh off their trip to China, the Bruins brass assessed the trip to the Asian nation in a variety of ways. Club president Cam Neely started things off in a lighthearted manner, noting that "I said I wasn't going to complain about Boston traffic anymore, but that lasted until this morning."

Neely noted that a practice had to be scratched but that he "thought the players really enjoyed themselves on the trip. They did bond well and they did a lot of activities together. I think it was a great opportunity for some of the veterans to get to know some of the new players."

CEO Charlie Jacobs brought up an interesting point as the NHL attempts to build an identity in a new market: the Chinese people may be more accustomed to the timing format of other games — particularly basketball.

"There was an element of bonding between players and front office officials during the trip that I don't think would have occurred if we had stayed in Boston," noted Jacobs. "It was a good opportunity."

"The games themselves were by and large sold out. But through my experience, I think we probably had a lighter crowd in the third period than we did in the other two. I'm not sure if the event-goers understood that hockey is a three-period game. Maybe they thought it was two and it was done, like a basketball game perhaps. But I do think there was significant interest. We had a very warm welcome and I think it's great for our sport to get exposed to such a large population."
