MBTA Releases Proposed Service Changes to Match New Ridership Patterns

No Fare Changes are Included in Proposals and Service Adjustments are Not Permanent Public Outreach Underway through December 4th — FMCB Will Vote on Proposals December 7th

proposed changes to its transit service that are intended to match service to new ridership patterns resulting from the COVID-19 pandemic. The proposed changes are part of the T's Forging Ahead effort to define and protect its core essential transit services.

A letter from MBTA General Manager Steve Poftak to riders regarding the Forging Ahead process and the proposed service changes can be found online on the MBTA website. The public is also encouraged to view these proposals and participate in the public engagement process, which is now underway and run through December 4th.

This comprehensive public engagement process includes

The MBTA released a series of a series of virtual public meetings, a public hearing, a team of Community Liaisons who are already gathering feedback directly from riders, and an online comment form for customers to voice and share their thoughts with the T. Specific details of these proposals and the public engagement processes are available at: mbta. com/ForgingAhead.

> As a result of the decline in ridership that is similarly impacting transit agencies across the country, the MBTA is now only transporting 330,000 trips on an average weekday — but is continuing to run the same high levels of service as it ran to serve 1.26 million daily trips prior to the pandemic, an unsustainable level of service delivery.

"COVID-19 has had a significant impact on ridership and the MBTA is releasing these proposed changes to adjust to the realities created by COVID-19, while protecting service for those who depend on it most," said General Manager Steve Poftak. "I want to reassure our riders that these service changes are not permanent, do not include any fare changes, and will not take effect immediately. We are carrying out a comprehensive outreach process and encourage all members of the public to provide comments and feedback, as we want to hear from riders to help us identify and transit-critical populations and communities."

The MBTA is proposing a series of service changes in addition to preserving its base-level service, or its minimum level of service as determined by the Fiscal and Management Control Board. The MBTA will continue to provide sufficient service for the current, reduced ridership on all modes except the ferry system, which is being proposed to be temporarily closed. The proposed base service levels are designed to ensure adequate capacity for all essential services as well as a reduced level of non-essential service that is still protect the services that support viable for most of those who are

currently using the T. The T's base service includes approximately eighty essential bus routes, The Ride, the whole of the rapid transit system including subway, and the Fairmont Commuter Rail line.

"The vast majority of MBTA service will continue, and these service adjustments are being proposed to preserve and protect service for those who depend most critically on the MBTA by reducing primarily non-essential services," said Transportation Secretary and CEO Stephanie Pollack. "Using limited resources to operate

Cross Street Ventures LLC has filed a Letter of Intent with city officials to build a sixstory hotel between Salem and Endicott Streets along Cross Street in Boston's North End. We spoke with the principal of 6M Development, Bill Caulder, who is also a longtime resident and parent in the neighborhood. Caulder previously worked on the Victor in the Bulfinch Triangle and has redeveloped multifamily units in the


The site faces the Rose Kennedy Greenway on the front side and Morton Street

is enthusiastic about bringing new activity to the park and working with the Friends of Cutillo Park group.

Preliminary plans call for a 125-140 room boutique hotel with a 50-60 seat hotel restaurant and a second full-service restaurant of a similar size. The total building footprint will be approximately 13,363 square feet according to the LOI as filed by Fort Point Associates to the Boston Planning and Development Agency.

Caulder said, "We have been reaching out to neighbors and look forward to continuing that as we move forward in the process." The team is working on renderings, including possible roof gardens, hotel amenities, and Italian-style

HORSES THAT EAT PEOPLE

Stories will always be told about the various circumstances under which men have eaten horsemeat. The story that is told today is reversed and tells of some horses that ate people.

The legend starts with a man named Diomedes. There were at least three famous men in antiquity who bore this name. The first Diomedes was a king, and one of the bravest of the Grecian chiefs in the Trojan War. The second Diomedes was a Roman grammarian who lived during the 4th century A.D. And the third man, our subject for this article, was a king of the Bistones, a Thracian people who dwelt near the Aegean Sea. This king was a son of Ares. We remember Ares as the Greek god of violence, brute force and the slaughter of war. It was often said that Diomedes inherited many of the violent characteristics of his father.

For his eighth labor, Hercules was required to go to Thrace and capture the four flesheating mares of Diomedes. The travel route took the strong man through Thessaly, where he was hospitably received by King Admetus. The king was in mourning for his wife, but out of respect for Hercules, and in order that his guest's pleasure would not be lessened, Admetus pretended that the dead person was a minor servant in the household.

While becoming familiar with the king's palace, Hercules was told that it was actually Alcestis, wife of King Admetus, who had died. Also, learning that Thanos, the Greek god of death, was about to carry off the woman, Hercules rushed to the Queen's casket, ambushed death and took her from him by force.

After returning Queen Alcestis to her grateful husband, Hercules and a small band of followers journeyed to Thrace. The grooms of Diomedes were quickly overpowered and the mares herded toward the boats. Some of the Bistones came in pursuit, causing Hercules to leave the mares in the care of his young assistant Abderus while the pursuers were being repulsed. After killing King Diomedes and driving off the other Bistones, Hercules returned to the boats. One version of the story tells of the mares attacking and consuming most of Abderus, while a second account claims that Hercules calmed the voracious beasts by feeding Diomedes to them. The mares were finally brought back to the city of Tiryns and presented to King Eurystheus as was required.

The horses were freed but were attacked and killed by wild animals on Mount Olympus as they attempted to find their way back to Thrace.



NEMPAC Begins to Transform 48-50 Tileston Street into Tileston Music Center

State-of-the-Art Facility to Triple 501(c)(3)'s Boston Footprint



North End Music & Performing Arts Center (NEMPAC) announced on November 10th it will forge ahead transforming 48-50 Tileston Street, awarded to the 501(c)(3) by the City of Boston and Mayor Marty Walsh, into a state-of-the art music center. Located in downtown Boston, this 2,200 square foot public music center will offer community members both professional performances and opportunities to study creative movement, music, performing arts, theatre, and voice.

This expansion of NEMPAC's campus will triple its Boston footprint, providing the space needed to launch programming innovations, as well as additional private and small group instruction rooms. From community collaborative music nights for local musicians of all levels to adult practice hours, programming plans for *Tileston Music Center* will prioritize accessibility, engaging rising and professional artists

Tileston Music Center will feature three floors equipped with acoustic doors and panels, STC-rated sound proofing, and recording technology:

Third Floor: New Music Classroom and Rehearsal Space Second Floor: Two New Private and Group Instruction Studios | New Keyboard Lab and Music Technology Room

First Floor: Multi-Use Accessible Ground Floor Community, Intimate Performance, and Reception Space "The pandemic continues to underscore the critical role of the arts in strengthening and uniting communities," said Sherri Snow, executive director at NEMPAC. "Tileston Music Center is an opportunity for community members in the North End, Charlestown, and surrounding Boston neighborhoods to find hope and comfort together as one NEMPAC family through the transformative power of the arts."

As NEMPAC kicks-off its capital campaign, the original goal was set at \$750,000. However, due to the pandemic and the need to secure the future for the arts going forward, NEMPAC has increased its goal to \$1 million.

L'Anno Bello: A Year in Italian Folklore An Appreciation for November

Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing (and mask wearing!) is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations—and as suggestions for ways to spend time in the future once this pandemic is finally over.



I first noticed the commercials a few days before Halloween. Ads for layaway deals in bigbox stores began to pepper my television viewing experiences, replete with images of smiling Santas, rolling ornaments and the sound of chattering jingle bells. Whenever one of these commercials caught my eve, a familiar, tingling sense of anticipation crept over me as I thought of the pleasures of the holiday season: swirling snowflakes, cookies baking in the oven, Christmas carols on the radio, potato latkes on sale for Hanukkah, trees illuminated with dozens of twinkling lights. However, I soon brought myself back to reality. I looked outside at the last yellow leaves drifting down from bare branches, the cornstalks and pumpkins decorating neighborhood homes. Halloween may be over, but we still have the whole month of November to enjoy! It is very tempting to dive into the pleasures of the holiday season early on, but the pulsating rhythms of the seasons and their unique feast days are meant to be experienced slowly, spiced with the trifecta of time, nature and mindfulness. This desire to live the seasons to their fullest proves especially palpable in November. Rather than a mere segue to the frenzied month of December, November boasts its own fascinating customs and traditions. As a month which signaled the end of the harvest and ushered in the beginning of winter, Italians honor the many faces of November, and their

At times, November can appear to be a somber month, sober and silent. Its skies are thick gray blankets outlined by bare, black branches. Dead leaves collect in clumps across the wet ground. Night wraps its dark cloak around the Earth early in the evening, uninterrupted by the colorful holiday lights that start to appear much later in the month. Winter feels imminent as the first bewildered snowflakes spiral down from the slate-colored sky. This is the month when nature settles into a nap, slumbering until its rebirth in the spring. Old Italian proverbs, hailing from the days of a primarily agricultural society, speak of the month's chilly, bleak characteristics. A dictum stating "Per Ognissanti, mantello e guante" reminds Italians to start putting on their coats and gloves on All Saints' Day, or November 1st. Another maxim, "Per Santa Caterina, la neve si avvicina," warns that snow looms close around the time of November 25th, the feast day of St. Catherine. 

Proper Storage Extends the Life of Leftover Seeds

by Melinda Myers

As you pack away the garden hose, tools and other supplies or transition to your winter garden, do not overlook those leftover seeds. Proper storage can extend their life so you will need to buy fewer seeds next season. With another shortage of garden seeds predicted for 2021 you will be glad you did.

Leave the seeds in their original packet whenever possible. It contains all the information you need to make planting easier and increase your success next season.

Place the seed packets in an airtight container such as a recycled jar or plastic storage container. If you have lots of seeds, consider organizing them as you pack them away for winter.

Arrange them alphabetically from A to Z using dividers for each letter of the alphabet or organize them by planting season. Group seeds to be started indoors together and those that go directly in

the garden by the month they should be planted.

Seal the lid on the container and place in a cool, dark location. The refrigerator is perfect, providing consistently cool temperature that increases seed storage success.

The longevity of a seed not only depends on proper storage, but also varies with the type of seed.

Eggplant, muskmelon, and Brussels sprouts will last five years or more while onions and parsnips may only last a year. Give leftover flower seeds the same care. Heliotrope, verbena, sweet William, geraniums, and Shasta daisies typically last one or two years.

Impatiens, Geums and Tithonia (Mexican sunflower) usually maintain viability for two years while ageratum, alyssum, amaranth and yarrow can last four years or more.

Take an inventory of your seeds as you pack them away in storage. Reference this list as you begin planning next year's garden. You will be able to see what seeds you already have and focus on those you need.

If you have extras or seeds you do not plan to use, consider sharing some with a friend. Most of us do not need to plant all 20, 30 or more seeds in a packet. Sharing and trading with friends or donating to schools, community gardens, master gardeners,

or other groups that may lack the resources to buy their own seeds is a great way to make a difference. Everyone will save money while growing beautiful and productive gardens.

Do not discard older seeds. They often outlast the average and continue to sprout at an acceptable level. You can test the seeds prior to planting. Just take ten seeds and wrap them in a damp paper towel. Then place in a plastic bag and wait to check for sprouting in a week or two. If all the seeds sprout, you can plant according to the packet. If only half sprout, you need to seed twice as thick.

And if you find some of your old seeds are no longer viable, use them to create seed art and other projects. It is a fun way to repurpose these seeds.

Be sure to add packing up leftover seeds to your fall to-do list. You will be glad you did when it is time to plan and plant next year's garden.

Blessed Maria Velotti

Maria Velotti was born on November 16, 1826, in Soccavo, Naples. Her parents were Francesco Velotti and Teresa Napoletano. Maria was orphaned before the age of three. She was raised by an aunt named Caterina who was virulently opposed to Maria's piety and call to religious life. Maria's situation became untenable at home and her neighbors Lorenzo Sabatino and Giuseppa Tuzzolo took her in and raised her as their own. Maria could barely read or write.

Maria's half-brother Giovanni (from her father's first marriage) remained in Soccavo and a chance meeting between the two in adulthood revealed their familial connection.

From a young age, she lived Franciscan spirituality under the guidance of the Friars Minor as a laywoman professed in the Third Order of St. Francis of Assisi. She took the name Maria Luigia of the Blessed Sacrament as her religious name. Maria was deeply committed in the way of



poverty and humility and experienced several visions in her life after spending several years in prayer and penance.

In 1877, she co-founded, with Eletta Albini the new religious order of the Franciscan Sisters Adorers of the Holy Cross for the education of girls and the promotion of women. In this way, with her work, she was fully immersed in social charity that characterized the Church of Naples in the 1800s. She passed away in the motherhouse of the Institute in Casoria on September 3, 1886, after a long and debilitating illness.

Sister Maria was Beatified on September 26, 2020, in Naples, Italy by Cardinal Crescenzio Sepe.The Feast Day of Blessed Maria Velotti is September 2nd.

A Nostalgic Remembrance



This week, we celebrated Veterans Day on November the 11th. When I was a kid, this holiday was called Armistice Day, and celebrated the end of WWI. In 1954, Congress changed the name of the holiday to Veterans Day to include and honor the men and women who fought in WWII and Korea.

My family has always loved the military. Babbononno came to America as a member of the Royal Italian Marine Band. While here, serenading President Grover Cleveland and the politicians in Washington, he was informed that his wife died in child birth. He resigned his commission and never went back to Italy. When he married Nanna and they had sons, he taught them to honor the flag and respect the military. They did.

After WWII began, Uncles Nick (my Godfather) and Uncle Gino were of draft age and both decided to wait until they were called and then enlist. Uncle Nick joined the Navy and Uncle Gino, the Army Air Corps. My father decided to do the same thing, wait and then join the branch of his choice. In his case, it was the Marine Corps.

Uncle Gino flew and fought his way through the Pacific, first in a B-17, and later in a B-29. Uncle Nick auditioned for the Andre Kostelanetz Orchestra and made it into the reed section. As a result, he spent WWII serenading the sailors stationed at the Newport, Rhode Island Naval Base. Dad was teaching machine shop and shop math at East Boston High School when the war began and had planned to do the same thing: wait until he received his draft notice, and then join the

Dad was called out of his classroom one day and spoken to by two men from the Office of Strategic Services (OSS), the forerunner to today's CIA. They recruited him to interrogate the Italian war prisoners, that were sent to Boston and housed at the old forts on some of the Boston Harbor islands, and also at the closed immigration station located in East Boston. His acceptance of this chore gave him a deferment and eliminated him from the draft.

my great uncles and aunts the statue of Butch O'Hare and fought in WWII, and thank his Medal of Honor both located God, all survived. But, my family's involvement in WWII wasn't the reason I decided to write this week's story. It was due to a story a friend from Florida sent me and I thought I would share it with you, so here goes:

PART ONE:

Back in the day, Al Capone virtually owned Chicago. He had a lawyer nicknamed "Easy Eddie." He was skilled at legal maneuvering and kept Capone out of jail for many years.

To show his appreciation, Capone paid Easy Eddie very well, very very well. Eddie and his family lived in a mansion and had several servants working the estate. Eddie gave little consideration to the atrocities perpetrated by Capone, but he did have one soft spot, however. He had a son that he loved dearly, and saw that his son had the best of everything ... price was no object, but he also brought him up with the best of Christian values.

In spite of the man he worked for, Eddie wanted his son to be a better man, but he couldn't give his son a good name nor set a good example for him.

Eddie's conscious finally got the best of him and he testified against Capone and his mob. Within the year, "Easy Eddie" was gunned down on the streets of Chicago. The police found a poem in one of his pockets that was dedicated with love to his

PART TWO:

WWII was underway, and Lt. Commander Butch O'Hare was a Navy fighter pilot assigned to the aircraft carrier U.S.S. Lexington, which was fighting in the South Pacific. O'Hare flew and fought in many battles, sometimes running out of ammunition and fuel. In each case, he continued to attack enemy planes, clipping their wings and tail sections to knock them out of the sky. His gun camera proved this. His greatest victory, taking place on February 20, 1942, was downing five planes in one sortie without any ammunition left. He became the Navy's first Ace of WWII and the first naval aviator to win the Medal of Honor. Unfortunately, a year later, O'Hare was killed in aerial combat at the age of

His hometown of Chicago would not allow the memory of this WWII hero to fade away. They named the airport in Chicago "O'Hare International" after their fallen hero. I have Many of the children of seen the memorial displaying at one of the terminals at that airport ... very impressive.

> OK, what do these two stories have in common ... Butch O'Hare was "Easy Eddie's" son.

> In my generation, many of my closest friends served in the military. We are of the

Vietnam Era. As a teacher, many of my students headed to Vietnam and never came back. Thank God, most of my friends made it home. On the 11th, I silently honored some close friends who served our country in a time of need, Colonel Dean Saluti, Colonel John Silva Jr., the late General Bill Hurley, General Joseph Carter, General Frank Labolita, the late Sergeant Ernie Fabbraio, the late Captain Leroy Ramsey, my godson General Mike Finer, those former students of mine that never returned home, and my late father-in-law Frank DeVito, who served aboard a couple of aircraft carriers in WWII. He fought in the Battles of the Coral Sea and Midway Island, was torpedoed and hit by kamikaze fighters, thrown overboard, waking up half way around the world at the San Juan Naval Hospital in Puerto Rico. He was a tough guy, originally from Chelsea Street

Thank God, my sons didn't have to experience what my generation has gone through. Thinking back, I can't remember when there wasn't a war going on. I was born just before WWII. I tried to enlist when the Korean War started, but I was only 13 years old and the recruiter sent me home. I've seen the effects of Vietnam, the Gulf War and Afghanistan (and everything else in between) on our men and women in uniform. Sometimes it wasn't pretty. Anyway, here's to those who served our country in time of need. Let's hope we don't have to call upon your sons and daughters nor grandchildren in the future, and due to our military's efforts, maybe we won't. Let's remember the past, because it has a dramatic effect on our future. So, happy Veterans Day.

Of all pastries, you would most likely never think of Italy when the word "strudel" is mentioned. However, in the Trentino-Alto Adige region of northern Italy, strudel is extremely popular. In fact, Strudel di Mele or Apple Strudel is Trentino's signature dessert. Traditionally, this dish was made from apples, pine nuts and raisins or currants that were rolled up in a paper-thin puff or shortcrust pastry. Strudel is so prominent in this region that it is even celebrated at a yearly Strudel Week festival held in the town of Castelrotto in late August early September. This festival features demonstrations on the art of making strudels as well as offers an array of delicious sweet and savory strudels to sample.

Strudels may appear hard to make; however, they are actually quite easy and can be made in very little time. When my Nonna made Strudel di Mele, she would make it with apples and raisins enveloped in her signature shortcrust, or simply with just apples enclosed in a scrumptious flaky puff pastry. While I love both versions, the strudel I am sharing today is made with puff pastry, and is extremely simple to make. I guarantee you and your family will love this version of Strudel di Mele. As this delicious dessert bakes in the oven, be prepared for your kitchen to be filled with the most amazing apple cinnamon aroma you will ever experience. Strudel di Mele is absolutely delicious and makes the perfect holiday dessert, particularly when served warm with a scoop of vanilla gelato!

APPLE STRUDEL Strudel di Mele



Puff Pastry (can also substitute 2 sheets of store bought) 1 1/4 cups very cold butter, cut 1/4 teaspoon salt 2 cups all-purpose flour into small cubes ½ cup ice cold water

Using a food processor, add flour and salt to the bowl, pulse. Add 3/4 cup ice cold butter and pulse about 10 to 12 one-second pulses. Add the remaining cold butter and pulse 3 to 4 times to combine. Slowly add the cold water and pulse just until the dough comes together to form a ball. Do not over process. Place dough on a lightly floured dough board and knead approximately 10 times. Flour a rolling pin and roll into a rectangle that is about 12 x 18 inches. Fold the dough in half, and then in half again, and again. Wrap dough in plastic, and refrigerate for 2 hours.

Filling

4 cups apples, peeled and cut into small slices or cubes 1/4 cup granulated sugar Zest of 1 organic lemon 2 heaping tablespoons allpurpose flour ½ teaspoon cinnamon

1/3 cup raisins or currants

(optional) 1/3 cup pine nuts (optional) 1/4 cup plain breadcrumbs ½ cup and 2 tablespoons melted butter *Extra granulated sugar for sprinkling

Preheat the oven to 350°. Line a baking sheet with parchment paper and set aside.

In a large mixing bowl, add apples, sugar, lemon zest, flour and cinnamon, mix well. If desired, add raisins or currants and pine nuts (I did not use either). Set mixture aside.

In a skillet, melt 1/4 cup butter, add breadcrumbs and cook until toasted and golden colored, set aside.

Place homemade or store-bought puff pastry dough on a lightly floured dough board. Carefully roll into a rectangle (dough should be thin). Take 2 to 3 tablespoons toasted breadcrumbs and sprinkle evenly over dough, leaving about an inch around the border free. Evenly distribute apple filling over breadcrumbs, leaving about an inch or so around the border free. Carefully roll up into a jelly roll/strudel making sure all edges are tucked and sealed around the filling. Gently place strudel seam side down on the prepared baking sheet and brush top and sides with remaining melted butter. Sprinkle generously with granulated sugar and bake for 45 to 75 minutes (depending on oven and size of strudel) until

nearly empty trains, ferries, and buses is not a responsible use of the funding provided to the MBTA by riders, communities, and taxpayers, and does not help us meet the transportation needs of our region. We look forward to working closely with the public to ensure we continue providing essential service and help the MBTA afford the growing service we will need to support our customers and communities in the future."

The proposed service changes announced on November 9th will not go into effect immediately. While some service changes on the Commuter Rail could take place as early as January 2021, the changes to Commuter Rail would be made in March, rapid transit changes would be made in spring 2021, and buses changes would happen later in the summer. This will allow the MBTA to adjust the proposed basic service if warranted by changes in ridership and if additional, durable revenue becomes available.

Service levels will be continually reassessed based on the status of the state of emergency, commuting patterns, and ridership and fare revenue recovery in 2021 and beyond. The MBTA is also proposing service packages that will include options to increase service once ridership returns and the T's revenue improves.

The MBTA is hosting a series of public engagement efforts that will run through December 4th to receive public feedback on the service changes that includes a series of virtual public meetings, and a public hearing to gather feedback directly from riders, and an online comment form for customers to engage with the T.

The T wants to hear from transit riders about the services people are using now, how often they are using them, and what their transit priorities are in order to shape the T's decisions about protecting transit-critical services

The FMCB is scheduled to vote on the changes on December 7th, so that planning can begin for making the changes in 2021.

Proposed service changes beyond the base-level service include:

Rapid Transit:

The Red, Orange, Blue, and underground Green Line stations are experiencing approximately 120,000 gated entries on weekdays, which is about 24 percent of its pre-COVID numbers. Proposed service level changes for the Red, Orange, Blue and Green lines and Mattapan trolley include:

- Weekday and Saturday service will operate from 5:00 a.m. to midnight (currently until 1:00 a.m.) and Sunday service will operate from 6:00 a.m. to midnight (currently until 1:00 a.m.).
- Reduce peak frequency by 20 percent and reduce off-peak frequency by an additional 20 percent on all lines.
- The Green Line E Branch will terminate at Brigham Circle with customers able to transfer to Bus Route 39, which mimics E Branch service from Brigham Circle to Heath Street.

Bus:

Buses are experiencing about 171,000 weekday boarding, which is approximately 41 percent of its pre-COVID ridership. Proposed service level changes include:

- All bus service will stop at midnight, though early service will continue on essential bus
- Eighty essential bus routes will see an average change in service of just 5 percent and routes with high ridership will not be changed.
- · Sixty non-essential bus routes will operate 20-30 percent less frequently.
- Approximately ten routes will be consolidated or restructured.
- Approximately twenty-five routes that served less than 0.5 percent of pre-COVID riders (about 1,700) will be eliminated.

Commuter Rail:

The Commuter Rail is experiencing approximately 13 percent of its pre-COVID ridership with about 8.5 percent of its normal ridership during morning peak periods. As a result, the following changes are proposed (with the exception of the Fairmount Line):

• No evening service after 9:00 p.m.

No weekend service (except for the Fairmount Line, which will be bused).

- · Decreased weekday peak service and some midday service, reducing from 505 trains (fall 2019) to 430 trains.
- · Close six (out of 141) stations based on low ridership, operational impacts, and availability of alternatives.
- Specific service levels by line will take into account ridership patterns from adjusted Fall 2020 schedules with more balanced service throughout day.

Ferry: Ferry ridership is approximately 12 percent of pre-COVID ridership, averaging 7 passengers per boat, and passengers have either bus or commuter rail service as an alternative. As a result, all Ferry service (F1, F2H, F4) is proposed to be

- Charlestown/Boston service (F4) has experienced very low COVID ridership and highly redundant bus service is available on Route 93 (an essential bus route which currently has minimal crowding and can support diverted ferry riders).
- Hull and Hingham service has also experienced very low ridership due to COVID-19 and passengers can use the Commuter Rail Greenbush line.

The RIDE:

- · With changes being proposed to the area and hours of operation of fixed route services, some RIDE trips may become "premium trips," though RIDE service boundaries would not
- Some trips will be able to be booked forty minutes from request time instead of the current thirty minutes.

The public is strongly encouraged to submit feedback online and/or participate in any of the eleven virtual public meetings, including an Official Public Hearing, where input may be provided and questions can be asked of MBTA officials. At every Forging Ahead public meeting, either Transportation Secretary Stephanie Pollack, General Manager Steve Poftak, or one or more members of the Fiscal and Management Control Board (FMCB) will be present to listen to public comments. All public comments on Forging Ahead received during public meetings, provided to MBTA Community Liaisons during engagement sessions, or through the online

comment form will be shared with members of the FMCB and senior executives, including the Secretary of Transportation and General Manager. MBTA Community Liaisons are also available by emailing: publicengagement@mbta.com to schedule in-person, phone, or online meetings with individuals, local municipalities, or neighborhood organizations to provide information and seek community feedback. HOOPS and HOCKEY in the HUB

There will be NBA basketball over the holidays — including Christmas afternoon and night - thanks to the players and league executives signing off on an agreement shortly before Veterans Day.

The agreement calls for an abbreviated 72-game regular season schedule (82 is the normal number) followed by the playoffs. Specific schedules for individual teams were not announced with the league stating that they would be forthcoming at a later date.

One aspect that the league is very concerned about is cutting down on travel. Under one scenario making the rounds, some teams would play two consecutive games in another team's arena, thus completing the season series for the year at one site.

For example, if the Chicago Bulls came east, they might play two games against the New York Knicks as well as two games against the Brooklyn

They might then travel up to Boston for two games against the Celtics or travel at bit south for two games against the 76ers in Philadelphia followed by two games against the Washington Wizards in D.C.

There has even been a report that the Toronto Raptors — the 2019 NBA Champions — might be shifted to Newark, New Jersey for the regular season because of tight travels restrictions on entering Canada from

Those restrictions led Major League Baseball to move the home games of the Toronto Blue Jays to Buffalo this past summer. The NHL was granted a special exemption after it promised to house its competing teams in bubbles set up in Toronto and Edmonton.

If Toronto home games are shifted to Newark for the coming 2020-2021 NBA season - something the Raptors are negotiating hard to avoid—this would mean that teams visiting the east coast could play as many as 12 games in a relatively compact geographical area two games apiece against the Knicks, Nets, and Raptors in Greater New York followed by a pair of contests against the Celtics in Boston and then two games each against the 76ers and the Wizards.

The travel restrictions put in place by the Canadian federal government are obviously also affecting the NHL — which has said it hopes to begin on or around New Year's Day. One current proposal under serious consideration is for the NHL to declare certain cities in the U.S. "hubs" for hockey. A number of teams from various locations would then go to these designated sites, play a number of games and then return home for 10 to 12 days. They would then repeat the process at the same hub or a different one as the regular season progressed.

For example, a team would go to site A and play a number of games against several opponents. The team would then go back to its home city for a break before resuming action at site A or another site.

"It's not going to be quite as effective as a bubble," noted NHL Commissioner Gary Bettman. "But we think we can, if we go this route, minimize the risk, to the extent practical and sensible. And so that's one of the things we are talking about." A Canadian division is also possible as Bettman noted that a temporary alignment may be needed "to deal with geography."

Greater New York might seem a natural location for one such site given that the Rangers, Islanders, and Devils already play there. However, New York State currently prohibits fans at college or professional sporting events. In New Jersey, where the Devils play, fan attendance at youth sports and high school sports is currently limited to 25 percent of capacity while fan attendance at pro and college outdoor games is limited to 500 — just 150 if indoors. Massachusetts banned hockey games at all levels in any indoor setting from October 23rd to November 7th

Restrictions such as these are regional, not national. At least 17 NFL teams are allowed to have some fans in attendance. Syracuse University in upstate New York can't have fans in the Carrier Dome — but played before 19,000 recently when the Orange took on Clemson in South Carolina.

Thus, it might seem that if the NHL were selecting "hubs" for hockey, those with less restrictive guidelines might be considered more warmly. Would league executives actually select a site in a state that had banned hockey (just the playing of hockey, even with no fans present) for a period of time? What if the ban were activated again during the NHL season?

And even if the NHL does not go with the "hub" proposal and allows all teams to play in their home arenas, it still would mean that the Bruins and all college and amateur hockey teams in Massachusetts would be playing in a state where such a ban could be reactivated at any time.

Another consideration is the rescheduled Summer Olympic Games in Japan, now set to start on July 23rd

This obviously affects the NBA since the entire Team USA roster is slated to be comprised of NBA players with the league's international stars forming the nucleus of their respective national squads.

But it also affects the NHL since the NBC network not only has the broadcast rights for the Olympics, but also the broadcast rights for the Stanley Cup Playoffs.

Thus, both leagues need to have their playoffs concluded by early July at the latest. The NBA should make it because of the December 22nd start date. But the later the NHL begins, the fewer regular season games will probably be played since the playoffs must be concluded by early July in order to allow NBC to have a smooth transition period entering the Olympics.

Quite a bit to ponder as the NBA and NHL take steps towards the start of their respective seasons.
