# Gettysburg Address Turns 150

The Gettysburg Address is one of the most important speeches in American history, delivered by Abraham Lincoln during the Civil War on November 19, 1863. Lincoln's "brief remarks" were a request from the committee for the November 19<sup>th</sup> Consecration of the National Cemetery at Gettysburg and they were delivered during the dedication of the Soldiers' National Cemetery in Gettysburg, Pennsylvania. The speech was short, in only ten sentences Lincoln summarized the war and spoke of American ideals while commemorating those Union soldiers who died in their victorious Battle of Gettysburg four and a half months earlier.

The Battle of Gettysburg lasted three days, from July 1<sup>st</sup> to July 3<sup>rd</sup>. It was the grizzliest battle of the entire Civil War with the biggest number of casualties. The Union defeated the Confederate Army marking a turning point in the course of the rest of the war, even though it went on for two more years. Historians are known to disagree on this

point; some say that this battle was not a turning point, but a strategic loss by the Confederate Army. Nonetheless, the general consensus is that if the Confederate Army had won, the Civil War would have ended then, and that a win for the Union redefined their involvement. Robert E. Lee who was leading Confederate forces at Gettysburg was known to be an almost invincible general, thus his defeat meant a lot for Union morale. Against him was George G. Meade leading the Army of Potomac.

In his Gettysburg Address, Lincoln urged those present to properly honor those deceased by continuing their cause so that "this nation, under God, shall have a new birth of freedom and that government of the people, by the people, for the people, shall not perish from the Earth." In this speech Lincoln redefined the Civil War as a "birth of freedom" and not just a struggle between the Union and the Confederacy making it a staple in the life of the United States of America.

There are five manuscripts of the speech that vary in structure, punctuation, and wording. Two of them are thought to be written by Lincoln before the speech and the other three, years afterward. The most accepted version is the one written for Colonel Alexander Bliss well after the speech was delivered. This one is the only one that he signed and titled. This manuscript is now displayed in the Lincoln Room of the White House.

There are a few events being held in Massachusetts in remembrance to this important speech on its 150th anniversary. The Abraham Lincoln Presidential Library and Museum in Springfield, MA is hosting free educational and entertaining events on November 18th such as a performance by an actress of the memories of a 15-year-old girl who witnessed the Battle of Gettysburg. The Milton Historical Society will present a free program "Four Score and Seven: Remembering the Battle of Gettysburg through Maps" on Tuesday, November 19, 2013. The program will take place at 7:00 pm in the Keys Room of the Milton Public Library, Milton

AT THE DEDICATION SERVICES ON THE BATTLE FIELD

Fourscore and seven years ago our fathers brought forth on this continent a new nation, conceived in liberty, and dedicated to the proposition that all men are created equal. Now we are engaged in a great civil war, testing whether that nation,or any nation so conceived and so dedicated can long endure. \* \* We are met on a great battle-field of that war. \* We have come to dedicate a portion of that field as a final resting place for those who here gave their lives that that nation might live. \* It is altogether fitting and proper that we should do this. \* \* But in a larger sense we cannot dedicate, we cannot consecrate, we cannot hal-low this ground. \* The brave men, living and dead, who struggled here, have consecrated it far above our poor power to add or detract. The world will little note, nor long remember what we say here, but it can never forget what they did here.\*\* It is for us, the living, rather to be dedicated here to the unfinished work which they who fought here have thus far so nobly advanced It is rather for us to be here dedicated to the ëreat task remaining before us, that from these honored dead we take increased devotion to that cause for which they gave the last full measure of devotion; \* that we here highly resolve that these dead shall not have died in vain: that this nation, under God, shall have a new birth of freedom, and that the government of the people, by the people, and for the people, shall not perish from the earth

#### POW/MIA Chair Dedicated at Natick

This past week we observed Veterans Day. Without question, we do right to honor our soldiers, seamen, airmen, and marines with a public holiday. As we honor those among us who served, we should also think of those who served but are not among us to enjoy the freedoms they fought for.

Today, there are still more than 83,000 American service men and women missing in action, according to the Department of Defense Prisoner of War-Missing Personnel Office. That includes almost 74,000 from World War II; nearly 8,000 from the Korean War; more than 1,600 from the Vietnam War; 126 during the Cold War; and 6 from the Iraq War and other conflicts.

Darren Bean, the representative for the veterans of the Natick Soldier Systems Center, wanted to remember those who were and still are prisoners of war and missing in action. This past Tuesday, the day after Veterans Day, in Natick, a chair, made of granite, was installed outside of one of the Department of Defense buildings, as a standing memorial to everyone affected.

# Saint Columban, Abbot



Columban was born in Leinster, Ireland about the year 559. As a young man he resolved to live an ascetic life. To escape the temptations of the world, he left his home town against the pleas of his mother and placed himself under the direction of Sinell, Abbot of Cluaninis in Lough Erne, he then went to an abbey in Bangor, County Down where he remained under the direction of the Abbot Congall.

Longing to spread the faith to other lands, Columban at 30 years of age left Ireland with 12 other live alone in the forest. monks, crossed Great Britain and landed in Gaul, he found the Catholic faith in existence but for the most part ignored. It was there that Columban and his followers spent several years preaching the Gospel. Eventually Columban arrived in Burgundy where he was received favorably by King Gontram, grandson of King Clovis. Befriended by the king who wanted Columban and his monks to remain in Burgundy he was given the ancient Roman castle of Amegray where the monks lived in community. Columban often left the con-

another Roman named Luxeuil where a second community of monks was established. It was destined to become the foremost monastic school in seventh century Gaul and lasted until the French Revolution. A third community was then established to contain the many hundreds of disciples who continued to flock to the monasteries. Columban had secured the favor of the ruling class who gave generously to the support of the communities many joining his ranks.

During his twenty years in France, Columban became

## **WEST END MUSEUM Seeks Donations**

the French bishops who may monks. Columban made his have feared his growing influence. During the first half of the sixth century, the bishop's absolute authority over religious communities. As heirs to the Irish monastic tradition, Columban and his monks used a method of calculating the date of Easter distinct from the system used on the continent. The bishops objected to their traditional celebration of Celtic Easter, as well as their Irish monastic tonsure.

Columban then entered into a dispute with King Theodoric, questioning and condemning the King's disordered and immoral life. The king gave orders that the saint and the Irish monks where to be sent back to their own land. The vessel carrying Columban and his monks ran aground; convinced that his holy passenger caused the tempest, the captain refused further attempts to transport the way across Gaul to visit King Chlothar II of Neustria at Soissons where he was well offers to stay in his kingdom, Columban left Neustria in 611 for the court of King Theudebert II of Austrasia in the northeastern part of the Kingdom of the Merovingian Franks.

Hethen decided to cross

the Alps into Italy. Columban arrived in Milan in 612 and was warmly received by King Agilulf and Queen Theodelinda of the Lombards. He immediately began condemning the teachings of Arianism, which had enjoyed a degree of acceptance in Italy. He wrote a treatise against Arianism, which has since been lost. Queen Theodelinda, played an important role in restoring Nicene Christianity to a position of primacy against Arianism, and was largely responsible for the king's conversion to Christianity.

King Agilulf gave Columban track of land called Bobbio between Milan and Genoa near the Trebbiaricouncils of Gaul had given to received. Despite the king's verto be used as a base for the conversion of the Lombard people, it was there that Columban erected a monastery in 614. Bobbio Abbey at its foundation followed the Rule of St. Columban, based on the monastic practices of Celtic Christianity.

During the last year of his life, Columban was asked by King Chlothar II, to return to Burgundy, now that his enemies were dead. Columban did not return, but requested that the king always protect his monks at Luxeuil Abbey. He prepared for death by retiring to his cave on the mountainside overlooking the Trebbia River, where, according to tradition, he had dedicated an oratory to Our Lady. Columban died at Bobbio in November 615. His feast is celebrated on November 23<sup>rd</sup>.



certainly deserves the vote of confidence by his constituents ... Eastie's loss could be Revere's gain. I'm speaking of the casino that East Boston voted down by a small group of individuals. The casino lost by a margin of less than 1,000 votes. Clergy involvement, the dropping out of Caesars Entertainment, and Mayor Tom Menino's retirement as Mayor of Boston may have been the deciding factor. Evidently Eastie anti-casino voters had no tunnel vision and could care less that hundreds will lose their jobs, and hundreds will not be given the opportunity of getting jobs a casino at Suffolk would bring. However, Revere stood their ground, backed Mayor Dan Rizzo, and voted YES. So, Suffolk Downs may go back to the drawing board to find a way to build the casino on the Revere side. Revere officials are cheerleading the idea of shifting the development entirely over the Eastie border. After Revere voters approved the plan on Tuesday, Mayor Dan Rizzo raised the possibility of the Suffolk Downs proposal being reconfigured to fit on more than 50 acres in his city. When the people of Everett voted yes, these people saw the potential a casino would bring to their city and wanted their city improved. East Boston will be just as impacted with traffic if a casino is built in Everett, with no added police and no mitigation money. It's what the "anti-casino"

#### NEHGS PRESENTS FIRST EXHIBIT IN OVER TWENTY YEARS WITH

## RARE MASSACHUSETTS FAMILY TREASURERS

The New England Historic Genealogical Society (NEHGS) presented their first external exhibit in over twenty years as the featured loan exhibitor at the Ellis Antiques Show in Boston from October  $24^{\text{th}}$ - $27^{\text{th}}$  at Boston's historic Cyclorama at the Boston Center for the Arts.

Rare historical artifacts and significant decorative art pieces highlighted at the show include a family tree with Benjamin Franklin and his Nantucket ancestry, John Hancock's armchair from his Beacon Hill home, and the sword of former Massachusetts Governor, Marcus Morton.

"We are thrilled to share the stories of early Massachusetts families and these cherished items from NEHGS collections with Boston residents and visitors to the Ellis Antiques Show," said Brenton Simons, NEHGS President and CEO.

NEHGS, which discovered the earliest photograph taken of Helen Keller with her teacher Annie Sullivan in its collections that shone media attention from around the world on the institution in 2008, is the oldest genealogical organization in the U.S. The organization actively collects and preserves valuable family history materials, historical documents, manuscripts, photographs, artifacts, and more. Other notable items on exhibit at the Ellis show include a portrait of Captain John Bonner, author of Boston's first engraved map, a bullet taken from the body of Dr. Joseph Warren at the Battle of Bunker Hill, and a cane owned by Peregrine White,  $1^{\rm st}$  child born to the Pilgrims, the son of William and Susanna White.

The Ellis Boston Antiques Show's 2013 loan exhibition celebrates Colonial and Post-Revolutionary family treasures from the New England Historic Genealogical Society's fine art, furniture and rare object collections. For the first time in nearly twenty years, NEHGS is showcasing an external exhibit highlighting unique three-dimensional art and decorative art pieces. Our exhibition includes a selection of paintings, furniture, and historical artifacts that share the stories of families in early Massachusetts.

The oldest nonprofit genealogical Society in the U.S., with over 60,000 constituents, New England Historic Genealogical Society was founded in 1865. To advance the study of family history in America and beyond, NEHGS educates, inspires and connects people through their scholarship, collections and expertise.

The breweries have been battling it out for decades, with trademark disputes still outstanding in more than 20 countries.

Juicy news! Starbucks Corp., hopes to squeeze more out of its juice business. The coffee giant opened a \$70 million factory in Southern California that will churn out 140,000 gallons of Evolution Fresh juice each week.

Hitting the streets! Benjamin Franklin just got a makeover, said Brian Fung in WashingtonPost.com. About 3.5 billion new \$100 bills entered circulation last week, featuring a fresh design that adds new anticounterfeiting measures and technologies to the C-note for the first time in 17 years. Among its new security features are a blue security ribbon and Liberty Bell icons that change their look when the bill is tilted. The new design also includes raised printing along Ben Franklin's shoulder and micro printing along his jacket collar. The bill's back also has a new look — it "features a much larger denomination indicator" and shows the rear of Philadelphia's Independence Hall, rather than the front. The change is "meant to force would-be counterfeiters to change all of the plates they use to print fake money, an expensive undertaking.

The man whose boat became the final hiding place for the suspected Boston Marathon bomber in April has bought a new vessel with donations from generous strangers. David Hennesberry's 22-footer was shot up by federal authorities after Dzhokhar Tsarnaev hid in it at the climax of the post-bombing manhunt. The FBI took away the bullet-riddled boat soon after, but an on-line campaign organized by strangers raised \$50,000 to buy Henneberry a used "fixer-upper" to replace it. "The bad guy didn't win," he said. "That's the way we're looking at it. He didn't take our passion."

Bow wow! Two dozen cities, including San Diego and Los Angeles, have banned retail dog sales, meaning canine pets will be available only via shelters and animal rescue organizations. The ban is based on evidence of widespread cruelty, overcrowding and starvation at the high-volume commercial breeding business or "puppy mills," that supply most dogs to pet stores.

#### BAKED MANICOTTI

In Tomato Sauce with Meat

4 eggs 2 cups flour 2 cups milk Pinch of salt 2 tablespoons olive or vegetable oil 1 small six-inch cast iron or a non-stick skillet

Practice is needed to be sure the same amount of mixture is poured into skillet for the same size manicotti.

Break eggs into a bowl and beat eggs. Slowly add remaining ingredients one at a time in the bowl. Use an electric mixture on slow speed until it resembles a prepared pancake mix.

Rub inside of cast iron or non-stick skillet with some oil. Heat skillet over burner until it is hot. Remove from heat and with a small ladle, drop about two tablespoons of mixture at one end of skillet. Quickly tip skillet to allow batter to spread over the entire bottom. When firm but not browned (about five seconds), remove by lifting round edge with a fork or small spatula. Place in a dish to cool. There should be no need to turn the round over for further cooking. If you do, be sure not to brown the round crepe. Layer eight or ten prepared rounds one on top of the other. Continue making these until all mixture is used. Stir mixture occasionally.

2 pounds ricotta cheese 2 beaten eggs Pinch of salt

Pinch of black ground pepper (optional) 3 tablespoons grated cheese of choice (optional)

In a strainer, remove any excess water from ricotta cheese. Then place in a bowl. Add beaten eggs, salt, pepper and grated cheese of choice if desired. Blend but do not whip with electric mixer.

Taking one Manicotti round at a time, place one to two tablespoon of filling in center. Then fold one end of round over the filling. Take opposite end of round and fold over to seal the filling in the stuffed Manicotti.

Using prepared tomato sauce, cover bottom of a Manicotti baking tray with the sauce. Line bottom of baking tray with rows of stuffed Manicotti (seal side down). Spread tomato sauce over them and then sprinkle grating cheese of choice over sauce. A second layer of Manicotti can be placed over the first layer, or if preferred you can continue the process by using another baking tray.

Bake in preheated 400°F degree oven for twenty minutes. Check to see if ricotta mixture needs to bake longer before removing from oven. Ricotta is cooked when you pierce the Manicotti with a toothpick and it comes out clean.

Serves six.


Manicotti rounds can be frozen. Wrap cooled Manicotti in wax paper in groups of eight or ten. Place in seal-locked plastic bags. Wrap each bag in aluminum foil before freezing. To defrost, remove from freezer and then from wrappings. Prepare a large serving tray with a clean towel. Cover with wax paper and allow defrosting on the towel before stuffing.

# Nanna & Babbononno

by John Christoforo

A Nostalgic Remembrance

There are many things that have gotten lost since the older generation of Italians in America has died out. Non Italian Americans have considered many of these aspects of Italian life a bit quaint, old fashioned or totally European. Among them are two in particular that I was exposed to as a child when my grandfathers were alive. One was wine

making and the other, hunt-

ing for mushrooms. My grandfather, Nunzio DeCristoforo, came from humble beginnings in San Socio de Baronia in Avellino. When he arrived in the late 1800s, he brought with him all the things he had learned as a child. Among them was wine making. From what I understand, most of the Italian peasantry made their own wine and the DeCristoforo family was no exception. Dad had helped his father make wine from the time he was a child growing up in East Boston, and for a time, in Peacedale, RI.

I became involved in the annual wine making event when I was about ten years old. One October morning, there was a knock on the kitchen door at about 6:00 am, when Dad opened the door, there was Grandpa Christoforo standing there holding a sprig with three red grapes dangling downward. Without saying a word, Dad knew that it was time to make the wine and he told me to get dressed.

I jumped into the back seat of Dad's 37 Plymouth. Dad and Grandpa climbed into the front seat and my grandfather told of the shipment of grapes that he had just purchased. He explained to Dad that he wanted to make both red and white wine for the coming year and Dad listened without saying a word. When we arrived at Grandpa's house on Chelsea Street we headed right to the cellar. I immediately inhaled the aroma of wine. The sweet smell of the precontained the wine made the previous year. As I looked around, Dad explained that we were going to help Grandpa and they both would

give me instructions as to what my part in the process would be.

My grandfather first showed us the wooden boxes that contained the grapes slated for crushing and Dad opened them and then showed me how to put them into the press, a cylindrical wooden tub that had a frame above it with a worm gear that suspended a lid. When the grapes filled the lower part of the cylinder, Grandpa lowered the lid into the vat crushing the grapes as it descended. This process continued until all of the red grapes were crushed. There was a smaller press that we used for the white grapes and we repeated the steps to extract the liquid from those

When all of the grapes had been crushed, I watched Grandpa and Dad siphon-off the liquid and pour it into barrels that were in horizontal positions sitting on X shaped frames. Each barrel had a hole on the top where a wellplaced funnel with cheese cloth inside allowed the liquid to be poured in without any debris, twigs or seeds to enter the barrels below.

Grandpa stirred up the crushed grapes in the vats and they were pressed again to extract any liquid not obtained the first time. Any remaining liquid was then poured into the barrels and each was capped with a large wooden peg. Dad told me that Grandpa might have to add sugar to the vats at some point in time but didn't go into detail.

As I looked around the cellar, I saw several empty gallon jugs and a dozen or so whiskey bottles. When the wines were ready to be poured from the barrels, these were Grandpa's containers. When we were finished, Grandpa took two bottles of wine from an earlier pressing, one red and one white, and said, "Andiamo a mangiare." (Let's eat)

We headed upstairs to vious year's vintage domi- his first floor apartment nated the atmosphere. It and I could smell the gravy came from what was left over cooking on the kitchen from the casks that had stove. After placing the wine on the table, he ripped a piece of bread from a round loaf, dipped it into the gravy, sprinkled some grated cheese on it and gave it to

me. I liked the taste and told him so. He smiled, saying, "Fa bene." With that, he set the table and strained a pot of home made gnocchi that had been sitting on the stove. He then poured the pasta into a serving dish and placed it on the table. Next he scooped out gravy meats from the large cooking pot on the stove, placed them on another serving tray which came to rest next to the dish of gnocchi on the table. A serving bowl was filled with the gravy and that too was placed on the table. With the addition of a shaker of grated cheese, we were ready for lunch, but before we could eat, Grandpa poured out three glasses of red wine and we toasted each other, "Salute a la famiglia."

Now I know my grandfather wasn't Mexican, but if you had ever tasted his gravy, you might think he was. It was hot. It was delicious, but very hot. We ate lunch with Dad and Grandpa savoring each sip of wine that was made the year before. I silently wished for a bottle of Royal Crown Cola. I was only a kid and had not acquired a taste for wine at the early age of 10.

Before we left, Grandpa went back to the cellar and returned with 2 gallons of red wine, saying this one's for you and the other for your father-in-law. He knew that Babbononno would enjoy the contents. When we left, Grandpa pulled me aside and slipped me a five dollar bill. He said, "Mi nipote, tu fai buona lavora." (My grandson, you do good work.) I thanked him saying to myself, "I'm rich!"

When we returned back to the big house on Eutaw Street, Dad presented the gallons of wine to Babbononno saying, "Besigliere, mi padre fa dono un regalo per ti." (Besigliere [his nickname] my father sent you a gift.) With that, Babbononno quickly sampled the wine and passed judgment saying, "Ooh, dissa gooda." Of course he had to prove what he said was true and poured himself another glass of wine. All was well with Nunzio DeCristoforo and Michele Contini, Grandpa and Babbononno.



#### These Guys Were All Great Red Sox Players

Boston Globe columnist Bob Ryan recently did a Sunday piece about all the Red Sox "Greats" over the years. Well before my time, there was Smoky Joe Wood a right hander who at age 22 in 1912 went 34-5 with a 1.91 ERA with 10 shutouts and then three more games in that year's 1912 World Series. Overall, he went 117-56 with the Sox. I remember Mel Parnell as a broadcaster. He was a Red Sox lifer going 123-75 with a pair of 20 game seasons and a no hitter in 1956. His best season was 1949. He went 25-7 with a 2.77 ERA. I remember "El Tiante" Luis Tiant who went 122-81 with the Sox with three 20-game seasons, 26 shutouts and 113 complete games

Then there's Babe Ruth, the Red Sox ace left-handed pitcher who was 89-46 and

headed for Cooperstown even before becoming the powerful slugger he became with the dreaded NY Yankees. We can't forget Jimmie Foxx who averaged 36 HRS, 129 RBIs in his first six seasons. His best year was 1938 when he finished with 50 HR, 175 RBI and a .349 average.

Bob Ryan many more of his favorites but these are mine along with others not mentioned by Ryan including Frank Malzone, Earl Wilson and Pete Runnells.

I almost forgot Roger Clemens. The best pitcher of his generation and one of the best in the 20<sup>th</sup> century but the controversy over what he did or didn't do has clouded his greatness. I think he has 354 wins but that doesn't really impress me. I was impressed with his Sox

all his glory. There was former Celtic Ray Allen, who got out of town even faster and earlier than Doc Rivers. Would his famous shots from the corner provide a plethora of nails for the Celtics' coffin on this night?

And there they were — the Celtics. No stars — just a team. Led by a rookie coach from the college ranks who is now experiencing his first season in the NBA.

But there was a surprise on this night. The Celtics could not be dismissed. They hung around. They didn't fade. The men in the Green and White were actually ahead by one point when the buzzer sounded to end the first half, having outscored the Heat by seven points in the second period.

That would be a preview of the final scenario. Once again there was a one point differential, this time in favor of Miami, as the Celtics took control of the ball with a mere sixth tenths of a second remaining in the game.

Gerald Wallace inbounded the ball across the court to Jeff Green in the corner. Up went Green over the outstretched hands of LeBron James. The aim was perfect — right on target — and when the ball went through the net, you knew ESPN had a highlight reel and the Celtics had a memorable 111-110 victory.

Later, Stevens would say: "We just had something kind of crazy happen. We snuck out of there with a win."

It was a victory that caught most observers of the NBA off guard. Wasn't this supposed to be the inept team that would be fortunate to win 30 games? But all along there were signs that the Celtics weren't exactly the terrible team that a number of prognosticators felt they would be.
