Thanksgiving arrives next week and "Black Friday" marks the official start of the holiday shopping season. As you make your holiday shopping lists, I urge you to skip the midnight lines and mall traffic and explore Boston's neighborhood retailers. Our Main Streets districts offer a variety of shops and restaurants where you can find unique gifts close to home. The Mayor's Holiday Special is a great resource for finding deals on holiday events and shopping in Boston.

We are also continuing the annual Holidays on Main Streets campaign, a small business initiative designed to highlight the many festive events taking place in and around the 20 Main Streets districts through the end of December. Businesses are getting into the holiday spirit by participating in our district-wide contest for the best dressed storefront window, offering shopping deals, and hosting fun family events including holiday strolls and tree lightings. Visit www.mayorsholidayspecial.com to find events, deals, and discounts in your neighborhood.

We're even offering free holiday parking hours in commercial shopping districts, making it even easier for shoppers to access their neighborhood retailers on weekends. As is tradition in Boston, weekend shoppers will enjoy

two free hours of metered parking throughout the city's commercial districts, including downtown, starting on "Black Friday," November 25 and continuing on five consecutive Saturdays through December 24. While meters will be free on these days, a two-hour time limit will be enforced by the Boston Transportation Department to accommodate as many visitors as possible in shopping districts.

If you do get a ticket, remember that you can redeem it with a toy donation through the city's "Toys for Tickets" program. The program will allow any driver that is issued a non-public safety parking ticket on Boston's streets between December 5 and December 9 to resolve their ticket by providing a non-violent, wrapped toy of equal or greater value than the fine on the ticket. Toys will be accepted from December 8 through December 16 between the hours of 9:00 AM and 4:00 PM on the second floor of Boston City Hall. To participate in the "Toys for Tickets" program, drivers must bring the parking ticket and a receipt for the toy. Last year the "Toys for Tickets" campaign contributed over \$3,000 in toys to brighten Christmas morning for many children.



# Stirpe Nostra

#### HADRIAN'S VILLA AT TIVOLI

about Hadrian's formal education and training. Some reports credit him with being an architect and others claim that he was an extremely talented amateur. Ancient writers say he was accomplished in arithmetic, geometry, painting and art. He was also a student of Greek art, architecture and civilization, and was responsible for sending many young men to Athens to study.

Hadrian was one of the most cultured and gifted figures in all of ancient Roman history, but was not without his vanity and temper. As a young man he was snubbed by the celebrated Greek architect, Apollodorus of Damascus. Later as emperor he was again severely criticized by the same architect on the design of a temple. This was a bit too much for Hadrian and it became the last critique ever made by the tactless Apollodorus.

Hadrian ruled as emperor from 117 to 138 A.D. Shortly after being proclaimed emperor he made a grand tour of the Roman Empire. He visited Greece, Asia Minor, Egypt, Mauritania, Spain,

History is still uncertain Germany, and Britain. A few years later he put down an insurrection in Palestine, and then visited Syria on his return trip to Rome. During his visits to these countries he was deeply impressed by many of their national monuments and had exact miniature reproductions constructed at his villa in Tivoli. There was the Academia, a public garden or grove originally located in a suburb of Athens. This original facility was named after Academus, the person who left it to the citizens of gymnastics. The entire area (in Athens) was surrounded by a wall and the interior space was adorned with buildings and statues of illustrious men. It was within this enclosure where Plato started a school for those who were sympathetic to his brand of philosophy. The Academic Sect was applied to this group and it in turn became the origin of the Academy as we know it today.

The Lyceum was also represented in miniature at Tivoli. This was originally a sacred enclosure at Athens which was dedicated to Apollo. The area contained

copies of fine buildings, fountains, and lush gardens that were originally designed by some of the best known figures during the Golden Age of Greece. It was the usual place of exercise for the Athenian youths who aspired to military career. The original Lyceum was especially famous because it was frequented by philosophers like Aristotle and his followers. Hadrian's villa at Tivoli also contained a reproduction of the celebrated temple of Serapis that was located in Canopus, an important city on the coast of Lower Egypt, about twelve miles from Alexandria. Serapis was a mythical deity of the lower world who was considered to be a god of healing. During ancient times his worship had spread from Egypt to Greece and then into Rome. Canopus was also noted for its commerce and luxury, but infamous because of its debauchery. This was also a point of origin of that world famous dye known as henna, that was used by women on their hair and finger tips.

#### HOME FOR THE HOLIDAYS

In our home, perhaps in yours too, Thanksgiving Day festivities begin with tuning the television set to the Macy's Thanksgiving Day Parade which we half watch and half just have in the background while preparing dinner. Macy's at least since the 1947 motion picture Miracle on 34th Street has come to be more than just another vendor for holiday gifts, but is itself a part of America's Thanksgiving through Christmas holiday season. Yes, for many of us the Macy's parade marks the beginning of the holidays.

Nevertheless, I miss the older television

practice of showing not just Macy's but bits of several department store Thanksgiving Day Santa parades. I liked when they would switch to the J.L. Hudson's Thanksgiving Day Parade in Detroit and the Gimbals' Thanksgiving Day Parade in Philadelphia. Hudson's Department Store in Detroit is gone, but the parade which like the Macy's parade started in 1924 continues as America's Thanksgiving Parade. The Gimbals' parade, now called the 6abc IKEA Thanksgiving Day Parade, is the oldest of America's Thanksgiving Day Santa parades, having started in 1920.

Locally, from the 1940s until 1972 and again in the early 1990s a visit to the Enchanted Village in the Jordan Marsh department store in Downtown Crossing was how Bostonians inaugurated the Christmas shopping season. Remember how, up to just a few years ago, Jordan Marsh, and its rival Filene's put up competing Christmas displays in their windows that faced each other on Summer Street?

I have nothing against R.H. Macy's Department Store. I wish it a profitable Christmas selling season. If Americans choose for our Thanksgiving Day morning entertainment a televised, extended-length, open-air advertisement for that retailer, who am I to object? But more and more local shops are giving way to national brands and "big-box" retailers. Local events (such as the Enchanted Village) give way to a few huge national spectacles. Likewise, our political discussions are focused much more on what is happening in Washington, rather than Boston.

The problem with looking to the national scene rather than locally is that nationally most of us have little opportunity to be anything more than observers. Locally we have power to change things. As the Democrats and liberals in Washington consolidate more and more power in the hands of a few remote unelected bureaucrats in Washington, let's be thankful this year that we still have locally elected representatives and senators in the General Court. Next year all 200 members of that body will be up for election. Have you thought of running? Surely no one is so happy with the current crop of state legislators that you can't think of a few you'd like to see replaced. If you think it's time for a change and you believe you have what it takes, change can begin with you!

As you may know, after years of struggling with the limitations imposed by lack of adequate space for children's programs, visitor amenities and program staff offices, the Paul Revere Memorial Association/Paul Revere House purchased 5 and 6 Lathrop Place. The 1835 building had languished in poor condition for the better part of 10 years. In 2010 we completed critical structural stabilization and restored the exterior to its 19th century appearance.

We are now gearing up to complete our project and hope to open the facility in 2013. The property at 5 and 6 Lathrop Place is currently zoned multi-family residential and we will be asking for a change of use to allow for its use as a cultural acces-



sory. This will allow us to extend our current operations into this facility, an action that is critical to our being able to use the building as we plan. The Association has been working for years to be able to transform our historic complex by making it fully handicapped accessible, increasing our program space by 400% and adding public restrooms. We value your support and hope we can count on it for our zoning request.

## WHAT HAPPENS WITH **MAYOR'S RACE IN '13 NOW?**

## **OBAMACARE**

Everyone is talking about lect the penalties from those closed higher in weaker tax reform in Washington, DC. President Obama is calling for reforming the tax code so it will be simpler and one of the road blocks is Obamacare. The penalties for not buying coverage runs through the tax code the IRS says it needs more than a thousand new auditors and staff and \$359 million in 2012 alone to administer Obamacare. Most returns focus on cutting special tax breaks that gum up the code and costs hundreds of billions of dollars a year in lost revenue, Obamacare will narrow be the tax base due to the refundable tax credit which will take 8 million more people off the income tax rolls according to an analysis by the House Oversight and Government Reform Committee. Another goal is to improve the fairness of the tax code measured by whether families with similar income pay the same amount of taxes. This could have a big effect on the costs of insurance for millions of Americans. There is a question as to whether the IRS has the authority to col-

who fail to buy insurance as mandated by law. Softwaremaker Solarwinds advanced to a new high up 3%. The stock is up 18% past a \$25 buy point. Advance Auto Parts rose 5% in triple its volume after topping estimates. On the downside Apple lost 2.05% in 30% fewer trades and the Euro dipped in value, estimates on iPad shipments the strong buy is buy. Top-rated stocks have some challenges in this choppy market. Nine stocks have triggered the 8% sell rule after breakouts. They are World Fuel Services, ARM Holdings, Opec Holdings and Omet Technologies. Some have bounced back to reduce their loses, others have not rallied.

Jobless claims are at seven month lows. New filings for unemployment fell by 10,000 last week was 390,000, the lowest since April. The data suggest the number of people who continue to get claims were 92,000 to 3.6 million, a 3 year low. This suggests improvement in labor markets, but still no hiring. Stocks

trades, as investors remain cautious about European debt crisis. Winners beat losers by 2-1 on the NASDAQ and 3-2 on the NYSE. Italy's yields fell to 7%, Lucas Papademos of Greece. France is in danger of losing its AAA rating and its yields are rising. In the week, good results are forecast for Dollar Tree, SalesForce.com, and Questor Pharmaceuticals up 30% for a \$32 buy point. Italy lost its prime minister. Prime Minister Silvio Berlusconi is stepping aside for an emergency government led by Mario Monti. Yields fell for two days after spilling over 7%. Greece tapped Lucas Papademos to be Prime Minister and lost its AAA rating and the Euro rebounded and tapped Lucas Papademos as head of Unity Government for Greece. Yields tumbled for two days after spiking over 7% yield.

## When it Comes to GPS-Tracking: **CALL ME A LIBERAL**

The U.S. Supreme Court will soon decide whether high tech tracking by police is such an intrusion on people's lives that police need to obtain a warrant before attaching a GPS device to a person's car. The case started to be heard on November 8 will test law enforcement's use of the latest technology (constant surveillance) to fight crime as it raises the specter of George Orwell's Big Brother government knowing one's every step. GPS tracking lets law enforcement engage in surveillance 24/7 over a prolonged period of time that could never be equaled by traditional law enforcement tactics.

The US Court of Appeals in Washington, DC ruled that the 4th amendment protection against unreasonable searches and seizures requires police to get a warrant before affixing a Global Positioning System device to a motor vehicle. US Appeals Court Judge Daniel Ginsburg wrote in the ruling that the US Supreme Court will take up, "A person who knows all of another's travels can deduce whether he is a weekly church-goer, a heavy drinker, a regular at the gym, an unfaithful husband, an outpatient receiving medical treatment, an associate of particular individuals or political groups and not just one such fact about a person, but all such facts.

The US Justice Department had appealed the' warrant requirement arguing that drivers do not expect their movements to be kept quiet. According to US Solicitor General Donald Verrilli, police officers aren't conducting a search when they observe things conducted in public. This case has a chance to be a ground breaking decision over the dispute of using new technologies regarding police tactics into the future.

The case in question involves a Washington, DC nightclub owner who was investigated in a drug trafficking case. Over a dozen 'friend of the court" briefs have been filed by numerous groups and includes Roger Eaton, 90, regarded by many as "the father of the GPS." Lawyers for Eaton say, GPS tracking is done in such continuous fashion that it cannot be compared to beepers and other electronic surveillance tactics previously reviewed by the US Supreme Court.

However, one group, the New York-based Center on the Administration of Criminal Law, see the cost benefits of GPS devices in tough financial times. They think it is far cheaper to use a GPS than have agents following supposed bad guys around. This group further states using a GPS is on solid constitutional ground because the information revealed was observed in plain sight. The US Justice Department is seeking the high court to re-instate the drug conspiracy conviction of a person who was tracked with a GPS device over four weeks in 2005. Federal agents had secretly placed a GPS on the

The suspect while it was parked in a public lot and then used the evidence from the suspect's travels to a stash house in Maryland to help get a conviction in court. Large amounts of cocaine were found in that house and some \$70,000 hidden inside the Jeep vehicle.

Solicitor General Verrilli is urging the Court to rely on another 1983 Supreme Court ruling that a beeper was not a search under the 4th amendment. The lower court in this case today said that a month long detailed tracking could not be considered "public" in the usual sense of the word. Be-





# Saint Margaret of Scotland

Margaret was born in Hungary in 1045; she was an English princess of the House of Wessex the daughter of an exiled noble known as King Edward the Exile and a Hungarian princess named Agatha. A tradition asserts that Margaret's father and his brother Edmund were sent to Hungary for safety during the reign of the Norman, King Canute.

Margaret and her family returned to England in 1057, but fled to Scotland following the Norman conquest of England of 1066. Around 1070 Margaret married Malcolm III, King of Scots, becoming his Queen consort. This event had been delayed for a while by Margaret's desire to enter religion, but it took place sometime between 1067 and 1070.

In her position as Queen, Margaret had great influ-



ence and used it in the cause of religion. Her private life was given up to constant prayer and practices of piety. Margaret instigated reforms within the Scottish church, as well as development of closer ties to the Roman Church in order to avoid a schism between the Celtic Church and Rome.

Margaret was also active

in works of charity. She frequently visited and cared for the sick, and had hostels constructed for the poor. She founded several churches, including the Abbey of Dunfermline, built to enshrine her greatest treasure, a relic of the true Cross. She established a ferry across the Firth of Forth for pilgrims travelling to the Abbey which gave the towns of Queensferry and North Queensferry their names.

Malcom and her eldest son Edward were killed in a battle against the English at the Battle of Alnwick on November 13, 1093, Margaret, who was ill, died in Edinburgh three days later, on November 16. She was canonized by Pope Innocent IV in 1250 and proclaimed Patroness of Scotland by Pope Clement X







Two international superstars showed up on the same early November weekend to meet two diverging groups of Boston area's young people. And though both never crossed each others' path, the reasons for attending their respective events drew stark contrast.

Mark Zuckerberg, the CEO and founder of Facebook, returned to Harvard University for the first time since dropping out seven years ago to grow his popular social network company into the gargantuan multi-billiondollar global business it has become.

He then rolled a few blocks up Massachusetts Avenue to the Massachusetts Institute in of Technology to chat with 200 students and drum up new recruits for Facebook's expansive network. pany here," said Zuckerberg.

The girls are patients at the Jimmy Fund Clinic at the Dana-Farber Cancer Institute. They got treated to a weekend of fine dining, makeovers, shopping spree, and pampering by several of Boston's best hair stylists and fashionistas.

Bundchen never tripped wowing her captive audience. "We all started clapping and everyone was excited," gushed Hannah Baiona, 15-year-old sophomore at Braintree High School, who's been in remission for seven months from Hodgkin's lymphoma.

Gisele strode a makeshift catwalk at the Newbury Street salon with girls reluctant to strut it alone. She

also flawlessly pushed a few girls in wheelchairs across the catwalk to the delight of the many sponsors and spectators who cheered the world's most sought-after supermodel for sharing the spotlight with her newfound friends.

The classy Bundchen gave each girl a rose and a hug, posed for photos, and made every girl feel super. "The one thing that you notice is that there's a deep and abiding sadness in their eyes," said WEEI DJ John Dennis. "But when she (Gisele) came in, it went away."

As Zuckerberg schmoozed with the elite at Harvard and MIT, he praised the Boston area for "having really smart people." Bundchen's unique talents and savvy business skills keep her brand burning white-hot. Despite their effervescent egos and the glamour that follows them, both superstars shone brilliantly by leaving their human imprint on hundreds of young people ready to meet the challenges before them.

cause it was very unlikely anyone could have actually observed all of the suspect's travels.

The high court must also look at whether the planting of a GPS device violated protections under the US Constitution. The Justice lawyers say it was permitted under the constitution because it didn't interfere with the driving of the vehicle or take up space inside the

Jeep itself.

The defendant's lawyer told the justices in his brief that unrestrained GPS monitoring becomes "a grave threat to the personal privacy and security of every individual in this country." I personally believe, as does the defense lawyer, that the government doesn't have the right to track people relentlessly without a warrant. With every day that passes,



## NONNA LUCY'S TURKEY STUFFING

- 2 large onions chopped 3 celery stalks chopped
- 2 cans chicken broth 2 chicken bouillon cubes
- 1 pound of white or brown instant rice
- 2 tablespoons chopped parsley
- ½ teaspoon poultry seasoning
- 2 eggs slightly beaten
- 1 small French bread cubed
- 34 cup pignoli (pine nuts) 2 tablespoons grated
- Romano Cheese
- 1/4 cup white wine 4 tablespoons butter or
- margarine
- Salt and pepper

One day earlier, cube bread and place in a paper bag to dry, or slightly toast cubed bread and cool on day of stuffing

Use one can of chicken broth as the liquid for cooking the instant rice and follow direction on package for cooking time. When cooked, cover and set aside.

Meanwhile melt butter or margarine in a large skillet. Add chopped onion and celery. Stir and cook until onion is opaque. Remove from burner. Carefully add remaining can of chicken broth to the skillet. Return to burner and heat broth slowly. Add cubed bread to the broth and mix until all bread is softened. If needed, add one chicken bouillon cube to one cup of boiling water. Dissolve bouillon cube and add gradually to bread as needed.

Combine rice and softened bread in a large bowl. Add parsley, poultry seasoning, grated cheese, wine, and pine nuts. Mix thoroughly. Salt to taste and store in refrigerator. When you are ready to bake the turkey, mix slightly beaten eggs thoroughly into the stuffing before you fill the turkey cavity. Place stuffed turkey into a proper-size baking pan and bake in preheated oven at 325°F until fork

Since my family enjoys having some stuffing baked separately, I oil spray a 9" x 9" baking dish, or size needed to bake any remaining stuffing. Baste both turkey and the separate pan of stuffing with turkey pan drippings.

This recipe is for a fifteen-pound turkey.

NOTE: I remember the days, as a child, when I grated the cheese and chopped the onion and celery for my mother for her turkey stuffing. My children, who called their maternal grandmother "Nonna," learned to prepare this same recipe by helping as I had done. Now we have another generation — my grandchildren — eager to follow in this tradition.



# Nanna & Babbononno

A Nostalgic Remembrance

Last week, I left off on a cross-Sicily trip with Sal Meli, a friend from East Boston that I had known since we were kids. At that point where I left off last week, we were heading for the ancient resort city of Taormina and then Messina. We climbed the mountain road to Taormina and discovered that it was filled with British tourists. The town was gorgeous and the view of the Bay of Messina below the mountain top, breathtaking. We stayed for a couple of days and then descended the mountain road to pick up the highway for Messina. When I got to the end of the road the ocean was in front of me, and I had to go either right or left to get to Messina, but there were no signs indicating which way to turn. I was pondering as to which way to go, when an old man crossed the road in front of me. I yelled out to him, "Scusi signore." (Excuse me, sir.) He took off his hat, placed it over his heart, bowed and said, "Prego." (Please) I yelled out, "Signore, e questo la strada per Messina?" (Sir, is this the road for Messina?) The old man pointed to the water and said, "Sempre diretto, no gira." (Straight ahead, don't turn.) I yelled back, "Ma gia sta la mare a la." (But the ocean's there) The old man nodded and yelled back, "Puo nuottare?" (Can you swim) I yelled back, "Si." (Yes) He yelled back, "Sempre diretto, no gira." (Straight ahead, don't turn) And with that, he walked away. Sal and I laughed but then analyzed the situation. The ocean was in front of me. We were on the east coast of Sicily. We wanted to head north. If I turned left, the water would be on my right and I would be heading north, so I turned left and we made it to Messina by early evening. We actually were out of gas by the time we arrived and I couldn't find an open gas station. We spotted a Jolly

We found out where the locals eat and walked to the trattoria that was mentioned to us at the hotel. After dinner, we walked the streets looking at the sights. We happened on a coffee shop with a bunch of guys about our age all hanging out talking politics and cars. Sal joined in the conversation and we were accepted by the crowd. Two of the guys were brothers and auto mechanics. They offered to show us the old city, a short drive from where we were. The old city of Messina was built during the middle ages and looked like it did back then except for the electric lights which illuminated the neighborhood. The streets were about as wide as the tiny FIAT 500 we rode in, but it was fascinating. Later, saw several men dressed

back at the coffee shop, I bought the two brothers coffee and we talked Italian and American politics with them and American cars, which seemed to fascinate the two brothers.

The next day, we booked passage on the ferry which connects Messina, Sicily to Reggio, Calabria, the city on the toe of the boot-shaped mainland. The ferry boat had several decks. The lower ones, parallel to the dock were for box cars left on the dock by the local trains. The next two decks were for cars and trucks and the top decks for passengers without vehicles. We ascended the ramp to the indicated deck where we would park our rental FIAT, but were halted due to the car in front of us stalling and not restarting. It was a new Rolls Royce. Two of the dock workers labored under the hood and finally got the car started after about an hour. Their rationale for the car stalling was. "An English car using Italian gasoline."

It was now late afternoon and I was a bit hungry. The ferry had a cafeteria and I bought myself two arancini. Don't tell Barbara Summa, but they were the best arancini I've ever eaten. When we finally arrived at Reggio, it took a while to unload the ferry, and we had to wait our turn. An older couple from Palermo suggested a hotel to stay at and a good family restaurant to eat in and we followed them. Things were uneventful and we only stayed in Reggio until the middle of the next day.

I had a friend from Watertown who had gone home to visit his family in Calabria. When I told him I would be in Italy the same time he and his wife would be there, he gave me his aunt's phone number so I could get in touch when I arrived on the mainland. They would be in Catanzaro, a beautiful Mediterranean coastal city facing Africa, and invited me to join them if I might be in their part of Italy. I calculated the distance and called the number that was given to me. My friend's aunt answered and told me that my friend, his wife and several relatives were out and about, but she would give them my message. I calculated my time of arrival and the aunt told me where to stop in the main piazza of the town and we would be met by my friend and his wife.

Unfortunately, I miscalculated the distance from Reggio to Catanzaro, converting miles to kilometers in my head. As a result, we were two and a half hours late. When we arrived at the piazza that my friend's aunt indicated we meet at, my friends were no where in sight. I looked around and

with suits and ties and green, white and red sashes across their chests. They looked at Sal and me, stared for a minute, and then turned away. I figured that they might be local dignitaries and asked where the home of my friend's aunt was. One of the men asked in English, "Are you the Americans?" I replied that we were and he began yelling, "Gli Americani sono qui." (The Americans are here) Everyone came to look at the two Americans. That part of Italy was off the beaten track and the only images of Americans they had was from Hollywood's cowboy movies. They were looking for two guys that looked like John Wayne or Clint Eastwood. They couldn't believe we were Americans. We didn't fit the image.

As it turned out, my friend and his wife were meeting with German developers. They owned waterfront property and the Germans were interested in buying it and building a hotel on the ocean. While we waited for them to return, we were directed to my friend's aunt's house. She had coffee ready for us and accepted my explanation as to why we were so late arriving. As it turned out, the men who greeted us were the mayor of the town and a few local dignitaries. My friend must have told them to intercept two Americans and entertain them until he got back from taking care of business.

I asked my friend's aunt if I could use her phone and reverse the charges. I wanted to call home and let everyone know that I was now on the Italian mainland. She pointed to the phone and I asked for the overseas operator, a necessity to call my folks collect, back in the day. Babbononno answered, "Allo, whozza dissa." When I told him who it was, I had to give him a rundown of everywhere I had been in Sicily. He listened and added in comments about what some of the same places looked like when he had been there in the late 1800s. Finally my folks were given the phone and I told them about my ventures. They were happy I was having a good time and we then cut it short due to the cost of an overseas phone call. I left off that I would call in a few days when I would arrive in Rome, and I'm out of space again. To be continued ... GOD BLESS AMERICA

In accordance with Massachusetts General Laws, Chapter 149A, sections 1 thru 13, Massport is seeking a highly qualified and competent Construction Manager (CM) to provide preconstruction services and implement the construction of the Project in accordance with an agreement where basis for payment is the cost of the work plus a fee for a negotiated quaranteed maximum price. This Request for Qualifications (RFQ) is being utilized to pregualify and shortlist CM firms who will be invited to submit proposals in response to a Request for Proposals (RFP) issued by Massport.

#### PROJECT DESCRIPTION AND SCOPE OF SERVICES

In 2002, in-line Checked Baggage Inspection Systems (CBIS) were installed and commissioned at various locations in Terminals B, C and E at Logan International Airport. Terminal A was subsequently constructed with an entirely new baggage handling system that also included an in-line CBIS. While these systems were state-of-the-art at the time, they were designed well before the adoption of the Planning Guidelines and Design Standards (PGDS) by the Transportation Security Administration (TSA) in 2009.

Under the proposed project, the Authority is proposing to make improvements to the CBISs at Logan International Airport. The proposed improvements at each location are categorized as either a recapitalization or an optimization of each existing system. The recapitalization of an existing system involves the modernization of the CBIS to the maximum degree possible. Conversely, the optimization of an existing CBIS will involve total reconfiguration, consolidation, and reconstruction of the CBIS. Under the Project, six existing CBIS's will be recapitalized and the remaining two CBISs will

The scope of work on the Project involves construction activities in all of the Terminals at Logan International Airport. Extensive interaction and coordination with the TSA and the airlines will be required. Construction of the Project will commence in the spring of 2012. The work will be completed in a minimum of five phases. The work on the last of the phases will be completed on or before April of 2014. Due to the fact that a portion of the project contains sensitive security information (SSI), certain trades will be managed in accordance with the SSI provision contained in MGL Chapter 149A. The CM must have a demonstrated ability to manage a sensitive security project and protect SSI.

In addition to the construction services, the CM shall also provide Preconstruction Services which shall include, but are not limited to, cost estimating, scheduling, phasing and logistics, value engineering, document review to support the preparation of trade packages and constructability reviews. The CM shall be expected to work closely with Massport's team including its Project Manager and design team in order to effectively implement the project.

The construction budget is estimated at approximately Seventy Five Million (\$75,000,000).

## SELECTION PROCESS

Massport intends to implement a two-step selection process including a Qualifications phase and a Proposal phase. At the Qualifications phase, the Pregualification Committee will conduct a qualifications-based evaluation of interested CM firms in order to create a shortlist of competent CM firms. Shortlisted firms shall be invited to respond to a written RFP which will require both a technical proposal and a price proposal. A Selection Committee shall review Proposals in order to rank the shortlisted firms and make the final selection. Massport intends to shortlist firms and issue an RFP in December 2011, and make a final selection in February 2012. The Designer shall participate in the selection of the Construction Manager.

I ran fast, trying to stay mostly on the sidewalk, or in the occasional shade! I will never forget that experience. The following day I read in the newspaper that the temperature had hit 56 degree C, about 122 F.! My strong advice to those who may plan to visit Catania (the area doesn't get northern winds which are blocked by Mt. Etna) in the summer to be very cautious. Unless you want to experience a little ... self-cooking! Good luck!

THE MENU THAT MAY SAVE THE ENVIRONMENT. To raise animals that supply a considerable portion of our food is a big business, but one that also imperils the environment. Therefore when you go to the supermarket avoid buying lamb meat, beefsteaks, hamburgers, mozzarella and most cheeses as well as prosciutto. Look rather for turkey, chicken, eggs and tuna, which are healthy food and tend to save the environment. By some coincidence, the good food indicated above has a prominent place in the Mediterranean diet. How nice!

# Remember Matty, Jesus and Felipe Alou in the Giants Outfield?

Matty Alou, once a part of an all-Alou outfield for the San Francisco Giants, passed away November 3 in his native Dominican Republic. Hall of Famer and former team-mate of his Orlando Cepeda said Alou had been sick for a while. Said Cepeda, "We roomed together a few times with the Giants, very funny guy, hell of a ballplayer, a dead fastball hitter and could pull anyone (no matter) how hard they threw.'

Alou was a 2-time All-Star and won the 1966 NL batting crown hitting .342. He spent his first six years with the Giants and also played for the Cardinals, Athletics, Yankees and Padres.

Alou and his two brothers, Jesus and Felipe, made history in 1963 when they appeared together for the first time as the All Alou outfield. Matty Alou was a career .307 hitter with 31 home runs, 427 RBIs, 1,777 hits and 236 doubles in 15 seasons.

The Alou legacy is a major league baseball legacy and it lives on!

### Duquette New Orioles GM

The Baltimore Orioles have hired the 53-year-old Dan Duquette as executive vice president of baseball operations. It will now be the job of Duquette to bring the Baltimore Orioles out of their run of 14 successive losing seasons. He takes over from Andy MacPhail. Since getting dumped by the Red Sox in 2002, he has not been in the front office until this latest hiring news. Previous to the Sox, Duquette had been the GM for the old Montreal Expos. After nine years of exile, Duquette has signed a three-year deal and is trying to resurrect the Orioles to its past greatness.

While many credit Theo Epstein for breaking the Curse of the Bambino in 2004, it was a Duquette-built team that carried on to victory over the St. Louis Cardinals that year.

Also, he was a rather good hitting pitcher as well with a career .212 average with 12 homers. He won 163 games for the Cardinals from 1974-88 and trails only Bob Gibson and Jesse Haines in team wins. 
