City of Boston COVID-19 Update

An average of **2,340** new Bostonians got tested each day, and the average number of daily positive tests went up to **224**.

The result was a positive test rate among unique individuals of **9.6%** on our existing metric. **Seven** neighborhoods had

positive rates over 10%, with East Boston, Dorchester, and Hyde Park experiencing the highest rates.

Our free mobile testing sites remain this week in East Boston, at Central Square Park; and Mattapan, at Jubilee Christian Church. In all, we have over 30 testing sites in Boston. Information about all the testing sites is at: boston. gov/coronavirus, or you can call 311.

UPDATING AND EXPANDING OUR COVID METRICS:

this virus, we have to follow the science and we have to follow the data.

What that means, he explained, is that our public health experts collect comprehensive testing data and hospital data. They analyze it to understand how and where the virus is spreading, and the impact it is having. We shape our responses and our guidance based on what the data indicates. And, we share the data with the public, so you can be armed with knowledge to help keep yourself, your family, and your community safe.

That's a process of continual feedback and learning because, just as this epidemic evolves and its impact on our neighborhoods evolves, our knowledge about it must evolve as well. We need to adapt and update our understanding of COVID spread in the community.

The Mayor announced that the City will be publishing a total of six key metrics relating to test results and hospital usage. The goal, he said, is to give you the most current and comprehensive picture of the virus as we can. "The more we know, and the more you know, the better informed and prepared we can all be."

Health and Human Services Chief Marty Martinez elaborated on the new metrics and the reasoning behind them.

RESPONDING TO THE CONTINUED INCREASE IN COVID-19 ACTIVITY:

The Mayor emphasized that every metric right now is telling us that we are in the midst of a significant and concerning increase in COVID activity in our city. The daily case increases we are seeing are starting to look like numbers that we saw near our peak, in April and May. Hospital admissions are not at that level, but they have increased over time. We all must be focused on turning this trend around.

The Mayor said that the City is looking closely at what steps we can take to further limit the risk of transmission.

We have taken a cautious approach throughout this pandemic, making safety our priority.

• We pulled back on in-person learning in the Boston Public Schools. We were able to bring back 150 students with the highest needs, who desperately need in-person services. The Mayor thanked the families and teachers for making that possible.

• We have kept our limits on gathering sizes low. Private, indoor gatherings are limited to 10 people, and private outdoor gatherings to 25 people. For events in public spaces, the limit is 25 people indoors and 50 people outdoors.

• We've worked with the state to limit restaurant hours and retail hours, and put in place a Stay-at-home advisory for the hours between 10:00 p.m. and 5:00 a.m. But, the Mayor cautioned, if these case numbers continue to go up, we'll have to go further.

• He said he is mindful of the impact that restrictions have on our economy and small businesses. But we must put the health of our community first because, in the end, there is no economic recovery without public health.

EXPANDING SUPPORT FOR SMALL BUSINESSES:

The Mayor pledged to support small businesses through whatever measures are necessary. He noted that we have distributed close to **\$10 million** so far, and the Reopen Boston Fund is still available to pay for safety materials and PPE.

We launched **three new funds** making a total of **\$6.3 million** available. These new funds are targeted to the hardest-hit businesses in the hardest-hit industries and each provides grants of up to **\$15,000**.

• One is for help paying commercial rent.

• One is for restaurants, to help them commit to paying a living wage to their workers. It's a partnership with some innovative national nonprofits, as well as the City Council.

• And another is for businesses certified as minority, women-owned, or veteran owned enterprises.

HISTORY'S FIRST PANTY RAID

We have been examining the stories associated with the fictional strongman named Hercules (Heracles in Greek). The selection of Hercules as our anchorman for this series on mythology is most appropriate because he is claimed to be one of the most ancient and most famous of all mythological heroes, and his legendary accomplishments are said to be the richest and most comprehensive of all myths.

I reminded all readers that the memory of Hercules is not strange to Italy. Renaissance Rome honored him in many works of art. There is a statue entitled The Farnese Hercules, which is now in the National Museum at Naples, a painting of Hercules killing the Hydra (his second labor) and another of Hercules crushing Antaeus, both are in the Uffizi Gallery in Florence, a statue of Hercules crushing Antaeus, in the Bargello (National Museum) at Florence, and a statue of Hercules slaying Cacus, a cattle thief in the Palazzo Vecchio at Florence, near the copy of Michelangelo's David.

All the famous "Labors of Hercules" were imposed upon him as punishment for killing his wife and children during a period of madness. We have discussed the first eight of the celebrated "Labors of Hercules." Today's labor is associated with the Amazons, a race of women who were represented in Greek legend as having lived in the northeastern part of Asia Minor near the shore of the Black Sea. They formed their own independent state, which was governed by a queen in the mythical town of Themiscyra on the River Thermadon. This was the capital from which they made warlike excursions against other tribes in Asia Minor.

In order to please his daughter, King Eurystheus, author of these labors, required Hercules to fetch the belt or girdle of Hippolyte, queen of the Amazons at that time. Because these women were such formidable enemies, Hercules selected a group of sturdy companions to accompany him on this venture.

After a long and dangerous journey, Hercules and his friends finally landed at the Amazons' town of Themiscyra, where they were met by the queen herself. After some discussion, Hippolyte decided to give up the belt and avoid unnecessary bloodshed. Greatly disappointed that this labor should be accomplished with so little effort, Hera, queen of the heavens, posing as an Amazon, caused the other women to believe that their queen was being abducted. As the women attacked the ship, Hercules believing that Hippolyte had betrayed him, killed the queen of the Amazons and took her belt. Following a perilous journey back to his home, Hercules delivered the famous belt of Hippolyte to the king.

Thanksgiving for Our Health

In other years Pilgrims, Plymouth Rock, Poultry, Pumpkin Pie, and large gatherings of friends and family would all be on the menu next week as we Americans of every origin reenact and re-interpret the story of that first Thanksgiving in 1621. Somehow, in the story of those Englishmen and women of a strict Calvinist religion, we find meanings to suit the needs of a multi-ethnic and multireligious nation. Now in time of Great Sickness and Mortality we all shall scale back our festivities. Perhaps this year we shall especially note that out of 102 Mayflower passengers, merely 51 survived the first winter in New England.

Thanksgiving 2020 brings a special Four Hundredth Anniversary commemoration. Originally headed for the northern part of the Virginia Colony — roughly in the area where New York City is now located — they ended up landing offcourse, up here in what would become New England. Being out of the bounds of any established

colony, where a colonial charter formed the basis for civil society, the Mayflower passengers found themselves, technically, outside of the law. Their response? They would remain loyal subjects of the king, but they would create their own local laws. Pilgrims, who made the passage for religious reasons, and others who crossed the Atlantic for commercial gain, agreed to live together in the New World under equal laws created democratically "for the General good."

The Mayflower Compact was signed four hundred years ago on November 11, 1620 (Julian Calendar, the 21st in our Gregorian Calendar) on board the Mauflower at anchor in Provincetown Harbor. In it they agreed to: "solemnly and mutually in the Presence of God and one of another, covenant and combine ourselves together into a civil Body Politick, for our better Ordering and Preservation, and Furtherance of the Ends aforesaid; And by Virtue hereof to enact, constitute, and frame, such just and equal Laws, Ordinances, Acts, Constitutions and Offices, from time to time, as shall be thought most meet and convenient for the General good of the Colony; unto which we promise all due submission and obedience." And, thus, was established the first experiment in limited self-government in North America.

This Thanksgiving may God bless all the readers of the *Post-Gazette* with his bounty and with health of body and mind.

In addition to our prayers of Thanksgiving, may I suggest —

O Most mighty and merciful God, in this time of grievous sickness, we flee unto thee for succor. Deliver us, we beseech thee, from our peril; give strength and skill to all those who minister to the sick; prosper the means made use of for their cure; and grant that, perceiving how frail and uncertain our life is, we may apply our hearts unto that heavenly wisdom which leadeth to eternal life; through Jesus Christ our Lord. Amen.

from health care inequities and racism, and our essential and frontline workers who care for the sick, with whatever it takes to get through another surge.

But, he urged, "we don't have to go down that road." We are one of the places in America that went through a major surge already, and we know we have what it takes, to rapidly bring our numbers down.

He urged everyone to wear a mask at all times outside the house; wash your hands frequently with soap and warm water; wipe down frequently touched surfaces; and avoid gathering with people from outside your household.

The Mayor said that Boston's contact tracing is showing two main locations where the virus is spreading: workplaces and gatherings in people's homes.

In the workplace, he said, people are letting their guard down, forgetting that each of our colleagues interacts with numerous people outside of work.

He reminded individuals to practice all the essential COVID precautions in the workplace. He urged employers to follow all the guidelines for ventilation, spacing, and capacity, and continue to permit and promote **working from home** wherever possible.

PRACTICING COVID SAFETY ON THANKSGIVING:

With in-home gatherings a major source of transmission, the Mayor urged everyone to plan carefully for a safe Thanksgiving.

He urged all Bostonians to spend Thanksgiving day in person with only members of their current household.

Larger gatherings with extended family present a big risk factor and the odds of outbreaks go up dramatically.

He urged people to make those connections virtually and to focus on the gratitude at the heart of the Thanksgiving holiday rather than the in-person traditions this year.

Those who do gather with family he urged to limit the number of guests. In Boston, indoor gatherings should be 10 people or less, and there are no exceptions for holidays.

- Everyone should wear a mask when they are not eating or drinking, and everyone should stay six feet apart as much as possible.
- Look at your ventilation, open windows if needed, and consider spending time outdoors, weather permitting.
- Clean and disinfect frequently touched surfaces and items between use.
- Anyone who travels out of state should follow the state guidelines on quarantine and testing when you return. And everyone who participates in any kind of gathering should get tested before and after Thanksgiving.

THANKSGIVING GUIDANCE FOR COLLEGES AND UNIVERSITIES:

The Mayor noted that normally, many students travel to their hometown for Thanksgiving and then return to campus for the rest of the term. The Administration has asked colleges and students not to do that this year. If you go home for Thanksgiving, the Mayor emphasized, you should not be returning to Boston this semester.

The Mayor thanked Emerson College and Suffolk University for simplifying the issue by going fully remote after Thanksgiving. He thanked Boston University and Harvard University for instructing students not to return if they go home. He thanked others who are taking some version of this approach, and he asked all colleges and universities to take similar steps, to help us contain the spread of this virus at a critical time.

LEADING THE WORK ON CLIMATE ACTION AND RESILIENCE:

The Mayor closed his remarks by addressing the King Tide coastal flooding we saw again. He noted that this phenomenon is a product of sea level rise that is being accelerated by climate change, and of the urgency we need to bring to this issue.

- This is why we're implementing a *Climate Ready Boston plan*, to build a resilient shoreline that protects our homes and businesses from flooding.
- It's why we're spending at least 10% of our capital budget on resilience projects like *Resilient Boston Harbor*, that also create new open space.
- It's why we have a goal of being a 100% carbon neutral city by 2050, and a roadmap to get there. The Mayor noted that this goal requires investing in public transit, not making cuts to the MBTA.

The Mayor said he is honored and grateful to have been named the new Chair of U.S. Climate Mayors, a national coalition of 450 cities who never wavered in their commitment to the Paris Agreement, or to protecting residents from the impacts of climate change.

He shared that on Tuesday afternoon, he would be leading a national discussion of the U.S. Climate Mayors, focused on how climate action will help our country recover from the COVID-19 pandemic.

He closed with the following reflection:

"We face considerable challenges, but we have more reason for hope and optimism right now than we've had in a long time. We have an opportunity moving forward to partner with Washington in this environmental work, and I will continue to take action in Boston while advocating for federal progress. In Boston, we will fight for our safety today and lead forward for a better tomorrow."

L'Anno Bello: A Year in Italian Folklore

Food for the Heart at Thanksgiving

Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing (and mask wearing!) is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.



As November curls its golden glow around us, my mind wanders to images of Thanksgiving, as vivid and fragrant as a perfectly seasoned stuffing. I think of pale sunlight painting patterns on the floor, shining through the last orange leaves which stubbornly cling to otherwise bare branches. Memories of relatives bustling through a crowded kitchen carrying plates of steaming food fill me with the warmth of a hug, especially when I smile as I remember the peals of laughter ringing throughout the house. The buzz of cheering crowds emanates from the sound of the Macy's Thanksgiving Day Parade on television, occasionally interrupted by commercials featuring jingle bells and Santa's robust ho-ho-ho. Most of all, however, I can taste the explosion of flavors in my mouth from our delectable Thanksgiving dishes: creamy sweet potato, tart cranberries, a velvety pumpkin cheesecake. Thanksgiving remains one of my favorite holidays because it celebrates the very essence of togetherness, reveling in the pleasures of the home and hearth. My family's Thanksgiving combines Italian and American customs, resulting in a feast that honors the universality of love and family.

Food has always been an invaluable staple of Italian culture, and as such my family views Thanksgiving as the epitome of the primordial desire to share a meal. Every

thought and care - yes, even my vegetarian Tofurkey, replete with its own gravy and wild rice stuffing. I always eagerly await my mother's sweet potato casserole, warm with autumnal spices and topped with a crunchy streusel of brown sugar and pecans. I contribute my fresh New England-style salad made with crisp apples, blue cheese and cranberries, as well as a pumpkin cheesecake with a seasonally appropriate gingersnap crust. My father-inlaw provides a pecan pie with a silky chocolate bottom, while my grandmother would make heaping bowls of spaghetti homemade on an ancient handcranked utensil caked with flour. No matter the food on the table, however, whether Italian or American, what proves most important is that we honor the bountiful harvest of the Earth. Thanksgiving occurs at the point of the year after the gathering of the harvest and withering away of vegetation; as such, it beckons us to enjoy the cozy warmth of family and friends, forming a barrier against the encroaching dark, cold winter. This symbolic connotation compels me to believe that Thanksgiving should never be celebrated alone but rather with others in a celebratory atmosphere, sharing in communal feasting and unending love of family. The more the merrier on this most ritual of holidays!

Indeed, communal food-based festivals similar to Thanksgiving dot the Italian calendar duritem on the menu is prepared ing the autumn and winter. with an abundant amount of The most famous of these,

St. Martin's Day, occurred this past week on November 11th, when Italian villages gathered for banquets featuring chestnuts, goose, and the year's new wine. Now that the Christmas season quickly approaches, Italians are busy in the kitchens or markets preparing delectable meals for the holiday gatherings and various saints' days that pepper the months of November and December. These ritualistic celebrations and meal tap into the powerful desire not only to share strength and sustenance with the community, but also to maintain an irrevocable connection to the traditions of the past. According to Italian-American author Helen Barolini in her book *Festa*, the most significant part of sharing food is the ritual behind it, the repeated customs and motifs that link it to larger, universal themes. Whenever I gather for a Thanksgiving feast, I sense a special kinship with my Italian ancestors of yore, who also congregated around a family table on cool, blustery days to pay homage to the last bounty the Earth bestowed on them before settling for its long winter nap. A tradition does not have to be intricate and fancy to remind us of our subconscious desires for love, gratitude and hope. For example, my husband and I sometimes go out for sushi the day after Thanksgiving, a way of eating a light meal to counterbalance the excesses of the day before and to eschew the rampant commercialism of Black Friday. Honoring our traditions, no matter how small, simultaneously joins us to our past while imbuing our present with renewed meaning.

There are many ways we can commemorate the importance of feasting and tradition this Thanksgiving ways that last beyond the date of the holiday on November 26th. We should donate food to local charities and food banks, giving families in need the chance to partake in this festival of gratitude, togetherness, and love. We should relish the time we spend in the company of family and friends, ensuring that we fill the air with laughter and constantly remind each other of our mutual love. And finally, we should all share food together, reveling in that highly symbolic act of community and familiarity, an act which formed the backbone of our ancestors' lives and drives us forward with hope for the future.




Mayor Flynn and I Remember Mayor Curley

I enjoyed reading former Mayor Ray Flynn's recent Boston Herald commentary on Mayor Curley's legacy of helping the poor and improving lives, and who James Michael Curley was and his impact on Boston and his legacy of leadership accomplished over nearly 50 years of public service.

I had the honor of meeting Mayor Curley during his final mayoral run a week before his final campaign in September 1955. He was 81 years old at the time and still managed to pull in 100,000 votes finishing out of the money in the preliminary that year.

He and I meet, of course, at Boston City Hospital where I was waiting for my dad to finish work as a medical worker with my mom. As Curley walked by us, my mom jumped up to greet him and he mayor, Boston (1922stopped to chat. I was introduced to 1926); mayor, Boston him and let him know I was growing (1914-1918) Circa 1914 up in his old neighborhood up the

street in St. Philip's Parish and he told me he was an usher there back in the day and I told him I was at that time an altar boy at the same church.

The smile on his face grew. He asked my name and I told him "My name is Giarratani, but my mother was a Harrington." He told me he always wanted to be part Italian; he could have got so many more votes in a lifetime of politics. When we shook hands and he went away, I felt like I had just met the President of the United States. I will carry this memory forever.

I knew who he was before I met him. My parents loved the guy for all he did for regular working people, making them feel like they were important just like everyone else.

Curley's disdain for the elites was legendary, the ordinary folks of Boston were the real elites.

I wish to thank Mayor Flynn for reminding me good politics is always helping people and improving lives. For Curley and Flynn, it was always about the politics of inclusion and not division. We need more of that today





we were back in the cars and hurried to the cottage where Grandma put together a breakfast of a prosciutto and mozzarella frittata, taralli, juice, and coffee. It was a strongly Italian breakfast in response to the non-Italian church. While having breakfast, Grandma commented, she missed sitting at her shrine of Our Lady of Pompeii during Mass. It was her custom to clean the shrine after Mass. She seemed uneasy with the thought, petals from roses, she placed at the shrine just before leaving for Kingston, would be dropping on the white marble making the shrine look untidy, at least in her mind. 

Do's and Don'ts: Feeding Your Pet on Thanksgiving

Thanksgiving is a time for community and good food. Why not include your pet in the fun? You can absolutely let your dog or cat have a feast of their own just make sure you know what foods are safe for them to eat. As always, also don't let your animal overindulge. Obesity can lead to several health problems, so treats shouldn't constitute any more than 10% of your pet's diet. And whatever in doubt, absolutely consult your veterinarian!

DON'T: Chocolate most pet owners are already aware that chocolate is highly dangerous for animals, but it never hurts to get a reminder. Dogs and cats should never eat chocolate, and other caffeinated foods like tea and coffee.

DO: Turkey it's generally okay to give any cat or dog lean sources of protein, such as plain chicken or tuna. Thanksgiving turkey is no exception. Even a small amount of Thanksgiving cranberry sauce is okay. Cats may not enjoy this treat as much as dogs though since they don't have the same taste receptors for sweet foods.

DON'T: Grapes and Raisins never give your pet raisins or grapes. Unlike other fruits, they can cause kidney failure in dogs. They're toxic and could prove extremely dangerous or fatal.

DO: Most Vegetables who doesn't love mashed potatoes? Potatoes can be a great food for pets and humans alike. Much like turkey, this treat needs to be plain and free of cheese, cream, butter, onions, scallions and other toppings. Pet can also eat plain broccoli, carrots, asparagus, celery, cucumber, green beans, green bell peppers and

DON'T: Alliums (aka Onions) many veggies are perfectly safe and delicious for your dogs and cats. However, onions and other alliums are definitely not. Animals should not consume onions, scallions, leeks, garlic and other similar vegetables.

DO: Macaroni and Cheese is the perfect comfort food, don't cha think? And this applies to humans and their four-legged pals. Plain pasta is okay to feed to pets, and as long as your pet is okay consuming dairy, a little cheese is fine too.

DON'T: Artificial Sweet-eners particularly those containing Xylitol might seem like a healthier choice. After all, you should limit your pet's consumption of sugar. However artificial sweeteners are actually more dangerous for your dog or cat. They are poisonous and potentially lethal to dogs.

DO: Pumpkin plain pumpkin is just plain vummy! It also has the added benefit of being good for dogs' and cats' digestive systems. Pumpkin can soothe a troubled tummy and double as a delicious delectable.

Saint Hubert of Liege

Hubert was born about 656, probably in Toulouse, the eldest son and apparent heir of Bertrand, Duke of Aquitaine. As a youth, Hubert was sent to the Neustrian court of Theuderic III at Paris. He was a worldly, popular and disreputable courtier at Neustria in northwest France.

The tyrannical conduct of the mayor of the Neustrian palace, Ebroin, caused an emigration of the nobles to the court of Austrasia at Metz. Hubert soon joined them. He was warmly received by Pippin of Heristal, mayor of the palace, who made Hubert grand-master of the household.

Hubert was passionately devoted to hunting. While chasing a stag on a Good Friday morning, he received a vision of a crucifix between the animal's antlers. A voice warned him, "Hubert, unless you turn to the Lord, and lead a holy life, you shall quickly go down to hell." It was a conversion experience for Hubert.

When his wife died, Hubert renounced all his worldly positions, titles and wealth, handed his patrimony, and the care of his son, to his brother, and studied for the priesthood. After ordination, he served as assistant to Lambert, bishop of Maastricht. Hubert was on a pilgrimage to Rome, where he was when Lambert was

Hubert was chosen to be bishop of Maastricht succeeding Lambert. Known for his excellent preaching and his generosity to the poor, he stripped the diocese of all excesses to help them. Following another vision, and to defend the memory of Lambert, he moved his




In a couple of weeks, I plan doing a book review on it.

Nanna & Babbononno

A Nostalgic Remembrance



It's getting close to Thanksgiving again and we will celebrate this traditional American holiday with my brother-in-law and my sisterin-law. Son Michael is on the west coast and Son John is afraid to expose his children to all of us even though Loretta and I have tested negative for the coronavirus.

In the past, we used to head to my Cousin Ralph's home in Wilmington and combine families on the holidays. Now, with my oldest son married and chasing two young children around a large house, we've made the decision to head to his place to spend the holidays, it's a lot easier, especially for me as I get older.

I remember asking Nanna a question when I was in short pants. She and Mom were getting things ready for Thanksgiving and I asked why she went all out for an American holiday like Thanksgiving, because it had nothing to do with being Italian. She answered by saying, "Babbononno and I give thanks to America. In the Old Country, we could never have the life for ourselves, our children, and grandchildren that we have here. We don't give thanks just for the food on the table but to the good Lord for everything we have in this country. This may be hard to explain; we are Italian, and are proud of it, but we are also American. We worked hard to become American and we give thanks once a year as Americans for the opportunities we have had in America, but we give thanks, Italian-style."

In the process of getting things ready, Mom and Nanna had to go shopping and I dressed to tag along. We walked down the Eutaw Street hill to Meridian Street and caught the trolley to Maverick Square, one of the main squares in East Boston. Both Nanna and Mom were carrying pocketbooks, but in each was a black oilcloth shopping bag to carry home the necessities for Thanksgiving. When we got off the trolley, we headed to Lewis Street and the abattoir that existed there. That is a fancy French term they used to use for a slaughterhouse, and this one was Kosher, but the Italians who wanted fresh chickens also bought there. During Thanksgiving week, you could pick out a turkey and they would slaughter it, and dress it for you. Once the bird was wrapped in wax paper and placed in Nanna's oilcloth shopping bag, we would head to Central Square, about a ten-minute walk from Maverick Square, heading north on Meridian Street. Nanna would head to the pushcarts that dotted the distance from the square to the entrance of the Sumner Tunnel. There was a butcher shop that was owned by Sal Lombardo, of Lombardo's fame. His father was a friend of Babbononno and fresh meats were often bought there. Nanna would next look at the fruit and vegetables sold from the pushcarts by the vendors, and more often than not, would whisper to my mother in Italian, "Esperiamo, voglio

videre le cose a Sr. Bruno." (Let's wait, I want to see the things at Mr. Bruno's.) Bruno's, a green grocer at the corner of Brooks and Trenton Streets and his store was where she usually bought the fruits and vegetables for the family.

From the pushcart area, we headed onto Bennington Street and stopped at Kennedy's Butter and Egg Store. A pound of butter and a couple dozen eggs later, we would walk along Bennington until we arrived at Tilly's Market. Looking at the latest imports from the old country, Nanna or Mom would pick out Torrone or chocolates. Tilly would wait on them speaking Italian to my grandmother. Years later, I found out that Tilly was Jewish, but living in East Boston all her life, learned Italian well enough to converse with her customers.

As we arrived at Brooks Street, we would head up the hill and stop at Faber's Fish Market. The fish would be for the Friday after Thanksgiving, as back then, Catholics couldn't eat meat on Friday. At the next corner, Saratoga and Brooks, was Umana's Bakery. They made fresh Italian bread and Nanna and Mom would pick out a couple of loaves that would grace the table on Thanksgiving. The store was owned by Guy Umana, the brother of Senator Mario Umana, and he always had a tray of Sicilian pizza on the counter. A couple of slices would become my lunch. When we reached Mr. Bruno's, Nanna would pick out the fruits and vegetables, argue over the prices, come to an agreement with Mr. Bruno and they would be bagged and placed in the second oilcloth shopping bag. From there we would head to Staffier's corner store at Eutaw and Brooks Streets. Nanna would buy the fixings to make pasta dough and ricotta for ravioli filling. Before we left there, she would include a bottle of Brioschi for Babbononno, just in case he got heartburn after Thanksgiving dinner.

The next morning was Thanksgiving. Mom and Nanna would begin to prepare the food for the dinner right after their morning coffee. In the meantime, Dad had brought Babbononno to Zi'Antonio's house to buy homemade wine. Zi'Antonio was Nanna's oldest brother and Babbononno's best friend, and according to my grandfather, he was the best winemaker in the world. Later in the day, my uncles and their families would arrive, each bringing something to grace the Thanksgiving table. A few minutes after their arrival, the kitchen table would be covered with Italian cold cuts, cheeses, olives, marinated mushrooms, artichoke hearts, hot peppers, sliced bread, and bottles of good cheer including one of the gallons of my great uncle's best red wine.

At around noon or 1:00 o'clock, someone would yell, "Siamo pronto a mangare." We are ready to eat. Each of us would have an assigned seat at the table and we would await the coming feast. Dad placed the turkey in the center of the table and the first course, escarole soup with pastina and tiny meatballs would be served. At this point, Babbononno would give thanks in Italian and English, and then it would be time to eat.

After the soup came the homemade ravioli accompanied by Nanna's meatballs, sausages, and chunks of gravy meat. This was followed by stuffed artichokes, sautéed mushrooms, assorted vegetables, and salad at the end. Dessert would include fruits and nuts. The pastries would come later with both Italian and American coffee. After dinner, the men would head for the living room, light up cigars and most would fall asleep before the cigars were half smoked. Most wouldn't awaken until the coffee was ready.

Oh, the turkey ... it could have been made out of plastic and no one would have known the difference. This was Thanksgiving, an American holiday, but we were Italian and we celebrated it Italian-style. Considering the other foods on the table, the turkey was just an ornament. Unfortunately, those days are gone, and with the corona virus still present, we will be wishing each other a happy Thanksgiving via the video conferencing cell phone technology allows.

There are just a few things you may want to keep in mind when ordering a pizza from a *pizzeria* in Italy. First and far most, when ordering, remember it is typically "one pizza per person"; pizzas are made for one. Unlike this country where we usually request a small, medium or large. Also, pizza does not come pre-sliced so it is proper to eat it with a fork and knife. Secondly, pizza is ordered by its proper name; picking and choosing ingredients or asking for substitutions is definitely not the standard. Third, the



gentleman who makes the pizza is referred to as a "pizzaiolo", and a good *pizzaiolo* is a valued and highly respected craftsman. Fourth, though Italians are known to love wine with their dinner, absolutely not the case with pizza. In Italy, it's always "una birra" or "a beer" that is ordered with pizza. Finally, those small round individual sized pizzas perfect for snacking on are known as "pizzettes"!

When I hear the word pizzettes, I automatically think of the "English Muffin Pizzas" my Nonna made so often when I was growing up. Though they were definitely not something you'd find in Italy, they were one of those Italian American cucina povera creations that were loved by all! Pizzettes made with pizza dough are also something my family made often, using a variety of sauces and/or toppings. This time of the year, with butternut squash and pumpkin in abundance, I thought my recipe for Butternut Squash Pizzettes or Pizzette di Zucca would be perfect to share. These delicious little rounds of dough topped with caramelized squash, onions and cheeses, are absolutely perfect to serve as an appetizer for your holiday event. They can be made with pumpkin or butternut, and even your choice of cheeses. I can assure you that your family and friends will absolutely love these amazing "Butternut Squash Pizzettes"!

BUTTERNUT SQUASH PIZZETTES Pizzette di Zucca

Pizza Dough (Can substitute store bought)

1 ¾ teaspoons active dry yeast 1 cup room temperature water 1 tablespoon sugar 3 ¾ cups all-purpose flour 1/3 cup warm water 1 ½ teaspoons salt

In a small bowl add yeast and sugar to 1/3 cup warm water and let stand until foamy then stir in the oil. In a food processor, add the flour and salt, pulse to blend. Slowly add the liquid mixture through the feed tube while the machine is running, and add the 1 cup of room temperature water, as well. Process until the dough makes a ball then remove and knead by hand on a lightly floured dough board. Place dough into an oiled bowl, cover and let rise until double in size. Split dough in half and roll and stretch each half into a rectangle. With a 3-4-inch round biscuit cutter, cut dough into approximately 12 rounds on each rectangle. Roll out and place the dough circles/pizzas on 2 parchment lined baking sheets. Cover each with a towel and let rise for at least 35-50 minutes.

Topping

1/4 cup olive oil

cups butternut squash, peeled and cut into 1-inch

2 shallots, finely chopped 6-8 ounces pancetta

6 sage leaves

 $Salt\ and\ pepper$ $\frac{1}{4}$ cup olive oil and 4 tablespoons

1/4 cup grated parmesan cheese 2 pounds mozzarella cheese, shredded

Preheat the oven to 375°. Toss butternut squash with ¼ cup oil, season with salt and pepper. Spread mixture on a large parchment lined baking sheet and roast, turning often, until squash is caramelized but holds its shape. Remove from the oven, immediately sprinkle with grated parmesan cheese and let cool.

In a medium skillet, over warm heat add 4 tablespoons of oil and add sage leaves, heat until fragrant. Remove sage leaves, discard or save for garnish. Add pancetta and shallots to the skillet and cook until the onions are caramelized, and the pancetta is cooked. Add shallot/pancetta and oil from the pan to cooked, cooled squash mixture, and mix together well.

Assembling Pizzettes


Preheat the oven to 450°. Take prepared pans with pizza dough and place topping evenly on each round, leaving the edges free. Place in the oven and bake for about 10 minutes. Remove from the oven and generously sprinkle mozzarella cheese over top of each pizza. Place back in the oven and bake until the dough is golden brown.

Brooklyn's Got a Winning Team: No Crum-Bum Here





The 1957 team photo; the last time the "bums" would be called the Brooklyn Dodgers.

To this day, the shipping of the Brooklyn Dodgers and the New York Giants out west still strikes a bad chord for many New Yorkers. The loss of the Dodgers is especially painful as the team was not only a quintessential part of New York, but its very name spoke to the city's flighty relationship with its famous streetcars.

New Yorkers had a more lukewarm relationship with the Giants. The team had an unimpressive streak and rarely grew a profitable crowd even after winning the World Series in 1954. For Horace Stoneman, the owner, the move to San Francisco was a last-ditch effort to find a new home and a new crowd for the team, the Polo Grounds rarely packing a house. Once in the Golden Coast, his hopes and projections were proven wrong.

Their rivals, however, were faring much better and Ebbets Field was never silent when the Dodgers were playing at home. They had five pennants under their belt and one victorious World Series. Nonetheless, team owner Walter O'Malley wanted expansion and in Brooklyn there was little room to grow

"The Finest All-Around Fighter I Ever Saw" — Eddie Futch
Inspiration for August Wilson Play

Though most that saw him in action are gone now, in years past when you asked those who knew boxing, their pick for the greatest all-around boxer of all-time, it wasn't unusual to hear the name Charley Burley come from their lips. Back then, people who were not well versed in boxing history would be puzzled by that response, as they had never heard of Burley. It was not unusual to

see an occasional article appear with a title something like, "Charley Burley: The Greatest Fighter Nobody Has Heard Of." Today, he is better known now, due to the work of dedicated boxing historians, and he has been getting the recognition he deserves.


Only a few minutes of footage from one of his fights exist, but by looking at his record, reading what people who fought him and saw him, as well as the people who refused to fight him, you get a pretty good idea that Charley Burley was one difficult opponent.

In 1944, Burley and Archie Moore faced one another. Charley decked Moore winning a tenround decision. Archie would later call Burley "The greatest pound-forpound fighter I ever faced." He described Burley as, "The man was fantastic; he could lean away from a punch, be clear off balance and knock your brains out with a counter." That's quite the endorsement.

Another little known story about Burley is


that he was the inspiration for the character Troy Maxson in August Wilson's play Fences. Wilson grew up across the street from Burley in Pittsburgh. In a 1993 interview with Ronald K. Fried Wilson said "I grew up without a father, and the male image that was in my life ... was Charley Burley. And that's what being a man meant to me, to be like him. I wanted to grow up and dress like him. He wore those Stetson hats and


things of that sort, and I couldn't wait until I got to be a man to be like Charley Burley."

When pressed by Fried as to whether Maxson was based on Charley Burley, Wilson responded, "I suspect so, maybe unconsciously. Troy Maxson has the magnificent spirit that I saw in Charley Burley."

It seems ironic that Charley Burley who was never given a shot at the title has been immortalized in a play, yet hardly anyone knows the character that he was the inspiration for the lead character.

Even long after his boxing career ended, he still couldn't catch a break.

There will be college hockey in New England this winter. So states an announcement from the Hockey East Association in Wakefield where new Commissioner Steve Metcalf is in his first year directing the conference.

That's good news for the players, coaches, and fans of Boston College, Boston University, and Northeastern, all three of which belong to Hockey East.

The announcement that Hockey East would return to action came just days following the announcement that the Ivy League — which includes Harvard — had canceled all winter sports (including men's and women's hockey and basketball) for the 2020-2021 season.

That move rocked the Eastern Conference Athletic Conference since not only the Crimson but fellow Ivy League colleges Cornell, Brown, Princeton, Dartmouth, and Yale also compete in the 12-team ECAC Division 1 hockey league. That leaves the ECAC with the task of putting together a schedule for the remaining six Division 1 teams.

Additional negative news came on November 16th, with the announcement that the Beanpot Tournament (the Hub's unofficial festival of college hockey) would not be played in 2021.

But Hockey East intends to lift the lid on its season today, Friday, November 20^{th} , before Thanksgiving.

"We are excited to make this announcement and very appreciative of all the hard work by so many in making it happen," stated commissioner Metcalf in a press release.

Each of the 11 men's teams will play 20 league games while the 10 women's teams will each play an 18-game schedule. Both the men's and women's slates feature weekend home-and-home series and day-of-game travel with the exception of contests against Maine and Vermont.

There is time built into the schedule both during the middle of the season and in the final three weekends to allow for rescheduled games to take place. They will definitely be needed since Vermont recently announced that it would delay the start of men's and women's hockey and basketball until December 18th.

Policies on fan attendance have been left to the individual schools. However, given how things are trending, we think it is a real long shot that fans will be in the stands this winter.

The men's regular season is slated to conclude on March 6th followed by conference playoffs. They normally culminate with the final four teams advancing to the TD Garden in mid-March for the championship weekend. However, as we all know, these are not normal times, so stay turned as to how, when, and where the culminating event of the Hockey East season will take place.

The NCCA men's regionals are still slated to take place the final weekend in March at Bridgeport, CT, Manchester, NH, Fargo, ND, and Loveland, CO. The regional winners are scheduled to advance to Pittsburgh for the Frozen Four in mid-April.

The women's regular season is scheduled to end on February 27th, followed by the league playoffs and the championship game — all at sites to be determined. The NCAA women's Frozen Four is scheduled to be played in Erie, PA in late March.

Switching gears a bit, the college basketball season is scheduled to begin across the country on November 25th and the usual patchwork of contrasting policies as to what can take place and when plus who will be allowed to attend continues to dominate an ever-changing landscape.

In one of the more interesting arrangements, the Mohegan Sun Arena in Connecticut will host several college hoop events between November 25th and December 5th, as some 40 men's and women's teams from across America will play 45 games over the course of that span

Each team will be assigned an entire floor of its own — in a hotel, which has been reconfigured into a bubble. There are a variety of tournaments within the overall event — so as teams return home, their floors will be cleaned and then assigned to incoming teams.

This is a big-time festival of hoops with several Top 10 teams on both the men's and women's sides taking part. Such a concept might have a future — even in the years after the virus passes. It is an interesting way to start the college basketball season.

Meanwhile, the conclusion of the upcoming college basketball season has been a topic of vigorous conversation.

The Atlantic Coast Conference recently proposed that all Division 1 teams (there are over 300) advance to the 2021 "March Madness" Tournament as "a celebration of basketball."

Under that proposal, there would not be a Selection Sunday since all teams would qualify. That proposal was shot down by NCAA executives.

One of the latest proposals is to have the entire 68-team tournament take place in Greater Indianapolis. Currently, Indianapolis is slated to host the Final Four event in mid-April at Lucas Oil Stadium.

Already a decision has been made to move away from regional sites that traditionally lead into the Final Four event. All that remains is to determine if the Greater Indianapolis area is capable of hosting the entire event.

According to the *New York Post*, Dan Davitt, the NCAA senior vice president of basketball, has indicated that players would be housed in a "controlled environment" during the tournament in a setting that could include several hotels and practice facilities. "It would be hopefully something we treasure and experience just once, not ever again," stated Gavitt.

If it is determined that Greater Indianapolis does not have the facilities to host the entire 68-team tournament, then other sites will be explored. But right now, the Indianapolis area is the favorite.

This brings to mind the slogan shown on the Jumbotron prior to all Indiana Pacers home games: *In 49 states, it's just basketball.* But this is Indiana!!!
