Stirpe Nostra

HADRIAN'S TOMB, CASTEL SANT' ANGELO

Getting back from last week's issue to a serious note and showing all due respect to this most gifted emperor, I must say there is little doubt that the most famous of all ancient Roman tombs is the mausoleum that Hadrian built for himself and the succeeding members of his family. He started construction on the tomb himself in 130 A.D. but it was completed a year after his death by Antoninus Pius. The structure is almost 300 feet wide and over 150 feet high. The exterior face of the entire structure, including a cone-shaped roof was faced with white marble. There were beautiful marble statues round the roof and a bronze quadrigae (chariot drawn by four horses abreast) at the summit. A central chamber held the sarcophagus (stone coffin) of Hadrian; its base was later destroyed by fire and the lid is now used as a fountain in the Baptistry of St. Peter's Basilica in Rome.

Pope Gregory was walking barefooted as he was conducting a penitential procession through the streets of Rome to pray for the cessation of a plague which was ravaging the city in 590 A.D. He beheld a vision of Michael the Archangel sheathing his sword while standing on the uppermost part of the mausoleum. This vision coincided with the end of the plague and the structure has been called Castel Sant' Angelo since that time. A covered passageway to the Vatican was built by Pope Nicholas III in 1277, and this permitted the tomb to be used by future popes as a place of safety during the times when the city was under siege.

The mausoleum has always been used by the party in power as a stronghold. At least one pope and many others were murdered within its walls. Antonio da Sangallo designed the octagonal dungeons, which were added to the corners of the lower floors. Pope Julius II added the front loggia, Pope Leo X erected a Chapel here, and Pope Clement X remained in safety within its massive walls during a seven month siege upon Rome. The tomb has been plundered by the Vandals and the Goths, and its beautiful statues were used as missiles from the parapets. It has been hammered by all the machines of warfare. despoiled by robbers, and remodeled by engineers, during the past centuries. Majestically it stands today overlooking the Tiber, one of the great landmarks of the city. Its history is almost the history of Rome.

Although some writers, including myself, have cast the shadow of suspicion on the manner of his accession to the imperial throne and upon a small portion of his moral character, Hadrian's death marked the passing of one of the most versatile and gifted figures in all of Roman history. The Wheels on the Bus Go 'Round and 'Round

On September 11, 2001, al-Qaeda terrorists used airliners to attack the United States. On March 11, 2004, al-Qaedainspired terrorists set off a series of coordinated railway train bombings in Madrid, Spain. And, just before the busy Thanksgiving travel season this year, the Transportation Security Administration warned U.S. police departments of a credible threat of terrorist attacks on city buses. Americans love political and topical humor. Many get their news from the Tonight Show monologue, Saturday Night Live, the Daily Show, and Colbert Report — perhaps more than from the "real" news. If that is true, then we are in good company. The ancient Athenians' often held up as an example of the most perfectly engaged citizens in a Democracy, got their current events and news from the bawdy comedies of Aristophanes.

Recently I was in Washington, D.C. and had the opportunity to see the Library of Congress exhibit Hope for America: Performers, Politics and Pop Culture. The exhibit focuses on the careers of Bob Hope and other entertainers who chose to involve themselves in the political climate of their times. The funny men and women featured in the exhibit served party, cause, and country and in the end made a difference in the political life of the nation.

So al-Qaeda is going to take the bus. Well, if Richard Reid, the unsuccessful "shoe bomber" of December 22, 2001 and Umar Farouk Abdulmutallab, the Christmas Day 2009 "underwear bomber" — who succeeded only in setting fire to his pants — are typical, I guess we must conclude that al-Qaeda will be on the short bus, if you know what I mean.

GUEST EDITORIAL QUINCY CELEBRATES VETERANS DAY IN GRAND STYLE

When I was growing up, my father always took my brother and I to Downtown Boston to watch the Boston Veterans Day Parade. Back in the '50s and '60s, it was probably one of the largest Veterans Day parades in the country. Today, in Boston like across America many of these patriotic displays have dwindled away. How sad that in Boston, where the American Revolution began, you have to leave the city to find a Veterans Day Parade. For the past quarter-century, I have celebrated the holiday by marching in the large Veterans Day Parade anywhere around here across the Neponset Bridge in Quincy, the City of Presidents.

The annual ceremonies are sponsored by the Quincy Veterans Council on behalf of the city's various veterans' posts. Guest speaker this year was James Fratolillio, a U.S. Army, Vietnam combat veteran and past state commander of the American Legion. He enlisted in the U.S. Army at age 17 and was stationed in Vietnam in 1967-68 and served with the 1st Field Forces Vietnam (Forward) Division. He was wounded in battle in 1968 and received a Purple Heart. His speech was quite inspiring as he talked about the sacrifices made back then by those who fought for their country. His comments were simple and direct. He talked about when he at 17 and his friend at 18 both enlisted together. His friend was killed in action at age 20 in 1968. He talked about his pain at the loss of a childhood friend who made the supreme sacrifice. As a baby boomer who enlisted in the U.S. Air Force right out of high school in 1966, I thanked him for his talk to all those gathered to honor all our veterans living and dead for their service to their country.

I return to Quincy yearly to stand and march with all those whose sacrifices make it possible for us to gather as free citizens and appreciate our individual liberties.

LET'S BE HONEST:

Congress Will Never Balance the Budget, and Knows Perfectly Well What that Means

Let's just recognize something: Congress is never going to get spending under control. It doesn't want to. It is never going to balance the budget. It doesn't want to do that either. It only wants to create a convincing enough illusion of its attempt to do so that it can get itself through the current election cycle.

And because the voters have thus bought tickets to this absurd theater act, and show no signs of doing otherwise any time soon, the problem is not going to be

Ever.

It is par for the course that the congressional supercommittee has failed to achieve the spending cuts that were allegedly its mission. Monday following Sunday is a bigger surprise than that.

The nation faces more than \$10 trillion in new debt over the course of the next decade unless Congress does something drastic to change the direction of events. Congress will not do this. Congress does not want to do this.

And why should it? The voters reward excellence in theater more than actual results, and members of Congress know this well. Consider: At the conclusion of the summer's so-called debt ceiling "debacle," it was announced that the sides had agreed on \$2.4 trillion in spending cuts over 10 years. The announcement was great theater because it

sounded like an achievement. It was not. The \$2.4 trillion, which would only amount to 15 percent of annual deficits anyway, will never be cut.

All the two sides did was accept a theoretical longterm plan that is as fictional as Happy Days. Future Congresses will make their own spending decisions, regardless of what anyone said in 2011.

Then, more theater: We were told that a supercommittee consisting of an equal number of members from both parties and from both houses of Congress would come up with a master plan to achieve far more deficit reduction. This was reported as a serious development. It was not. The supercommittee was never going to achieve anything. Its failure was not only preordained but certainly known to be inevitable by every one of its members.

Ah, you say, but what about the sequester - the automatic across-the-board budget cuts that go into effect if the supercommittee fails? Surely you have seen by now the excellent chart created by Veronique de Rugy at George Mason University, which shows that spending with the sequester and spending without it are almost exactly the same, especially over the long term.

The joke's on you, and always has been.

Here's the basic problem: In order to bring spending

down to the same level as revenues, Congress would have to tell a whole bunch of people who have come to rely on federal support, benefits or largesse that they can no longer do so. Democrats absolutely refuse to do this. Republicans express willingness rhetorically, but as a practical matter, they are also unwilling because they shrink from the fight by which they would have to defend the cutting or elimination of specific programs. The federal government now spends \$3.7 trillion annually, and almost no one in Washington really wants it to spend less than that. That's why the best they can come up with is a theoretical 10-year plan that cuts the annual spending figure to only \$3.4 trillion or so, but in reality does not cut it at

This spending level will not decrease. Ever.

But the federal government is only taking in \$2.1 trillion a year. If you're not going to cut spending and they're not — then the only way to stop taking on new debt is to somehow bring revenue levels up by \$1.6 trillion a year or more. In addition to being almost impossible, since there are not enough millionaires and corporate jet owners from whom to confiscate that much money, it would also destroy the ability of the private sector to create wealth.

Violent movies, violent video games and violent life on the street. Thanksgiving and peace seem so rare; it probably should be listed as





Two Special Events

On Thursday, November 17, the Saint John School Development Board, headed by Director of Development, Lisa Santarpio, sponsored its second annual awards celebration at the Fairmont Battery Wharf Hotel. Sister Eileen Harvey, CSJ, Principal of Saint John School for the past 27 years opened the event with a welcoming address and prayer. The Saint John School Choir then, charmingly sang several songs to appreciative guests who gave them rousing applause. Honored at the cocktail party for their contributions to the school and the North End Community were: Mary Wright of the North End Health Center, Peter Nobile Jr., Nobile Insurance, and David Banning Fair of the Hard Rock Café. Robert Verrier Co-Founder of The Architectural Team was the guest speaker. Serving as Master of Ceremony for the second year was Jason Aluia.

On Sunday, November 20th, Vincenza Raspa, along with other recipients was presented with the Cheverus Award at the Cathedral of the Holy Cross by Cardinal Sean O'Malley. Nominated by Father Antonio, Pastor of Saint Leonard Parish for her service to the parish, Vi, as she is known to her friends, is a life-long resident of the North End, who for all of her 90 plus years has been a faithful and active parishioner of Sacred Heart Church. Vi remains an active parishioner to this day, tending to the needs of the church and continuing in her decades long devotion to the recital of the rosary which she does with other members of the Rosary Group starting at 6:00pm in the evening every day but Sunday at Sacred Heart Church.

The Cheverus Award takes its name from Jean-Louis Lefebvre de Cheverus who was born on January 28, 1768 in Mayenne, France. Cheverus was ordained deacon in October 1790. At the age of 22 after completing his theological studies at the Seminary of St. Magloire, he was ordained a priest of Montauban, France by special dispensation on December 18. Cheverus refused to take the oath imposed by the leaders of the French Revolution costing him his parish, and nearly his life. He escaped from Paris to London, in disguise. A letter from a former professor, the Rev. Francis A. Matignon, then pastor at Boston, told him of the hard conditions and the needs of Catholics in America. He answered the call, and arrived in Boston on October 3, 1796. His work in New England, spanned twenty-seven years, during which he performed every form of missionary activity. Gradually he won the respect of the Puritans. Ministers invited him to their pulpits. The Massachusetts legislature sought and acted on his counsels. He was ecclesiastically ordained bishop of Boston and consecrated on All Saints Day, November 1, 1810. Cheverus supported the establishment in 1816 of the Provident Institution for Savings established in Boston, the first chartered savings bank in the U.S. He believed the bank would inspire virtuous thrifty behavior among his parishioners. In 1823, Louis XVIII insisted Cheverus return to France where he became bishop of Montauban, January 13, 1823. On July 30, 1826, he was elevated to the Archbishopric of Bordeaux and became Cardinal on February 1, 1836, in accordance with the wish of Louis Philippe. He died in Bordeaux on July 19, 1836 at the age of sixty-eight.

To Those of Us Born 1925 - 1970:

At the end is a quote of the month by Jay Leno. If you don't read anything else. Please read what he said.

To all the kids who survived the 1930s, '40s, '50s, '60s and '70s!!

First, we survived being born to mothers who may have smoked and/or drank while they were pregnant. They took aspirin, ate blue cheese dressing, tuna from a can, and didn't get tested for diabetes.

Then, after that trauma, we were put to sleep on our tummies in baby cribs covered with bright colored leadbased paints.

We had no childproof lids on medicine bottles, locks on doors or cabinets, and, when we rode our bikes, we had baseball caps, not helmets, on our heads.

We would spend hours building our go-carts out of scraps and then ride them down the hill, only to find out we forgot the brakes. After running into the bushes a few times, we learned to solve the problem.

We did not have Play Stations, Nintendo's and X-boxes. There were no video games, no 150 channels on cable, no video movies or DVDs, no surround-sound or CDs, no cell phones, no personal computers, no internet and no chat rooms.

If we took all of this away from kids today they would not know how to handle it!!!!

We had friends and we went outside and found them! We fell out of trees, got cut, broke bones and teeth, and there were no lawsuits from those accidents.

We would get spankings with wooden spoons, switches, ping-pong paddles, or just a bare hand, and no one would call child services to report abuse.

We ate worms, and mud pies made from dirt, and the worms did not live in us forever.

We were given BB guns for our 10th birthdays, 22 rifles for our 12th, rode horses, made up games with sticks and tennis balls, and although we were told it would happen — we did not put out very many eyes.

We rode bikes or walked to a friend's house and knocked on the door or rang the bell, or just walked in and talked to them.

Little League had tryouts and not everyone made the team. Those who didn't had to learn to deal with disappointment.

Imagine that!!

The idea of a parent bailing us out if we broke the law was unheard of. They actually sided with the law! These generations have produced some of the best

risk-takers, problem solvers, and inventors ever. The past 50 to 85 years have seen an explosion of innovation and new ideas.

We had freedom, failure, success and responsibility, and we learned how to deal with it all.

If you contract with a company to do a job and it does not have workers compensation coverage for its workers, can you be liable for injuries to that company's employees?

In 2005, the defendant was the general contractor at a residential construction site in Newburyport. It hired a subcontractor, Great Green Barrier Co. (Great Green), to perform waterproofing work on the residence. An explosion at the site resulted in the death of Timothy B. Wentworth and serious injuries to Timothy's son, Ezekiel, both of whom were Great Green employees.

Great Green did not carry workers' compensation insurance. In 2007, pursuant to G. L. c. 152,.§ 18, the defendant's insurer agreed to lump-sum settlements of Timothy and Ezekiel's workers' compensation claims. ⁵In 2006, the plaintiff had insurance carrier of the

filed a complaint alleging that the defendant's "negligence, gross negligence and/or willful, wanton, or reckless conduct" resulted in Timothy's death and Ezekiel's injuries.

The decedent's Estate even though it received a lumpsum settlement sued the General Contractor for the deaths. The General Contractor said the decedent was not its employee and it wasn't responsible the Supreme Judicial Court decided the original contractor was responsible.

The Court Said:

Where an injured worker is an employee of an uninsured subcontractor, the general contractor that entered into a contract with that subcontractor is required to pay the workers' compensation. "[T]he oft-declared purpose of is to prevent ... [an insured entity such as a general contractor] from escaping the obligation of the compensation act by letting out part of [its] work to irresponsible subcontractors or independent contractors."

So if you have a company to put a new roof on your house, or a painting contractor or a plumber or electrician make sure they carry workmen's compensation. If one of their workers get injured on the job they may come after you.

DON'T LOSE SIGHT OF DIABETIC EYE DISEASE

Thousands of American Adults are at Risk of Losing Their Vision as a Result of Complications from Diabetes

Diabetes affects nearly 26 million people in the United States. In addition, another 79 million people are estimated to have pre-diabetes, a condition that puts people at increased risk for diabetes. All people with diabetes, both type 1 and type 2, are at risk for diabetic eye disease, a leading cause of tion Program. "If you have

vision loss and blindness.

"The longer a person has diabetes, the greater his or her risk of developing diabetic eye disease," said Dr. Suber Huang, chair of the Diabetic Eye Disease Subcommittee for the National Eye Institute's (NEI) National Eye Health Educa-

diabetes, be sure to have a comprehensive dilated eye exam at least once a year. Diabetic eye disease often has no early warning signs, but can be detected early and treated before noticeable vision loss occurs."

Diabetic eye disease refers to a group of eye problems that people with diabetes may face as a complication of the disease and includes diabetic retinopathy, cataract, and glaucoma. Diabetic retinopathy, the most common diabetic eye disease, is the leading cause of blindness in adults 20-74 years of age. According to NEI, 4.1 million people have diabetic eye disease and its prevalence is projected to increase to 7.2 million by 2020.

While all people with diabetes can develop diabetic eve disease. African Americans, American Indians/ Alaska Natives, Hispanics/ Latinos, and older adults with diabetes are at higher risk of losing vision or going blind from it. All people with diabetes should have a dilated eye exam at least once a year to detect vision problems early. In fact, with early detection, timely laser surgery, and appropriate follow-up care, people with advanced diabetic retinopathy can reduce their risk of blindness by 90 percent.

Clinical research, supported in part by NEI, has shown that maintaining good control of blood sugar, blood pressure, and cholesterol can slow the development and progression of diabetic eye disease. In addition to regular dilated eye exams, people with diabetes should do the following to keep their

The Higgins Armory Museum evolved from a PRIVATE COLLEC-TION OF ARMS AND ARMOR FROM MEDIEVAL AND RENAISSANCE EUROPE, FEUDAL JAPAN AND ANCIENT GREECE AND ROME into a world-renowned museum. Founder, John Woodman Higgins, a leading Worcester industrialist, spent a lifetime building his collection. In 1929, he constructed a four-story building to house it, and in the same year, received a charter for a museum of historical and modern metal artifacts. The Armory's collection, displayed in a Gothic castle setting is extensive. The European portion consists of 3,000 armors and components, 1,000 weapons and accessories, 500 swords and daggers; 100 firearms; a tapestry, stained glass, paintings and wood carvings. In addition, the non-Western collection comprises 1,000 African, Islamic, Indian, and Japanese body defenses and arms. The four-story art deco Museum was one of the first all steel and glass curtain-wall structures built in America, and was placed on the National Register of Historic Places in 1980. On John Higgins' death in 1961, the building, collections and an endowment were given to the public. Harvard University researchers tracked the drinking habits of more than 100,000 women over 28 years and found that just three glasses of wine or beer per week increased their breast-cancer risk by 15 percent compared with teetotalers. Downing more than two glasses a day increased their risk by 50 percent. And even if women quit drinking later in life, their alcohol consumption between ages 18 and 40 still had some effect. Moderate drinking is known to lower the risk of stroke and heart disease, which the average woman has a 50 percent chance at some point in her life; the average chance of developing breast cancer is 12 percent.

Using teaspoon, drop a spoonful of cookie mixture into the sesame bowl. Gently cover with seeds and place on lightly greased cookie sheet.

If desired, beat one egg. Using a pastry brush spread egg wash over cookies prior to baking. Bake in preheated 350°F oven for fifteen to twenty minutes or until done.

Makes about five dozen cookies. Store in a cookie

NOTE: My introduction to the Regina cookies was in the 1950s when the family decided to bake and sell a selection of cookies in our bakery along with the Italian bread. This sesame seed cookie continues to be popular in my family. I prepare this downsized recipe to bake for use at home and to give as gifts during holiday.



A Nostalgic Remembrance

First of all, although it is a day late, let me wish all of you a Happy Thanksgiving. Once again, I combined my family with that of my cousin, Ralph Pepe. We had an added surprise this year, company from Italy. Loretta's friend, Manuela Ferarri, from Milan, had never experienced an American Thanksgiving. We invited her and she accepted. Later, when we were alone, her comments included her observations of family, several generations of family, and the interactions that took place between them all. She also indicated that it was like an old fashioned Italian gettogether except for the fact that the food was American and English was spoken.

Last week, I left off with Sal Meli and me arriving in Catanzaro. Actually, we drove to a little town just outside of the main city of Catanzaro, called Andeli, with the accent on the "A." A friend from Watertown and his wife had gone back to visit family and check on an offer given to them by a German developer. They owned a piece of beach-front property and the developer wanted to buy it and put up a resort of sorts. We were late driving from Reggio and they were with the representatives from the German company.

Sal and I were entertained by my friend's aunt at her home, and within an hour or so, my missing friends showed up with smiles on their faces. Without saying anything in the way of business, I guessed that the Germans offered them quite a bit to purchase their beachfront land. It was late afternoon, and time for dinner. They took us to the best local restaurant in town along with just about every other relative that wasn't committed to something. We hit it off with one of their cousins. He was young, single and relished the idea he was going to hang around with two Americans for a few days.

My friend's aunt insisted that we stay at her home, but it was overcrowded and inconvenient. My friend knew that the best thing for us was to check into a hotel and he knew one on the beach that might be to our liking. When we saw it, it was. Most of the guests were young single Italians on summer holiday, and this meant many lovely young ladies

from Watertown, brought his single cousin and joined us at the hotel for lunch. We sat out on a veranda that was actually on the beach. Before they arrived, Sal and I spent most of the morning and early afternoon on the beach sunning ourselves, swimming and admiring the scenery, if you catch my drift.

When Al and his cousin arrived, we selected a table at the hotel's beach restaurant. We sat in the shade with most everyone around us still in their bathing suits. We began discussing the qualities of the young ladies that surrounded us, but it was in Italian. Al's cousin really didn't speak enough English to converse in anything but Italian. We ordered something to eat and I began eaves dropping on a conversation between two girls at the next table. By their accents I knew that they were English. They were actually discussing Sal and me, not thinking that we could understand English. One of them indicated that she found Sal quite attractive with his tan and curly hair. When Sal had hair, it was so curly that he had an Afro, long before it became stylish in the U.S. Sal overheard the young ladies and mentioned their conversation to the rest of the table, only in Italian. From that point on, we focused in on what the two girls were saying. The next thing we heard were comments from the second of the two, describing me and that she would like to meet me, but how? Being a wise guy, I told my companions that I was going to put a cigarette in my mouth, and not finding a match, would ask them if anyone had matches. Each of them was to say no and I would take it from there.

The two young ladies observed us searching. I soon turned to them and saw a lighter sitting on a pack of English cigarettes near the one that made the comments about me. As I turned. she said, "Si signore." In my perfect Boston accent, I said, "May I borrow your lighter, we seem to be out of matches." She turned purple, now knowing that we understood everything they were saying. Well, they were embarrassed and that was the end of the relationship. Like I said, I could be a wise guy.

We stayed with my friend The next day, Al, my friend Al and his family for another

day or so and then hit the road. The only reservation we had made was for a hotel room in Rome and I wanted to see southern Italy before we headed for the Italian capital. Rome is like any other big city worldwide, no reservation, no rooms. Before we left, I called home to let them know that we were heading north. When speaking to Babbononno, he reminded me that I had promised that I would visit Foggia where he was born and try to find family. I said that I hadn't forgotten and that I would head there when I was on the east coast of Italy. Mom and Dad wished us luck on our trip north, and after many good byes, we

left Catanzaro. On the outskirts, we passed a wine stand. In rural America we have fruit and vegetable stands with some of them selling apple cider. In Italy many of the local mom and pop vintners sell their wine on the side of the road. I sampled a couple of the blends the owner had for sale, selected the one I liked and bought a five liter bottle of it. The bottle was a giant Chianti bottle without the wicker around it. The vintner carved out a stopper from a piece of cork, stuck it in the top of the bottle and we were on

We drove west on the highway that connected Catanzaro and Reggio. There was no major highway heading northward in that general area except from Reggio. So, we retraced our steps and looked at the local scenery. Part of the way, we were up in the mountains of Calabria. The road was a two lane road with no guard rails and I took it slow manipulating some of those mountain curves. Without any warning, a tropical thunderstorm developed and surrounded us. We were up so high, we weren't below the storm, we were in it. You couldn't see anything as the rain came down in sheets. The thunder sounded like the sixteen inch cannons on a battleship and when lightning flashed, it flashed horizontally across the car. We were in trouble. I couldn't see the edge of the road and I knew that, if I made a mistake, we would end up in the valley below the hard way. I soon saw red lights flashing in front of me and downshifted to second gear. An 18-wheeler was in front of us just crawling and I pulled in right behind the giant truck. We finally exited the storm and by the time we were at the foot of the mountain, the sun was out and the car was dry. I think what helped were the Hail Marys that Sal and I silently said. That day, we got religion.




CORNER TALK



ADDED ATTRACTIONS -With the first doubleheader already sold out, another attractive twin bill has been added to the outdoor hockey festivities at Fenway Park in January.

Come January 14 rivals Boston College High and Catholic Memorial High will take to the ice at 3:00 p.m. Then at 6:00 p.m. Northeastern will meet Boston College in a regular season Hockey East matchup.

The first event — scheduled for January 7 — sold out in less than a week, prompting officials to seek additional games in order to satisfy the eager crowds.

That doubleheader has the University of Vermont meeting UMass-Amherst at 4:00 p.m. to be followed by the University of New Hampshire facing the University of Maine in the nightcap at

NESN is televising both January 7 games as part of its TV tripleheader that day. The Bruins will play Vancouver at the Garden starting at 1:00 p.m. in a matchup of the two Stanley Cup finalists. When that concludes, NESN will immediately switch to Fenway to broadcast the action there.

Additional games on different days are a possibility. The rink will be available for several days between the two doubleheaders, leaving time slots available to schedule more games.

If you are going to any of these games, remember to dress warmly. You will be sitting in a cold weather environment for several hours, which is different than moving around in the cold. In addition, your seat will probably be more at a distance from the action than any seat at the Garden. Even though the games will be up on the Jumbotron, a pair of small binoculars might come in handy.

CLOSING IN ON TRIPLE DIGITS — When the Bruins emerged victorious in their shootout victory over the Columbus Blue Jackets on November 17 at the Garden, it was the 97th consecutive time that the B's had played before a sellout crowd on Causeway Street, a span that includes regular season and playoff games. If the home sellout string continues, the B's will reach No. 100 in early December.
