

AT HOME IN OLD ROME: THE DOMUS



Plan of a Domus

Domus or domo are the Latin words for house, building, mansion, home, residence or family. I feel that I must repeat a portion of two earlier columns which stated: "The shape, nature or character of all structures that have been built at any place or time in history have been influenced by their geographical location, geology, climate, religious beliefs and/or their social attitudes. Understanding these influences is prerequisite to an understanding of their architecture."

Keeping this in mind while examining the remains of Roman houses makes the pieces fall into place like the parts of a jigsaw puzzle. The geography of old Rome favored high density and large concentrations of people in urban areas, a natural progression from a City State. The geological influence is surely reflected in their choice of building materials. They were blessed with an abundance (abbondanza) of building stone, marble, and an excellent quality of sand and gravel, especially a clean sandy earth called pozzolana, which when mixed with lime, formed an exceedingly hard and cohesive concrete. The climate favored more outdoor life than Boston will ever have. They averaged 44°F in January and 77°F in July. During these pre-Christian times they practiced paganism. Ancestor worship was a recognized part of their religious rites. Socially, Imperial Rome was overcrowded and noisy, a barbarous arena during the daytime and a treacherous jungle at night.

If we take all of these ingredients and blend them together in a giant mixer, then set the dial to "Domus," the result will be a house built of stone and concrete that looks like a fortress from the outside but is designed for relaxed outdoor living within

the confines of its forbidding exterior.

It occupied most of the land that the family owned. The rear yard as we know it was a high-walled garden. The side yard space was moved to the center of the domus and called the atrium and the peristylium. Every home had a temple for the pagan worship of their family ancestors. Social attitudes turned rentable shops or blank walls to the narrow and noisy streets. After dark, these inviting shops and entrances became locked shutters and barricaded doors.

Entrance to the *domus* was from the public street through a door and framework which was the ostium. Passageways or corridors were called fauces. Guests were always ushered through the entrance court or vestibulium, and business affairs were always conducted in a room or space called the spatium. This spatium was always located in the public portion of the domus near the atrium. The atrium was always open to the sky for light and fresh air. The open portion above was called the compluvium and any rain which fell through was collected in a sunken floor tank called the impluvium. Guests who expressed an interest in the family roots of the host were ushered into the tablinium and permitted to view the family archives, line of descent, and proof of rank. Business documents were also kept on file here. The host would then suggest that the guest step into a nearby alcove called the alae, where he had very proudly displayed waxen images of the ancestors of the house.

The *alae* generally led to an inner court surrounded by columns, which was known as the *peristylium*. It served to beautify the private living quarters which all opened off this area. Overnight guests were permitted to occupy a small

bed chamber called a cubicule, but before retiring they might be invited to view a prized art collection in the picture gallery, which was called the pinacotheca. Small talk and interesting conversations alike were reserved for a sitting room called the exedrae. Libraries were always elegantly furnished and were called bibliotheca. The bath was always taken in the balineum and food was prepared in the culina. They prayed to their family gods in a chapel, which they called the sacraium. Extra all-purpose rooms were called dieta and a sunny spot or sunroom was known as the solarium. Dark and dingy rooms for the family slaves were called cellae, and any rooms in the upper story were known as cenacula. That often used, but seldom mentioned, little room where they did their daily "dooties" was called the

The rear of the domus usually contained a beautiful flower garden with statues and pools. The statues were in numbers to suit the family budget or at least to try to keep up with the Joneses. The walls of many interior rooms were painted with scenes showing the owner's favorite hobbies, such as a beautiful landscape, horses, boats, dogs, or women (I think I'd better get off this subject in a hurry). The dining room was the largest room in the house and the best paintings were usually placed here. Nine persons were the recognized number for a Roman feast; therefore by tradition, the proper dining room, or triclinium, always had three couches, which were large enough to accommodate three gluttons each.

latrina.

Guests invited to a Roman dinner usually arrived at three o'clock in the afternoon. They might have walked, but were usually carried in a litter by their slaves. Wine and food were served in great quantities. At the beginning of the meal, the servants placed the food on the tables. Later, when the guests were too full to reach, the food was handed to them.

Still later, when the guests became immobile, the food was placed in their mouths by the servants or their own slaves. Their manners didn't seem to be very formal. A notice placed on the *triclinium* wall in a Pompeian house still remains today and reads:

- 1. Guests will please refrain from casting improper glances at the serving women.
- 2. Do not make passes at the wives of the other guests.
- 3. You must take your shoes off, and you must let the servants wash your feet.
- 4. Use the napkins which are provided. Do not wipe your hands on the furniture or the clothing of the other guests.

Three weeks before the 1932 Presidential Election

As candidate, Mr. Trump made a bold statement; he promised to "Make America great again." For many of us who supported him, the issue of the contest was, as in 1992, "the economy, stupid." For a generation, we have seen the rich get richer, the middleclass get poor, and the poor get condescended to and/or scapegoated. Mr. Trump has promised to make the economy work, again, for ALL Americans. It's a big promise; I do not know how much he can deliver. He has four years (two years if the 2018 midterm election yields a Congress unwilling to advance his agenda) to deliver on his promises.

Mr. Trump is a Republican and his party will be in the majority in the 115th Congress. The last time Republicans enjoyed such strength in Washington was after the 1928 election. His positions on trade are in some ways close to those of many Democrats, so there is hope that, at least on trade and the economy, his agenda can advance with bi-partisan support.

Trump's call to renegotiate NAFTA, while bold, is not radical. NAFTA is not a static document and has been modified many times. The agreement sets forth lengthy and complex rules relating to border trade.

The rules are what the three nations agreed to in 1993. Since then, circumstances have changed and many times the three nations have come back and renegotiated specific rules (I was the drafter of a couple of those changes). Trump needs to identify what changes he believes are necessary to re-balance the agreement to address specific American concerns. Mexico and Canada will have their lists, too. Then the three negotiate. Yes, it will be more far-reaching than the modifications I was involved in. but it's a difference of degree, not kind. I hope disappointed Democrats will be open to working with President Trump on crafting a foreign trade policy that creates more good-paying American jobs.

To my many good and close friends and family who supported the other candidate and party I say, "You will live to fight another day. Calm down, President Trump can't do onetenth of the Bad Things you fear he'll do. He likewise will not do one-tenth of the Good Things I'd like him to do." As the poet laureate noted on the eve of another realigning election (yes, just four years after winning HUGE majorities in 1928, the GOP was repudiated in 1932), this country is too big for any one man to spoil.

L'Anno Bello: A Year in Italian Folklore

The Joy of Waiting

Every year, I unfailingly hear the same refrain uttered from the lips of exasperated coworkers and family members: "The Christmas season starts earlier and earlier each year!" This nebulous phenomenon is actually known as Christmas creep, and it can be a real pain for those of us who wish to enjoy each season slowly, watching it unfurl naturally. I remember staring in shock at a commercial featuring Santa Claus which aired a few weeks before Halloween, and marveling at the boxes of Christmas lights that stocked store shelves before the last jack-o-lanterns or witches' hats made their way to the storage room. Then, of course, comes Black Friday, the day of long lines snaking out of department stores at the wee hours of the morning and crowds jostling to find the perfect deal. I try to avoid the rampant commercialization of Christmas. My Black Friday tradition involves a refusal to set foot in any store; instead, I spend a quiet day watching television, grading papers or eating sushi with my husband. I prefer to settle into the Christmas season calmly and organically, savoring it with the same appreciation as a cup of velvety eggnog. For this reason, I am especially thankful that the calendar sets aside a special time devoted to waiting, a value that too often seems lost in our fast-paced world. This period of reflective spirituality is known as Advent, and it brims with its own fascinating customs and traditions as it patiently ushers in the joyful Christmas holiday.

November 27th this year, stretches across the four weeks prior to Christmas. The meaning of this deeply

changed considerably from its medieval roots. In the early days of Christianity, Advent meant spiritual cleansing in preparation for Christmas. It was time set aside for fasting, and vestiges of this practice can be seen in the many European cultures, including the Italian, which serve seafood rather than meat during the traditional Christmas Eve dinner. However, modern Advent celebrations focus more on the delightful anticipation for Christmas. This forms the symbolic crux of the Advent wreath. Every Sunday during Advent, someone lights one of the four candles — three purple, one pink — on the wreath until they all burn radiantly on the last Sunday of the season. These luminous candles cut through the dark nights of winter and reference the reemergence of light at Christmas, religiously through the birth of Jesus, and metaphorically through the slowly lengthening days after the winter solstice. I honor Advent with several quaint family traditions. My husband and I light a candle on our Advent wreath every Sunday, accompanied by the reading of an appropriate Bible verse and the singing of an Advent carol like "O Come Emmanuel." When we visit his parents, we attach a special ornament to an old cloth Advent calendar that they have had for years. On the first Sunday of Advent, I set out my Christmas decorations and begin baking my holiday cookies as well. These customs instill in me a keen eagerness for the Christmas festivities Advent, which begins on while still allowing me to revel in the unique delights of Advent.

During Advent, I also pause to remember my father's childhood memories of a Christmas significant time period has season in Italy. Advent had

his hometown of Sulmona, nestled in the mountains of the Abruzzi region, and every tradition was imbued with a profound sense of holiness. Bagpipe players known as zampognari, decked out in folkloric garb, still descend from the frosty mountain pasture to the haunting tune of their ancient Christmas melodies. They make their way to Rome and stay there until the Italian Christmas season ends on the holiday of the Epiphany. Throughout Advent, presepi, the quintessential Italian Christmas decoration, begin to appear throughout the whole country. Presepi, or Nativity scenes, adorn private homes, city plazas, and village squares, sometimes with live actors portraying the members of the Holy Family. These Nativity scenes form such an indispensable part of Italian Christmas celebrations in part because they were created by the country's beloved patron saint, St. Francis of Assisi. My father always remembered with great love and nostalgia the enormous presepio he helped construct in his town church, replete with moss and running

Finally, Advent signals the arrival of the ubiquitous Christmas markets in Italy. These enchanting bazaars grace nearly every Italian city, with the most famous located in Piazza Navona in Rome. Stalls burst with Christmas ornaments, toys and edible treats, all to the soundtrack of performers and musicians entertaining the shoppers. Tourists line up to try famous fruit-studded Christmas breads like panettone and panforte. These markets are just one of many customs which add to the magical charm of an Italian Advent, a season which excitedly awaits the arrival of Christmas while also commemorating the spirituality of the holiday.

I realize that it can be all too easy — and frustrating — to get caught up in the frenzied rush which frequently characterizes the holiday season. The incessant drone of commercials and the overwhelming surge of people in a crowded mall can either propel us to buy more and more material goods, or hide away home. However, by honoring Advent, we give ourselves a reprieve from the holiday turmoil. This period shines with the themes of anticipation, light and the humble pleasures of a Christmas season spent with loved ones. It is a time for waiting, for shivering with the hope that soon light will break through the dark winter evenings and that the world will unite with love and joy. This Advent, always be sure to focus on the real pleasures of the holiday — symbolic, communal, spiritual — rather than the commercialism, and always keep faithfully anticipating the light to come.

MARATHON The Patriots Day Bombing

I am sure we all remember where we were when we heard the news of the two bombings at the Boston Marathon's finish line on Patriots Day, April 13, 2013. It is hard to forget such a horrible event. For many, it reminded us of September 11, 2001. And for me, since I'm older, it also reminded me of the terrible day, November 22, 1963, in Downtown Dallas.

HBO Documentaries, with the assistance of the Boston Globe, has produced an outstanding documentary of that terrible afternoon back in 2013 when the normalcy of the annual marathon was forever marred by the horrible act of terror perpetrated by two apparent jihadists who wanted to send America a message. Their goal was to frighten us, but that did not happen. In a sense, it empowered all who were trapped in the carnage of that day. Five people are dead due to the twisted logic of those who would harm us. So many others survived, but with missing limbs and other permanent injuries to show for it. Almost three hundred were injured in all, and that is just counting the physical injuries.

I was privileged to be invited to the prescreening of this documentary on November 15th. I sat next to members of the medical staff from nearby Tufts Medical Center who were at the ER that afternoon tending to many of the victims of that day's horror. Others in the audience were the first responders who were along Boylston Street. Many of the survivors of that horror were there, too. I was invited, not as a retired police officer, but as a news reporter, and I was so grateful to be invited because there is always so much we can all learn by remembering all the events of that day.

The one thing I was reminded of when sitting in my seat at the Shubert Theatre was that MARATHON The Patriots Day Bombing was an inspiring story of hope, and the resilience of the human mind and body. It did justice to all caught up in this ugly event that marred a beautiful day.

As I watched the tragedy unfold on the screen knowing what was to come, I realized that the finish line at the 2013 Boston Marathon would become for many the starting line on the road back to recovery. Some days are harder than others. Heartbreak Hill, after Heartbreak Hill, after Heartbreak Hill. When most think of that day, we remember it in its entirety, but for the many victims it comes piece by piece. The road to this kind of recovery will be the hardest marathon imaginable for these folks. It might last a lifetime. It is like going back to square one. You need to come out of the birth canal all over again, learning everything over, sometimes painfully.

The aftermath of the Marathon Bombings isn't one story, but many stories of courage. Taking new baby steps. Thanking God for being alive. Waking up every morning wondering if this is the day you succeed in doing something like standing up, or maybe allowing yourself to laugh again. It is a lonely story each individual must live through.

If you are planning on seeing Patriots Day next month, you need to see this documentary first. It premiered on HBO on Monday, November 21st. See it first. Reflect on its message. Then, see the movie and see if they got it.

Boston's Historic First Corps of Cadets

Annual Veterans Recognition Event

For the last 15 years, Boston's historic Association of the First Corps of Cadets has held an annual Veterans Recognition Event. This year, the event was held at the old First Corps armory, "The Castle," in Boston's Park Square, at the Smith & Wollensky Restaurant.

In 2001, the restaurant invested \$12 million in the restoration of the building, including distinctive military carvings on the walls and fireplace mantels citing the First Corps' service in the Civil War, and actual artifacts, such as uniforms, swords, and pictures, are on display. This was, indeed, a fantastic venue for the Veterans Recognition Event.

This year, a deceased WWI veteran, Private Frank Coffey, was honored by his descendants, the Walton family. This soldier from Cambridge joined the Massachusetts Army National Guard's 25th (Yankee) Infantry Division, and was shipped overseas for combat duty. He died in France, where he is buried. The Walton brothers – Bob, Charles, David, and Jim – and their families were there to honor him.

Four WWII veterans were also honored. James Newell was recently awarded the French Chevalier Legion of Honor for his combat in the Normandy Invasion. Frank Bajowski served in the U.S. Coast Guard and U.S. Navy in WWII, retiring in 1973 at the rank of E-9, the highest enlisted rank. Bill Campbell fought in the Battle of the Bulge, and was a POW. Enoch O'Dell Woodhouse, II received honors as a WWII Tuskegee Airman. He was awarded the Congressional Gold Medal by President

George W. Bush. All four had their families with them to witness the honor.

Two other veterans served in Korea and also Vietnam. Fred Fletcher, an Air Force veteran, served in Korea in 1951 and Vietnam in 1967. Colonel Ed Graham was an Air Defense Artillery Officer who served in Vietnam and later Korea. Sons of Italy Renaissance Lodge member and Navy Vietnam veteran, Tom Tully, was recognized for his service, as well as Major James Brown, a U.S. Army Vietnam veteran, a helicopter pilot who earned three Purple Hearts. Navy Captain Dean Pedersen, a Vietnam veteran, was honored for his service as a Chaplain. He retired after 28 years of service, and became Dean of Students at Gordon Conwell Theological Seminary in Hamilton, Massachusetts.

Two corporate CEOs were recognized for their support of the military – Steven Magnus of Iron Bridge Consulting in New York City, and Dirk Burrowes of Vytek Industrial Laser Systems in Fitchburg, MA. They were given the "President's Award" by Association President Larry DiNardo. They also received civilian medals. There were many community dignitaries present to honor the veterans, including Dr. Dom Amara, former Deputy Superintendent of the Boston Public Schools; Dr. Lori Azzara from North Shore Community College; Rosario Cascio from Boston's Pirandello Lyceum; Frank Addivinola, President of the Dante Alighieri Society, and Janis Stanziani, President of the Middlesex Bar Association.

Saint Euphrasia Eluvathingal

Saint Euphrasia was born Rosa Eluvathingal on October 17, 1877, in a Syro-Malabar Catholic Nasrani family in Kerala, a state on India's tropical Malabar Coast. Rosa was the eldest child of wealthy landowner Cherpukaran Antony and his wife Kunjethy, a devout Syrian Catholic who taught her how to pray the rosary.

Rosa is said to have experienced an apparition of the Blessed Virgin Mary, which led her to make a commitment never to marry and to commit her entire life to God. As she grew older, Rosa wanted to enter the Sisters of the Mother of Carmel, who follow the Rule of the Third Order of the Discalced Carmelites. Her father opposed her vocational interest, but her intense prayer life which included the rosary, fasting, and abstinence — as well as the sudden death of her younger sister, brought about his change of heart, and granted Rosa permission to companied her to the Carmelite Convent in Ambazakad.

Rosa was received as a postulant, taking the name Sister Novice Mistress of Saint Mary's.



Euphrasia of the Sacred Heart of Jesus, and was admitted to the novitiate of the congregation on January 10, 1898. Her constant poor health, however, threatened her stay in the convent, as the superiors considered dismissing her.

Euphrasia made her solemn profession on May 24, 1900, at the time of the blessing of the enter the convent. He even ac-newly founded St. Mary's Convent at Ollur. Afterwards, she took her perpetual vows and was appointed assistant to the

Though frail in health, in 1904, Euphrasia was appointed Novice Mistress of the congregation. She held this position for nine years until 1913, when she was made Mother Superior of the convent. She lived in the convent the rest of her life, serving as Mother Superior until 1916.

For almost 48 years, the convent of St. Mary was home to Mother Euphrasia. Observing her life of prayer and holiness, the local people called her "Praying Mother," and her Sisters in the community referred to her as the "Mobile Tabernacle," because the divine presence she kept within her radiated to all she encoun-

Mother Euphrasia spent much of her day in the convent chapel before the Blessed Sacrament, and possessed a great love and devotion for the Blessed Virgin Mary; as a result, she was a fervent advocate of the Eucharist and of the Rosary. Mother Euphrasia offered her life in sacrifice for love of God. She passed away on August 29, 1952. Saint Euphrasia was canonized on November 23, 2014, by Pope Francis.

Recipes from the Homeland

MEATBALLS

1 pound ground beef (or ground turkey) 1/2 cup Italian-style bread crumbs

2 slightly beaten eggs

1 tablespoon grated Romano cheese

1/8 teaspoon garlic powder or one small chopped garlic

Place ground beef or turkey, prepared breadcrumbs, and slightly beaten eggs in a bowl. Mix ingredients thoroughly. Shape meatballs by taking a full tablespoon of mixture and rolling it in the palm of your hands into a ball shape. Place each meatball on a lightly greased baking tray. Bake in a preheated 350°F oven for about 15 to 20 minutes.*

Remove from baking tray to separate meatballs from excess oil. Makes about twelve to fifteen meatballs, depending on the size preferred.

*To microwave: Place meatballs on a microwave-proof platter and cook for five minutes, then turn and continue cooking for five to eight more minutes.

NOTE: The aroma of frying meatballs filled the air in most North End apartments every Sunday morning. My brother and I waited for Mama to start frying her meatballs so that we could enjoy one before the noontime meal.

My recipe evolved from watching my mother prepare her bread crumbs for the meatballs. Most families had a special technique to acquire their desired taste. When I prepare my meatballs, I add one tablespoon of grated Romano cheese and one-eighth teaspoon of garlic powder (or one small chopped garlic clove) to the flavored bread crumbs. These additions give me the taste and aroma of the meatballs I remember enjoying in my childhood.







Back then, Monday was the day musicians would congregate at the Union to socialize and book in future work. There were no DJs back then: all music was live. There was also no such thing as synthesized music that electronically duplicated instruments. What I mean is, if you needed a violin sound, you hired a violinist. An electronic keyboard had yet to be invented that duplicated the sounds of other instruments. This guaranteed that almost everyone worked during the Christmas season.

By the time I became a professional, Babbononno had long stopped playing. His sons, my Uncles Paul and Nick, were among the best sax and clarinet players in Boston. Dad was one of the best bass players who carried a union card. Just as soon as they arrived at the union on that Monday, contractors, bookers and band leaders cornered them to book them for a series of dates before any of the other men in their category could get to them. As a result, the men in my family would probably be working seven nights a week from then until Christmas Eve. They would refuse Christmas Eve and Christmas afternoons. They had agreements with Jewish musicians who played the same instruments. If they would cover the jobs on those two days, my uncles and father would cover them when the Jewish holidays arrived so that they could have the time off when necessary.

Back then, most businesses had Christmas parties for their employees. Often they were

held at the businesses during the day with catered food and live music. These parties were no longer than two or three hours and, if things worked out time-wise, a musician could book two or three in one day. As an example of how busy it could be. Dad would hire a chauffeur to drive him from job to job. This was necessary, especially if the jobs were in downtown office buildings where on-street parking could be a problem.

The Boston Globe even ran a story on him back in the '50s, and called it, "Boston's Busiest Bass Player." Just about the time I started college, he became one third of a trio that played at Santa's Enchanted Village at Jordan Marsh. With Dad on bass, Charlie Opper on violin, and Danny Cavicchio on accordion, they entertained the kids who were visiting Santa. Their outfits were Tyrolean with lederhosen (short leather pants), just like in Germany or Switzerland back in the day.

From that Monday after Thanksgiving through December 23rd, the men in my family worked both day and night because, as I mentioned, all music was live back then. Any shopping they had to do for gifts would have to wait until the day before Christmas, or on the way from one job to another if there was enough time. Somehow, they seemed to buy the gifts they had in mind for the family members.

I must have been in my second year of college when Dad came home one day with another car following him. I had just walked up the Eutaw Street hill after leaving the trolley that brought me from Maverick Station to the corner of Eutaw Street. When Dad pulled up, the other car pulled up behind him and I noticed that there was a bass violin in that second car. The driver slid the bass from the inside of his car and held it upright on the sidewalk. Dad introduced me to the man holding the bass and we brought Dad's bass and this new one into the house and carried them to the third floor. Once we were inside our apartment, the man took the cover off the bass and played a few notes on it. Dad listened and told me to try it out. I did, and I liked it. Dad pulled money out of his pocket and gave it to the man, who thanked him and then excused himself and left.

Up to this point in time, I was playing a rented bass. Dad had just given me an early Christmas present, my own bass. As it turned out, the

original owner was moving to New York and selling off some of his instruments. Dad bought the bass for \$75.00, cash.

At that point in time, I was playing for the Ken Reeves Orchestra(s). Ken booked the social functions for what was left of Boston's Beacon Hill society. He was from a blue blood family and networked with the members of the Union Club, the Algonquin Club, the Somerset Club, and the Harvard Club. Even during the day, any function we played at one of these clubs required the musicians to be dressed in tuxedoes. Before the Christmas break began, I would attend class at Boston State with my book bag over one arm and my bass violin under the other, and I was always dressed in my tuxedo.

Even before I left the house, Babbononno would inspect me just like a drill sergeant. He made sure my shirt had the right amount of starch, my nails were clean and polished and my shoes were spit-shined.

One day, I left class early and played two or three two-hour parties in downtown Boston. Then, once I got home, I had to deal with homework and a night working at the Seville Theater. When I got home from the Seville that night, Dad was just getting out of his car with his bass under his arm. He looked at me and said, "Son, it's called paying your dues."

The schedule was tough between Thanksgiving and December 23rd, but I had one thing in my favor ... I was young. Things would slow down between Christmas and New Year's Eve, which was our biggest night of the year. In spite of the grueling schedule, we never missed Christmas Eve or Christmas day with the family.



HOOPS and HOCKEY in the HUB

When the Celtics and Golden State played at the Garden last week, it was familiar territory for some of those with ties to the West Coast team.

For example, Warriors Co-Executive Chairman and CEO Joe Lacob, spent five years as a minority owner of the Celtics, serving on the basketball committee and earning a rare benefit for his service to the franchise — a 2008 NBA Championship ring.

In addition, Warriors assistant coach Ron Adams was an assistant with the Celtics, serving on head coach Brad Stevens' staff during the 2013-2014 season. Plus our own Scal—Celtics television analyst Brian Scalabrine—also served as an assistant coach with Golden State during that same 2013-2014 season.

And 50 years ago, current Warriors television analyst Jim Barnett was selected by the Celtics as the eighth overall pick in the 1966 NBA Draft. He played his rookie season on Causeway Street, averaging 4.1 points, 1.1 rebounds, and 8.0 minutes per game while seeing action in 48 contests.

DOUBLE DUTY — It's an impressive list, considering that it comprises a select number of those in the NBA family that have accomplished something amazing — they have won at least one NBA Championship as a player and at least one as a head coach.

Only 13 men are on that list and six of them either played, coached, or did both for the Boston Celtics.

Current Celtics TV broadcaster Tom Heinsohn was a member of ten title-winning Celtics teams. He was with the Cs through eight NBA Championship seasons, from 1957 through 1965 (no title in 1958). He was also the head coach of two more (1974 and 1976).

His teammate Bill Russell won 11 — the same ones as Heinsohn, plus adding 1966 as a player and two more (1968 and 1969) as a player-coach.

Bill Sharman, another member of the Celtics from a slightly earlier generation, overlapped both Heinsohn and Russell, winning four titles as a player (1957, '59, '60, and '61). He also coached the Los Angeles Lakers to the 1972 NBA title.

And, of course, there was K.C. Jones, who won eight consecutive titles as a player (1959 through 1966), and two as a coach (1984 and 1986).

More recently, there's Rick Carlisle, who was a member of the 1986 Celtics championship squad. He coached the Dallas Mavericks to the title in 2011. And then, just last season, Tyronn Lue accomplished the feat. Lue never coached the Celtics, but was hired as the Director of Basketball Development, a post he held until 2013 when he became an assistant coach with Cleveland. He was elevated to the head coaching position midway through last season and directed the team to a memorable victorious NBA Finals conquest of the Warriors this past June. His title as a player came in 2001 while playing for the Lakers.

By the way, of the 13 who have won at least one title as a coach and another as a player, Phil Jackson, the president of the New York Knicks, is the leader in the category. He won a pair of titles (1970 and 1973) while playing for the Knicks, won six more while coaching the Chicago Bulls (1991, '92, '93, '96, '97 and '98), and picked up another five (2000, '01, '02, '09, and '10) as coach of the Lakers.

WHO IS FRANK SAUL? — The name won't ring a bell unless you're a real fan of the history of the NBA. But Frank Saul, one of the oldest living NBA players at age 92, still is in the contemporary record books.

Saul, who grew up in the New Jersey suburbs of New York City, went on to play for Seton Hall and became the first 1,000 point scorer for the Pirates. After graduation, he was drafted by the Rochester Royals in 1949 and was a member of their 1951 NBA Championship team. He also went on to win three consecutive NBA Championships with the Minneapolis Lakers in 1952, 1953, and 1954.

Up until 1999, he was the only player in NBA history to have won four consecutive NBA Championships while playing for two different teams. In 1999, he was joined by Steve Kerr, currently the head coach of Golden State, who also won four in a row with two different teams — three with the Chicago Bulls (1996, 1997, and 1998), plus the 1999 title with the San Antonio Spurs.

Saul resides in Hackensack, New Jersey. He will turn 93 on February $16^{\rm th}$.

ICONIC ISAIAH — Downstairs, in the waiting area at North Station for commuter rail passengers, there's significant signage adorning various spaces with the message "Pick Me Last Again" — a reference to the selection of Isaiah Thomas in the 60th (and dead last) position in the 2011 NBA Draft by the Sacramento Kings.

Let's just say, if there was a do-over, no one would make that mistake again. Thomas would definitely be selected in the early moments of the first round.

But that was then and this is now — when Thomas scored 37 points in a tough 106-105 loss to the New Orleans Pelicans on the road, and then followed that up with a 30-point performance, including a spectacular 22-point effort in the final five minutes of the fourth quarter, as the Celtics downed Dallas 90-83 at the Garden recently.

Thomas rededicated himself to hard work in the offseason as he strove to improve. "I worked so hard over the summer," said Thomas after the Dallas game. "I didn't want to be satisfied. Now I'm reading the game of basketball at a different level. I go in toward the basket at a certain pace, just enough to get opponents off their pace — especially the shot-blockers who are usually a foot taller than me (Thomas is only 5'-9"). I try to jump quicker than they do. I have a few different ways of scoring in the paint and in the air, and I try to remember to do that."
