Despite the ongoing pandemic, the Friends of Christopher Columbus Park (FOCCP) and the Boston Parks and Recreation Department continued the tradition of the annual lighting of the park's signature trellis on Monday night November 23<sup>rd</sup>. Park goers will also get to listen to a holiday soundtrack as they walk under the trellis. This year represents the 18<sup>th</sup> year the trellis will feature the iconic display.

There was no party with local officials, just a few volunteers to flip the switch. FOCCP President Joanne Hayes-Rines said, "We thought this year during COVID-19 was especially important to bring the winter lights to the park. With the new audio, it's quite an experience!" In contrast, Faneuil Hall Marketplace has canceled its annual Blink show and holiday tree.

The holiday display is located at 110 Atlantic Avenue on Boston's historic waterfront. The trellis is 260 feet long and illuminated with 50,000 blue lights along with 14 decorated trees. Enjoy the display throughout the winter season until Patriot's Day in April 2021.

# MBTA Transit Police To Offer Face Masks to Riders

The MBTA announced that Transit Police officers would begin offering face masks to transit riders in need of a face covering. This effort is part of the T's <u>Ride Safer</u> campaign to educate riders and shift behavior to the new way of riding on



system by issuing a civil fine up to \$300 per violation.

Ride Safer consists of three components: providing face masks to riders in need at key stations during peak travel times; signage and messaging to promote the importance of keeping a safe distance and wearing face coverings while on the T; and the Ride Safer webpage at mbta.com/RideSafer that provides travel tips and a behind-the-scenes look at the MBTA's expanded efforts to clean and disinfect stations and vehicles. Joining Transit Police in offering face masks to riders are Transit Ambassadors and MBTA Customer Service Agents. Face masks are now available from 6:30-9:00 a.m. and 4:00-6:00 p.m. Monday through Friday at Charles/MGH, Downtown Crossing, Forest Hills, Hynes Convention Center, Maverick, Orient Heights, Park Street, and Quincy Center Stations. 
On November 2<sup>nd</sup>, the Baker-Polito Administration strengthened its Executive Order requiring people to wear face coverings in public places to require anyone older than 5 years of age to wear a face covering in public, including public transit, regardless of their distance from others.

The revised Executive Order authorizes Transit Police to enforce the order onboard MBTA vehicles and within the

#### THE GOLDEN GUERNSEYS

The next in our series on the celebrated trials of Hercules involved King Geryon, a giant of a man who dwelt on the Island of Erythia. He was the owner of a herd of prized red cattle.

The herd was constantly guarded by a shepherd and a two-headed dog named Orthrus. The tenth labor demanded of Hercules was to bring the red cattle back to the City of Tiryns.

The outward journey of Hercules took him to the Strait of Gibraltar. This is where he erected pillars on both the European and African sides of the strait, to show how far he traveled. Tourists to this area are still told about the journey of Hercules and are shown the two peaked rocks, which flank the entrance to the straight. One legend claims that these were barriers, built to keep sea monsters out of the Mediterranean, while another story tells us that both continents were joined at that point and Hercules dug the channel to provide access to the open sea. Stories go on to tell how Hercules, wearied because of the bright sun and intense heat, drew his bow against Helios himself. The sun god, admiring the boldness of this demigod, loaned him an enormous golden cup to use as a boat. Hercules used this as a craft to sail into the Atlantic and along the coast of Spain to the Island of Erythia. Taking up a position on a mountainside near the grazing cattle, the hero waited for the guard dog to attack him. Hercules clubbed the dog to death and then killed the shepherd in the same manner. Having overcome all obstacles to the removal of the cattle,

Hercules was about to make off with them when he was rushed by the king himself. The monarch, being no match for the Greek strongman, was quickly dispatched. Hercules then brought his prized cattle to the nearby port on the mainland, returned the boat to Helios, and headed back to Greece on foot.

After passing through southern Spain, the hero came to a region that is now called Marseilles. This is where he was attacked by two bandits who tried to steal the cattle. He killed both of them, but was then attacked by a larger force. A fierce battle raged and the wounded Hercules fell to his knees. He would have been killed had not Zeus caused a shower of stones to fall near him. While still on his knees, Hercules used these stones to fight off his attackers until they retreated. We are told that the stones still litter the plains west of Marseilles.

Hercules continued his homeward journey by a route that led down the peninsula of Italy. He rested at spot we now call Rome. Unknown to Hercules, this was the abode of Cacus, a fire-eating giant and son of Vulcan, who stole some cattle while the strongman slept. The cattle were dragged backwards by their tails into the giant's cave. Supposedly, this was done to confuse or foil any rescue effort. The entrance to the cave was then closed by using a rock so huge that twenty oxen were unable to move it. As Hercules was passing the cave with the balance of his mooing herd, one of the stolen cows mooed in answer. He quickly removed the stone from the cave entrance and, after a fierce struggle, slew Cacus with his club. The inhabitants of that area paid the Greek hero every honor for freeing them of this monster. The homeward journey of Hercules was completed without further incident, the cattle were delivered, and the tenth labor was satisfactorily concluded.

Whenever you visit Florence, Italy, be sure to spend a few minutes at the entrance to the Palazzo Vecchio. A copy of Michelangelo's David stands on the left side (the original is in the Accademia di Belle Arti) while the right side displays a sculptured masterpiece by Bandinelli (1546 A.D.) showing Hercules as he is about to club Cacus to death.

### ABCD Urges Struggling Elders, Families to Apply for Fuel Assistance

As Pandemic Surges, Winter Cold Descends HHs Releases Federal LIHEAP Funds as COVID-19, Unemployment Expand Need in Low-Income Neighborhoods

As the COVID-19 pandemic surges and cold temperatures descend on the region, ABCD encourages low-income individuals and families who are struggling to get by to apply for home heating fuel assistance.

ABCD administers the federal Low Income Home Energy Assistance Program (LIHEAP) for income-eligible residents in Boston, Brookline, Newton and seven communities north of Boston: Malden, Medford, Everett, Melrose, Stoneham, Winchester and Woburn. Last year ABCD provided fuel assistance **to more than 25,000 households**.

This year the need for heating assistance is greater than ever as COVID-19 continues to take a huge toll on low-income neighborhoods and communities of color where long-standing health disparities make residents highly vulnerable to the virus and where escalating unemployment has led to mounting distress.

The federal Department of Health & Human Services released \$3.36 billion to fund LIHEAP nationwide. Massachusetts received \$123 million — up about \$9 million from last year. Federal CARES Act funding designated for fuel assistance increases the Massachusetts allocation to \$150 million.

Right now the maximum fuel assistance benefit is \$600, with benefits scheduled to be increased soon. Last year the maximum benefit was \$1,140.

"We thank our Congressional delegation for their tireless advocacy for fuel assistance and appreciate the work of HHS in getting the funds released as bitter cold descends on America's northern tier," said ABCD President/CEO John J. Drew.

Drew noted that the upcoming winter holds harsh challenges for low-income, working families. "With COVID-19 surging and no sign of Congress passing a second sweeping virus relief bill that would keep unemployed workers and small businesses afloat and make it possible for struggling families to survive, the elders and families served by ABCD face a desperate situation," he said. ABCD's Fuel Assistance Program opened for applications on November 1st and takes applications through April 30<sup>th</sup>. There is a wide range of eligibility based on income and number of household members. Read the guidelines at: **bostonabcd**. org/fuel-assistance. For example, a family living at or below the federal poverty level of \$26,200 for a family of four would receive the maximum fuel assistance benefit of \$600. A person living alone at or below the federal poverty level of \$12,760 would receive that same benefit

those slightly above poverty from slipping through the cracks. For example, under the current benefit levels, a family of four earning 60 percent of the state's median income or \$75,200 can receive \$430 in fuel assistance. A single person earning \$39,105 also receives \$430.

As noted earlier, those benefit levels are expected to rise significantly in the near future. ABCD pays the household's fuel vendor directly.

Judge Joseph V. Ferrino

May He Rest in Peace

Judge Joseph Vincent Ferrino, Sr. passed away peacefully on November 22, 2020 in Boston, Massachusetts.

Born in 1926 in Boston, MA, he was a child of Sicilian parents who immigrated to the Boston area via Ellis Island around 1910. In addition to his parents, he was predeceased by his wife of over 60 years, Marie A. ("Jeanette") Ferrino, his brother, Peter J. Ferrino, MD, and his sister, Annette M. Nazzaro. He is survived by his four children: Joseph V. Ferrino, Jr. of Winthrop, MA, Joanne F. Zahrobsky and her

husband Colonel Joseph R. Zahrobsky, USAF (Ret.), of Tampa, FL, Paula J. Fosa of Winthrop, and Richard H. Ferrino and his wife Rhonda K. Ferrino of Winthrop. He is also survived by nine grandchildren, several great-grandchildren, and numerous nieces and nephews.

Judge Ferrino was a World War II veteran, a Boston area attorney, a district court justice, a veterans organization leader, a patriotic organization founder, a beacon in the Italian American community, and a volunteer for hundreds of community causes and organizations.

A graduate of Boston University Law in 1951, Judge Ferrino returned to his roots to open a one-man practice in a brownstone law office in East Boston. There he served clients and became involved in several national causes until, in 1971, the Governor of Massachusetts appointed him a judge in the East Boston District Court. In 1976, he was promoted to presiding justice of that court. Over the ensuing 25 years, Judge Ferrino stewarded his court into a unique community asset - a multi-dimensional community court complete with a totally unique in-court community medical clinic and a Boy Scout coeducational Explorer Post. In addition, he also initiated Law Day in the Massachusetts courts. In 1989 the president of the Massachusetts Bar Association presented him their Public Service Award, calling his court "unparalleled in the state." In addition to his court responsibilities, Judge Ferrino was a member of the Massachusetts, North Suffolk, and Boston Bar Associations. He sat on the Executive Committee of the International Association of Jurists, the Governor's Task Force on Juvenile Justice, and the Judicial Committee on Courthouses and Facilities. He also served as President of the Justinian Law Society and was recently named "Honorary Dean". His academic lecture and advising resume included Harvard University, the National Judicial College, the Massachusetts Bar Association, the University of Massachusetts, Brandeis University, Salem State University and numerous others. Many of these activities resulted in published scholarly work.

Beyond his legal career, however, Judge Ferrino lived a remarkable life in many other diverse fields. He entered the Merchant Marines and then later, enlisted in the U.S. Navy for the last 24 months of World War II. After the war ended, he attended college at the University of Alabama. and Boston University for law school. But he never lost his connection with veterans. He was a member of the Disabled American Veterans, the Italian American War Veterans, the East Boston Veterans Council, and most notably, the American Veterans — commonly known as the AMVETS. There, he commanded its local post, served as its Massachusetts Judge Advocate, co-wrote the national constitution and by-laws, and commanded its Northeast District. He went on to serve as its



National Judge Advocate and its representative to international veterans councils in The Hague and Geneva. Finally, in 1968, he was elected its 25<sup>th</sup> National Commander and served in Washington, DC for a year.

He was also fiercely patriotic. Judge Ferrino founded the Bay State Chapter of Freedoms Foundation at Valley Forge. It became a major focus of his energies, particularly after retirement from the bench in 1991, and he served in multiple offices, including president. His work in building the group from scratch ultimately provided

hundreds of young people an immersive U.S. policy and education experience at the Freedoms Foundation national education center in Valley Forge, Pennsylvania even as his local chapter served Massachusetts as a cornerstone organization in public affairs and traditions.

Judge Ferrino's role in the Italian American community was legendary. Over the decades he served in every leadership role in the Dante Alighieri Society of Massachusetts. He was instrumental in building the cultural center in Cambridge, MA. In 1998, working closely with the governor, he was instrumental in establishing the annual October Italian Heritage Month in Massachusetts. He maintained active membership in a plethora of Italian American organizations his entire life. He also worked closely with the Italian Consulate in Boston, hosting and supporting a number of consuls general and their work in Massachusetts and New England.

Judge Ferrino also served in numerous other leadership and advisory capacities. At various times he co-chaired the 1987/1988 East Boston and Winthrop Bicentennial Committee, the Trinity Neighborhood House, the Boston Bicentennial and the Boston Jubilee. He incorporated and advised the East Boston and North Suffolk Mental Health Clinics. He served as president of the East Boston Chamber of Commerce, the East Boston Kiwanis Club, and the East Boston Social Centers, Inc. He sat on the Boards of the YMCA Armed Services, Huntington General Hospital, Trinity House Camps, Inc., and the Board of Trustees of the Boston Public Library. He served as Scoutmaster of Troop 15, and sat on the Executive Board of the Boston Council of the Boy Scouts. And he copublished the East Boston Leader.

Judge Ferrino's U.S. and International awards and decorations were myriad. He was knighted by the President of the Italian Republic as Commendatore dell'Ordine della Stella della solidarietà italiana (A Commander of the Order of the Star of Italian Solidarity). In May 2016, Freedoms Foundation presented him its highest national award, the "Spirit of '76" medal and, in 2018, the Massachusetts State House of Representatives honored him for his "collective body of work" on the Italian Heritage Month Committee. In 1989 he was honored with a Grand Knighthood in the Order of Saint Michael the Archangel of the Massachusetts Italian American Police Officers Association. He held awards and recognition from every level of the Massachusetts Bar and countless other organizations.

Arrangements are being made through Caggiano Funeral Home of Winthrop, MA. In view of

the national health emergency, memorial and interment services will be held privately for the immediate family only. A retrospective public celebration of life is contemplated for some later date when safety can be assured. Friends wishing to make a memorial gesture are encouraged to donate to the American Diabetes Association.

# L'Anno Bello: A Year in Italian Folklore Advent and Anticipating the Light

Note: L'Anno Bello is reprinting articles that were written before the Coronavirus pandemic. Obviously, advice on gatherings and reunions contained within are not applicable to this current time when social distancing (and mask wearing!) is the best practice. Please read these articles as a testament to the joy and love that imbues Italian celebrations — and as suggestions for ways to spend time in the future once this pandemic is finally over.



Every year, I unfailingly hear the same refrain uttered from the lips of exasperated coworkers and family members: "The Christmas season starts earlier and earlier each year!" This nebulous phenomenon is actually known as Christmas creep, and it can be a real pain for those of us who wish to enjoy each season slowly, watching it unfurl naturally. I remember staring in shock at a commercial featuring Santa Claus which aired a few weeks before Halloween, and marveling at the boxes of Christmas lights that stocked store shelves before the last jack-o-lanterns or witches' hats made their way to the storage room. Then, of course, comes Black Friday, the day of long lines snaking out of department stores at the wee hours of the morning and crowds jostling to find the perfect deal. I try to avoid the rampant commercialization of Christmas. My Black Friday tradition involves a refusal to set foot in any store; instead, I spend a quiet day watching television, grading papers or eating sushi with my husband. I prefer to settle into the Christmas season calmly and organically, savoring it with the same appreciation as a cup of velvety eggnog. For this reason, I am especially thankful that the calendar sets aside a special time devoted to *waiting*. a value which too often seems lost in our fast-paced world. This period of reflective spirituality is known as Advent, and it brims with its own fascinating customs and traditions as it patiently ushers in the joyful Christmas holiday. Advent, which begins on November 29<sup>th</sup> this year, stretches across the four weeks prior to Christmas. The meaning of this deeply significant time period has changed

considerably from its medieval roots. In the early days of Christianity, Advent meant spiritual cleansing in preparation for Christmas. It was time set aside for fasting, and vestiges of this practice can be seen in the many European cultures, including the Italian, which serve seafood rather than meat during the traditional Christmas Eve dinner. However, modern Advent celebrations focus more on the delightful anticipation for Christmas. This forms the symbolic crux of the Advent wreath. Every Sunday during Advent, someone lights one of the four candles — three purples, one pink — on the wreath until they all burn radiantly on the last Sunday of the season. These luminous candles cut through the dark nights of winter and reference the reemergence of light at Christmas, religiously through the birth of Jesus, and metaphorically through the slowly lengthening days after the winter solstice. I honor Advent with several quaint family traditions. My husband and I light a candle on our Advent wreath every Sunday, accompanied by the reading of an appropriate Bible verse and the singing of an Advent carol like "O Come Emmanuel." When we visit his parents, we attach a special ornament to an old cloth Advent calendar that they have held for years. On the first Sunday of Advent, I set out my Christmas decorations and begin baking my holiday cookies as well. These customs instill in me a keen eagerness for the Christmas festivities while still allowing me to revel in the

hometown of Sulmona, nestled in the mountains of the Abruzzi region, and every tradition was imbued with a profound sense of holiness. Bagpipe players known as zampognari, decked out in folkloric garb, still descend from the frosty mountain pasture to the haunting tune of their ancient Christmas melodies. They make their way to Rome and stay there until the Italian Christmas season ends on the holiday of the Epiphany. Throughout Advent, presepi, the quintessential Italian Christmas decoration, begin to appear throughout the whole country. Presepi, or Nativity scenes, adorn private homes, city plazas, and village squares, sometimes with live actors portraying the members of the Holy Family. These Nativities form such an indispensable part of Italian Christmas celebrations in part because they were created by the country's beloved patron saint, St. Francis of Assisi. My father always remembered with great love and nostalgia the enormous presepio he helped construct in his town church, replete with moss and running water. Finally, Advent signals the arrival of the ubiquitous Christmas markets in Italy. These enchanting bazaars grace nearly every Italian city, with the most famous located in Piazza Navona in Rome. Stalls burst with Christmas ornaments, toys and edible treats, all to the soundtrack of performers and musicians entertaining the shoppers. Tourists line up to try famous fruit-studded Christmas breads like panettone and panforte. These markets are just one of many customs which add to the magical charm of an Italian Advent, a season which excitedly awaits the arrival of Christmas while also commemorating the spirituality of the holiday. I realize that it can be all too

easy — and frustrating — to get caught up in the frenzied rush which frequently characterizes the holiday season. The incessant drone of commercials and the overwhelming surge of people in a crowded mall can either propel us to buy more and more material goods, or rather hide away home. However, by honoring Advent, we give ourselves a reprieve from the holiday turmoil. This period shines with the themes of anticipation, light and the humble pleasures of a Christmas season spent with loved ones. It is a time for waiting, for shivering with the hope that soon light will break through the dark winter evenings and that the world will unite with love and joy. This Advent, always be sure to focus on the real pleasures of the holiday — all which is symbolic, communal, spiritual - rather than the commercialism, and always keep faithfully anticipating the light to come. # Blessed Josefa Naval Girbés

Josefa Naval Girbés was born on December 11, 1820 in Algemesi, near Valencia, Spain, the eldest of six children of Vincenzo and Josefa Girbés. She attended the school of a close neighbor and learned needlework in addition to the core educational framework. She received the sacrament of Confirmation and First Communion at the age of eight and nine.

After her mother's death when she was 13, Josepha helped her father raise her younger siblings. For the next several years, she received spiritual direction from the parish priest and her love for Jesus and His Blessed Mother grew steadily. Through the influence of her spiritual director, her commitment to God grew, and at age 18, she consecrated herself to the Lord with the vow of perpetual chastity. Josepha dedicated herself to a life of holiness and service to Church and neighbor. She formed an informal school in her own home, and invited young girls and women to take embroidery instruction. During the needlework classes, Josepha taught her students how to pray, contemplation, the evangelical virtues, and basic catechism. She read to them from the Bible and they engaged in spiritual conversations. She also prepared children for their First Holy Communion. Josepha eventually became a secular Carmelite, entering the Third Order Secular of Our Lady



of Mount Carmel and St. Teresa of Jesus.

Josefa began to feel chronic pains in 1891 due to a heart condition and was in great pain as a result of it. She died on February 24, 1893, after a long illness related to her heart. Her last request was granted: to be buried in the brown tunic and white mantle of the Carmelite habit.

For those living in the secular world, Blessed Josepha is a wonderful role model because she herself lived in the secular world, and well understood its distractions and attachments. Despite these allurements, she chose to follow God's will in all the ordinary circumstances of daily life. She loved God, cultivated a deep interior life, and showed her love for others by generously giving of herself.

The Feast Day of Blessed Josefa Naval Girbés is held on February 24<sup>th</sup>.

This tradition is carried on by a committee of about a dozen people led by Robert "Ted" Tomasone and agencies like the North Health Center, North End Athletic Association, Nazzaro Center, North End Against Drugs, A.B.C.D. – North End/West End Service Center, North End Seniors and Ausonia Council Knights of Columbus.

Each year a fabulous luncheon is held at Filippo's Restaurant and with the generosity of the Frattaroli Family, a fantastic raffle and many donations, we raise approximately \$15,000. For the last several years more than 200 checks per year have been distributed to those who need our help.



We were cutting through the field like locusts, within an hour, our buckets were filled.

Mom decided we should take a break, so we spread out a blanket under an old Maple tree, growing at the edge of the field near Mr. Baker's house. While Mom was spreading out the blanket, we were to have lunch on, she began doing her imitation of Patty Andrews, singing the "Boogie Woogie Bugle Boy." Auntie Angie and Auntie Stella quickly joined in, together they began singing and dancing like the Andrews



Sisters, standing shoulder to shoulder, clapping their hands and swinging their hips to the Jive Rhythm. Pietro grabbed Grace and began dancing with her, while the rest of us jumped up and down making a lot of noise. The raucous we were making attracted Mr. Baker's attention, who first began to shout at us, and then set off a blast from his BB Gun. None of us were frightened, but we decided we should clear out, for we picked the place clean. So, we pretended to be frightened, shouting, "Mr. Baker don't shoot, we're leaving!" As we got back on the road, Pietro turned toward Mom and jokingly said, "I guess he didn't like your singing." Mom threw a fistful of blueberries at Pietro, some

of which he snatched from the air and stuffed in his mouth, causing Mom to laugh. She turned to Pietro and said, "I know a monkey back in Boston that does the same trick." So, she threw another fistful at Pietro, once again, he snatched some out of the air and stuffed them in his mouth. This caused Auntie Angie to shout, "Stop! As a member of the English High School of Boston's alumni group, I was able to speak with a former Boston English teacher who arrived at the school shortly after I graduated there in 1966. He showed up with his piece of chalk a few years later and had a very interesting career teaching at this hallowed school, which was the first public high school in America opening in 1821.

This year, the school celebrates its 200th anniversary and has gone through good times and bad, but it also went through much turmoil during the busing era, too. The school is a survivor and is still plugging away trying to educate many young people today and insist in them the love of learning.

Mike Thomas, who heads the school's alumni group and who is hard at work as we speak on the upcoming 200<sup>th</sup> celebration gave me a copy of this book written by Joe Dotoli, the then young teacher, now a bit older and retired in Rhode Island. The book, as I mentioned, is called A Piece of Chalk, and was published in 2015, by Mill City Publishing.

His personal retrospective of interviews with his former colleagues and students provided such a human element to all the stories, headlines, and TV images of that time in Boston's political history.

> In the book's forward written by Natalie Jacobson anchor and reporter at WCVB-TV for a number of years, she talked of speaking with Judge W. Arthur Garrity who told her, "Education is not the issue before the court," and she responds in the forward "Here we had a problem, a lesser quality education to blacks and the fix had nothing to do with solving it."

> As I flowed through the pages of this book, all those past images still in my head came forward. I could see old Boston in too much turmoil again, and see the middle-class flight from the city only make the demographics even worse.

> Reading the perspective from an eyewitness inside the classroom at English High only humanized all the damage taking place, all the hatred sowed, and somehow how much of the hope that never extinguished. Teachers survived, students survived, Boston survived, English High survived, but all that pain seemed so needless and marred forever the lives of all who lived through those times, gone but never forgotten ugliness.

Anyone who lived through those times will find this book filled with fascinating insight and those too young, a look at part of Boston's history and will hopefully learn from it. I didn't find it depressing, but rather hopeful that there were so many heroes in the classrooms whos only interests were educating young people for their future

A Nostalgic Remembrance



Back in the day, the week after Thanksgiving brought the musicians in my family into the Christmas season, and that was our busiest time of the year. Up until the '70s, most music was live. DJ's were just coming into vogue and there was a reason why. Many of the older musicians refused or couldn't play the music the younger people liked to listen and dance to. They came up with every reason in the book as to the negatives attached to, especially, Rock and Roll, but whether they couldn't feel it or understand it they didn't want to play it. Most of the rock groups couldn't play the traditional dance music and the compromise was to hire a DJ.

Dad, Uncles Nick and Paul played mainly society music, working with the dance bands of Boston. If I was not playing steady somewhere, I would let it be known that I was available and the work rolled in. Back then, there were Christmas parties day and night up until December 24<sup>th</sup>.

For many years, Dad played at Santa's Enchanted Village at Jordan Marsh. New York had Macys and Gimbals, but Boston had Filenes and Jordan Marsh. Jordan's, as most Bostonians called the long gone department store, each Christmas season would have Santa Claus stationed in their Enchanted Village, and during the afternoons of the Christmas season, had a trio dressed in Tyrolean costumes playing for the kids and their parents. Dad was the bass player with the trio. Danny Cavicchio played accordion and Charlie Opper was on violin. They were quite a site dressed with lederhosen (Swiss leather short pants with suspenders), knee length stockings and Tyrolean Alpine hats.

Most businesses had Christmas parties for their employees and they all had live entertainment. The bands that serviced the parties were hired during the day for a two or three hour time interval, and there might be two or three to play on any given day. Dad and Uncle Nick would hire chauffer driven cars to take them from one job to another. Parking in downtown Boston has never been easy, and with jobs being spaced close together, being let off in front of a building was a lot easier (and cheaper) than hunting for a parking space. I was teaching school in Boston beginning in the early '60s, but was able to book in the late afternoon Christmas parties in downtown. I really never worked with Dad as we played the same instrument,

bass violin, but many times, I worked with Uncle Nick who played tenor sax and often led the small groups that played throughout the city. The nights were just as busy during the Christmas season. There were many parties held in the function rooms of Boston hotels and private clubs. Organizations like the K of C, the VFW, Masons, Sons of Italy, Elks, Moose, Lions, Odd Fellows, and dozens more all held parties in their buildings usually in the suburbs, which made it easier on the parking situation, as most had their own parking lots.

If all of us were playing and finished early, we would head to our house where Mom and Babbononno would be waiting with a pot of coffee and something to eat in case we hadn't eaten on the job. Babbononno was long retired from the music business, but lived it again through the stories the men in his family told about playing with the different bands we had worked with. He knew that we played what might be called the American songbook. All of the musicians who played these single engagements never used any written music. Whatever tune it was ... was memorized. Most of the top men in Boston had at least 1000 or more songs they could play from memory. If we played a set of, let's say 6 songs, all we had to know was the key for each, and as the leader would segue from one to the other, he would hold up a series of fingers to indicate what the new key was ... one finger for the key of F, two for B flat, three for E flat, 4 for A flat, an arched thumb and index finger for the key of C and an index finger pointing down for the key of G. These were the most common keys and most of the dance tunes, the fox trots, waltzes, polkas, etc ... were written in these keys.

Quite often, Dad and Uncle Nick would talk about the men in the bands they were working with that day or/and night. Babbononno could often identify with the names. If it was a multi-generational family in music, he most likely knew their fathers or uncles especially if they were Italian. Italians, Jews and African Americans dominated the music business back in the day. There were, of course, people from every other ethnic group, but the main body of commercial musicians were from those three backgrounds. During some of those years, I was working the night club scene, which meant that I couldn't play the parties that my Dad and Uncles played.

More often than not, parties

were held at the night clubs by social or business groups which kind of put things on an equal level. As we headed into the 1970s, I met Dean Saluti and we became fast friends. He was in graduate school at the time, and to earn tuition and living expenses, was working as a bar tender at Lucifer's, one of three nightclubs located in the same building called the Kenmore Club in Kenmore Square. Uncle Nick knew the owner and I often would meet my uncle at Lucifer's for a last call drink. Chances were that we finished at either midnight or 1:00 a.m., and the club closed at 2:00. Once the club closed, Dean, Uncle Nick and I would head to Chinatown for a bite to eat before going home. Dean would tell stories about what happened in the club that night and who some of the people were that frequented the place, and Uncle Nick and would talk about the jobs we had played and how the people were into the spirit of the season.

Dad wasn't interested in "hanging out" after a late job, and would head home, so he wasn't part of the late night scene. Aunt Dorothy (Uncle Nick's wife) had retired and was living in Florida. As soon as the holidays were over, Uncle Nick would head south for a couple of weeks and then, maybe a weekend a month, until he retired. When he did retire, he headed to Florida and Aunt Dorothy, permanently.

Today, it's a toss-up as to whether a Christmas party has live entertainment or a DJ. When I speak to full-time musicians (and there are only a few of them), they tell me how difficult it is to make a living at their craft. Most of the luckier ones learned another trade and work days and have made music an avocation. With the Covid Virus still with us, I don't know what this year's Christmas season will be like. I guess I was one of these luckier ones back in the day, I taught public school during the day and played music at night. Now, in my old age, I've retired from teaching and music but spend my leisure time writing this column. The old days were quite adventuresome, and I was on top of my game. Oh yeah,



Italians are bound by so many beautiful traditions, most of which are always accompanied by amazingly delicious foods. After wrapping and decorating each one, we'd hand them out to family and friends as a way to spread warmth and cheer. I had my favorites and of course, Nonna had hers. If there is one thing that stands out in my mind the most, it would have to be how much she loved maraschino cherries. It seemed like Nonna put them in almost every cookie she possibly could! As the holiday season begins, I am sharing a delicious recipe that dates back many, many years. Nonna referred to these as her "Cherry Cuts". However, I am going to call them "Nonna Mary's Maraschino Cherry Slices". These cookies are baked as loaves, but only once. They are a soft sliced cookie, not a twice baked biscotti, and they make a beautiful addition to any Christmas Cookie tray. I share this recipe with much love and hope you enjoy them as much as my Nonna Mary did.

#### NONNA MARY'S MARASCHINO CHERRY SLICES Fette di ciliegia al maraschino di Nonna Mary



- 5 cups flour 5 teaspoons baking powder
- 6 eggs
- 2 cups sugar
- 1 cup butter-flavored Shortening (Crisco)
- 2 teaspoons vanilla extract 1 cup walnuts, chopped
- 1 cup of maraschino cherries,
  - drained (reserve the liquid) and chopped

Preheat the oven to 350°. Line 2 baking sheets with parchment paper, set aside.

In a medium bowl, sift together flour and baking powder, set aside. In a large mixing bowl mix eggs, sugar, Crisco, vanilla and beat until creamy. Gradually add the flour mixture and mix together well. Blend in the cherries and walnuts and knead together well. Set dough aside in a cool place for 30 minutes. Divide dough into 4-6 pieces and roll into loaves. Place 2 loaves on each cookie sheet spread apart and flatten to approximately 2-inches wide and half an inch tall. Bake approximately 15 to 20 minutes or until lightly browned. Remove from the oven and cool completely before icing.

Blend in chopped cherries and mix well. With an icing spatula, ice loaves and let dry completely before slicing. 

National League in saves with 16 in 1959, and again the following year with 27. In 1959, he was named to the All-Star team, The Sporting News named him baseball's top fireman that season. Over his final 16 seasons, he started a mere 15 times.

In a 1961 interview with a New York Times sportswriter, he stated, "When I threw with that sidearm motion, I didn't get enough speed to strike out batters ... As a sidearmer I had a sinker, curve, forkball, and slider. As an overhander, I have a fastball, curve, forkball and changeup curve."

He was traded to the Cubs after the '62 season and in his first year won 13 games and saved 22 games. Another good season for him was 1966 with the Giants, winning 10 games in relief and having a 2.66 ERA. In 1968, he joined the Yankees and spent six seasons there, but these weren't the power clubs of the '50s and early '60s with most of their stars fading fast.

In his last season in pinstripes, he was 12-6 with a 2.68 ERA for a team that was sub .500. He ended out his career with the Kansas City Royals for two seasons.

Here's some good stuff from 1968, he retired 32 consecutive batters over four games and the same year pitched seven perfect innings in relief in a 19 inning game against the eventual World Series champs that season.

His career stats, 141-119 win-loss record, with 174 saves. However, only once in his long career did his teams finish as high as second place. And he never made it to postseason.

Outside of baseball, he was ordained by the Church of Christ and more recently was an elder of the Levon Church of Christ near Dallas.

I will be saying a prayer for him. He was one of my baseball heroes growing up. He had one cool name too that always reminded me of Charles Lindberg another childhood hero.



### HOOPS and HOCKEY in the HUB

A NOTABLE PASSING - It was given just a brief mention in the Boston media, but when Minneapolis Star-Tribune sports columnist Sid Hartman passed away recently at age 100. It certainly was a major loss that was felt across the landscape of professional athletics and big-time college sports.

That's because he was still writing on a regular basis for the Star-Tribune, a routine that saw him produce three columns a week through most of the year, an output that increased to four in a seven-day span during football season.

Hartman wrote his first story in 1945. Many would say he had written "countless" ones since that time. But someone was taking notice. When his regular column was published on his 100<sup>th</sup> birthday back in March, the Star-Tribune noted that he had 21,149 bylines over the course of his 75-year career in print journalism. His last column — on the Minnesota Vikings — was published on the day he died (October 18<sup>th</sup>).

"I followed the advice that if you love what you do, you'll never work a day in your life, Hartman wrote in his 100<sup>th</sup> birthday column. "Even at 100, I can still say I love what I do."

He was also a co-host of a sports talk radio show for more than 40 years on WCCO, one of the most powerful stations in the Midwest. At the time of his passing, he was the longest active member of the Baseball Writers' Association of America.

Hartman's son noted that while his father did not die from the current virus, he was affected by it. "I want to make it clear. He didn't die from COVID," Chad Hartman told the Star-Tribune. "But COVID took away the enjoyment of his life by making him stay home. It took away the chance to see the people he liked. It took away his zest — not being able to go to four or five different places every day."

The current NBA Champions are the Los Angeles Lakers. According to his autobiography, in 1947 Hartman wrote a check for \$15,000 to the owner of the Detroit Gems of the National Basketball League for the franchise. The Gems soon became the Minneapolis Lakers, a team that won one NBL championship and five NBA titles before moving to Los Angeles in 1960. Hartman remained affiliated with the franchise in an unofficial capacity until 1957, even while writing several times a week for the Star-Tribune. As the digital age arrived, Hartman continued to use a large classic tape recorder at press conferences and to keep the records of his numerous media contacts in a voluminous paperbound notebook. However, he used a desktop computer at the office and had a Twitter account through the Star-Tribune. Born in Minneapolis in 1920, Hartman most enjoyed covering the various teams at the University of Minnesota, an institution he never attended since he dropped out of high school after the 10<sup>th</sup> grade.

But way back when, at a time when expectations and standards were different, he was able to secure an internship at a local paper. The rest, as they say, is history. His first stories on the Golden Gophers appeared in 1945.

We know Sid was not from New England but we thought we would share some of the details of his amazing life with you. After all, how many people do you know who are not only still living at age 100 but are continuing to remain active in their career, all the while enjoying what they do?

Not many. That is why the life of Sid Hartman is so interesting and inspirational.

UNNECESSARY PRESSURE — There was joy in New York the night of the NHL Draft when the Rangers proceeded to select teenager Alexis Lafreniere as the number 1 pick overall.


The glowing tributes continued on the inside pages where Lafreniere was highlighted in headlines as "Broadway's Newest Star" with the accompanying article describing him as "the crown jewel of the 2020 draft."

All this for a young man who has never played one minute in the NHL or any of its top affiliates in the minors.


What he does have is a very impressive resume from his time performing for Rimouski Oceanic in the Quebec Major Junior Hockey League.

During the 2019-2020 season, the left wing put up 112 points on 35 goals, plus 77 assists across 52-games.

The unfortunate aspect about these media expectations is that Lafreniere can't just come to the Rangers and gradually grow into the role of an NHL star. Rather, he will expected to be one right out of the box, from Opening Night forward, leading the Rangers to a glory they have not experienced in recent times. We remember when former Bruins GM Peter Chiarelli first set eyes on David Pastrnak at a Bruins summer prospects camp. "I like what I see," said Chiarelli that day. But Chiarelli wasn't afraid to send him to Providence to gain more experience. Pastrnak later rejoined the Bruins as a member of the regular roster and continued on the path that led him to becoming the star player that he is today (one with a six-year, \$40 million contract signed in 2017). We are not saying that Lafreniere should be sent to the minors. We do say that he should be allowed to grow into his game without all the outside pressure being placed on him at the outset — before he even skates one stride in the NHL.




