#### CNN Investigates VA Hospitals

Apparently, according to a CNN report, the Department of Veterans Affairs even after getting additional funding from Congress still hasn't dealt with the long waits that put our ailing veterans using the system at risk. ## L'Anno Bello: A Year in Italian Folklore

A Season of Waiting and Cheer

The holiday season, that wonderful time of light and greenery and chiming bells, has wrapped itself around me like a warm sweater. This morning, as I stepped outside into the chilly air, I noticed how perfectly the leaves scattering my front lawn were ensconced in frost, seeming like crystallized Christmas ornaments. Hanukkah begins the last week of November, so households around the country shine with soft light from golden menorahs. Holiday music fills the air from car radios all around me, setting a mood of cheer and good spirits. Foods of the season, from tart cranberries to silky eggnog, tempt me with their delectable smells and festive flavors. Yes, the holiday season has come upon us, evident in the holly wreaths that line doorways and the shoppers that zigzag in and out of bustling stores. In the midst of all this excitement, however, it is important to remember that a period of reflection and respite precedes Christmas. This time, known as Advent, contains

of the season. Advent, which begins on December 1st this year, refers to the weeks of preparation for the birth of Jesus Christ on Christmas. Falling on the four Sundays before Christmas, Advent used to be a period of fasting in the Middle Ages, though now the focus has shifted to the anticipation and eager waiting that accompanies the Christmas holidays. Advent also contains a strong emphasis on light, linking it to all the midwinter festivities that honor the rebirth of the sun after the winter solstice. All around the world, people light candles on Advent wreaths, circular like the sun in the sky, to help count down the weeks before Christmas. Traditionally, three of the candles are purple, except for the rosecolored candle which corresponds to the third week of Advent, its cheerful hue tantalizing people with thoughts of the holiday joviality to

a plethora of folksy traditions come. My husband's family celebrates Advent with strikingly simple rituals that are both cozy and intimate. Every Sunday of Advent, they light the appropriate candle and read a Biblical passage. After that, they choose a small homespun ornament to pin to a felt Christmas tree tapestry. By Christmas Day, there are 25 ornaments adorning the tree, ranging from a quirky seal to more quintessential adornments like a Santa Claus face and a haloed angel. In some other families, children open little drawers on Advent calendars on the days preceding Christmas. The prominence of waiting during Advent reminds us that stepping away from the chaos that all too often characterizes the holiday season provides us with invaluable opportunities to spend time in the company of loved ones. Meanwhile, the light of the Advent wreath tells us that the sun will shine again, even in the midst of the dark winter nights.

#### Thankful for a Job

If your household is anything like mine, you are still eating turkey leftovers as you read this week's Post-Gazette. As we finish off the culinary remains of Thanksgiving Day, I suggest we keep alive the sentiment of the holiday by maintaining a spirit of thankfulness. #### The United States of Bullying

As the Miami Dolphins' case shows, our society has trouble dealing with adult-on-adult bullying.

When 12-year-old Rebecca Sedwick jumped to her death from an abandoned concrete plant tower in early September after intense bullying by two other girls, it made headlines around the world.

While some teen-on-teen bullying was once accepted as a rite of passage, we now know it can have deadly consequences. Today, schools, the media, and families are all taking it more seriously, including the role that adults sometimes play in stalking teens and tweens.

What about adult-on-adult bullying? While possibly just as harmful, it's a less prominent and much more complex story. Consider the current case of alleged bullying by white Miami Dolphins lineman, Richie Incognito, against his black teammate, Jonathan Martin.

Yes, a certain amount of hazing is part of football locker room culture. Playful teasing, mild insults, and innocent pranks are commonplace among both white and black football players at all levels, from high school to the pros. For the most part, this has been viewed as acceptable and even beneficial team-building behavior in the high testosterone world of male competitive

But every person and every football player is different. Not all are comfortable with locker room roughhousing and crude language, especially when it crosses the line into racial slurs. Incognito has acknowledged leaving a voicemail for Martin in which he used the N word, threatened to kill Martin, and threatened to slap Martin's mother.

Incognito's words and actions caused Martin to leave the team and seek counseling. Incognito has been indefinitely suspended by the Miami Dolphins and the NFL is conducting an investigation of the matter, which involves other members of the team.

"Beyond the well-publicized voice mail with its racial epithet, Jonathan endured a malicious physical attack on him by a teammate, and daily vulgar comments," Martin's lawyer said in a statement that featured a sample (and unprintable) text.

## Joseph S. Giuffrida

Joseph S. Giuffrida, a lifelong resident of Lawrence passed away peacefully on Sunday, November 17th surrounded by his loving family.

Joe was born on November 8, 1924, and was the son of Petrina and Giusseppe Giuffrida. He attended Holy Rosary Grammar School and Lawrence High School. He later went on to receive his professional designation of M.A.A. (Massachusetts Accredited Assessor) at the


University of Massachusetts at Amherst.

Joe was predeceased by his loving wife of 66 years, Sandy, and brother Mario Giuffrida. His family includes his cherished daughters Patricia and husband Nelson Mariano of Lawrence, Jo-Anne and husband Scott Corcoran of Methuen, grandchildren Joseph Mariano and his wife Kelly (Stevens), and Christina Mariano. Joe was proudest of his great-grandson, Anthony Joseph Mariano. Joe is also survived by a godchild, Ida Vasta of Lawrence as well as nephews Richard Giuffrida and his wife JoAnn, and Ronald Giuffrida and Kathy Burke all of Chicago.

Joe began his work career as a driver for the Eagle Wonder Cleaners, where he met his future wife ... the boss's daughter, Sandy. They were married in 1946. He worked for more than 20 years for the H.P. Hood Company as a milkman, supervisor and later as the Vice President of the Hood Credit Union.

In 1968, the Honorable Joseph Bacigaluppo, Justice of the Lawrence District Court, appointed Joe the first official Court Officer, followed by Deputy Probation Officer, due to his ability to communicate with juveniles. Joe was then appointed Assistant Registrar of Deeds by John J. Buckley, which for three years, he did in conjunction with his position of Deputy Probation Officer, at the request of Judge Bacigaluppo. One year later, Joe became acting Registrar of Deeds and Assistant Land Court Recorder. A vacancy in the Assessor's Department in Lawrence City Hall, prompted Joe to apply. He was selected, and four years later was appointed by the Mayor as Chairman of the Board and Chief Assessor. In October 2008, Joe retired from this position after 36 years of service to the City of Lawrence.

Joe was dedicated to the Order Sons of Italy since he joined over 50 years ago. He had served for 24 consecutive years as an immediate member of the Grand Council. During his early years, he served as Orator, as Trustee and Chairman of the Community Center Trust. Following many years of



faithful service to Lawrence Lodge 902, the brothers and sisters of Lodge 902 honored him in 1994 for his accomplishments. On the Sons of Italy Grand Lodge level, Joe served as State Trustee for 8 years, Chairman of the State Trustees for 3 years, State Financial Secretary for 4 years, and State Orator for 4 years, State 1st Vice President for 2 years and State President for 4 years. As a member of the State Council he chaired the

committee to review the State By-Laws, chaired a reception for the Italian Council General, chaired the United Cerebral Palsy Telethon for 4 years, served as a member of the Italian Cultural Commission, liaison to the Italian Student Ambassador Program, liaison to the cable program Tele-Italia, a member of the Italian Republic Day Committee for 3 years and then Chairman. Joe worked to promote the teaching of Italian in public high schools with the President of the Senate in the Commonwealth of Massachusetts. Joe was also a Supreme Lodge Member of the Immigration Committee, former Deputy of the Ohio Grand Lodge, a member of the National Commission for Social Justice, a member of the Supreme Council O.S.I.A., a member of the Advisory Board of the Don Orione Home and Madonna Queen National Shrine.

Joe has been a member of the St. Alfio Society for 52 years serving as Treasurer for 30 of those years, as well as a member of the Council. He also was a member of the Board of Directors of the Casa Monte Cassino, a home away from home that brings people from Italy and other countries that need medical care at a Boston Hospital, a member of the American Heart Association, member of the Holy Family Guild, member and Past President for 2 years of the Essex County Assessor's Association and past president of the Legislative Council. He was a faithful communicant of the Holy Rosary Church at Corpus Christi Parish. He was also involved with programs such as Big Brothers/Big Sisters, YWCA Battered Women, Abused Children and Mothers Against Drunk Driving.

## The Sons of Italy Urges Members to **SUPPORT ITALIAN AP EXAM**

is urging its members to support the Advanced Placement Examination in Italian, using a strategic plan outlined by Claudio Bisogniero, Italy's ambassador to the U.S., in his recent letter to Italian American organizations.

"In 2013, about 2,000 students took the exam, but an additional 500 are needed to meet the goal for 2016 set by the College Board," he noted in his letter, which included a "strategic plan of action" for his embassy, Italian American organizations and institutes as well as concerned citizens. [See below.] The College Board administers these high school advanced placement programs in languages and other subjects

Cost is a factor affecting applications to take the exam, according to Joseph Sciame, a former Sons of Italy national president and the current chair of the Conference of Presidents of Major Italian American Organiza tions. "Students must pay about \$85.00 to take it and some just cannot afford that," he says. But Sciame points out that as the biggest national Italian American organi-

The Order Sons of Italy in America (OSIA) zation, the Sons of Italy is in a unique position to help.

"We have 214 U.S. high schools that offer Italian," says Amb. Bisogniero. "If just two more students in each school take the exam, we can meet our target of 2,500 students."

#### STRATEGIC PLAN FOR THE ITALIAN ADVANCED PLACEMENT EXAM

Expand Italian Studies. Organizations and institutions should lobby and fund-raise to introduce or expand Italian classes in their local high schools.

Support Existing Programs. Clubs and lodges can adopt a school, a class or a teacher, giving finan-cial aid to buy teaching materials, DVDs and other tools to make learning more exciting.

Assist Needy Students. Clubs can help students pay for the AP Italian exam.

Teacher Study Grants. Give scholarships solely to teachers of Italian at the AP level so they can perfect their teaching methods and command of Italian.

Reward AP Students. Give students who take the exam a financial reward just if they take it, with larger amounts going to those who pass it with high marks.

## Lombardo's Honors Fisher House of Boston at Anniversary Gala







For me, Advent means Italian Christmas traditions, those beautiful customs which tap into the true love and generosity of the holiday through their rustic simplicity. My father knew Christmas was approaching when he heard the sound of zampognari descending from the frosty hills of his hometown region of Abruzzi. The zampognari are bagpipers dressed in traditional garb who entertain people in villages, city squares, and religious shrines across Italy with their melodic tunes. Presepi, or Nativity scenes, also appear in nearly every Italian home and town. The presepi serve as Italy's premiere Christmas decoration, nowadays standing alongside Christmas trees, in part because they were created by one of the country's most famous saints, St. Francis of Assisi. Presepi range from small, humble figurines adorning someone's fireplace to large statues gracing public plazas; they even include living presepi where actors assume the role of the Holy Family. My father fondly remembers helping his local parish priest build a large presepio that took up most of the room and sported such realistic touches as moss and running water. In addition to presepi, holiday preparations in Italy always comprise of Christmas markets. Among decorations of seasonal greenery, shoppers scour through the stalls for handcrafted Christmas

fresh produce, and baked holiday goods like cookies or the fruit-studded breads known as panettone or panforte. The most famous Christmas market in Italy is housed in Rome's Piazza Navona, though villages also boast their more quaint versions. Finally, the Italian Advent season brims with boundless generosity: families inviting lonely people over to share a holiday meal. children bringing gifts to the elderly, charity campaigns across the country. Because Italian traditions largely miss the flashy commercialism that often plagues the nificant issues like family, spirituality, community and waiting for this Advent. kindness.

As the holiday season settles in with a burst of cheer and goodwill, I urge everyone to focus on the simple aspects of this time period rather than getting caught up in any tumult. Light an Advent candle and

watch it flicker against a dark sky. Eat a crispy latke, or potato pancake, for Hanukkah, perhaps accented with a dollop of sour cream or applesauce, and note the way the traditional flavors explode in your mouth. Donate to a charity, and spend time with your family. I know that I will take a cue from the Italian Advent and pay attention to the side of Christmas that includes olden customs and the wisdom of past generations. 



## Recipes from the Homeland

#### VEAL AND CABBAGE STEW

- 1 1/2 pounds veal shoulder chop
- 1 small cabbage
- 1 medium onion chopped
- 3 small garlic cloves chopped
- 2 ripe tomatoes
- 4 small white potatoes

Heat oil slowly in saucepan before adding veal shoulder to sear on both sides. Remove meat from saucepan and set aside in a platter.

Add chopped onion and chopped garlic to saucepan and simmer until onion is opaque. Do not burn garlic. Add chopped fresh tomatoes ten ounces canned crushed tomato. Stir, cover and simmer for about ten minutes.

Meanwhile, peel potatoes and carrots. If potatoes are large, cut into two-inch portions and set aside. Cut carrots into two-inch portions and set aside separately. Remove spoiled outer leaves of cabbage. Cut cabbage in half. Cover one-half with

2 pieces dried bay leaf

4 whole cloves

1/4 cup canola, vegetable or olive oil

1/2 cup minute or regular rice (optional)

Salt

plastic wrap and store in refrigerator. Cut second half into three portions, wash and set aside.

Add veal to the saucepan. Cover and simmer about five minutes. Add carrots, bay leaf and whole cloves to the saucepan. Stir, cover and simmer slowly about ten minutes. Then add potatoes to the mixture. Place cabbage portions over potatoes and carrots. Spoon the tomato mixture over cabbage. Add a little water if needed. Cover and simmer until meat and vegetables are fork tender. Salt to taste. Remove bay leaf before serving. Serves two.

# Nanna & Babbononno

A Nostalgic Remembrance

been writing my columns from a bed at either Mass General Hospital or Mass Eye and Ear Infirmary. I thought I was indestructible. I knew I took after Babbononno, who was never sick a day in his life and made it to age 99. Well, I was wrong.

The problem began about a year and a half ago when I began losing hearing in my right ear. I started listening to the phone on my left side and that worked with no problem. I blamed the many loud drummers I had worked with over the years in music and just let it go as an occupational hazard.

With the insistence I kept being prodded with by my wife, I made an appointment with a hospital-based hearing specialist. Prior to this, I tried every hearing aid money could buy from the cheap ones found in drug stores to the sophisticated electronic devices that cost thousands. Nothing worked.

Daniel Lee one of the heads of the Department of Otology at Mass Eye and Ear examined me and sent me for an MRI. The results showed that I had a brain tumor on the right side of my head between the right ear and the brain. It was non cancerous but it had to come out if it kept growing. Well Dr. Lee checked the progress of its growth, and sure enough, it continued to grow. The next step was to select a neurological team to do the operation with Lee's team backing them up. I researched the names of the best possible choices and came up with Frederick Barker from Mass General. After discussing him with several friends who are in medicine, I knew I made the right choice.

On October the 16th, the teams were ready for me early in the morning. Loretta, both sons and my son John's fiancé were all there for moral support. I don't ever remember going under from that point on. I guess that was a blessing eral people had put prayer because, as I now understand it, they had a hard vigils for me to rely upon. time ... nothing knocked me After the first surgery, a out. They had to give me priest visited and put me at quadruple the dosage two or ease. Twice after that Euthree times to finally get me charistic ministers dropped under. Finally I was out and the Barker team operated for the next eight to nine hours removing the tumor. I woke up in an intensive care unit

For the past month, I've throbbing pains across my forehead. I was totally out of it, screaming for help, medicine and something to drink. If they had shown me how to use the signaling device, I wasn't aware of it, but I sure made enough noise for them to keep me comfortable. The next day, they sent me home. I thought it was a bit premature, but they insisted.

> Once home, I had a problem that had to be addressed. It seems that with these tumor operations, they take a piece of fat tissue to fill in the spaces where the tumors had been. With about maybe 10% of the cases spinal fluid runs into the brain and ear canals and I got caught in that 10%. This can be dangerous as it could cause spinal meningitis and had to be corrected. This time I headed to Mass Eye and Ear and Dr. Lee who headed up a medical team to solve the problem. After about a three hour operation the leaks were stopped. The only problem was they had to give me three spinal taps to finalize things. That wasn't fun. The next thing I knew, my heart was fluttering and in came a team of cardiologists to equalize everything. Well, this time I stayed in the hospital for about a week or so in order that the teams could observe me each day, each making suggestions and prescribing meds that would get me back to normal.

Well, here we are Thanksgiving week and I'm trying to get back to normal. I turned my college teaching schedule over to an associate who often team teaches with me, and I may take the next semester off and not return to any of the colleges until the spring. The only task I will let challenge me is this column and I'll write it if it has to be from my bedside.

What I didn't realize until all of this happened was the amount or friends I have. Close friends have been by me my side non-stop. Sevgroups together and formed by with Communion.

Relatives began calling from all over the country to check on me and if one more edible arrangement arrives, unable to swallow, severe I can start my own fruit neck muscle cramps and store. To top it all off, my wife

has taken a short leave of absence from her job and has been constantly next to me assisting me with whatever my needs are and I can be a pain in the butt.

Each day, several people arrive from various levels of home health care. The most important is the nurse who gives me my daily intravenous meds. She'll be here in a couple of hours and I'm going to relax until she arrives. Hopefully this will come to an end by next week and I'll try to get back to normal.

Lots of things were happening within the family while I was going through my paces. My son John and his fiancée, Beth, decided to get married and bought a house in the suburbs. I really like her and she has become part of the family with no effort. I wish I could have been more a part of the process with the real estate, but considering what's been going on I observed the goings on and my son handled things rather professionally which made me proud of

I'm out of steam ... and have to put my head down. I still have a long way to go before I'm back to normal, so with your permission, I'm going to call it quits for the week. I hope everyone has had a great Thanksgiving ... lots of turkey, stuffing, other fixin's and something nice to drink and toast the season.

To those of you who have been sending me correspondence at the paper, I'll get to you soon and to those of you who knew what was going on, thanks for the cards and letters. With all of your support behind me, it's helped me go on and stay on the mend.

Next week, we'll talk about starting to plan for Christmas. I don't know how much help I will be to the family, I'm not able to drive yet. If things stay this way, I'll just supervise and let the younger generation do the dirty work.

Anyway, time to go and

WHEN STERILIZATION FAILS, WHO IS LIABLE, HOW AND WHY? The pre-surgical procedure of sterilization performed at a hospital in the town of San Danilele Del Friuli, in the province of Udine, wasn't successful. Attitudes on the team and within the football fraternity are split, with many of the Dolphins' black players even defending Incognito and criticizing Martin for breaking a code of silence. Some of this may be due to the fact that, as a Stanford grad and the son of Harvard-educated parents, Martin doesn't fit the traditional tough football player mold.

"To African Americans on the Dolphins, Martin was a 6-foot-5, 312 pound oddball because his life experience was radically different from theirs," Jason Reid wrote recently in The Washington Post. "It's an old story among African Americans. Too often, instead of celebrating what makes us different and learning from each other, we criticize more educated or affluent African Americans for not keeping it real."

How this turns out is anybody's guess. What concerns me more than the incident's particulars is the larger message it sends about setting and honoring racial and other boundaries of respect in the schoolyard, at the workplace, and in public discourse.

Nearly every state has mandated measures to prevent bullying in our schools and more attention is being paid to cyber bullying.

But name-calling still too often takes the place of civil discourse in public debates. "Attack ads" have become a staple of political campaigns and the "comments" section on many newspapers and blogs are filled with hateful speech.

In addition, according to the Workplace Bullying Institute, about 35 percent of U.S. workers say they are bullied on their jobs. As the NFL and the Miami Dolphins decide the fates of Richie

Incognito and Jonathan Martin we must all ask ourselves: Is America becoming a nation of bullies?


