Mayor Thomas M. Menino

December 27, 1942 - October 30, 2014

Thomas Michael Menino is a name that will forever be connected with the City of Boston. The 53rd mayor of the city he loved, and the first of Italian-American descent, he served as mayor longer than any other before him from July 12, 1993 until he completed his fifth unprecedented term on January 6, 2014.

During his 20 years in office, Menino embodied what it meant to be a Bostonian.

Like his city, he was at times brash, but more than willing to point people in the right "direction."

His ascension to the highest position in the city may best be defined as pure luck. While serving as City Councilor from Hyde Park, in 1993, Tom Menino was elected president of the city council by a razor thin margin, one vote.

When President Bill Clinton appointed then-Boston Mayor Ray Flynn as U.S. Ambassador to the Vatican, Menino was automatically elevated to the office of Mayor. He was not expected to win that November's election, but did so by a large margin, going on to successfully defend his title on four more occasions. He never lost an election.



His point of view was of what Boston would be as opposed to what it should. "Here's what I see all across this great city - people working together to make Boston a better place to live and to raise children, to grow and pursue dreams."

Mayor Menino spent the bulk of his 20 years as mayor venturing outside his City Hall office to meet with fellow Bostonians. It was fitting that in the end, thousands of Boston citizens came to

pay their respects to him at Faneuil Hall, directly across the street from that same office, becoming the first to lie in state in the iconic structure's Great Hall since another life-long Bostonian, orator Wendell Phillips in 1884.

"When you take the oath as mayor, you're mayor of all the people. And how do you improve all of their lives, not some of their lives?" Mayor Menino found a way to improve the lives of all those he met. To paraphrase the trademark Frank Sinatra song that would become Menino's theme through 20 years as mayor of our city, he truly did it "his way." A job well done!

PROMETHEUS, EPIMETHEUS AND PANDORA

Once again we are reminded that all references to Zeus or Jupiter, supreme god of the heavens, are used synonymously in Roman and Greek mythology.

Prometheus and brother Epimetheus were sons of the Titan Iapetus and they were also brothers to Atlas. Prometheus and Eipmetheus were charged with the duty to create man and to provide him, and all other living things with the means necessary for their survival. Prometheus mixed some earth with water. made man, and then caused him to walk upright in the image of the gods.

As animals had already been created, Epimetheus undertook to provide them with various gifts, such as courage, swiftness, claws, etc. When man, however, was to be provided for, there was nothing left to bestow upon him. Meanwhile the gods were negotiating with mankind, after their conquest of the Titans, regarding the honor to be paid to them. Prometheus was ordered to kill a bull and offer it in sacrifice to both gods and men. He divided the bull into two sections. One half of the hide contained the flesh and inner organs after cleverly concealing them beneath the stomach. In the second half he put the bones, but hid them beneath a layer of rich fat. Zeus was asked to choose one of the halves, with the understanding that the other half would be given to mankind. Zeus selected the portion displaying the fat, and

after realizing that he had been tricked, flew into a violent rage. In his resentment he resolved to destroy the human race by withholding fire from them and to create other beings in their place.

Prometheus alone was concerned with the fate of the poor mortals so he saved them from destruction by going up to Olympus, stealing fire, and bringing it back to mankind in a hollow reed. This is the fire which was to become the source of all discoveries and the element which would permit man to be the master over nature.

When the act of Promet-

heus was discovered, it is said that the anger of Zeus knew no bounds. Prometheus was seized and chained to a rock or pillar on a mountain, where each day a monstrous eagle tore at his liver, which re-grew whole again each night. Finally, Hercules, on his journey to perform one of his celebrated labors, shot and killed the eagle and freed Prometheus from his bonds. The next time you visit the City of Philadelphia; don't miss the masterpiece by the Flemish artist, Peter Paul Rubens, entitled "Prometheus Bound." It's in that city's museum of art.

Mankind was also punished for its participation when Zeus created a woman of great beauty and named her Pandora (the all-gifted). Every god had contributed something towards her perfection. She was brought down from the heavens, declared to be the first woman on earth, and presented to Epimetheus who took her as his wife against the advice of Prometheus.

The house of Epimetheus contained a jar in which was sealed all of the evils of mankind. Pandora's curiosity caused her to open the jar and the evils poured out. She hastily replaced the lid but only succeeded in preventing the escape of "hope." This episode of Pandora is interpreted to signify that whatever evils might surround us, we are never left without hope. "Speranza."

Celebrating the Fall of the Wall

Twenty-five years ago, the concrete "wall of shame" that East German Communist dictators used to imprison the residents of East Berlin began to fall. It was the most conspicuous symbol of the Cold War of 1946 to 1991, which pitted Communistic oppression against Western freedom. By the 1970s it was accepted wisdom among the elite in America and Western Europe that the infamous wall would be around for many years or decades to come, with the East and West in a seemingly endless standoff.

All that changed in 1981 when Ronald Reagan became President. "My idea of American policy toward the Soviet Union is simple, and some would say simplistic," said Mr. Reagan to an advisor back in 1977, "It is this: We win and they lose." Mr. Reagan found an ally in the fight against Communism in British Prime Minister Margaret Thatcher. "Freedom and democracy will leave Marxism and Leninism on the ash heap of history," Mr. Reagan accurately predicted in a June 8, 1982 speech in the British House of Commons.

On June 12, 1987 President Reagan called out Soviet leader Mikhail Gorbachev, when, standing in front of the Berlin War, and with Berliners on both sides able to hear him, Mr. Reagan said:

"General Secretary Gorbachev, if you seek peace, if you seek prosperity for the Soviet Union and Eastern Europe, if you seek liberalization: Come here to this gate! Mr. Gorbachev, open this gate! Mr. Gorbachev, tear down this wall!"

The wall did come down, starting on November 9, 1989. The rest of Soviet Communism soon followed.

Polish-born and reared Pope John Paul II lent the moral weight of his office to Solidarity, the independent, Polish labor union, which successfully challenged the regime in that nation. Soviet General Secretary Gorbachev is often cited as having said, "The collapse of the Iron Curtain would have been impossible without John Paul II."

For nearly 50 years, from the end of World War II to the beginning of the 1990s, America faced an enemy unlike any we had known before. Victory was not won, as in WWII, by dropping more and bigger bombs. Nor, as in WWI, by wearing out an enemy with a war of attrition. Nor, as in our Revolutionary war, by unconventional fighting techniques combined with assistance from foreign allies to defeat a larger, stronger, and better-equipped foe. Communist ideology and thuggery collapsed under its own weight of lies once leaders such as Thatcher, Reagan, and Pope John Paul II stood up to it. Today, again, we face and unconventional enemy, terrorists who use Islam as an excuse for committing the inexcusable. It is yet to be seen if America can produce a leader to stand up to this threat.

The records, once confined to the original documents stored at the Roxbury offices of the Boston Parks and Recreation Department, date back to the 1850s and include annual reports, information about the formation of the Emerald Necklace, and the minutes of one of the oldest Parks Commissions in the country.

Copies of official Commission meetings, including many historical maps and plans, and annual reports are preserved in perpetuity and easily accessible to researchers and anyone else interested in this facet of Boston's history and the decisions that helped shape the city's park system.

The collection begins with the handwritten minutes of the first Parks Commission meeting held July 21, 1875. The first volume continues with various proposals for new parks at a time when a

L'Anno Bello: A Year in Italian Folklore

November 11th: Exploring the Heart of the Month

The month of November encompasses two faces, similar to a copper penny. One face of November involves the countdown to the frenzy and joy of the holiday season. Commercials featuring jangling jingle bells and shiny wrapped Christmas gifts are already beginning to inundate television channels. When my best friend and I visited the mall the day after Halloween, evergreen boughs and white-gold electric lights draped along every balcony and column. The second face of November is its most immediate however. This is the gray November of early winter, when cloudy skies disguise the early-setting sun. This is the November when chilly winds blow the last scraggly yellow leaves off the trees and geese plaintively call from above as they fly south. Too often, we only pay attention to the bright holiday face of November, trying desperately to rush into the festivities of November, which we forget to appreciate the beauty of the present month. The blustery days of November carry their own sense of beauty and significance. They encourage us to reflect on the cycle of nature, the memory of the past and beckon us to spend time with loved ones. Right in the middle of the month, the special date of November 11th encapsulates all that is powerful and meaningful

about this time of the year. When I was preparing my desk calendar for November, I drew a little American flag on the eleventh day of the month. I wanted to honor Veterans' Day, the most well known commemoration-taking place on this date. Originally Armistice Day, Veterans' Day celebrations began as a way to honor the end of the First World War, when peace was declared on the eleventh hour of the eleventh day of the eleventh month. Nowadays, this holiday serves as a reminder of the heroic sacrifices our veterans — of all wars — have undertaken on behalf of the country. One of my co-workers is a veteran and conducts an assembly every year along with other teachers who had served in the armed forces. The assembly includes speeches by those who witnessed war first hand, music provided by the school's band and chorus, and testimonies from veterans of all ages. I am eager to bring my classes to this event so



that my young students will grow in gratefulness and appreciation towards these brave men and women, and so that knowing the horrors of war they will be more likely to strive towards peace. Veterans' Day can also be a somber occasion, honoring the soldiers who died on duty. Indeed, in ancient Europe the whole month of November was completely dedicated to the commemoration of the dead. As the vegetation withers around us and the year sighs its way to a close, our minds drift to matters of memory and the past. This Veterans' Day, we should all keep the sacrifices of our veterans, living and dead, close to our hearts, and express our deepest thanks for the freedoms they provided. Moreover, we should carry this gratitude with us all year long, for the courage of our military men and women is never confined to just one

November 11th is also the date of a holiday which hearkens back to the Middle Ages. St. Martin's Day, often known as Martinmas, honors St. Martin of Tours, a fourth-century French bishop. All across Europe, Martinmas functions as an agricultural as well as religious holiday, an occasion marking the end of the harvest season and the beginning of the winter. As such, St. Martin's Day is often celebrated with feasts of hearty autumnal delicacies and family reunions. In Central Europe and Scandinavia, goose is the dish of choice, often stuffed with fall staples such as chestnuts. The use of goose stems from a legend regarding St. Martin, which states that the humble man hid in a goose pen when he was reluctant to accept the position as bishop. In Germany and the Netherlands, children dress up and participate in processions bearing lanterns, while in Poland people feast on croissants filled with poppy seeds and almond paste. However, St. Martin's Day retains a very strong association with wine.

known as il Giorno di San Martino, is the day when people sample the new wine of the year. My father always repeated the proverb "San Martino, si fa il vino," meaning that wine is made on Martinmas. Another Italian proverb simply and succinctly declares: Martino, castagne e vino," which translates to "St. Martin, chestnuts and wine." These proverbs speak to the Italian love of seasonal food and traditions with deep roots in the old agricultural-based society. I too celebrate St. Martin's Day with comforting Italian autumn recipes. For several years now I have been making pumpkin gnocchi on this day from a recipe in my much-beloved copy of Festa by Helen Barolini. As the scent of nutmeg and browned butter wafts through the kitchen, I feel a special kinship to my ancestors who battled the darkness and cold of winter with cozy meals and the love of family. Martinmas is special to me because it honors both sides of November. Its emphasis on the harvest and the commencement of winter teaches me to appreciate the uniqueness of the month, while its customs of feasting prove a tantalizing foreshadowing of the holiday season to come.

November is a month of many delights and much significance, despite the fact that many people view it as simply a cold and gray transitional point to the festivals of December. However, if we pay special attention to the hidden wonders of the month, we will find them most rewarding. The sight of bare branches across a cloudy sky and the pale yellow light of the afternoon sun encourage me to pause and reflect on the past year, evaluating my goals and desires. The cold evenings beckon me back home, creating treats in my kitchen or enjoying the irreplaceable company of loved ones. November 11th is a special date for recognizing the uniqueness of the month. During Veterans' Day, we honor the bravery, courage and sacrifice of America's military men and women, an action we should undertake all year long. On Martinmas, we prepare for the coming winter while reveling in traditional foods and feasts with our family. By observing these commemorations, we will discover the warm and loving heart beneath November's chilly exterior.

Faneuil Hall to see Mayor Thomas Menino was January 29, 2013 when I waited in a long line to be present for Mayor Menino's recordbreaking State of the City address. He had already been battling a series of medical setbacks, but that night he strolled into the hall to deliver a powerful speech looking forward to Boston's best days ahead. He marched in to a tune stating, "what doesn't kill you makes you stronger." On that night, a few months before the horrific Boston Marathon Bombings, he was already "Boston Strong."

At the end of the evening's speech, I went up for a momentary conversation to thank him for all he had done for Boston in public service, both as mayor and city councilor since 1983. A friend of mine, Don Harney from the mayor's press office grabbed that moment with his camera for me.

Previous to that, I remember catching him in the North End getting a haircut from Gino Colafella. Gino or Johnny "Shoes" Cammarata cut the mayor's hair for about 31 years. The place is still called "Johnny & Gino's" years back. On that day, Johnny wasn't around and I kidded the mayor if Johnny knew he now liked the way Gino did his hair. Menino ton. He will not be forgotten.

The last time I was at laughed and told me if Johnny's hand wasn't shaking so much holding the scissors, he still might be cutting his hair. The mayor added he didn't like to see blood in a barber shop. I said "Goodbye, Mr. Mayor" and he said "Goodbye Sal." I was back in Faneuil Hall this past Sunday to once again say "Goodbye Mr. Mayor." This time the lines there were even longer than back on that January evening in 2013.

> Over the years, I have bumped into the mayor on several occasions. We met at the groundbreaking dedication of the new Mass. Mental Health Center near Brigham & Women's Hospital a few years back when I showed up in my police uniform and got a great shot of him and me together. Countless times we have met. He and I both knew we weren't always on the same page. Sometimes, he loved what I wrote, other times not so much.

> Actually, my prized photo of the mayor now hangs inside Doyle's Pub in Jamaica Plain where I hang on the Wall of Fame with Menino, Bob Consalvo and Angelo Sciacca.

He was mayor for five but Johnny retired a few terms and took Boston into a new century of life. He will be remembered as both a legend and for his compassion, and his handiwork is all over Bos-



Te Deum and Jubilate ... The Henry Purcell Society of Boston will present a program entitled Purcell's "Te Deum and Jubilate" on Sunday, November 23rd, featuring this seminal work alongside selected works from the life and death of Queen Mary II.

Written in 1694, Purcell's "Te Deum and Jubilate" was

English Church music. Composed in a style that was vastly different from the very conservative liturgical settings at the time, Purcell's setting of the "Te Deum and Jubilate" presented a modern, flamboyant verse anthem; scored not only for treble and adult choirs, soloists, strings and continuo, but also for trumpets. It caused such a sensation, that Baroque Composer Thomas Tudway, who was in attendance, wrote: "There is in this Te Deum, such a glorious representation, of ye Heavenly Choirs, of Cherubins and Seraphins, falling down before ve throne and singing Holy, Holy, Holy as hath not been Equall'd, by any Foreigner or Other... He brings ye treble voices, or Choristers, singing, To thee Cherubins, and Seraphins, continually do cry; and then ye Great Organ, Trumpets, the Choirs and at least 30 or 40 instruments besides, all Joine, in most excellent Harmony and Accord ... This most beautiful and sublime representation, I dare challenge all orators, poets, painters of any age whatsoever, to form so lively an idea, of choirs of angels singing, and paying their adorations." (London, British Library, Harl. MS 7342, f. 12v.)

The Henry Purcell Society of Boston presents the work in collaboration with the Schola of All Saints Brookline under the direction of Emily Howe, the Trebles from the All Saints' Ashmont Choir of Men and Boys under the direction of Andrew Sheranian, and the adult choir of All Saints Brookline.

Emily Howe will conduct the November 23rd performance. The program will begin with three polyphonic settings of the "sentences" of the Burial Service perwith the National A Cappella the first of its kind in formed at the funeral for

Queen Mary II the following year in 1695. Composed at different times, Purcell assembled three verse anthems scored simply for soprano, alto, tenor, bass soloists, choir and organ.

The first anthem: "Man that is born of a woman," Z. 27, is an incredibly moving setting of text taken from the Book of Common Prayer and reflects on the shortness and misery of human life. With rising and sinking melodic lines (sometimes simultaneously), Purcell perfectly illustrates human frailty and our temporal state. Upon the tragic death of the Queen, Purcell assembled the second and third sentences, In the midst of life, Z. 17A, B, and Thou know'st, Lord, the secrets of our hearts, Z. 58A, B, C, for the service.

For this concert, the later version of Thou know'st Lord, the secrets of our hearts will be performed. The earliest versions dated from 1683. Ironically, the very same funeral sentences were performed at Purcell's own funeral only eight short months later. Other works also being performed are the more personal lament written by Purcell after Queen Mary's death, "O Dive Custos Auriacae Domus" a song for two sopranos and continuo; and anthems, "O God, Thou art my God,' for choir and soli; and "Thy word is a Lantern," for choir and

This performance will feature established and emerging soloists from the Boston area, including sopranos Jessica Cooper and Shannon Canavin, countertenors Gerrod Pagenkopf and Douglas Dodson, tenor Charles Blandy, and bass-baritones Robert Honeysucker and Jacob Scharfman, plus the treble choirs of All Saints

Saint Didacus (Diego de San Nicolas)

Didacus of Alcalá, more familiarly known as Diego de San Nicolás, was a Spanish lay brother of the Order of Friars Minor. He was born in the year 1400 into a poor but pious family in the small village of San Nicolás del Puerto in the Kingdom of Seville. He was named Diego, a derivative of Santiago (St. James), the patron saint of Spain. As a young man in Spain, Diego joined the Secular Franciscan Order and lived for some time as a hermit. He later placed himself under the direction of a hermit priest living not far from his native town. He then led the life of a wandering hermit.

Diego felt drawn to religious life, he applied for admission to the Franciscan Order at the monastery of Arizafa and was received as a lay brother. During his years living in that location, he journeyed to the villages in the regions surrounding Córdoba, Cádiz and Seville, where he would preach to the people. A strong devotion to him still exists in those towns.

He then was sent to the new friary of the Order in Arrecife on the island of Lanzarote, where he was assigned the post of porter. That island, which was part of the Canary Islands, had been conquered by Spanish forces about 40 years earlier and was still in the process of introducing the native people to Christianity.

In 1445 he was chosen guardian of the Franciscan community on the Canary Island of Fortaventura; and though it was an exception to the ordinary rules for a lay brother to be made superior, his great zeal, prudence, and



sanctity justified his choice. In 1450, Diego was recalled to Spain. He went to Rome to participate in the Jubilee Year proclaimed by Pope Nicholas V, and to be present at the canonization of Bernardine of Siena in 1450. In addition to the vast crowds of pilgrims arriving in Rome for the Jubilee Year, thousands of friars had headed to Rome to take part in the celebration of the canonization of one of the pillars of their Order. These travelers brought with them various infections, which broke out into an epidemic in the city. Didacus spent three months as Infirmarian caring for the sick at the friary attached to the Basilica of Santa Maria in Ara Coeli. He was then recalled again to Spain and was sent by his superiors to the Friary of Santa María de Jesús in Alcalá, where he spent the remaining years of his life in penance, solitude, and contemplation. He passed away on November 12, 1463 due to an abscess. He was canonized by Pope Sixtus V, in 1588. His feast day is celebrated on November 13. San Diego, Califor-

nia, is named for him.





Recipes from the Homeland

EYE ROAST OF BEEF

4 pounds eye roast of beef 1 large onion chopped

2 chopped celery sticks 3 tablespoons olive, canola,

or vegetable oil

1 beef bouillon Aluminum foil or roasting bag Salt

Heat oil in a skillet. Add chopped onion and celery. Simmer until onion is opaque. Remove onion and celery from skillet and place in a bowl. Add eye roast of beef to the skillet and sear all sides to retain juices in the meat. Cut a wide piece of aluminum foil in which to bake the roast. Place foil in roasting pan. Place seared roast in center of aluminum foil, or in a roasting bag. Gently add the oil from skillet. Place chopped onion and celery over the roast. Salt to taste. Cover roasting pan with aluminum foil to fully seal roast and contents (or place in a roasting bag). Bake in 350°F preheated oven for thirty minutes.

Meanwhile, add a beef bouillon to one cup of water and bring to a boil. Stir and turn off burner. Check roast after thirty minutes. Add a small amount of beef bouillon liquid and baste the roast. Cover and continue baking, basting every 15 minutes. Bake to tenderness of beef desired. (Approx. baking time - about 90 minutes)

NOTE: After baking this roast for my family, I place remaining bouillon liquid into a small saucepan over low heat. I stir a tablespoon of flour* into 1/4 cup of water and add to bouillon. Then I add liquids and onion and celery from the roasting pan. By stirring and allowing all this to simmer slowly, contents will thicken into the gravy that I serve with the roast. *For thickening gravy, use approximately one tablespoon of flour to one cup of liquid.

My family enjoys home-baked biscuits, mashed potatoes and salad with this meal.





Iron Mike Pusateri Honored



On October 31st a plaque honoring the late Iron Mike Pusateri was unveiled at the Norwood Civic Center where Mike spent so much time working with young people while being a very positive influence on their lives.

Mike was a long time member of Ring 4 and an inductee into the Ring 4 Hall of Fame. He was one of the most loved people in boxing and had friends all over the world. In 1961 Iron Mike won the Middleweight Golden Gloves Title in Lowell. Soon after he turned pro and fought until 1972 facing the top contenders of his day both locally and in their hometowns. Mike never shied away from a challenge and scored wins over world ranked contenders Willie Luddick and Doyle Baird while holding Charley Shipes to a draw. Mike's two very close fights with Joe DeNucci in Boston are still talked about. His last two bouts in Boston were very exciting matches against Johnny Coiley.

For many years Mike was a chef at his family's restaurant The Gardens in Dedham. Along with being a world-class boxer he was also a champion in the kitchen. I will never forget his Chicken Marsala, the best I ever had.

After retiring from the ring Mike stayed active in boxing and was always there for his brother boxers. He was known as the Ring 4 Ambassador and lived up to the title. Iron Mike always had a smile on his face and a nice thing to say. He loved to talk about his friendships with Rocky



Marciano and Allie Columbo. One funny story he would relate was about the time in the early '60s when he and Rocky were traveling in London. A photographer came up to them and asked if they would pose for a photo with a group of young musicians. When they walked into the hotel lobby where the young men were waiting and took a look at them with their long hair they said to forget about it. It wasn't long after that that The Beatles made their debut on the Ed Sullivan Show. Mike would shake his head and laugh while reliving that moment.

Sadly, Mike left us much too early when he passed away in 2011 at the age of 71. He was still cheering people up till the very end with phone calls. He called me a couple of days before the end. He was totally upbeat and was not looking for sympathy. I knew when the conversation was over that it was his way of saying goodbye. I felt deeply sad but also inspired by this man who was taking his final hours and using them to reach out to those whom he knew and loved.

The plaque that was placed at the Civic Center reads as follows:


"IRON" MIKE PUSATERI

availability. Often, as is the case in Boston, an NBA franchise shares a facility with an NHL team. In at least one instance (the Staples Center in Los Angeles), there are three pro teams using the same facility (the Lakers and Clippers of the NBA, plus the Kings of the NHL). Throw concerts, occasional college games, plus other events such as figure skating shows and one comes to understand that there just might not be enough days over the course of the sixmonth regular season to give everyone the exact days they

People have proposed various "cures" for this problem. All center on the concept of having fewer games in the regular season. Several proposals, most often coming from beat writers or players (such as LeBron James) but not from NBA officials, call for a regular season of 60-65 games spread over the same amount of time as the current regular season. This would give the players adequate time to rest between games and would eliminate the need for back-to-back games, the bane of virtually all players and coaches. How well can a coach prepare for a team overnight when compared to having 2-3 days to prepare for an opponent? When Doc Rivers was coaching the Celtics, for example, he often was forced to watch video of the second opponent on the plane as the team flew through the night. We think that while this discussion brings forth a number of positive points, the reality is that the regular season will not be shortened. Fewer games would result in less exposure on television and reduced funds from "broadcast partners" that pay huge sums to televise games. There also would be reduced revenue from sponsors and "corporate partners" of the NBA, plus fewer tickets that could be sold to fans. All of the foregoing would reduce incoming revenue the stream, a stream that has enabled sky high salaries to and league executives. Fans of the NBA love the league and want to see the stars perform as often as possible. Fewer games mean fewer opportunities to purchase tickets, thus decreasing the chances of seeing a game(s) in person. The NBA, through shrewd marketing and interactions with broadcasting and corporate entities, has built up a successful enterprise over the decades. It's not about to shorten a formula of success that has worked well for the league over the decades.
