All Saints Day Mass

Honors North End Religious Organizations

For more than a hundred years, Italian immigrants in the North End from various regions of the "Old Country" have paid homage to their patron saints with public displays of faith. Young men hoisted their regional patron saint's statue on their shoulders and carried it with great care over the cobbled streets of the North End. People lined the streets to watch the procession. Meanwhile, food stands along the streets were busily selling fried dough, nougat, and pastries. Indeed, the Feasts have always been something special for Italians.

This year, however, in a very special event, the area's religious societies came together to participate in a Friday evening Mass on All Saints Day in a program that honored them

The star-filled night was marked by unity and common respect. St. Leonard's Church was filled to capacity once again as representatives of all the North End's religious organizations placed their banners along the sides of the church prior to an evening Mass celebrated by Rev. William Joy and concel-

ebrated by Rev. Claude Scrima, O.F.M.

As impressive as the activities were, Fr. Joy was moved to comment about how very pleased he was to see the church filled by so many young people and so many men.

Following Mass, Society members marched through the streets of the North End with their banners. Residents of the North End as well as visitors stared reverently at the images of saints honoring the people who had been honoring them. The newly renovated hall below St. Leonard's Church will now serve as a preserving home repository for these sacred relics and statues.

Religious Orders were the first to serve Italian immigrants and preserve the Religious Feasts. They understood how important it was for the Italian people to venerate their saints. The Franciscans arrived in Boston in 1873. Italian Jesuits founded St. Mary's Church in 1849, and in 1883, the Scalabrini Fathers arrived in America to help minister to the growing number of Italian immigrants.

The North End Society's that

participated were: St. Joseph's Society, Madonna Di Anzano, St. Anthony of Padua, St. Padre Pio, Madonna delle Grazie, San Rocco, St. Agrippina di Mineo, Madonna Della Cava, Fisherman's Feast of the Madonna Del Soccorso di Sciacca, St. Lucy's, Santa Rosalia di Palermo, and San Gennaro.

The event was sponsored by the St. Joseph's Society which expressed gratitude to all the members of the religious organizations who participated and then invited them to an evening of celebration with food prepared by Mimi's Kitchen, the Verano Group, and A Frank DePasquale Venture.

Entertainment featuring classical and traditional Italian music was provided by Ray Cavicchio, Vanessa Salvucci, Gian Faraone, the popular singing group Street Magic, and Ilaria Della Bidia.

In the end, one spectator summed it all up by saying, "This was truly a night to remember. It was a night when all our Saints 'came marching in' and smiled at the North End."

SUETONIUS, MARCELLINUS, AND CLAUDIAN

This is the last issue in the entire series honoring the Latin literati. Last week we briefly examined the work of Florus, Gaius, and Apuleius, the first three greats in the Age known as the Late Empire. Today we honor the three remaining scholars.

It is probable that **SUETONIUS** was born in Rome about 69 A.D. into an equestrian family. There is very little information about his early life except that he started his career as a lawyer, and shortly thereafter became a private secretary to Emperor Hadrian (magister epistolarum). Suetonius was a scholarly man with comparable tastes and habits. He wrote in Greek as well as in Latin. His biographical works include The Lives of the Caesars; also brief accounts of illustrious men in literature, writings on famous courtesans and on many kings. He also wrote, on Roman antiquity, their manners, customs, feasts, clothing, and public office. Additionally, his work included the reckoning of time, nature, bodily defects, and grammar. Considering all of his writings, the lives of the Caesars (Vitae Duodecim Caesarum) has come down to us in more complete form than any other of his works. Although it overflows with scandalous anecdotes, this is the publication which gave him universal recognition. It is certainly the most celebrated today, and also the most authentic reference source for anyone who wants to write an X-rated movie.

AMMIANUS MARCELLINUS was born in Syria of Greek parand meter. Most of his poems were written in praise of the Emperor Honorius, and of the notorious General Stilicho. In spite of their flattery, the poems have an important historical value. His work is of high quality and reflects important historical matter. The best work of Claudian is said to be Raptus Proserpinae (Rape of

Proserpine). He also wrote epistles, epic, and miscellaneous poetry, and is considered to be the last important poet of this Late Empire.

Turnout, and Making History Top Election Night

With only City Council races on the ballot, the November 5th general election saw a 16.5 percent turnout, up from 2015 when only 13.6 percent showed up with only the City Council spots on the ballot.

In the City Council at-Large race, Michelle Wu topped the ticket by nearly a 7,000 vote margin over second place finisher Annissa Essnibi George, coming in a close third was Michael Flaherty.

Fourth place looks like it is still up for grabs between Julia Mejia and Alejandria St. Gillen, showing Mejia 10 votes up on St. Gillen, who has called for a recount. One of these two candidates will become the first Latina elected to the Boston City Council, and for the first time the City Council now has a female majority membership.

It looks like Althea Garrison has reached the end of the road finishing seventh out of eight candidates.

In contested district races, both Andrea Campbell and Kim Janey easily won re-election in District 4 and District 7 respectively

In District 5, Ricardo Arroyo became the third member of the Arroyo family to become a City Councilor beating Maria

In District 8, Priscilla Kenzie Bok handily beat Jennifer Nassour, and in District 9, Liz Breadon beat Craig Cashman.

All eyes were on Michelle Wu's vote topping the ticket. Many see this year's run by her as a test run in 2021 for Mayor. We shall see what's next for her.

The turnout is always a big story, and this year was no different. A little over 16 percent means nearly 84 percent of voters stayed home. One non-voter I talked with passing the voting site told me, "I only vote in Presidential elections." There are many of these kind of voters out there who simply don't realize that your life is far more determined by who your City Councilor is rather than who sits in the White House.

Finally, the dismal showing in both District 4 and 7 shows a historical apathy in both these districts going back I think for at least a half-century. Does anyone have an answer as to what to do to correct this situation? U.S. Rep. Ayanna Pressley has a campaign motto "The Power of Us." How do we get that power of us to become a reality?



L'Anno Bello: A Year in Italian Folklore

The Heart of November 11th

November, probably far more than any other month, embodies a multifaceted range of characteristics and qualities. One side of November encompasses the frenzied threshold to the holiday season. Advertisements set to the tune of tinny jingle bells or featuring a jolly, smiling Santa Claus overtake our television sets and billboards. Shopping centers are already wrapped in evergreen boughs and twinkling electrical lights. However, the other side of November remains its most immediately recognizable. This side involves the gray skies of early winter, the cranberrycolored leaves strewn across the ground as tree branches stand bare, the plaintive cries of geese streaking across the heavens as they migrate south. We are often in too much of a hurry to jump into the gaiety of the festive aspect of November that we forget to appreciate the month's unique beauty. November, in all its chilly and hushed glory, offers us a chance



to reflect on the past, to ponder on our memories, to express gratitude for our loved ones and the blessings in life. November even contains a date that seems tailor-made for honoring the simultaneous somber and communal nature of the month. It is November 11th; a day which demonstrates to us all that is meaningful and powerful about this time of the year.

As a history teacher, I always try to bestow upon my students an appreciation for the sacrifice and dedication of the men and women in our armed forces, living and dead, past and present. I tell them that it is important to

honor Veterans Day, the most well-known commemoration occurring on November 11th. Originally called Armistice Day, Veterans Day began as a way to mark the anniversary of the end of the First World War, when peace was declared on the eleventh hour of the eleventh day of the eleventh month. Nowadays, this holiday functions as a reminder of the sacrifices our veterans, of all wars, have made on behalf of our country. Often, my veteran coworkers organize a school assembly that includes speeches by those who have witnessed the horrors of war firsthand, patriotic music by the school's band and chorus, and poignant recollections from veterans of all ages. This event endeavors to foster gratitude towards our brave veterans, and it is my hope that, hearing about warfare through the words of those who have experienced it, my students will be more likely to strive for peace. Veterans Day is also a solemn occasion, honoring the men and women who died in the line of duty. This fits into the very history of November, a month that ancient Europeans distinguished as a time to commemorate the dead. When vegetation withers and the air turns gray and cold, our minds wander to thoughts of mortality and memory. This Veterans Day, let us keep the sacrifices of all our veterans forever in our minds, and let us offer thanks for the freedoms they protected and enabled. Moreover, let us always ensure that this sense of honor and gratefulness for our military does not end on Veterans Day, but continues all year long.

November 11th also holds a European festival celebrated since the Middle Ages. St. Martin's Day, commonly known as Martinmas, honors the fourth-century French bishop St. Martin of Tours. Across Europe, Martinmas blended religious significance with agricultural importance, as it marked the end of the harvest season and the beginning of winter. Martinmas celebrations boasted feasts of seasonal foods and boisterous family reunions. In Central Europe and Scandinavia, people dine on goose, often stuffed with the autumnal chestnuts. This meal imemorates a well-known legend about the humble St. Martin, who supposedly hid in a goose pen when he was reluctant to receive the position of bishop. In Germany and the Netherlands, costumed children collect sweets and coins in lantern-bearing processions, while people in Poland enjoy croissants filled with poppy seeds and almond paste. Italians celebrate Martinmas, or il Giorno di San Martino, by sampling the year's new wine. One of my father's favorite proverbs was "San Martino, si fa il vino", meaning that wine is made on St. Martin's Day. Another proverb, "San Martino, castagne e vino," states that chestnuts and wine can be expected at Italian Martinmas celebrations. These proverbs reveal the Italian affinity for seasonal delicacies and



Listen To Me I Came from Lower Roxbury, I Know Where It's Located

As I read a couple of news stories concerning the South End & Lower Roxbury and resident parking signs, I had to wonder what all this feuding is about.

The area between Melnea Cass Boulevard and Massachusetts Avenue hasn't been part of the South End since the late 18th century. There once was a stone marker from the colonial days near today's site of Melnea Cass. However, for pretty much all of the 19th century the border was somewhere between the old-numbered side of Massachusetts Ave and Northampton Street.

Back in my younger days folks from both sides of Massachusetts Ave. got along quite well. In fact, the residential area between the Immaculate Conception and St. Philip's churches was unofficially considered a sub-neighborhood of its own.

The Hotel Alexandra was always considered inside Lower Roxbury and never considered the South End. However, nobody cared about designations back then.

You know what I don't understand? Why did residents on the south side of Massachusetts Ave., accept South End resident stickers to begin with? Back

in the day, when folks in the South End knew where Lower Roxbury began, how did today's residents not know their neighborhood's past?

Having grown up in both the South End and Lower Roxbury, I liked both sides of Massachusetts Ave., but I knew when my address was in the South End and when it wasn't. Of course I knew the Post Office was confused because the 02118 zip code crossed over into Lower Roxbury up to East Lenox Street. Ladder 3 from the South End and Ladder 4 from Roxbury met at East Lenox, too.

I don't now why people are all confused and fighting each other. This is not an old feud because back in the day there was no feud. There were plenty of things to fight over but none of them was over what your neighborhood's name was.

It is sad that the folks running the South End Landmark District don't know where they are located. So, if anyone out there is still confused, just listen to me. I'm right. The City of Boston made a mistake putting up South End Resident Parking signs in Roxbury. I think the only reason the parking department put up 2-hour parking signs after taking down the South End Resident Parking signs is because this City Department didn't like being told they mixed up the South End with Roxbury.

I liked living in both the South End and Lower Roxbury growing up. Both were great neighborhoods but I always knew which was which. I also know where Lower Roxbury and Roxbury meet, too. It is down by Williams and Eustis streets. Just saying!





She always dressed in black, out of respect for Grandpa Bernardo who passed away in 1940. Grandma was slightly under five feet tall, wore a little pug at the top of her head, and constantly fingered a rosary in her pocket. Many people described Grandma as looking like a china doll. She was in her sixties and still had a wonderful complexion. Grandma lived with her unmarried daughter Stella. Auntie Stella was the tallest of Grandma's children. As a child, she was rail thin and known as "Skinny Stella." She had light brown, wavy hair, parted in the middle, which delicately framed her Neapolitan features. Auntie had a caustic wit and sharp tongue. She was the family bomb thrower.


Auntie Angie was the oldest of Grandma's four children. Her real name was Angelina, but she much preferred being called Angie. Auntie was a heavyset woman with a very pretty face. She was a woman with great common sense whom everyone turned to for advice, and typical of her Neapolitan heritage, she had a terrific sense of humor coupled with a great laugh. She had an uncanny ability to create nicknames, and always hit a bull's eye, once she launched one of her descriptive missiles. She and Grandma basically ran

Mom's brother, Carmine, lived down the street with Aunt Loretta and their two children.

Uncle, for a while became a local hero, when one day a woman fell from her first-floor window while washing it. Lucky for her, Uncle happened to be in the right place at the right time and broke her fall. From then on, he could have dated any woman in the North End.

Our Mom, Carmela, was the youngest of Grandma's children and without doubt, the feistiest, she loved being with people. She was full of life, the spark plug of the family. She, like her two sisters and brother, never made it out of high school, something that Mom always regretted. This was so typical of the children in the North End of her era. Mom, who was only five foot one, was the shortest of the children, slightly heavyset and very pretty.

Saint Francis Solano

Francis came from a leading family in Andalusia, Spain. He was born March 10, 1549 in Montilla, the third child of Mateo Sánchez Solano and Ana Jiménez. He was educated by the Jesuits, but felt drawn to the poverty and penitential life of the Franciscan friars. At the age of twenty, he joined the Order of Friars Minor at Montilla, entering the novitiate at St. Lawrence Friary.

The community there belonged to the Reformed observance within the Order, following a very strict routine of prayer, silence and fasting. Francis followed this regimen rigorously, always going barefoot, abstaining from meat, and wearing a hairshirt throughout that entire year. As a result, however, his health was permanently affected, leaving him sick and fatigued.

Francis was solemnly professed in 1569. He was then sent to the friary of Our Lady of Loreto in Seville for his seminary studies. He was ordained

in 1576, and was then named Master of Ceremonies for the community. Still a lover of simplicity, Francis built a small cell for himself by the chapel of the friary, made of clay and reeds.

In 1589 he sailed from Spain to the New World, and having landed at Panama, crossed the Isthmus and set sail for Peru. His missionary work in South America extended over a period of twenty years, during which time he overcame many obstacles and dangers that stood in the way of evangelizing the vast regions of Tucuman and Paraguay.

While working in what is now Argentina, Bolivia, and Paraguay, Francis quickly learned the local languages and was well received by the indigenous peoples. His visits to the sick often included playing a song on his violin.

Around 1601, he was called to Lima, Peru, where he tried to recall the Spanish colonists to their baptismal integrity. Francis also worked to defend the indigenous peoples from oppression.

Besides being engaged in active missionary work, Francis was elected Guardian of the Franciscan monastery in Lima, Peru. In 1610, while preaching at Truxillo he foretold the destruction that was to happen to that city, which was destroyed by an earthquake eight years later, many of the inhabitants perishing in the ruins. The death of St. Francis, which he himself had foretold, was the cause of general grief throughout Peru. In his funeral sermon Father Sebastiani, S.J., said that "Divine Providence had chosen Father Francis Solano to be the hope and edification of all Peru, the example and glory of Lima."

St. Francis was beatified by Pope Clement X, in 1675, and canonized by Pope Benedict XIII, in 1726. The Feast Day of Saint Francis Solano is celebrated on July 14th.



Talking the Talk, Not Walking the Walk

At SpeakEasy Stage Company Explores Privilege, Values, Snobbery, and Hypocrisy

A few years ago, I was watching a news program featuring a story about a successful inner city high school where most of the graduates were going on to college. It was an uplifting story, but one part stuck in my mind to this day. A young African American girl was asked why she wanted to go to college. She responded, "So I can be better than other people." My heart sank when I heard those words.

In watching Joshua Harmon's newest play Admissions, now at the SpeakEasy Stage Company in Boston, those words kept echoing in my head. The play which takes place far from the inner city, at a second tier, on the verge of being first tier, prep school in New Hampshire, deals with what happens when white liberals who are in a position of power, in this case expanding minority admissions to the school, talk the talk of making their school more inclusive and diverse and then have to face the reality of walking the walk when it turns out it means giving up their own privilege.

Sherri Rosen-Mason is the Head of Admissions for Hillcrest Prep School. Her husband Bill is the Headmaster, and their son Charlie is a senior whose dream has always been to attend Yale. He has worked hard toward that goal and has the grades and test scores to show for it. Things don't work out as planned when Perry, Charlie's close friend who is biracial is accepted at Yale while Charlie's application is deferred. Charlie believes it is his skin color that has made the difference.

I have seen three of Joshua Harmon's plays, and he is a master at writing dialog. In the opening scene of Admissions the back and forth between Sherri

Rosen-Mason (Maureen Keiller) and Roberta (Cheryl McMahon) who works in development at the school is both funny and telling. Roberta is working on the school catalogue and Sherri is critiquing her work for not showing how racially diverse the school is. It becomes a numbers game about how many students of color attend the school and if they are properly represented in the catalogue. More so, are minority kids made to feel comfortable when perusing it.

The conversation between the two on who qualifies as black enough becomes awkward for Sherri as Roberta cuts to the quick with just what Sherri is trying to say. While funny, the conversation can also make many in the audience feel uncomfortable as while the goal of being more inclusive is good, the discussion of putting people into boxes based on ethnicity has ugly overtones.

This combination of humor and questioning of values is also evident in Charlie's diatribe when he confronts his parents about why he wasn't accepted at Yale. Nathan Malin as Charlie is positively outstanding when he goes on about what he sees as the absurdity of figuring out who qualifies as a minority and who doesn't. Sherri and Bill (Michael Kaye) are stunned by what their son has said. Bill, "It looks like we successfully raised a Republican." Oh! The horror!

Another awkward moment occurs when Perry's mother Ginnie (Marianna Bassham) is sharing her joy over her son being accepted to Yale when she realizes Sherri is implying he only made it because of his skin color. Later in the play Ginnie captures the difficulty her son and so many others have to face because many people feel that way. Marianna Bassham is terrific as always.

The part of the play I found most revealing was where Charlie had decided to take things into his own hands and walk the walk that his parents talked, and made his own decision about where to attend college. Bill launches into a revealing screed about how his son will now have to do such low level jobs as "tossing pizzas and bussing tables." He also can't contain his disgust for community colleges. It really does all come down to being better than other people.

While the play is meant to make people look at their own privilege, in this case white privilege, it is about much more than that. No matter how well intentioned people are, when it comes to getting ahead, or having their children get ahead, are they ever going to cede their connections and power to make things happen?

White liberals will see this play and feel appropriately guilty. But how many of them will be willing to have a minority student take the seat at the table they reserved for their son or daughter? And is that really the solution?

As with other Speakeasy Productions, I would love to see a more politically diverse audience attend and participate in a discussion. Joshua Harmon knows how to raise questions. He is not afraid to make people uncomfortable, and I would assume this includes himself. And, unlike so many of today's authors, he does not preach. The audience has to grapple with these questions on their own.

Sherri's words are very telling, "If you don't have a school like a Yale or Harvard on your resume, that actually puts a ceiling on what's possible in your life. And our son is smart enough to see that. Going to Yale means your life contains all the possibility in the world. Not going there, or one of a handful of schools like it, means there are tables you will never get to sit at, tables whose existence you may never know about."

Keeping the table small means always putting limits on what people can achieve. Maybe it's time to find new places to sit.

While it is easy when hearing about Admissions to put it in a box as a play by and for liberals, it should not be dismissed as such. This is an excellent work and a superb production. The talented cast is outstanding. The set which smoothly transitions from campus office to family kitchen is perfect. No matter your political beliefs, I would strongly urge you to pull up a chair to this table at the SpeakEasy.

Nanna & Babbononno

A Nostalgic Remembrance

October, 1961, and I wanted to plan a 25th anniversary party for my folks on or around the 25th of the month, their actual anniversary date. I was 23 and was teaching days and playing music nights, so money wasn't an issue. I spoke to Uncle Nick about putting together a surprise party and his comment was, "You concentrate on the guest list, and I will put the rest of it together." A few days later, he called and asked me to meet him after school at Blinstrub's Supper Club on Broadway in South Boston. He chose a day when neither of us was playing in the evening which would afford us enough time to meet without rushing to get a party plan into action.

Before I go on, some info for you younger folks: Blinstrub's was typical of the entertainment concepts of the day. It had both a restaurant/nightclub atmosphere and featured the top names in entertainment in the country. Places like Blinstrub's were found in major cities all over the country. There was the Latin Quarter in New York, the Copacabana in New York, the Cocoanut Grove in Hollywood, the Copa at the Sands Hotel in Las Vegas, and back home, Caesar's Monticello in Framingham and several Chateau DeVilles in the Boston suburbs They all featured decent food, good dance bands and the top singers, dancers, comedians, and actors money could buy.

Uncle Nick brought me to meet Stanley Blinstrub, the owner of the club that bore his name. He was an elderly gentleman who had started from scratch and built his South Boston establishment into a nationally recognized supper club. My uncle did the talking and Blinstrub took mental notes. When it was my turn, I described what I had in mind. Blinstrub pieced everything together and then told us that he would have the center stage table set up for about 20 to 25 people and each person could order off the menu instead of the usual package where everyone had to eat the same type of dinner.

Let me first mention how the tables were arranged. Tables for groups were arranged perpendicular to the stage and the center tables were usually reserved for the high rollers. I was just starting out in life and felt honored. Mr. Blinstrub knew

It was the beginning of october, 1961, and I wanted to lan a 25th anniversary party or my folks on or around the 5th of the month, their actual nniversary date. I was 23 and ras teaching days and playing usic nights, so money wasn't n issue. I spoke to Uncle Nick bout putting together a surrise party and his comment of the manufacture of the Musicians' using the second of the manufacture of the Musicians' union and handled all the contracts between incoming entertainment and the people in Boston that hired them.

The date was set and it was to be my folks' exact anniversary, October the 25th. After leaving Uncle Nick, I headed to a friend's apartment and began making phone calls to relatives and friends of my folks. I had to pick and choose because I had a budget to consider and didn't want to go into hock. I lucked out in that everyone that I included was able to attend. After my list was complete, I headed home and told my folks that I had booked a table for three at Blinstrub's on the night of their anniversary. I added that, seeing the entertainment was Sammy Davis Jr., I could only get a small table. They were OK with this and I was set to go, with only one problem.

Babbononno had not gone to any social function since Nanna died three years earlier. He was "old school" and wore a black arm band for a year and a black tie for the rest of his life. That's the way it was, he never stopped mourning. I tried to convince him that the event was something special and he replied, "Jenny, you make-a da nyza tymba foh you mutha eh fatha, ma I canna no go. Sinza Nanna die, I stay inna da houza, capice?" (Johnny, you have a nice time for your mother and father, but I cannot go. Since Nanna died, I stay in the house, understand?) I didn't want to force Babbononno to break his ancient tradition and I backed off.

When October 21st arrived, my folks had a birthday party for me. Our top floor flat at 74 Eutaw Street in East Boston was filled with relatives and friends who came to wish me well as I turned 23, and dine on Italian and Chinese food, both served buffet style. Four days later it was my turn to celebrate my folks 25th. I had told all of the guests to be at Blinstrub's at a particular point in time as I wanted everyone there when I brought my folks in. I wanted it to be a total surprise. My mother couldn't understand why Babbononno seemed to be so happy and smiley when we left the house. She chalked it up to an extra glass of home-made wine he might have indulged in and let it go at that.

When we arrived at Blinstrub's, the Maitre-d escorted us to the designated table, and as my folks approached the stage, everyone at our table stood up and yelled, "Surprise!" Well, the party was on; it began with a champagne salute to my folks and then dinner. Right after the dishes were cleared the entertainment began, first a comedian came on and did his routine. I believe it was a local entertainer named Teddy English who worked the night clubs in and around Boston. Following him was Sammy Davis Jr. He performed for about an hour and a half and made mention of my folks' anniversary to the audience, all of whom extending a round of applause to Mom and Dad as they stood up in recognition.

The evening finally came to an end and Uncle Nick and I headed to the kitchen where Mr. Blinstrub had an old couch positioned so he could relax and keep an eye on what was going on, all at the same time. I asked him for the bill and he asked if I had tipped the wait staff who served us during the evening. I told him that I had based the tips on the bill total and I had taken good care of the waiters by adding in an extra five percent to the tip. "Well then, you've paid your bill." As a favor to Uncle Nick and in recognition of my folks, the cost of the evening was on the house. I thanked Mr. Blinstrub and was almost in tears. Just then, my father came into the kitchen. Blinstrub shook hands with Dad and said, "Johnny, you've got quite a kid, here. He even looks like you. I hope everyone enjoyed themselves." Dad was humbled and thanked his benefactor for the evening and we left. I would repeat this type of evening twice more. I had a surprise 40th for my folks at Polcari's in the North End and a 50th at a function facility in Cambridge. They were great times, but nothing ever came close to that 25th anniversary party at Blinsturbs, back in 1961. During the show, I was called to the stage and sat in with the house band that backed Sammy Davis. This was the beginning of a friendship with a member of the Rat Pack who was considered one of the world's greatest entertainers. He could sing, dance, play drums and act.

Before he left the club, Sammy Davis gave me his private Los Angeles phone number which I utilized when I started knocking on doors in Hollywood, but that's a story for another day. I and Aunt Ninna, my late Uncle Gino's wife, are the only ones left from that guest list and she in her mid '90s.

A Sformato could easily be considered Italy's version of a flan or soufflé. Though frequently made with seasonal vegetables, sformato can be savory or sweet, and contain almost anything. Sformato comes from the word sformare, meaning "to unmold". This soft, velvety custard creation is typically baked in a casserole dish, individual ramekins (as I used), or a ring type mold. When done, the sformato are turned onto a serving plate and served warm. Besciamella (bechamel sauce), cream, or ricotta typically serve as the base or binding agent to which vegetables, meat, cheese, or even chocolate are added. Reportedly, the sformato was once popular on the tables of well-to-do families in Italy, due to their elegant appearance.

As the holiday season approaches, it seems everyone is always searching for new "side dishes". In my family, there are always many to choose from and Butternut Squash is usually one of the most favored. My mom always made hers on the sweet side using butter, brown sugar, and roasted pecans. Nonna's was a bit more savory, flavored simply with salt, pepper and butter. Though they were both equally delicious, this Italian Butternut Squash "Sformato" is not only exceptionally pleasing to the palate, but it also makes an absolutely beautiful presentation on a holiday table!

Preheat oven to 350°. Butter twelve 4-ounce ovenproof ramekins (I use disposable aluminum). Slice both butternut squash in half, scoop out seeds, place on a parchment lined cookie sheet and bake until completely cooked/soft. Scoop out squash, puree and put aside. Warm the milk in a small pan. At the same time, melt butter in a saucepan, add flour and stir (you now have a roux), add the warm milk and whisk until smooth. Cook while stirring gently until sauce thickens (making a besciamella), add grated cheese and stir together until melted. Season with salt and pepper, take mixture off



of the heat and cool slightly. Add beaten eggs and pureed squash, mix well. Pour mixture into buttered ramekins and bake for 30-40 minutes or until sformato is firm, golden brown, and begins to pull away from the sides of the mold. Let cool a few minutes, remove from mold/s and serve plain, with grated cheese shavings or cheese sauce/fonduta.

Cheese Sauce/Fonduta (optional):

Heat cream in saucepan, add cheese and whisk over medium heat until cheese is completely melted and blended in with cream.

The San Francisco Earthquake of 1906



The worst earthquake in the recorded history of California happened on the morning of April 18, 1906 when a 7.9 magnitude quake ruptured in the San Andrea's fault caused major waves and destruction in San Francisco. Occurring at around a quarter past five in the morning, the shaking was felt from Eureka to Salinas Valley, but the real cause of destruction was the ensuing fires which took firefighters several days to extinguish with the city's water mains destroyed in the earthquake. By the end, an estimate 3,000 (according to modern estimates, though numbers continue to vary) people had died, 28,000 buildings were destroyed (roughly 80% of the city), and 250,000 locals were left homeless and moved to camps across the bay.

With limited record keeping and general panic and confusion numbers vary. Initially, only 375 deaths were given, but hundreds of deaths in Chinatown went unrecorded. In addition, initial estimates omitted a near 200 deaths in nearby cities, such as Santa Rosa and San Jose.

Adding to the confusion were the two always dependable partners in crime: business and politics. Because home insurance companies offered reimbursement for fires but not earthquake, many residents were deliberately setting their damaged properties on fire.

Politicians, perhaps with not altogether self-serving motivation, saw the need to bring the city back to its status as California's leading commercial and financial beacon (this may have come too late, as in the immediate aftermath investments began shifting to Los Angeles). In order to avoid discouraging businesses and spur financial aid, California governor George Pardee said, "This is not the first time that San Francisco has been destroyed by fire; I have not the slightest doubt that the City by the Golden Gate will be speedily rebuilt, and will, almost before we know it, resume her former great activity." Numbers of fatalities and total destruction were purposely downplayed, though the magnitude of the disaster soon became apparent.

Donations and financial help poured in, however, the \$400 million worth in damages was soon recovered. London sent thousands of dollars across the sea, Standard Oil company donated \$100,000 as did Andrew Carnegie, as did the Dominion of Canada and even Ottawa branch of the Bank of Canada sent over





its share. Military troops were deployed to the city to help with the housing camps and fight off looters, though some soldiers were also caught looting.

By the time the city hosted the World's Fair in 1915, virtually no signs of the destruction were evident and the city regained much of its former glory.

In this regard, the earthquake of 1906 had very much the same effect the Great Fire had for Chicago some forty years earlier. Through the ashes of destruction a clean slate was given to developers and business magnets to turn the city into one of the nation's cosmopolitan treasures.

Tougher building codes were written into law, though, admittedly were often ignored in the rush to rebuild. Fighting a plan to push survivors from Chinatown further to the boundaries of the city, Chinese citizens united and their efforts led to the reconstruction of Chinatown. The Palace Hotel was rebuilt in all its glory and new structures such as a neoclassical civic center, wider streets, an expanded Fisherman's Wharf, and a subway under Market Street.

GREAT KNOCKOUT ARTISTS

Great Defensive Boxers

It was Hard to Stop These Guys

Last week, I wrote about Tony Canzoneri, and I argued that even though the stats did not show him to have an overabundance of knockouts, I still consider him to be a harder puncher than Roberto Duran. Of course, people will say if he was such a tremendous puncher why didn't he have more kayos? The answer lies in the competition from the era in which he fought.

I've taken a look back at the *Ring Magazine* rankings of featherweight, lightweight, and welterweight divisions during the 1930s. I choose these three divisions because many of the contenders at these weights moved among these classes during their careers. It is an impressive lot.

What is striking is the amount of all-time great talent that was competing at the same time in these divisions. Even more striking is the fact that they did not avoid fighting one another. On top of this, it is amazing to read how often they fought and the total number of fights they had over their careers.

Even more amazing is how rare it was for any of them to be knocked out. You are not looking at the records of fighters who were being fed stiffs. No, these guys were the best and they were consistently fighting the best. When any fighter during that era became a champion, he was truly a champion. Being a ranked contender was a feat in and of itself.

So who were these men? Looking through the rankings the names that show up are incredible. Men such as Tony Canzoneri, Lou Ambers, Henry Armstrong, Fritzie Zivic, Charley Burley, Cocoa Kid, Baby Arizmendi, Sammy Angott, Petey Sarron, Ceferino Garcia, Jimmy McLarnin, Holman Williams, Kid Chocolate, Andy Callahan, Sammy Fuller, Billy Petrolle, Teddy Yarosz, Fidel LaBarba, Johnny Jadick, Lou Brouillard, Battling Battalino, Andy Martin, and Louis Kid Kaplan. While there are a lot of names here, it is only a partial list and only includes top ten contenders and champions. There were also dozens of fighters competing on a level just below the top ten who were incredible fighters. After all, in order to get into the top tier a fighter had to wade through those guys.

Looking at the records of the boxers on the list provides some interesting data. As I have pointed out with Canzoneri, many of these fighters were terrific punches but did not have stunning knock out percentages the way many of today's fighters do. Why is that? Because while today's fighters are being fed a diet of stiffs to build their records, the fighters from the '30s were fighting each other which meant they were fighting the best talent in the history of the sport.

Another thing they had going for them is they knew how to practice the art of boxing. They had defensive skills, were highly experienced, and knew how to





keep calm and fight while hurt. These men were professionals in every sense of the word. Even beyond that, they were highly talented artists and craftsmen.

Something else to remember when taking their knockout percentages into account is the fact that these men were rarely kayoed themselves. When you have fighters of such high caliber fighting each other the odds of one stopping another go way down.

In the list of 23 fighters I have compiled above, they have a combined total record of 3,154 bouts. Out of that huge sum there were only 55 fights where they lost by kayo. Boxers such as Barney Ross, Charley Burley, and Fidel LaBarba were never stopped. Others, such as Teddy Yarosz (127 fights), Lou Brouillard (133 fights), Battling Battalino (88 Fights), Sammy Angott (131 Fights), Petey Sarron (139 Fights), Jimmy McLarnin (69 Fights), and Canzoneri (171 Fights) were only stopped once. The highest amount of losses for a fighter by kayo was 6. One was Johnny Jadick (6 out of 153 total fights) and the other was Ceferino Garcia (6 out of 120 fights).

Henry Armstrong had 183 fights and was only stopped twice. One of those was in his first pro fight. He was stopped one other time, by Fritzie Zivic. Zivic had a total of 232 fights and only lost four times by kayo.

These are astounding numbers, made even more so when you look at the level of competition these men were facing. But if you think more deeply about what was going on, then it isn't surprising to see these statistics.

To begin with, none of these fighters entered the ring assuming they were going to win by knock out. They were always ready to go the distance. They would score a kayo if the opportunity presented itself, which was rare when facing such talented opposition. They also had great defensive skills. Having fought often, for instance, Canzoneri fought 13 times in 1930 alone, they were always sharp. On top of this, when in the gym they were starring with seasoned pros. They studied the sport and knew it in depth.

These great fighters also knew how to keep their wits about them in a fight. When hurt the kept their composure. They knew how to tie up an opponent and make time to clear their heads. They also knew not to get wild when they had an opponent hurt as often a hurt fighter could be more dangerous, and getting wild with punches would leave give that opponent an opportunity to land a shot that could turn the fight around.

When comparing fighters from today to the greats of the past it is important to look at more than just knock out percentages. You have to take into account the level of opposition. When you do that there is no comparison. Just spend some time watching these old masters at work and you will see how superior they were.

HOOPS and HOCKEY in the HUB

It seems like he has been with us forever — but he has not. You can easily pick him out of a crowd. That's what happens when you are tall. But that's just one feature of this player who is so very much outstanding in so many other ways.

We speak, of course, of Zdeno Chara, the longtime Bruins captain and standout defenseman who played in his milestone 1,500th regular season National Hockey League game against Montreal early in November.

Given how valuable he has been to the Bruins, it is hard to believe that Z is not an original B, but played with two other teams before coming to Causeway Street in the summer of 2006.

Like many others who are now here, he came from overseas. In Chara's case that would be Slovakia where he was born on March 18, 1977. And yes, when the Bruins blasted out of the gates for the first regular season game back in early October, there was Z at 42—the oldest active player in the entire NHL.

And while his coach — Bruce Cassidy — a man in his 50's, is more than a decade older than Z, the big captain is much closer in age to the man who runs the team located just down the hall at the Garden. Brad Stevens, who is in his sixth year of directing the Celtics, is only about five months older than Chara (born October 22, 1976).

Which in a way calls to mind that way back when, as athletic coaches in his home area first got a good look at him, they felt that Chara just might be a good candidate for the roundball game. It never became serious but when Z topped out at his adult height of 6-9, that did give him the rather lofty status of being the tallest player in the history of the National Hockey League.

And when it was time for the big selection, in Chara's case the 1996 NHL draft, he was taken in the third round (56th overall) by the New York Islanders — a selection that makes one wonder whatever happened to the 56 others that were chosen ahead of him.

Whoever they were, they are all gone — all of them. A good number probably never made it to the NHL. Others may have played a few games. A fortunate few may have stuck around. Whatever, they have all disappeared. Only the Big Man remains, night after night patrolling the back end, experiencing like all who follow the fortunes of the Black and Gold the high points (2011 Stanley Cup Championship), the disappointments (losing in both the 2013 and 2019 Stanley Cup Final) and the current exhilaration of the impressive out-ofthe-gate start of the 2019-2020 Bruins.

And whenever media members from around the world ask Chara for an interview, it is possible that he will be able to fulfill that request in the native

language of the journalist. Yes, Z does speak English, the language most often used by those around the Bruins. But he also can converse in six additional languages — Slovak, Czech, Polish, Swedish, Russian, and German.

Early on, Chara spent four years with the Islanders organization, including a brief 23-game span with the Lowell Lock Monsters way back during the 1998-1999 season.

Front office executives make mistakes and the Islanders very probably wish they could take back their decision to trade Chara to the Ottawa Senators in June, 2002.

Four impressive seasons with Ottawa followed, including something that contemporary fans might find mildly surprising. Z often found himself in physical confrontations out on the ice.

In his final year with the Islanders Chara played all 82 games while being assessed a total of 157 penalty minutes. That trend would continue while he was with the Senators. All four years while he was playing with Ottawa, Chara topped out with significant totals in penalty minutes — the low being 116 and the highest 156.

And here's a really interesting stat. During the 2004-2005 lockout season when he played 33 games for a team in Sweden, he spent a total of 132 minutes in the sin bin. Imagine that — 132 penalty minutes in just 33 games.

Z arrived on Causeway Street after being signed as a free agent and the player we have come to appreciate and respect soon was on display. Chara was named the winner of the Norris Trophy (league's outstanding defenseman) for the 2008-2009 season — his third with the B's and the second of consecutive 50-point seasons.

His penalty minutes have also declined during his tenure with the Bruins. The highest annual total has been 60 over the most recent three-year span.

Unlike a number of people affiliated with the Bruins who choose to live in the suburbs, Chara is a Bostonian. He famously rode his bicycle over to the Garden in the days following the B's return from Vancouver following their 2011 Stanley Cup victory.

Within a year of his arrival in the Hub he married his longtime girlfriend Tatiana in 2007. They have three children, all of whom were born in Boston.

Many summers will find Z on the move. He often pays a visit to his hometown overseas. He once climbed Mount Kilimanjaro, the tallest mountain in Africa (16,100 feet from its base) and is active in many charitable causes.

The letter Z is the last letter of the Roman alphabet but the man who answers to that as a nickname is truly thought of as one first-class person by the many thousands who comprise the citizenry of Bruins Nation.
