Democrats Gain House Seats, Blue Wave Caught Off Guard by Red Tide Ted Cruz Barely Beats Beto for Texas Senate Seat Baker Cruises to Easy Victory, Diehl No Real Deal vs. Warren



Stirpe Nostra

PICKING UP THE TAB



"Picking up the tab" is an expression that most people use with hardly a thought given to its origin. Tab in Latin is generally used when referring to a written note or mark. Interestingly ... tab expands into "tabulae" for notebook, "tabella" for writing tablet, and "tabellarius" for letter carrier.

The Latin word for letter, however, is "epistola" and this in turn is the origin of our English word epistle. Epistola was originally intended to signify a letter that was written on paper for transmission to another person. The date and place of origin were noted at the end of the letter, but names of the sender and recipient were attached separately and not placed on the letter itself. Collections of the works of ancient Greek authors boast of letters from the hand of Plato, Demosthenes, Aeschines, Xenophon and Epicurus.

The art of letter writing was also cultivated by the Latin literati from classical times, but being about five hundred years younger, more samples were preserved. The most valuable of these preserved letters were written by Cicero and they number close to one thousand. This was the medium of correspondence that was used by jurors in response to questions of law, by schools for their learned discussions, by physicians for medical purposes, and by rhetoricians as a form of expression.

After a letter was written, the next problem was to get it delivered. This is where the Tabellarius (letter carrier or courier) came into the picture. He was usually employed by private citizens for the purpose of carrying these letters or messages. Letters to foreign countries were usually given to ship captains and then transferred to carriers in that country. History tells us that as far back as 2000 B.C.

the City of Babylon had a postal service. This is the area where people wrote on clay tablets and the letter carriers were very, very strong. Ancient Egypt also developed a system of carrying letters by hand, but the country of Persia under Darius (about 500 B.C.) probably originated the first national postal service. Herodotus, a great Greek historian tells of horsemen stationed at intervals to convey the imperial will in all directions of the Persian Empire.

The vast extent of the Roman Empire and its system of roads or highways not only facilitated the movement of legions and supplies, but also the development of its own form of postal system, which was called "Cursue Publicus" (public courier). Under the Roman Republic, government officials were dispatched from Rome as couriers on alleged public business. These couriers were empowered to impose arbitrary requisitions on communities to supply them with the necessities for travel, such as food, lodging, etc. The Latin expression for this kind of activity is "juncus," and there is no doubt that it is the origin, in word and deed, for the good old American iunket.

During the time of Cicero, a juncus could not extend beyond one year but Julius Caesar extended it to five years. Communicating between Roman senators and generals, allies, or provinces, was done by dispatches which were carried by mounted messengers, but the thought of allowing up to five years for the delivery of a long distance letter staggers the imagination. Sometime around 20 B.C. the emperor Augustus appointed mounted couriers to work in a relay fashion along the public roads. He also provided postal stations, which were provisioned for overnight

tions with fresh horses between those postal stations. Each of the communities involved was required to furnish and maintain the teams, keep the stables in good repair, furnish veterinarians, wheel-rights, grooms and guards. This kind of service became a tremendous burden on the public until the emperor Nerva relieved the individual communities of the financial obligation and ordered the state to assume all costs. Later, Emperor Hardrian made the postal service a department of the state administration throughout the empire and appointed fixed stations, which were superintended by government officials. This relieved the municipal magistrates of all responsibility for the function.

It might be of interest to note that a postal service was established in the Massachusetts Bay Colony in 1639, and it was controlled by the British until the Revolution. At that time, Benjamin Franklin, as we all know, became our first postmaster. In 1847, the annual volume of U.S. mail averaged six pieces per capita, and by 1980, it increased to 455 pieces per capita. Today the U.S. handles about forty percent of the world volume of mail.

Saint Benedetta Cambiagio Frassinello

Cambiagio was born on October 2, 1791, in Langasco, near Genoa, as the last of six children. She was the daughter of Giuseppe and Francesca Cambiagio. She grew up in Pavia, Italy. At the age of 20, she had a profound mystical experience that left her devoted to prayer and desiring a religious life. However, in o b e d i e n c e with her family's wishes,

she married Giovanni Battista Frassinella on February 7, 1816. He was a farmer and carpenter. The couple had a happy married life for two years, but Giovanni, impressed with Benedetta's holiness and desire for religious life, agreed to live

Benedetta became an Ursuline


In 1826, Benedetta was forced

was assigned to help. The schools continued to grow and prosper, and Benedetta was appointed Promoter of Public Instruction in Pavia. However, no matter how chastely they lived, Benedetta and Giovanni's close relationship drew gossip and criticism from civil and Church authorities. To insure that she did not get in the way of the work, in 1838, Benedetta

turned her work over to the bishop of Pavia, and withdrew to live as a nun at Ronco Scrivia, Genoa, Italy.

Not content to withdraw from the world, Benedetta began all over again. With five companions, she founded the Congregation of the Benedictine Sisters of Providence dedicated to teaching, and opened another school. Living alone, the local authorities found no causes for gossip, and Benedetta spent her remaining years in prayer and

Sister Benedetta passed away at Ronco Scrivia on March 21, 1858. She was canonized by Pope John Paul II on May 19, 2002. The Feast of Saint Benedetta Cambiagio Frassinello is on March 21st.

Save the Nazzaro Community Center

What would the late State Rep. Michael Nazzaro think of the city of Boston's plans to sell the North End's beloved Nazzaro Community Center that bears his name, in order for a private developer to build modern condos? It's hard to imagine that he would be pleased. He devoted his career to saving the North End, fighting successfully against the Boston Redevelopment Authority who had already decimated the West End. He knew that once you give up your authentic legacy and culture, you can never get them back again.

Even now most North Enders don't know that some city officials have been working for months on a plan to sell the Nazzaro Center. City architect Allistair Lucks and the consultants of the Sasaki group briefed the public on October 17th about their plans to close the Nazzaro Center and create a new community center on Sargeant's Wharf. When pressed by citizens at the packed meeting, they admitted that they had already sought a real estate estimate to sell the Nazzaro building.

These consultants half-heartedly presented an option of expanding the Nazzaro building, but they said it would require closing off a large portion of the open-air Polcari Playground, which no one - not the North End residents who were present at this meeting, nor even the city architects themselves — thought was a good idea. The new expanded building still wouldn't be big enough, the architects said.

Instead, the city architects want to give up the North Bennet Street location and move all the community's programs into a large new building on Sargeant's Wharf or next to the Mirabella Pool. The people at the meeting did not like this idea either. They complained that it would be in a flood zone, and the youngest children and the North End's seniors would have a very hard time crossing busy Commercial St. Instead, the residents offered a much more logical solution: keep some programs in the current Nazzaro Building, updating it as necessary, and build the new basketball court and swimming pool on the city's Fulton Street parking lot. Then the community would finally have enough space.

City officials were not pleased with this, because it would cost them money. They tried to frame this issue as being only about the facilities that the North End's young people need, without regard to what they are asking the community to give up. They didn't calculate that the Nazzaro Center and Polcari Playground are beloved public institutions, used throughout the day, by citizens of all ages for over 100 years. Those of us who live nearby love the sounds of the children on the playground, the staging of the bands for the feasts, the Halloween Party and all other community events there. To sell the North End's cultural legacy for private development — because the city is too cheap to build a new regulation basketball court for the North End on Fulton Street — is outrageous.

With your help, we can get National Landmarks status to protect the Nazzaro building and Polcari Playground, while still supporting the city's plan to build a new basketball court and community facility on Fulton Street. We are gathering signatures now for a Landmarks Petition. We hope all of our officials and neighbors will sign it. The petition would save the beautiful exterior of the building, and the open space of the park. It would not, however, prevent updating the inside of the building as needed, and redesigning it for new uses. Wouldn't it be wonderful to have one corner of the building be devoted to a museum of Italian-American heritage?

The Landmarks Commission should accept our petition because the Nazzaro building at 30 North Bennet Street. has such historic significance. But getting it protected will require strong community support, including lots of people showing up at a hearing that will be held on our petition,

a European festival celebrated since the Middle Ages. St. Martin's Day, commonly known as Martinmas, honors the fourth-century French bishop St. Martin of Tours. Across Europe, Martinmas blended religious significance with agricultural importance, as it marked the end of the harvest season and the beginning of winter. Martinmas celebrations boasted feasts of seasonal foods and boisterous family reunions. In Central Europe and Scandinavia, people dine on goose, often stuffed with the autumnal chestnuts. This meal commemorates a well-known legend about the humble St. Martin, who supposedly hid in a goose pen when he was reluctant to receive the position of bishop. In Germany and the Netherlands, costumed children collect sweets and coins in lantern-bearing processions, while people in Poland enjoy croissants filled with poppy seeds and almond paste. Italians celebrate Martinmas, or il Giorno di San Martino, by sampling the year's new wine. One of my father's favorite proverbs was "San Martino, si fa il vino", meaning that wine is made on St. Martin's Day. Another proverb, "San Martino, castagne e vino," states that chestnuts and wine can be expected at Italian Martinmas celebrations. These proverbs reveal the Italian affinity for seasonal delicacies and traditions hearkening back to olden agricultural days of society. I always make pumpkin

some months from now.

The importance of this building is not just local, but national. Originally the North End Bathhouse and Gymnasium, the Renaissance Revival building was sponsored by Mayor "Honey Fitz" Fitzgerald, President John F. Kennedy's grandfather, and designed in 1906 after the Villa Medici in Rome by one of the city's most celebrated architects. It was refurbished by our only Italian-American Mayor, Thomas Menino, in 2004 for \$1 million, including a new floor on the basketball court. It was where World Welterweight Champion Tony DeMarco began his career.

The building is an artifact of America's Progressive era at the turn of the 20th century, when social reformers were struggling to respond to the overwhelming flow of immigrants arriving from Europe. In Boston, they lived in crowded North End tenements without baths or even private toilets. The land on North Bennet Street was bought by the city in 1902, and the ornate bathhouse was designed in 1907 at a cost of \$130,000. By the time it opened in 1910, the Irish area had become largely Italian, with some Jews also living there.

In her book Washing the Great Unwashed, scholar Marilyn Thornton Williams describes how reformers thought the baths would not only improve health, but also the moral character of the poor, making them better citizens. Public baths aimed to bridge the gap between the classes and help achieve a small measure of social justice. Cleanliness was extolled as one of the hallmarks of civilization and progress. Even as late as 1940, about 90% of North End homes were without private baths and about 50% lacked private toilets.


Although bath reformers can be criticized for not demanding for the poor the same private bathing facilities that

they enjoyed in their homes, Boston Mayor Josiah Quincy maintained in 1898 that the public baths were "architectural monuments of the city" which raised "the whole idea of public bathing to a high and dignified plane."1 The most notable example of this was the North End's ornate North Bennet Street Bath House, as cited by Maureen Meister, Arts and Crafts Architecture: History and Heritage in New England.

The building was still used regularly as a bathhouse by an estimated 900 North End residents until it closed in 1976. In 1985, it was restored and repurposed as the Nazzaro Community Center, with recreational and community programs for all ages. Old timers still remember taking their showers here, and, as teenagers, getting ready for their dates: "Back then there was no bathtub or shower in my childhood apartment. We had the North End Bathhouse," wrote Natalie Cinelli in NorthEndWaterfront. com a year ago. "My cousin Lucille, who grew up with me in my grandmother's building on the fourth floor, recalls the Saturday nights at the bathhouse when all the young girls would be getting ready for their big dates, doing their hair, primping and putting on makeup, gossiping about boys. A true communal experience!"

The Nazzaro Center is completely unprotected right now by any historical landmark status, and can be torn down or sold by the city at will. Please join us and sign the Landmarks Petition, and tell our officials that we want the Nazzaro Center and Polcari playground to be maintained for public use. The North End should not have to sell out its treasured legacy in order to get the new basketball court and other facilities that its tax-paying citizens deserve.





- 8. **She keeps you fit and fabulous.** The minute you pull


out the leash, she goes crazy. It's time for that walk you both need

So when "business" takes him to L.A. to collect a debt from down-andout filmmaker Harry Zimm (Gene Hackman), Chili jumps headfirst into the Hollywood scene. He schmoozes a film star (Danny DeVito), romances a B-movie actress (Rene Russo) and even gets reservations at the hottest restaurants in town. In fact, all would be cool for this smooth new producer if it weren't for the drug smugglers and an angry mobster who won't leave him alone. But hey, this is Hollywood and no one said it would be easy.

MY GIRLS

A Lifetime with Carrie and Debbie Written by Todd Fisher

The venue was a quaint little Italian bookstore located in Boston's historic North End, and the program was a presentation of the recently released book My Girls, A Lifetime with Carrie and Debbie (HarperCollins, publisher) with the author Todd Fisher, son of Debbie Reynolds and sister of Carrie Fisher.


My Girls ... is not only a revealing chronical about both iconic film stars and their contribution to the world of entertainment — both staring in two of Hollywood's most popular motion pictures, Reynolds in Singing in the Rain and Fisher of Star Wars fame, but also the book is an inviting narrative by the one who perhaps was closest to both. The work is a firsthand account of the often challenging and demanding lives of both actresses; and Todd provides the reader with both interesting and enlightening background material that not only their admirers would welcome but undeniably the general public as well.

With Reynolds, the book reaches back decades, covering her early career including her marriage with singer Eddie Fisher and their separation (due to his leaving Reynolds for Elizabeth Taylor,) causing nothing less than international scandal. Todd also addresses obstacles and dilemmas resulting in her subsequent two marriages, which also culminated in financial loss; however, My Girls ... allows one to realize that Reynolds significantly prevailed over some grim adversarial conditions — but not without tenacity and hard work! The author also provides some good contextual information throughout the book that allows an understanding of Reynolds durability; case in point is the loss of her earnings due to her second's husbands overwhelming debts; debts that she repaid however while continuing to work as a performer, or the eventual forteiture of her investment in her hotel/ casino and museum project in Las Vegas, or the hurdles of trying to develop a permanent home, albeit unsuccessfully, for the Hollywood memorabilia that she amassed over decades — Hollywood memorabilia that was believed to be the largest private collection in the world!

Todd recounted in the intimate gathering at the venue that Debbie's film The Unsinkable Molly Brown, (the 1964 film which Reynolds was nominated for an Academy Award for Best Actress,) that his mother, similar to the character Molly Brown, was resolute and determined — traits that certainly aided in her defeating the odds that seemed to trail her in her; vet, despite those seemingly insurmountable difficulties, Reynolds was still the consummate performer, pleasing her fans on national tours and appearances as well as being devoted to her family.

Todd also writes of his sister Carrie, their close relationship, and in her struggles with (albeit later detected) bipolar disorder.

Carrie Fisher, along with her celebrated role in the Star Wars



films, was also an accomplished author. Todd writes of his sister respectfully and fondly; certainly they shared a remarkable mother and grew up together in the ambiance of Hollywood; Todd writes of Carrie as his friend and sister going back to their early childhood in Beverly Hills and enjoying a youth that would make one envious, but as the years progressed Carrie was eventually affected with the strain and often impasse that those suffering with substance abuse as well as the struggles of bipolar disorder can cause. Todd writes of her dilemma candidly, and addresses issues that certainly need to be addressed and dealt with, and obstacles that we too often know are not always defeated. Carrie herself addressed publicly her encounters with substance abuse and being bi-polar; in fact, she wrote of the topic in her 1987 book Postcards from the Edge, published in 1987.

Todd writes of his and Carrie's relationship going back to their beginning at 813 Greenway Drive in Beverly Hills and continuing through until just at the end of 2016, when the world lost both Debbie Reynolds and Carrie Fisher a mere one day

However, notable aspects of Carrie's professional career, and indeed, some affecting behind the scenes recollections by the author, gives the reader the opportunity to know Carrie a little more; maybe the chance to know what the public remembers not only as a successful actress in her own right but also recognized as a respected generation of entertainers con- entertainment industry.

tinue with Carrie's daughter Billie Lourd who has also made a name for herself in the industry.

The biography is of course linear, however within its 21 chapters Todd allows the reader a good understanding of the individual chapter's particular subject matter and brings in relevant and ancillary information that indeed gives perspective to the book's overall themes. An example would be Carrie's early estrangement from her mother; a division that was not understood by others; but as the years progressed, both daughter and mother became increasingly devoted. Or, the lifelong friendships Carrie enjoyed with fellow actors; and, indeed, with her brother Todd.

Todd also covers writes about her marriage to Paul Simon, her relationship with Billy's father Byron; being the respectful daughter to Eddie Fisher; and her associations with those who were with her in her truly prolific life. But Carrie also did something else, she took her own quandaries, her own difficulties and problems and wrote about them in a compelling way: indeed, one of her aptitudes has been as screenwriter and playwright - bringing to light the problems that for so many and for so long were always kept concealed; problems that could be addressed and dealt with.

My Girls ... by definition is biographical; but it is more than biography; the author shares his life too with the readers and therefore can be considered autobiographical as well. Todd has been associated with Carrie and Debbie virtually all his life; with Debbie's business endeavors, he has helped in her ambition of securing a place for Hollywood artifacts; and in her goal of establishing her namesake hotel in Las Vegas along with additional situations. With Carrie, he has been there when situations necessitated his presence, and being there when it was important for, well, just for a brother to be there.

My Girls, A Lifetime with Carrie and Debbie is definitely recommended; it is cogently and sincerely written; and engaging for those who have followed both Debbie and Carrie's author, advocate, daughter, careers, as well as appealing for wife and mother. The third those interested in the overall

A Nostalgic Remembrance

NO ONE COVERED THE FIG TREE

Several of you have asked me to print this story. It is from the pen of an anonymous writer, but it sums up a lot of who and what we are, so enjoy:

I was well into adulthood before I realized that I was an American. Of course, I was born in America and have lived here all of my life, but somehow, it never occurred to me that just being a citizen of the United States meant that I was an American. Americans were people who ate peanut butter and jelly on mushy white bread that came out of plastic bags. Me? I was Italian. For me, as I am sure for most second generation Italian American children who grew up in the '40s and '50s, there was a definite distinction to draw between us and them. We were Italians. Everybody else, the Irish, Germans, Poles, they were "Mericans." There was no animosity involved in that distinction, no prejudice, no hard feelings; just ... well ... we were sure that ours was a better way. For instance, we had a bread man, a fruit and vegetable man, a chicken man. We even had a man who sharpened knives and scissors right outside our homes. They were part of the many peddlers who sold their wares in the Italian neighborhoods. We would wait for the call, their yell, their individual distinctive sounds. We knew them all and they knew us.

The Americans, they went to the supermarket for most of their foods, what a waste. Truly, I pitied their loss. They never knew the pleasure of waking up every morning to find a hot, crisp loaf of Italian bread waiting behind the screen door. And, instead of being able to climb up on the back of the peddler's truck, a couple of times a week just to hitch a ride, most of my American friends had to be satisfied by walking with their mothers to the store. When it came to food, it always amazed me that my friends and classmates only ate turkey on Thanksgiving Day or Christmas. Or rather, they only ate turkey, stuffing, mashed potatoes and cranberry sauce. Now, we Italians, we also had turkey, stuffing, mashed potatoes and cranberry sauce, but only after we had finished the antipasto, soup, lasagna, meatballs, salad and whatever else Mama thought might be appropriate for that particular holiday. The turkey was usually accompanied by a roast of some kind (this was just in case somebody walked in who didn't like turkey) and it was followed by an assortment of fruits, nuts, pastries, cakes and of course, the homemade cookies sprinkled with little colored things. No holiday was complete without some home baking; none of that store bought stuff

This was where you learned to eat a seven course meal between noon and four p.m., how to handle hot chestnuts, and put peach slices in red wine. My friends ate cornmeal mush; we did too, but only after Mama covered it with gravy

and added spareribs, sausages and meatballs. We called it polenta ... now it is a gourmet food. Mama must have known it all the time. I truly believe Italians live a romance with food. Sunday was the big day of the week. This was the day you'd wake up to the smell of garlic and onions frying in olive oil, as it dropped into the pan. On Sunday, we always had gravy and macaroni. Sunday would not be Sunday without going to Mass. Of course, you couldn't eat before Mass because you had to fast before receiving Communion. The good part was that we knew when we got home, we'd find hot meatballs frying, and nothing tasted better than recently fried meatballs and crisp bread dipped into a pot of hot gravy. There was another difference between us and them. We had gardens, not just flower gardens, but huge gardens where we grew tomatoes, tomatoes and more tomatoes. We ate them, cooked them, jarred them, and of course, we also grew peppers, basil, lettuce and squash. Everybody had a grapevine and a fig tree, and in the fall, everybody made homemade wine. Then, when the kegs were opened, everybody argued over whose wine tasted the best.

Those gardens thrived because they also had something that our American friends didn't seem to have, our grandparents. Of course, it's not that they didn't have grandparents; it is just that they didn't live in the same house or on the same block. Their presence wasn't that noticeable. We ate with our grandparents, and God forbid we didn't visit them at least six times a week. I can still remember my grandfather telling us about how he came to America as a young man, in the bottom of a boat, and how the family lived in a tenement and took in borders in order to make ends meet. My grandfather decided that he didn't want his children, five sons and two daughters, to grow up in that environment. All of this, of course, in his own version of Italian/English, which I learned to understand quite well. When they saved enough money, and I never still can figure out how, they bought a house. That house served as the family headquarters for the next forty years.

I remember how they hated to leave the house for any reason. They would rather sit on the back porch and watch their garden grow. When they did leave for some special occasion, they had to return as quickly as possible, after all, nobody was watching the house. I also remember the holidays when all the relatives would gather at my grandparent's house and there would be tables of food and homemade wine. The women would be in the kitchen, the men in the living room and the kids ... they were everywhere.

I must have a thousand cous-

ins, first cousins, second cousins and some friends who just became cousins, but it didn't matter. My grandfather, sitting in the middle of it all, his pipe in his mouth, his fine mustache trimmed, would smile; his dark brown eyes would twinkle as he surveyed his domain, proud of his family and how well his children had done. One was a cop, one was a fireman, the others had their trades, and of course, there was always a rogue about whom nothing was ever said.

The girls, they had all married well and had fine husbands, although my grandfather secretly seemed to suspect that one son-in-law wasn't Italian. But, the one thing we all had was respect for each other. The old timers had achieved their goal by coming to America, to Boston, New York, New Jersey, Chicago, or Philadelphia. Now their children and their children's children were achieving the same goals that were available to them only in this great country.

When my grandparents died a few years ago, things began to change. Family gatherings were fewer and something seemed to be missing. Although we did get together, usually at my mother's house, I always had a feeling that the old timers were still there. It is understandable that things change. Everybody now has families of their own and grandchildren of their own. Today, we visit once or twice a year or we meet at wakes or weddings. Other things have also changed. That old house my grandparents bought now is covered with aluminum siding. A green lawn covers the soil that grew tomatoes. *There was no* one to cover the fig tree when the weather turned cold, so

The holidays have changed. Yes, we still make the family rounds, but somehow things have become formal. The great quantity of food we once consumed without any ill effects is no good for us anymore: too much starch, too much cholesterol, too many calories in the pastries, etc...No one bothers to bake anymore. Everyone is too busy. It's easier to buy ... and anyway ... too much is not good for you.

The differences between "us" and "them" aren't so easily defined anymore, and I guess that's good. My grandparents were Italian-Italians; my parents were Italian-Americans. I'm an American and proud of it, just as my grandparents wanted me to be. We are all Americans now, the Irish, the Germans, the Poles, U.S. citizens, all. But, somehow, I still feel a little bit Italian. Call it culture, call it roots. I'm not sure what it is. All I do know is that my children. my nieces and nephews have been cheated out of a wonderful piece of heritage. They never knew my grandparents. (I hope you liked it ... GOD BLESS AMERICA)





The Killing Fields

Based on the correspondence of the late New York Times reporter Sydney Schanberg, the single most influential American in bringing news of the Cambodian war to the States, The Killing Fields is a raw, powerful, and gritty war film. Its main significance is a British production is how un-Hollywood it feels.

Director Roland Joffe remembers the day he was given the script, "David Puttnam asked to see me, which in those days was a bit like being invited out to Hollywood. He gave me Bruce Robinson's script, which was enormous, but it was so full of passion and energy I couldn't put it down. I'd heard about Cambodia and the Khmer Rouge, but didn't know much until I read it. I wrote to David saving that whoever made the film would have to be careful because it wasn't just a war story: it was about human connection, how friendships are born and what they do to us. I didn't hear from him for six months, then we bumped into one another and he said he'd interviewed most of the directors in the world including some very big names who would make the studios happy — but no one had really understood it. "You're the only man who has," he said.

I'd done a lot of TV and theatre, but this was my first film and I was working with some highly experienced people: the cinematographer Chris Menges and the production designer Roy Walker, who had worked with Stanley Kubrick. The killing fields were where the Khmer Rouge executed people and dumped their bodies. We shot those scenes in the countryside outside Bangkok. Lots of very realistic looking corpses had been laid out. It was all very disturbing: you'd get a crawling feeling up your back during shooting. And there was a real panic when a farmer's wife went out early

in the morning and got a total shock when she saw them, poor

Haing S Ngor, who played Dith Pran, was an extraordinary person, tormented and confused, but warm and friendly. He'd lived through all these events in Cambodia, but he was a doctor not an actor. He'd managed to escape and was now working in Long Beach, California. Pat Golden, who worked on casting, said: "You should look at this man Haing, he's really interesting." When we talked, Haing vividly told me about his experiences and I thought, "Hmm, there's an actor in here." I got him to talk through what had happened when he was in the operating theatre and had seen the Khmer Rouge approaching. I asked him to pretend Pat was the nurse and repeat exactly what he'd said. "Khmer Rouge are coming!" he said. "We must go! I'm telling you – GO!" Then he burst into tears. "Haing," I said, "you have to do this film. There is a voice for Cambodia and you are that voice. It's your duty to bring it to the world."

It was quite a horrible, manipulative thing to say. During shooting, I would sometimes crawl below the camera and call out to him: "Remember how you felt!" He was such a brave man. At the wrap party, everyone came in

costume and he came dressed as Khmer Rouge. He had the courage to face his demons."

Indeed, the most remarkable aspect of The Killing Fields is the seamless performance of the late Dr. Haing S. Ngor, himself a survivor of the murderous regime, in the role of the heroic Dith Pran.

"For me, movie not different," Dr. Ngor said, still trying to master the language of his new land. "I have enough experience in Communist times. I put emotion into the movie. We have a lot of scenes like in Khmer Rouge time. Everything the same."

Pran himself admired Dr. Ngor's performance, "One thing I know, this is a true story. Only someone who got trapped like me could do this part. Haing did well because he lived like me. When I see the movie, I try to say, 'That's past. That's past. Don't give away your tears anymore.' I try to pull myself out, but you cannot pull all the way out. You say, 'Oh my God, I am there again.'

The last thing Dr. Ngor thought of himself as, however, was an actor. But, discovered at a family wedding in California, the war survivor was quickly cast into the role and stunned the filmmakers.

To properly capture the horrors of life under Pol Pot, Joffe spoke to other survivors as well as former political prisoners from Eastern Europe. The result if a shocking but thoughtful war film. The Killing Fields is, in the words of Joffe, "Anti-ideology. The argument is that the degree of bombing on a peasant country creates a kind of distress and a fury. The average age of the Khmer Rouge troops that came into Phnom Penh was 17, and those troops had had 75 per cent casualties. That would psychologically affect you. What the film is saying is that the world isn't filled with strange and bizarre acts for no reason. I think the most terrifying thing in Pol Pot's writing was the outstanding mediocrity and crudeness. One realized a mind that mediocre couldn't see the ridiculousness of his ideas. It was close to being psychotic. The other thing I detected in Pol Pot was an intense nationalism and traces of paranoia - paranoia of the West, of Vietnam, of Thailand, even of China. Pol Pot had the idea of rebuilding the ancient peasant empire of Angkor Wat. He became an expression of the terror and hysteria of a

whole country just as Hitler

HOOPS and HOCKEY in the HUB

HE WAS THERE THAT NIGHT—When the Chicago Blackhawks defeated the Bruins in six games to win the 2013 Stanley Cup at the Garden.

He would be Joel Quenneville, a man synonymous with the dynamics of those behind-the-bench strategies whenever the topic of coaching comes up in the National Hockey League.

The Blackhawks got off to a rocky start this season, going 6-6-3 before the plug was pulled by the front office. More than the overall record, though, was the fact that Chicago had failed to make the playoffs for each of the last two seasons and was mired in a fivegame losing streak, a string of setbacks that put the team from the Windy City in sixth place in the Central Division of the Western

In addition to leading Chicago to the 2011 Cup, he also led the Blackhawks to the big prize in 2013 and 2015. Overall, he was 452-249-96 in 11 seasons with the team and was the second-winningest coach in the history of the league with 890 regular season victories.

Of course, as a coach in contemporary times, he has the advantage of coaching in 82-game regular seasons, campaigns far longer than those of the mid 20th century or earlier. Thus, there are now more chances for victory just as there were fewer opportunities for wins for excellent coaches such as Bruins legendary bench boss Art Ross who was surpassed in triumphs by Claude Julien back in March, 2016.

Quenneville is remembered by fans in southern New England because he played for the Hartford Whalers from 1982 to 1990 and later was the head coach of the Springfield Indians AHL team.

He is also a member of a rather exclusive group in Chicago. You see, only four men have coached pro teams to multiple championships in their respective sports in the city by Lake Michigan — Quenneville with the Blackhawks, George Halas with the Chicago Bears, Phil Jackson with the Chicago Bulls and Frank Chance with the Chicago Cubs.

The veteran mentor, who has coached for more than three decades, was replaced on an interim basis by a man close to half his age — 33-year-old Jeremy Colliton, who was the head coach of the Chicago's AHL affiliate in Rockford, Illinois. When he got out of the car after the 86-mile drive into Chicago, he had acquired a dual status. Not only was he an NHL head coach but he was also the youngest one among the 31 active mentors in the league.

You'd have to be a real diehard NHL fan to remember Colliton from his playing days — three goals and three assists while playing off and on as a center for the New York Islanders from 2005-2011.

The Bruins first encounter with the Blackhawks will come at the Winter Classic on New Year's Day at Notre Dame Stadium. They will also play Chicago at the Garden on February 12th.

A VIEW FROM THE OTHER SIDE — That's what it was as he stared down the ice in a place he once patrolled with a bit of regularity.

Anton Khudobin, the former Bruins backup goalie, was back in the nets on Causeway Street, attempting to deny his former mates as they skated in a quest for victory against the Dallas Stars. He didn't quite pull that off but he had a good night, stopping 33 of 35 shots in the 2-1 Bruins overtime win.

Both of the B's goals came on power plays with David Pastrnak finding the range early in the first period and Brad Marchand notching the game-winner on a 5 on 3 man advantage with just 31 seconds left in overtime.

Other than that it was a clean night for Khudobin, who played 31 games in net for the B's last season, going 16-6-7 with a .913 save percentage and a 2.56 goals against average.

"It was kind of weird because I never, ever played against the Bruins at the TD Garden," noted Khudobin, who also played 16 contests for the Black and Gold during the 2016-2017 campaign. "So it was kind of like a first game. That was my experience."

Tuukka Rask, his former B's teammate, stopped 24 of 25 shots at the other end of the rink to pick up his fourth win of the young

On this night he was the Tuukka of former times and all the talents that enabled him to win the Vezina Trophy in 2014 were on display. This season, he's been pressed for starts by Jaroslav Halak, who has played superbly in the early going.

"I just wanted to feel solid, to feel good about my game," said Rask. "It was good to get the win. A lot of goaltending is mental. Everybody in the league has the skill to play at a high level. A lot of times you either win or lose the battle inside your head. I'm just trying to win it."

It marked the first time since 1967 that the B's recorded an overtime victory against the Stars franchise, which originated in Minnesota and later moved to Dallas. The two teams meet again on November 16th in Dallas.

ANOTHER BIG CONTRACT — The Red Sox defeated the Dodgers in the World Series but that didn't prevent one member of the Los Angeles pitching corps from coming away a big winner.

Clayton Kershaw, one of the aces on the mound for L.A., recently agreed to a new three-year, \$93 million contract for the next three years. That works out to \$84,931 per day year round for the next 36 months. That means that if Clayton sleeps eight hours a night, he's already earned just over \$28,000 upon awakening. What a way to greet the morning.

Ah, but there are additional features. There are incentives. Why anyone who is being paid nearly \$85,000 a day would need incentives we do not know but they are in the deal. They include an additional \$1 million for starting at least 24 games per season plus an additional \$1.5 million for winning the National League's Cy Young Award.

Kershaw has won the award four times. He also started 26 regular season games in 2018. But however the Dodgers fare next year, we already know one thing: the 2019 season will be a successful one for Clayton Kershaw.
