



Stirpe Nostra

Mention the word "basilica" and many people immediately think of the Basilica of St. Peter in Rome. The name "basilican style" is correctly applied to any church that is rectangular in plan has columns at the side aisles, a raised altar and a semicircular section behind the altar which is called the apse. Any church can be built in the basilican style, but it is not properly called a basilica until the Church hierarchy confers that title upon it. During recent years, however, that policy has been relaxed to the point where a Catholic Church of any shape can be designated a basilica if the hierarchy so desires. There

The whole concept of the Christian Basilica was taken from the pagan Roman court of law that was called a basilica. This, in turn, was copied from

the earlier Greek civilization. The climate of Greece is intermediate, between rigorous cold and relaxing heat, and it favors outdoor life. The "Ecclesia," or Town Meeting of the ancient Greek communities, met once a year in their "agora," or market place. Later, it was held in open theaters and the number of meetings was increased to four per year. In the event of a rain shower the meeting had to be adjourned and everyone scooted for cover. The problem was soon solved by a supreme authority known as the "Archon-Basileus," who ordered the construction of a huge building for the purpose of transacting civil and legal affairs. The Roman counterpart to this structure was first built about 200 B.C. by a high civil officer named Marcus Porcius Cato. He was commonly known as "Cato the Elder." He used public funds to purchase about six buildings, demolished them, and constructed a civil and legal courthouse on the site. The name Basileus was changed to the Latin "basilica" and the structure was called the Basilica Portia after his family name. Many similar structures were built during later years. These included the Basilica Julia by Julius Caesar, and also one by the emperor Trajan. Probably the largest of all basilicas was the one that was started by the emperor Maxentius in 306 A.D. and completed by Constantine a few years later.

Although Constantine's basilica is now in ruins, many of the walls and some of the domed roof sections are still standing. We are told that the architects Bramante and Michelangelo spent a considerable amount of time studying the structural principles of this edifice before finalizing their plans for St. Peter's Basilica in Rome.

20 Years Ago Today

Twenty years ago today, fire broke out at Malden Mills Industries, Inc. The cause was a boiler explosion, which knocked out the sprinkler system. The fire continued well into the next day. About 30 people were injured. Malden's commitment to safety issues and evacuation training yielded excellent results, as there were no fatalities in the huge conflagration.

I had just started my second year working for a trade association that represented American textile mills. Malden Mills was one of our members. The response of the industry was incredible. Malden's competitors, rather than take advantage of Malden's loss by trying to pick up business, actually offered to assist Malden in fulfilling contracts by letting Malden use their facilities to produce fabric so that Malden could return to operation even before rebuilding.

Malden Mills employed more than 1,500 workers at the 2-million-square-foot facility which straddled the Methuen-Lawrence city line in the Merrimac Valley region of Massachusetts. Everyone assumed that Malden's president, Aaron Feuerstein, would take the insurance money and that would be the end of the company, at least as a manufacturer in Massachusetts. If he rebuilt at all, it was assumed it would be elsewhere, perhaps in China.

Feuerstein shocked the business world by declaring, immediately after the fire that he would rebuild, rebuild in Lawrence, and that he would use the insurance money to pay the workers while rebuilding and that they would have jobs. For this he became known as the "Mensch of Malden Mills."

He kept his word. A new Malden Mills, with the latest in new technology, rose on the site where the 19th century mill had stood. The workers were paid. And, to the extent that he could, their jobs were waiting for them when the new plant opened. (Not all 1,500 jobs were preserved, as Feuerstein was forced to recognize that the only way the company could survive was as a smaller operation).

In an interview on CBS's 60 Minutes program, Feuerstein explained that in doing what he did he was simply following the teachings of the Torah — $\,$

"You are not permitted to oppress the working man, because he's poor and he's needy, amongst your brethren and amongst the non-Jew in your community."

Aaron Feuerstein did all he could to save the business and those jobs. Unfortunately, he couldn't do it all. By 2001, the company was bankrupt and he was forced out. The company survived, and was renamed Polartec after its best-known product. There is still production in Lawrence, mostly for the U.S. Department of Defense which requires that clothing for our armed forces be made in America. But much of the rest of their production is in China.

Later this month, Feuerstein will turn 90 years of age. He said recently to a *Boston Globe* reporter; "I go on living with gratitude and humility. I'm happy with my life. I do the best I can."

L'Anno Bello: A Year in Italian Folklore

Embracing the Celebrations of Light

Is there a Christmas symbol more powerful and life-affirming than the light? Everywhere I turn this season, different lights glow in the air around me, each providing a distinctive sensation of the holiday season. When I see the multicolored lights strung around the bushes in the Hilliard's near my home, playfully blinking at me with their bright hues of red and green and

blue, I am filled with a childlike zest for Christmas. These lights remind me of old-fashioned toys and candy canes, chocolate treats and wrapping paper. The golden lights that drip off ceilings are more elegant, reminiscent of a candle's warm heart and the generosity that accompanies the holidays. After all, a candle glowing in the window has long been a sign of hospitality and welcome. Meanwhile, the icy blue lights that adorn trees in some town squares remind me of quiet and snowy winter evenings, as sparkling as Elsa's palace in *Frozen*. Indeed, lights do form a significant aspect of the Christmas season, serving both a religious and symbolic purpose. Religiously, these candles signify the light Jesus brought upon the world at His birth on Christmas. Symbolically, the lights brighten the darkest nights of the year and celebrate the return of the sun after the winter solstice. Two holidays which occur this week, St. Lucy's Day and Hanukkah, incorporate lights as central features of their celebrations, spreading warmth and cheer into the chill wintry air.

St. Lucy's Day, one of my favorite feasts, occurs on December 13th. Known as la Festa di Santa Lucia in Italian, this holiday honors a fourth-century martyr from Syracuse, Sicily. Italians celebrate St. Lucy in varying ways depending on the region. According to a Sicilian legend, St. Lucy once alleviated a famine by sending ships bearing wheat into a port. To commemorate this event, some Sicilians prepare cuccía, a porridge of boiled wheat berries that can be served with honey and ricotta, on the feast day. In the northern areas of Italy, such as Veneto and Friuli, She distributes small gifts to children on the eve of her



donkey and by her assistant Castaldo. The name Lucia stems from the same Latin root as the word light, making her the perfect saint for festivities which take place on one of the darkest nights of the year. Before the calendar reform, December 13th was the winter solstice, a vestige which remains in the Italian proverb Santa Lucia, il giorno piú corto che ci sia ("St. Lucy's Day is the shortest day there is"). Her association with light also explains why St. Lucy is such a popular saint in the Scandinavian countries, where winter darkness can last for the better part of the day. Candlelit St. Lucy's Day processions occur along the streets of major Scandinavian cities, featuring lots of girls dressed like St. Lucy, and boys wearing gingerbread men costumes or conical hats decorated with stars. On the feast of St. Lucy, a daughter in the family wakes up early and dresses in a white robe and a red sash. Sporting a wreath of electric candles on her head, she greets the family at breakfast by serving them hot chocolate and lussekatter, or raisin buns spiced with saffron which infuses a cheerful yellow shade. On St. Lucy's Day, I honor the light breaking through the darkness by baking sweet potato biscuits, which emerge warm from the oven with a beautiful sunny glow.

Hanukkah, a Jewish holiday which begins on December 6th this year and ends on December 14th, also incorporates light into its festivities. Hanukkah celebrates the over twothousand-year-old victory of a Jewish patriotic group known as the Maccabees over the Seleucid Army, which wanted to impose Greek culture and religion on the Jews. When the St. Lucy serves as a gift-bringer. Holy Temple in Jerusalem was rededicated during the revolt, there was only a small supply of festival, accompanied by her oil to light the sacred menorah, or candelabra, in the Temple. Miraculously, however, the oil lasted for eight days, which forms the basis of Hanukkah as an eight-day celebration. Families honor the miracle of the oil by lighting one candle on their own menorahs every night of Hanukkah. Fried food is traditional for Hanukkah because it also commemorates the oil that lighted the Temple's menorah.

These foods can include latkes, which are potato pancakes, and sufganiyot, a jelly-filled donut. Italy is home to a number of old Jewish communities in cities like Rome and Venice, and there Hanukkah is celebrated with beloved traditions and specialty foods. One such food is precipizi, or deep-fried dough balls coated with honey. Golden and warm, the precipizi look like miniature suns, reaffirming the motif of light breaking through the darkness. Italian Jews also popularized frying vegetables, and as such fried artichoke remains a popular Italian Hanukkah dish. I grew up in a town with a large Jewish population, and holiday parties in my elementary school always featured a blend of Christmas and Hanukkah festivities. I remember playing dreidel, a game involving a spinning top and a pile of prizes, with my classmates and accumulating delicious gelt (chocolate coins) wrapped in golden foil, and topping latkes with sour cream and applesauce. It was wonderful to have two great holidays bring my town close together during the dark of winter.

As the winter solstice approaches, the nights get progressively darker, casting a gray gloom earlier and earlier into the afternoon. For this reason, holiday lights play a powerful and heartfelt role in many winter celebrations. Candles illuminate the nights across the world, whether they spring from the crown of a girl dressed as St. Lucy or from a Hanukkah menorah being lit by a family. It is easy to get bogged down in a metaphorical darkness this time of year — not just because of the early sunsets, but because of the stress and depression that sometimes accompany the holiday season. During moments like this, it is important to pay attention to the symbolic lights in our life: family and friends, nourishing food, personal strength, acts of kindness. When we dwell on these aspects, rather than let the darkness get the best of us, we will see that our inner light can outshine anything.

The Dashcam Couldn't Have Looked More Damning

As a police officer for more than 27 years (now retired), I viewed the dash cam video released under a court order to be quite damning of law enforcement in the City of Chicago. In the video, I watched Laquan McDonald walking down the middle of a street waving what reportedly was a three-inch folding knife. Anyone who watched the video felt like they were in the driver's seat of a police cruiser.

As another cruiser approaches from the opposite direction, we see something has gone wrong. One officer gets out and starts shooting at the 17-year-old teen who just drops to the ground ... This officer fired all 16 shots in 17 seconds, killing the subject of the police pursuit. Other officers stood by and took no visible action at that point.

The shooting took place in 2014, and it took until November 25th for that police officer to be charged with first degree murder. The officer continued firing after the subject was down and, as a retired police officer I was sickened by that event captured on video. Before the release of the video, both Mayor Rahm Emanuel and Police Supt. Garry McCarthy said they expected large demonstrations and urged people to avoid violence. Mayor Emanuel said, "It is essential that it [the crowd] remain peaceful."

What happened on that street that night seemed criminal. What was the justification by Chicago City Hall to keep this video secret? What benefit came from their apparent inaction?

As a police officer, my number one job was to provide public safety and the best way to do such is to have the community working with you. That is not what I saw on that video. You can't just shoot somebody and think that is justified. There were at least 7 other officers at the scene, and while they weren't shooting, none moved to stop 16 shots from being fired at a suspect passing by

I never agree with Rev. Jesse Jackson on anything, but I think he is right in calling for a federal investigation, adding that the other officers at the scene took no visible action. Jackson is also right in calling for a special prosecutor to replace Cook County state's attorney who delayed justice in this case for far too long.

Personally, I believe both the mayor and police superintendent have to explain and justify holding back first degree murder charges against a Chicago police officer for over a year. Leaders are supposed to lead.

If I lived in Chicago, I would be ashamed of my political leaders who did nothing for so long and only moved after a judge ordered them to do so.

No wonder many folks in Chicago are so angry. What happened on that video never should have happened, and if it happened, why did it take so long to hold someone responsible for the death of a 17-year-old, regardless of whether he was on PCP

The job of a police officer is to both serve and protect. Sixteen shots in seventeen seconds is unacceptable in America and the City of Chicago.

I will be waiting for his defense attorney to explain away the evidence of the video. Without the pursuit of justice, what do we have?

Well, Chicago Mayor Rahm Emanuel has fired the police superintendent to help ease tensions, but if he really wants to ease tensions he should resign as mayor because the buck stops with the mayor, not the top cop. And as for bringing in former Massachusetts Gov. Deval Patrick to advise a new mayoral task force on the police department, does he really have outside eyes? Deval is not an outsider in Chicago. He came from there and we here in Massachusetts know that fact all too well. Bottom line, the mayor needs to follow his former top cop out the same exit door.

It's Beginning to Look a Lot Like Christmas:

HOLIDAY PET SAFETY

It may only be December 11th, but many of us put our Christmas trees up a week ago. We know the stockings will soon be hung on the mantle, and our homes will slowly turn into a glittery, holiday tinsel town between now and the 25th. Yet, all of the decorations and Christmas festivities bring a whole new world, which can be quite dangerous for your pet to explore. I wanted to bring you a few helpful hints for keeping vour decorations, tree, parties, and gifts safe for your pooch.

DECK THE HALLS

Ribbons, tinsel, bright lights, and foot after foot of electrical cords can transform your pal into a proverbial kid in a candy store. The first thing you need to do to prevent injury, and an electrical fire, is to secure and conceal all electrical cords. If you need a quick fix until you can go out and buy cord covers, tape down the power lines and spritz a citrusy smelling spray in the area. This should hold your dog off for at least a few hours. Next, you need to make sure all decorations are out of your pet's reach. You don't want your pet scratching up your walls or shelves just because she's determined to get at your wreath! If seasonal plants are part of your holiday home décor, be aware of what you use and where you put it. It may surprise you to know that poinsettias aren't as bad as many people think. Your pet will have a bad reaction if he eats the entire plant, but a few leaves won't do much harm.

However, you should be very conscientious about mistletoe, holly, lilies and Christmas roses. Specifically, while mistletoe leads to human holiday romance, it may cause a drop in blood pressure, swollen mouth and throat tissue, and vomiting for your pet. When it comes to lighting the menorah, advent wreath, or decorative candles, keep pets in another room where paws and claws can't reach them.

O CHRISTMAS TREE

Covered in sparkly ornaments and glistening lights, housed over a sea of flashy wrapping paper and taunting bows, your tree is your pet's equivalent to a field of landmines. One wrong move could cause a disaster. To begin, artificial and real pine needles can get lodged in your pet's esophagus. Even if they can manage to get them down, they are impossible to digest.

Artificial snow some spray on their trees can be very poisonous. Even the water beneath the tree can cause diarrhea, mouth sores, vomiting, and loss of appetite. Make sure your tree is on a flat, wide base. Cover the base of your tree well. Forgo the fake snow and vacuum around the tree often. You may also want



to secure your tree with fishing wire tied to the top of the tree and anchored to a curtain rod or wall/ceiling hook. Strategically place your ornaments so your pal can't sit and play with them all day. Also be sure to secure fragile ornaments to prevent them from falling and shattering. If your Christmas spirit overwhelms your ability to restrict your tree-decorating, you may want to purchase a ScaMat Christmas skirt or a Paws Away indoor pet barrier. Finally, keep presents secure in a pet free area. You don't want your pet to rip open everything before Santa arrives!

HOLLY ... JOLLY CHRISTMAS

Your calendar is probably quickly filling up with holiday parties and celebrations. When entertaining guests in your home, it is important to consider your pet in the mix. After all, no one wants to embarrass themselves and their pet with a debut on America's Funniest Home Videos from a holiday party. If your pet is easily excited, or you have guests who may feel anxious around him, you may want to create a safe haven for your pet in another room. You can also use a baby gate to keep him in a certain area, so he can still see you or you can visit him easily during the party. It is also important that your guests know the rules for your pet. You don't want your friends feeding him extra food, or encouraging bad behavior. Don't let them give him any poisonous holiday treats, and keep him out of the eggnog.

Alcohol and pets never mix. It can lead to a coma, respiratory problems, and death. Remember, the more people you have in your home, the greater risk for your pet escaping. Make sure he has proper identification and your contact information in case he does make a run for it!

Enjoy the holiday with your loved ones and friends, and especially your pets.


Did you hear that Baltimore recorded its 300th homicide of the year, up 42 percent from 2014's overall total? The number of killings has surged in the city since it was hit by rioting over the death of a black man in police custody in April.

So what else is new? Lower blood pressure is better. Current blood pressure standards are too high, and aggressively treating people now considered healthy can prevent more heart attacks and strokes and save lives, a new National Institutes of Health study has concluded. Under existing clinical guidelines, healthy adults should have a systolic blood pressure of 140 or lower.

Health scare of the week. Beware! Belly fat, beer belly, spare tires, and love handles. These seemingly innocuous terms are used to describe an extra fat that accumulates around some people's waistlines, but new research suggests so-called central obesity is actually a serious health concern even for people with a "normal" body mass index (BMI). After examining data compiled on 15,184 adults who were followed for an average of 14 years, researchers found that men and women with higher levels of belly fat have a greater risk of death than overweight or obese adults whose fat is more evenly distributed throughout their bodies. One possible explanation is that belly fat is associated with a build-up of deeper visceral fat that wraps around internal organs, increasing the risk for heart attacks and strokes.

It's well established that a sedentary existence is bad for us and that regular exercise promotes better health. Apparently, new research reveals, we don't even have to hit the treadmill to feel

Standing for half of the day reduces the likelihood of obesity among men by 59 percent, compared with 47 percent among women. It's unclear from the data if standing directly reduces obesity risk, or if people who are obese simply stand less.

Rent-a-Mom, A Brooklyn woman began renting "mothering" services to needy hipsters. For \$40 per hour, Nina Keneally will cook meals, go shopping, or offer guilt-free motherly advice to Millennials. "Everybody needs a mom now and then," Keneally said, "but maybe not his or her own mom."

CANNALICCHI "Kanna lee kee" A Sicilian Christmas Fig Cookie

FILLING:

1 pound dried figs

1 cup red wine

1 cup water

1/8 teaspoon black ground

pepper 1/2 cup fine chopped walnuts

Sprinkle of salt

(optional)

DOUGH:

5 cups flour

3 tablespoons sugar

1 egg

1/2 cup vegetable oil

3/4 cup water

DAY 1: Place dried figs in bowl with wine and water to soak overnight. Cover and refrigerate. (Less liquid may be required if you are not using dried figs.)

DAY 2: Chop figs or mince in food processor. Add black pepper, walnuts and mix in bowl.

DOUGH PREPARATION: Place flour, sugar and salt in a 12-inch bowl. Add slightly beaten egg and oil. Add water gradually until mixture holds together. Remove from bowl. Knead to smooth consistency. Cut into four portions. Roll individual portions into long rolls one-inch thick. Cut these rolls into three-inch portions. Place in bowl. Keep covered. With rolling pin, roll each three-inch portion into long strips approximately 1½ inches wide. Place filling in center of strip with teaspoon. Fold sides over. Turn so seam is on bottom. Press to flatten slightly. Cut pieces diagonally about 1 ½ inches long. Longer pieces can be shaped as S's or U's or round-like doughnuts. Slit sides with point of knife before baking. Place on greased cookie sheet and bake in preheated 400°F oven for twenty to twenty-five minutes. Tops will not color much. Bottoms will brown. Cool before storing in a canister.

NOTE: During Christmas week, relatives gathered in one of the homes to make this traditional Christmas cookie. I particularly loved watching my grandmother and Aunt Marianna shape thin rounds of dough with the rolling pin. Then they placed the fig mixture in the center of each round of dough and proceeded to gently pinch pleat the dough around the fig filling. It created a small tart. Not having mastered that procedure, I continue to shape my Cannalicchi as mentioned in the recipe.

Nanna & Babbononno

A Nostalgic Remembrance



When I was a kid, I belonged to the Trinity Neighborhood House, a settlement house located at 406 Meridian Street in the Eagle Hill section of East Boston. The house was built in 1847 for a local businessman named Noah Sturtevant. In 1917, it became the Trinity House, a Red Feather recreation facility and day nursery for locals established by the Trinity Church in Copley Square. In 1966, it merged with the East Boston Social Centers and is now being rehabbed to provide elderly housing for neighborhood folks, but is registered as a landmark, which means that changes to the outside of the building are prohibited. This was within walking distance of Eutaw Street where we lived and I joined the settlement house to learn how to box, make model planes and play basketball. At one point, I even learned how to ballroom dance, but this was years later. They had a Cub Scout group in operation at the center; I joined for a short time, but I had to quit when they told us that we would have to attend a particular Protestant Church that was an affiliate. I wound up joining the Cub Scouts at the Sacred Heart Church which was our parish. Things were a bit restrictive in those days.

Well, it was 1949, and I was making model planes one evening a week, and playing basketball, or boxing on another. When I first started, a man named Mr. Dudley was the director. He was replaced by a local, J.J. Dana, and after a basketball game one night, he informed the teams that the Trinity House was having a children's Christmas party and we were invited to attend with our folks if they could make it. I told my mother and grandparents about the party when I got home, but the date and time conflicted with everything Nanna and my mother would be preparing for Christmas Eve and Christmas day dinners, and Dad would be playing with the band he was with back then.

This left only Babbononno. I asked my grandfather to bring me to the party and he agreed. When I gave him the date and time, he cancelled a trip to whatever social club he frequented on that night and we were set to go. On the night of the party, Babbononno dressed in a suit, shirt, and tie. He always had to look the part which included a spit-shine on his shoes. He supervised my dressing and helped me tie a necktie, fearing that I couldn't make a four-in-hand knot. Once he was satisfied with the way I looked, we headed to

Meridian Street and the Trinity House. When we arrived, we were greeted by Ms. Orr, one of the directors, and Edith DeAngelis, her assistant. (Years later, Dr. Edith DeAngelis would become an advocate for all things East Boston, but that's another story.)

Once inside, there was entertainment and music for us kids, and later, soda and cake. After the treats were consumed, we all sat down and the Gospel according to St. Luke was recited by Ms. Orr as she held a Bible in front of the guests. After, we might hear The Night Before Christmas, by Clement Clarke Moore, or Yes, Virginia, There is a Santa Claus, by Francis P. Church. When the evening came to an end, there was a little gift for each of us that was handed out by Ms. Orr as we exited the building. Babbononno had a sweet tooth and the cake and soda was always to his liking. With him satisfied, I knew that there would be no complaints once we got home.

Around the same time, the Scout Master at the Sacred Heart Church would hold a Christmas party for the kids in the Cub Scouts. His name was Bill McGonagle, and his wife, Mary Jane, was our den mother. I would attend the general party at the church and another party at the McGonagle house which was on Saratoga Street, a few blocks away from Sacred Heart Church. Back then, Christmas time was a busy period for the men in my family. Dad was playing at Santa's Village in the Jordan Marsh Department Store during the afternoons and several parties in the evenings through December 24th. Neither he nor my uncles worked on Christmas Eve. They all had morning jobs on Christmas morning. Uncle Nick played a Christmas party for the kids at the Fernald School in Waltham. They all had special needs, and to him, this was giving back. I don't remember where Uncle Paul played, but he had something every Christmas morning as well. For years, Dad played a Christmas morning party aboard the U.S.S. Vulcan, an aircraft repair ship that was based in Boston. Much of the crew was composed of Bostonians and they and their families attended a Christmas party aboard the ship with good food, good entertainment and a visit from Santa for the children of the men who manned the ship. I often attended the morning party with my father and loved the idea of being on a war ship with the kids of the sailors who manned the vessel.

Later in life, beginning when

I was about 18 or 19, I followed suit. I was in college at the time and often attended class in a tuxedo, carrying my bass violin with me. I wasn't afraid of it being stolen if I left it in my car all morning, but was always worried about the wood cracking in the cold and the strings going out of tune due to the temperature outside the car.

When I began playing for the Ken Reeves Orchestra, we often had several afternoon parties to play, one after another. Most businesses would have parties in their offices for a couple of hours and this was in the day before DJs. Everything was live music. On a given afternoon, I might play a party from 3:00 pm to 5:00 pm and rush to another location and play a second party from 5:30 pm to 7:30 pm. I would then have a half hour to rush to where ever I was playing that night and entertain at another party, or maybe two, if they could be squashed in together without overlapping.

If we had jobs to play on the 24th, Dad, my uncles and I would make sure that they ended before it was time to head home, and have the Christmas Eve fish dinner that my mother and Nanna would prepare. If there were jobs that were booked for Christmas Eve, everyone in the family would have a backup musician who was Jewish, to cover them. They had agreements with Jewish musicians and Dad and my uncles would cover for them on Jewish holidays when work interfered with their religious practices. Things worked out well; back then the Boston's Musicians Union was a combination of Italian and Jewish musicians.

Those days are long gone, but the money I made helped to pay my college tuition. Beyond this, I had fun. Looking back at the first part of the story, I guess I've had fun all of my life — no complaints thus far.



Two weeks ago the Patriots were 10-0 and stood atop both the AFC East division and the AFC standings. Anderson ended the game and the Patriots run at perfection with a 48-yard scamper down the sideline for the decisive six points.

Last Sunday, at Gillette no less, the Patriots dropped a 35-28 decision to the 5-7 Philadelphia Eagles. Yes, the same Eagles that came in on a three game losing streak having lost to the Miami Dolphins, Tampa Bay Buccaneers and Detroit Lions by a combined score of 110-50.

Title is Lost in a Flinch

Klitschko Exhibits a Lack of Basic Boxing Skills While Losing the Title



Klitschko vs. Fury.

Recently, I watched something on television that was billed as being a "fight" for the Heavyweight Championship of the World. Now, there may have been some confusion since the event was being broadcast from Germany and the American commentators said they had no control of the live feed. I am imagining there was also some language barrier. What I witnessed could not have possibly been a match for the Heavyweight title. As a matter of fact, I am not sure what it was I was watching. It certainly wasn't a boxing match. While the names of the contestants were familiar to me, neither of these guys had even the remotest idea of how to box.

Okay, I'm being a bit sarcastic here. But the reality is the bout that took place between Wladimir Klitschko and Tyson Fury was without a doubt the worst title fight in the history of boxing. Neither of these very large men had the skill level of a decent amateur from years ago. Klitschko went into the ring with 67 bouts under his belt, yet he looked like a guy who had just walked into a gym and didn't have the slightest idea of how to box. Fury, with a career consisting of 24 bouts, was just as lacking in talent.

The most obvious example of how truly awful these guys were, was the fact that when Fury would appear to be getting ready to throw a punch (this used to be called feinting), Klitschko would flinch. Instead of attempting to slip and counter the punch, he would close his eyes or just throw up his hands awkwardly out of fear of being hit. He appeared flustered and confused throughout the entire match. Fury was certainly no Gene Tunney. He lumbered around the ring like a guy who had never even seen a boxing match. To call the moves I witnessed amateurish would be an understatement.

When young men have their first experience sparring in a gym, they will quite often close their eyes, or put their heads down when a punch is thrown at them. I can remember the many times I have heard trainers yelling at a young guy, "Don't shut your eyes, you'll get clobbered doing that." It is the most basic of basics when learning to box; you have to stay cool and aware. You have to see the punches in order to counter them and/or block them. Shutting your eyes and flinching make you disoriented. It was truly and utterly amazing to see someone with the amount of bouts Wladimir had doing this.

Some people have said that he lost because he is getting old. He lost because he cannot fight. The fact that he has as many wins as he does speaks volumes about just how bad the heavy-weight division is and has been for years. Fury has no boxing skills either, but just the fact he was moving around the ring a little was enough to completely fluster the champion.

After watching this debacle, I have to say I be-

lieve that Klitschko and Fury are by far the two worst champions in the history of the division. I can't name a past champ, from Larry Holmes to John L. Sullivan, who would have lost to either of these guys.

Listening to the commentators talking about Klitschko possibly beating Joe Louis's record for most title defenses was truly sacrilegious. Just breathing the name Louis in the same sentence with either of these guys is disgraceful and a slander to the memory of perhaps the greatest fighter who ever lived.

Boxing has had its obituary written many times over the years and has always defied the pronouncements of its demise. But today things are different. In the past, boxing was thought to be out because of its being controlled by gangsters, or because of a tragedy in the ring such as the death of Benny Kid Paret, or because a great champion had retired and the successor to the throne was overshadowed by his predecessor.

What is different today is the fact that there are no heavyweights that can fight. They have absolutely no boxing skills whatsoever. Most young fans, having been educated about boxing from watching the endless stream of *Rocky* movies, are completely ignorant about what a real professional heavyweight should look like.

The other night I watched another world title bout. This one was in the middleweight division, between Peter Quillin and Daniel Jacobs. Again, the loser lost because he shut his eyes when a punch was being thrown at him. He clearly saw the punch coming at him and just froze, which led to him being stopped in the first round. This was a former world champ with 31 wins. It was interesting that the commentators used the term flinch to describe what Quillin did. What was surprising is the fact they did not seem surprised that an experienced fighter would do such a ridiculous thing.

I think we will be hearing about more fighters flinching before it is stopped. It doesn't appear it is considered important to teach this most basic of the basics, learning to react to punches, to today's fighters.

Something called boxing will continue to be broadcast on television, and people will pay to watch it. But make no mistake, this is not the sport of Louis, Dempsey, Marciano, Ali, and thousands of others who fought throughout the years. This is an entirely different thing, and it is time to stop pretending any of these so-called boxers would have stood up to those who went before them.

HOOPS and HOCKEY in the HUB

It was almost a year ago that Boston Celtics Director of Basketball Operations Danny Ainge finally pulled the plug and initiated the move that everyone knew was coming—he jettisoned guard Rajon Rondo by trading him to the Dallas Mavericks.

The action really caught no one by surprise. It had been talked about for the better part of 2014. In its NBA preview edition that hit the stands in October of that year, *Sports Illustrated* predicted that Rondo would be gone by the trade deadline in March.

The only think Ainge did was move up the date of the departure — it was December 18, 2014 — and send him to a team owned by one of the more talkative executives in the NBA (Mark Cuban) and coached by a former Celtic — Rick Carlisle.

It was also the last year that Rondo would be under contract to the Celtics. So Ainge sent him on his way for three players (only Jae Crowder is still with the Celts) and some draft picks. Don't cry. He was making somewhere in the neighborhood of \$55 million over the course of a multi-year deal.

The move was also symbolic since Rondo was the last player remaining in Boston from the team that had won the 2008 NBA Championship. The Big Three of Paul Pierce, Kevin Garnett and Ray Allen had already left for other teams, as had Kendrick Perkins, Glenn "Big Baby" Davis and Coach Doc Rivers.


Rondo was only 6-1, meaning that the average man could look him in the eye at press conferences — a rarity in the NBA. But he stood tall in one category that is often overlooked in today's game of NBA giants — assists.

He had mastered the art of the dish off so well that he had led the league in the assist department for three of the last four years prior to the trade and was leading the circuit again when he was sent to the Lone Star State.

When he boarded the plane for Texas, he had played 17,346 minutes for the Celtics over the course of 527 games in which he had scored 5,783 points. He also accumulated 4,474 assists — he was fourth alltime in Celtics history in that category — and had developed a reputation as a highway robber on the court with 990 steals – third on the C's all-time list. Averaged out, his stats included 11.0 points, 7.5 rebounds and 8.5 assists per contest while playing just over eight seasons for the Green.

Still, there was the feeling that the Celtics, in their new configurations without the Big Three, were better off when he was not on the floor. Celtics fans can recall when Rondo was injured during the 2012-2013 season with many feeling that the team played better when he was out.

Once out of Ainge's sight, he was on someone else's mind — that of Carlisle, the mentor of the Mavericks. Over the next several months, the two would fail to be on the same

page numerous times as Dallas media members chronicled how he would differ with the coach on how to run the offense.

In the era of Pierce, Garnett and Allen in Boston, it was Rondo who became the playmaker. The three stars, Coach Doc Rivers and the rest of the team were all on the same page.

However, the Rondo of the Banner 17 team was not in that role as much when playing for Dallas. Things started out OK. In a return to the Garden a scant three weeks after he left, Rondo canned 29 points (including 5 three-pointers) as the Mavs rolled over the Celtics 109-91.

But things changed. Like all coaches, Carlisle had a way he wanted to see things run. Rondo, according to observers, wanted more freedom to be the playmaker. There was a difference of opinion that went public in February and resulted in a one-game suspension.

As time went on, things never really improved. Consider this observation by NBA writer Michael Lee: "After arriving in Dallas averaging a league-leading 10.8 assists, Rondo had only seven double digit assist games with his new team. And in the final 25 games of the regular season, the Mavericks were outscored by 108 points with Rondo on the floor."

The end finally came during a first round playoff series with the Houston Rockets. Rondo performed poorly in Game 3, and when Carlisle was asked if he expected him to ever play for the Mavericks again, the coach said: "No, I don't."

However, in the land of 30 NBA teams, there are always other opportunities. Come summer, Rondo signed a one-year free agent deal with Sacramento for \$9.5 million. Fast forward to December 3rd when the Celtics squared off against the Kings in Mexico City. The new Celtics team topped the Kings 114-97. Rondo was ejected in the third quarter for arguing with an official. He left the court after having contributed five points and eight assists over 24 minutes for his team that is the third worst in the Western Conference after New Orleans and the L.A. Lakers.

Things seem to be following a familiar path. There's already been a meeting this month between Head Coach George Karl, Rondo, and DeMarcus Cousins. Something about the two players wanting the offense slowed down.

There's three quarters of the season left to go. Anyone care to predict what will happen next in the NBA career of Rajon Rondo?
