#### He just wants to be Younger

Former Undisputed Welterweight Champion and Boston favorite son Tony DeMarco was known in his day as an active boxer as having a devastating knockout punch. In 58 victories he kayoed 33 opponents. While he did go the distance on a number of occasions, no fight lasted as long as his wait to be honored with an induction into the International Boxing Hall of Fame in Canastota, NY. Politics and personalities play a role in these things, but Tony is finally being recognized for the great champion he was and is. It is an honor he deserved long ago and, as the saying goes, all good things come to those who

DeMarco will be inducted on the weekend of June 6, 2019. He will now be part of the Hall of Fame that includes his most famous rival and long time friend, the late Carmen Basilio.

DeMarco's boxing career was remarkable. During his 14 years in the professional ring he defeated eight world champions. The biggest of these victories came on the night of April 1, 1955, when he won the welterweight title from champion




# Stirpe Nostra

#### THE ROMAN FUNERAL "PREP"



During the past two issues, we examined the vigil and funeral procession that was generally observed in ancient Greece. This week I thought it might be of interest to outline these same events as they were observed in ancient Rome. I feel it necessary to remind our readers once again, however, the "funus" is the Latin word for rope, cable, or cord. It is also the name that was given to the funeral rites in ancient Rome. Their Latin word "funus," and in turn, our English word "funeral," are both derived from the burial procession during those ancient times which employed twisted ropes that had been smeared with pitch and then used as torches to light the way. Torches were necessary because their funerals took place at night.

Among the Romans, the burial of the dead was a most solemn duty as it was with the Greeks. It was incumbent

upon anyone who found an unburied body to at least cast earth upon it three times. If funeral rites were not performed, the soul of the dead person was believed to wander homelessly upon the earth forever. When a person was on his deathbed a near relative caught the last breath in his own mouth and as soon as death came, the eyes and mouth of the corpse were closed by one of those present. Next came the "conclamatio" a cry or the recall of the dead, by uttering his or her name three times in order to ascertain the fact of death. If there was no answer, then the person was considered officially dead. A parallel custom is still observed at the deathbed of a Pope, but with the addition of a good strong whack on the

Immediately after death, the body was washed with warm water, anointed with perfumes or spices and then clothed in a toga or robe of office, if appropriate. Precious ornaments and rings were often added. The corpse was placed on a couch and then adorned with flowers. Among the Romans as among the Greeks, it was customary to place a small coin in the mouth of the deceased for the purpose of paying Charon's passage money. Charon was the ferryman from mythology who conveyed the dead souls across the River Styx in a lower world called Hades (similar to our Purgatory). In Rome as in Greece, coins have been found in the mouths of many

All of the preparations necessary for the proper laying out of the body were performed by an embalmer. He usually made the original cast of the death mask, but the contract for conducting the entire funeral was made with an undertaker. After the body was properly prepared and adorned, it was laid on a couch of state, generally in the atrium of the domus, with the feet towards the door. Outside of the front door, they placed cypress or pine branches in order to warn those persons who might feel polluted by entering a house in which there was a corpse. Private funerals were conducted by the family of the deceased (funus privatum), or possibly a public funeral was voted by the Senate (funus publicum).

### Saint Marie of the Incarnation

Marie was born Marie Guyart in Tours, France on October 28, 1599. She was the fourth of Florent Guyart and Jeanne Michelet's eight children, from an early age she was drawn to religious liturgy and the sacraments. When Marie was seven years old, she experienced her first mystical encounter with Christ. She said "Yes" to the Lord when she dreamed that he asked her to be His.

At age 17, although she was attracted to cloistered life, she obeyed her parents' wishes and married Claude Martin, a Master Silk worker. He died only two years later leaving Marie a widow at 19 with a six-month-old son, also named Claude. With her husband's death, Marie inherited his failing business, which she then lost. Penniless, she went to live with her family.

In 1621, her brother-in-law asked her to take over the management of his transportation company. She spent her days in a stable in the harbor. It also served as a storehouse and a shelter for longshoremen. She could sometimes be found late into the night at the wharf, supervising the loading and unloading of merchandise.

Her call to religious life pursued her, so in 1631, she asked her sister to look after her son, who was now 12 years old, and she entered the novitiate of the monastery of the Ursulines of Tours. She took the religious name of Marie of the Incarnation. The emotional pain of the separation would remain with both Marie and her son.

In 1633, she experienced a powerful vision, which functioned as the catalyst for her mission to New France. (Canada) On May 4, 1639, Marie and Madeleine de la Peltrie, along with several associates and a Jesuit, set sail from Dieppe, France for Quebec on board the Saint Joseph.

Marie later wrote, "The first thing we did was to kiss the



ground of the place to which we had come to fulfill our lives in the service of God and the Indigenous people." She was never to return to France.

She organized the building of a small monastery for the consecrated community and a boarding school for Indian and French girls whom the Ursulines decided to shelter and educate together. She welcomed and fed the Huron and Algonquin adults who knocked at the door; she gave them Christian instruction and encouraged them to share the Good News with their communities.

She wrote the Constitutions and Rule of the Ursulines of Quebec (1647), and created dictionaries, grammars, catechisms and prayer books in four First Nations languages. Then, at the request of her son, by now a member of the Benedictine Order, she wrote an autobiographical memoir on "her states of prayer and of grace". The experiences she reveals place her among the masters of the spiritual life.

She maintained an ongoing correspondence with her relatives, friends and benefactors in France. Nearly 300 letters have been conserved; they are of great historical and spiritual interest.

Marie died in Quebec on April 30, 1672. She was canonized by Pope Francis on April 3, 2014. The Feast of Saint Marie of the Incarnation, O.S.U., is on April 30<sup>th</sup>.





# DAVID J. GEMELLI

May He Rest In Peace

David J. Gemelli, 71, of Hanover, passed away on Monday, December 10, 2018.

David was the son of the late Joseph and Mary (Ford) Gemelli. He was born in Boston on July 8, 1947.

David graduated from Archbishop Williams High School in 1965. He played football for legendary Coach Armond Colombo. He regarded Coach Colombo as a second father to him and stayed in touch with him for his entire life. Coach Colombo passed away very recently at age 87.

David did a postgraduate year at Choate School in CT and graduated in 1966 and attended University of Vermont and graduated in 1970. He was a member of the football team and ROTC, and Sigma Phi Epsilon fraternity. He had the "David Gemelli Chapter Room" named after him at the Sig Ep house. David recently helped bring back football at UVM on the Club Level after the university dropped the football program in the mid-1970s.

He later attended University of Arizona and graduated with an MBA in 1972. David won a Distinguished Alumni Award in 2006 for his successes in business and dedication to the university. He worked at American Optical Corporation and Polaroid before joining the family business, Gem Gravure, in 1976. David worked alongside his father and Gem founder, Joseph Gemelli, until his passing in 1989. David increased Gem revenues by over 30 times during his tenure with the company, from \$1M annual sales to over \$30M.

David was very active in the Wire & Cable industry and



won just about every award in the industry. He was elected President of Wire Association International (WAI) in 1994 and traveled the globe representing the industry, including trips to China, South America, and all across Europe. He won the Wire and Cable Manufacturers Alliance (WCMA) Distinguished Career Award in 1999 and the Donnellan Award from WAI, given annually to recognize one individual for his contributions to the industry and was honored with a lifetime membership in the WAI.

David was beloved in the industry and was well-known for his generosity, kindness, and dedication to the industry and his many friends and colleagues. He always loved that he was in a position to give people opportunities and help them succeed, it was what he enjoyed most about his career.

David was very involved with the National Italian-American Sports Hall of Fame and was inducted in 2004. He created the Armond Colombo Scholarship Fund at Boston College to honor Coach Colombo and the impact that he had on so many players that he coached.

He was a devoted father and loved following his children's sports pursuits, attending nearly every game, despite his busy travel and professional schedule. Paul played baseball at Trinity College in CT, Brian played football and baseball at Pomfret School in CT. David was a huge sports fan, Gem Gravure has proudly had Red Sox season tickets since 1962, and he has a near encyclopedic knowledge of sports history, especially boxing and football at all levels, high school, college, and pro.

David was the beloved husband of Carol A. (Gagne) Gemelli, devoted father of Brian Gemelli and his wife Amie of Braintree, Elizabeth "Beth" Gemelli of Quincy, Paul Gemelli and his wife Anna of Norwell. Loving grandfather of Evan, Ezra, and Caroline. He was the brother of Nancy Dwyer of Plymouth, Mark Gemelli of Marshfield and the late Diane Kolson. He is also survived by many nieces, nephews, and cousins.

## L'Anno Bello: A Year in Italian Folklore

Evergreens, the Solstice and Christmas Symbolism

Lately, it seems as if the world around me can be defined in terms of light — or, sometimes, lack thereof. When I wake up in the morning, a sky as black as a stormy sea greets me, sending me scuttling towards the comfort of a warm breakfast. During the day, the sun is low in the sky, gracefully sending golden spangles of light through the bare trees. The upcoming winter solstice, after all, serves as the darkest day of the year, when night wraps its cloak around the feeble sunlight of a short day. However, the winter solstice also marks the return of the sun, as after this date the sun will stay for a longer time in the sky. No wonder that so many midwinter festivities, from Christmas to Hanukkah to Kwanzaa, emphasize the theme of light! In preparation for the winter solstice on December 21st, I decided to pay attention to origins of the Christmas symbols and customs that surround us. I found a fascinating tale of history and metaphor, of the yearning for light and eternal life. Below are a number of Christmas customs and their beginnings, in the context of both our Italian heritage and universal human nature:

**Pre-Christmas Holidays:** Historians have identified several ancient feasts that served as symbolic precursors to the secular celebrations of Christmas. Our ancestors in Italy gathered for a wild weeklong festival known as Saturnalia starting on December 17th. This



holiday honored Saturn, the god of agriculture and time. During Saturnalia, slaves and masters exchanged places, a harbinger of the misrule that characterizes that Christmas, New Year and Epiphany traditions to this day. Ancient Romans also exchanged gifts on Saturnalia, a custom which has survived in the modern Christmas. Meanwhile, the people of Northern Europe celebrated a holiday known as Yule. They adorned their homes with greenery as an example of eternal life in the midst of the dark winter, and lit candles not only for warmth but to symbolize the return of the sun after the solstice. We still see greenery and candles in our contemporary Christmas decorations, and we still use the word Yule to describe the Christmas season!

December 25th: In her comprehensive book Encyclopedia of Christmas and New Year's Celebrations, author Tanya Gulevich outlines the fascinating story of how Christmas became associated with the date of December 25th. The earliest Christians did not celebrate Christmas. In fact, though Christmas gets more attention, Easter which honors the Resurrection of Christ, remains the most important holiday in the Church calendar. Christians were observing Epiphany, the day that the Three Kings visited Baby Jesus, before they observed Christmas. The first mention of Christmas falling on December 25th occurs in a calendar from 336 A.D. In the year 350, the Pope officially declared December 25th as the date of the Nativity. Some scholars theorize that this date was chosen to bring a Christian perspective to winter solstice celebrations, as the birth of Jesus symbolically offered a return of light in the world.

**Christmas Trees:** Mention the word "Christmas," and the first image that may pop into your mind is that of an illuminated, beautifully decorated evergreen. Pagan's long venerated trees in the winter. Evergreens were considered symbols for eternal life, as they persisted through the cold, barren winter. Romans even adorned their homes with greenery for the solstice celebration of Saturnalia. The Christmas ornaments hanging from the trees, meanwhile, may derive from the medieval practice of paradise plays. Performed around Christmas, these folk dramas recreated the Biblical tale of Adam and Eve. A tree festooned with apples, symbolizing the Tree of Knowledge in the Garden of Eden, formed the centerpiece of these plays.

Christmas trees didn't catch on in America until people caught wind of the fact that the fashionable Queen Victoria celebrated the holiday with a tree, a remnant of her German heritage. The Christmas tree has spread to Italy as well, where it stands as a well-known holiday decoration and is known as *l'albero di Natale*.

Holly and Mistletoe: Like the Christmas tree, holly speaks to the potent allegory of eternal life around the winter solstice. An evergreen plant, holly was worshipped during the winter by European pagans. It acquired a Christian perspective in the Middle Ages, when its leaves came to symbolize Jesus's thorny crown and the red berries His blood. Meanwhile, mistletoe, a plant sacred to the Celts, also became equated with rebirth due to its status as an evergreen. The custom of kissing under the mistletoe may derive from ancient Scandinavia, where mistletoe served as emblems of peace. According to tradition, enemies who passed each other under a mistletoe branch had to lay down their arms and call a truce. In Italy, holly is known as agrifoglio and decorates homes for Christmas and New Year's. Misteltoe, or vischio in Italian, holds a special place in the country's culture because it was the fabled "Golden Bough" the mythological figure Aeneas needed in order to placate the gods during his journey into the underworld.

Yule Log: There is nothing like a warm, crackling log on the fire to conjure images of a cozy, joyous holiday. However, the yule log's origins are enshrouded in mystery. Ostensibly it derives from the Germanic Yule celebrations, the feast celebrating the winter solstice in which greenery and fire were brought indoors to form a literal and symbolic barrier against the cold air. Yule log traditions vary across the world. The English hold a plethora of superstitions around the Yule log, such as one which states that bad luck will follow if the Yule log is extinguished before the night, or that log contains healing properties. The French eat buche de Noel, or a sponge cake shaped like a log, during their Christmas Eve dinner. In Italy, the Yule log is called il ceppo di Natale and is blessed with prayers and songs.

The Christmas traditions which surround us burst with rich symbolism and complex spiritual significance. They remind us of the comfort and joy which characterizes the holidays and link us to the universal hopes and desires of our ancestors. These customs tell us that though the nights around the solstice appear dark and gray, the love of family and of our shared humanity ignites the most brilliant light of all. This season, be sure to view the ubiquitous symbols of Christmas with new eyes, and spread the love of the holidays to all you encounter!

# Nanna & Babbononno

A Nostalgic Remembrance



Each year at about this time, Dad would say to me, "What the heck am I going to get your mother for Christmas?" Mom was fussy. She never liked fur coats or really fancy clothes, but she did like jewelry. Uncle Nick was the guy to talk to about jewelry as he had several contacts in the business. How this came about was due to the GI Bill that he took advantage of.

As WWII ended, Uncle Nick was discharged from the navy and decided to use the Bill and get himself an educational. He had heard that the North Bennett Street School in the North End, the oldest trade school in the country, had courses on watch making and watch repair. Once trained, he made several contacts in the jewelry business but never spent more than spare time in it as he ran for office in the Musicians' Union and became the vice president, a position he would hold for about 25 years.

When Dad and I approached him about both of us buying jewelry for Mom for Christmas, he brought us to 333 Washington, the best known Jewelry Exchange in Boston at that time. Daniel Seidler was the company he was involved with and introduced us to Jack and Fred Seidler, the sons of the man whose name was on the door. Fred waited on us with enthusiasm as he was a close friend of Uncle Nick's and had assured him that anyone in our family would receive a good discount if they purchased jewelry or silverware from him

We discussed Mom's tastes with Fred Seidler and the tail end of the conversation revealed to us that Mom didn't have a charm bracelet, something that was very popular back in the day. Dad and I looked over several designs and decided on one that was rather nice. Dad added the first charm to the bracelet and I picked out one that would be my present to my mother and her second charm. Uncle Nick then picked out the third one and told us that it would be his and Aunt Dorothy's Christmas present to my mother.

The price was at a whole level, as Fred Seidler cut the profit down to a minimum. We were happy and the card that was added into the box explained everything. The one thing I didn't mention was that all of the charms were gold copies of musical instruments. Mom was the daughter of a musician (Babbononno), the sister of two musicians (Uncles Paul and Nick), the wife of a musician (my Dad), and the mother of a fledgling musician (me). We thought that, considering the circumstance, she would like a charm bracelet with musical instruments dangling from it. We were right, and it would give us good cause to add more instruments when her birthday rolled around.

After the present was wrapped, Fred Seidler engaged me in conversation as he was curious about his friend Nick's

nephew-Godson. Fred was a short round well dressed man with a constant smile on his face. His end of the conversation was mainly questions as to my status in life. I told him that I was a freshman in college, worked in a movie theater, studied music from family members and was going to be a bass player like my father, and played baseball in the spring and summer. Before the conversation ended, Fred Seidler gave me an offer that seemed to fit right into my schedule. He asked, "How would you like to fill your briefcase with jewelry and sell what you have on campus. You could take the stuff on consignment with a knowledge of the prices I will charge you. You can add on whatever you want as your commission, let's say, and we will all make a little money." As I thought about it, what came to mind was the amount of students I ran into at Boston State that asked me for the time or for a light when we were on a break in the smoking lounge. I told Fred that I would like to start out with a variety of lighters and inexpensive watches for both men and women. Most of what they sold at Seidler's was high end, but they did have several brands of imported watches that were inexpensive and a good array of lighters including a new type that was electronic. Fred priced each item that I picked and told me how much to add on for a profit and still keep the prices lower than the retail stores. He then found an old jewelry case and placed all of the items in it, roughly 20 watches, 10 men's and 10 women's, and about the same number of lighters. He added in two identical watches, one made out of stainless steel and the other gold plated. They were as thin as a silver dollar, which back in the day indicated an expensive time piece. He then said, "You wear these, alternating each day. One picture is worth a thousand words. He then had a lighter engraved with my initials on it and told me to use only it when I lit someone's cigarette. When I asked what I owed for my two new watches and the lighter His answer was, "Not much, but I'll let you know later."

When I was back on campus, I wore the watches and carried my monogrammed lighter. When my fellow students commented, I showed them what was in my brief case. Before that week was over, I had sold everything I had, wholesale, but returned home with a pretty good profit. This new venture would continue throughout my college career and I even thought about going into the jewelry business when I graduated. Back at the Seville Theater, by that Christmas, every usher and candy girl had a new watch or and lighter. Some even bought their parents, siblings or significant others their presents from me. A year or so later, after I became a professional musician, I began taking a briefcase filled with

watches and lighters to the jobs I played, just in case the other musicians might have needs or wants.

As time went on, Fred Seidler's health headed down hill and he wasn't at the helm of his business more than a couple of days per week. His brother, Jack, passed away suddenly and their sons and sons-inlaw took over. They were not as friendly as Freddy had been and sort of resented me being involved in the business. As a result, I would call and ask for Fred. If he was in, I would speak to him and discuss my needs. He would put things together and I would pick them up on that same day while he was there. No one was going to go against him when he was there and things worked out for me to my liking. After graduation three years later, something had to go. I began teaching, was playing music at night and continued working at the Seville Theater whenever I could fit it in. The first thing to go was the jewelry business, and after ten years, the job at the Seville. As a young adult, I narrowed things down to teaching in Boston and playing music at night. I would continue with both careers and add in several other aspects of show business for the next few

decades of my life. That Christmas, when Mom saw the charm bracelet, she fell in love with it. ## Recipes from the Homeland

#### CANNALICCHI A Sicilian Christmas Fig Cookie

DOUGH:

5 cups flour

3/4 cup water

3 tablespoons sugar

1/2 cup vegetable oil

FILLING: 1 pound dried figs

1 cup red wine

1 cup water

1/8 teaspoon black ground

1/2 cup fine chopped walnuts (optional)

Sprinkle of salt

Preheat oven to 400°F.

DAY 1: Place dried figs in bowl with wine and water to soak overnight. Cover and refrigerate. (Less liquid may be required if you are not using dried figs.)

**DAY 2:** Chop figs or mince in food processor. Add black pepper, walnuts and mix in bowl.

DOUGH PREPARATION: Place flour, sugar and salt in a 12-inch bowl. Add slightly beaten egg and oil. Add water gradually until mixture holds together. Remove from bowl. Knead to smooth consistency. Cut into four portions. Roll individual portions into long rolls one-inch thick. Cut these rolls into three-inch portions. Place in bowl. Keep covered. With rolling pin, roll each three-inch portion into long strips approximately 11/2 inches wide. Place filling in center of strip with teaspoon. Fold sides over. Turn so seam is on bottom. Press to flatten slightly. Cut pieces diagonally about 1 ½ inches long. Longer pieces can be shaped as S's or U's or round-like doughnuts. Slit sides with point of knife before baking. Place on greased cookie sheet and bake in 400°F oven for twenty to twenty-five minutes. Tops will not color much. Bottoms will brown. Cool before storing in a canister.

NOTE: During Christmas week, relatives gathered in one of the homes to make this traditional Christmas cookie. I particularly loved watching my grandmother and Aunt Marianna shape thin rounds of dough with the rolling pin. Then they placed the fig mixture in the center of each round of dough and proceeded to gently pinch pleat the dough around the fig filling. It created a small tart. Not having mastered that procedure, I continue to shape my Cannalicchi as mentioned in the recipe.






DeMarco became friends and remained close until Basilio's death in 2012.

It is important to remember that when DeMarco was champion there were only 8 recognized divisions with one champion in each of those different weight classes. In contrast to today when it seems like anybody with a couple of pro fights is called champion, Tony DeMarco was truly a world champion.

Tony DeMarco was born January 14, 1932, on Fleet Street in Boston's North End. His original name was Leonardo Liotta. He changed it so he could fight in the amateurs. He was too young at the time to compete as an amateur boxer, so he borrowed the name of a boy who was old enough. The name stuck and he continued using it for the rest of his life.

In a professional career that spanned the years from 1948 to 1962, the "Fury of Fleet Street" compiled a record of 58 wins, 12 losses, and 1 draw. Among his opponents, you will see listed, in addition to Basilio and Saxton, the names Johnny Cesario, George Araujo, Jimmy Carter, Chico Vejar, Vince Martinez, Gaspar Ortega, Denny Moyer, Don Jordan, Walter Byers, and Kid Gavilan. Pretty amazing array of talent, and that's just part of the list. With a pulverizing left hook, DeMarco was never in a dull fight. A Tony DeMarco fight was always an electrifying experience.

In 1962, DeMarco retired. For a time he lived in Phoenix, Arizona where he ran a successful night club. He later returned to Boston where he still lives with his lovely wife and best friend Dottie, not far from where he won the title. In 2011 his autobiography, Nardo: Memoirs of a Boxing Champion, was pub-

lished. If you haven't yet read it I urge you to get a copy. It is a fascinating story.

Fleet Street has been renamed Tony DeMarco Way in his honor. On October 20, 2012 a statue of Tony was erected at the corner of Hanover and Cross Streets, the entrance to the North End. The beautiful statue represents just how well loved and respected he is by the people of Boston.

The main criteria for induction into the Hall of Fame is a fighter's record in the ring. By that standard alone DeMarco should have been inducted years ago. But there is more to being a champion than wins in the ring. A true champion also knows how to carry himself with dignity and a strong measure of character. Tony DeMarco passes this test with flying colors. He has never forgotten where he came from. He greets everyone he meets with a warm smile and is quick to answer questions and to share stories of his long and remarkable life. For a man who has received so many honor and accolades, he has never allowed it to go to his head. DeMarco is always DeMarco.

On January 14th, Tony De-Marco will turn 87 years old. The honor of being inducted into the Hall of Fame will be a great



## HOOPS and HOCKEY in the HUB



WINNING DOES WONDERS Sometimes, it is worthwhile reflecting on what winning does for a team. It is like an elixir, a tonic that supplies the dosage for an immediate recovery. When one is well, there are smiles all around as health is restored. The days of coping with a malady can be brushed aside, banished to the background of our thoughts or almost completely hidden by the euphoria of present pleasures.

Thus, it was for the Bruins in the first portion of December as the team put together a threegame win streak, all without the services of stars such as Patrice Bergeron and Zdeno Chara. A three-game losing streak was broken and replaced by a trio of triumphs.

"It can go in a hurry," noted head coach Bruce Cassidy in a nod to realism when he spoke about how things were before the recent spate of success took hold.

Someone said to me that after three (losses), like three can turn into five or six, right? Then all bets are off and it is panic mode. I think our guys recognized that we had to bear down in the home game against Toronto. We were at home against a team that we've played well in this building so it started then. We then built off of that against Ottawa."

Cassidy was especially pleased with the third win the one against Arizona at the Garden. That contest saw the B's sink into a 2-0 hole after the first period before turning on the scoring jets in the second.

In the space of four minutes and 50 seconds the Black and Gold tallied four goals to take a 4-2 lead. They would eventually emerge as 4-3 victors, increasing their record to 4-5-1 in games where they trailed after the first period. It was Arizona's third loss of the season when the Coyotes led after the first period.

"Our better players turned it on in the second period," said the coach. "The losing streak is in the rear view mirror a little bit. It means you're enjoying your time at the rink a little more and not squeezing the stick as much. So that's what we're hoping now — that our scoring continues to build. When you're not getting it and you're losing, you hear about it more. When you're not getting it and you're winning, well, you have a little more patience."

It was the 14th win in a row for the Bruins over Arizona. It is the longest active win streak by any NHL team against a single opponent. You have to go back over eight years — to October 9, 2010 — to arrive at the last time the Bruins lost (5-2) to Arizona.

The triumph increased the B's home record to 11-3-0. It is a mark that served to somewhat offset their pedestrian road ledger of 6-7-4. It was the 31st game of the season, meaning that the NHL is now in the second third of the 2018-2019 schedule.

Although there is a lot of hockey left, it is debatable as to whether the Bruins will be able to catch red-hot Tampa Bay, the Atlantic Division and Eastern Conference leader. As

of December 12th, the B's trailed the Lightning by 11 points but had a stat for many in the NHL to envy. They had allowed the fewest goals in the Eastern Conference this season (79), only one more than Western Conference teams Dallas and Nashville who had yielded 78.

In fact, if the B's were in the Metropolitan Division, they'd be challenging for the lead right now, just a point behind Washington. But the weakness of the Metropolitan group does hold a silver lining for the Bruins. It means that even if they don't qualify for one of three automatic playoff berths allotted to the Atlantic Division, they will probably get in via one of the two Eastern Conference wild card slots.

An example of just how perilous the game of hockey can be was unfortunately on display in the game against Arizona when B's forward David Backes was struck in the face by a skate with just over three minutes left in the first period.

Backes immediately went to the locker room for medical attention but later returned to action. It was another testament to the will of hockey players to play through pain and injuries — more so than athletes in any other sport we've covered over the decades.

But it was also scary. The injury was just a bit below the bottom of the visor.

"I didn't know what happened at first but the way he came off you figured it was worse than a high stick," said Coach Cassidy. Those are tough, up around your eyes, too. But he was able to play through it."

It was another example, though, of why full facial protection — as is the rule in youth leagues, high school and college — might be the way to go. At the very least, it goes a long way towards preventing an injury — and perhaps a lifelong scar — to the face. To make matters worse, about three dozen players in the NHL still choose to go without any facial protection, not even a visor. What a chance they are taking.

A couple of big home games are on the horizon for the B's — a December 22<sup>nd</sup> contest at the Garden against Western Conference leader Nashville and a January 3<sup>rd</sup> matchup with the Calgary Flame — the Pacific Division leaders.

The iron men so far for the Bruins this season include Brad Marchand, David Krejci, and David Pastrnak. Those three have played in all 31 games through December 12th. Marchand was the penalty minutes leader with 74 while Matt Grzelcyk was a distance second with 38 and Chris Wagner had

Provided that the December 16 home game against the Buffalo Sabres is a sellout (17,565), it will mark the 400th consecutive sold out home game (regular season and playoffs) — a streak that that dates back to December 5, 2009 against Ottawa. The last nonsellout game at the Garden came on December 2, 2009 — a Wednesday night game against Tampa Bay.
