

Stirpe Nostra

AURELIUS THE EMPEROR

After he was adopted into the imperial household, Marcus' respect for his relatives, friends and finances remained unchanged. Hadrian died about six years later, leaving Antoninus Pius as heir to the throne. This is the time when Marcus worked very closely with the new emperor, did a tremendous amount of work for him, but still found time for his studies. Marcus soon married Faustina, the daughter of Antoninus Pius instead of Hadrian's granddaughter. In spite of Faustina's extravagance and recklessness, he highly praised her obedience, simplicity and affection.

Pius ruled for 23 years and when he saw that his end was drawing near he called his chief magistrates and friends around him and formally named Marcus Aurelius as his successor in the empire. He ordered that the golden statue of Fortune, which he normally kept in his own chamber, be transferred to that of Marcus, uttered the famous "Aequanimitas" to the Tribune of the night watch, and then expired.

Marcus Aurelius was now forced by the Senate to assume the office of emperor. One of his first acts was to name an adopted brother as his colleague in the empire. He gave his colleague the name of Lucius Aurelius Verus Commodus, but also bestowed upon him the titles of Caesar and Augustus, however, history records him as just plain Lucius Verus. This was the first time in history when two adopted brothers sat in joint rule of the Roman Empire.

Having taken care of all preliminary matters with the Senate, the two rulers set out for the Praetorian Camp where they promised 20,000 sesterces apiece (about \$1,000) to the common soldiers and a proportionately larger amount to the officers. The joint rulers acted in such democratic fashion that even the lenient manner of Pius was not missed. Marcus pursued his philosophical interests while at the same time he cultivated the goodwill of the people.

Mother nature always has been able to find some way to disrupt any form of national tranquility; the time of Marcus and Verus was no exception. A flood of the Tiber River, probably the most severe of their time, ruined houses, drowned animals, and caused widespread famine. The joint emperors helped to alleviate the pain and suffering by their own personal financial aid. A volatile situation in Parthia now erupted into a full scale war, hostilities threatened to break out in Britain, and forces of the Catti tribes invaded Germany. Agricola, an excellent general, was sent to Britain, General Victorinus repelled the Catti, but the Parthian war became the personal concern of brother Verus. Marcus kept watch over the administration of the empire while Verus was successful in the prosecution of the war. At the end of hostilities each emperor was voted the name "Parthicus" and later "Father of His Country."

THE WAR ON CHRISTIANITY IS REAL AND MUST BE DEFEATED

That the war on Christianity is in full bloom is indisputable. The enemies of Christ know that to succeed in establishing a Socialistic form of government where they will have total power over the people, they must destroy the people's faith in God.

SHERIFF CABRAL SPEAKS ABOUT WOMEN IN LEADERSHIP, POLITICS

Sheriff Andrea J. Cabral recently lent her support to two events created with the intent to encourage increased participation by women in politics and roles of leadership.

Taking part in a panel assembled by the Massachusetts Women's Political Caucus and titled, "Building the Pipeline: Women at All Levels of Government", Sheriff Cabral joined with Massachusetts State Auditor Suzanne Bump and State Representative Shaunna O'Connell to deliver on the day's message.

Presented as a quarterly breakfast series, Massachusetts Women's Political Caucus panels feature "outstanding elected officials, community leaders, or political activists who have made great advances in promoting the participation of women in the political process." The breakfast is also utilized as a networking event that brings together the organization's membership with inspiring speakers to engage in conversation about increasing political participation of women throughout the ranks of government.

THE DODD-FRANK BILL

chill hiring in the private sector and fill the seats with thousands of bureaucrats. The bill was signed into law last year as the government was hiring thousands more bureaucrats and it resulted in the biggest rewrite of financial legislation since the New Deal. It was intended to reign in Wall Street excess, but the banking industry says red tape is hurting economic growth and an already sluggish job growth environment with 29 million less jobs being created. Dodd-Frank has resulted in 2,300 pages of proposed and final rules which would exceed the height of New York's Empire State Building five times over. One-fourth of the laws have gone into effect so far, yet have imposed 20 million hours of paperwork on U.S. businesses. It took an estimated 20 million man hours in con-

The Dodd-Frank bill could tracts to build every iPhone. In the boom to lawyers, fewer loans get made. Banks have laid off thousands of people to raise revenue to net higher capital reserves mandated by law. In the end it means fewer loans get made, it's a boon to lawyers and government workers and a cost to tax payers of \$1.3 billion. It will eventually cost American workers until they can navigate through this maze of regulations and a loss of hundreds of thousands of workers in the financial sector. German Chancellor Angela Market French President Sarkozy agreed to a Euro zone that requires members to ask permission rather than beg for forgiveness, but the proposal would take months to satisfy while the bond market can spike in hours or even minutes. That means the European Central Bank may have to start

large-scale bond purchases to keep the debt crisis under control before countries have formally committed to any changes. The "Merkozy" deal and Italy's new austerity plan pushed yields down on Spanish, French and Italian bonds. US stocks rallied on the news and put 15 euro nations on credit, including AAA Germany and AAA France. That suggests a 50% chance of a downgrade within 90 days. Dollar General notched a new closing high in huge volume as Dollar General is breaking out of a flat base. The retailer's earnings hit a new high in volume as it hoisted its full year outlook and breaking out of a flat base. Analysts expect flat earnings for the current

MAKE TIME FOR FRIENDS THIS CHRISTMAS





Saint John of the Cross

by Bennett Molinari and Richard Molinari

John de Yepes was born at Hontoveros, Old Castile, Spain on June 24, 1542. He was the youngest child of Gonzalo de Yepes and Catherine Alvarez. His father gave up wealth, status, and comfort when he married a weaver's daughter and was disowned by his noble family. After his father died, his mother kept the destitute family together as they homeless wandered search of work.

John was sent to the school for the poor at Medina del Campo, where the family had gone to live, and he proved to be a good student. He worked for seven years in a hospital for the poor while attending a school established by the Jesuits. John was inspired in prayer to serve God in a religious order that he would reform. He joined the Carmelites and received the habit on February 24, 1563, taking the



name John of St. Matthias.

After profession he obtained permission from his superiors to follow to the letter the original Carmelite rule without the modifications that had accumulated through the years. He was sent to Salamanca for the studies, and was ordained a priest in 1567. Shortly after his ordination, he considered joining

Carthusians, however, before taking any further action he made the acquaintance of St. Teresa, who had come to Medina to fund a convent of nuns, and who persuaded him to remain in the Carmelite Order and to assist her in the establishment of a monastery of Discalced Carmelite friars at Duruelo, Spain based on the ancient rule.

John of the Cross, as he now called himself, became the first master of novices. He filled various posts in different places until St. Teresa called him to Avila as director and confessor to the convent of the Incarnation, of which she had been appointed prioress. He remained there for over five years.

St. John was ordered by his provincial to return to the house of his profession

No Post Office? No Saturday mail delivery? No assurance of first-class mail reaching our mail boxes or getting checks or letters across town or to their destinations? Is this nation I awoke in early this morning still the United States of America?

What we're witnessing is the dangerous decimation of not a mere daily convenience. Rather, the United States Postal Service is still the lifeblood of millions of Americans of all walks of life. A recent factoid in The Washington Post shows that 40 percent of the world's mail is delivered by the USPS to 150 million homes and businesses.

No corner mail box for my 84-year-old next door neighbor and a trio of 90-something neighbors is time for panic. Their daily walk to the corner keeps them active and vibrant as that grand ritual keeps their bodies in motion. Gives them purpose and an outdoor occasion they look forward to. That blocklong walk or 'round the corner trek is a regular happening they've lived by their entire lives. Greeting your familiar postal carrier is akin to seeing family. Mail delivery is simply a way of

Recent decisions by the officials in charge of daily operating the Postal Service are gloom and doom at best. No, the woes of the Postal Service didn't hit overnight,

or the past decade. These troubles were long in the making and easily correctable. At worst, our elective public servants in Congress sat silently as matters worsened.

That shameful inaction cannot be comprehended by millions of Americans who still daily depend on the service to conduct their affairs. Medications are delivered via the Postal Service. Many recipients of Social Security prefer to get their monthly checks in their mail boxes. And, yes, they still put postage stamps on envelopes to pay bills or send letters or Christmas cards. Those are a few essential reasons for keeping mail delivery to our homes and businesses that we know it's reliable and efficient despite the Internet age.

Villages and small towns will be hardest hit by the decision to close 3,700 post offices and slash 28,000 jobs by next spring. That decision alone is even more absurd than the closure of too many U.S. military bases around the nation in the 1990s.

Rural areas will suffer immeasurably as they struggle to receive and send mail. Hours of traveling to the nearest Post Office is disheartening to merely ponder. Importance of community will be lost. Urban neighborhoods will also lose a large part of their identity without a Post Office nearby. In times of national emergency the Postal Service must be available when planes are grounded. Communicating via the Internet or Twitter could be affected. So, the seeming outmoded method of communicating is still relevant within the latter possible scenarios. Add in the factor that many older folks lack the skills to operate a computer, don't own one, and care less to learn

how to navigate cyberspace. Saving the United States Postal Service is not only about jobs and pensions. After all, its \$8 billion dollar debt is the result of Congress demanding five years ago the Postal Service cover 75 years of its retiree fund within 10 years. Where does such suspect wisdom derive from? Stop playing politics with peoples' lives and get smart!

The Postal Service has thrived despite challenges in the past. For example, the advent of the telephone in the 19th century threatened its viability, invention of the Fax machine in the 1950s, and nowadays the Internet has spouted forth the sureas-hell death knell to the USPS. Each time its resiliency prevailed.

Now it's all up to members of Congress to recognize their constitutional obligation to continue to safeguard the public trust. Do the right thing by building up, not tearing down, a worthy and worthwhile institution that Americans need and want.





After more than two decades, Governor Deval Patrick on November 22 signed a gaming bill that will permit up to three full-scale casinos in different regions of the state plus a single slot machine-only facility. Intended to bring jobs to the Bay State and provide new revenues for state and local government, the law starts a process to create a powerful new state agency that will be charged with licensing and overseeing new gaming operations. The signing of the law also marks the start

The three regions of the state where a fullscale casino could be located are the following: the five eastern counties (Suffolk, Middlesex, Essex, Norfolk and Worcester), Massachusetts (Hampshire, Hampden, Franklin and Berkshire counties), and the southeastern part of the state (Bristol, Plymouth, Nantucket, Dukes and Barnstable counties). The law creates more than a dozen new special purpose funds to receive a portion of license fees and taxes on casino profits, including a number of funds to benefit cities and towns.

Recipes from the Homeland

SICILIAN GREEN OLIVE SALAD

- 1 jar Sicilian green olives*
- 2 stalks celery chopped
- 1 large onion chopped 1 large garlic clove minced
- 1 tablespoon oregano
- 2 tablespoons olive, canola, or vegetable oil
- 2 tablespoons cider vinegar

*Sicilian green olives are not usually found pitted. To pit olives, use a paring knife to cut olive meat from olive pit. Another method is to place each olive, one by one, on a cutting board. Using a wooden mallet, hit the olive so that the meat separates and exposes the olive pit. Place olive meat in a large bowl.

Add chopped celery, onion and minced garlic to the olives and mix. Sprinkle oregano, oil and cider vinegar over the mixture and mix thoroughly. Additional oregano, oil, vinegar or salt may be added. When kept in a clean covered jar or bowl this salad stores well for a lengthy time in refrigerator. This salad is ready for serving within thirty minutes of preparation.

NOTE: In my childhood, I remember my father buying a large wooden box of shinny light green olives from the produce market. The large quantity was to be shared with aunts who lived nearby. The women knew how much water and salt were needed to soak the olives and how long before they could be ready for this special Sicilian salad.

In 1931, when my parents took the family to Sicily to meet our paternal grandmother, my brother Peter and I had the privilege of going to the olive groves with our relatives to harvest olives. As a six-year-old, I thought of it as a picnic day under the beautiful but old craggy-looking olive trees. We ate lunch and stayed most of the day before returning in the horse-drawn carts. Another day, Papa and his brother-in-law, Uncle Nino, took us to a processing plant near their hometown. There we saw olives that had been crushed, processed and stored in huge containers. The scent of olive oil was so strong in that small, cold processing plant that it made my eyes tear. I wanted to rush out into the fresh air. My love for the green olives and the olive oil extracted from them grew from that experience.



Nanna & Babbononno

A Nostalgic Remembrance

Christmas is coming and I'm going to hold up on my story about a trip to Italy for the next couple of weeks. I have many fond memories about celebrating Christmas when I was a kid growing up in East Boston. Preparations for Christmas Eve and Christmas Day would begin long before the 24th and 25th of December would arrive. Most of the preparation was done by Nanna, Babbononno and my mother. The men in my family were musicians and Christmas time was their busiest season of the year. Back then, it was live music for every event. There were no such things as DJs playing records, tapes or CDs. My uncles were sax players and Dad played bass violin, and were among the best in Boston. As a result, they worked morning, noon and night playing Christmas parties at this time of year. For years, Dad played at Santa's Enchanted Village in Jordan Marsh, entertaining the kids who were there to see Santa Claus.

The preparations for Christmas Eve fell mainly on Babbononno. It is traditional that Italians celebrate Christmas Eve with a dinner that consists of seven fish courses. Babbononno used to say that seven was the minimum and that you could have any number of offerings as long as it was an odd number, seven, nine, eleven, etc... Nanna often bought the common types of fish at Faber's Fish Market on Brooks Street in East Boston, but Babbononno insisted that he could only get the specialty items at Giuffre's in the North End. Faber's didn't sell eels, snails, scungili, quahogs, razor clams and mussels, but Giuffre did. Walking in the front door, you had to pass several galvanized tubs filled with water. Some had bacala soaking in them and the others had eels swimming aimlessly in oval patterns around the inside of the tubs. Babbononno would buy his share of these specialty items, leave the bags with the salesperson that waited on us and we would head into the North End to visit his friends. When it was time to return home, we would make a detour into the midst of the pushcarts and he would buy a few more specialty items that, according to him, could only be purchased in the North End.

At about the same time, there had to be a visit to see Santa. Mom would take me into Boston and head for Jordan Marsh. There were Santa Clauses at other department stores, but Mom used to say that they were helpers for the real Santa. The Real Santa was only to be found at Jordan's. Of course, there would be the annual visit to the toy department. I think it was either the 4th or 5^{th} floor of the main building on Washington and Summer Streets. Quite often, we were accompanied by her favorite cousin, Louise Pepe and her two sons, Anthony and Ralph. At other times, we would be accompanied by Grace Manfredonia and the first three of her four children, John, Fred and Adelaide.

Whichever the case, the first stop would be at the electric train display. I have not seen anything like it since. One whole section of the toy department would be

designed as a town somewhere in the U.S., with business buildings, schools, churches, snow covered hills, frozen ponds with skaters, and train stations with bill boards advertising the products of the day. Moving around the perimeter and through the middle of the display were several sets of electric trains, most of them Lionel, with a couple made by American Flyer. Many of the cars dumped coal, picked up milk cans, deposited lumber and displayed passengers through illuminated windows. All the while, the engines puffed white smoke which was supposed to resemble steam and they whistled as they passed several points in the

When we had had our fill of trains, it would be time to head to look at the model airplanes, most of them being World War II aircraft. I was a model maker and had wooden models that I made, most of them purchased at a local hobby store in East Boston. Jordan Marsh had models made by Strombecker. These were the Cadillacs of models, and I would tell Mom which ones I was going to ask Santa for.

Next, we would visit the Erector Set display or the Gilbert science displays and marvel at the things that could be made by kids by just owning their latest sets of materials necessary to construct or invent. Before heading to see Santa, I always wanted to look at the latest in baseball equipment. There would be uniforms identical to the ones worn by members of the Red Sox or the long-gone Boston Braves. One of the few foreign uniforms I remember was that of the Brooklyn Dodgers, but after a quick glance, it was time to check out the latest in bats and gloves.

When our mothers deemed it necessary to heard us into the Santa line, we would head for a group of kids standing in single file with snow suits hanging from their bodies. Unlike most kids, we were dressed with shirts, ties, coats, hats and gloves, all looking like miniature businessmen. The discussions with Santa would be abbreviated and right to the point. He would ask our names and then question us as to what we wanted him to bring us. Of course, we would ask for everything we saw in the store, and quite often, Santa's reply would be a bit nebulous, with him saying he would see what he could do.

The next part of the day found us heading to a restaurant for lunch. Mom knew the places on either Tremont or Boylston Street and while we ate, we kids would discuss what we had seen and what we had asked Santa for. Once we were back home, Mom and Nanna would continue to plan out the menus for both Christmas Eve and Christmas Day.

There were no supermarkets back then and a shopping trip to pick up the necessities for a holiday table meant visiting specialty stores, a butcher shop for meats, a fish store for sea food, a green grocer for fruits and vegetables, an Italian specialty store for cold cuts, cheeses and exotic Italian delicacies. Butter and eggs were purchased at Kennedy's on Bennington Street and bread at either LaCarcia's. Blundo's or Umana's bakeries.

No one drank bottled wine. Someone in the neighborhood made wines, both red and white, and most Italians had their favorite vintner from whom they bought wine. For Babbononno, it was his brother-in-law, Nanna's brother Zi'Antonio Ceruolo. According to my grandfather, he was the best winemaker in the world.

My uncles and father lived in their tuxedoes during Christmas, playing several office parties during the day and early evenings and were seldom able to help in the purchasing or preparations necessary for the holidays. They just supplied the money.

We kids supplied the anticipation, and for me, there was the party held at the Trinity Neighborhood House, a settlement house I attended on Meridian Street. The people I remember from there were Miss Orr, J.J. Dana and Dr. Edith DeAngelis. I'm out of space and will continue next week as Christmas approaches.

(Medina), and, on his refusing to do so, he was imprisoned on December 3, 1577 and taken to Toledo, where he was incarcerated for over 9 months. It was during his imprisonment that Saint John wrote some of his finest poetry. He made his escape in August of 1578. After the death of St. Teresa (Oct 4, 1582) John, for supporting the nuns in their adopting of the new constitutions, drew upon himself the displeasure of the superior, who deprived him of his offices and relegated him to one of the poorest monasteries, where he fell seriously ill. As his illness increased he was removed to the monastery of Ubeda, where he passed away on December 14, 1591. Saint John's beatification took place on January 25, 1675; he was canonized on December 27, 1726. Saint John is a Doctor of the Church.

Saint John left us many books of practical advice on spiritual growth and prayer that are just as relevant today as they were when they were written. The most wellknown of which is "The Dark Night of the Soul."

THE FIAT-CHRYSLER CORPORATION PAYS ITS DEBT TO CANADA AND TO THE UNITED STATES. An important event took place recently in the USA when the new Italian-American multinational refunded both Canada and the United States \$7.5 billion to clear the debt it had with the two countries. The CEO of the Italian American combine, Sergio Marchionne, now also the president of the corporation, signed the checks to cancel the debts, in a ceremony taking place at the assembly plant of Sterling Heights, near Detroit. The US was represented by President Obama's personal envoy, Ron Bloom, while Canada was represented by Brian Deese, of the National Economic Council, Canada.

As FIAT has now taken control (51% of stocks) of Chrysler, Marchionne became the corporation's president, as it was expected. Eventually FIAT will control a much larger chunk of Chrysler.

A GOOD SLEEP AND SPORT CAN KEEP US SLIM AND **HEALTHY.** There was a time when people thought that, perhaps, obesity could affect the quality of our sleep. Now we begin to understand, for we know better. An Italian endocrinologist, Aldo Pinchera, has recently explained the significance of lowering, or at least preventing obesity. He suggests that it is essential to maintain the habit of a good sleep by actively practicing some sport, which helps to lose weight, but too often there is no loss of calories.

Instead sport activity awakens in the body the leptin, the hormone that limits hunger in the body. It may seem a paradox that sleeping can make us lose weight, but we know now that sleeping and sport activities have actually the role of re-establishing a balance in our metabolism.

ITALIAN PARLAMENTARIANS SELDOM ABIDE BY THE CONSTITUTION! The Italian Constitution states, in no uncertain terms, that there are fundamental criteria that supersede anything the Parliament, or the Government (the council of ministries) wants to do. The same goes for the President of the republic, or the Premier. The President of the Constitutional Court (one of the three supreme courts), Ugo De Siervo, stated recently that when the Constitutional Court finds a law unconstitutional, how is it that this Court, representing the popular sovereignty, has failed in its basic role by allowing a Bill approved by the Parliament, to become a law even though it is constitutionally illegitimate. The Parliament, therefore, continues to err, obviously under political pressure by certain leaders who demand the approval of a law, at any cost!

They seem to care less if the Constitution is the law of the land; but it finds to be relegated to an irrelevant role! Is this what democracy in Italy is all about?

HOOPS and HOCKEY in the HUB

LENS CRAFTER — Sports Illustrated recently ran a fairly long piece on Walter Iooss, Jr., one of the magazine's master photographers who has spent 50 years covering athletic events.

And, wouldn't you know it, for a person who has been all over the world, it was a current member of the Boston Celtics that drew one of the most positive assessments from the photog.

"As far as photography goes, (Michael) Jordan and Kevin Garnett are the best I've seen in front of a camera. They never change their posture or their faces. If I put a camera up to you, you're going to worry whether you're in the wrong position or whether you look bad. They understood the camera and they knew they looked good."

While Jordan has retired to the ranks of ownership and KG may well move to the sidelines in a couple of years, Iooss, whose first year at the magazine was in 1961 — not bad for a fellow who didn't take his first sports picture (a shot of a New York Giants football game from the cheap seats) in 1959. Now 68 years young, he says he has no plans to retire.

THE ROAD OFTEN TAKEN It was the poet Robert Frost who penned the famous poem The Road Not Taken. It is a poem everyone should read. But for one who has journeyed a bit more in life we present one Tomas Kaberle, formerly of the Bruins, who has managed to play for (count them) a quarter of NHL teams during the 2011 calendar year.

Starting off the year with Toronto, he was traded to the Bruins back on February 18 for prospect Joe Colbourne and draft picks. To make room under the salary cap, the B's sent Blake Wheeler and Mark Stuart to Atlanta (now Winnipeg) for Rich Peverley and Boris Valabik. It was part of an attempt by the B's to reinvigorate the power play. Kaberle was less than outstanding while with the Bruins — but was with them at the right time as he experienced the full postseason ride to the Stanley Cup Championship.

He became the latest example of a rent-a-player as over the summer he was signed as a free agent to a three-year, \$12.75 million contract by the Carolina Hurricanes. But things didn't work out for the veteran defenseman as he had no goals and nine assists and was a minus 12 in 29 games with the Hurricanes. In early December the Canes unloaded him to Montreal for Jaroslav Spacek, who will be a free agent come summer. But you know what? In his first game with Montreal Kaberle came to life as he assisted on both goals in the Canadiens' 2-1 victory over New Jersey.

So, now that he's with the Habs, we'll be seeing a bit more of Tomas during the year unless, of course, he is traded to a Western Conference team

before too long. Seems like with him, it pays to a have a packed suitcase ready.

HOW THE B'S PULLED OUT OF THE DIVE — Early on, when the Bruins took to the ice for the first month of the season, they looked anything but the defending Stanley Cup Champions as they literally became a last place team.

But now they are one of the best teams in the NHL. What happened?

"I think we were a tired group and still not mentally ready to start the season," noted coach Claude Julien. "We had our backs against the wall there by the end of October and we had to do something. I think our focus came back, along with the urgency and commitment and then we started playing well again."

And, says the coach, once things got rolling, it was just like old times. "The guys got that good feeling that they had at the end of last year and they've just kept it going. The biggest thing I think is that you saw the urgency come into play. When you see your team in last place at the end of October after winning the Cup, I think that's certainly a wakeup call. But we had enough character, enough guys who had pride and wanted to do something about it."

ACCOUNTING FOR YEARS OF INFLATION — When Brad Marchand was fined \$2,500 by the league recently, coach Julien was asked what that amount of money would have meant to him during his playing days. "That would have been my yearly salary. I didn't even get a signing bonus," he replied.

ALMOST A DECADE -When the Bruins posted a 3-0 victory over the Los Angeles Kings on December 13, it was the first time the B's had shut out the West Coast team in nearly a decade. Of course, the Bruins and Kings don't play that often — $n\ddot{o}$ more $t\bar{h}$ an twice a year and sometimes less than that, depending on the schedule. Still, it was interesting to note that the last time the Bruins whitewashed the Kings was way back on January 10, 2002 when Byron Dafoe and John Grahame shared netminding duties during a 5-0 victory, This time it was all Tuukka Rask who stopped all 41 shots to pick up his first shutout of the season and the ninth of his career.

ALL ALONE — Through games of December 13, the Bruins were the only team in the NHL that had not allowed a shorthanded goal this season. In contrast, the New Jersey Devils led the league in shorthanded goals allowed with eight.

STREAK STOPPED When Bruins goalie Tim Thomas had his 10-game win streak halted via a 2-0 loss to Florida back on December 8, it ended the longest win streak by a B's netminder since Andy Moog won 10 straight from February 27-March 25, 1993.
