Hundreds packed into Saint Leonard Church on Sunday, December 17<sup>th</sup>, as Cardinal Sean O'Malley joined the Franciscan Friars to reopen the iconic church and perform the consecration of the new altar. On hand were Fr. Antonio Nardoianni, Fr. Claude Scrima from St. Leonard, and dozens of

local clergy along with a standing room only crowd at the restored church that recently underwent a \$3+ million and year-long renovation project.

The renovation touched nearly all aspects of the historic structure, including the refurbishment of the stainedglass windows, gilt ceiling, and frescoes throughout the church. New lighting fixtures along with a white porcelain tile floor make the church brighter. Handmade cherry pews were custom designed and are now arranged around a center aisle. # Stirpe Nostra

## HADRIAN — HIS PERSONAL LIFE

Hadrian was quite tall and was elegant in appearance. His hair was curled by artificial means and he wore a full beard to cover some birthmarks on his face. He rode and walked a great deal and kept fit by using arms, the javelin, and by hunting. He was many things in one person: austere and genial, dignified and playful, sluggish and yet quick to act, miserly but yet generous, deceitful but yet honest, cruel but yet merciful, and in all matters and at all times, he was changeable.

His vigilance was not confined to the military, but was extended to his private household and to those of his friends as well. Private agents were used for this purpose and it was conducted so skillfully that the persons involved were never aware of it. This habit of probing into the affairs of his friends coupled with his notorious passion for males and adulteries with married women are listed among his most grievous faults.

Hadrian often visited the public baths and bathed with the commoners. One day, he observed an old soldier who was scratching his back against the marble wall. When asked the reasons why, the veteran replied that he did not own a slave to rub him. The man was soon presented with some

slaves and the cost of their maintenance. Others who tried this trick later were called out of the pool and forced to rub each other.

He gave public games and constructed fine buildings in many cities of the Empire; in Rome, he furnished public entertainment which was of unbounded extravagance. He gave rare spices to the people in honor of his mother-in-law, and at one time even spread costly perfumes in the theater in honor of Trajan. Plays were presented in the theaters, wild beast fights were held in the circus, and he even produced public exhibitions of ancient Greek (Pyrrhic) dances. He was responsible for restoring many public buildings but insisted that the original dedication be preserved. One of his most noteworthy projects was the relocation of the Colossus of Nero while keeping it upright at all times. As many as twenty elephants were used during this project. When the relocation was completed, Nero's features were removed and the statue was dedicated to the Sun.



# L'Anno Bello: A Year in Italian Folklore

For the Love of Christmas

The magical season known as midwinter is upon us! The shortest day of the year, also known as the winter solstice, descended upon the world this past Thursday, the 21st of December. On the days surrounding the solstice, I can sense the darkness enveloping me like a thick velvet cloak, veiling the world in a perpetual state of dusk. However, I do not mind the darkness, as I view it as a necessary and intriguing spoke on the wheel of the year. These are the nights when stars appear sharp and bright against the inky black sky, their light sending diamond-like spangles flitting across the frost below. The darkness also imbues the winter solstice with a profound significance: now that the date has passed, we know that the sun will remain for longer perimuch-awaited warmth and sweet, luminous blaze. For this reason, Christmas — with its focus on candles and crackling yule logs and electric light displays — occurs during the darkest time of the year. Religiously, Christmas represents the light arriving to the world in the form of Jesus' birth while, metaphorically, the radiant decorations of Christmas signify the return of the sun after the solstice. Due to the complex symbolism comprising this holiday and its traditions, I revel in Christmas customs that emphasize the literal and figurative lights of my life. Whether enjoying age-old

ancient and essential part of the Italian Christmas Eve feast known as la Vigilia di Natale, which my family celebrates every year. La Vigilia di Natale, or "Christmas vigil," is traditionally a meatless meal in Italy, a vestige from the era in which Christmas Eve was considered a fast day in preparation for Jesus' birth on the following day. Therefore, many Italian families trim their tables with seafood dishes for la Vigilia. I am always excited to plan fish recipes with my mother for la Vigilia; in the past, we served sole bursting with a buttery shrimp stuffing and a delectable smoked salmon quiche. This year, my mother will prepare a creamy seafood lasagna laden with shrimp and scallops. However, my favorite component of Christmas cooking involves the plethora of desserts that fill my family's kitchens. A great number of traditional Italian desserts have become inextricably linked with Christmas and remain an indispensable part of my holiday celebrations. My father would always bring a cylindrical cardboard box of panettone home right before Christmas. Panettone, whose name means "great bread," is a sweet bread studded with dried fruit and candied peel. I am not a huge fan of the taste of panettone, but I appreciate its time-honored symbolism in the Italian Christmas festivities. I hold the nostalgic struffoli, a dessert my grandmother has been making since I was little, in high esteem. Struffoli are deepfried spheres of dough soaked in honey, then arranged into the shape of a tree or wreath and sprinkled with colorful nonpareils. Struffoli are a fun, whimsical way to celebrate the childlike wonder of the holiday

# **Boston Globe** Seems to Love Picking Scabs Off Old Wounds

Recently, I read the Boston Globe's Spotlight series on Boston's reputation as a racist city. Whenever I go vacationing down in Texas, I meet folks who think Boston is this horrible city with horrible people. They are surprised at how friendly I am. The liberal media has for a long time painted Boston as a very segregated and racist community. One day in Downtown Austin, someone got to talking with me at a Starbucks. He had an awful picture of Boston in his head. He told me that there was no racial divide in Austin, a city of over 800 thousand citizens. Why couldn't Boston be like them? I asked one question that ended the conversation. I asked him why Austin's African-American community is only four percent. He got up and left me to my peace and quiet.

I remember forced busing back in the '70s, when Judge Arthur Garrity from Wellesley single-handedly destroyed the Boston Public Schools in the name of saving them. I was 26 years old when the buses started rolling across the city, taking kids here and kids there. Everyone's children were just different colored jelly beans to the liberals who thought good education would happen when black kids from Roxbury were bused to Southie and white kids from Southie were bused to Roxbury. A whole generation of young people got lost in that ideological game the people who thought they knew better played.

The Spotlight team went out and found the ugliest photo

from those bad old days of busing. Of what value was it to print that old black and white photo of an angry mob in South Boston chasing a black man running for his life after getting pulled from his vehicle?

That photo, according to the Spotlight team, "crystallized" Boston's racist reputation for many years. I was active in the anti-forced busing movement back then and remember both the incident in question and that ugly photo.

However, it was a snapshot of one terrible moment and did not represent anything more than an angry mob of people reaching inside to find the worst in themselves. Most parents opposed to their children being forcibly bused were not racist and race relations hit rock bottom at that time thanks to the federal edict that pitted poor and working people against each other across the race divide. All the parents on both sides of this battle wanted was a good education for their children.

The quote printed from Michael Che, a so-called funny guy on Saturday Night Live! just before the start of last year's Super Bowl was far from funny and pretty much ignorant, too, as he stated, "I just want to relax and watch the blackest city in America beat the most racist city I've ever been to."

Boston is not perfect when it comes to race, no very large cities are. However, the Boston of 2017 is a far cry from the

# Saint Meinrad

Meinrad was born into the family of the Counts of Hohenzollern in 797 in what is today Switzerland. He was educated at the abbey school of Reichenau, an island in Lake Constance, by his relatives, the Benedictine abbots Hatto and Erlebald. There, he developed a thorough knowledge of Sacred Scripture and became a monk, following the Rule of Saint Benedict.

When he was twenty-five years old, Meinrad was raised to the office of deacon and, not long afterwards, to the rank of priest. He was always prompt to obey, strict in fasting, zealous in prayer, generous in works of mercy, and, most of all, humble. In time, Meinrad was assigned by the abbot to a small cell belonging to the monastery, close by Lake Zurich. He was to be in charge of the school there and share his talent and extensive knowledge.

In time, Meinrad left the cell and the school he had presided over and moved to a lonely place on Mount Etzel, where he practiced his faith unceasingly with fasts and prayers. Villagers provided him with the necessities of life and, with the help of pious folks and especially a certain abbess by the name of



Helwiga, he built a cabin, the bare necessity for his vow, and he remained in that place for the rest of his life.


He mortified himself with the greatest fasts, as much as human frailty allowed, and prayed without ceasing. He gave alms to his visitors — all those things which faithful men and women used to send him.

After Meinrad had lived in that lonely place for twentysix years, serving the Lord in fasts and by abstinence from all worldly things, two thieves named Richard and Peter

came upon his hermitage and killed Meinrad, taking what few belongings he had in the form of gifts made by pilgrims. This occurred on January 21, 861.

Legend tells us that there were some ravens who used to come regularly to this servant of God when he was alive and take what was offered from his hands. And, as if wishing to avenge the dead man, the ravens followed the thieves while they were fleeing from the hermitage and filled the woods with loud cawing. The thieves were caught, judged, and were burned alive for their crime.

The venerable abbot Walter and the brothers living under him took the body of Meinrad from his hermitage and transferred it to the monastery of Reichenau, where Meinrad was buried with due honor. The Feast of Saint Meinrad is celebrated on January 21st.

downstairs in Saint Antony Chapel, has been completely restored. Also, a new Baptismal font and podium are made out of white marble. Lastly, the church has been upgraded with accessibility features and new restrooms.

It is customary to erect an altar over the graves of martyrs' tombs as in the ancient Church, where Mass was celebrated in catacombs. Relics embedded under the altar of St. Leonard Church include:


- St. Vincent M. Strambi, 18<sup>th</sup> century bishop

## 'Holiday Gift Guide'

#### BILLIE HOLIDAY - DINAH WASHINGTON - STAN GETZ Universal Music Group + Verve (Vinyl)

There are many who would agree that classic jazz from the 1950s and '60s sounds best when played on vinyl LPs. UMe presents three vinyl box sets via Verve Records on key albums from three of jazz's biggest and most influential stars of its golden era: singers Billie Holiday and Dinah Washington, together with tenor saxophone sensation, Stan Getz. Each box set contains five of the artist's most popular and enduring albums, presented in authentic period sleeves that reproduce the original artwork.

Billie Holiday (1915-1959) is one of the most influential and iconic jazz vocalists of all time. Her uniquely expressive voice, with its unmistakable tone, timbre, and horn-like phrasing, had an emotional sincerity that made everything she sang seem an honest reflection of her own personal struggles in life. By the 1940s, she was a big solo star, but behind the showbiz glamour, there was a dark underside of drug and alcohol dependency.

Dinah Washington (1924-1963) was known for her clear diction, crisp phrasing, and dramatic delivery. Like Billie Holiday, she possessed an immediately recognizable singing voice. A 1993 inductee into the Rock and Roll Hall of Fame, Washington first recorded during the 1940s, serving up risqué blues songs. In the 1950s, Washington recorded a clutch of classic albums for the Mercury subsidiary, Emarcy, which revealed her to be a sophisticated song stylist who could sing blues, jazz, and pop with consummate ease.

Tenor saxophonist Stan Getz provides the final box set in this trio. Though born in Philadelphia, Getz was a key architect in the development of the West Coast "cool school" sound and was heavily influenced by the airy tone of saxophonist Lester Young. Getz rose to fame in the late 1940s after serving his musical apprenticeship in the bands of Jack Teagarden, Benny Goodman, and Woody Herman. As a solo artist, his career took off in the 1950s, a time when he earned the nickname, "The Sound," which referred to his light, feathery saxophone tone and gift for effortless melodic improvisation.

# A CAPITOL CHRISTMAS VOLUME 2 Capitol + UMe (Vinyl)

Capitol Records' celebration of its 75<sup>th</sup> anniversary continues with the release of A *Capitol Christmas Volume 2*, a collection of 24 timeless holiday and seasonal classics sung by the label's unmatched list of legends. Available as a double LP in gatefold cover, the album brings together some of pop music's most iconic holiday songs with extremely rare recordings originally issued in very limited release. The list of singers includes Glen Campbell, The Beach Boys, Wayne Newton, Lena Horne, Dinah Shore, Nancy Wilson, Les Paul & Mary Ford, Johnny Mercer, The Louvin Brothers, and many more.

# LIONEL RICHIELIONEL RICHIE + CAN'T SLOW DOWN + DANCING ON THE CEILING Motown + UMe (Vinyl)

Three historic albums on vinyl from Lionel Richie, one of the most successful solo artists in Pop/R&B crossover history. *Lionel Richie* (1982) is a quadruple-platinum release Richie crafted for his '80s success with the chart-topping ballad "Truly," the upbeat "You Are," and the ballad "My Love." *Can't Slow Down* (1983) featured the Caribbean-flavored hook "All Night Long," plus the haunting ballad "Hello," the grooving "Running with The Night," and the romantic "Stuck on You." *Dancing on the Ceiling* (1985) completed Richie's 1980s chart-success trifecta, highlighted by the album's title track "Dancing on The Ceiling," then topping the Adult Contemporary chart with "Love Will Conquer All," and adding the #1 ballad "Say You, Say Me," the song recorded for the film *White Nights* that earned Richie an Academy Award for Best Original Song.

# REBA McENTIRE - MERRY CHRISTMAS TO YOU MCA Nashville + UMe (Vinyl)

There is a very long pause before he begins to speak. This creates an expectation that what we are about to hear from Mr. Hirabayashi is going to very important. In fact, not only is what develops on that stage important, it is also deeply moving.

The story, based on the real life Hirabayashi, is about an American citizen of Japanese ancestry who had the courage to stand up to his government during the onset of WWII when Japanese-American citizens were being rounded up and placed into internment camps

while being denied the due process afforded them by the Constitution. That they were denied their rights solely because of their ancestry is a frightening tale. Most of these citizens and it must be remembered that these people were American

citizens — also lost their homes, furnishings, and businesses. Some had relatives who, at the same time, were in the military defending the nation and, yes, its Constitution.

Michael Hisamoto commands the stage for a little over 100 minutes, portraying a man who is both charming and steadfastly determined. Playwright Jeanne Sakata has included much humor in her work. which makes this tragic story bearable. Using this humor, Mr. Hisamoto, with his infectious smile, is able to break the tension when it begins to overwhelm while at the same time using his eyes to convey the steely determination of his character. Make no mistake, Gordon Hirabayashi, though good-natured, is tough as nails. And, as he points out using a Japanese proverb his mother taught him, "The nail that sticks out is the one that gets hit."

Mr. Hisamoto plays all the characters with the exception of those that are voiced from off stage. He is accompanied by three kurogos, characters from Japanese theatre whose faces are fully covered and do not speak on their own. The kurogos move about while Hisamoto voices their lines. The use of lighting cast onto a minimally furnished stage, along with some projections on the back wall and subtle mood music, is all wonderfully effective. Director Benny Sato Ambush has done a masterful job.

As I watched We Hold These Truths, I thought about the temptation to slip into feelings of self-righteousness as I felt a bond with Mr. Hirabayashi. But would I have felt the same way if I were there in 1942 after the attack on Pearl Harbor? I would like to think I would have, but it is easier looking back at this dreadful period with the emotions of the time removed.

What I did conclude was how important it is for our Constitution to be upheld by judges who will not be ruled by emotion or the temptation to legislate from the bench. In the Hirabayashi case, which he fought all the way to the Supreme Court, the justices ruled unanimously against him even though this was certainly a clear case of his due process being denied. The fact that there was little public support for these Americans who were being deprived of their rights should never have played into the judges' decision, but it certainly did.

Michael Hisamoto's stirring performance not only honors Mr. Hirabayashi, but is also a reminder that while we may look back and like to believe we would have stood up for this courageous man, we should test ourselves as to whether or not we would do the same today in different situations. In this age, where so many look to the courts to create laws, we have to ask ourselves if we are able to respect the process and if we can support decisions we are not happy with, but are what is dictated by the Constitution. If that process had been followed in 1942, we would not have seen so many of our fellow Americans treated in such a shameful way

I urge you to see We Hold These Truths and watch it with your eyes wide open. It is an important work and one that should cause you to reflect, no matter where on the political spectrum you fall.





# THOUGHTS BY DAN ABOUT THIS & THAT

Lawrence of Arabia



If *Brief Encounter* was the most modest creation of David Lean, *Lawrence of Arabia* was the ultimate statement to his love of epics and grandeur. It is one of the greatest masterpieces of the movie screen ever made.

It was also the crown jewel of Peter O'Toole's career. Of course, his role was already a legend. T.E. Lawrence became a hero for Britain for his attack on Aqaba and Damascus, opening them as ports for British supplies during World War I. The film traces his early days as an insolent officer in the British regiment to his involvement in the Arab National Council. Albert Finney, Marlon Brando, Anthony Perkins, and Alec Guinness (who had played Lawrence on stage) were all considered for the role, but then Lean saw the 1960 crime film The Day They Robbed the Bank of England and when he saw the relatively new actor Peter O'Toole on screen, he exclaimed, "This is Lawrence!"

Guinness instead took the role of Prince Faisal who, through an allegiance with Lawrence, would become King of the Arab Kingdoms of Syria and Greater Syria. It was to be a large epic cast with Anthony Quinn, Omar Sharif, and Claude Rains all joining the crew.

Lean had been planning a film about T.E. Lawrence for at least a decade. Distractions (such as a failed attempt to film the life of Gandhi and his first grand epic, *Bridge on the River Kwai*) delayed the project. By the end of the decade, however, Lean would return to the subject of T.E. Lawrence. He joined up with Columbia Pictures, a studio that had been waiting to make a movie about Lawrence's exploits in the Arabian Peninsula for as long as Lean

had, and purchased the rights to Lawrence's biography.

The first draft of the screenplay was written by Awardwinning American screenwriter Michael Wilson, whose previous credits included It's a Wonderful Life and A Place in the Sun. Had Wilson's vision not been rejected by Lean, the already gigantic production would have expanded even more. Wilson's script covered the historic background before the arrival of T.E. Lawrence, complete with the Arab revolts and struggles under the Ottoman Empire. Lean, however, did not like the script deviating too much from his central figure and so gave the project to English writer Robert Bolt, who turned it into more of a character study, though it retained a decent amount of Wilson's relevant

Perhaps because he expected it to be so grueling, Lean began shooting before the script was completed. Most of the shooting was done between Jordan and Morocco. Filming was complicated by political unrest in the region, uncooperative locals, hard to manage camels (O'Toole injured himself falling off his), and Bolt's arrest for participation in an anti-nuclear demonstration. When the crew became ill, however, production was moved to Spain for the scene depicting the attack on Aqaba.

Ironically, Jordan was among the nations to ban the film, objecting to its depiction of Arab culture. However, thanks to the prominence of Omar Sharif, the film became a source of pride in Egypt, where it enjoyed a wide release.

Almost everywhere that Lawrence of Arabia was released then as well as subsequently, it has been hailed as a master-



piece of epic filmmaking. Steven Spielberg has proclaimed it his favorite film and considers it the one that has most influenced him. "It pulverized me," he said. "I went out and bought the Maurice Jarre soundtrack and, for the next couple of months, played the score over and over again. They had a production book inside the soundtrack album and I devoured each picture one at a time, wanting to know how that film was made. It was a miracle, that picture."

More than fifty years later, *Lawrence of Arabia* remains one of cinema's greatest triumphs, a breathtaking adventure that only a master of film could create.

# Recipes from the Homeland

## **BISCOTTI**

4 cups flour 4 beaten eggs

1½ cups sugar

1 cup vegetable oil

4 teaspoons baking powder

3 teaspoons vanilla\*

1 cup chopped walnuts\*

Preheat oven to 350°F. Mix sugar and oil. Add beaten eggs and vanilla. Gradually add flour and baking powder. Fold in chopped walnuts last. Spoon mixture by tablespoon onto highly greased cookie sheet, forming a long strip about two inches wide and one inch thick. Place each strip about two inches apart because mixture spreads while baking. Bake at 350°F about fifteen to twenty minutes or until firm with bottoms slightly browned.


Allow cooling only a minute. With spatula, carefully lift one strip at a time onto cutting board. With sharp serrated knife, slice each into 1-inch thick biscotti. As you slice, place sliced portions on the baking tray, side down. Return full tray into heated oven of 350°F for about ten to fifteen minutes to toast lightly.

After toasting, remove from cookie sheet to cool. These store well in a large canister.

A Nostalgic Remembrance

To those of you who attended my book signings this week, thank you (mille grazie).

If you weren't able to attend and would like a copy of True Short Stories, an account of my teen years in **East Boston** while I attended **English High School**, you can purchase a copy in the following way: Send a check for \$20.00 made out to me, JOHN CHRISTOFORO, and mail it to Beagsley Publishing Co., Box 342, Arlington, MA 02476.

At Christmastime, I remember several stories from when I was a kid. The first concerns Clement Clarke Moore. In 1882, he wrote a story for his family entitled, "A Visit from St. Nicholas." (Twas the night before Christmas ...) The second concerns a young girl sending a letter to the editor of the New York Sun, who turned it over to one of his newsmen, a Mr. Francis P. Church. The letter questioned the reality of Santa Claus.

Mr. Church responded with the article, "Yes, Virginia, there is a Santa Claus." The third story was told at the Trinity Neighborhood House, located at 406 Meridian Street in the Eagle Hill section of East Boston. It is a brick townhouse that was originally built in 1847 for a local entrepreneur, Noah Sturtevant. In 1888, it became a social service center operated by the Trinity Church of Boston and, when I was a kid, I was involved with many of the activities offered there on a daily basis.

Christmas was approaching and we kids were informed that a party was to be held for all of the young members and their families a few days before the 25<sup>th</sup> of December. I asked everyone in my family if they could attend but hit a stone wall. Dad and my uncles were musicians and worked day and night during the holiday season. Mom and Nanna were constantly food shopping and readying things for Christmas Eve as well as Christmas Day. That left only one person to accompany me to the Trinity House Christmas party ... Babbononno. The people directly involved were a Ms. Orr, who seemed to run things for the girls, J.J. Dana, who ran things for the boys, and old friend Edith DeAngelis, who assisted Ms. Orr with everything concerning the working of the center.

On the night of the party, Babbononno and I walked the three or so blocks from our Eutaw Street address to 406 people. Today, in the town of Meridian Street. Once inside, David, a Savior has been born

involved and we were instructed to help ourselves to the food and drink provided for the occasion. Babbononno looked at the sandwiches made with white bread that had the crust cut off, the potato salad, the potato chips, and the bowl of red punch. He then looked back at me with an expression that said, "You've got to be kidding me." My response was, "Prego, no dire niente" (Please don't say anything). He suffered through a couple of tuna or chicken salad sandwiches and a dollop of potato salad washed down by the red punch. He was happy when a Christmas cake was cut up and served with coffee for the adults. He had a sweet tooth and the cake saved the day.

Parents were given a tour of the facility by J.J. Dana and Edith DeAngelis and, when we were back in one of the large rooms all seated together, Ms. Orr read from her Bible about the birth of Jesus (Luke 2:1-20):

In those days, Caesar Augustus issued a decree that a census was to be taken of the entire Roman world. This is when Quirinius was governor of Syria and everyone went to their own town to register. Joseph also went up from the town of Nazareth in Galilee to Judea, to Bethlehem, the town of David, because he belonged to the house and line of David. He went there to reregister with Mary, who was expecting a child. While they were there, the time came for the baby to be born, and she gave birth to her firstborn, a son. She wrapped him in swaddling clothes and placed him in a manger because there was no room for them at the inn.

And, there were shepherds living out in the fields nearby, keeping watch over their flocks at night. An angel of the Lord appeared to them, and the glory of the Lord shone around them, and they were terrified. The angel said to them, "Don't be afraid. I bring you good news that will cause great joy for all I introduced him to everyone to you; he is the Messiah, the

Lord. This will be a sign to you and you will find him wrapped in cloths and lying in a manger."

Suddenly, a great company of the heavenly host appeared with the angel, praising God, saying, "Glory to God in the highest heaven, and on Earth, peace to those on whom his favor rests." When the angels had left them and gone into heaven, the shepherds said to one another, "Let us go to Bethlehem and see this thing that has happened, which the Lord has told us about." She concluded with these three royal figures standing and kneeling among the shepherds, followed by, "Amen," which everyone repeated.

When the Bible reading was over, we kids ran off to play with one another while Ms. Orr, J.J., and Edith tried to keep the adults entertained. Soon though, it was time to leave and Babbononno didn't refuse a piece of cake to take home. (Like I said, he had a sweet tooth.) When we arrived back home, Nanna and Mom questioned him about his experiences at the Trinity House. He talked about the great time we had and how close the Protestant version of the birth of Jesus was to the Catholic writings.

Soon it was time to go to bed. I had only one or two more days of school before the 24th of December and the Christmas Eve tradition of the seven fishes, and the following morning when I could see if Santa brought me all that I had asked for. Beginning late morning on Christmas day, the entire family would show up and wish each other a Merry Christmas and pass out gifts to one another. Several hours later, after one of Nanna's holiday dinners, we would all mellow out and just relax and enjoy the atmosphere filled with Christmas joy.

From the descendents of Mike and Jenny Contini and Nunzio and Antoinette DeCristoforo, a very Merry Christmas to one and all. Buon Natale Tutti and





#### **Tiant Misses** Hall of Fame Again

Detroit Tigers teammates Jack Morris and Alan Trammel will be entering the Baseball Hall of Fame on July 29, 2018. They both started for the Tigers in 1977 and played together until 1990. Louie Tiant missed out again. Morris won 14 votes and Trammel 13 from the 16-member Modern Era Committee, which considered candidates whose biggest contributions came from 1970-87.

Morris won 254 games for the Tigers (mostly), Twins, Blue Jays and Indians, and pitched for four World Series champions. He was on the regular ballot for fifteen years, topping out at only 67.7 percent in 2013. # HOOPS and HOCKEY in the HUB

PROCEEDING TOWARD DES-TINY? - It doesn't seem possible, but Boston Celtics head coach Brad Stevens is now in his fifth season at the helm of the storied franchise.

We remember with clarity the day Stevens, who had been the highly successful coach at Butler University, was introduced to the media at the team's practice facility in Waltham. It was July 5, 2013. The press conference was the culmination of one of the most impressive secret searches in the recent history of athletics.

In this day and age, where everyone has a camera built into their Smartphones and information is exchanged at a rapid rate through the use of social media, the Celtics had managed to pull off an old-fashioned search, with the official announcement being the first indication concerning who had been hired to replace departing mentor Doc Rivers.

It was secrecy supreme and immediately made the Celtics the envy of the corporate world, where it seems that whatever is discussed in the boardroom makes its way down to the lunchroom the next day.

But no, not in this case. Celtics GM Danny Ainge, co-owner Steve Pagliuca, and team attorney Mike Zarren apparently had managed to slip into the Indianapolis area completely unnoticed, bringing with them a six-year, \$22-million contract for one of the best young college coaches in America to consider. Of course, Stevens had to run it by his lawyer — who was sitting right next to him. That would be his wife, Tracy. They were married back in August, 2003.

One of the biggest questions was whether Stevens would leave an area where he had grown up and had achieved almost unparalleled success as a college coach. His popularity on campus and in the Greater Indianapolis area was at its zenith

Named the head coach at Butler in 2007, all Stevens did in his debut campaign was lead the team to its first 30-win season in school history. Only 31 at the time, he was the third youngest Division 1 coach in history to lead his team to 30 wins. He was also the youngest to do so in more than 50 years.

Two years later, at the conclusion of the 2009-2010 season, Butler finished the campaign ranked No. 2 in both national polls.

Overall, Stevens completed his six-year tenure as Butler's head coach with a 166-49 record, a register that included four regular season league championships, three league tournament titles, and two trips to the NCAA Division 1 National Championship game.

Yessir, Bradley Kent Stevens (born on October 22, 1976), a former marketing associate at Eli Lily and Company, had done quite well for himself, thank you very much.

But would he leave the paradise that he had created in basketball-mad Indiana to come to the storied Celtics in Boston? After all, only in the Hoosier state can one read the following: "In 49 states, it's just basketball but this is Indiana!"

As revealed earlier this year, Stevens indicated that he would come with one condition — that he not be asked to tank games in order to improve the team's potential position in the NBA

Given assurances that he would only be asked to be successful, Stevens signed on the dotted line. And the rest is history in the making.

The Celtics did have a losing mark in their first season under the direction of Stevens, but by the end of his second year, he had the Cs in the Eastern Conference playoffs.

Some fans openly expressed their desire for tanking, but Stevens would have none of it, guiding the team to the seventh seed in the Conference. The team's reward: exiting the first round of the playoffs via a fourgame sweep at the hands of the powerful Cleveland Cavaliers.

Constant improvement was the theme. In his third year, the Green finished with a healthy 48-34 mark and made the playoffs once again.

Last year, the Celtics finished atop the Eastern Conference in the regular season with 53-29 and made it all the way to the Eastern Conference Finals before bowing to Cleveland in five games.

Asked in a press conference if he was satisfied with how the season went, Stevens said he had only one goal: "To win the whole thing."

As the current NBA regular season nears its midpoint, the Celtics appear to be in control. Through games played as of December 19th, the Celtics owned an excellent 26-7 record, the best mark in the Eastern Conference and third best in the entire 30-team NBA after Houston and Golden State.

Much like last year, Cleveland appears to be the team that will provide the biggest challenge to the Celtics in their quest to earn a berth in the NBA Finals this coming spring. After a somewhat slow start, the Cavs appear to be back on track. They had won eight of their last 10 games as of December 19th. They may well continue to improve as a team when former Celtics star Isaiah Thomas makes his debut as a Cavalier in the near future.

One of the reasons for Steven's success is how he treats his players. Former Celtic Kelly Olynyk, now with the Miami Heat, said back in the fall that not only was Stevens a good coach but that he is one of the finest human beings he has ever

In short, there is a human dimension to Stevens that can't be quantified, can't be placed in a stat book, or logged into a database. But it is there. And it may well be that characteristic that carries the Celtics forward to the next level and possibly Banner 18.

Coach Bradley Kent Stevens is one who possesses gifts not only for the season but throughout the season — characteristics that won't be recorded, but may well be rewarded in the positive attitude of his players as this exceptional season continues.
